**DESCRIPTION**

FIG. 1 is a perspective view of a bottle return apparatus showing our design;

FIG. 2 is a front elevational view of the bottle return apparatus of FIG. 1;

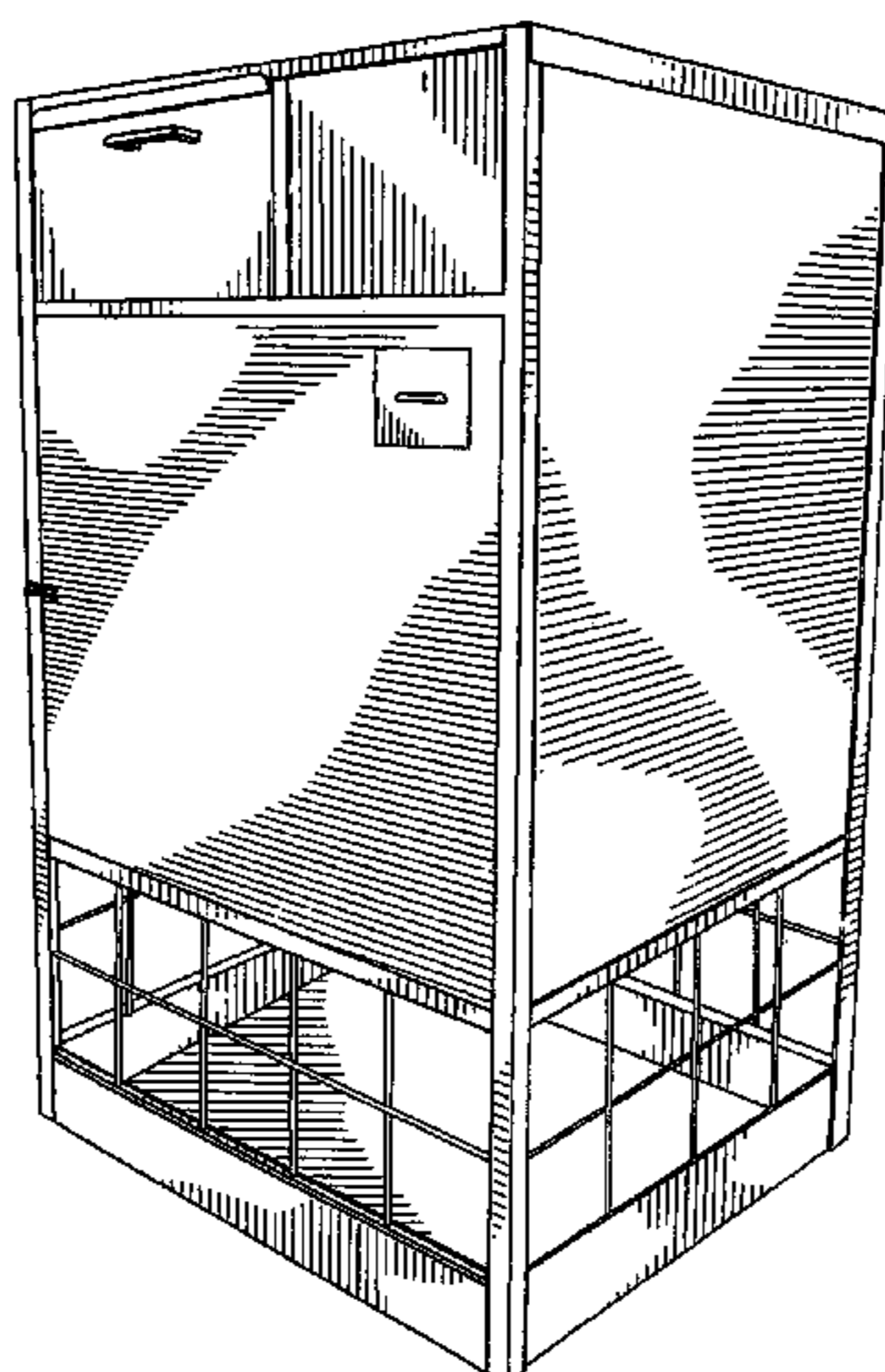
FIG. 3 is a rear elevational view of the bottle return apparatus of FIG. 1;

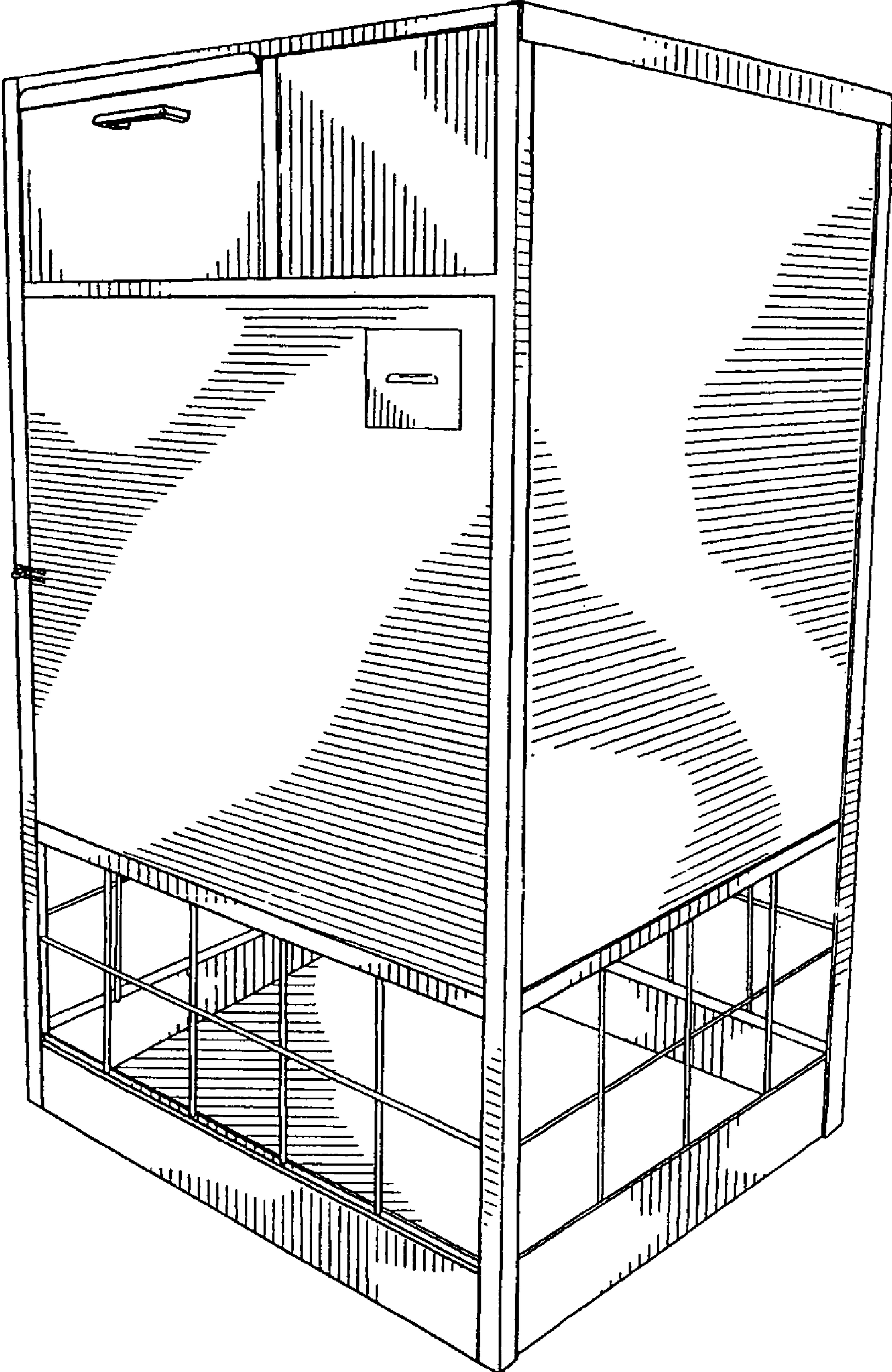

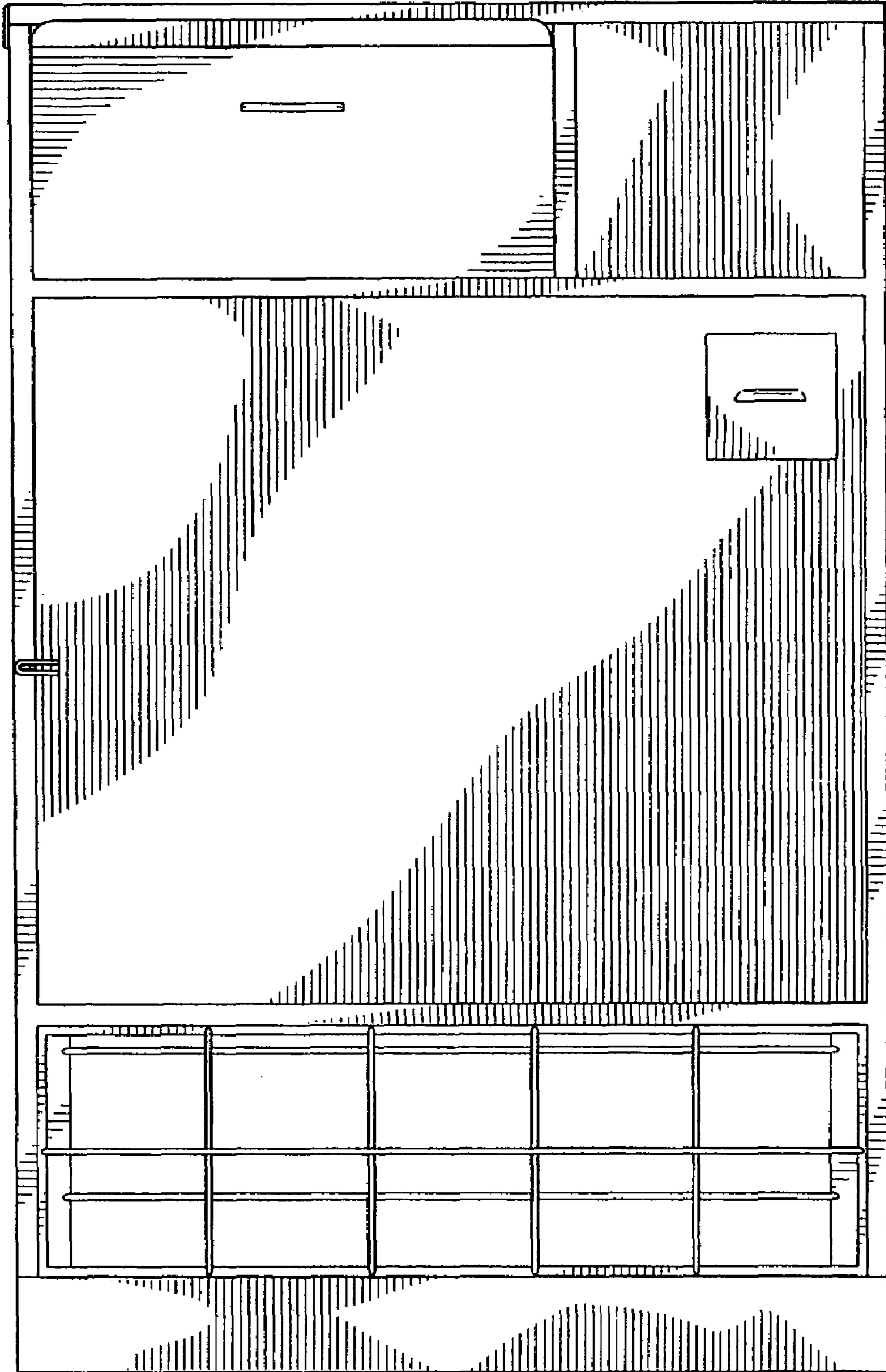

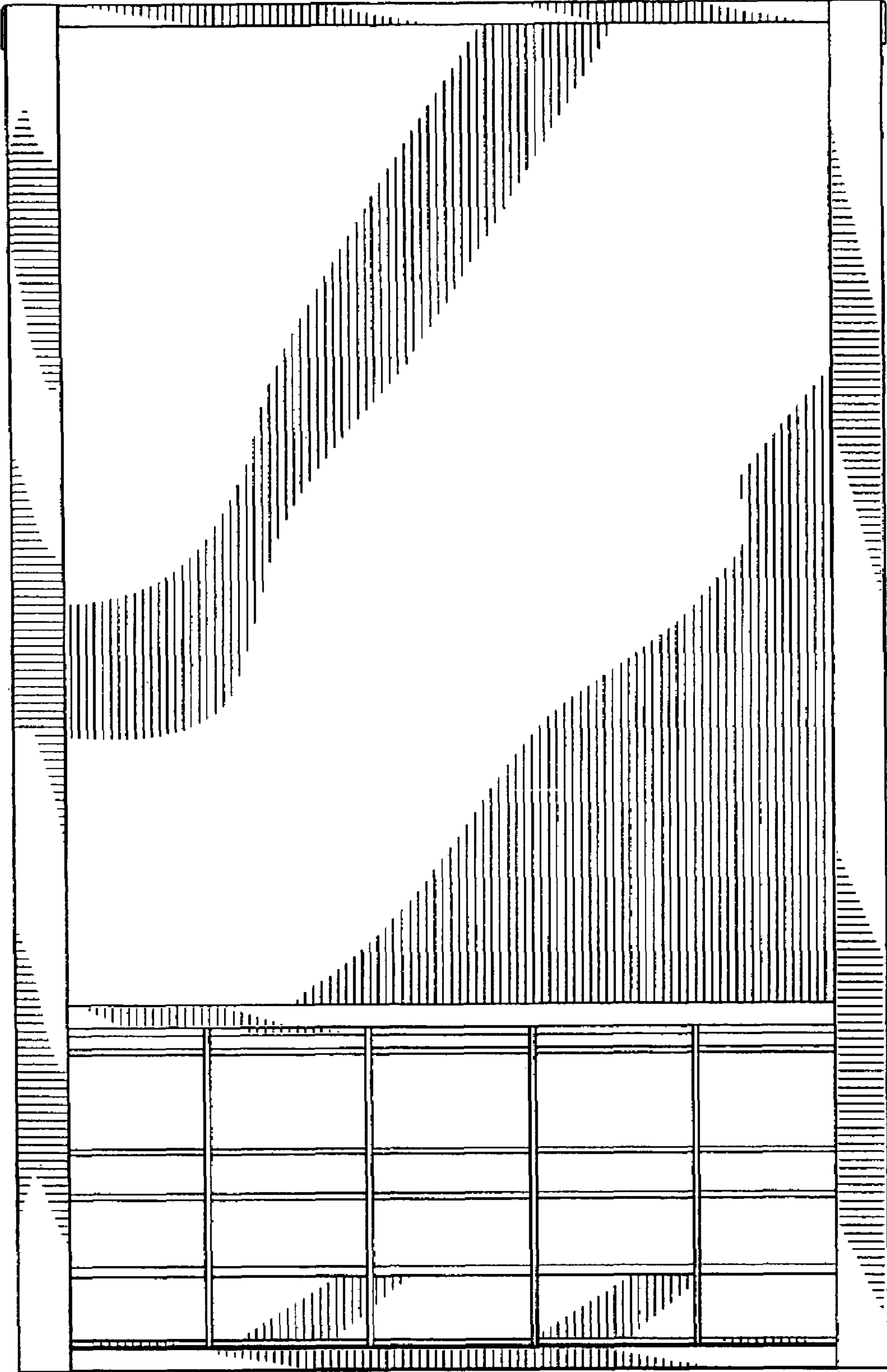

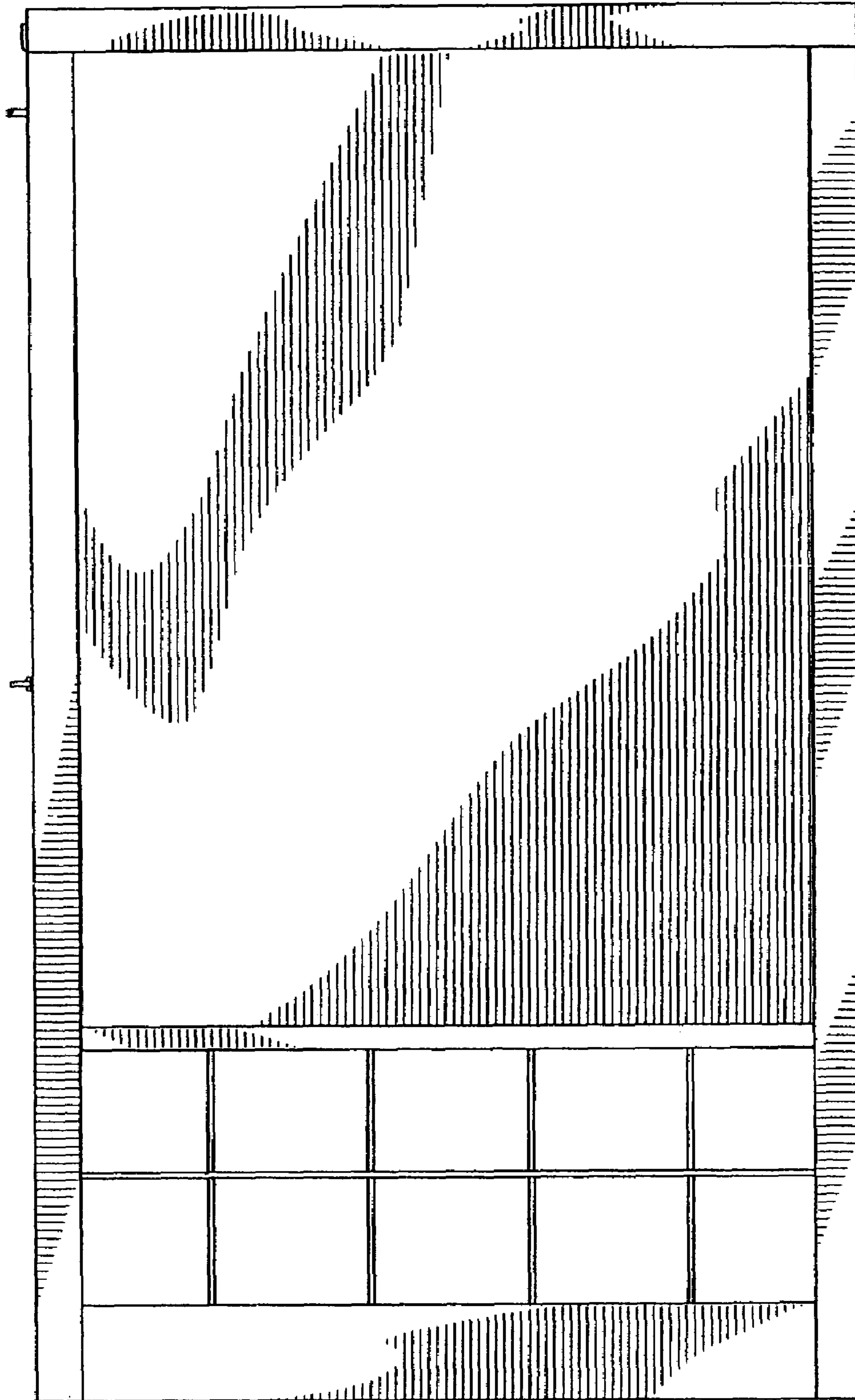

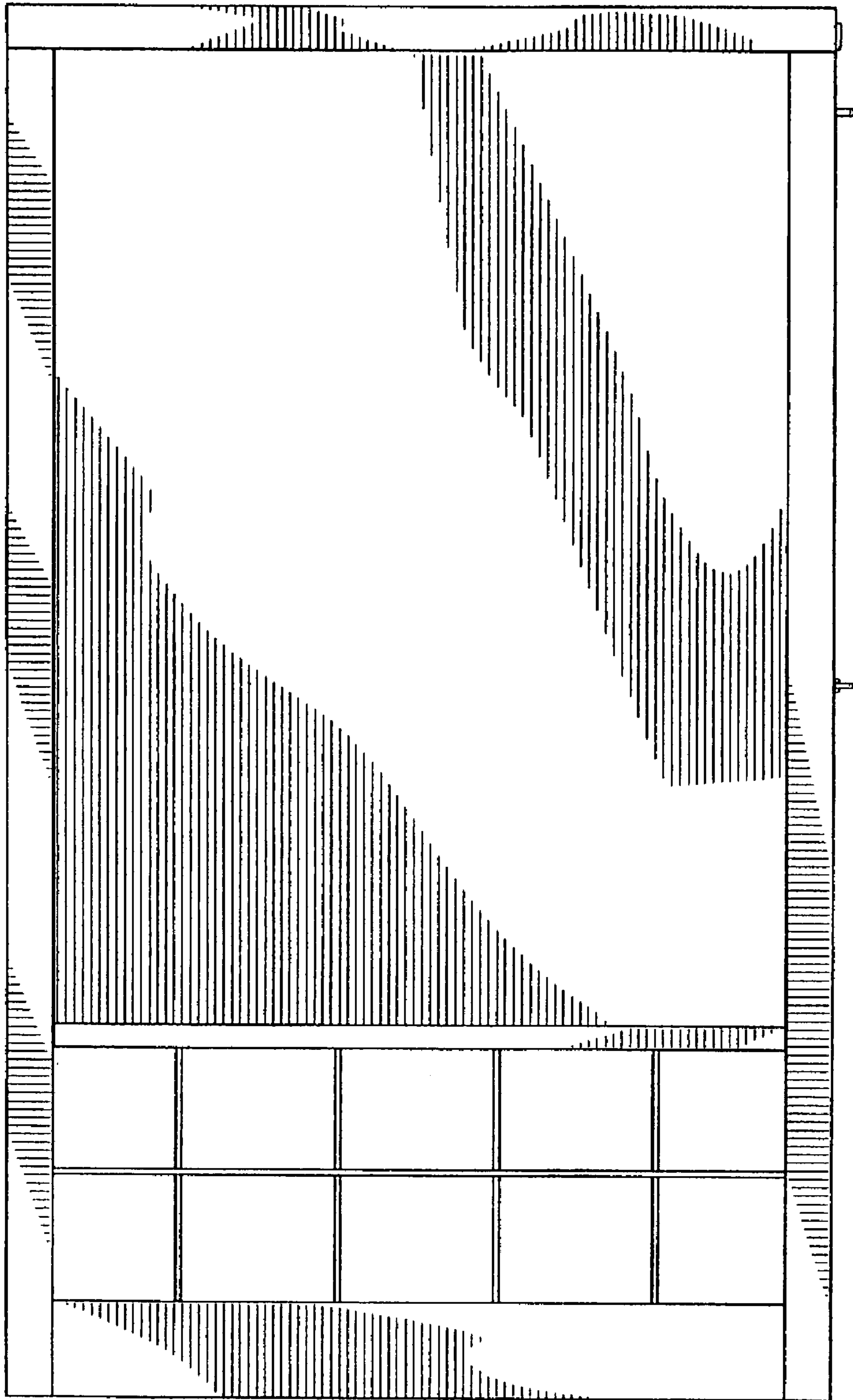
