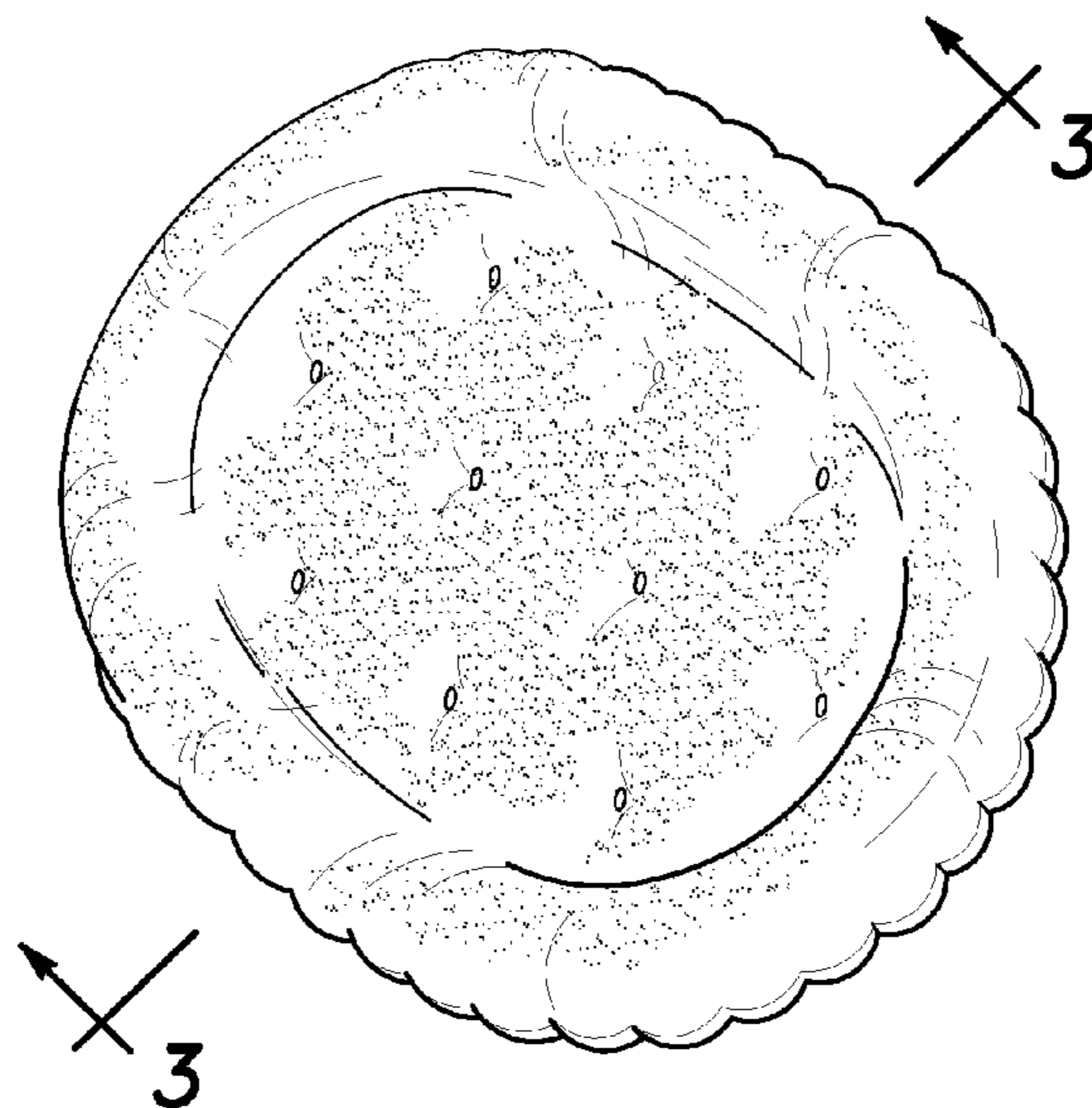
(57) **CLAIM**

We claim the ornamental design for a tub-shaped snack, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing the tub-shaped snack;
FIG. 2 is a bottom perspective view showing the tub-shaped snack; and,
FIG. 3 is a cross-sectional view of the tub-shaped snack taken along sections lines 3—3 in FIG. 1.

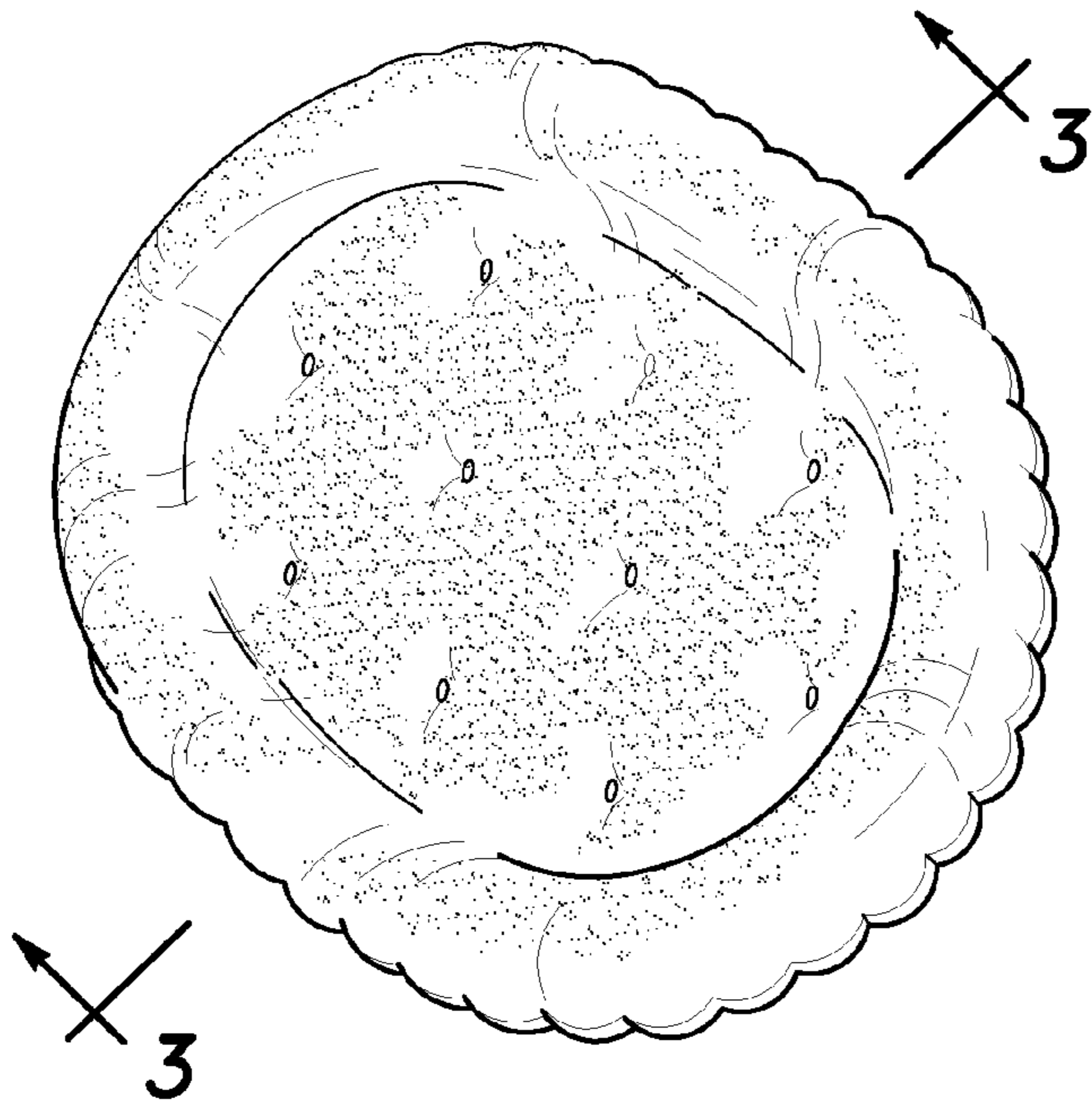

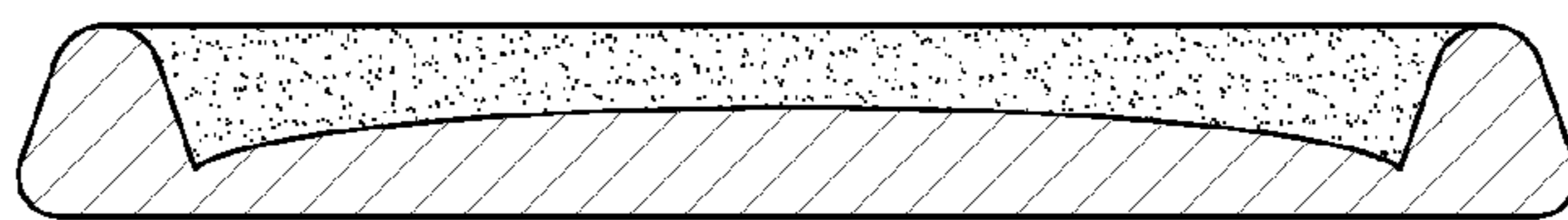
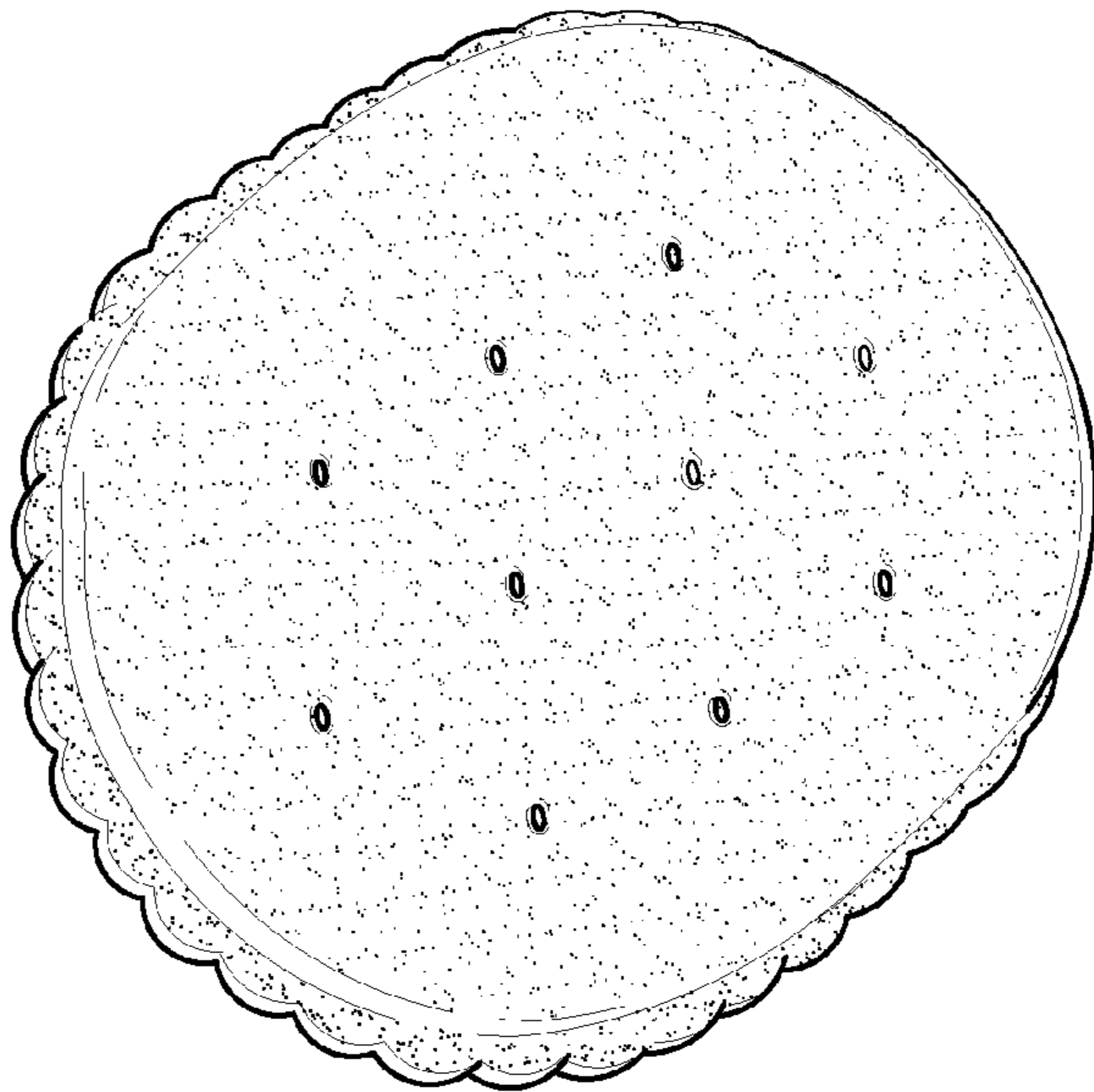
