DESCRIPTION

FIG. 1 is a perspective view of a bladder for a shoe sole showing our new design;

FIG. 3 is a bottom plan view thereof;

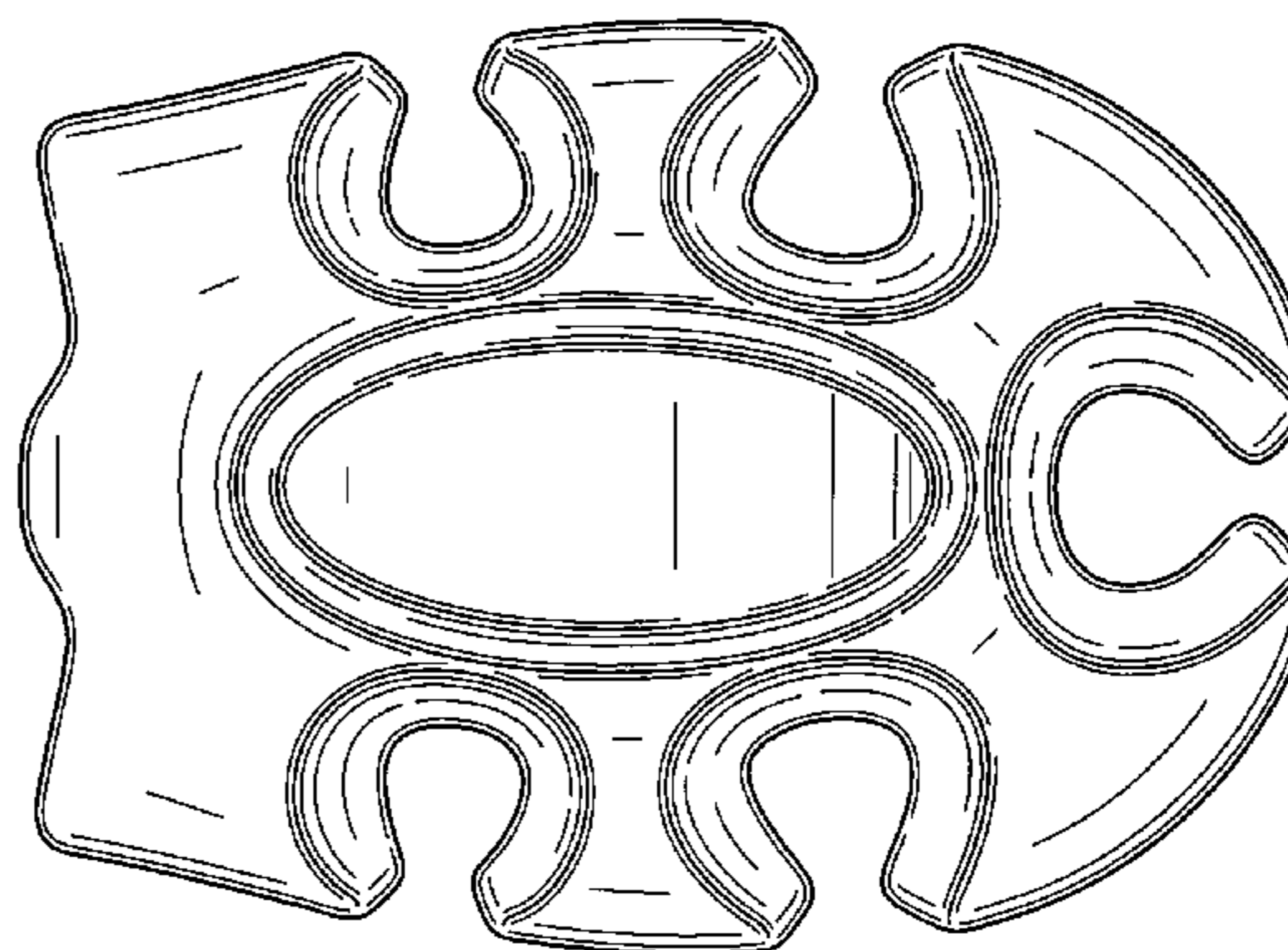
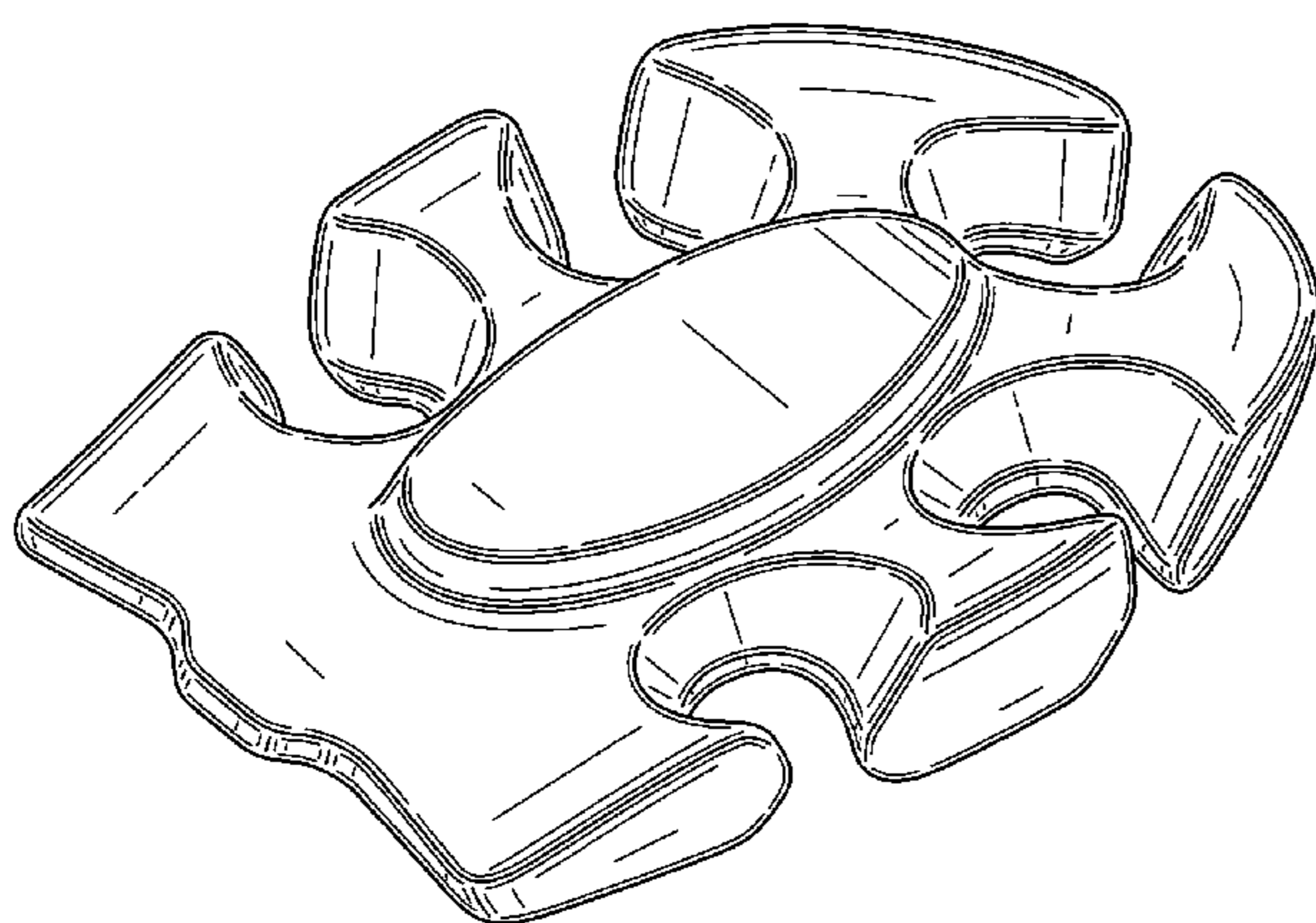
FIG. 4 is a side elevational view of the right side thereof;

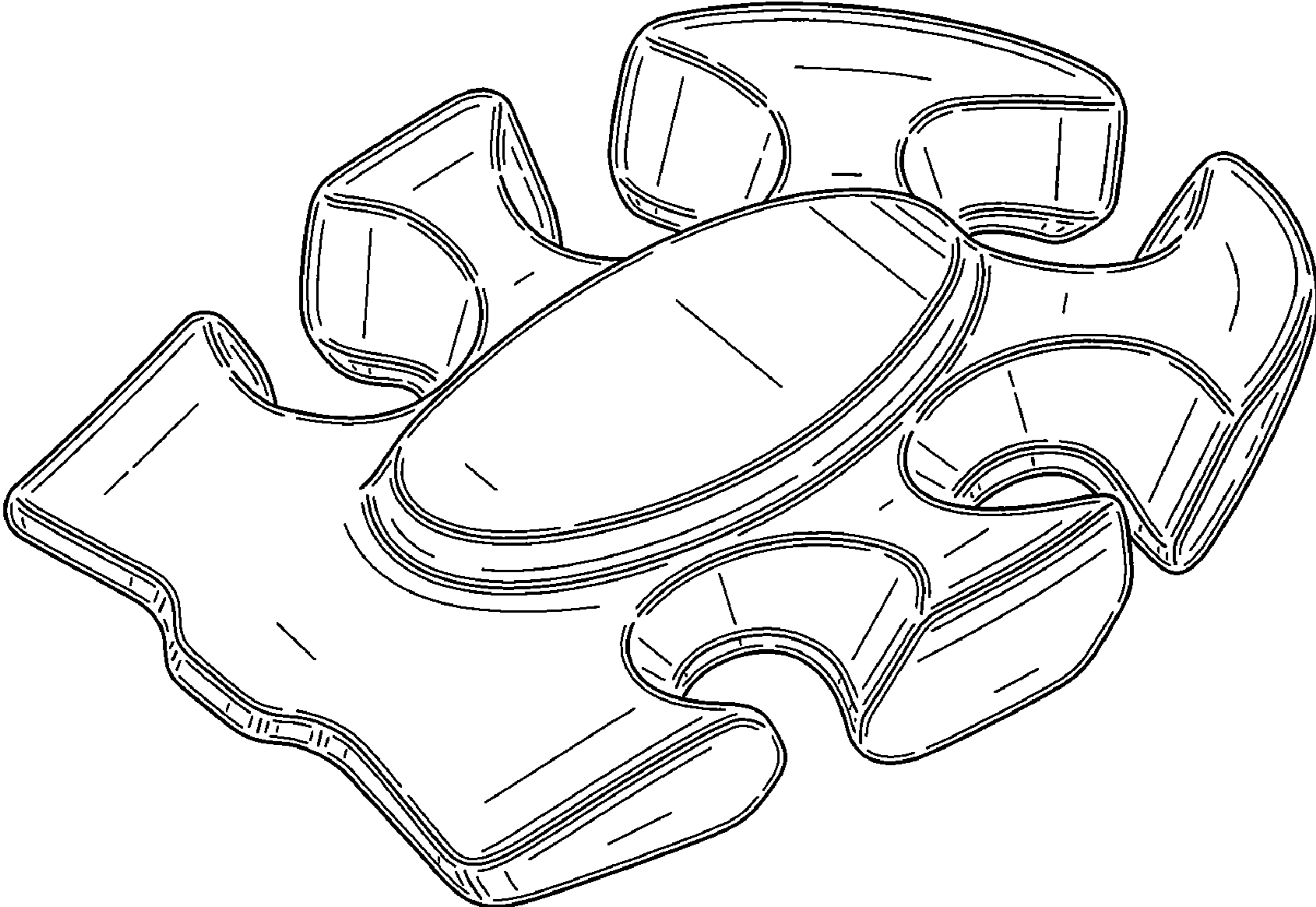

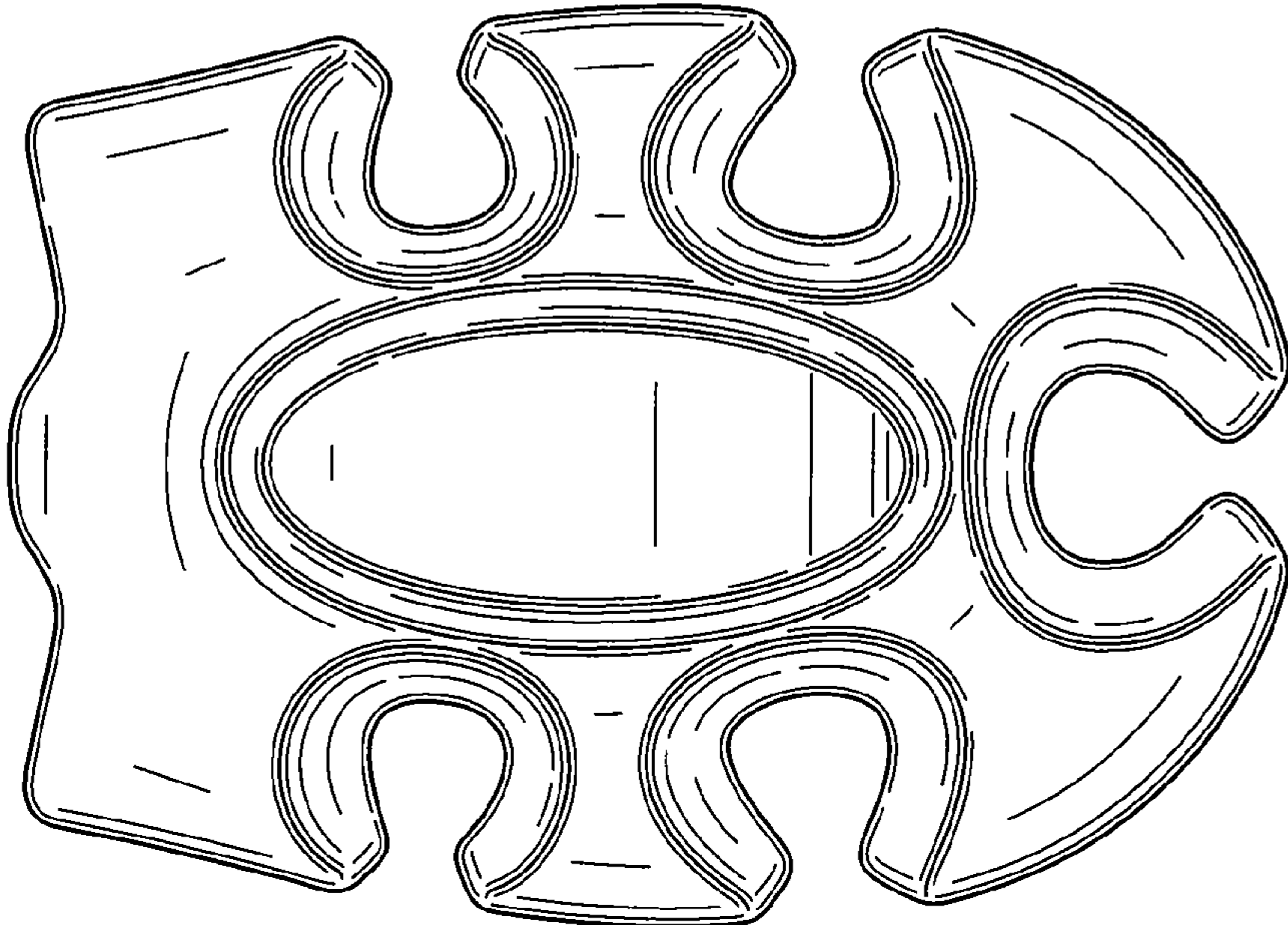

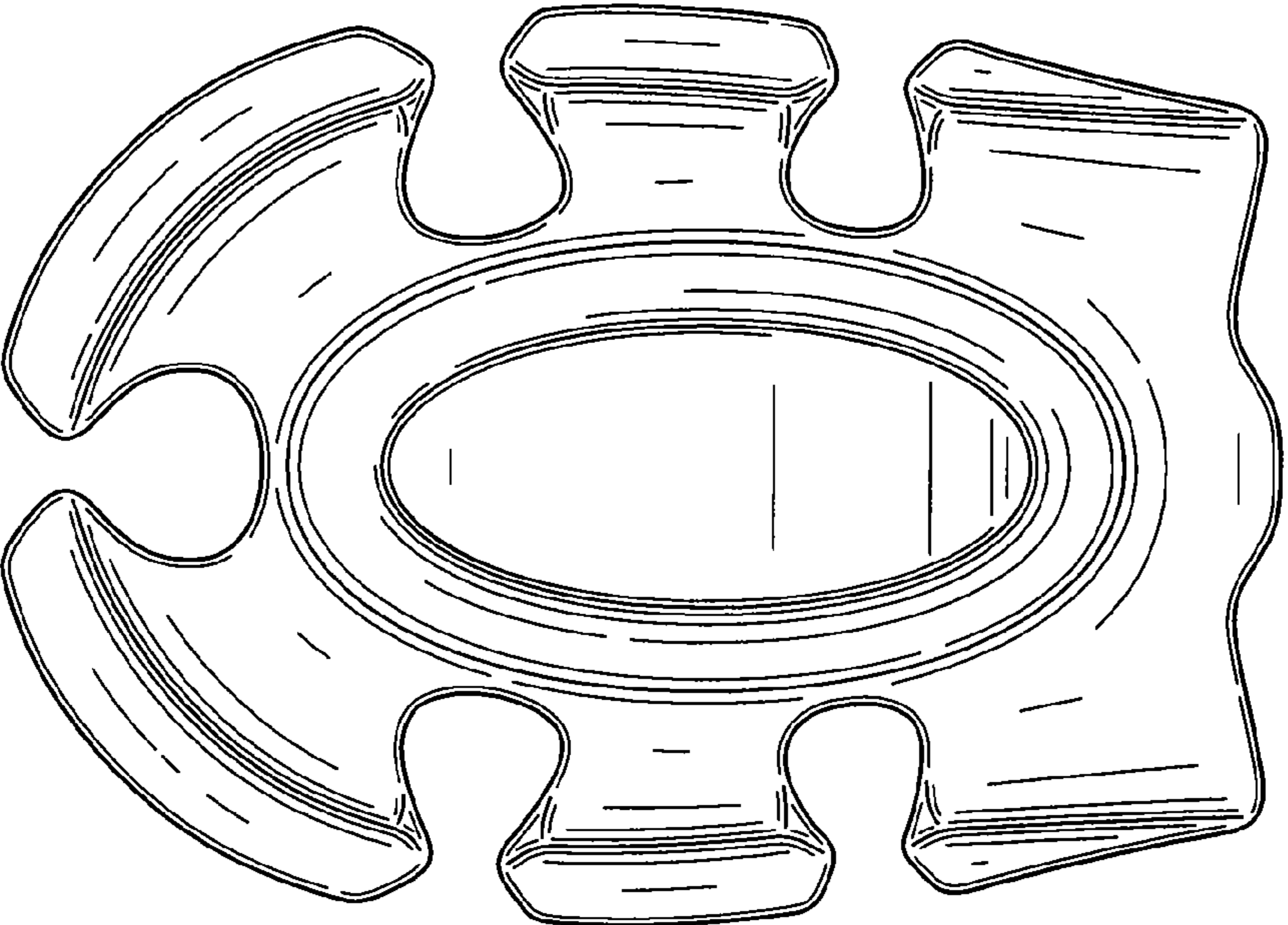

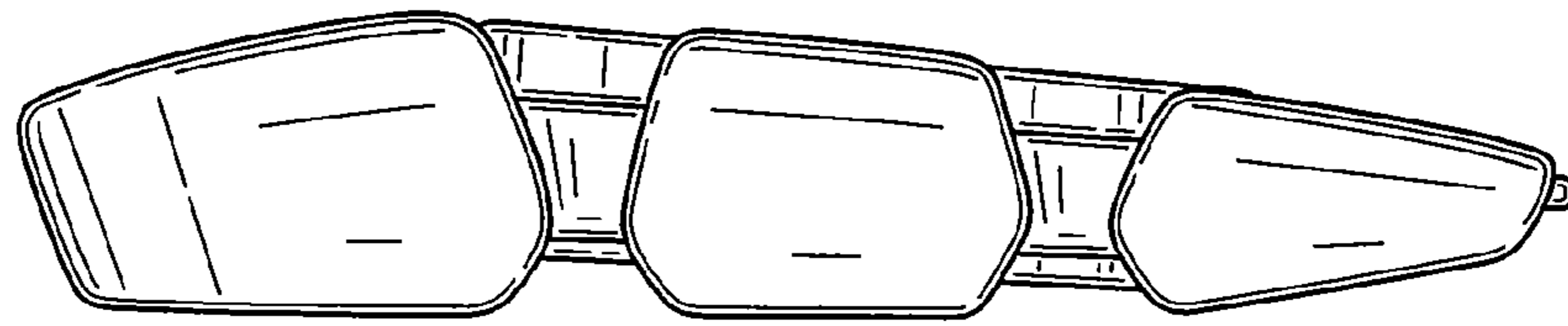

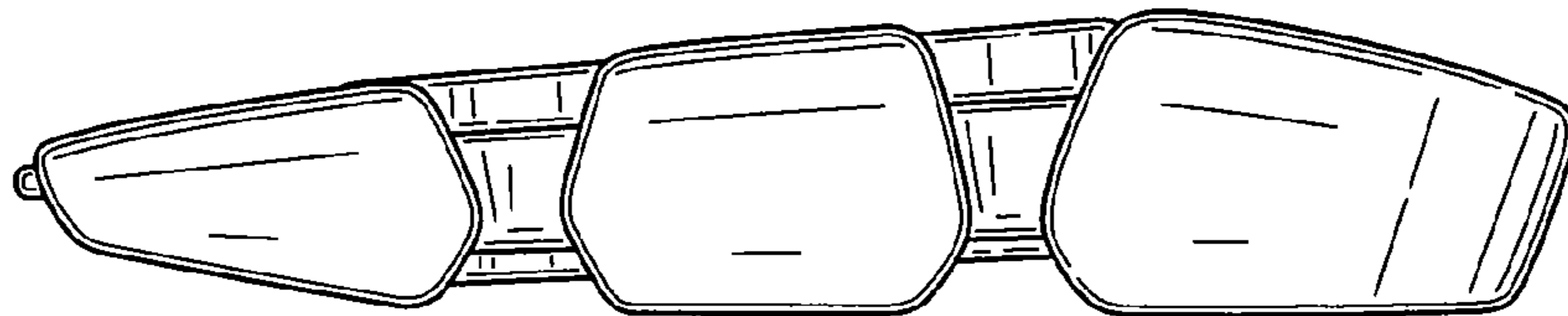

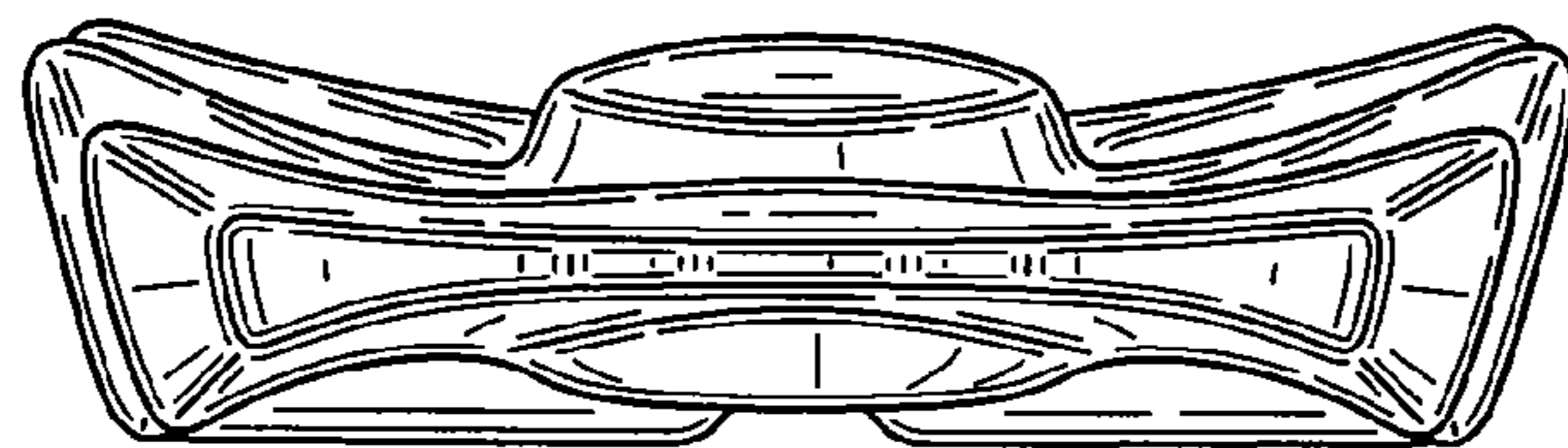

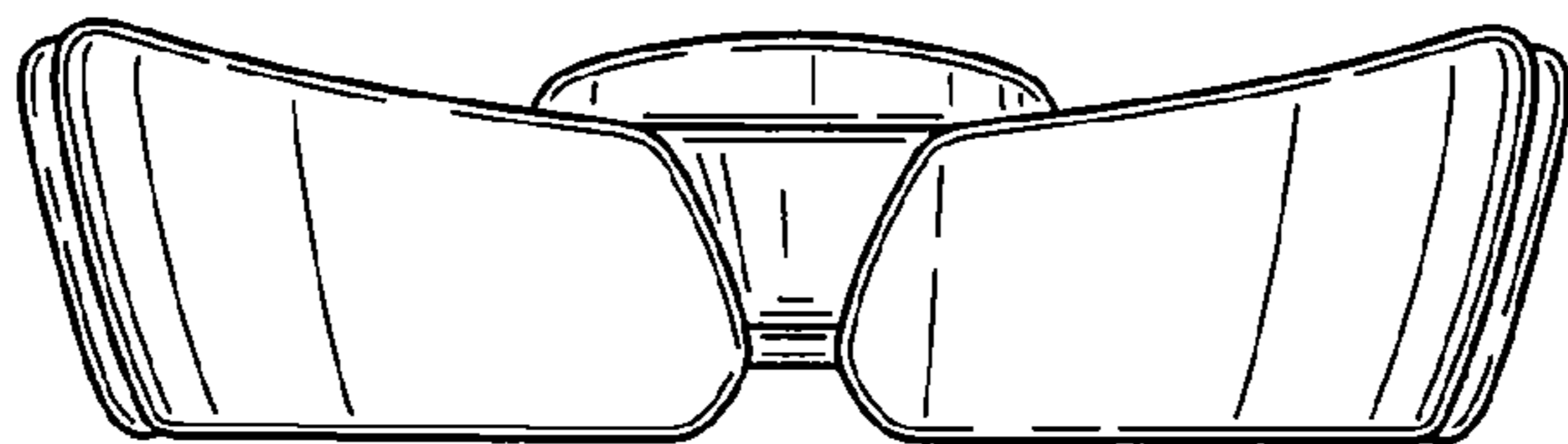
