DESCRIPTION

FIG. 1 illustrates a front perspective view of the dispenser tower;

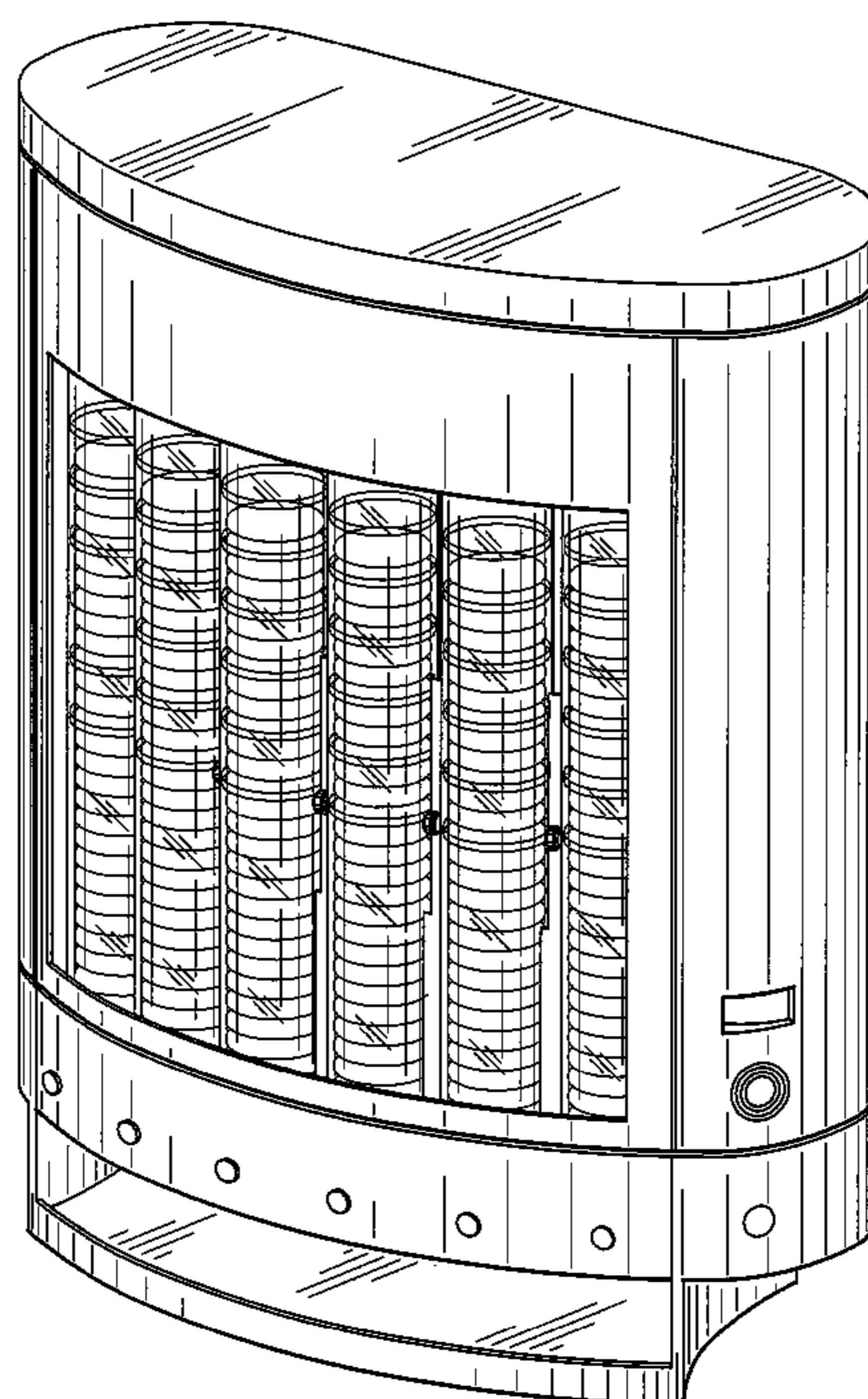

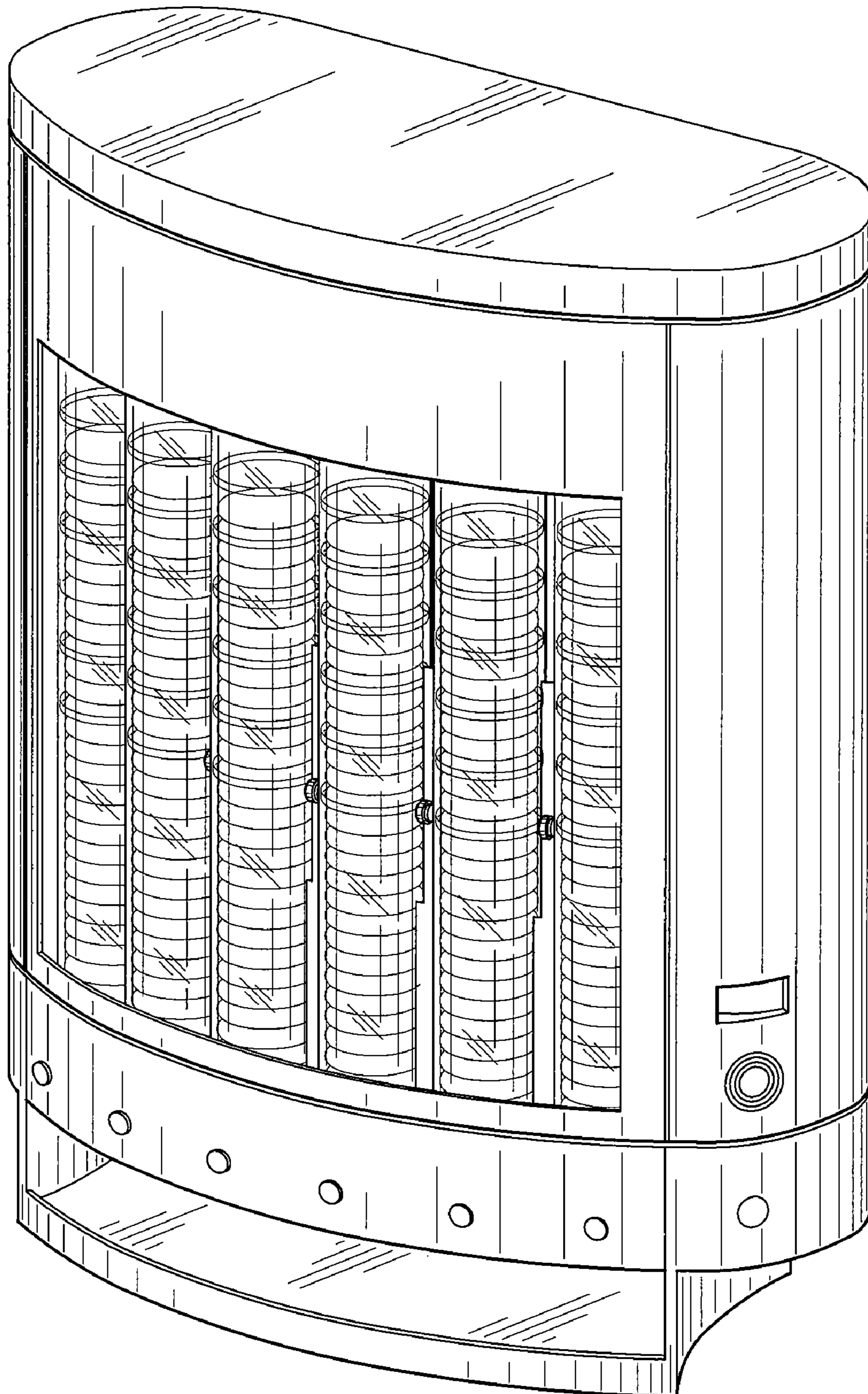

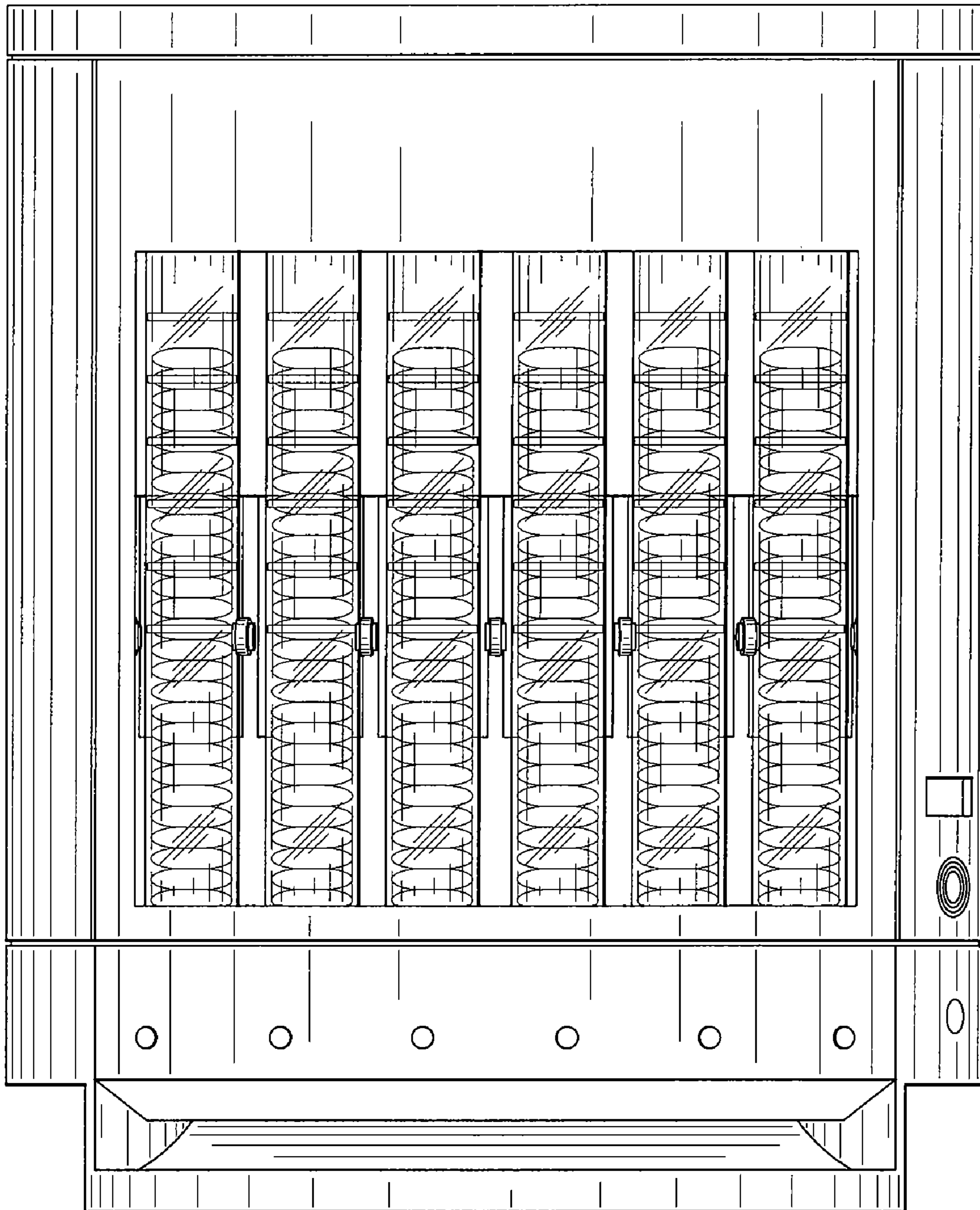

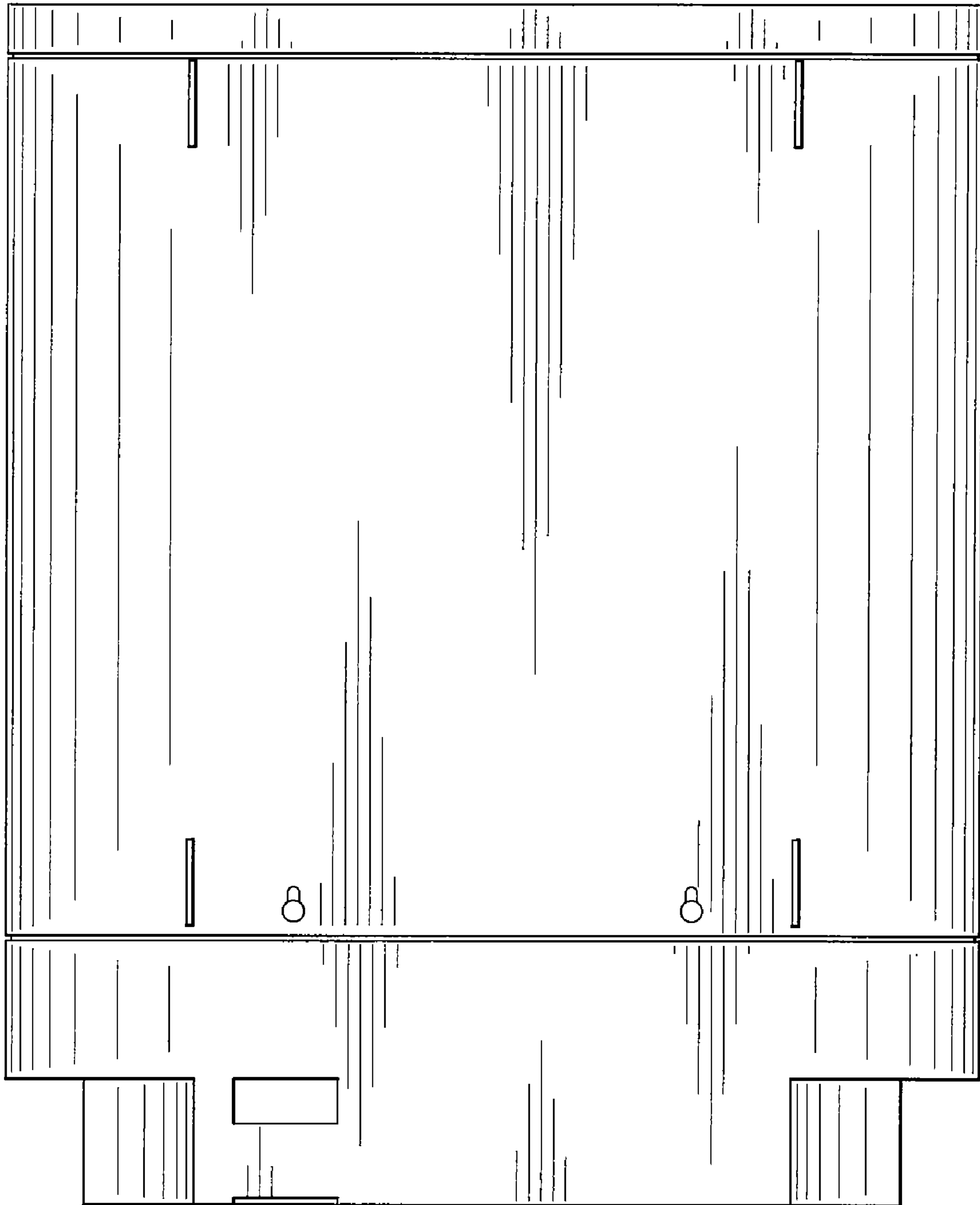

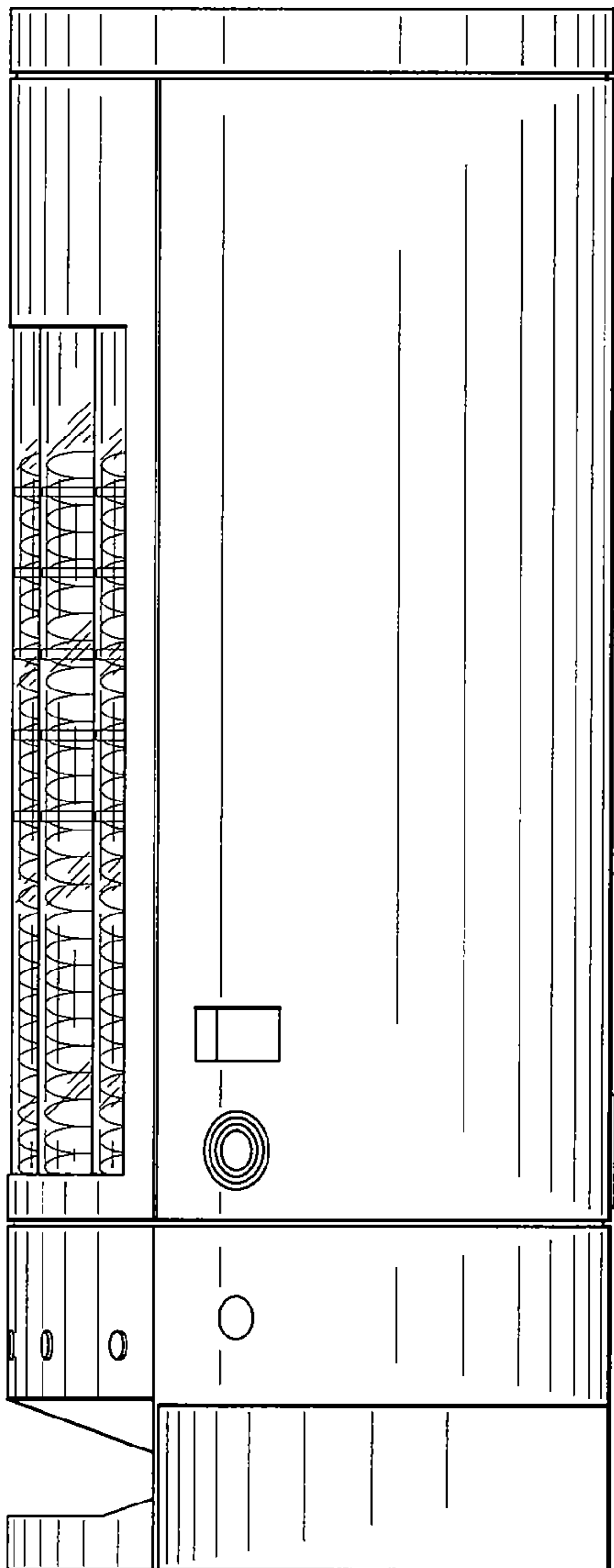

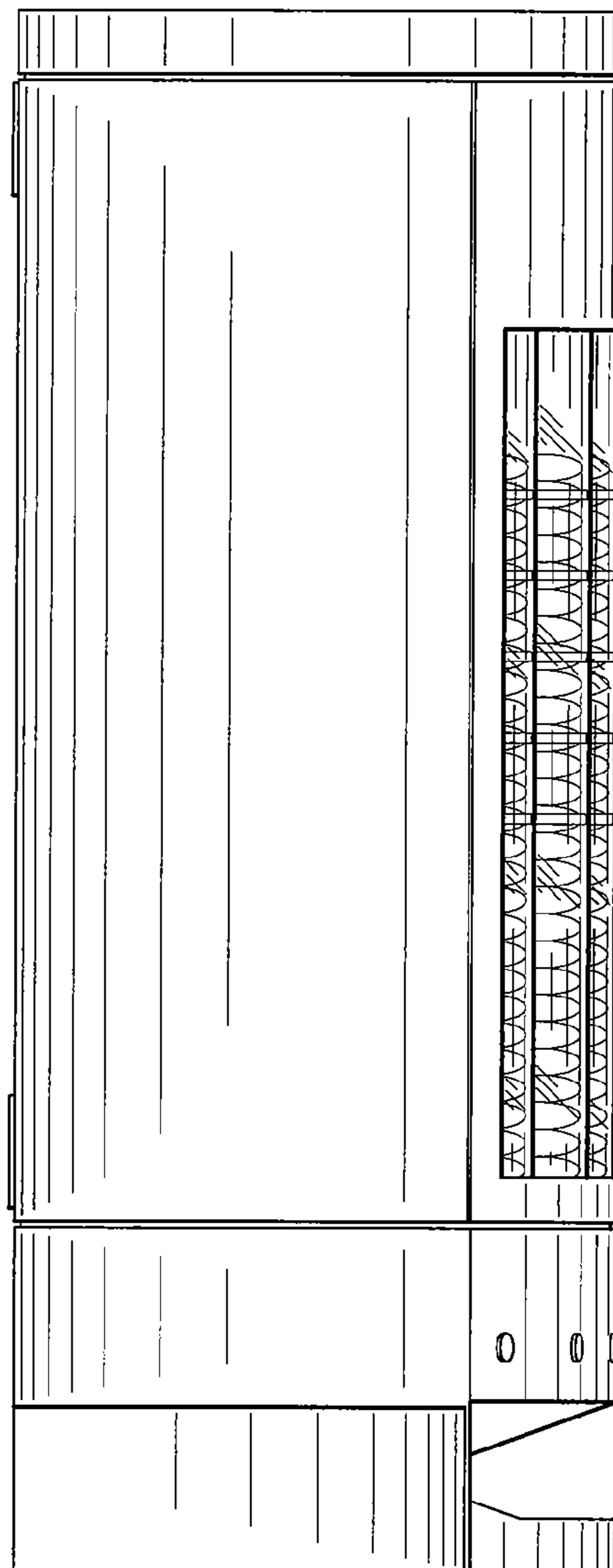

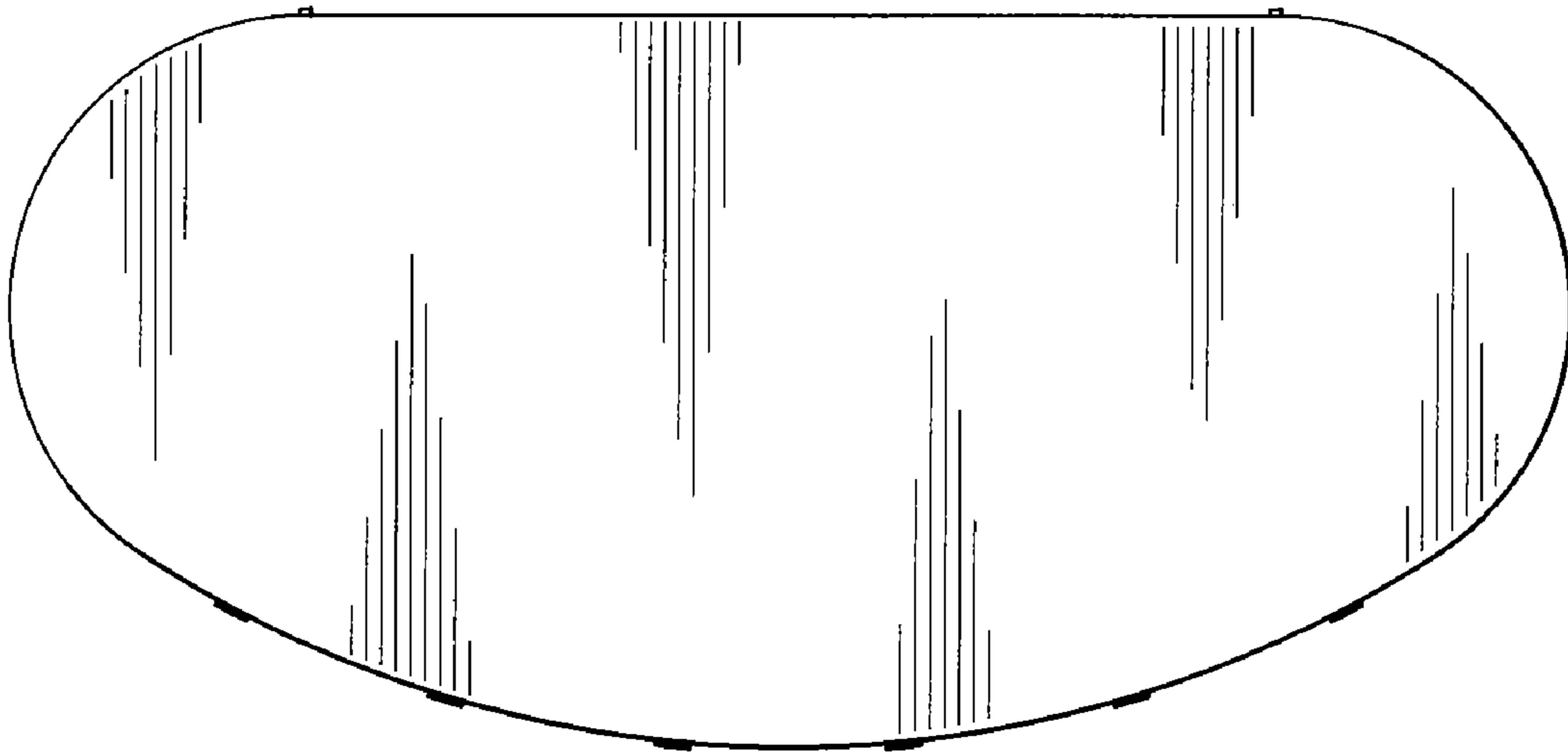
