The ornamental design for a set of support legs, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a set of support legs showing our new design.

FIG. 2 is a top plan view thereof.

FIG. 3 is a bottom plan view thereof.

FIG. 4 is a front elevational view thereof, the rear elevational view being an identical view thereof.

FIG. 5 is a left side elevational view thereof, the right side elevational view being an identical view thereof.

FIG. 6 is a perspective view of a second embodiment thereof.

FIG. 7 is a top plan view thereof.

FIG. 8 is a bottom plan view thereof.

FIG. 9 is a front elevational view thereof, the rear elevational view being an identical view thereof.

FIG. 10 is a left side elevational view thereof, the right side elevational view being an identical view thereof.

FIG. 11 is a left side elevational sectional view thereof taken along the 11—11 sectional line of FIG. 7, the right side elevational sectional view being an identical view thereof taken along the 11—11 sectional line of FIG. 8.

FIG. 12 is a perspective view of a third embodiment thereof.

FIG. 13 is a top plan view thereof.

FIG. 14 is a bottom plan view thereof.

FIG. 15 is a front elevational view thereof, the rear elevational view being an identical view thereof.

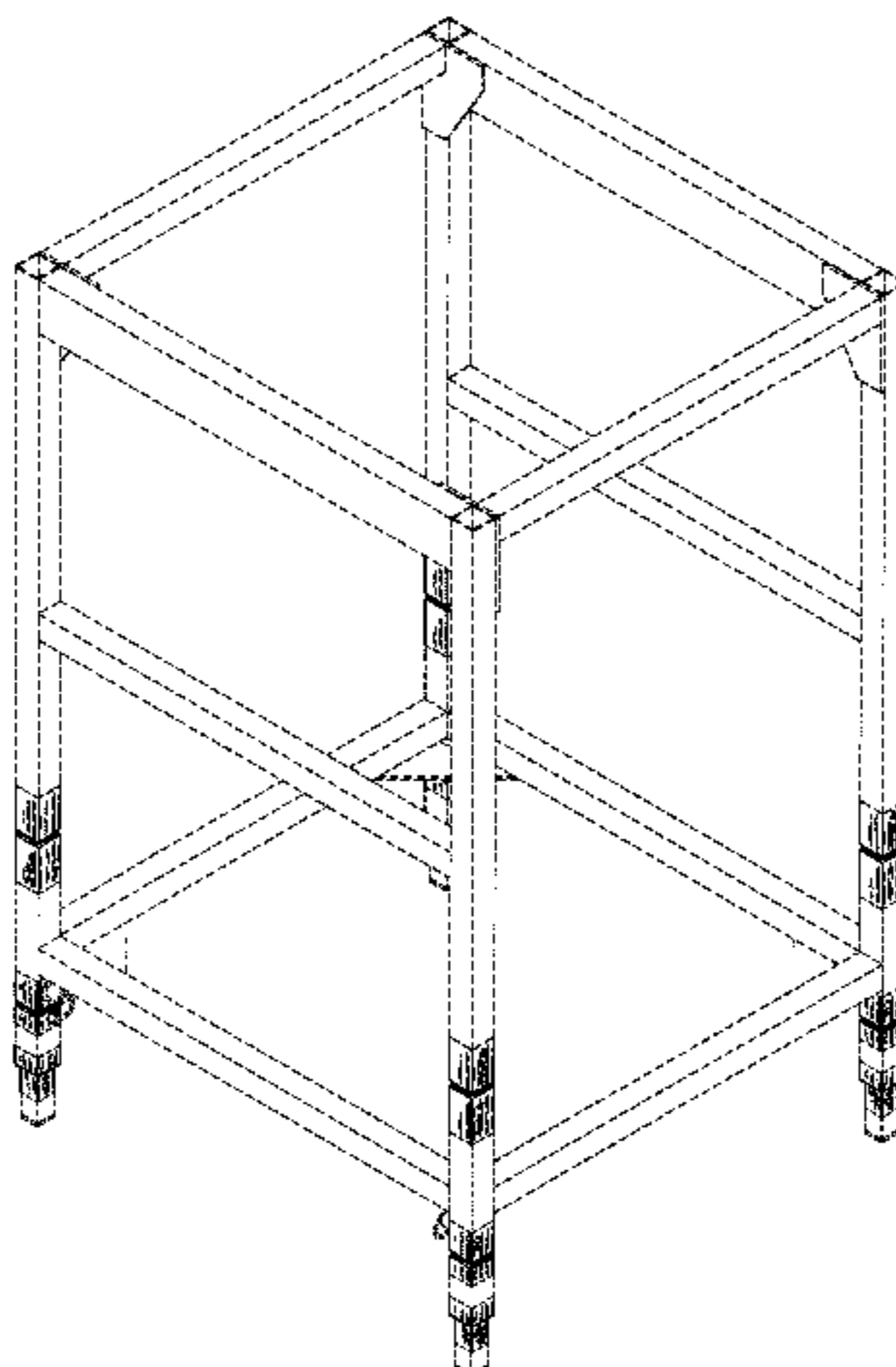
FIG. 16 is a left side elevational view thereof, the right side elevational view being an identical view thereof; and,

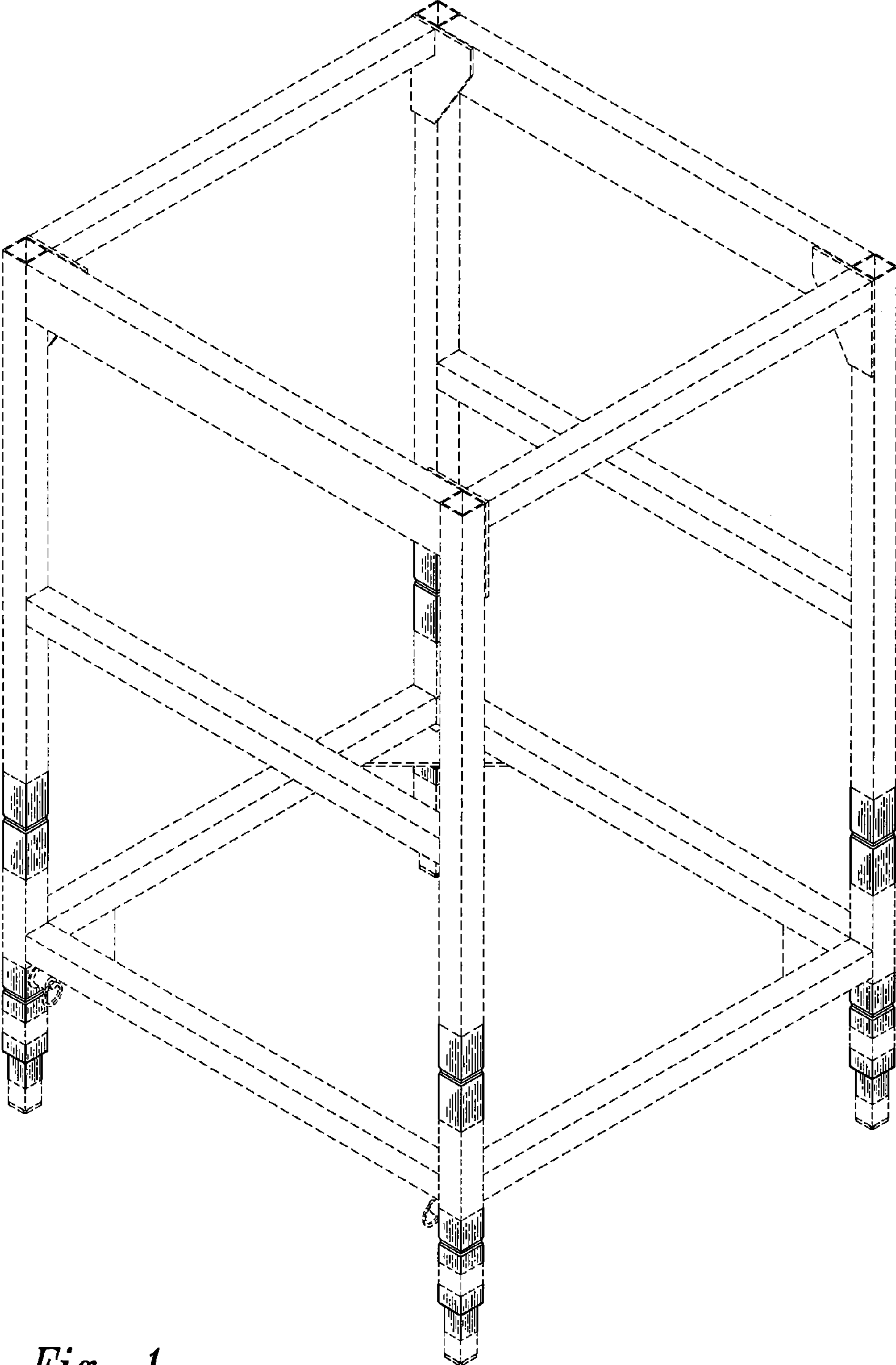

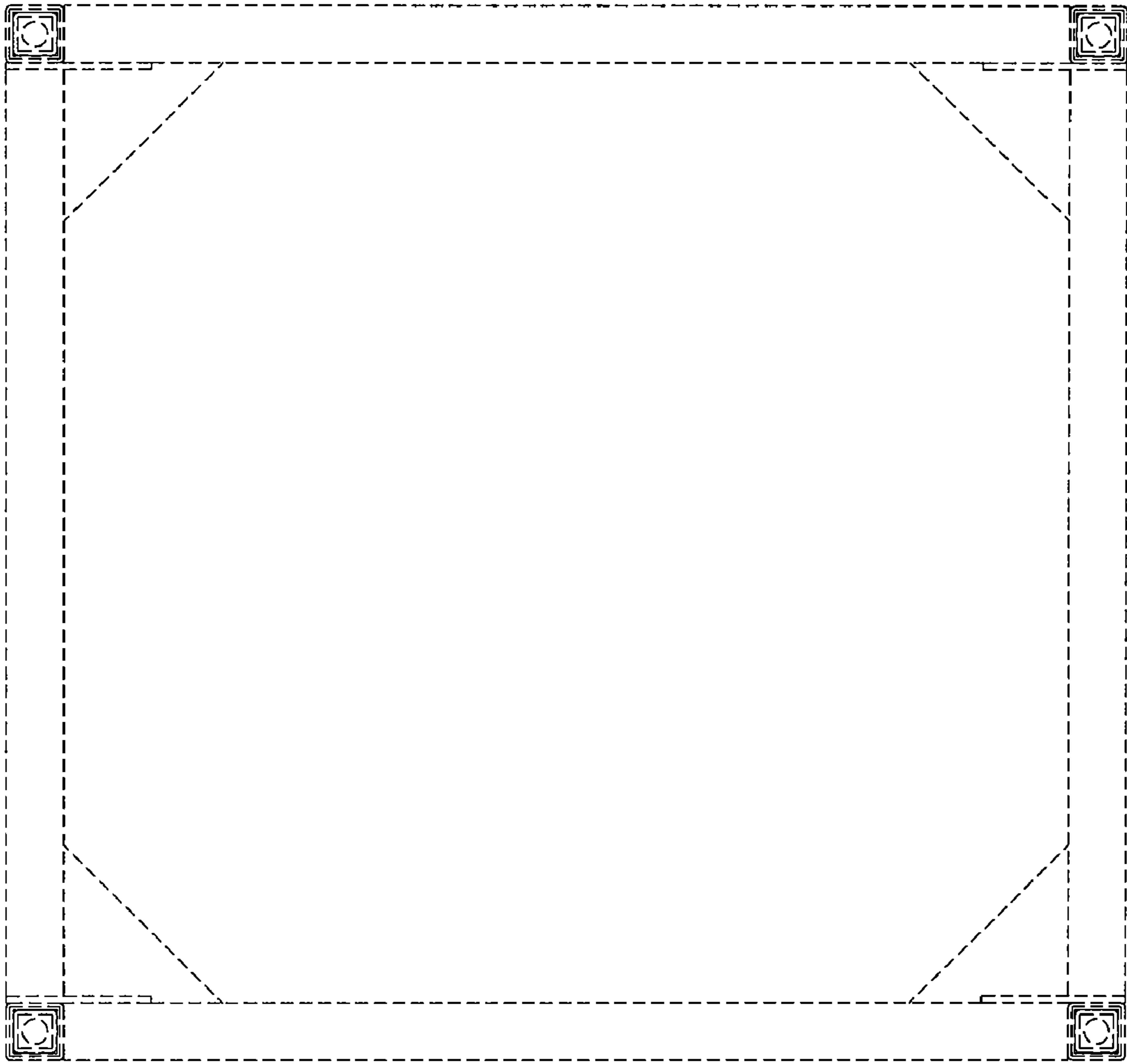

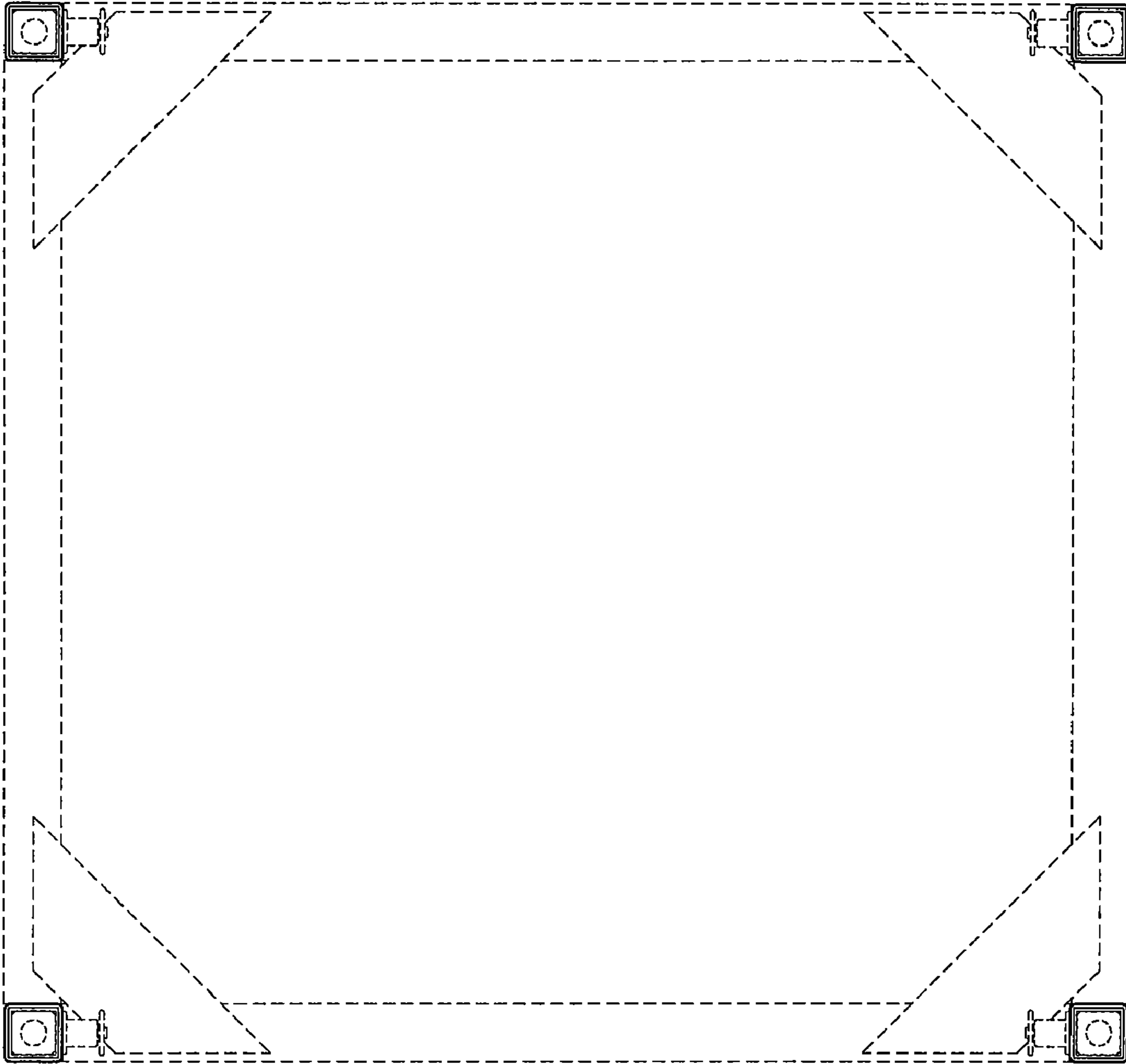

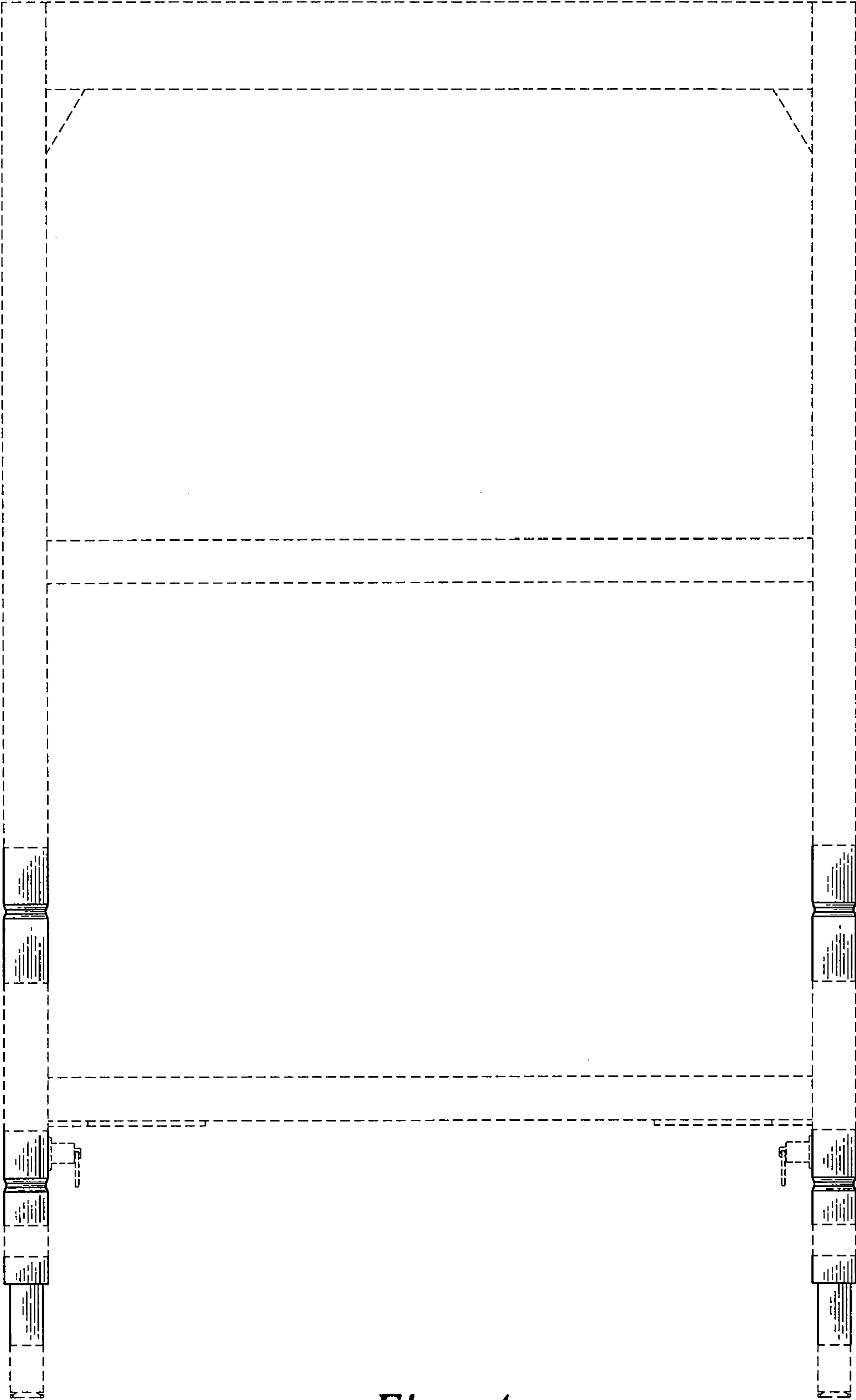

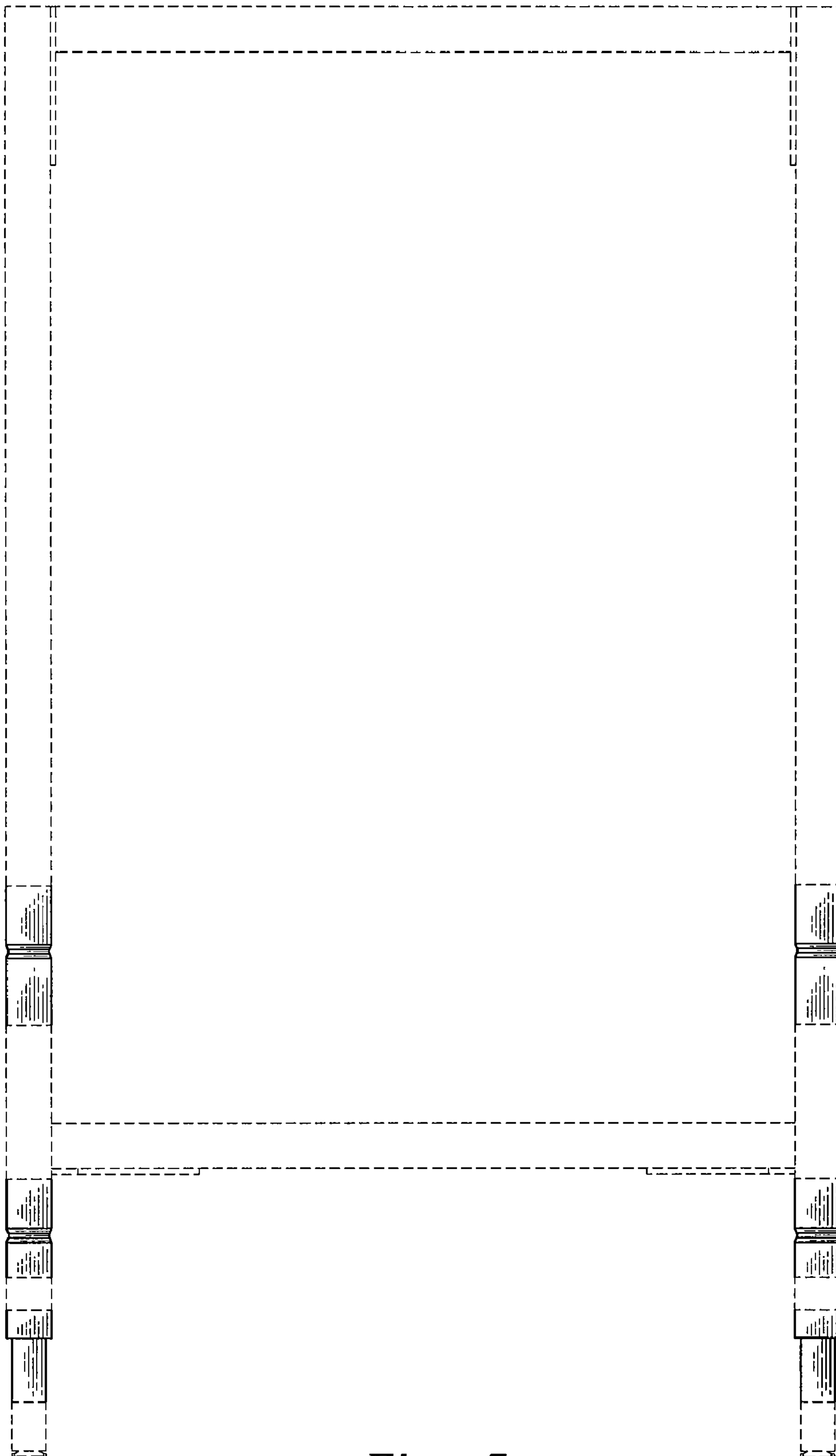

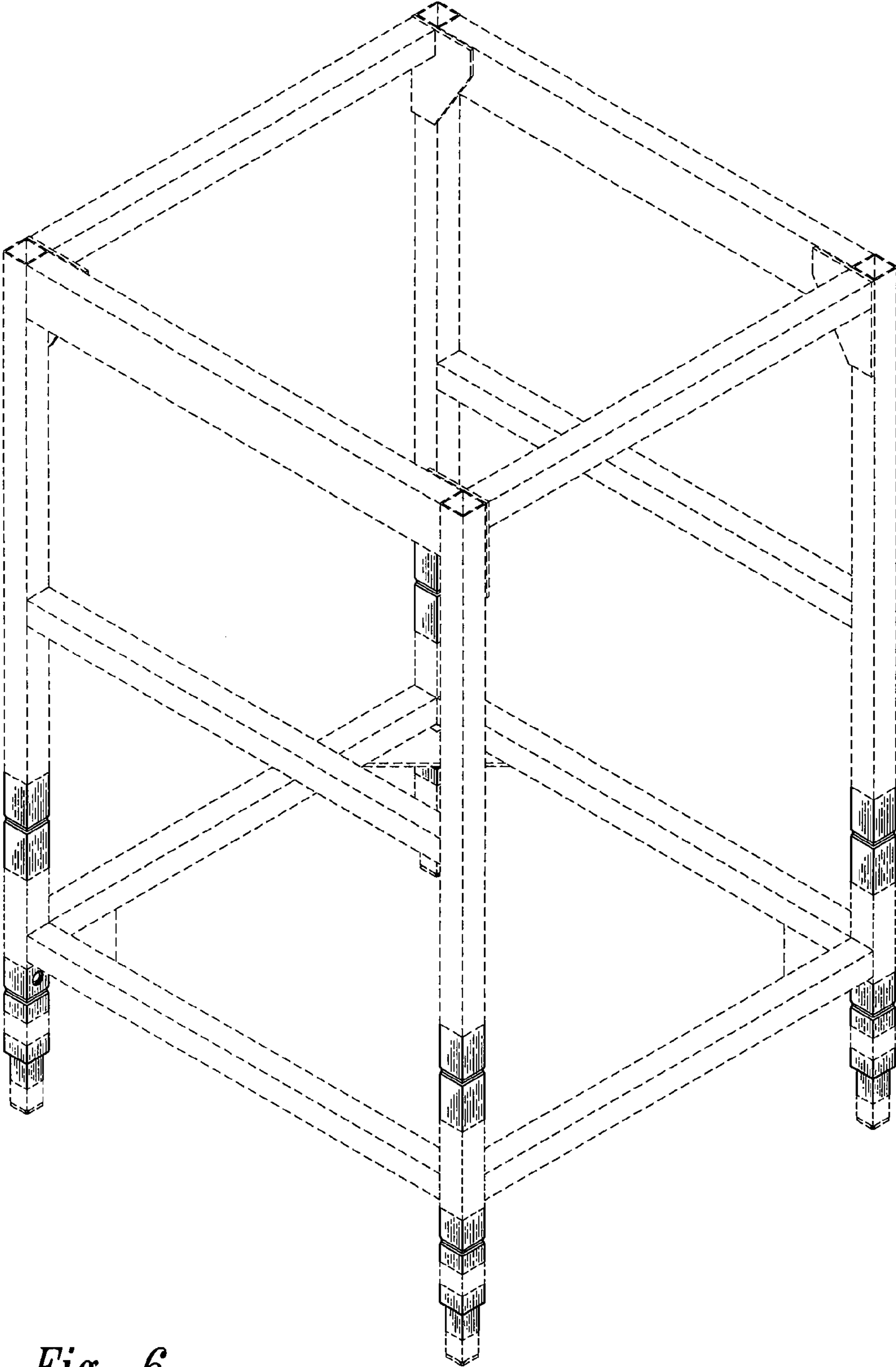

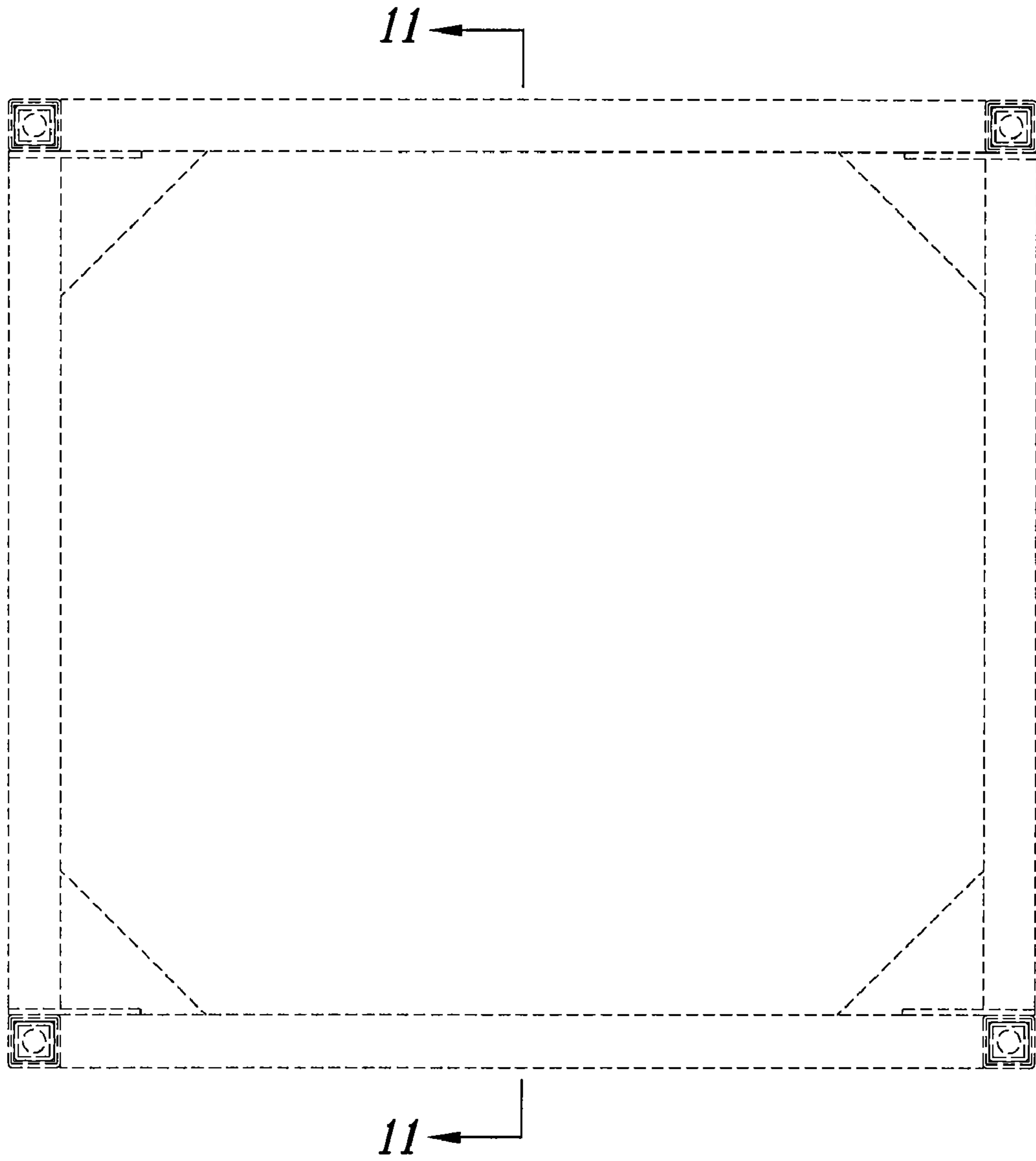

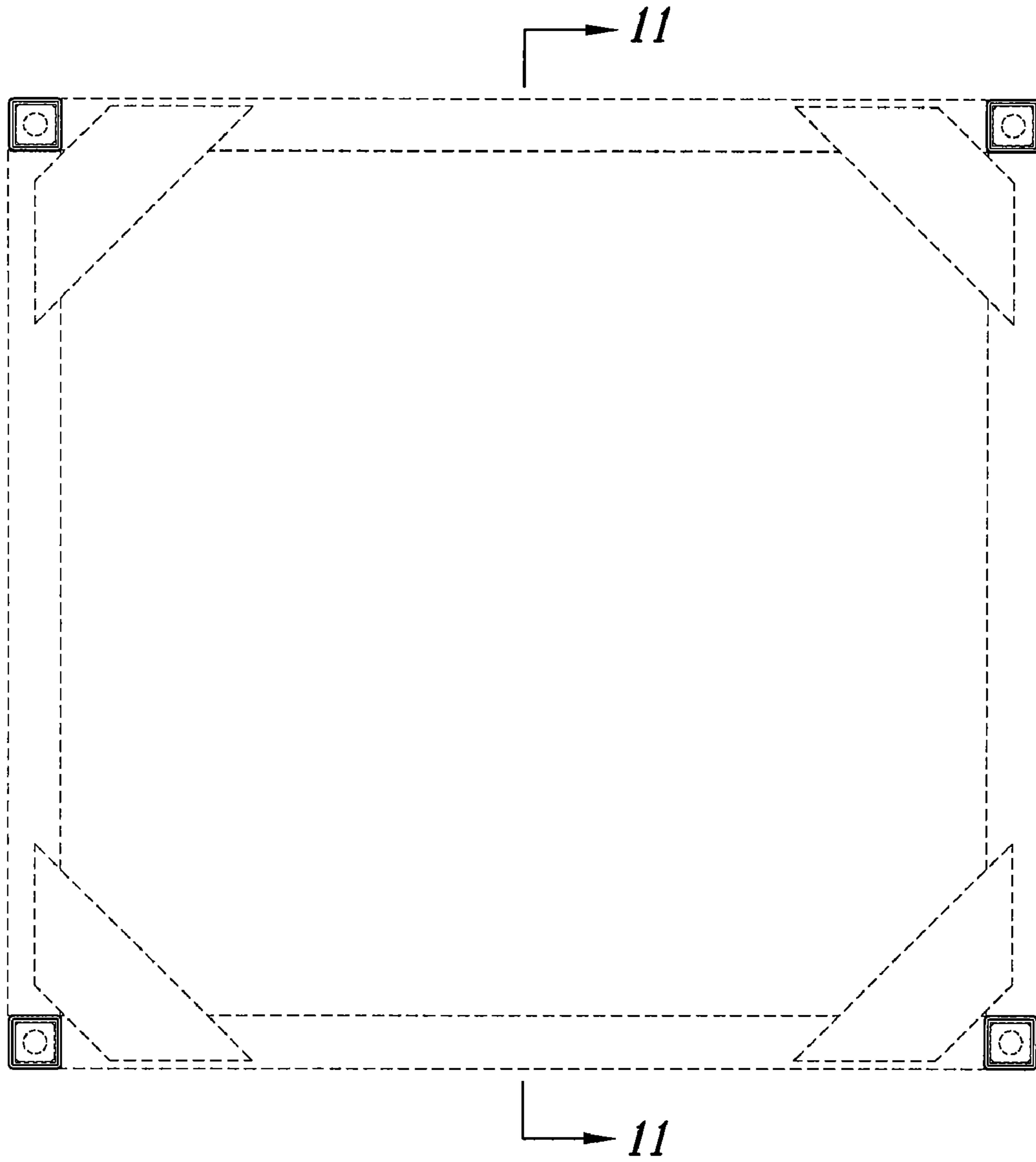

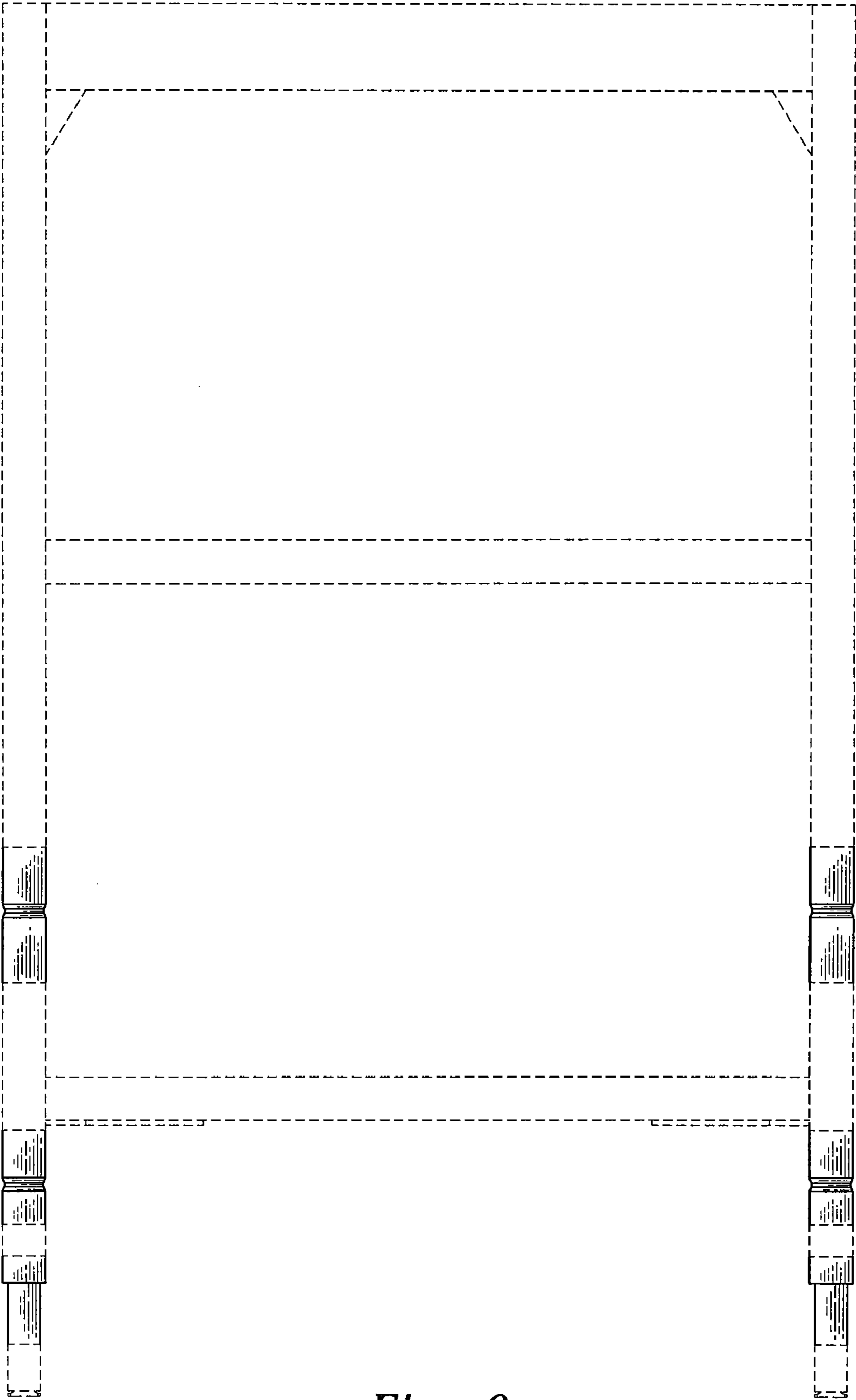

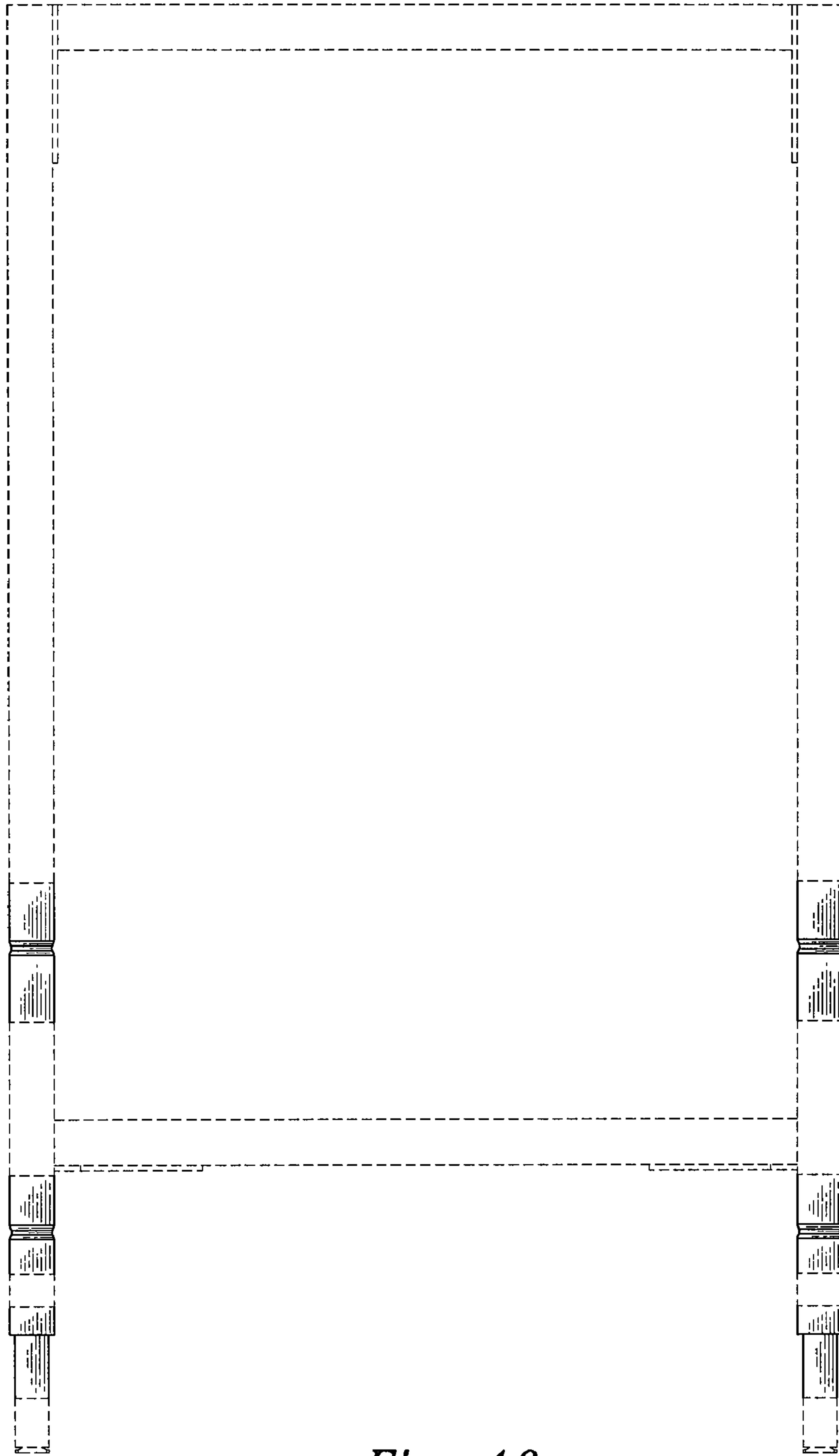

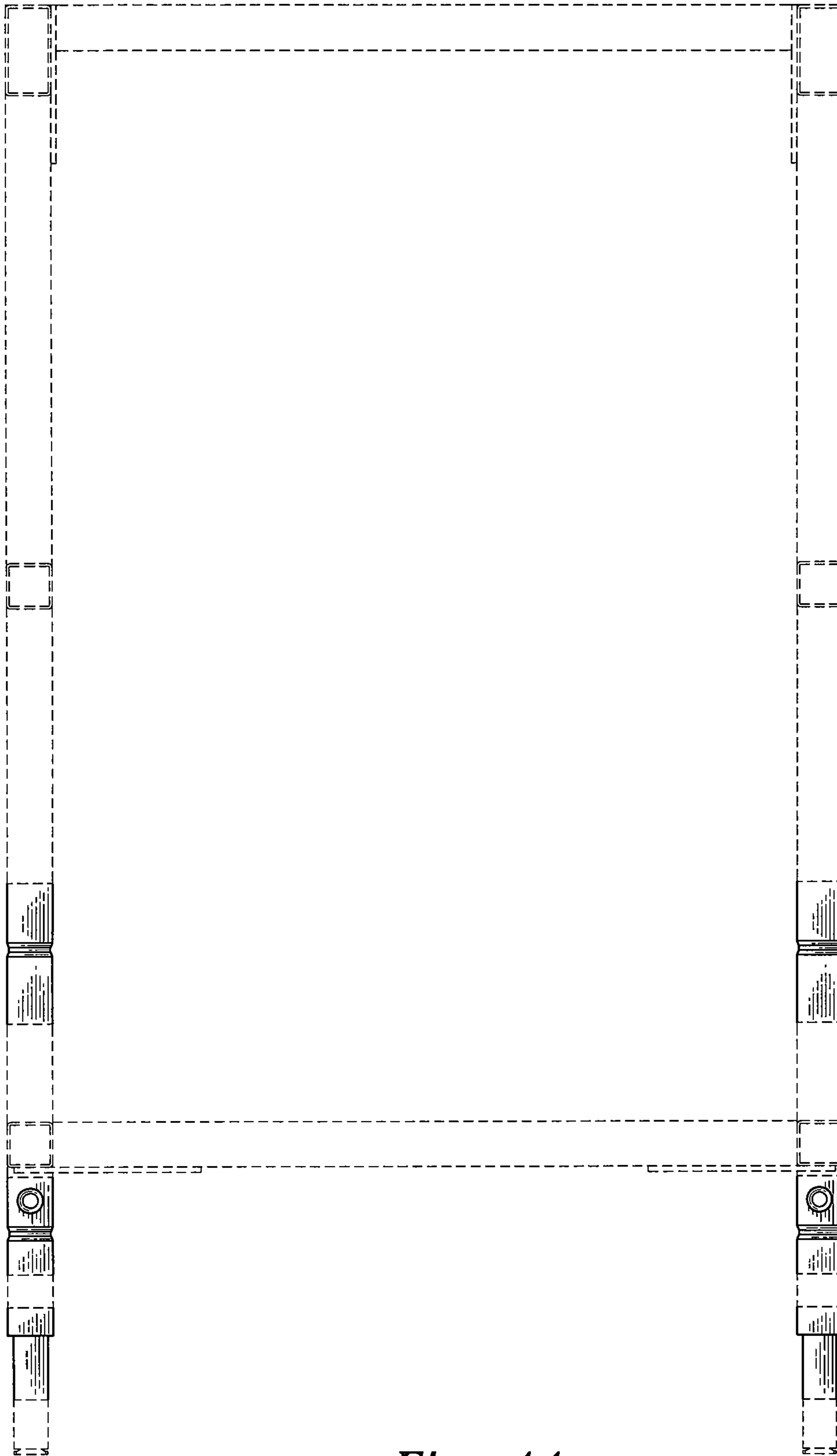

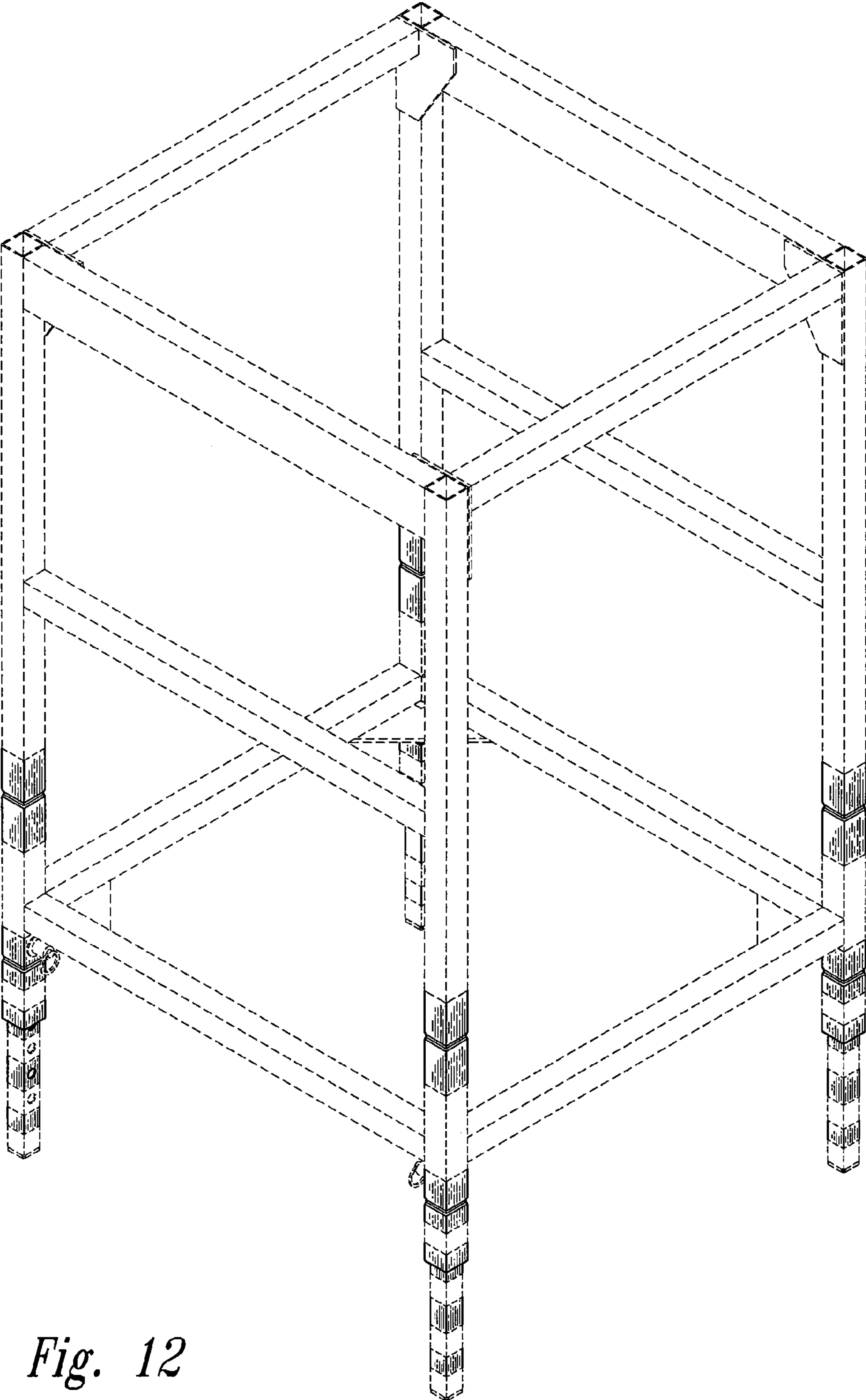

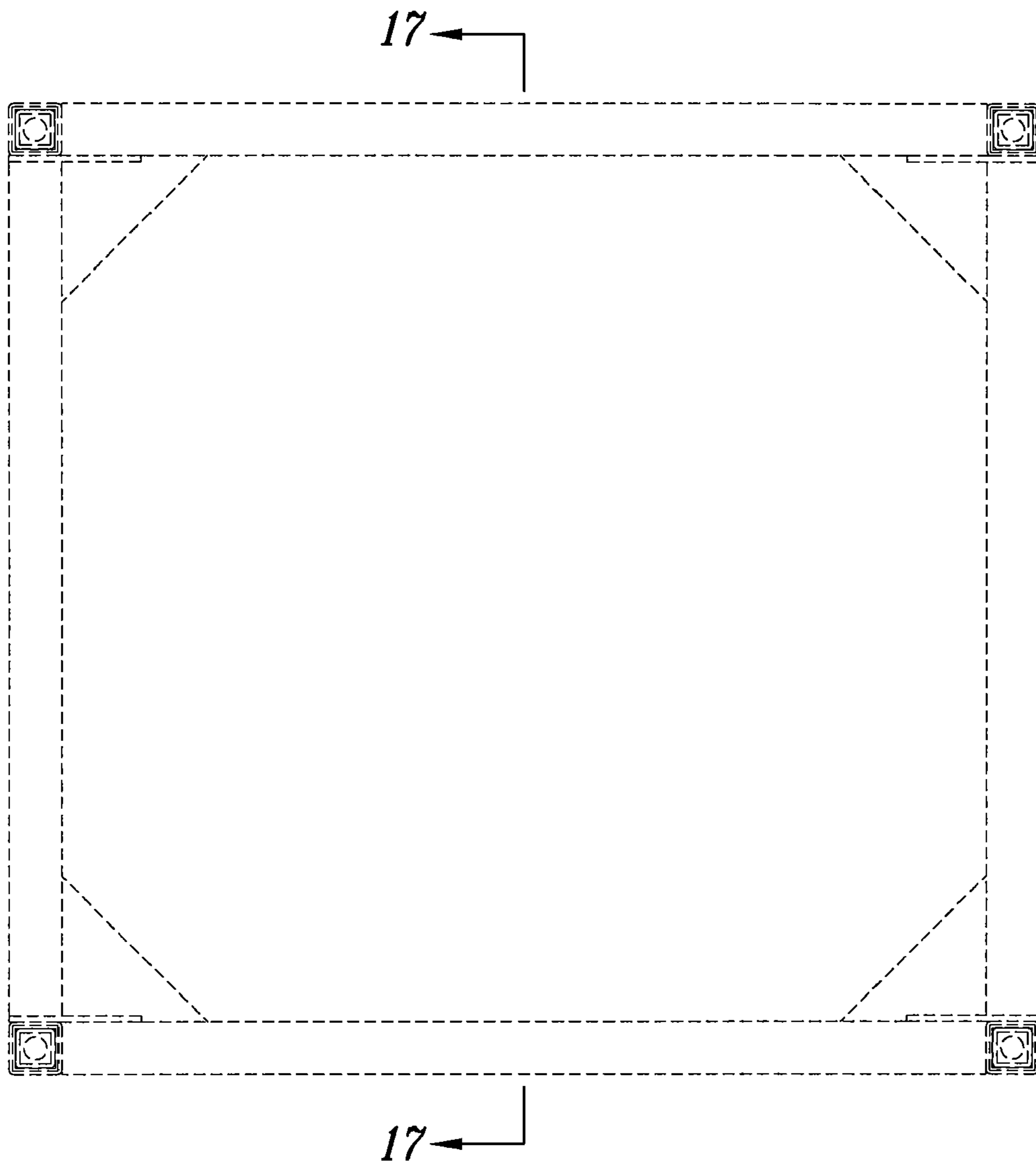

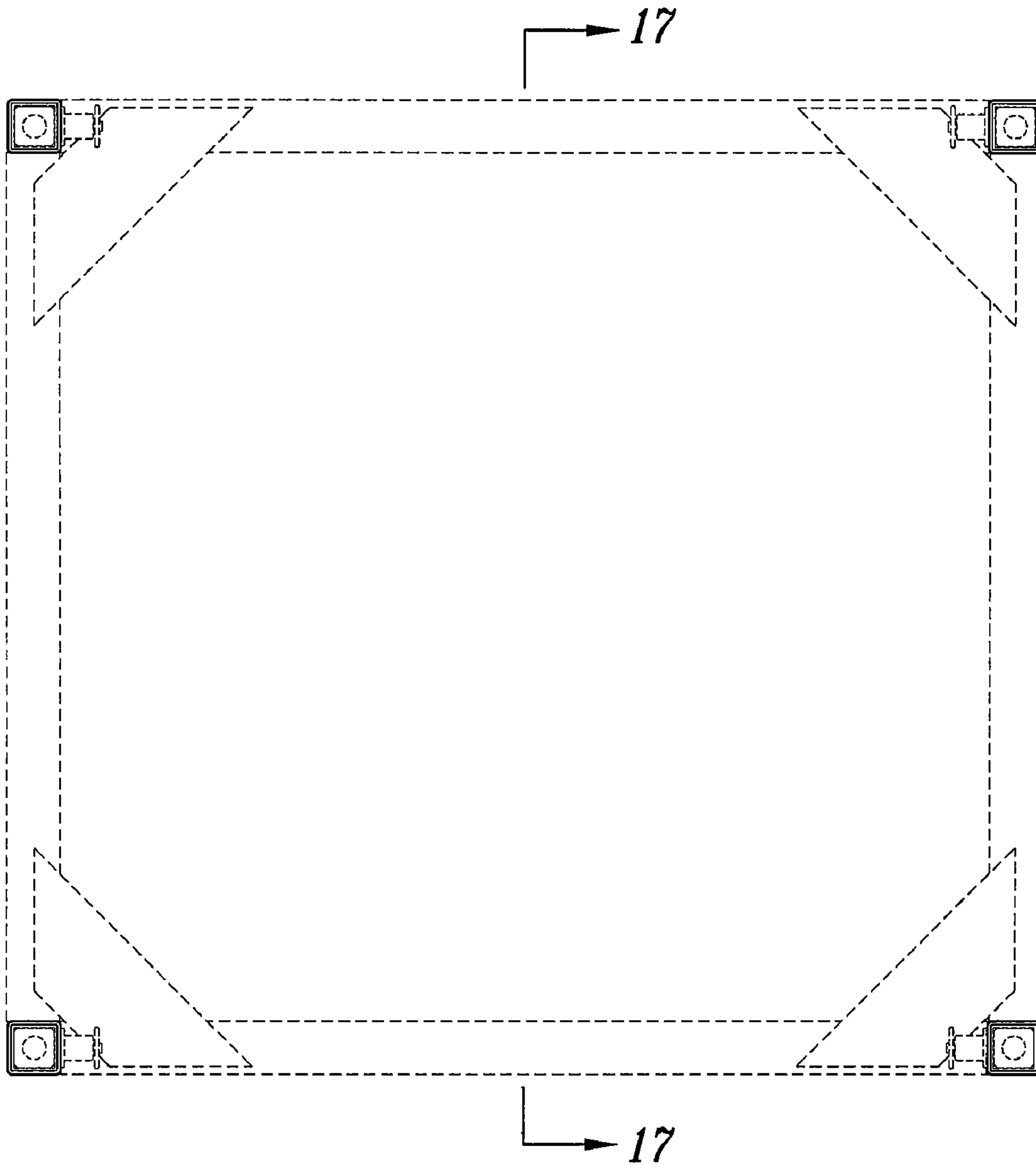

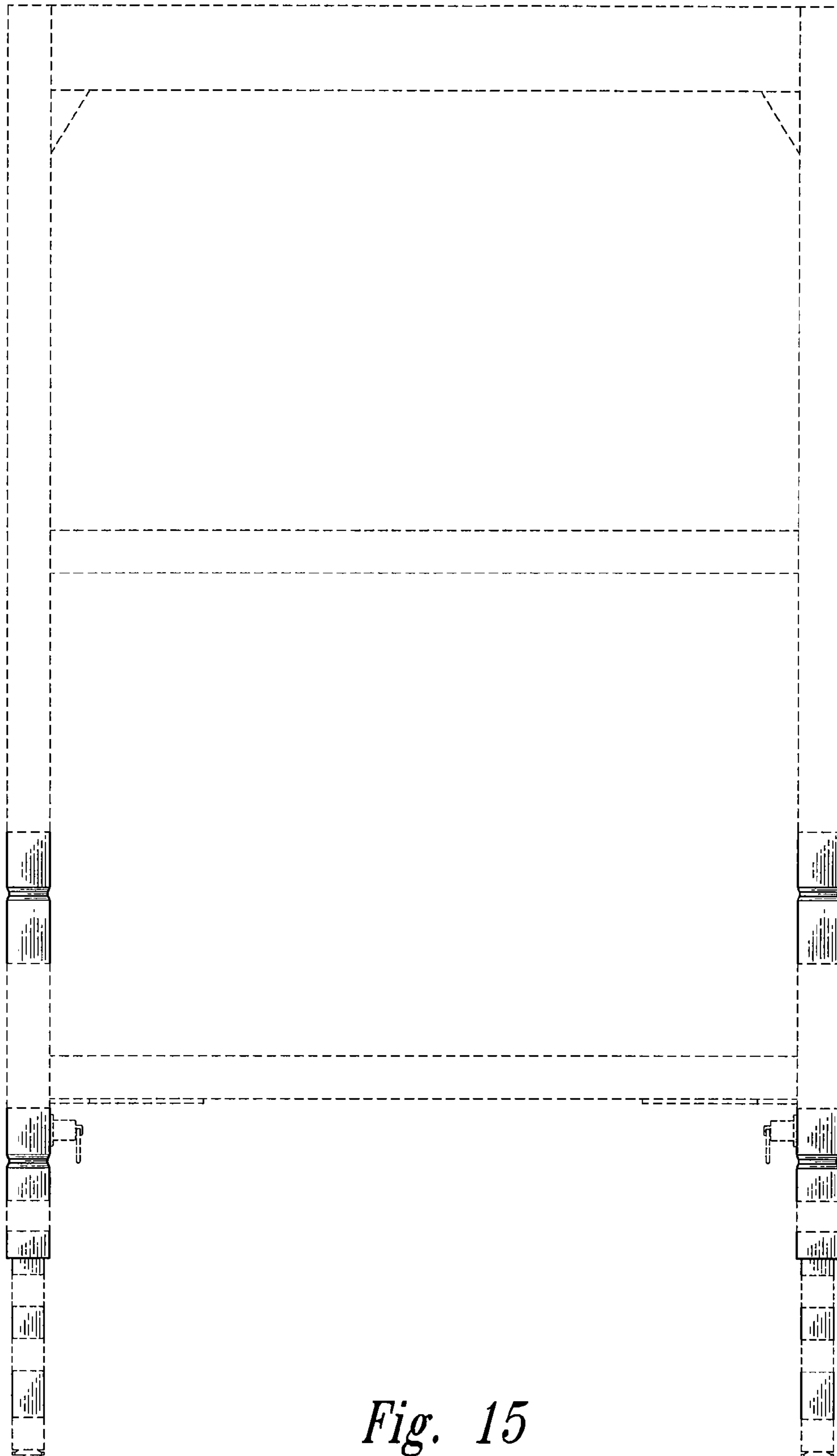

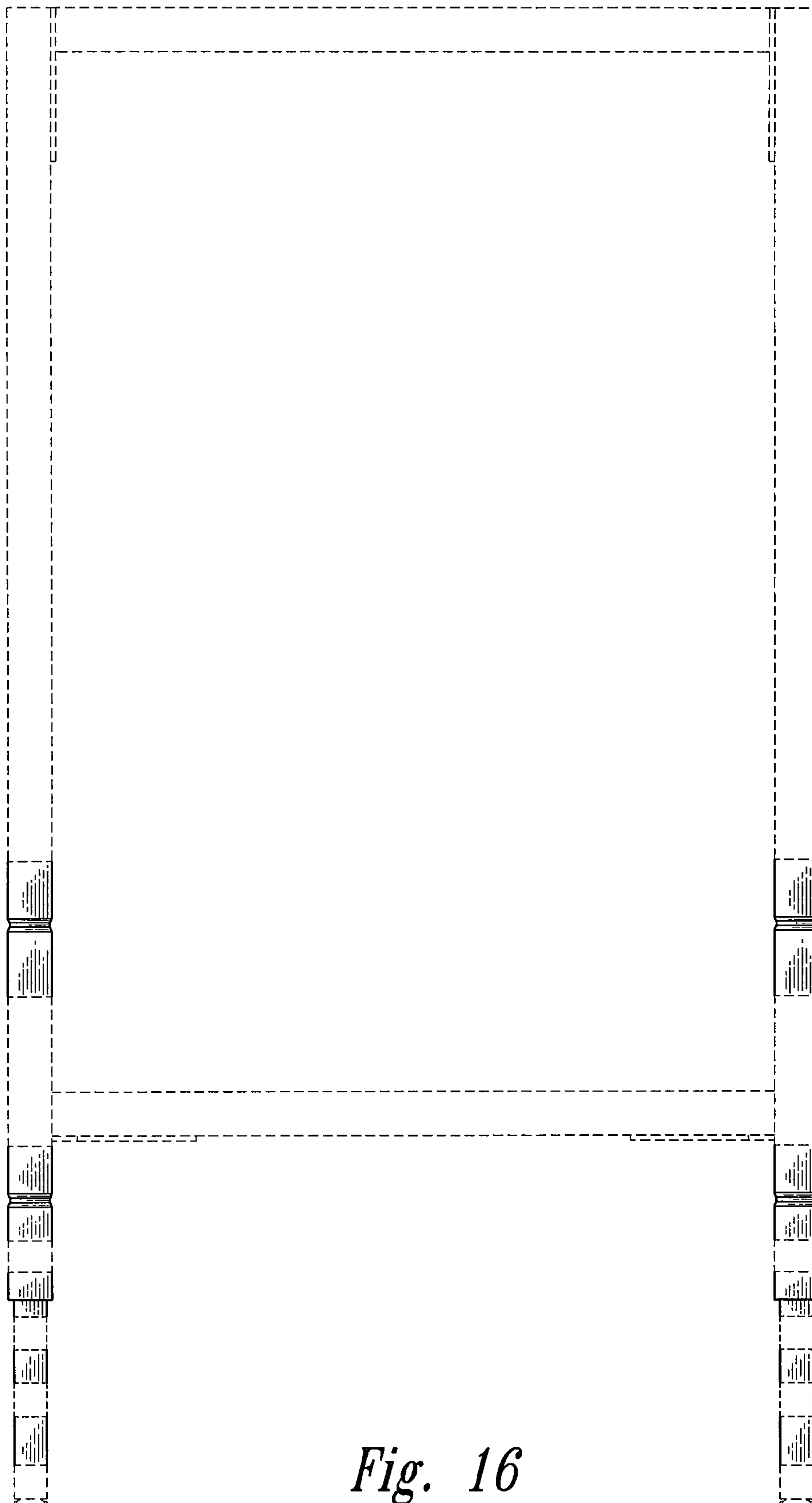

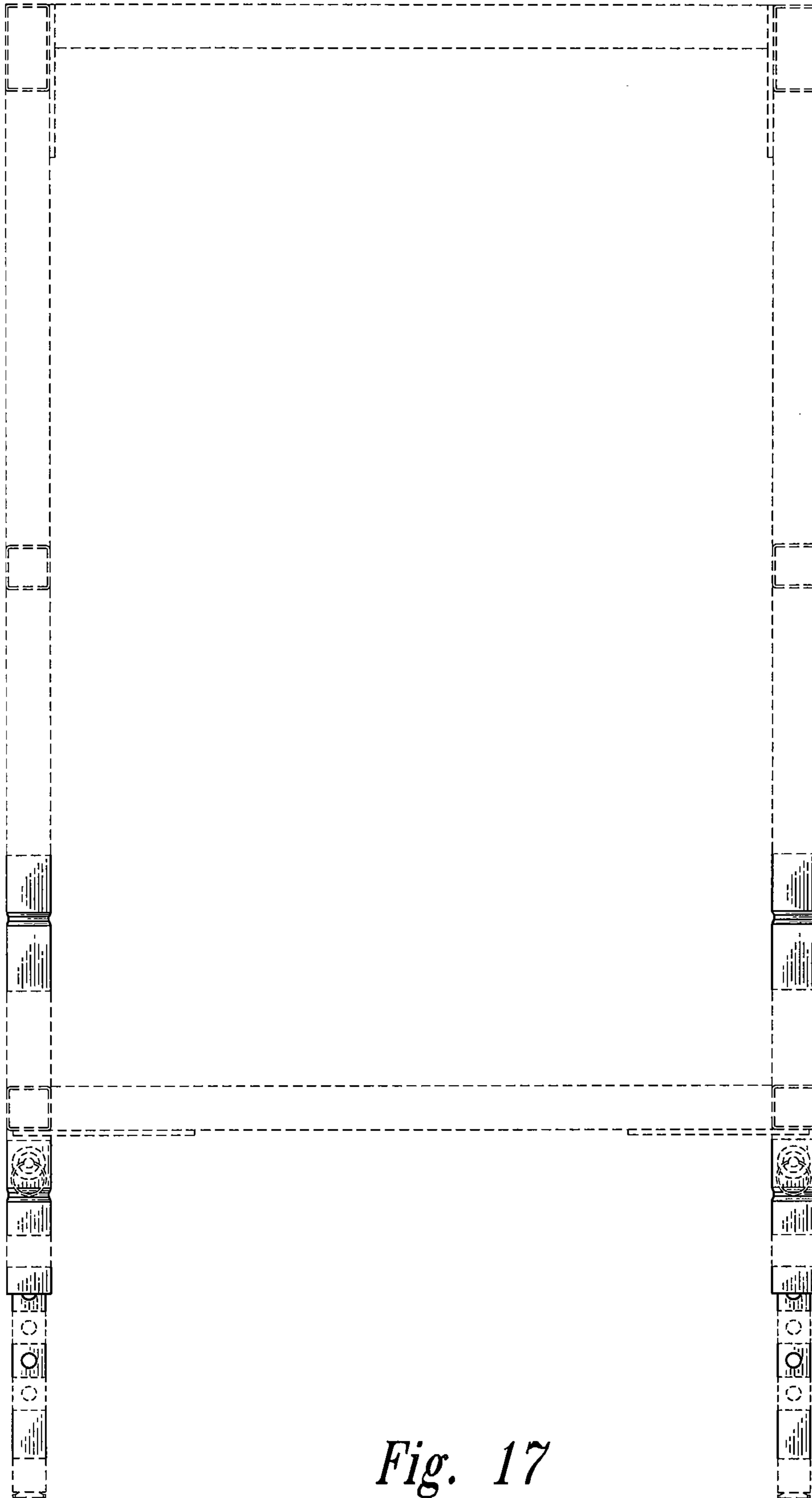
