FIG. 3 is the rear elevational view thereof;

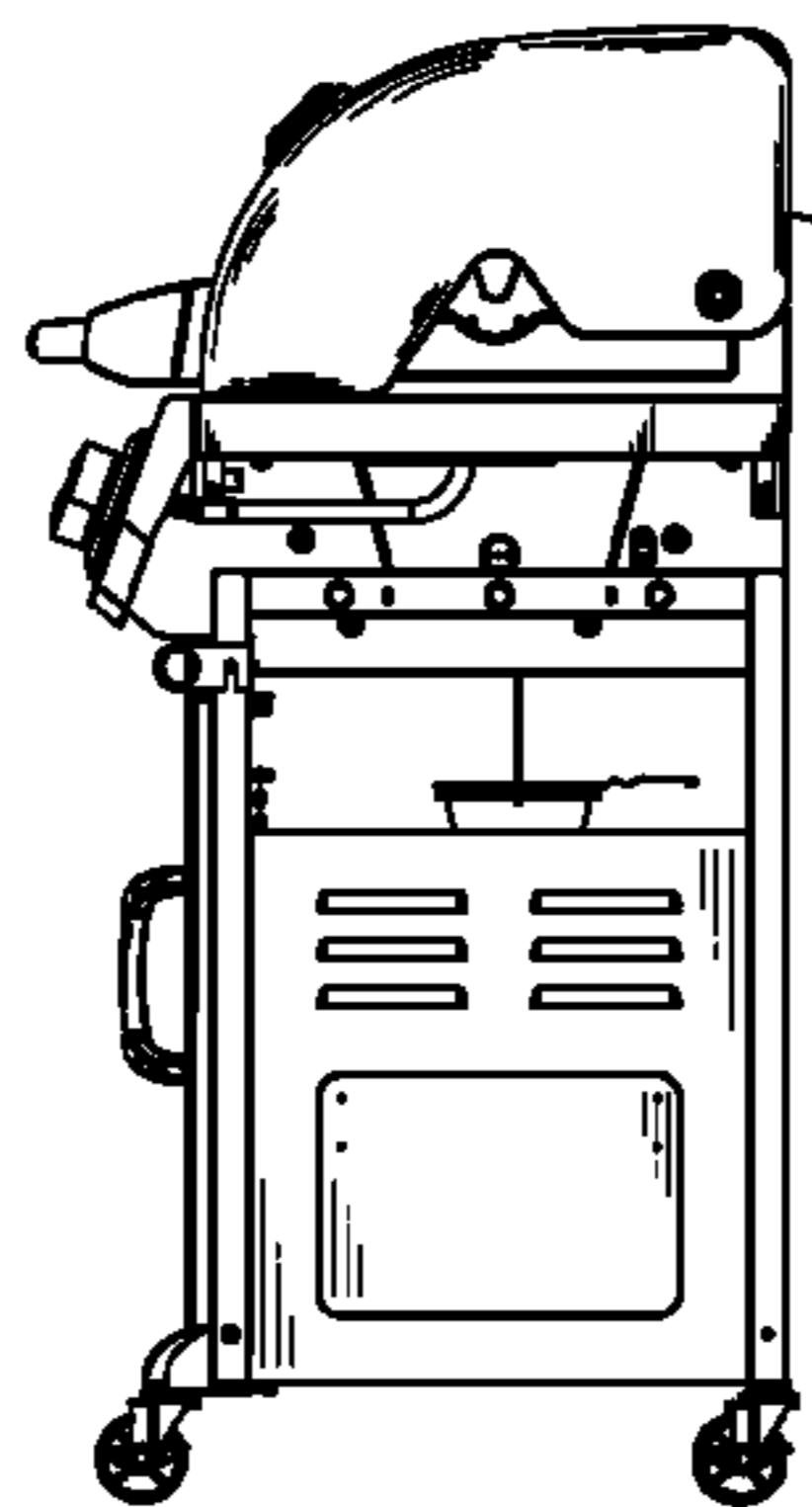
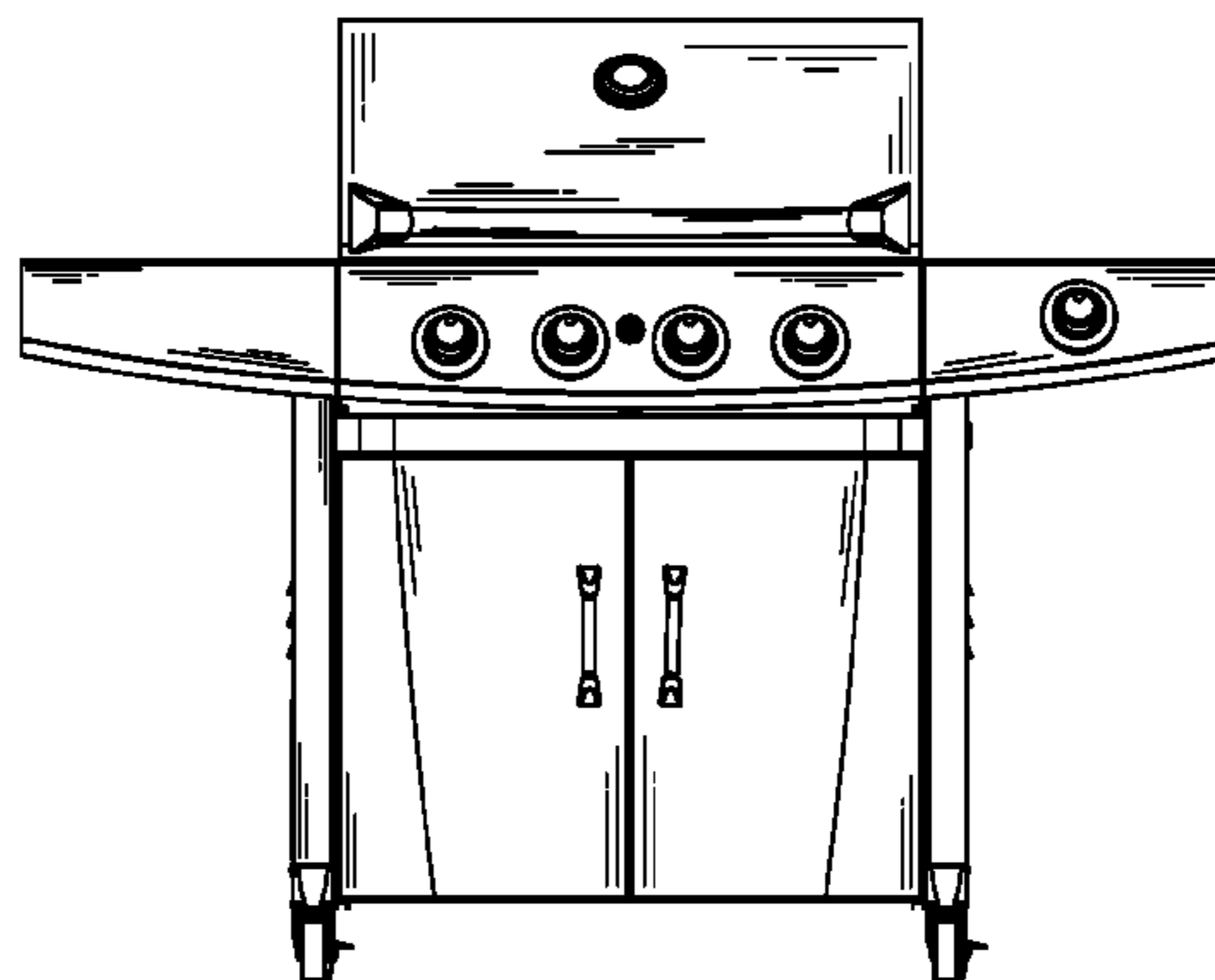
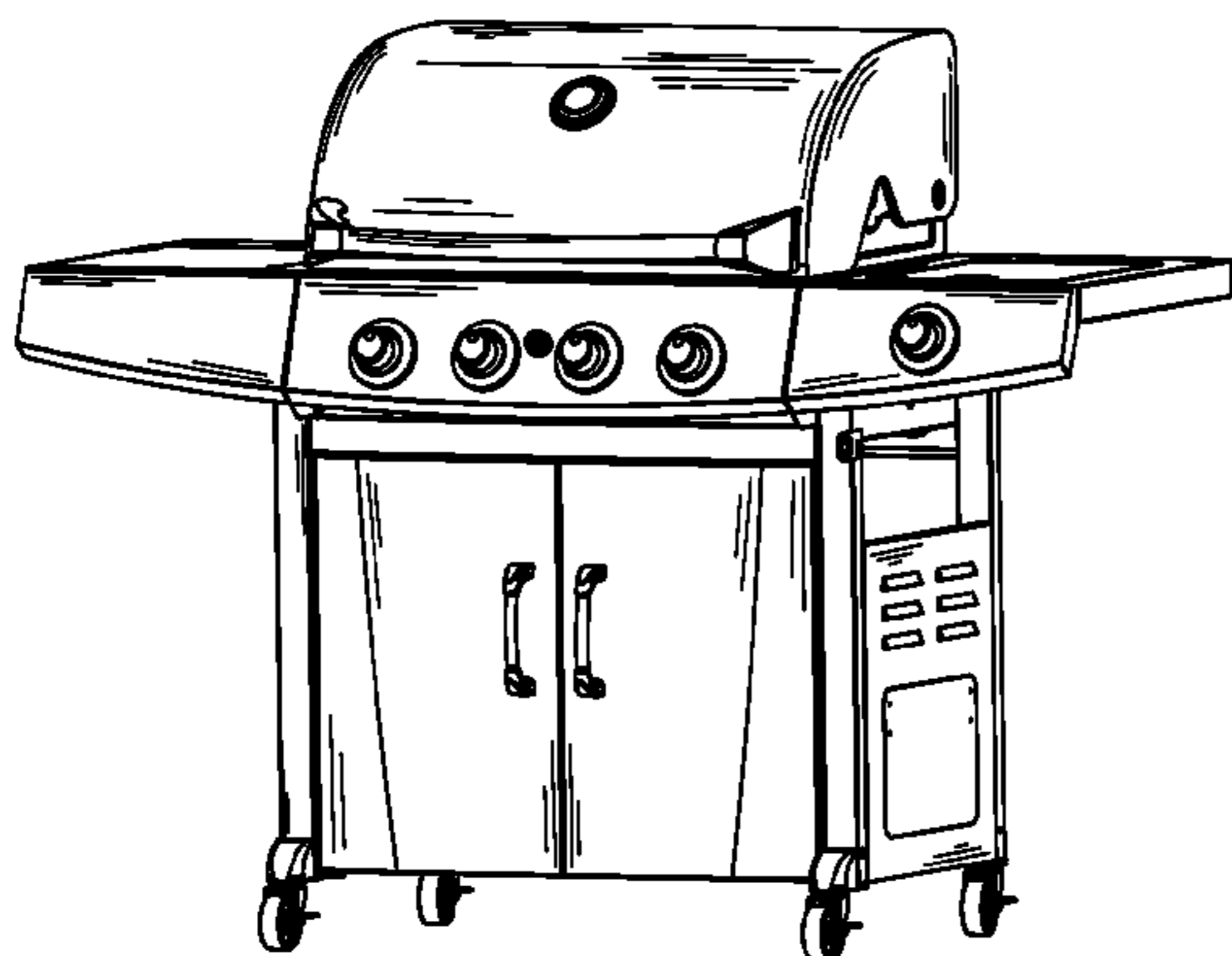
FIG. 4 is the left side elevational view thereof;

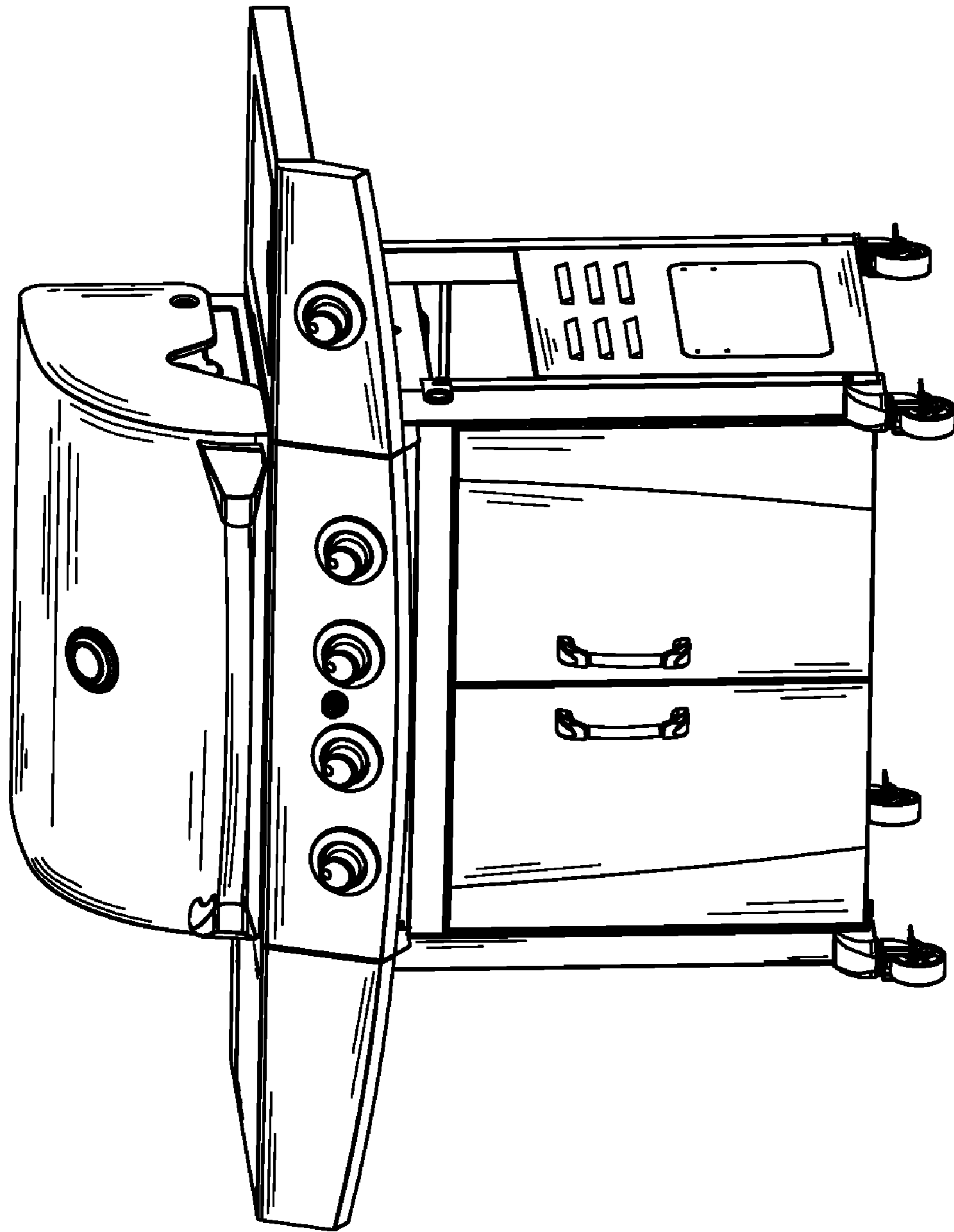

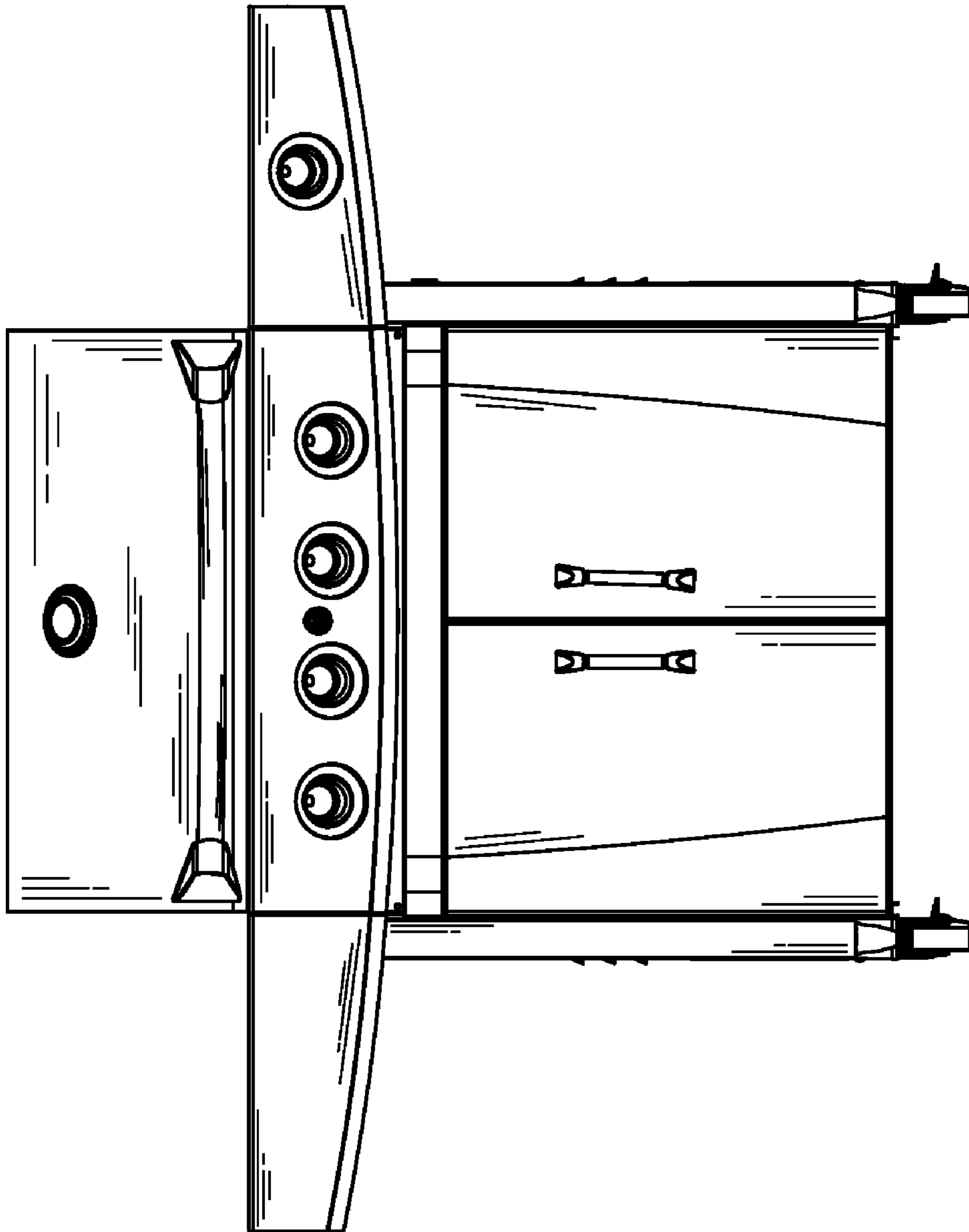

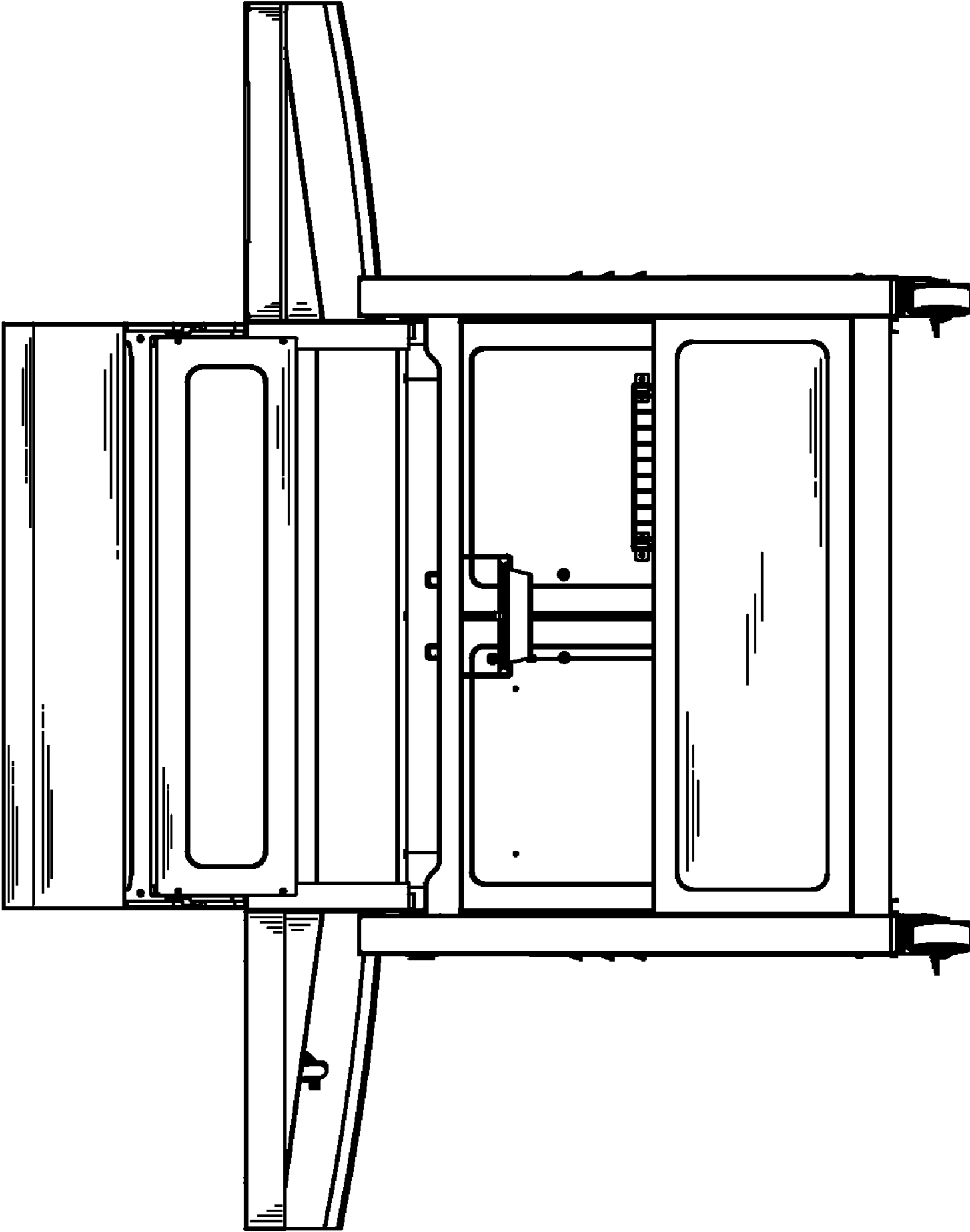

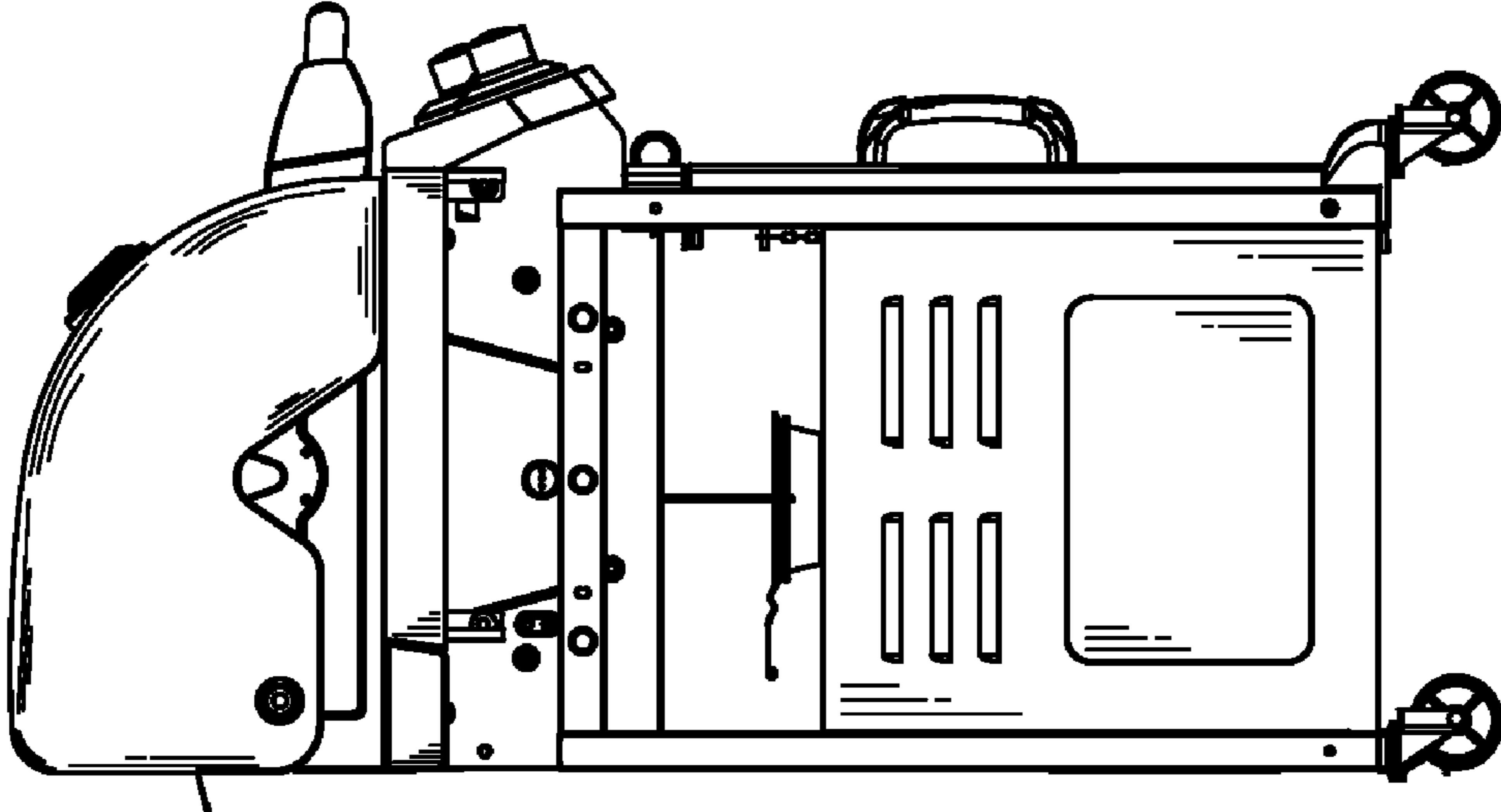

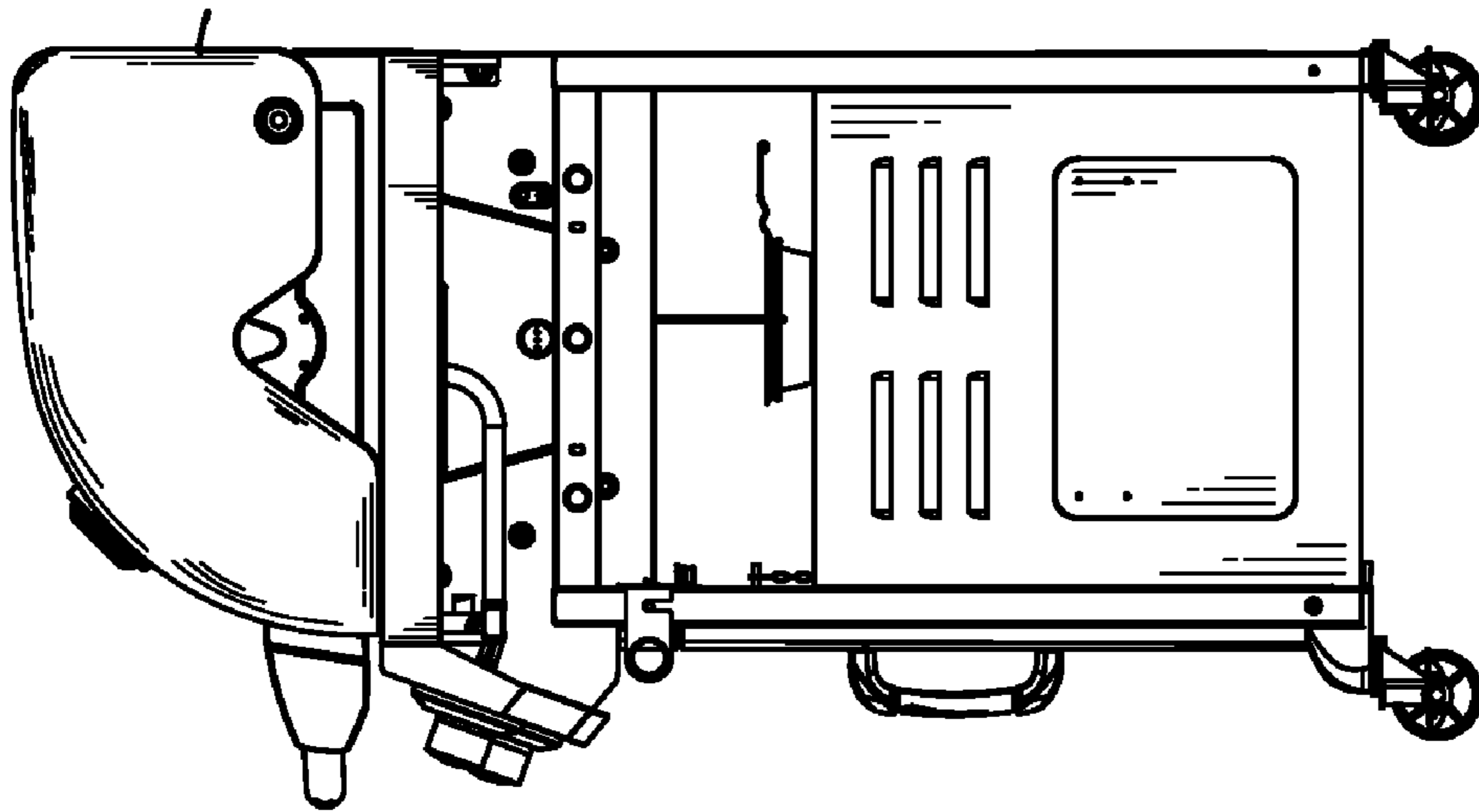

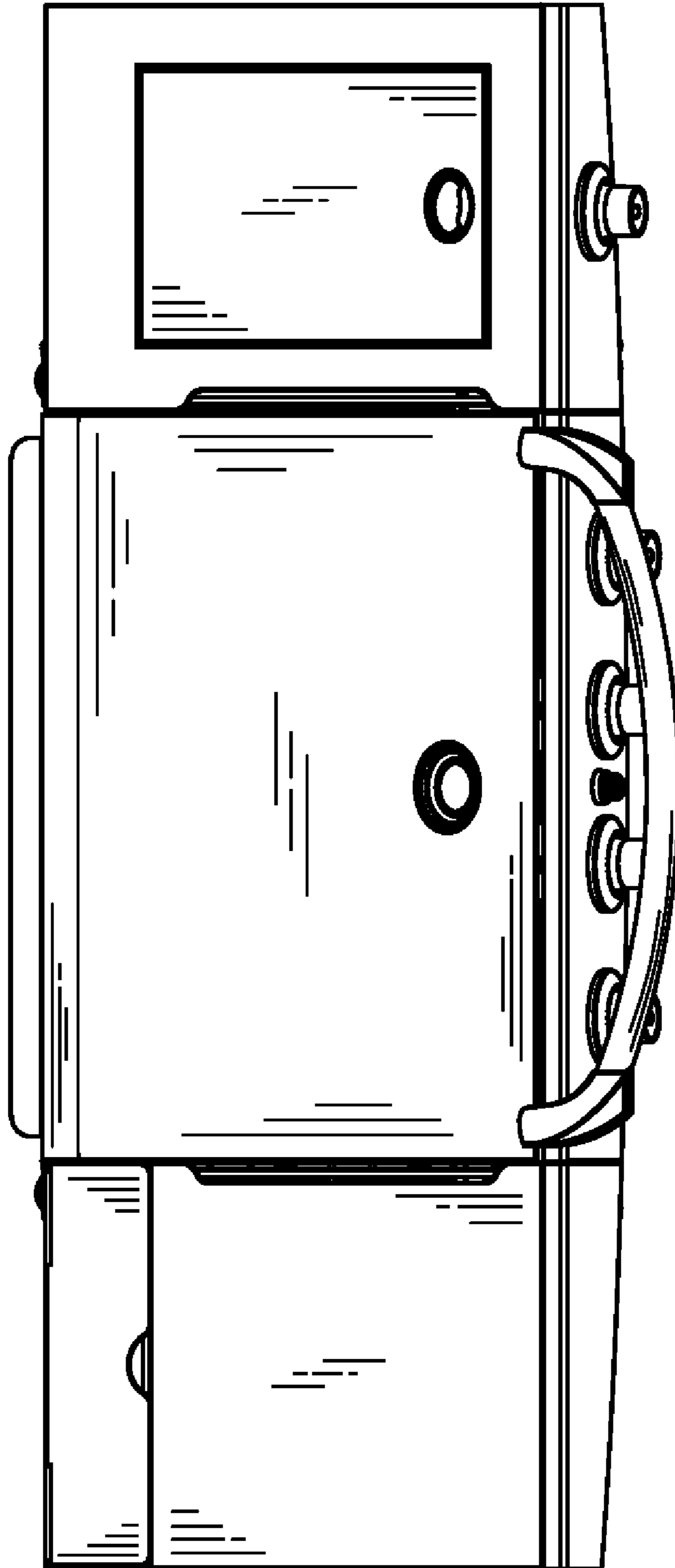

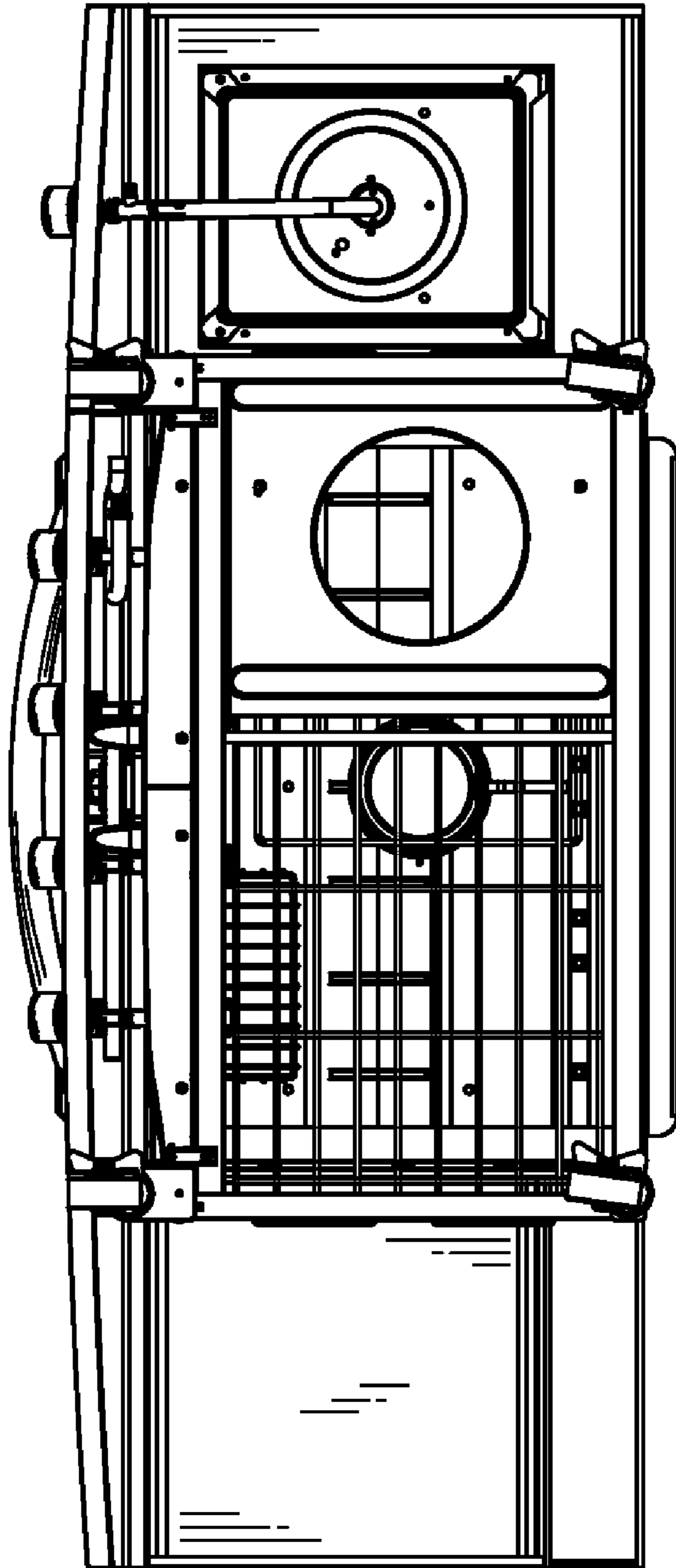
