FIG. 3 is a top view of the design.

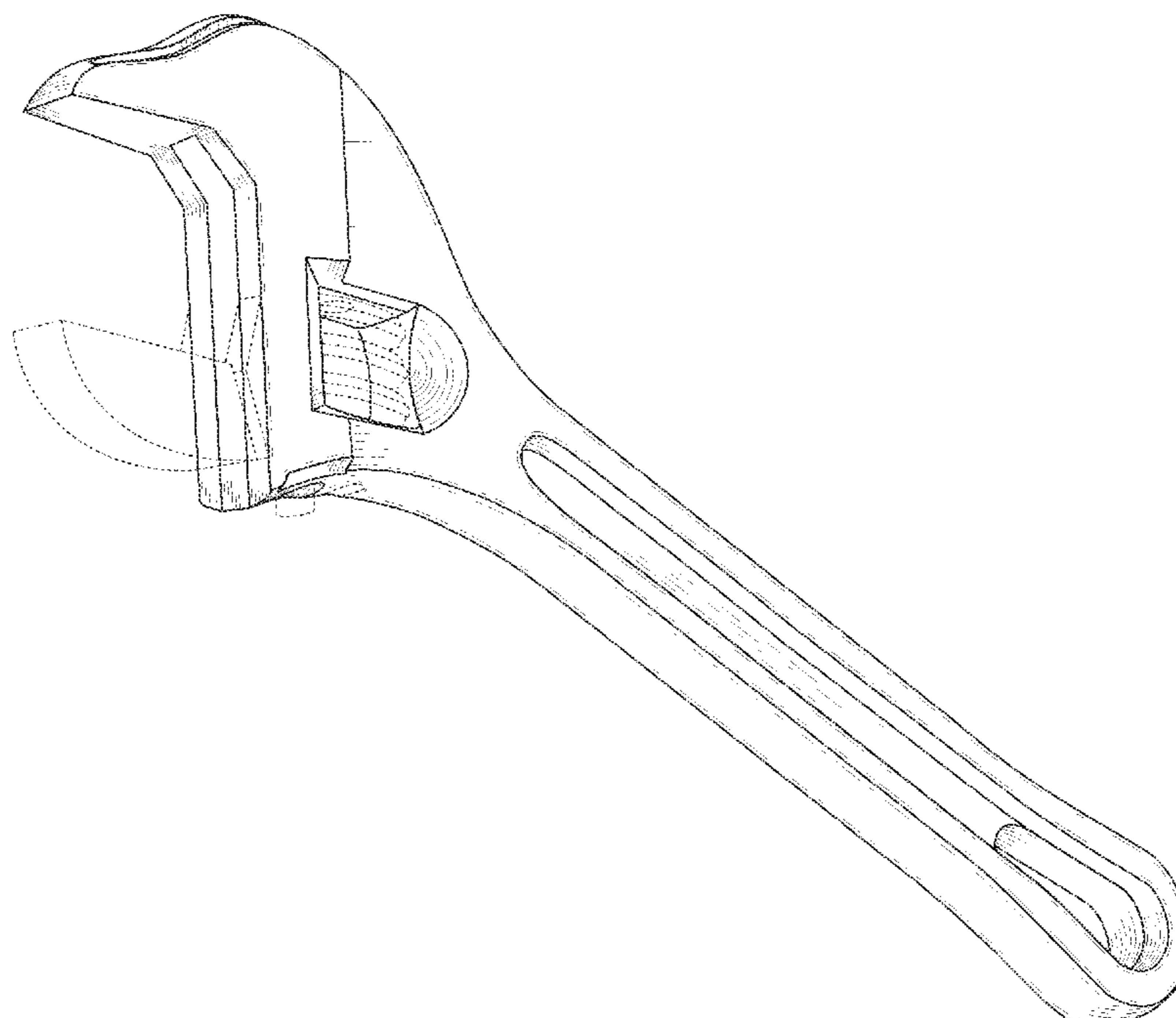
FIG. 4 is a bottom view of the design.

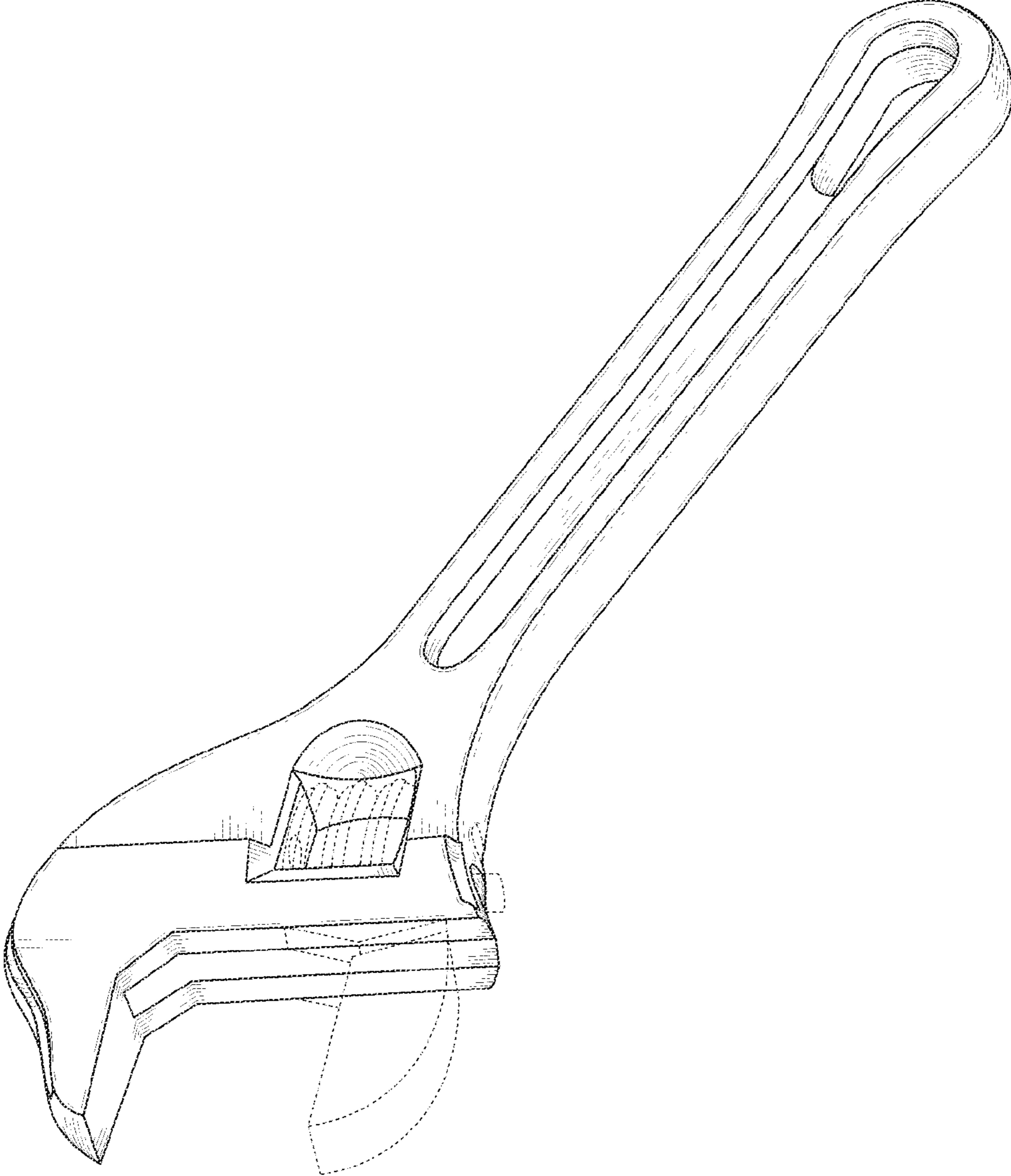

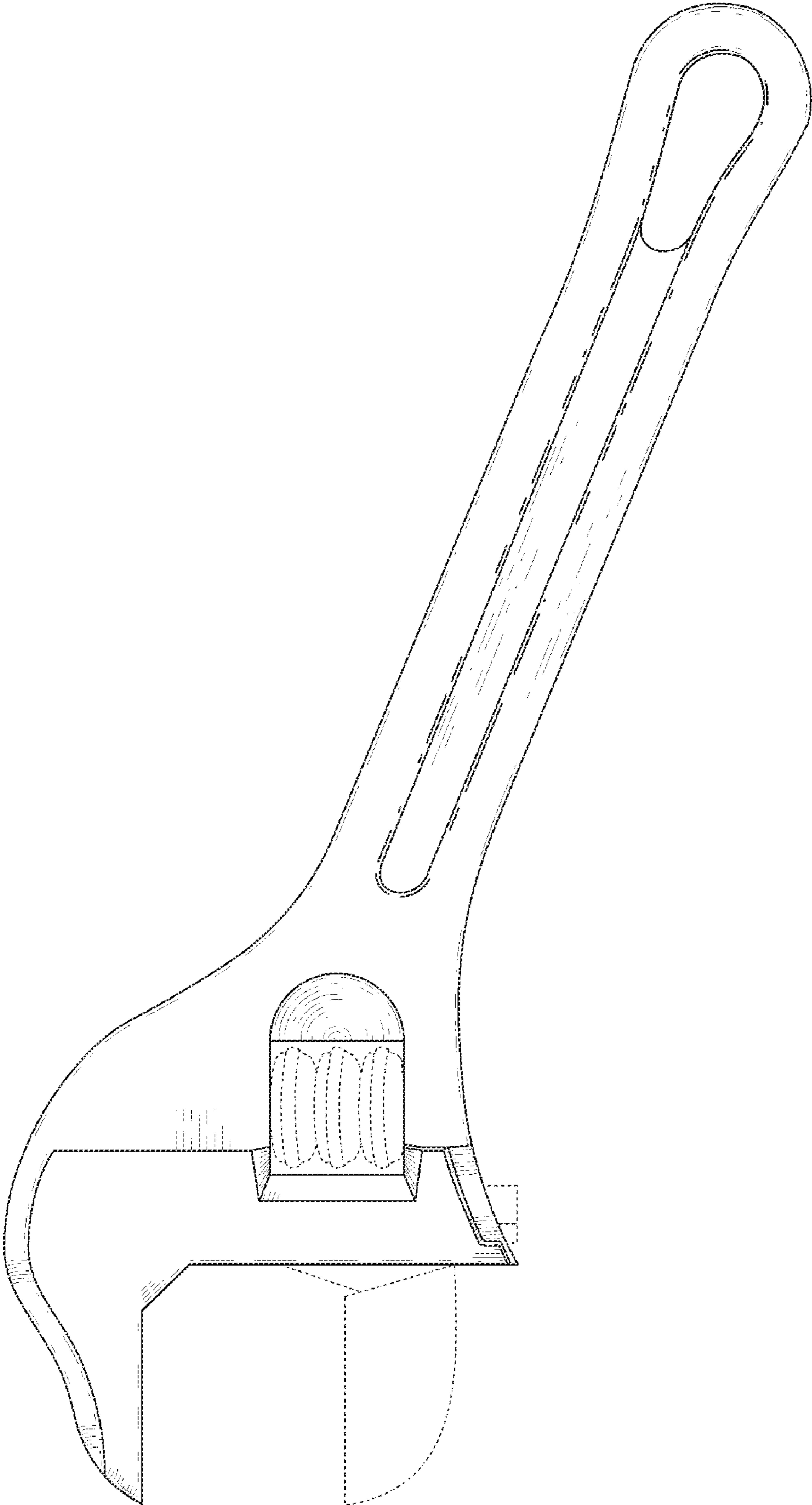

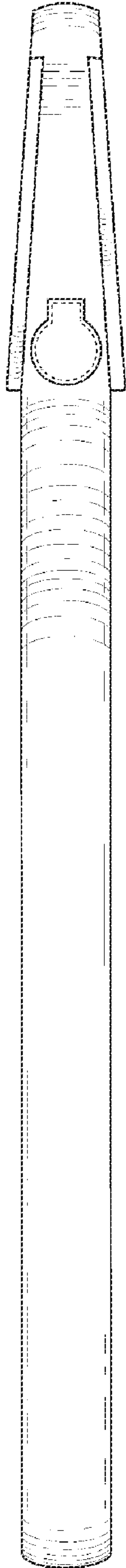

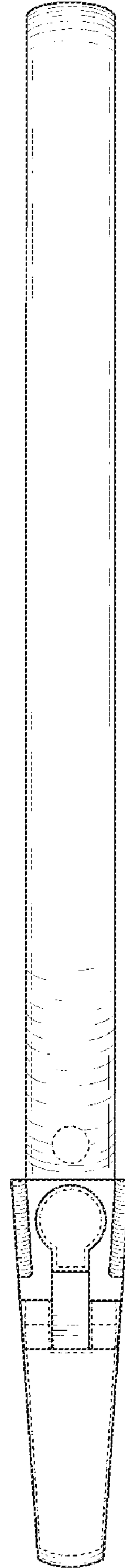

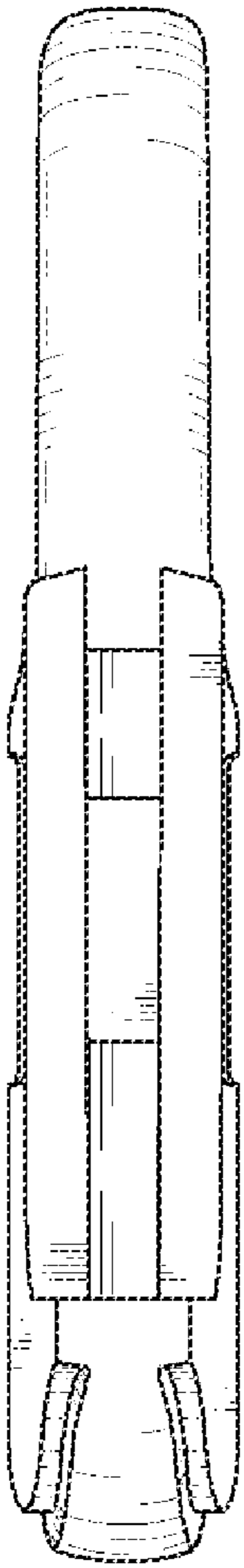

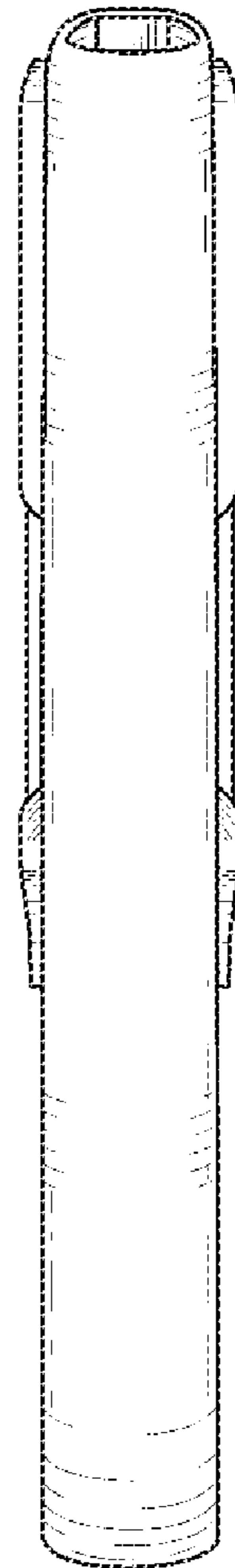
