DESCRIPTION

FIG. 1 is a perspective view of packaging showing an embodiment of our new design;

FIG. 2 is a front elevational view of the packaging of FIG. 1;

FIG. 3 is a back elevational view of the packaging of FIG. 1;

FIG. 4 is a right side elevational view of the packaging of FIG. 1;

FIG. 5 is a left side elevational view of the packaging of FIG. 1;

FIG. 6 is a top plan view of the packaging of FIG. 1;

FIG. 7 is a bottom plan view of the packaging of FIG. 1;

FIG. 8 is a perspective view of packaging showing an alternative embodiment of our new design;

FIG. 9 is a front elevational view of the packaging of FIG. 8;

FIG. 10 is a back elevational view of the packaging of FIG. 8;

FIG. 11 is a right side elevational view of the packaging of FIG. 8;

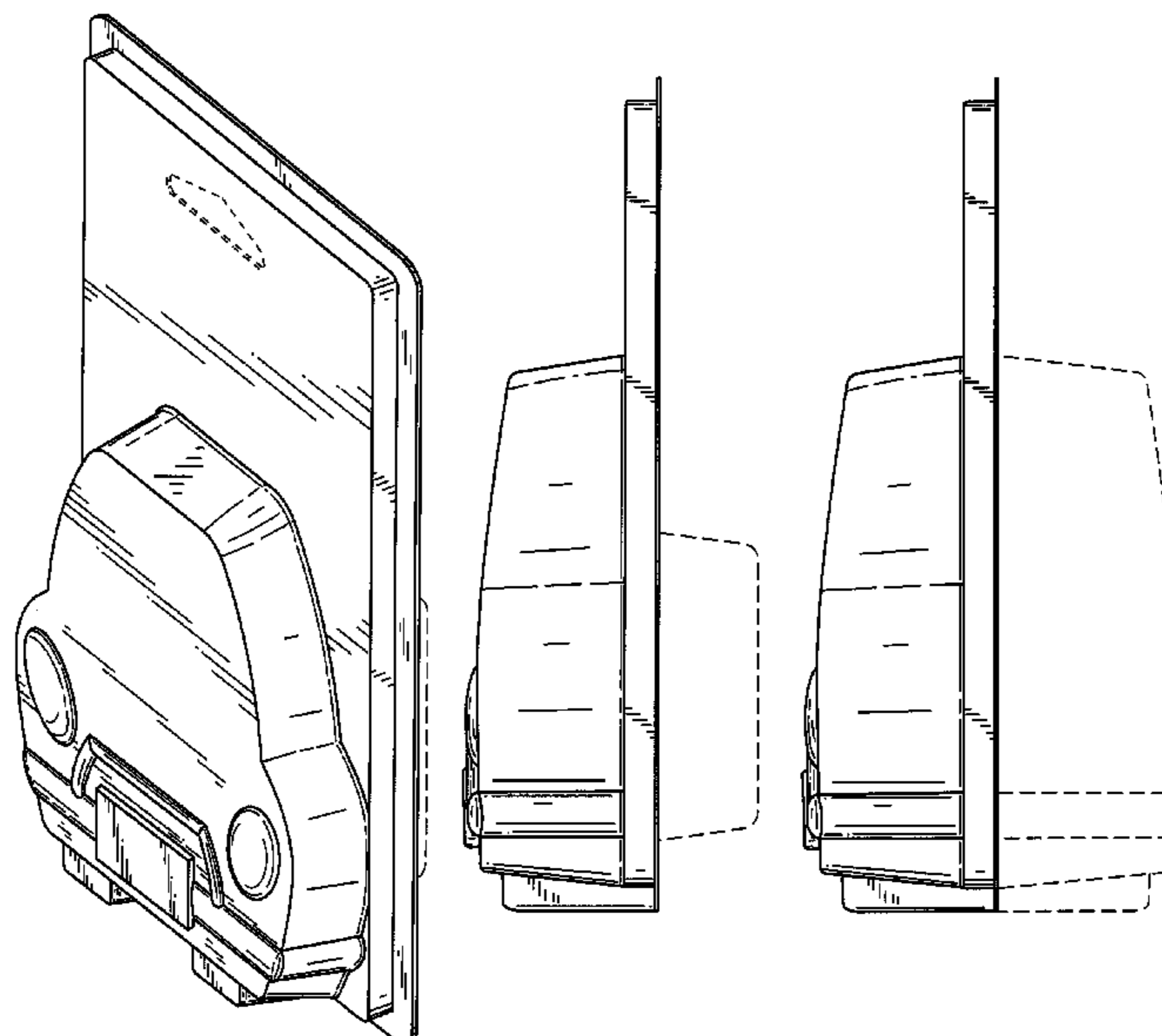
FIG. 12 is a left side elevational view of the packaging of FIG. 8;

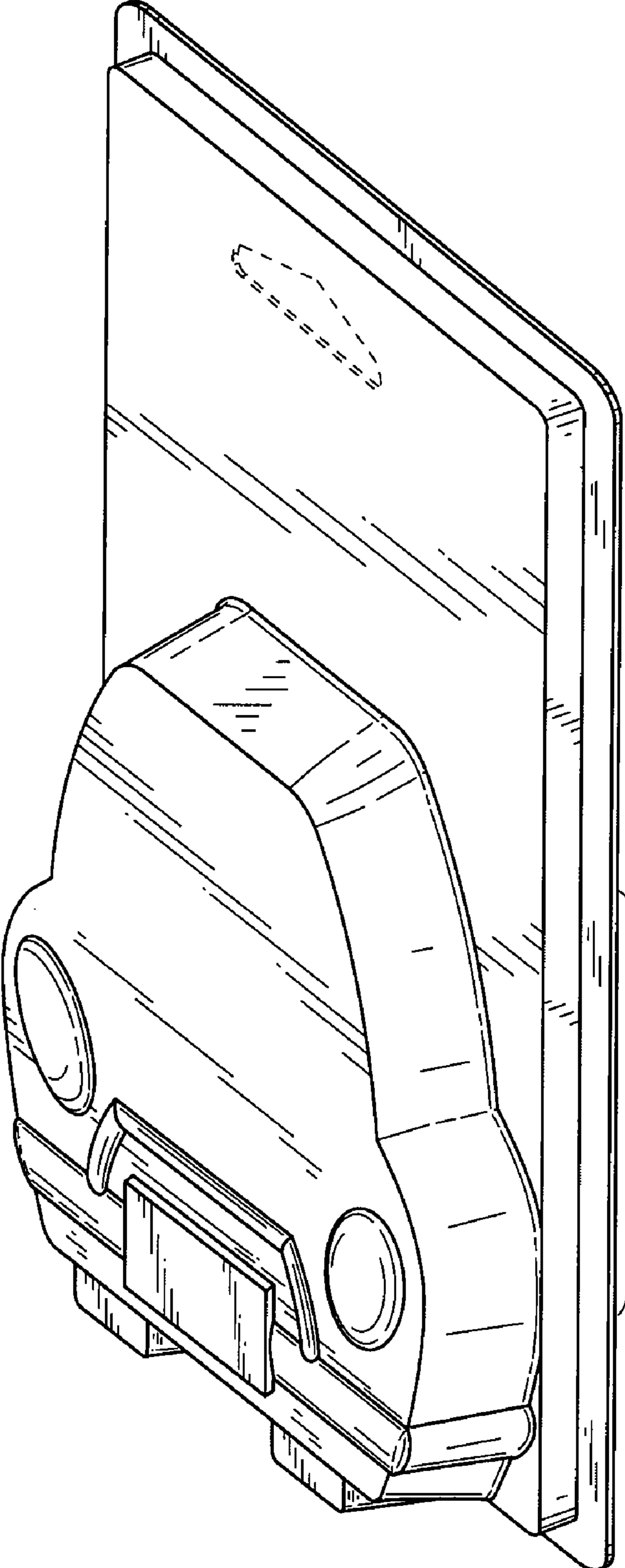

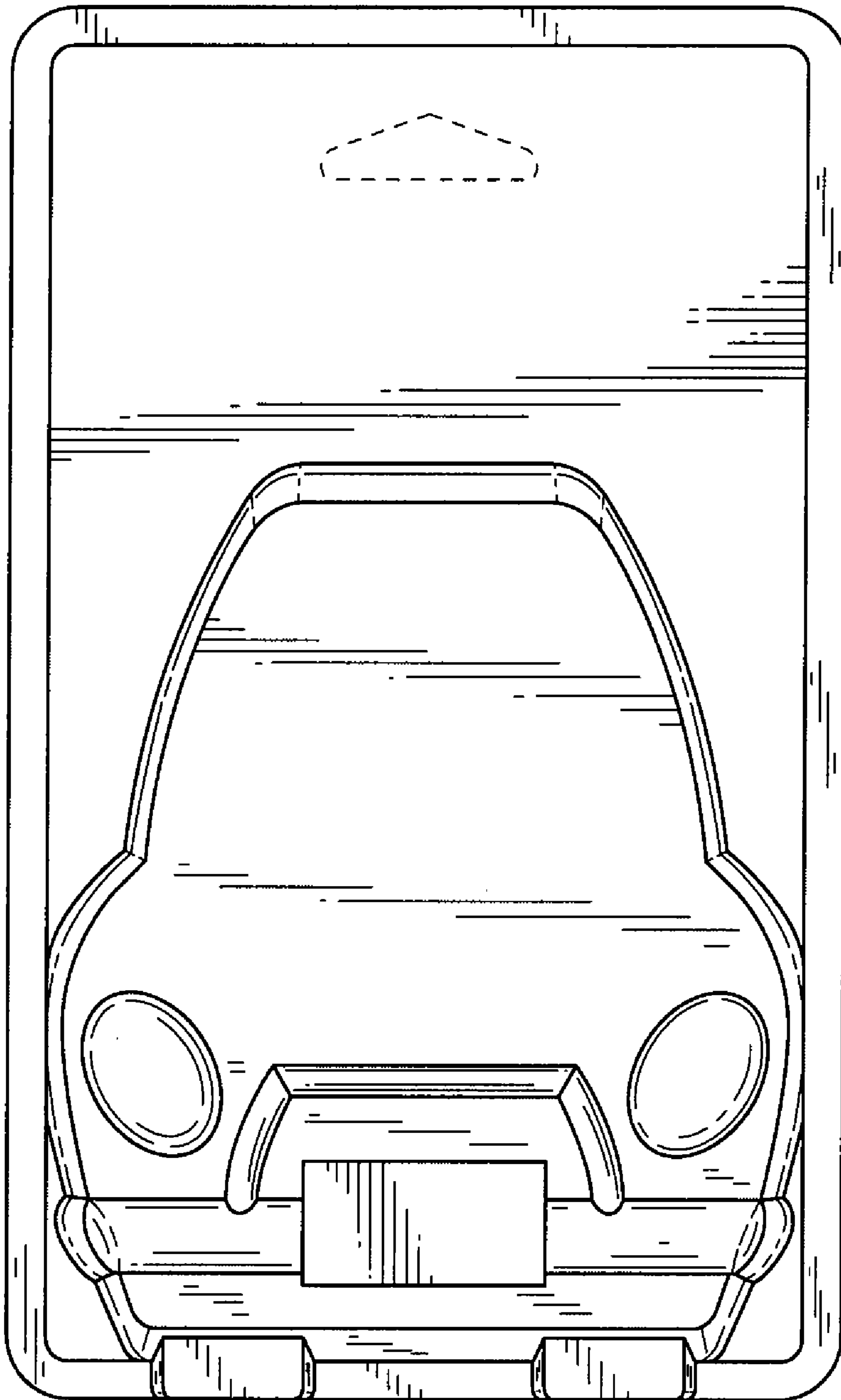

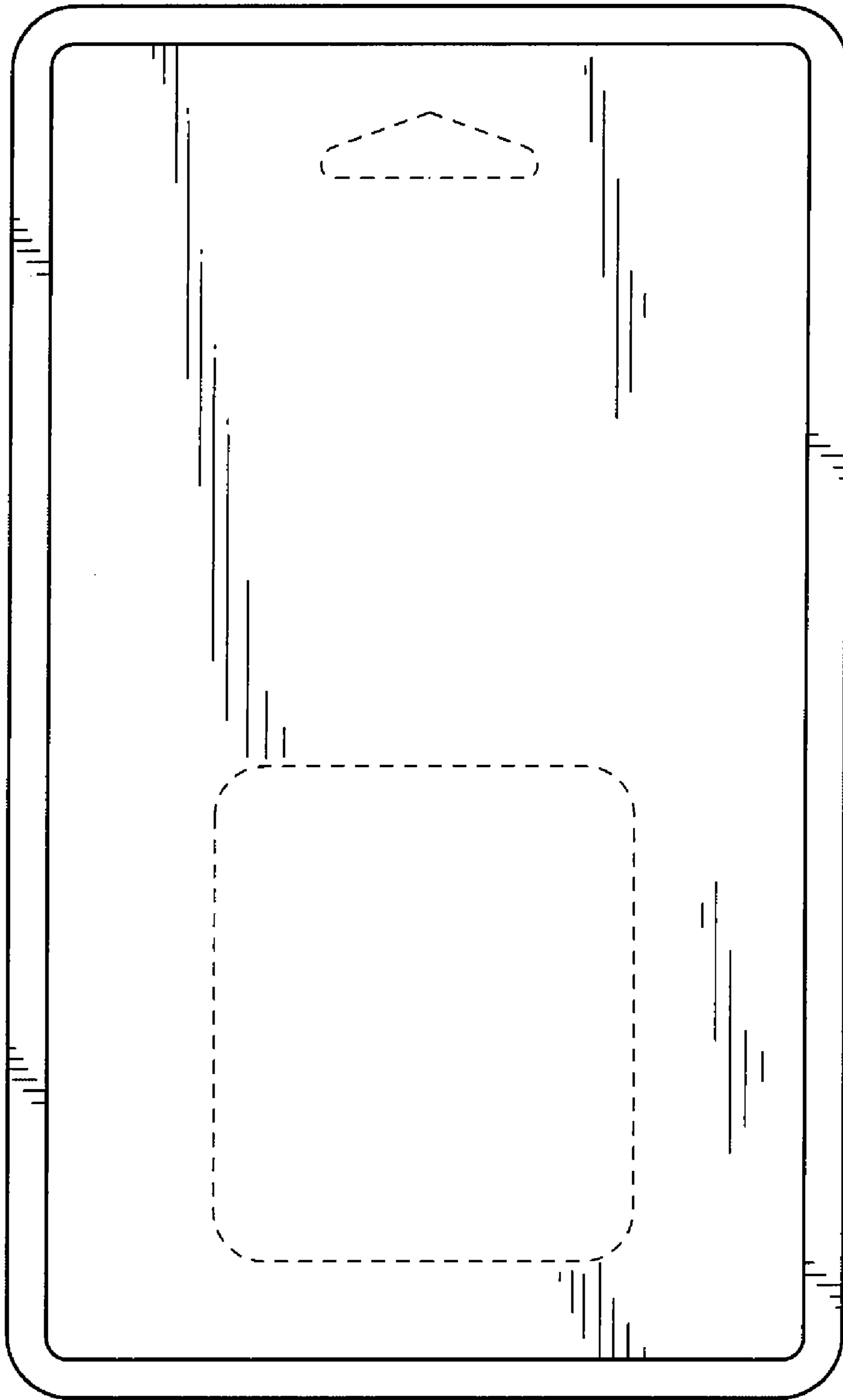

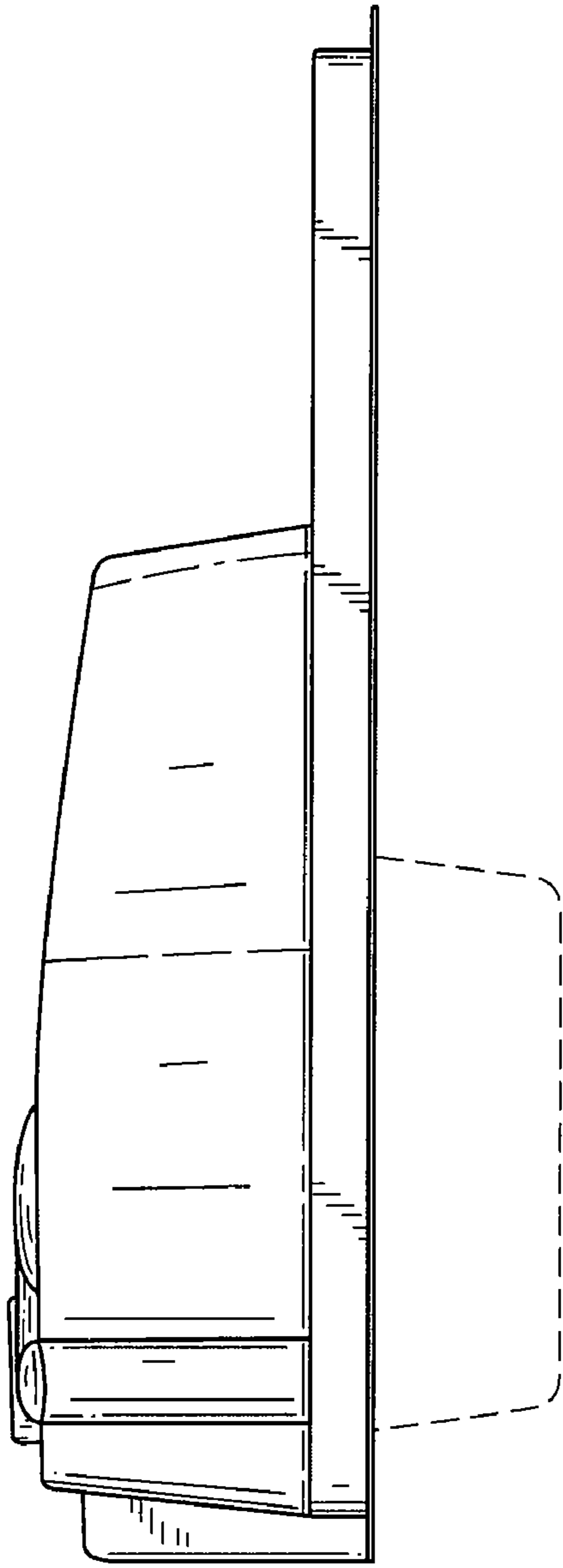

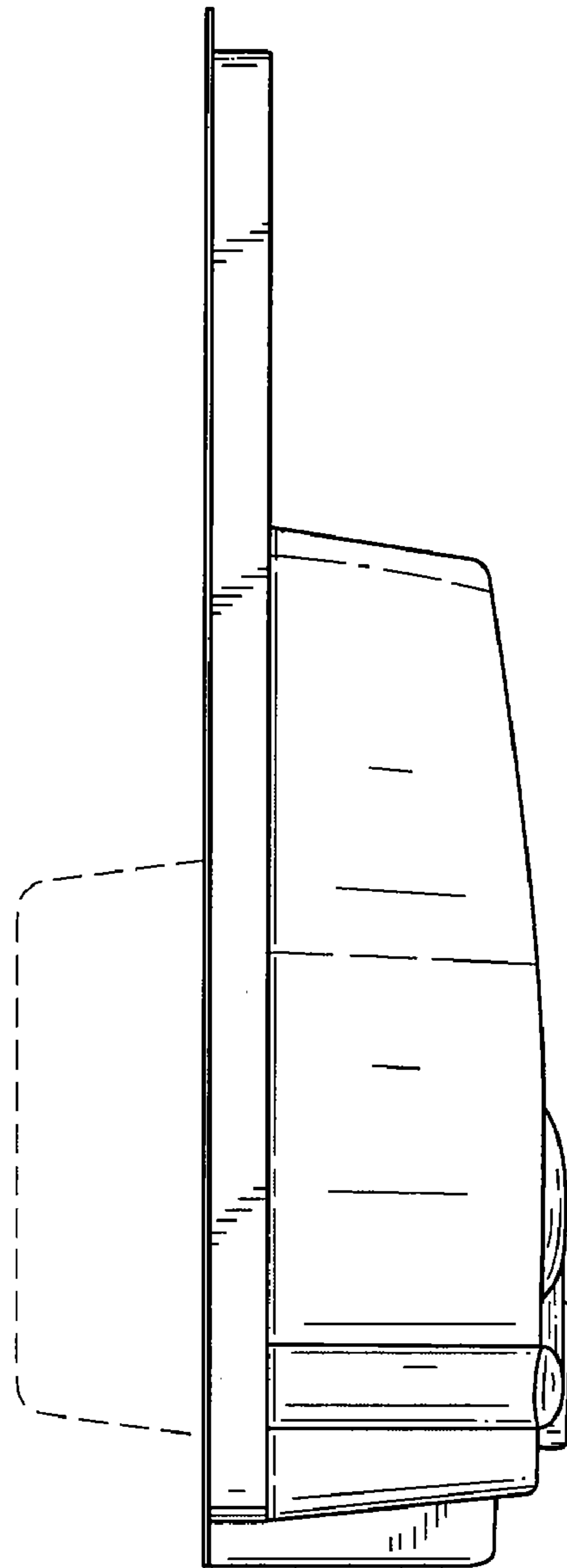

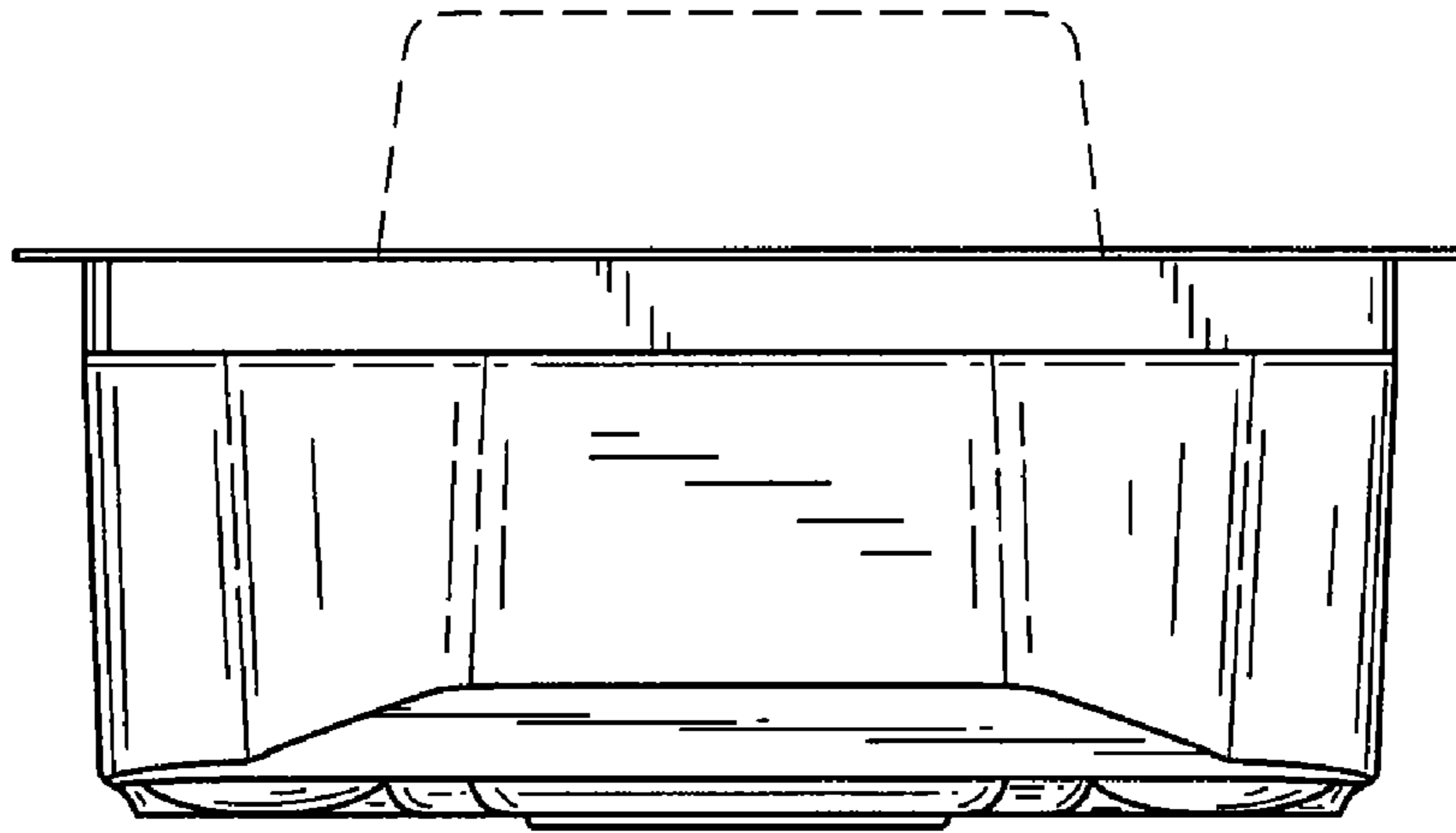

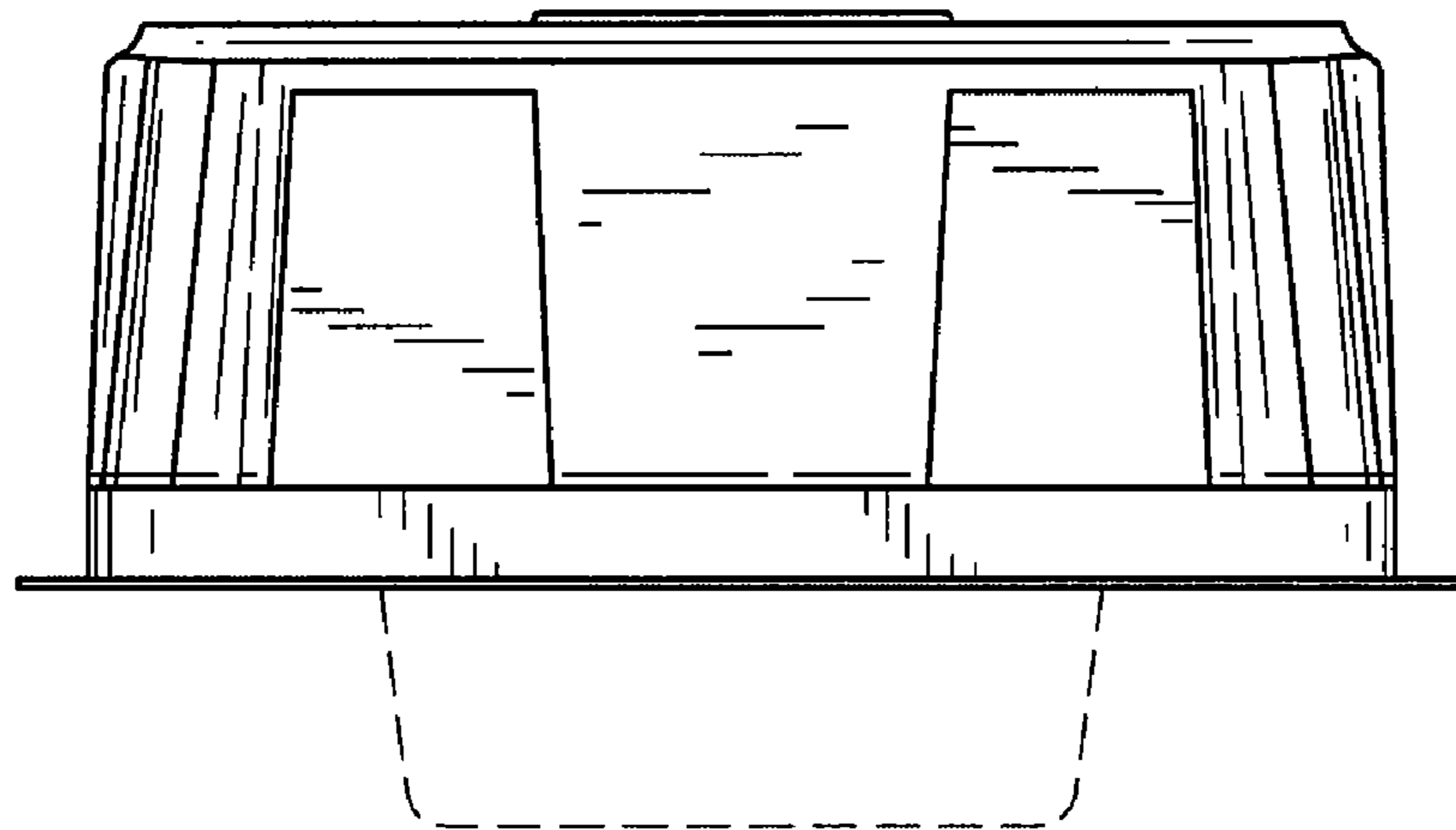

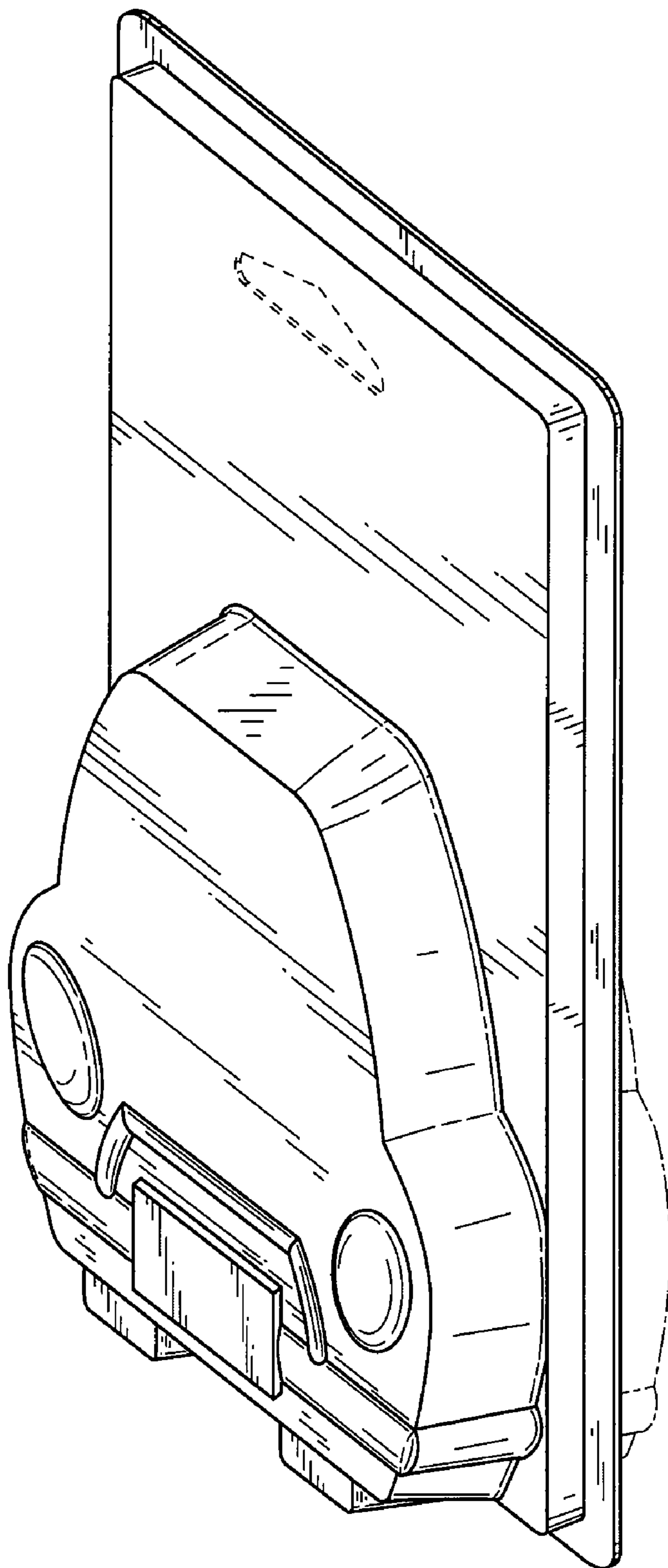

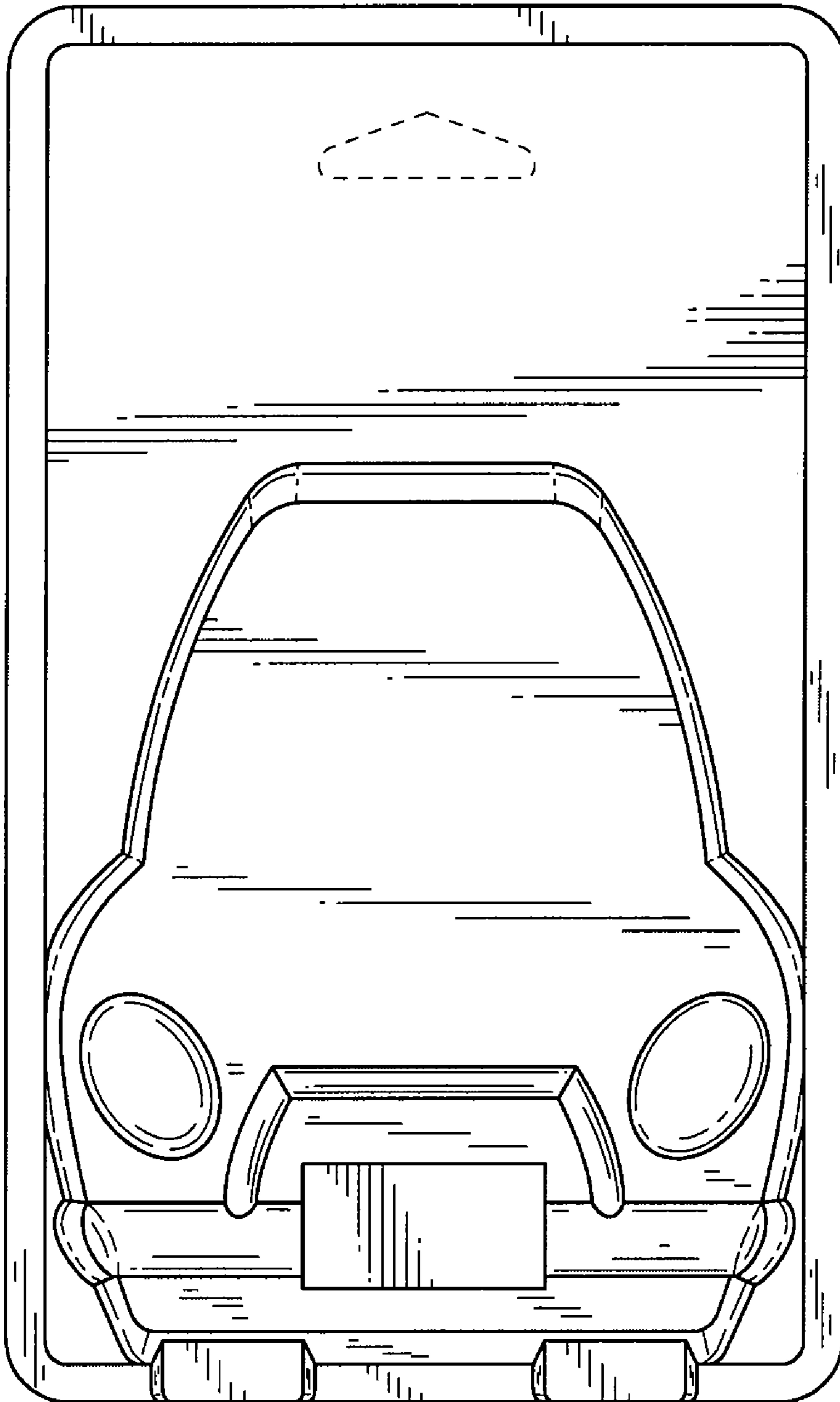

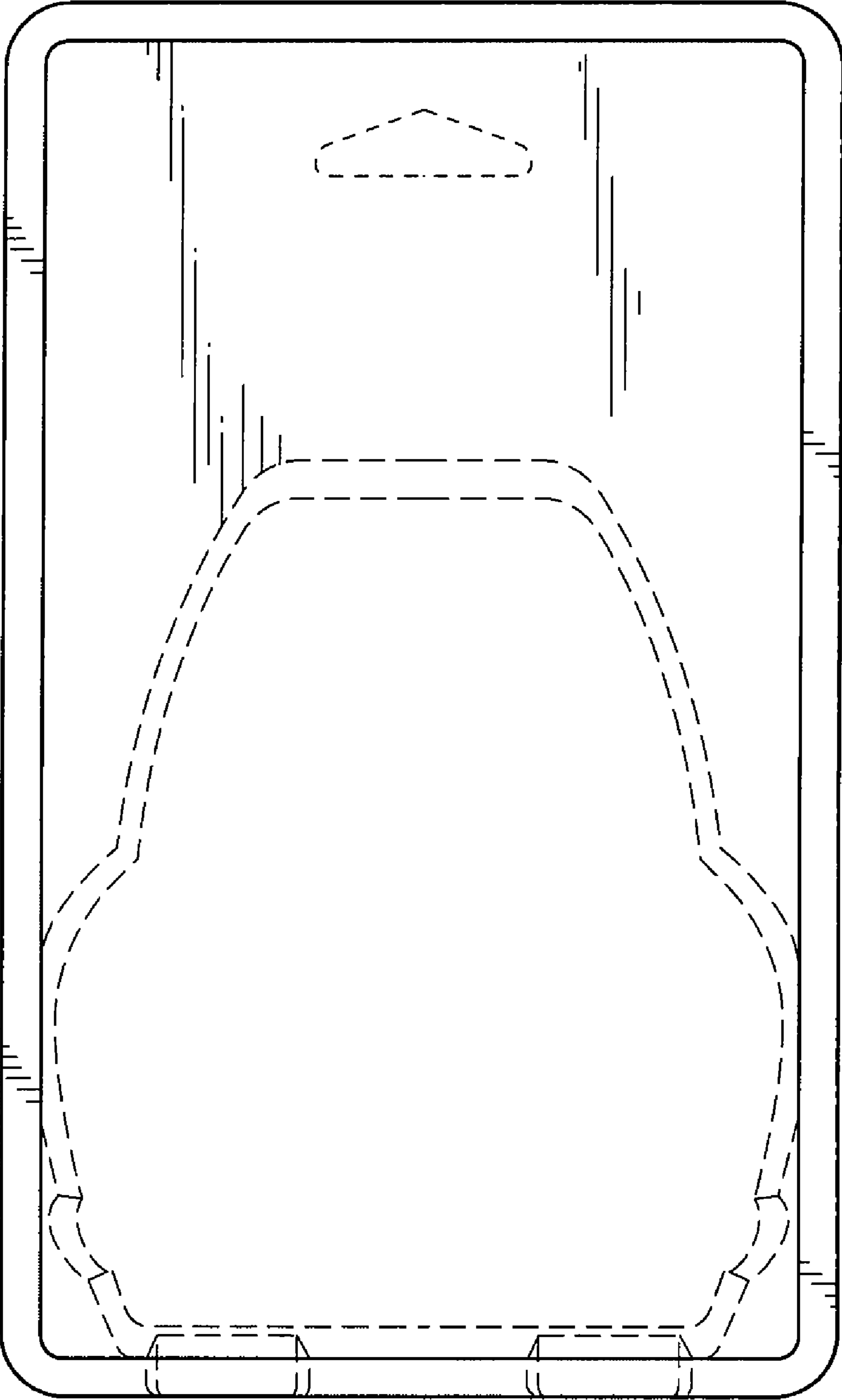

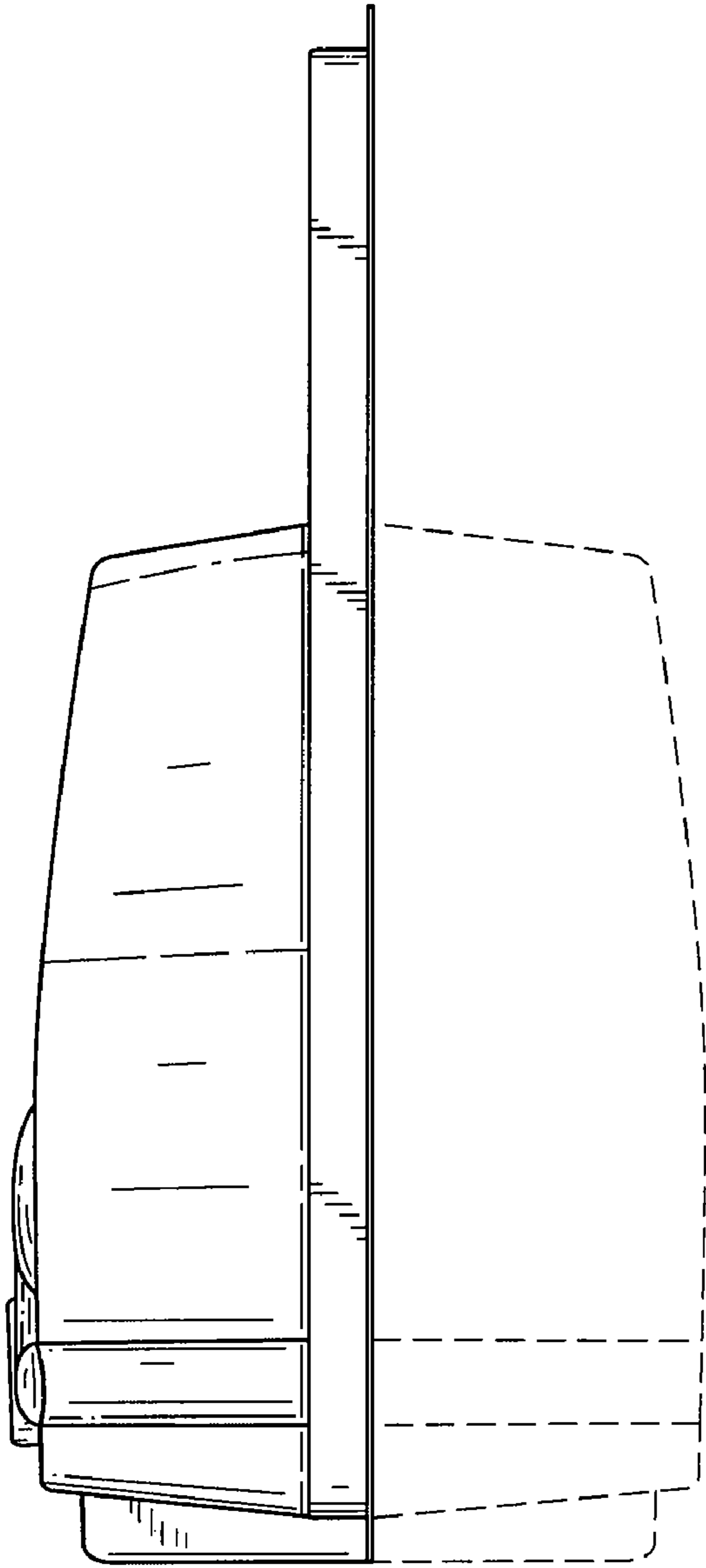

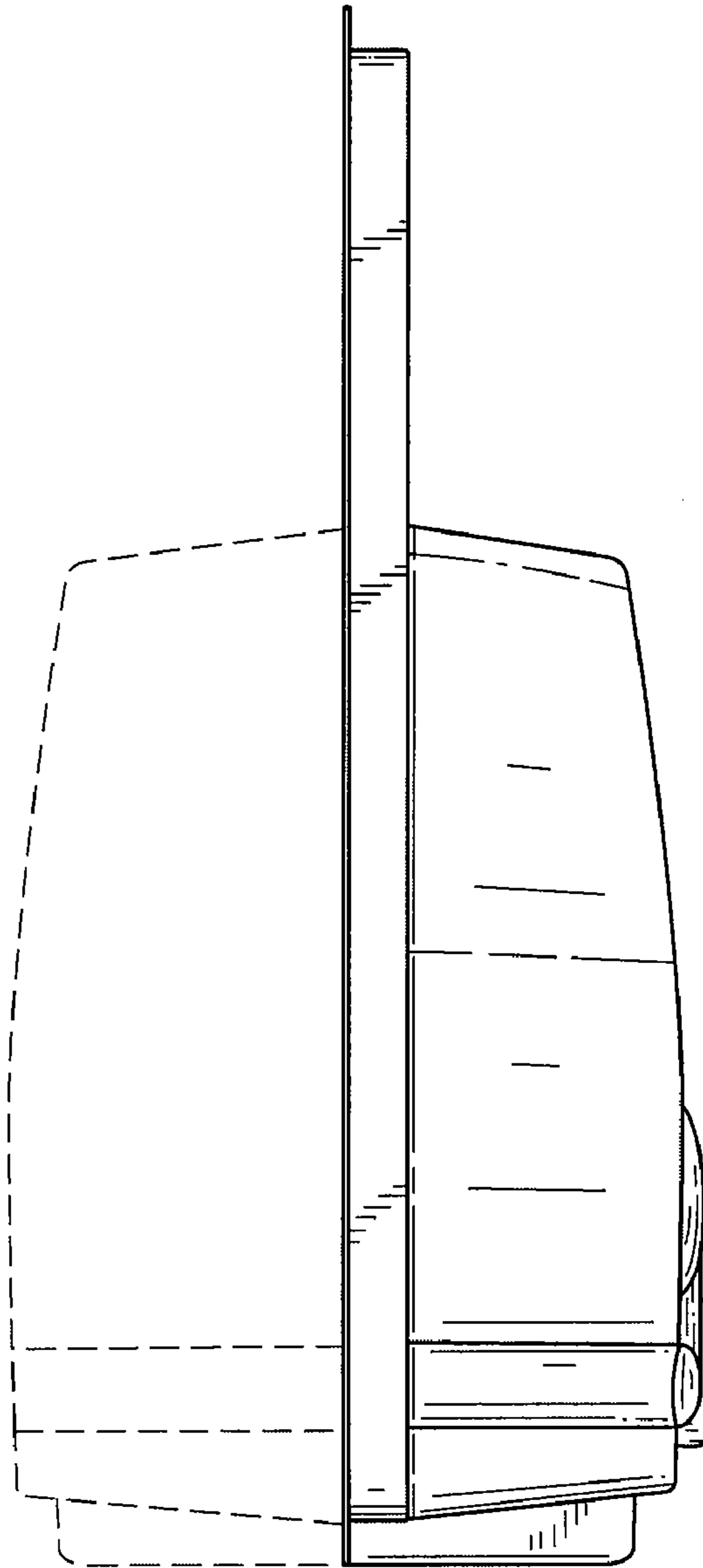

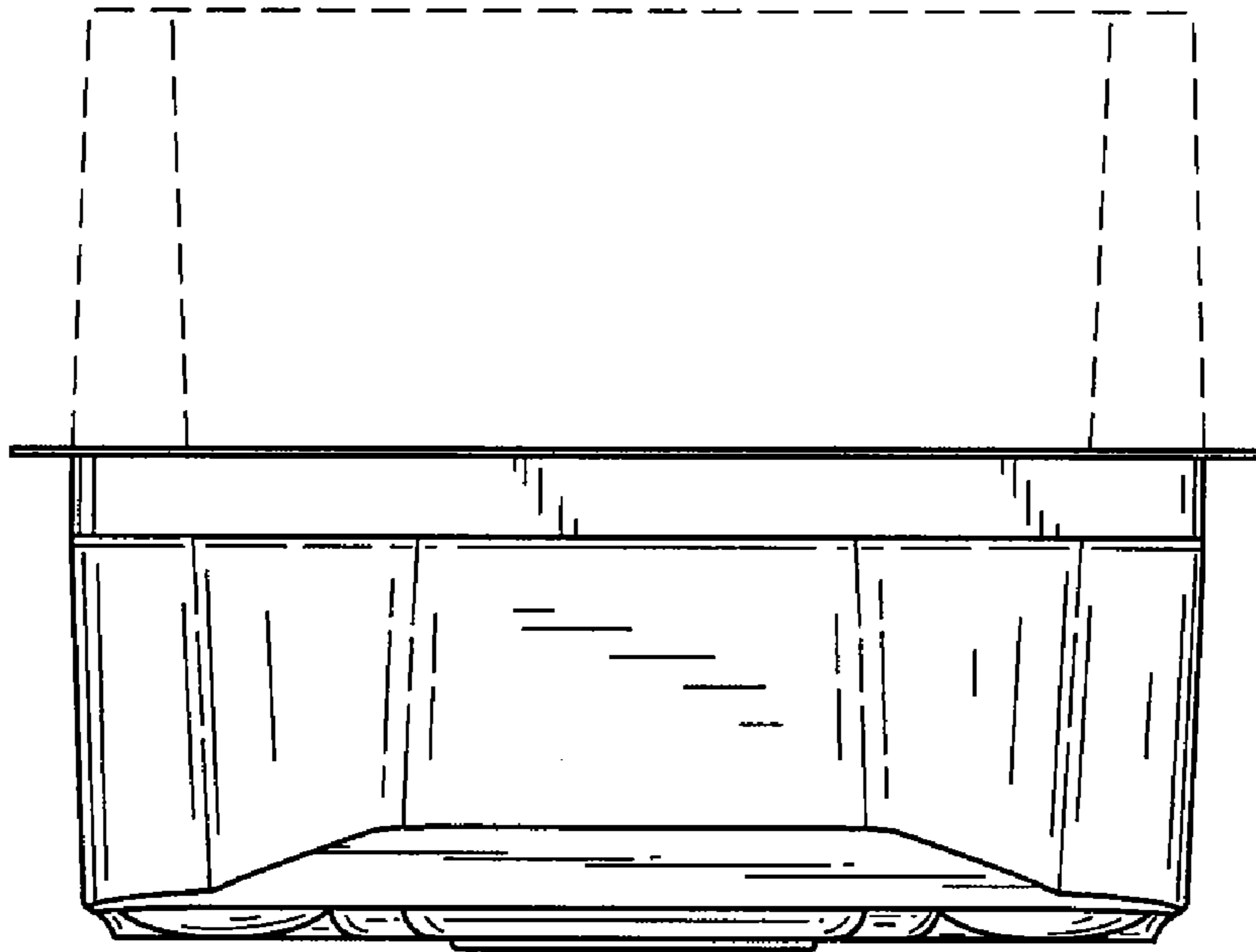

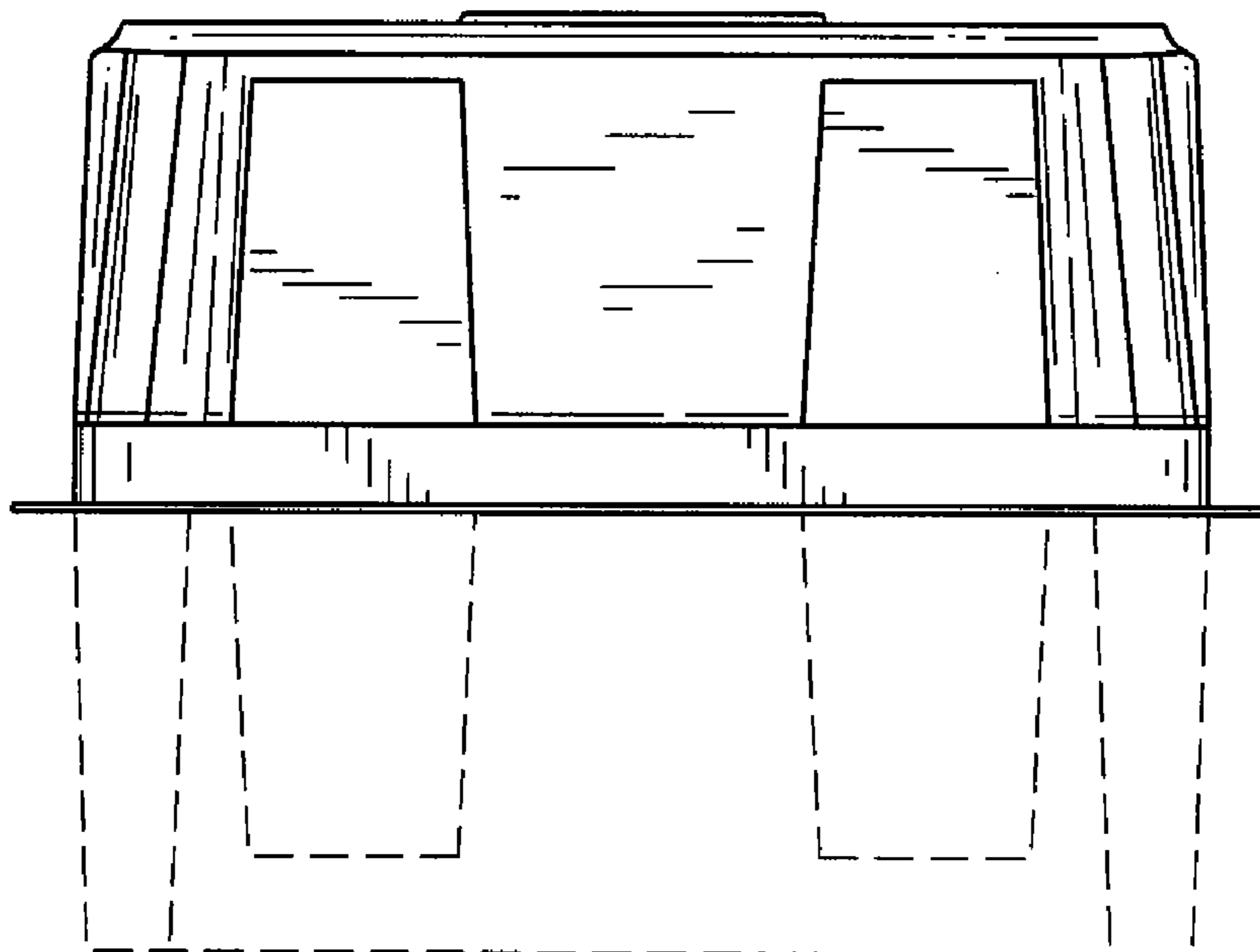
