DESCRIPTION

FIG. 1 is a perspective view as seen from the top, front and left side of a container showing my new design;

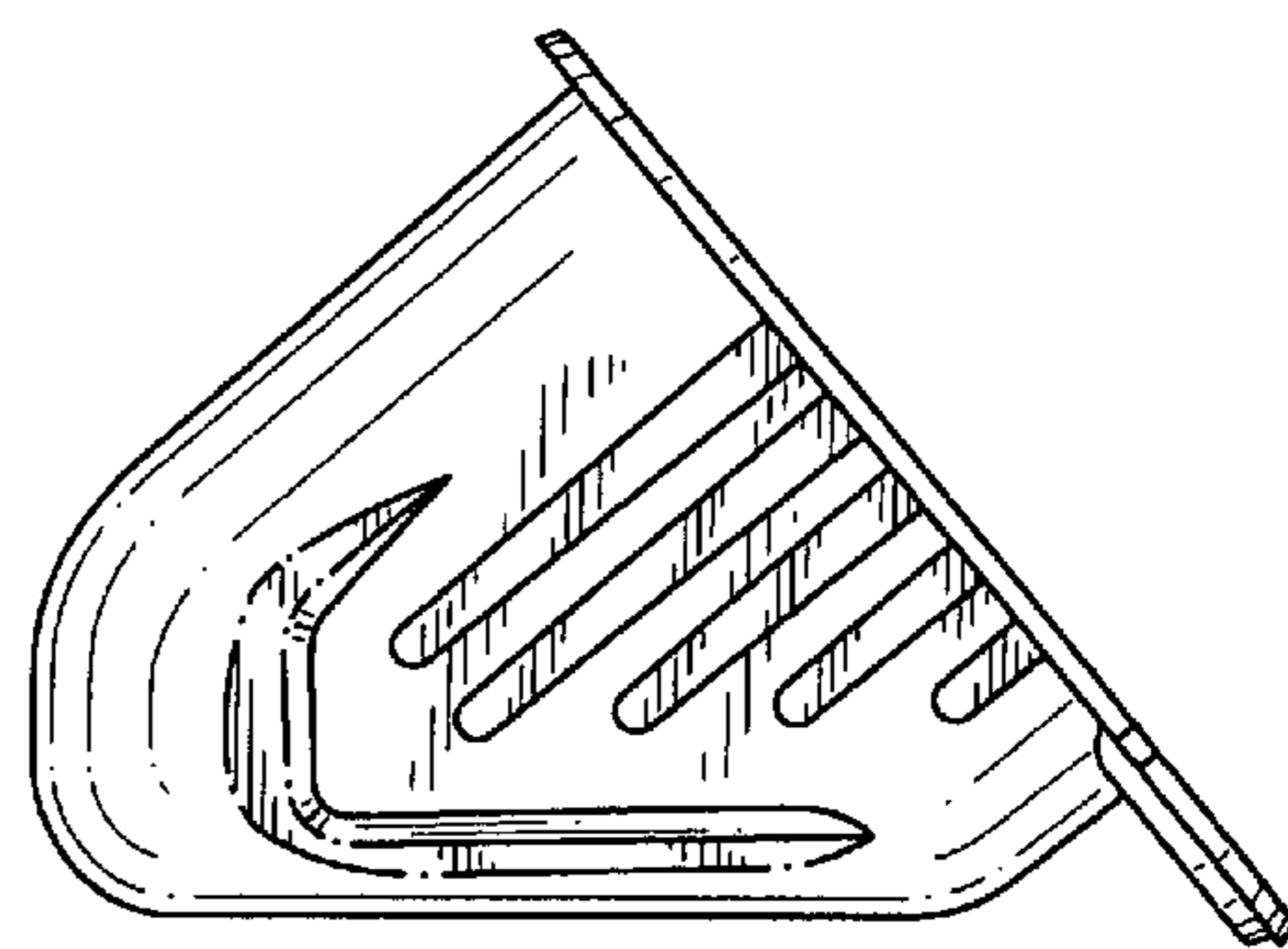
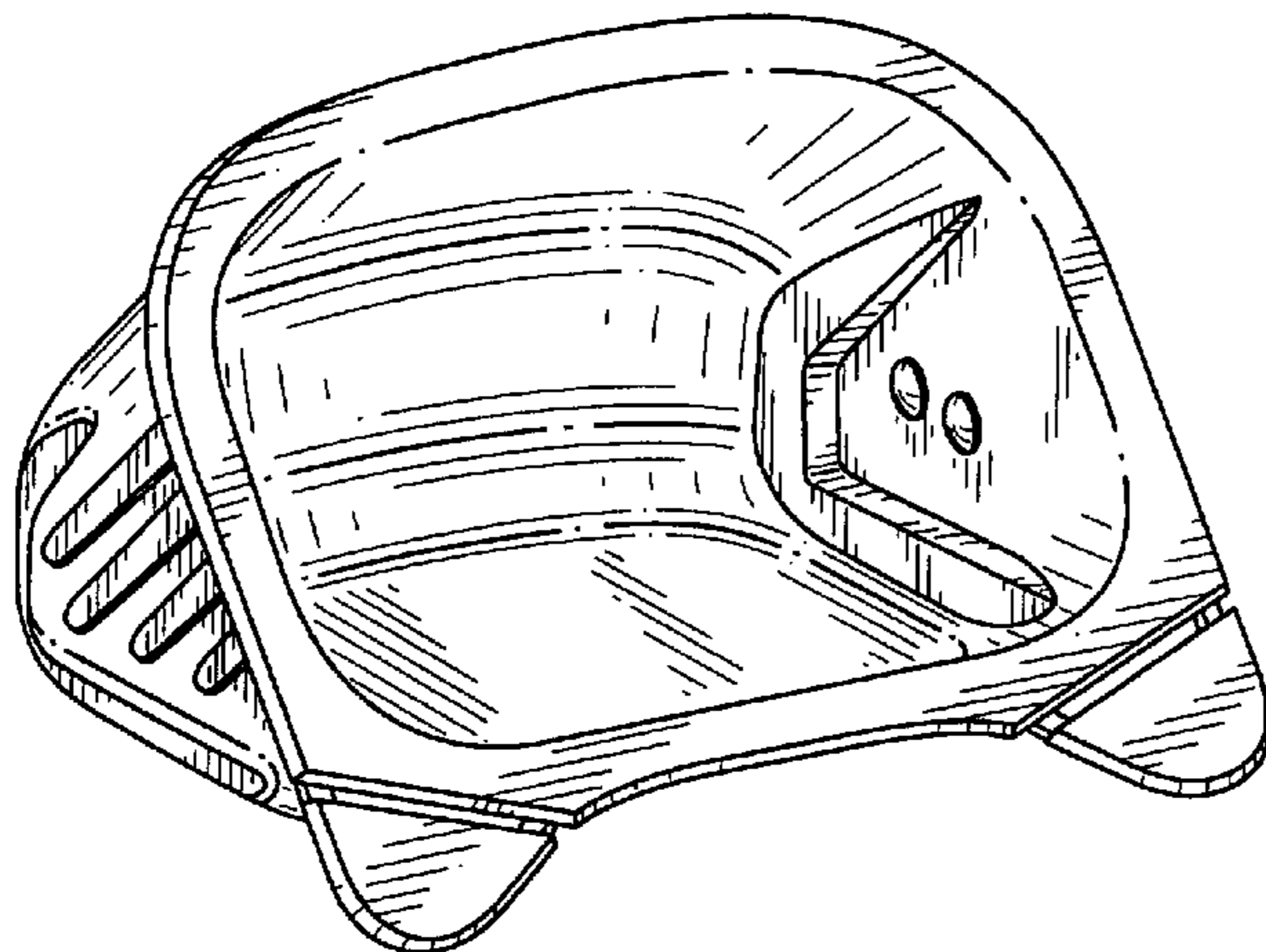

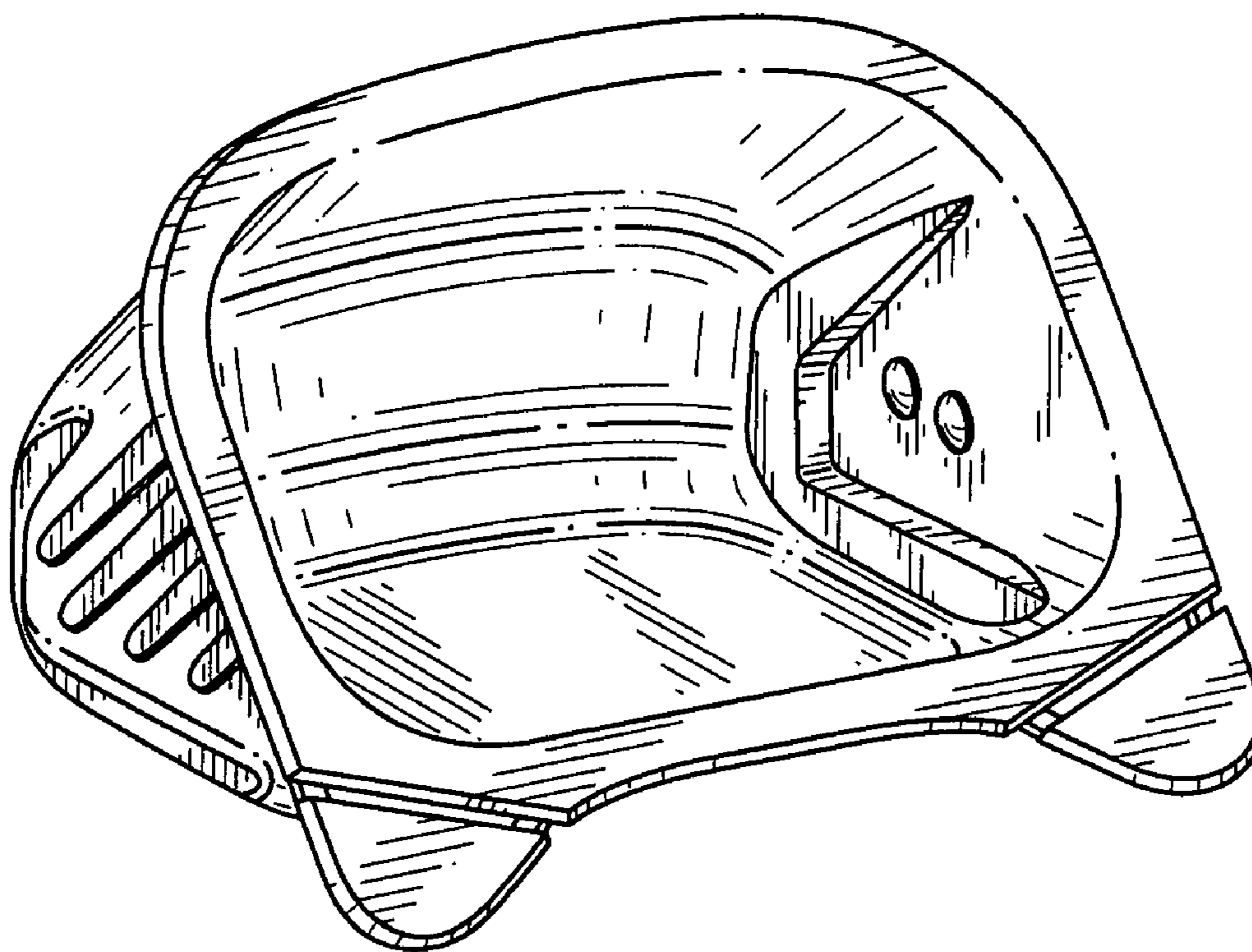

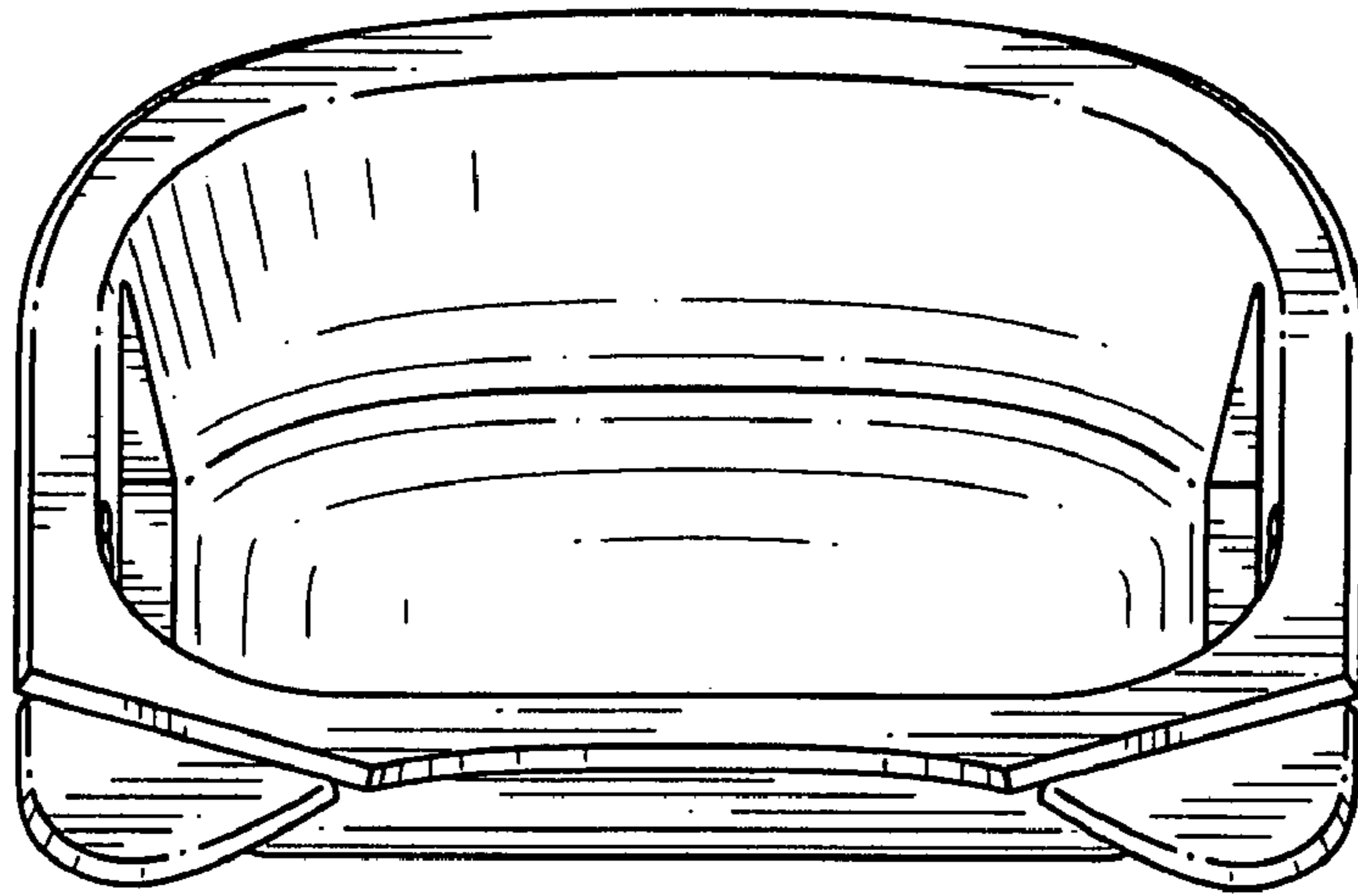

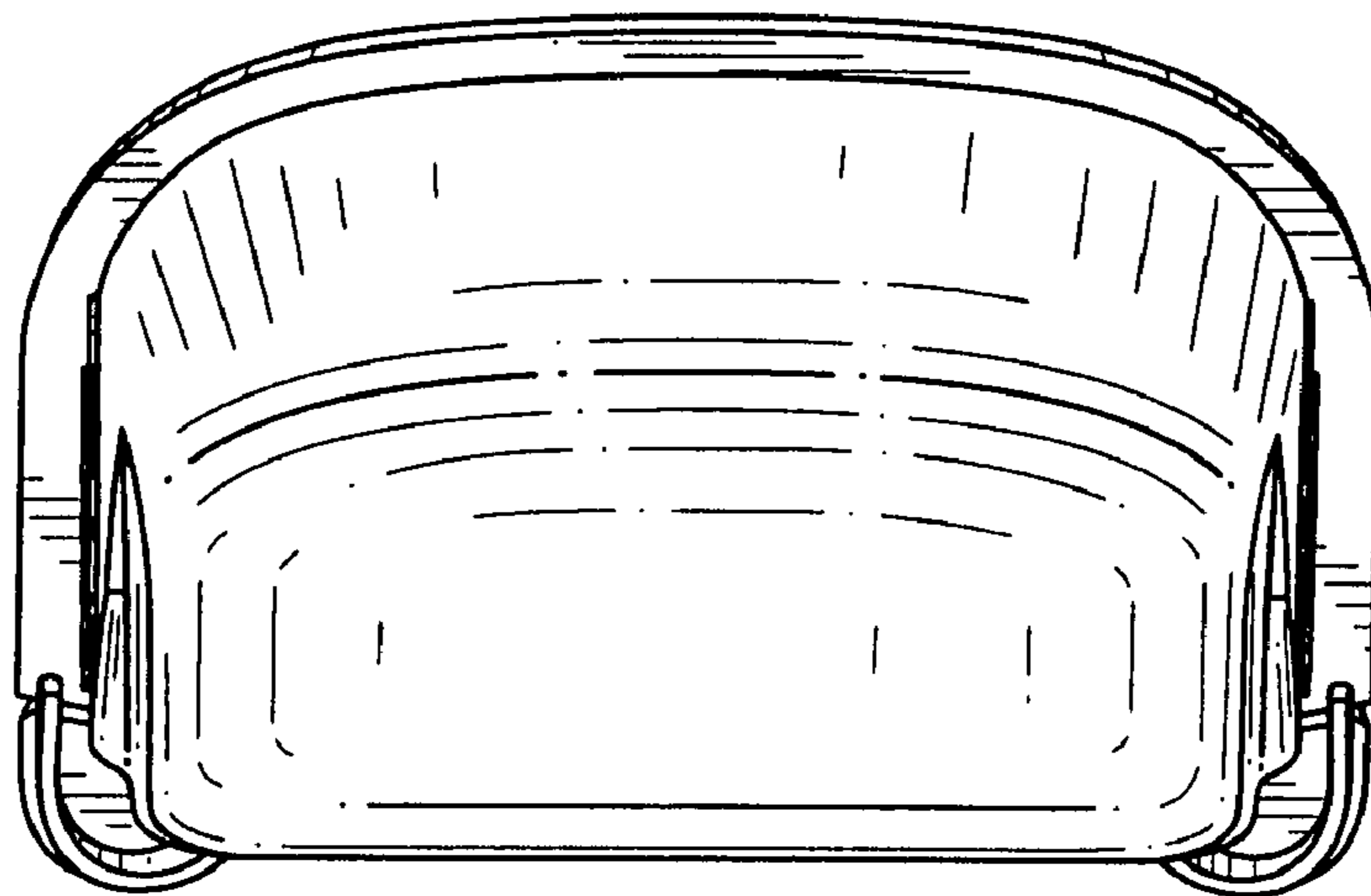

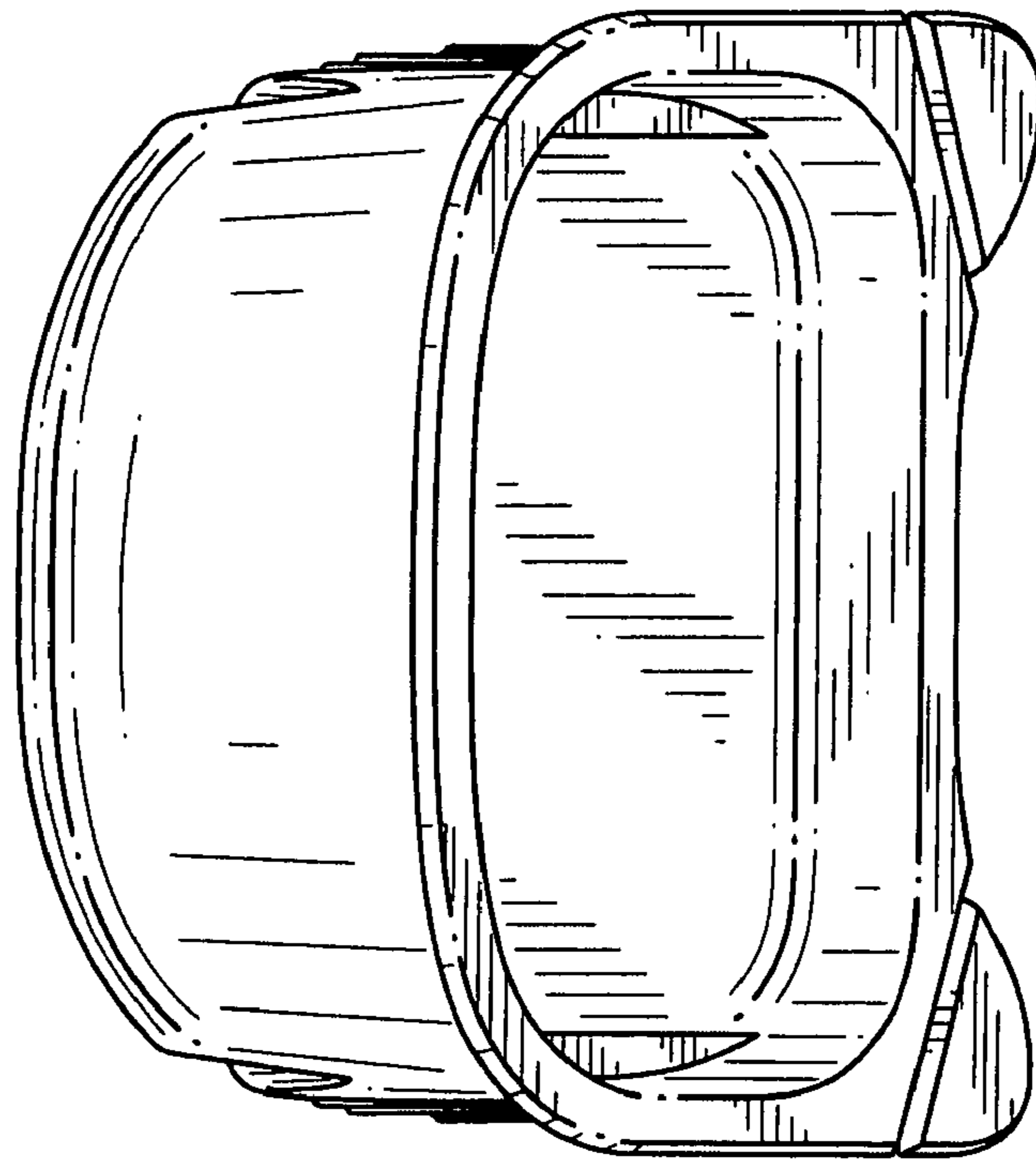

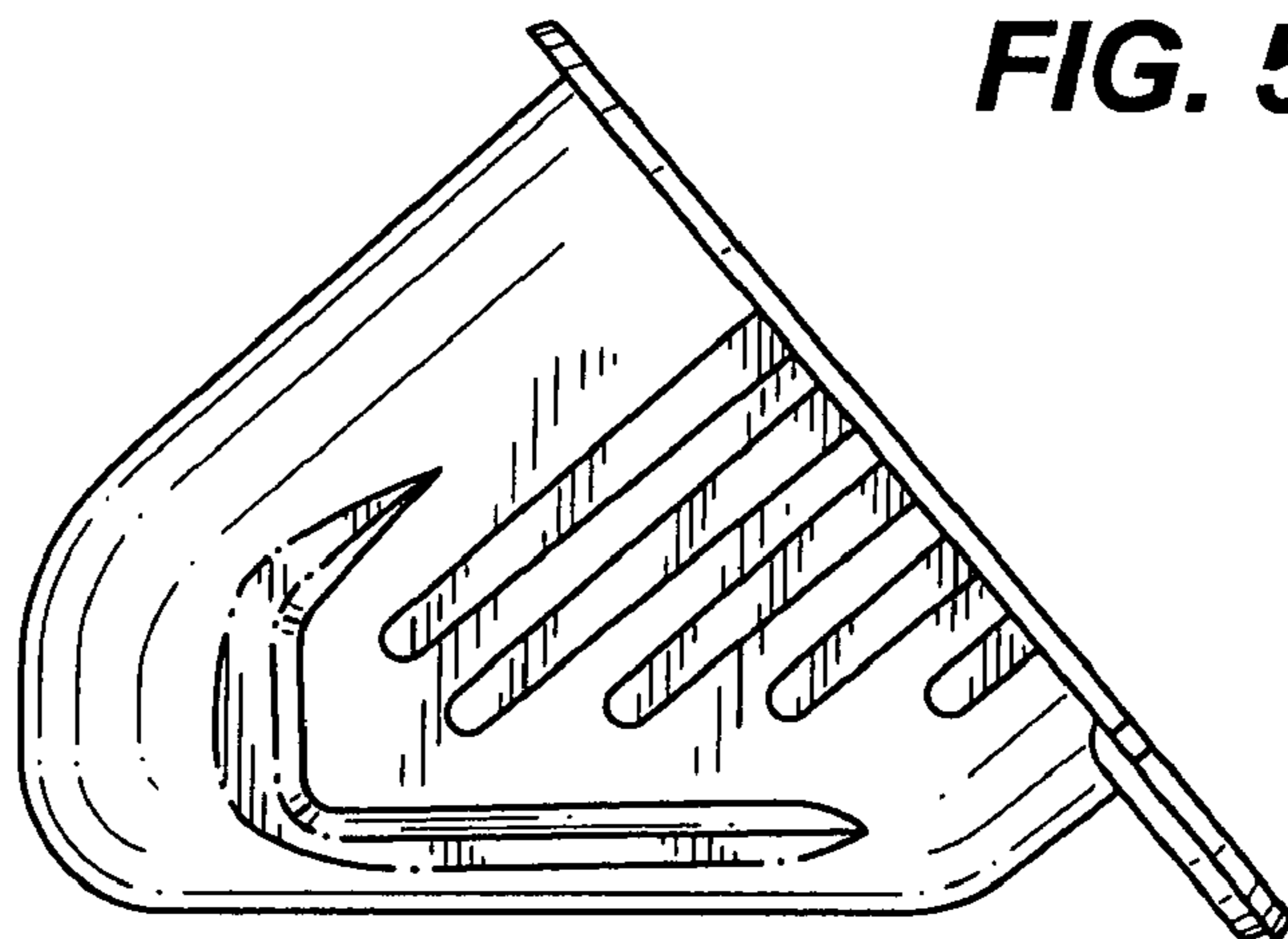
