FIG. 3 is a rear elevation view of the fragrance bottle and cap shown in FIG. 1;

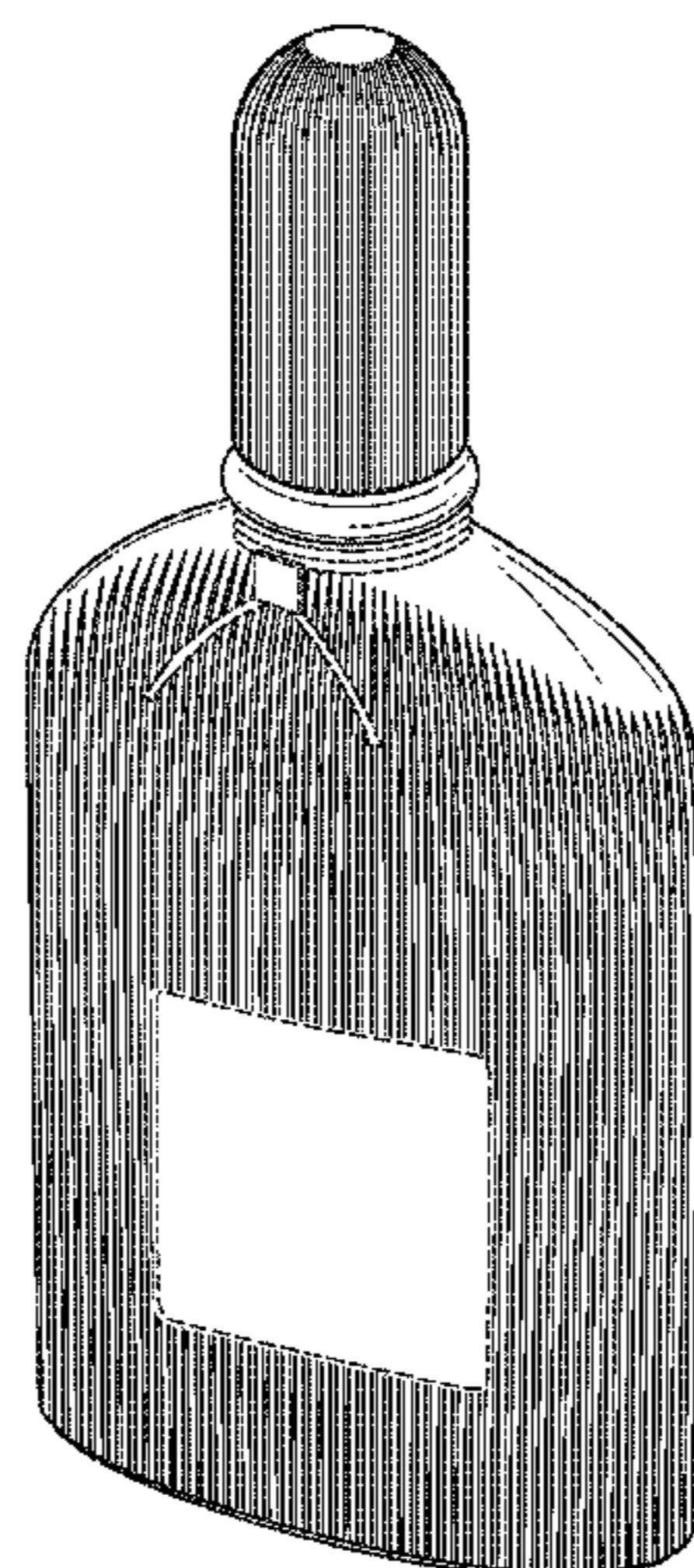
FIG. 4 is a right side elevation view of the fragrance bottle and cap shown in FIG. 1, a left side elevation view being a mirror image thereof;

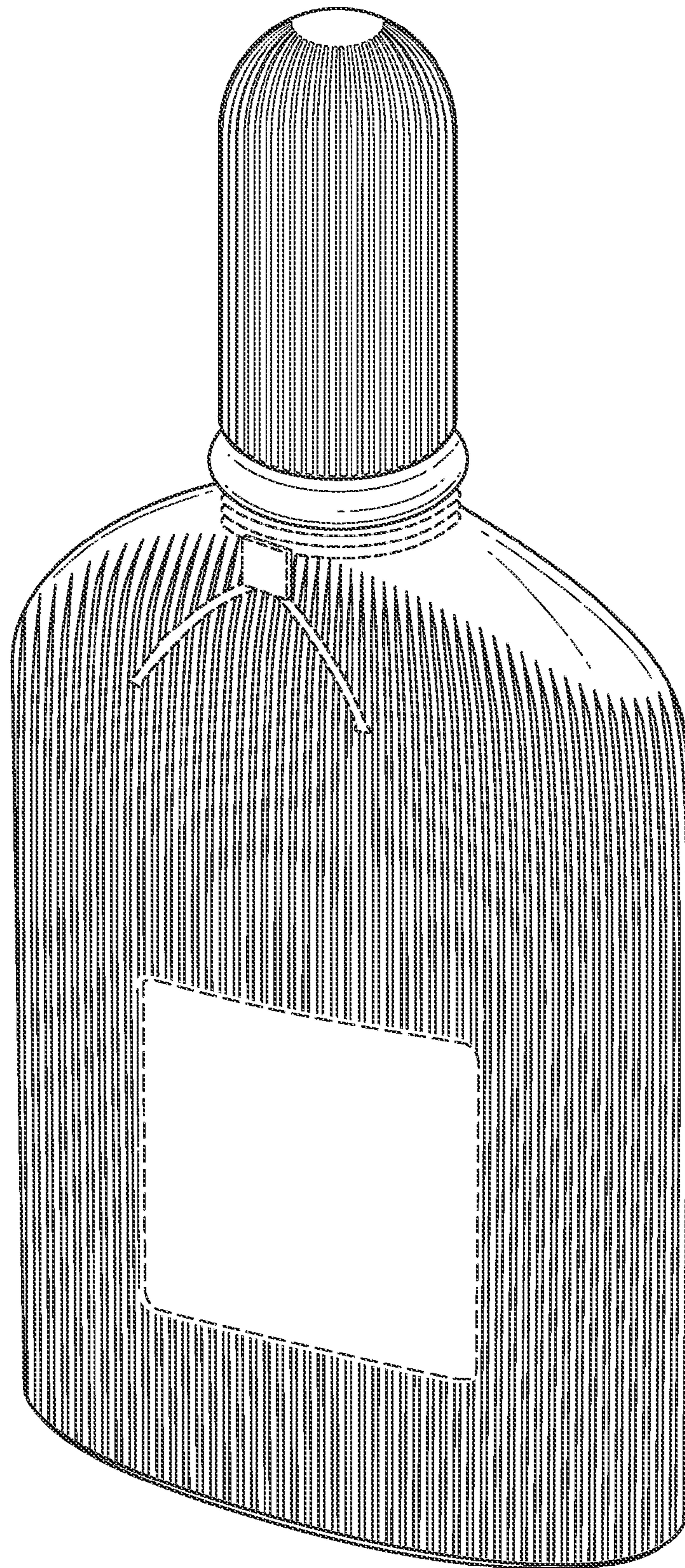

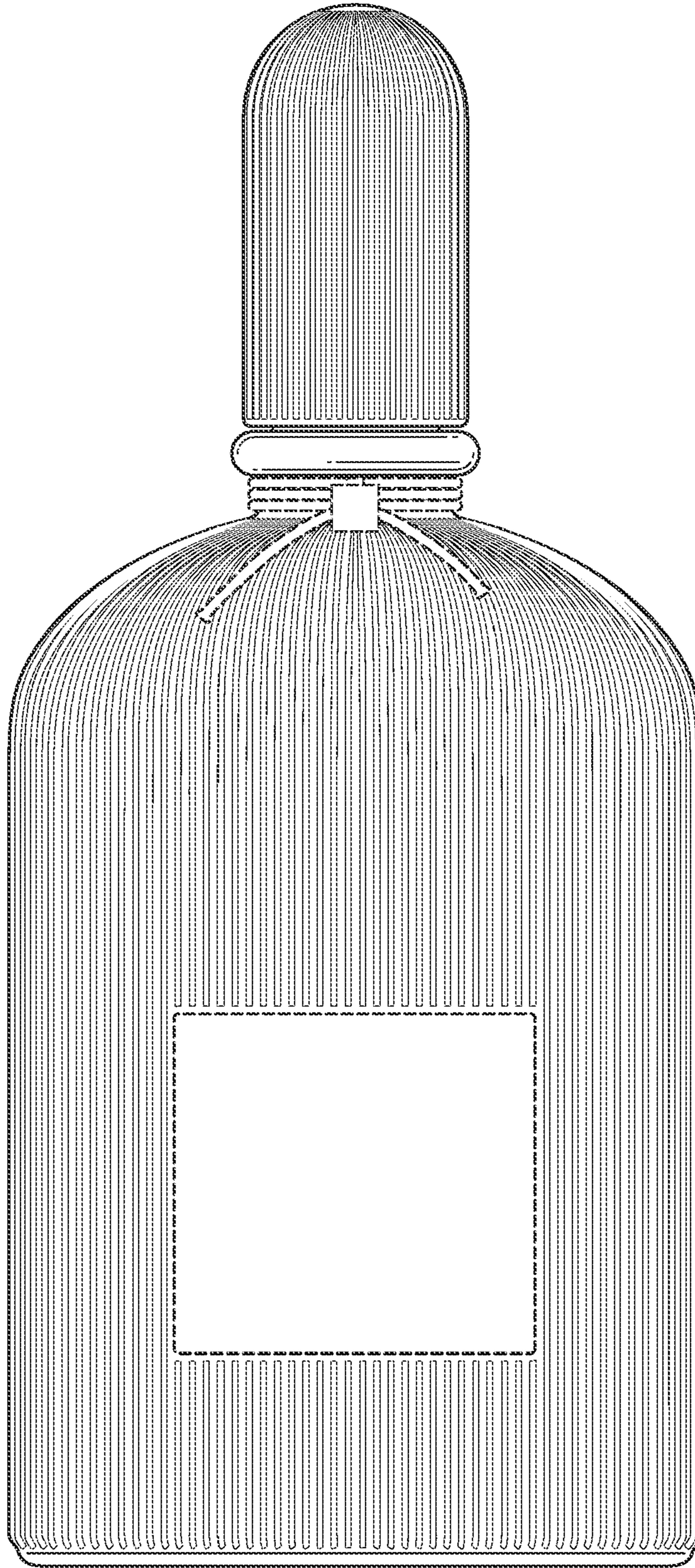

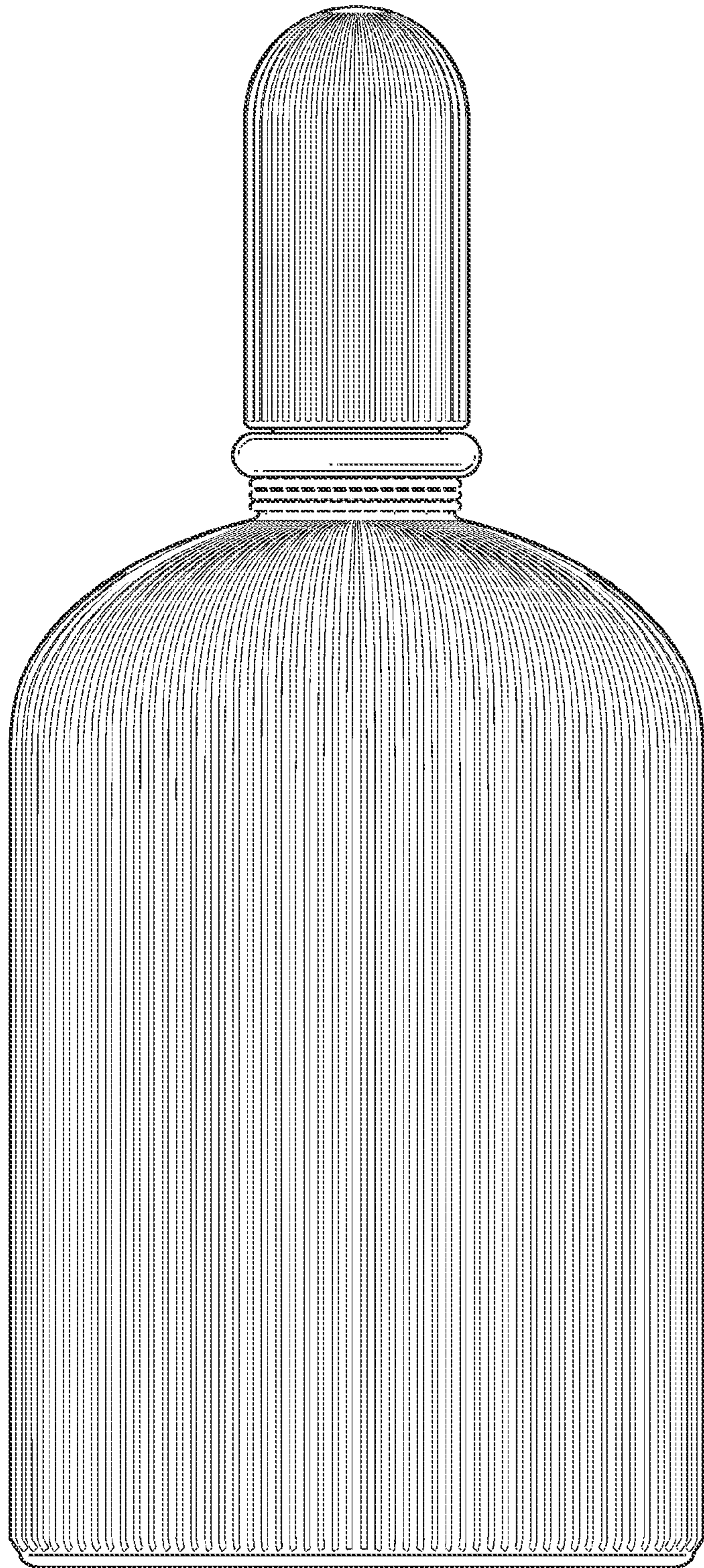

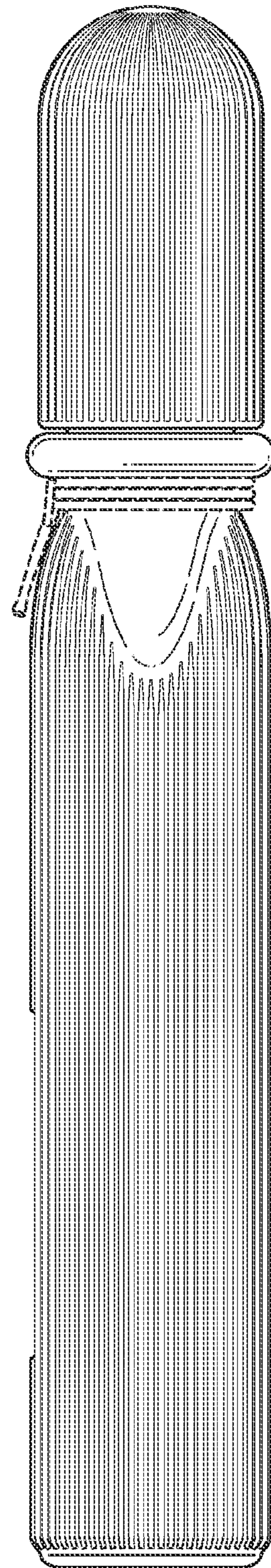

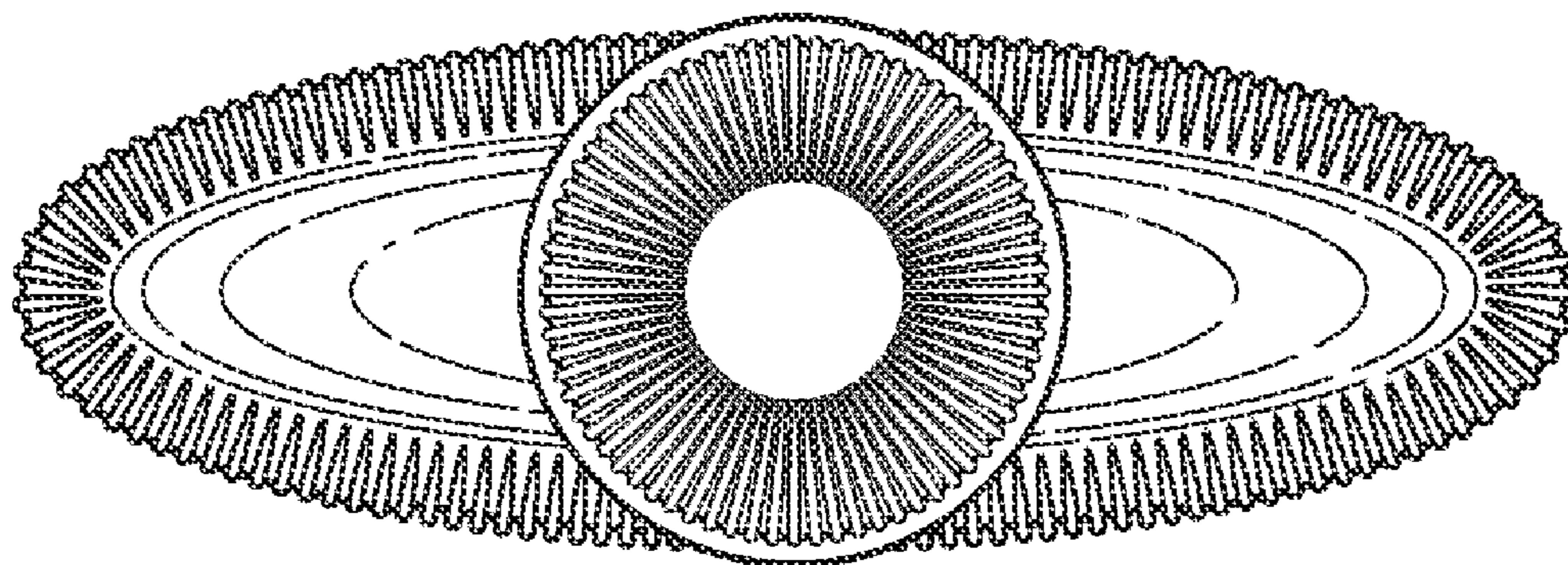
