DESCRIPTION

FIG. 1 is a front view of a telephone set showing the new design.

FIG. 3 is a right side view of the telephone set shown without the handset.

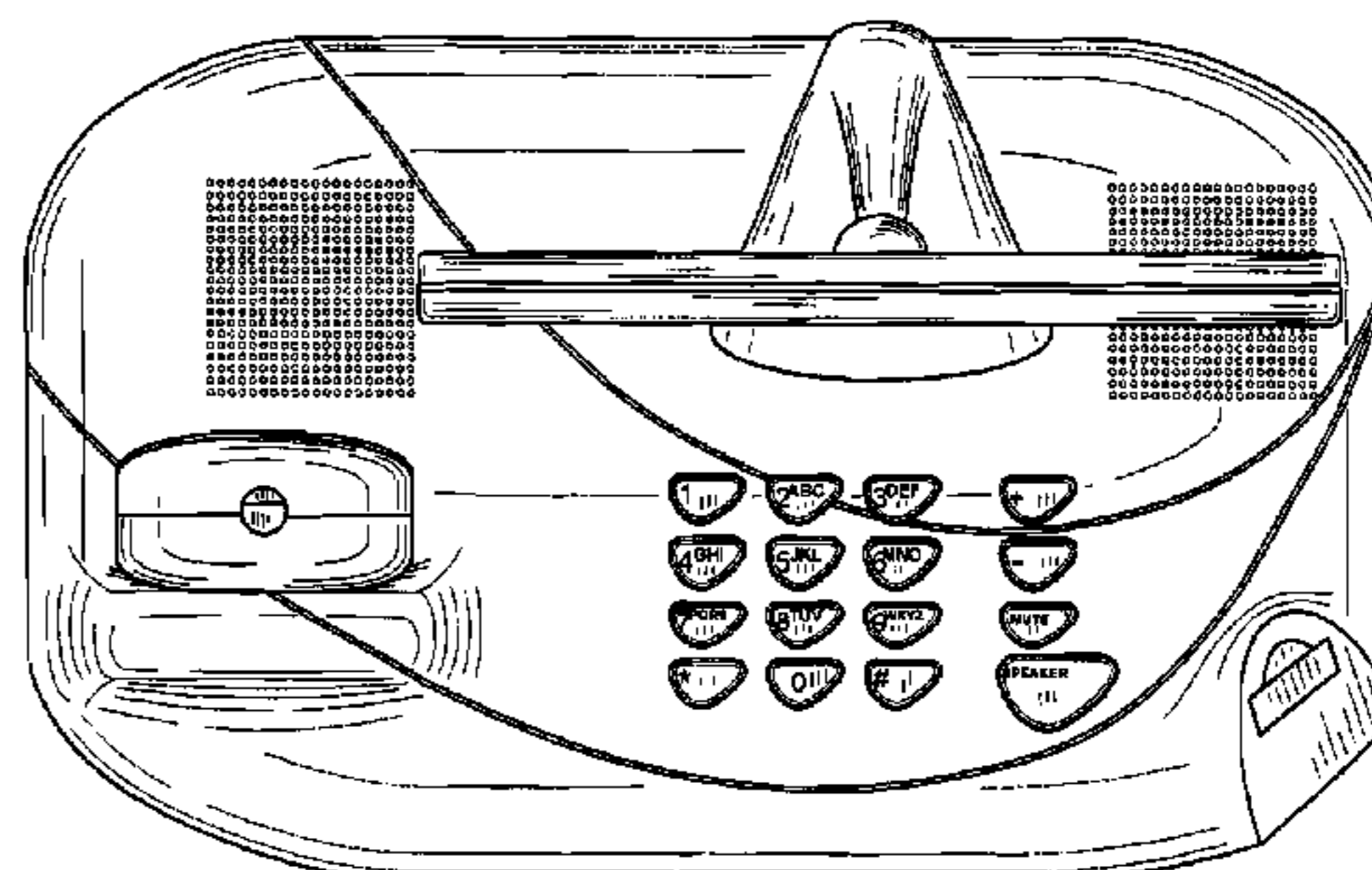
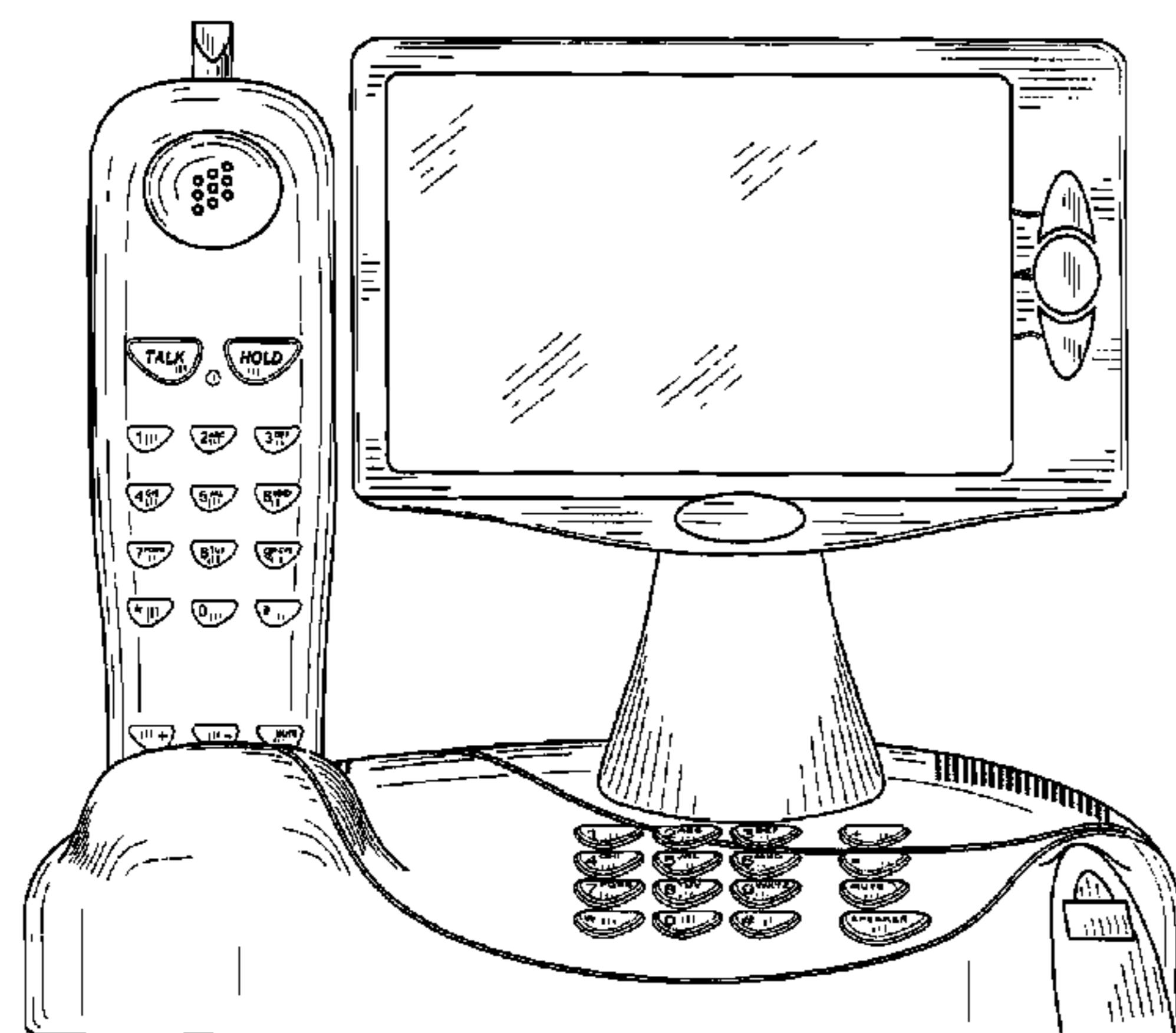
FIG. 4 is a rear view of the telephone set.

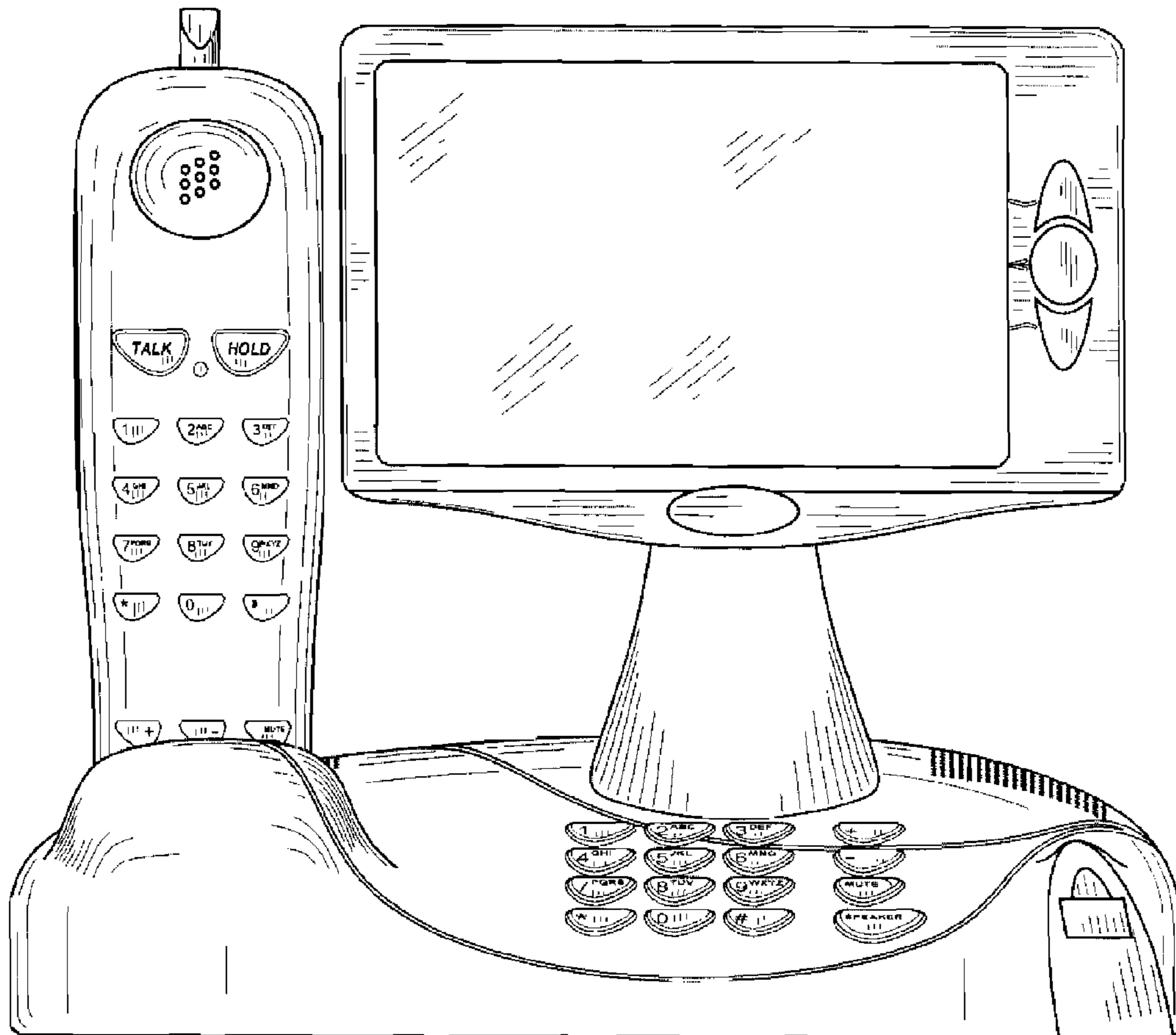

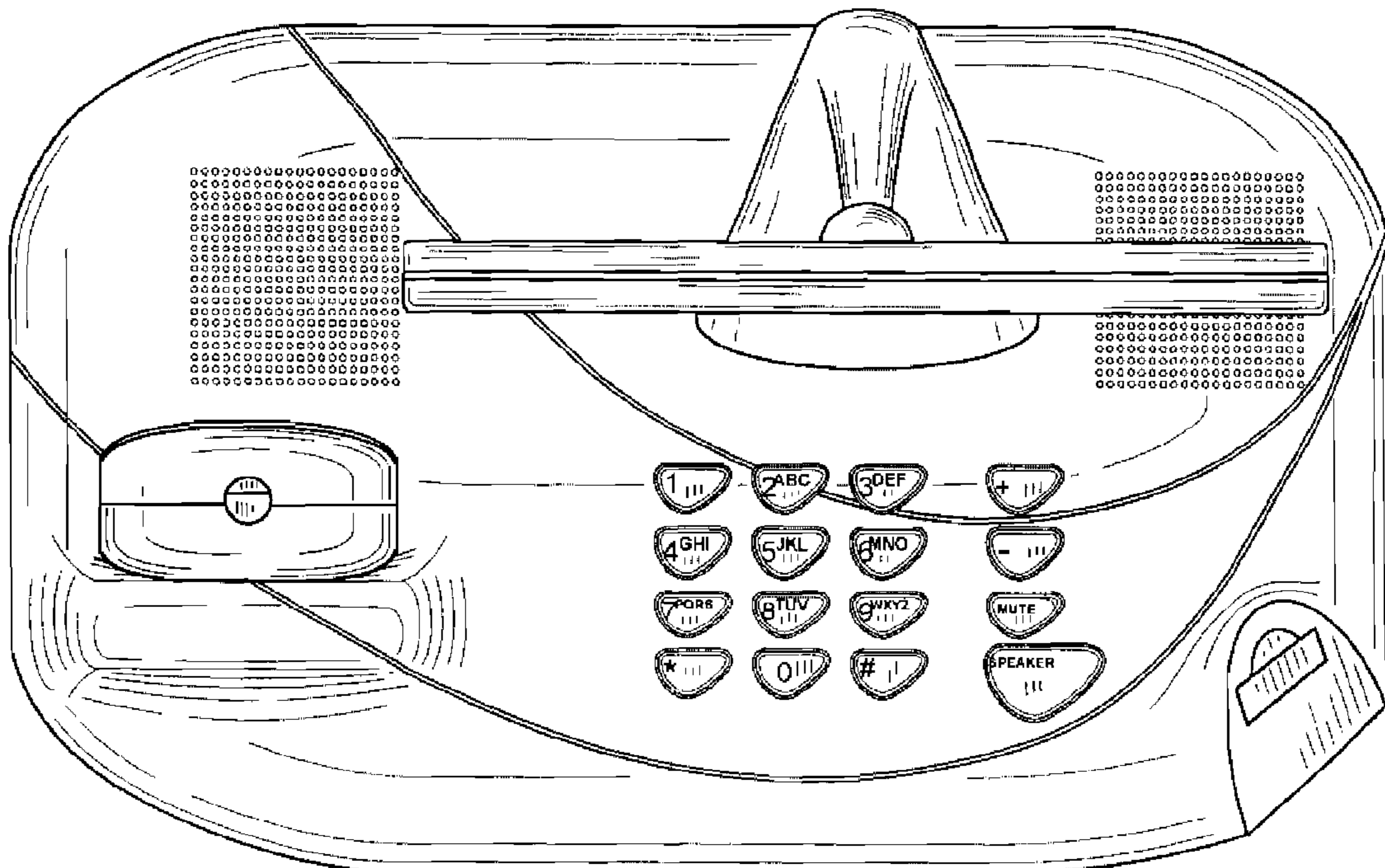

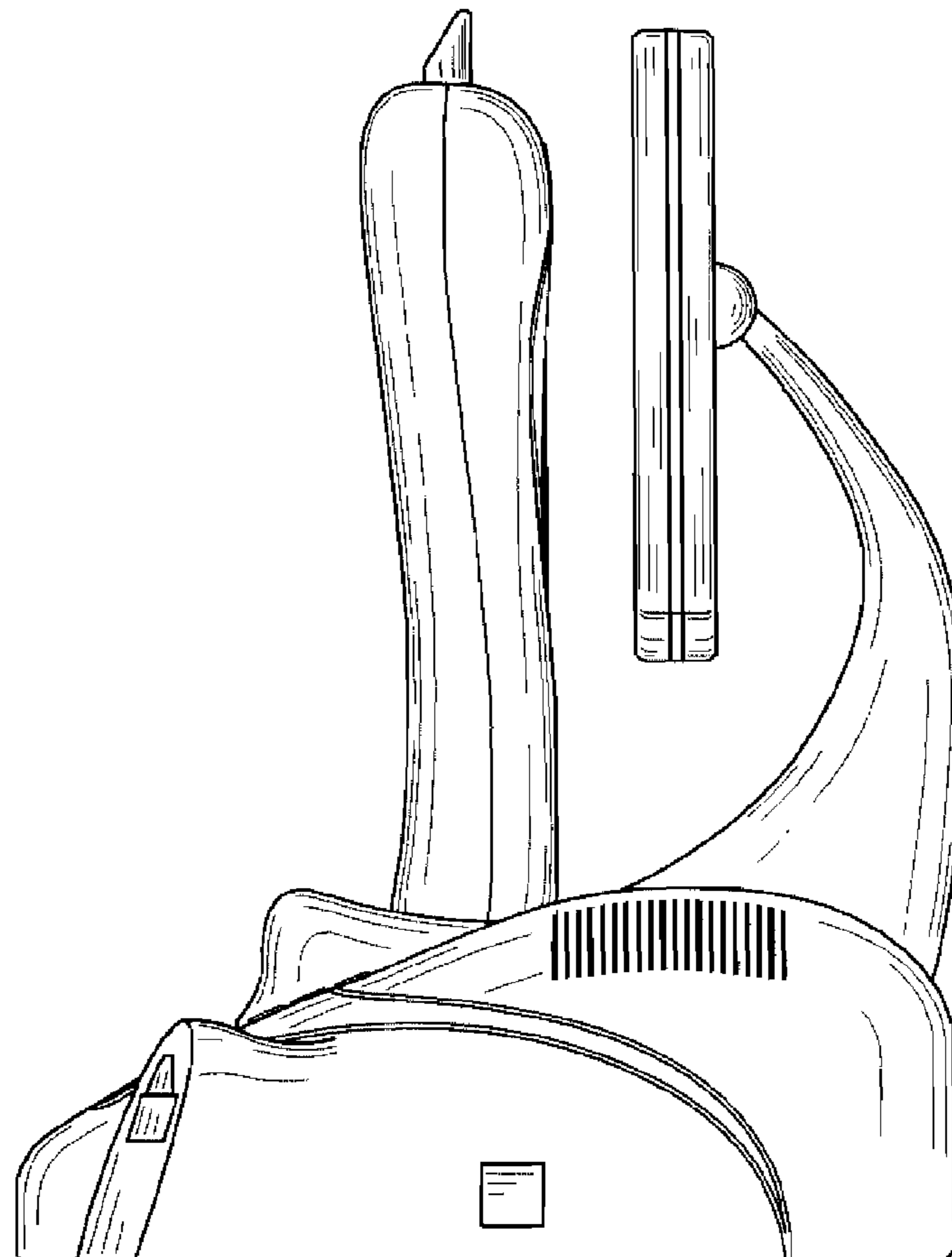

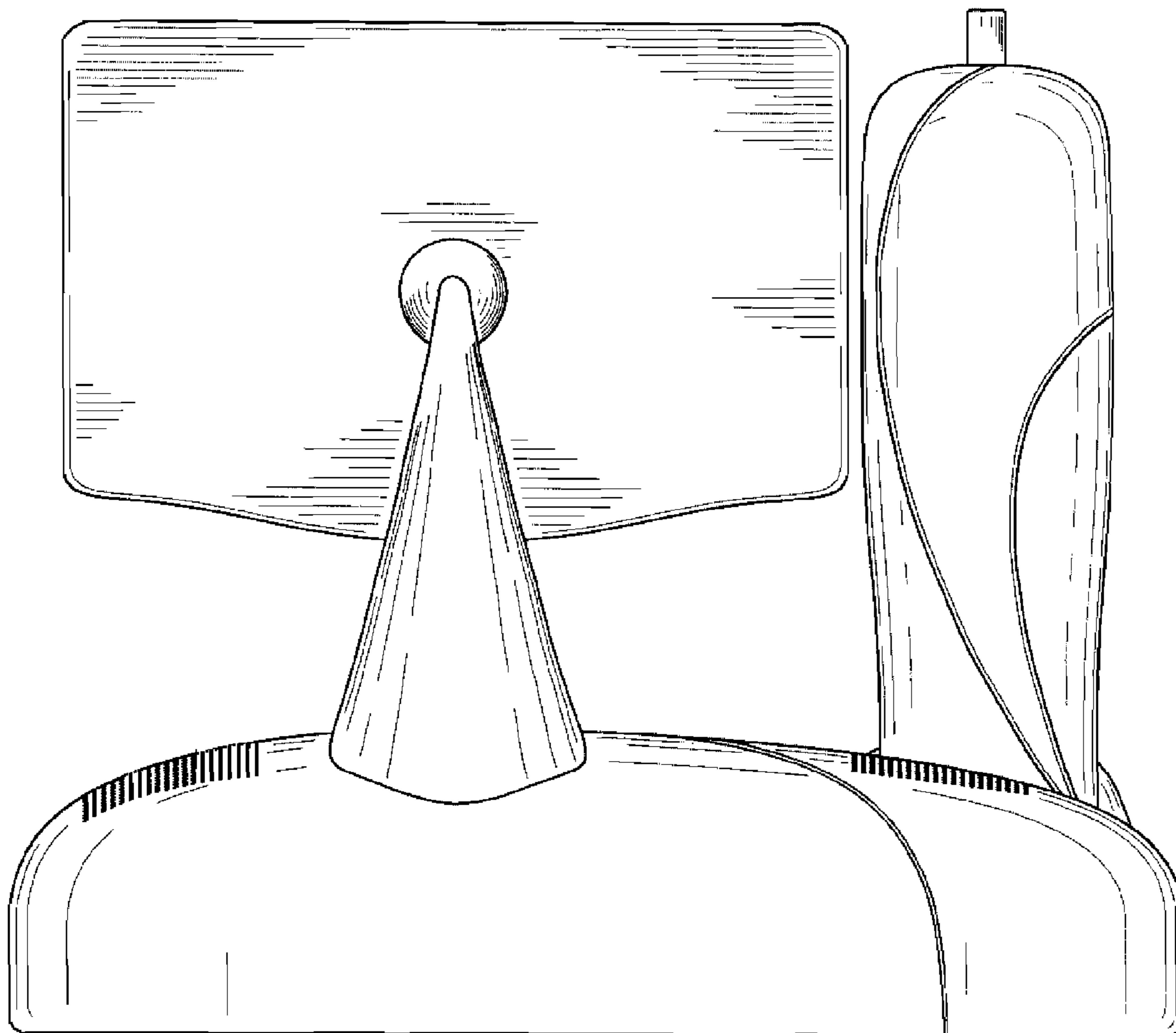

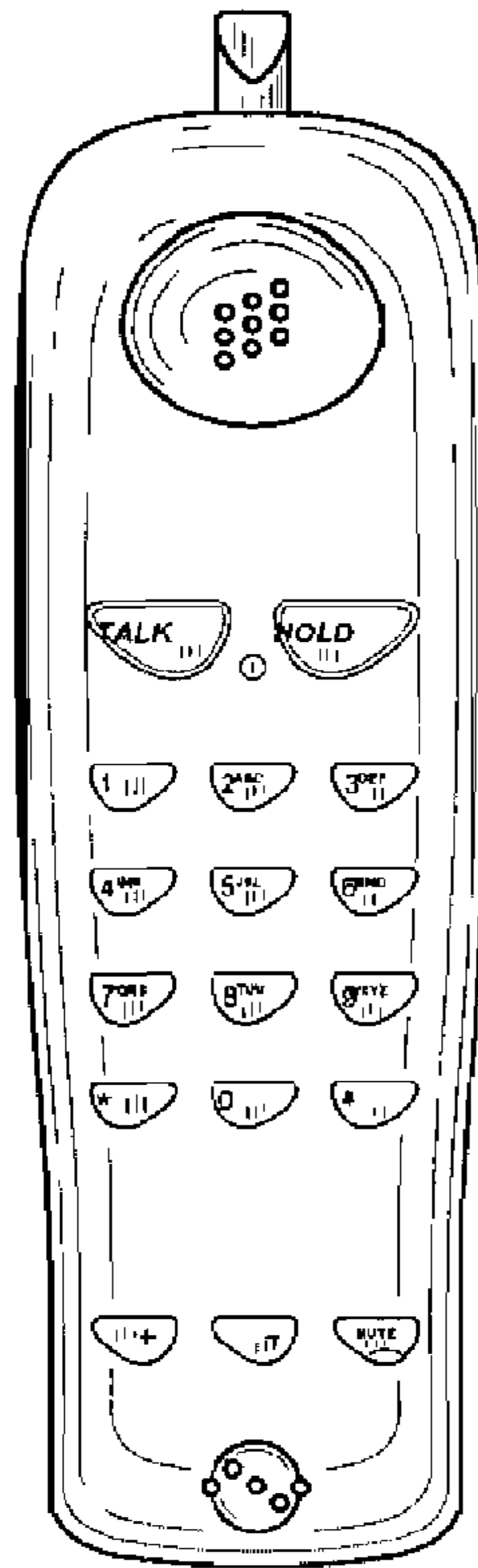

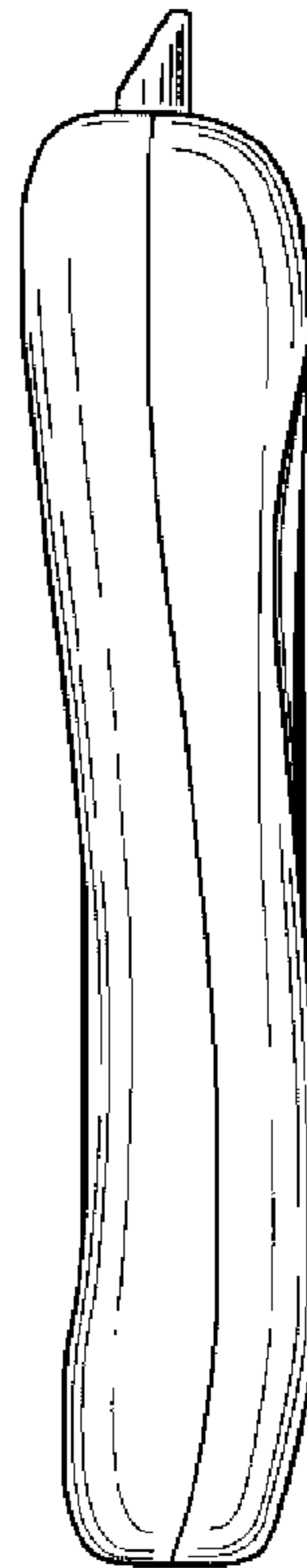
