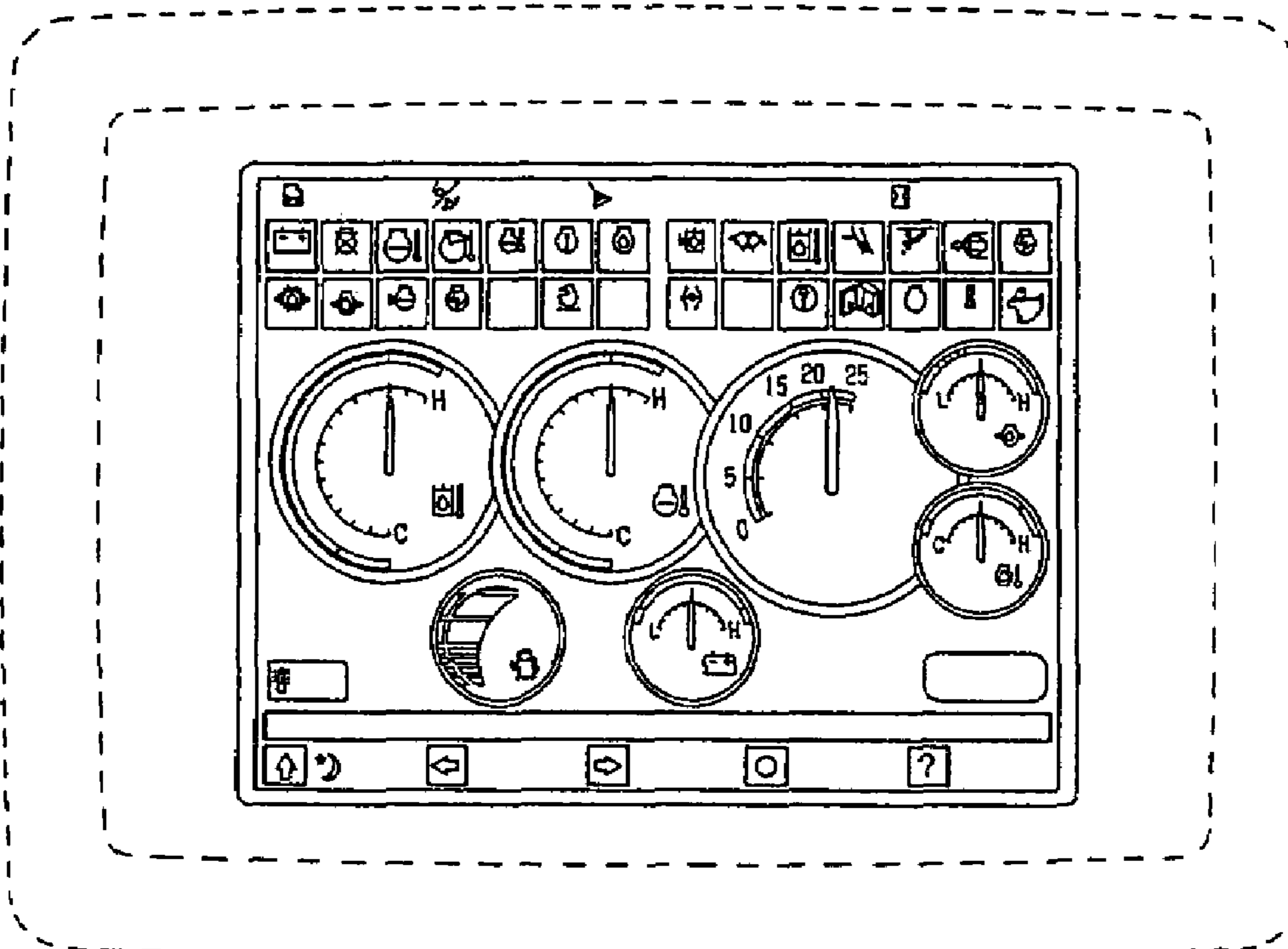
We claim the ornamental design for graphic user interface for display for construction machine, as shown.

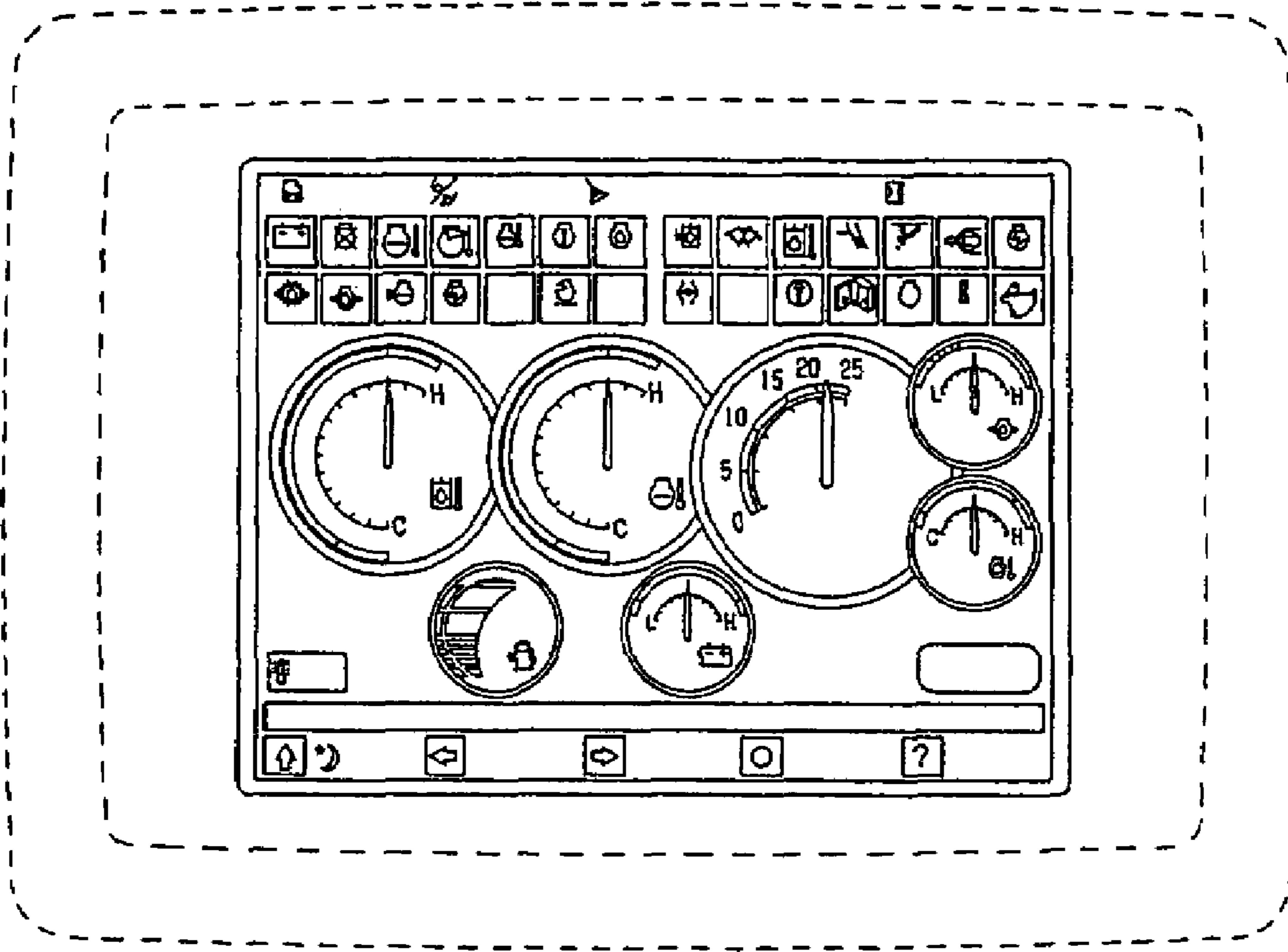
DESCRIPTION
