FIG. 3 is a bottom view of the engine shroud of FIG. 1;

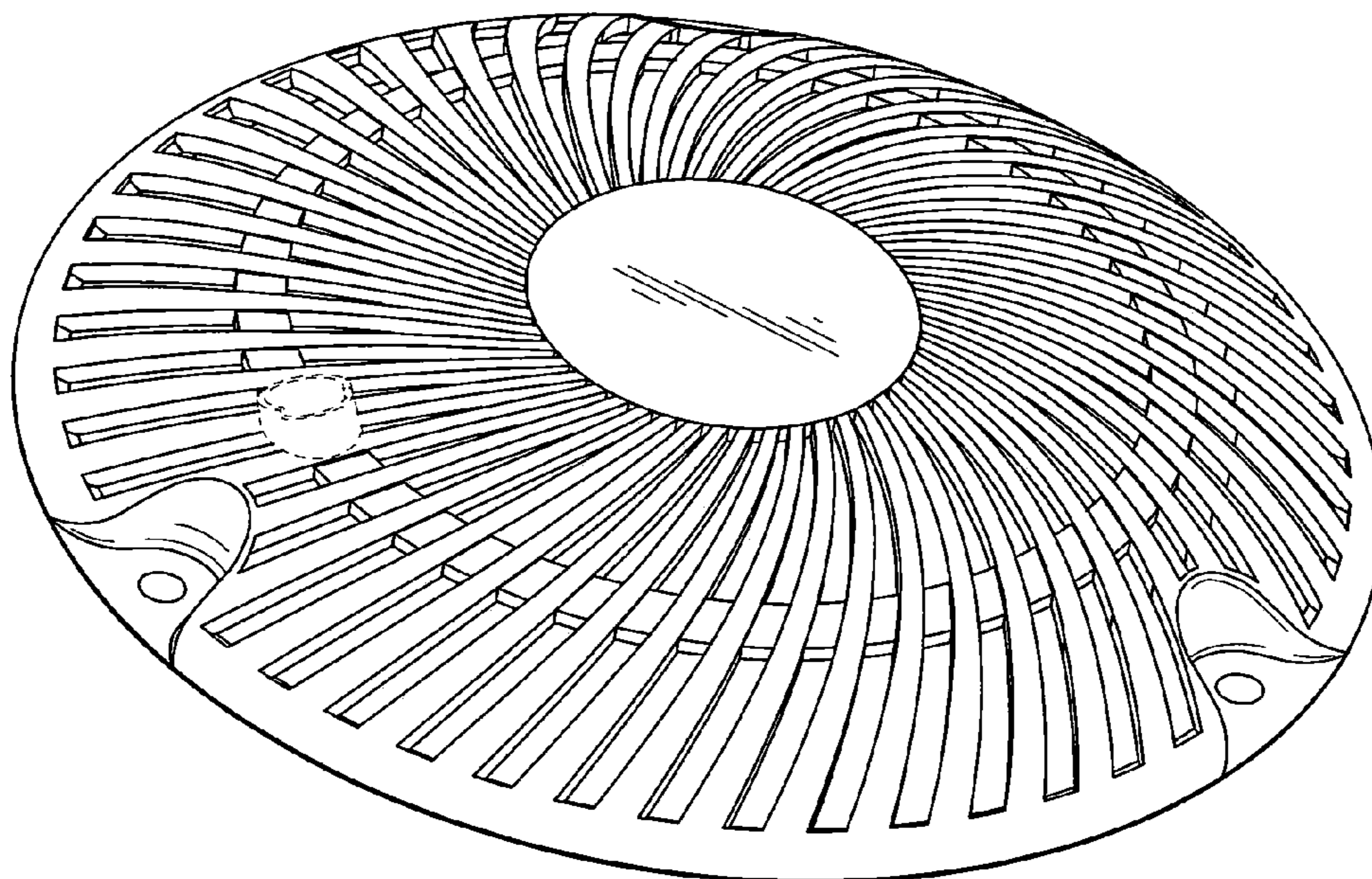
FIG. 4 is a right side view of the engine shroud of FIG. 1;

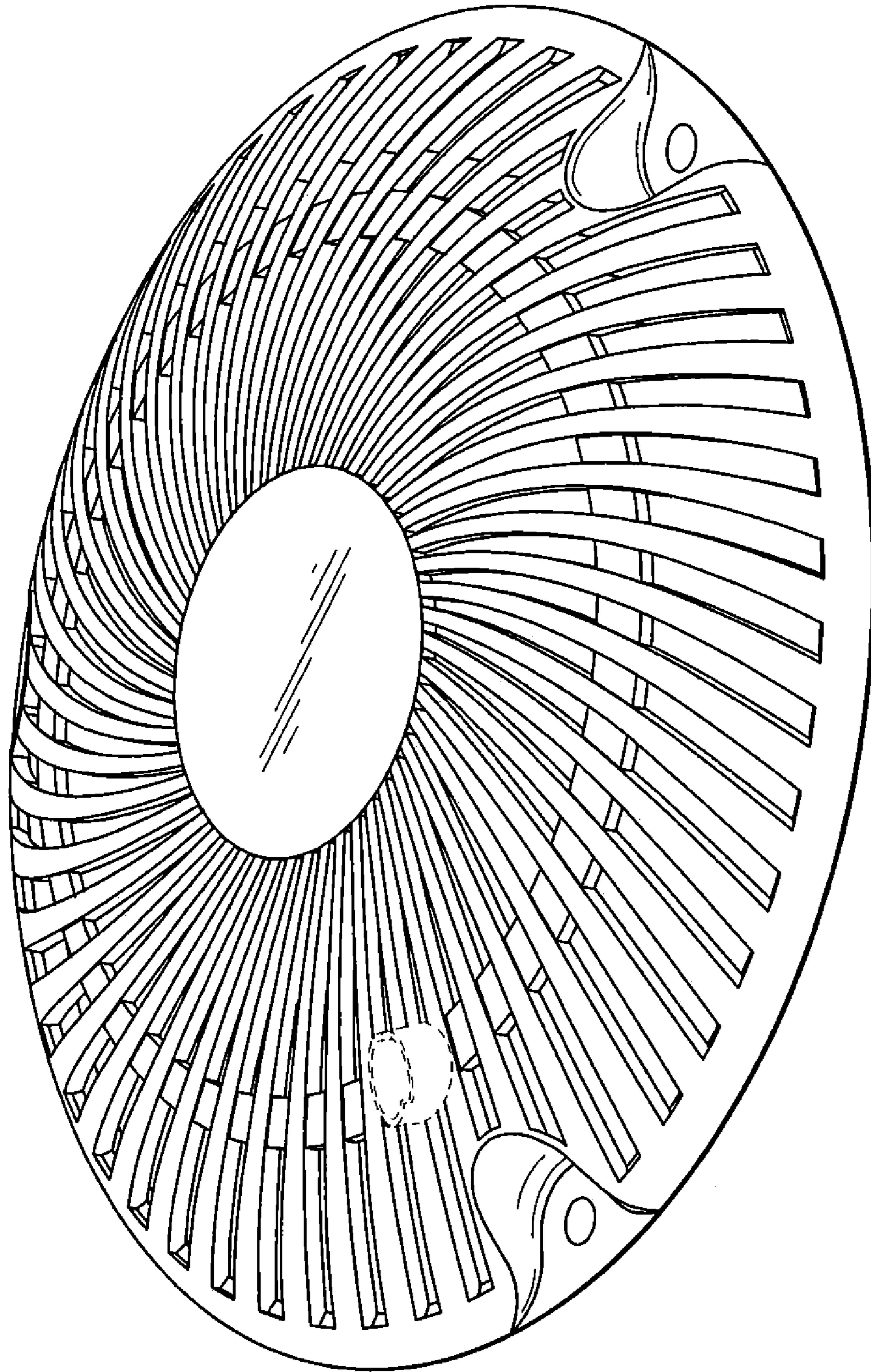
FIG. 5 is a left side view of the engine shroud of FIG. 1; and,

FIG. 6 is a front view of the engine shroud of FIG. 1.

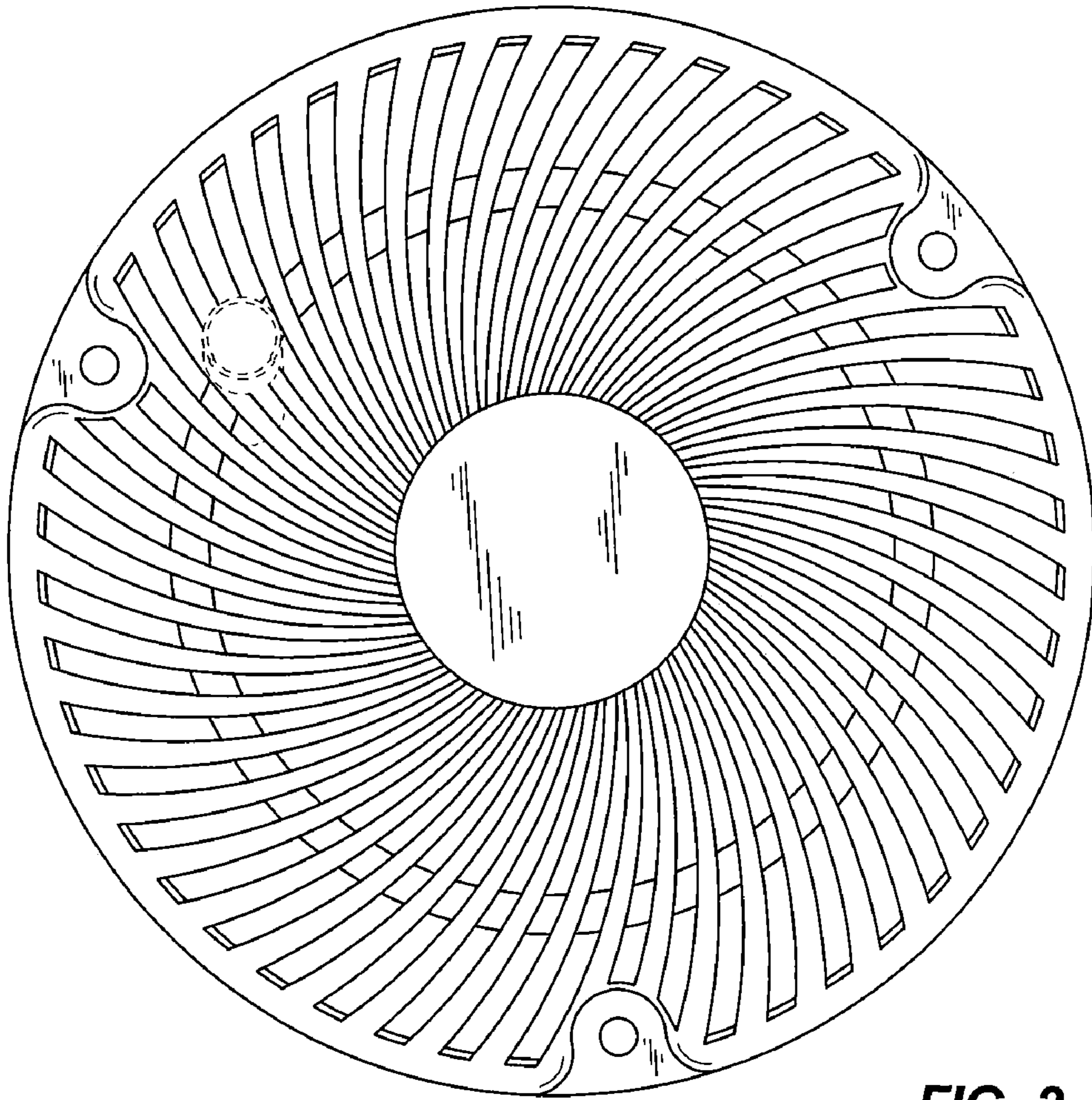

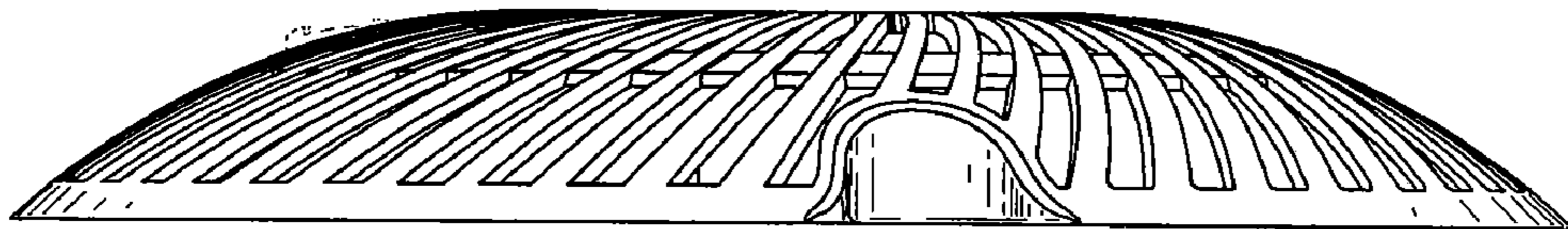




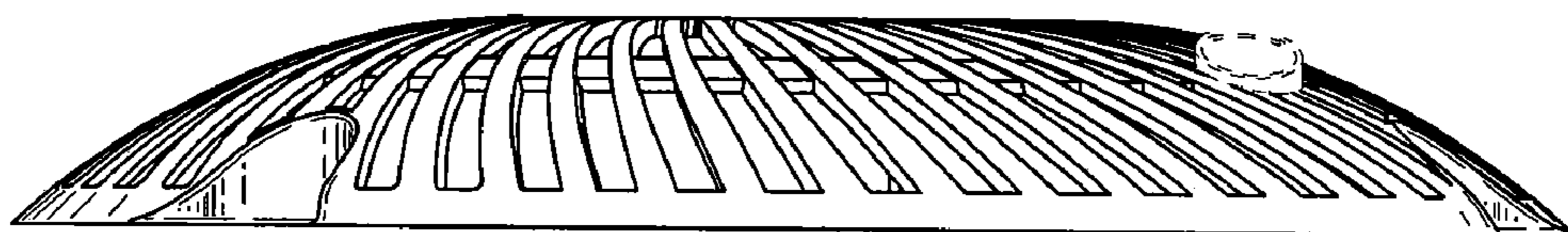

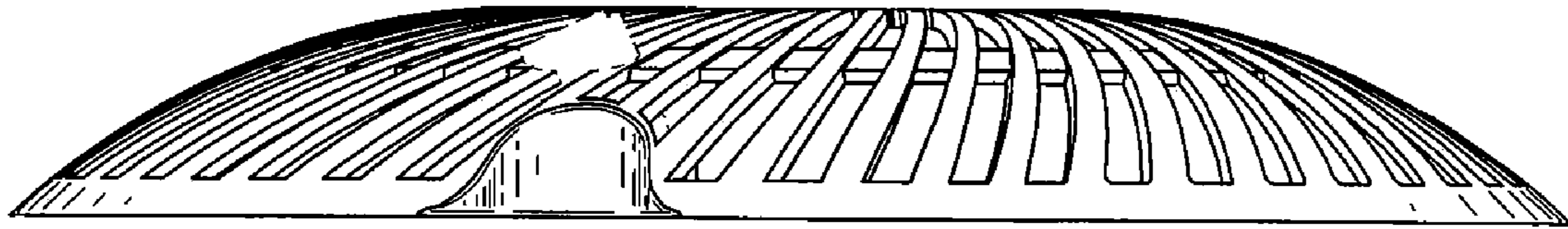

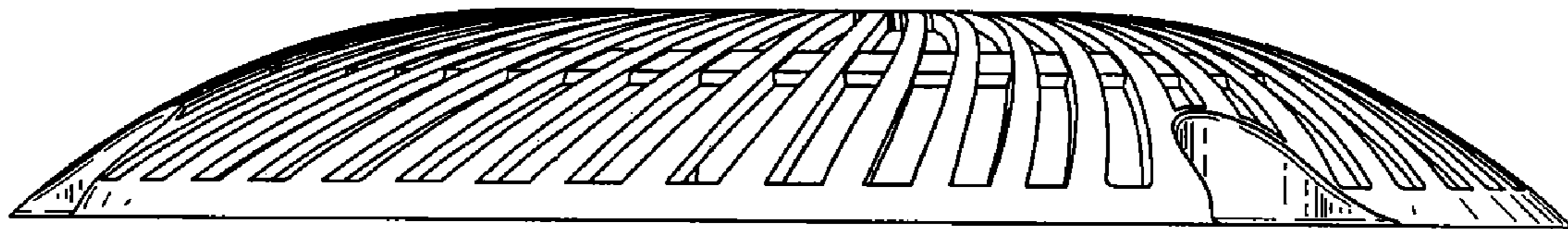
