**DESCRIPTION**

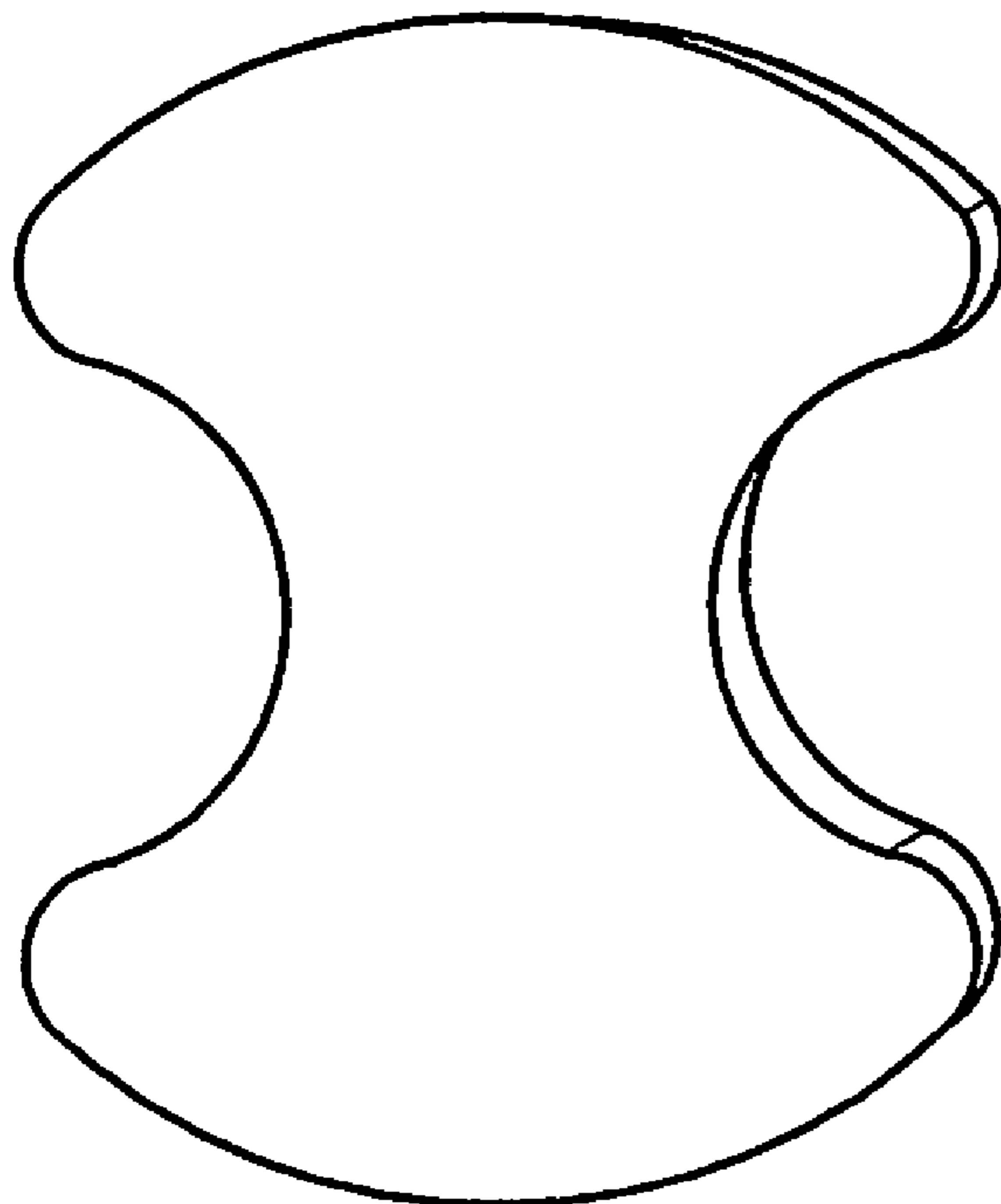
FIG. 1 is a perspective view of the I-shaped oral device of our design;

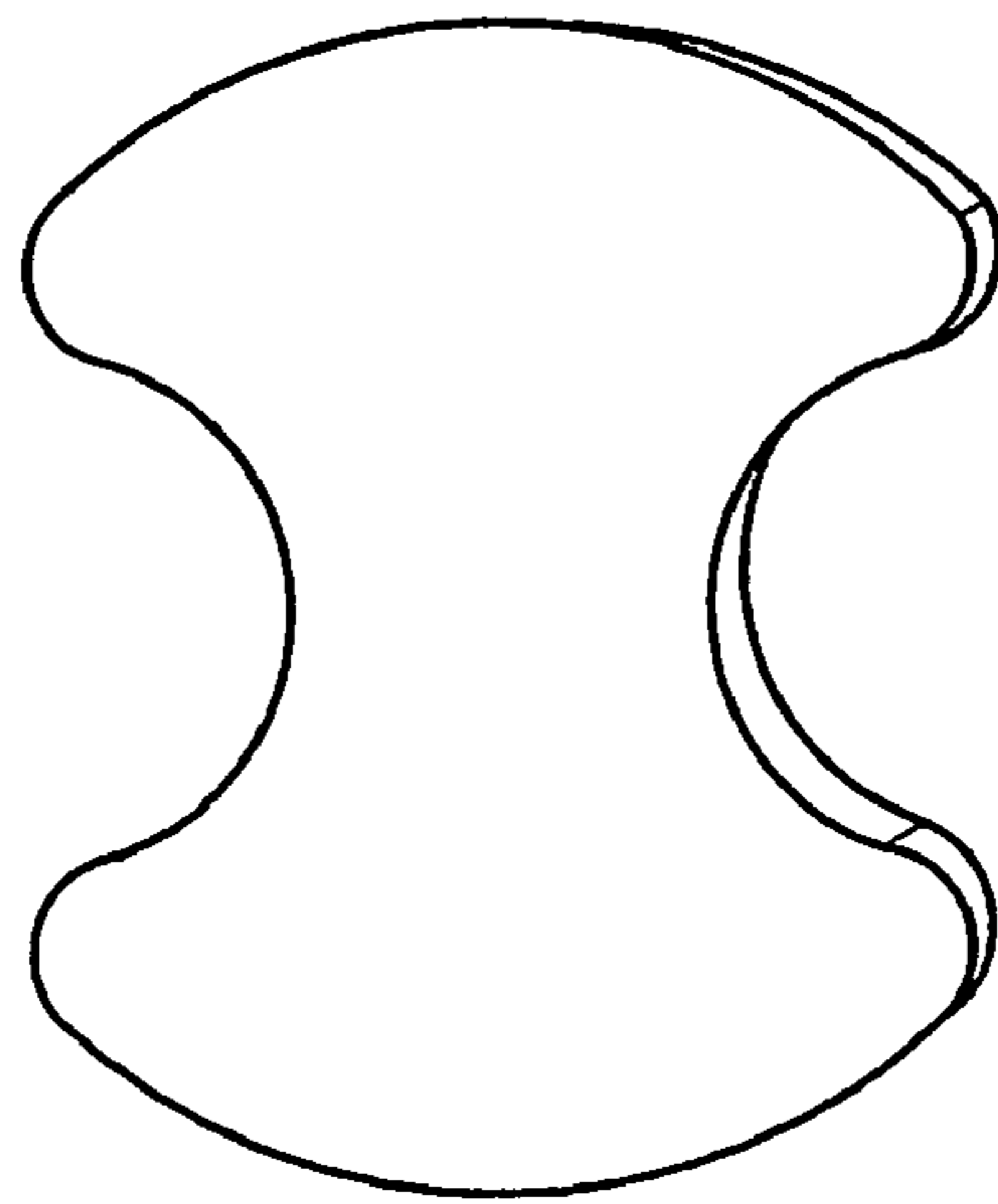

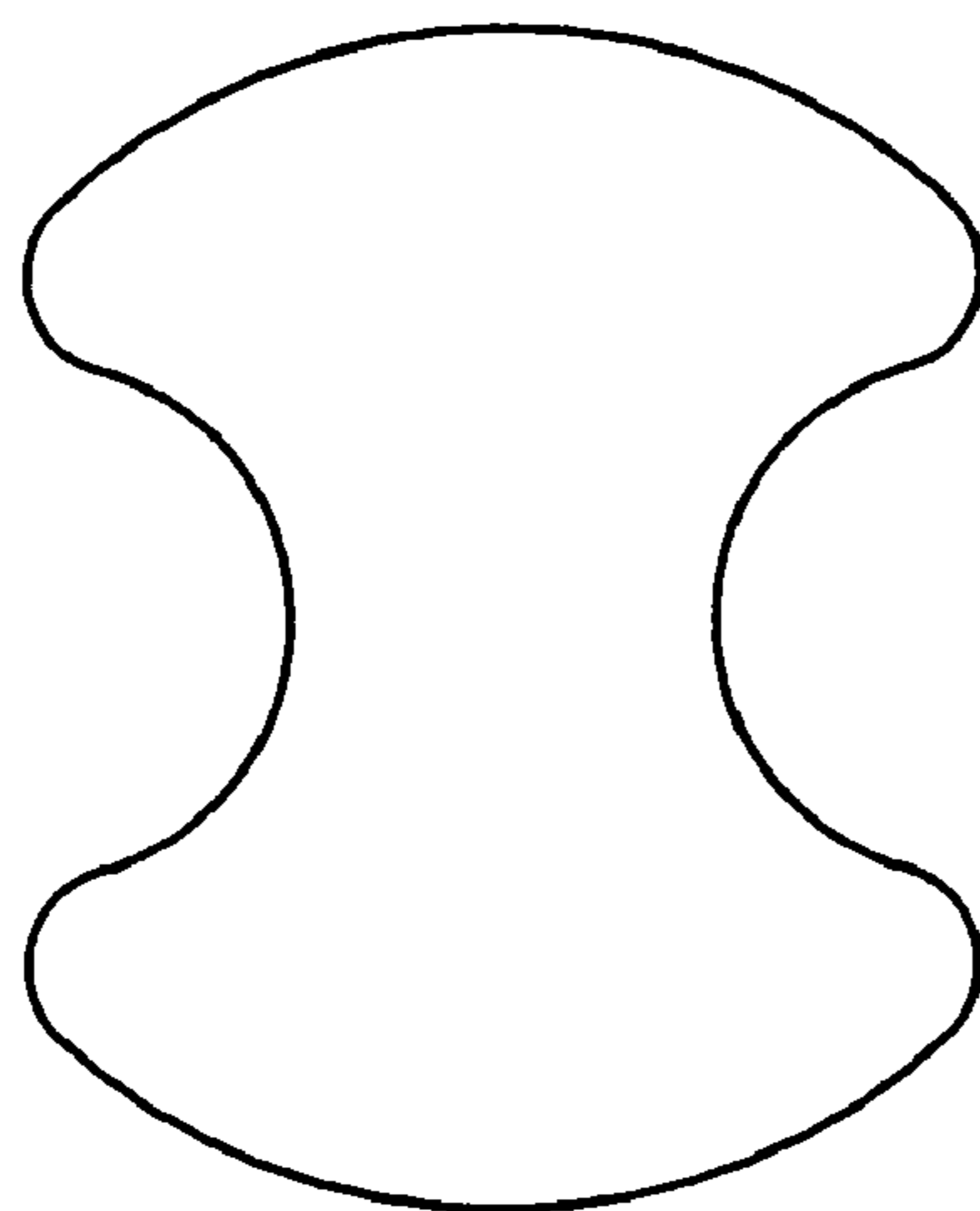
