FIG. 3 is a rear view of the design according to the invention.

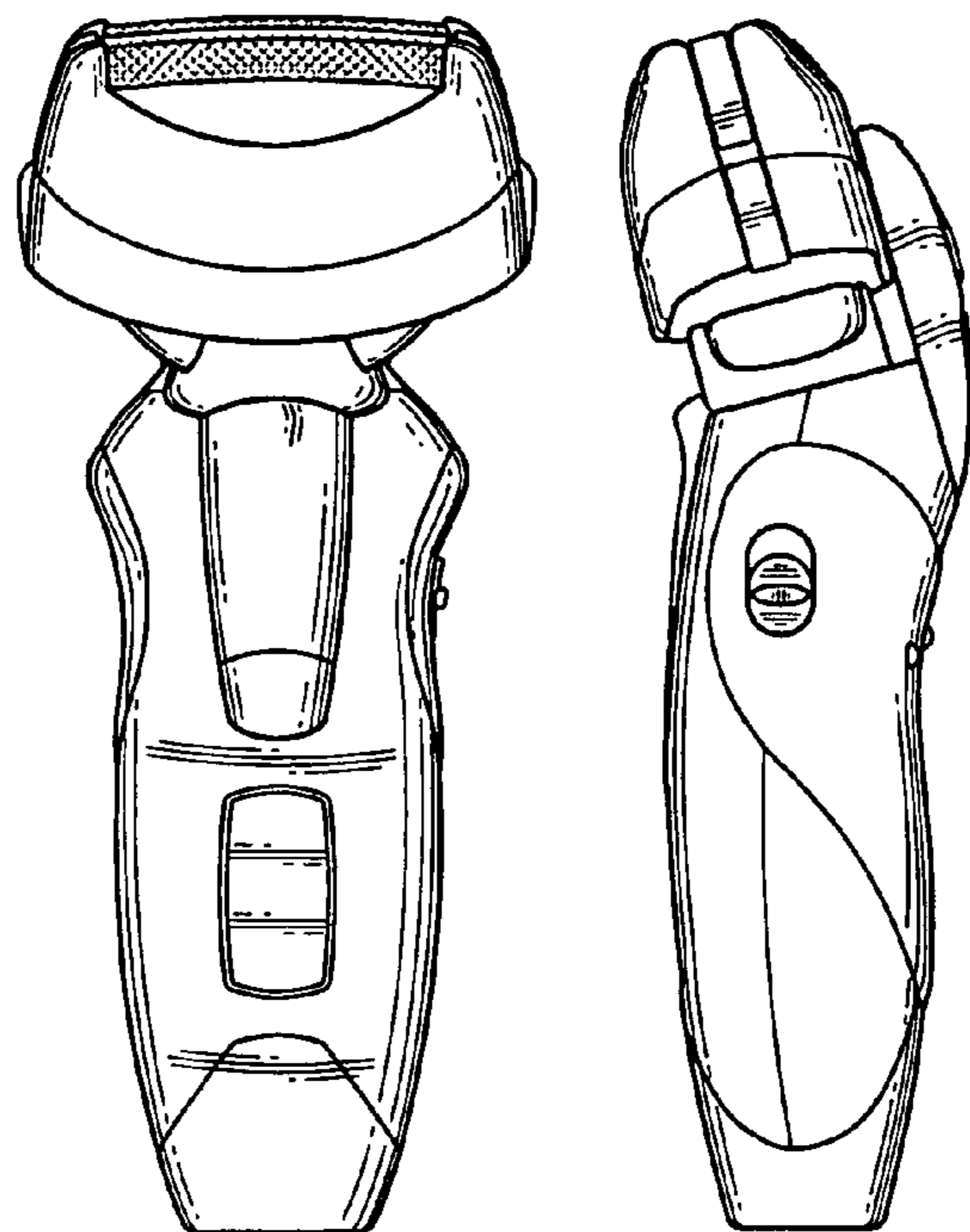
FIG. 4 is a left side view of the design according to the invention.

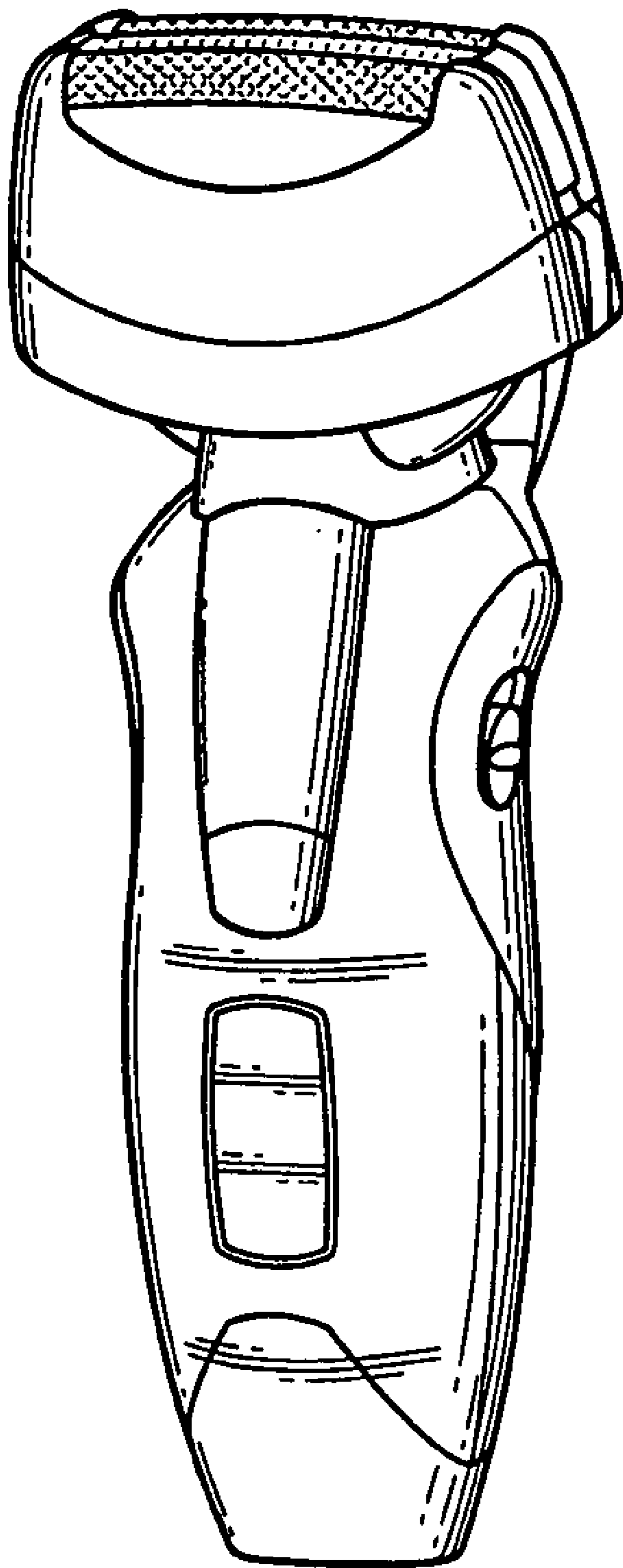
FIG. 5 is a right side view of the design according to the invention.

FIG. 6 is a top view of the design according to the invention; and,

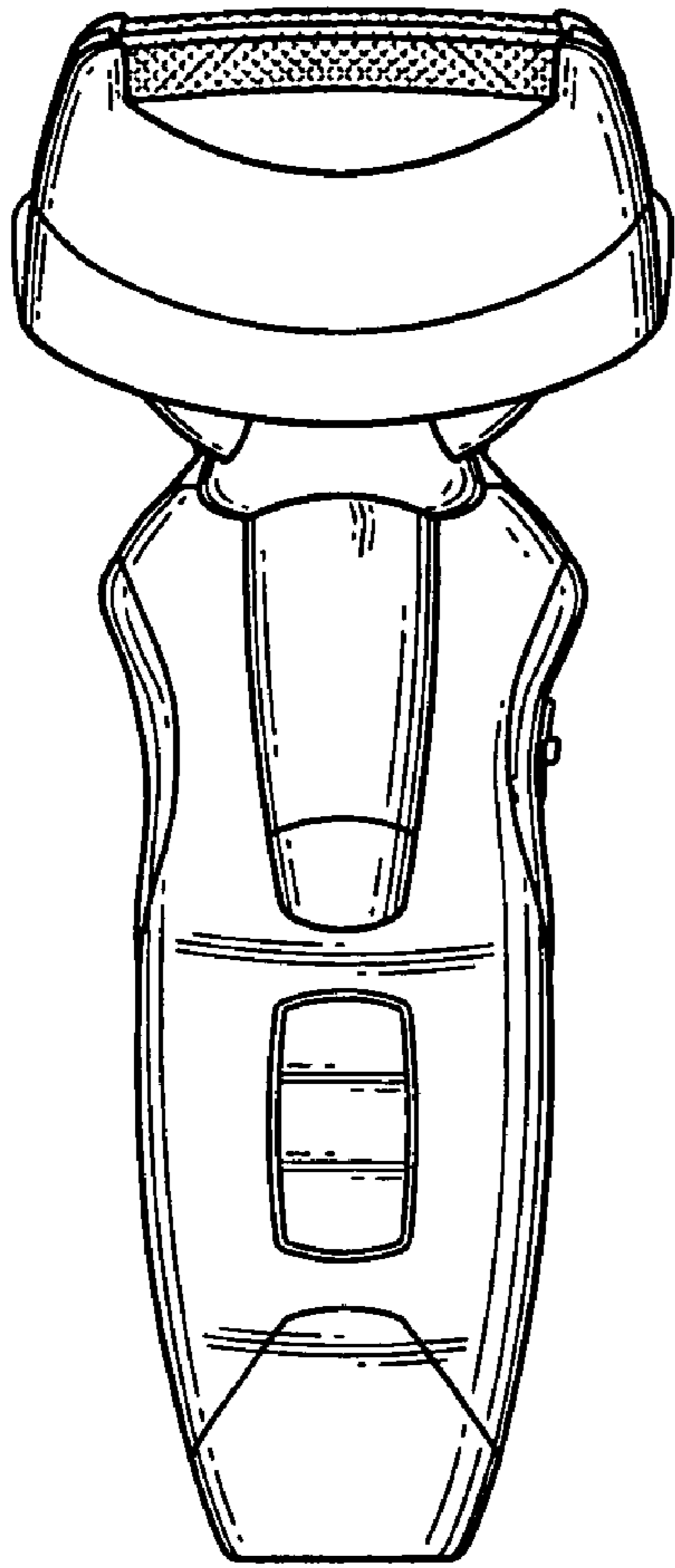
FIG. 7 is a bottom view of the design according to the invention.

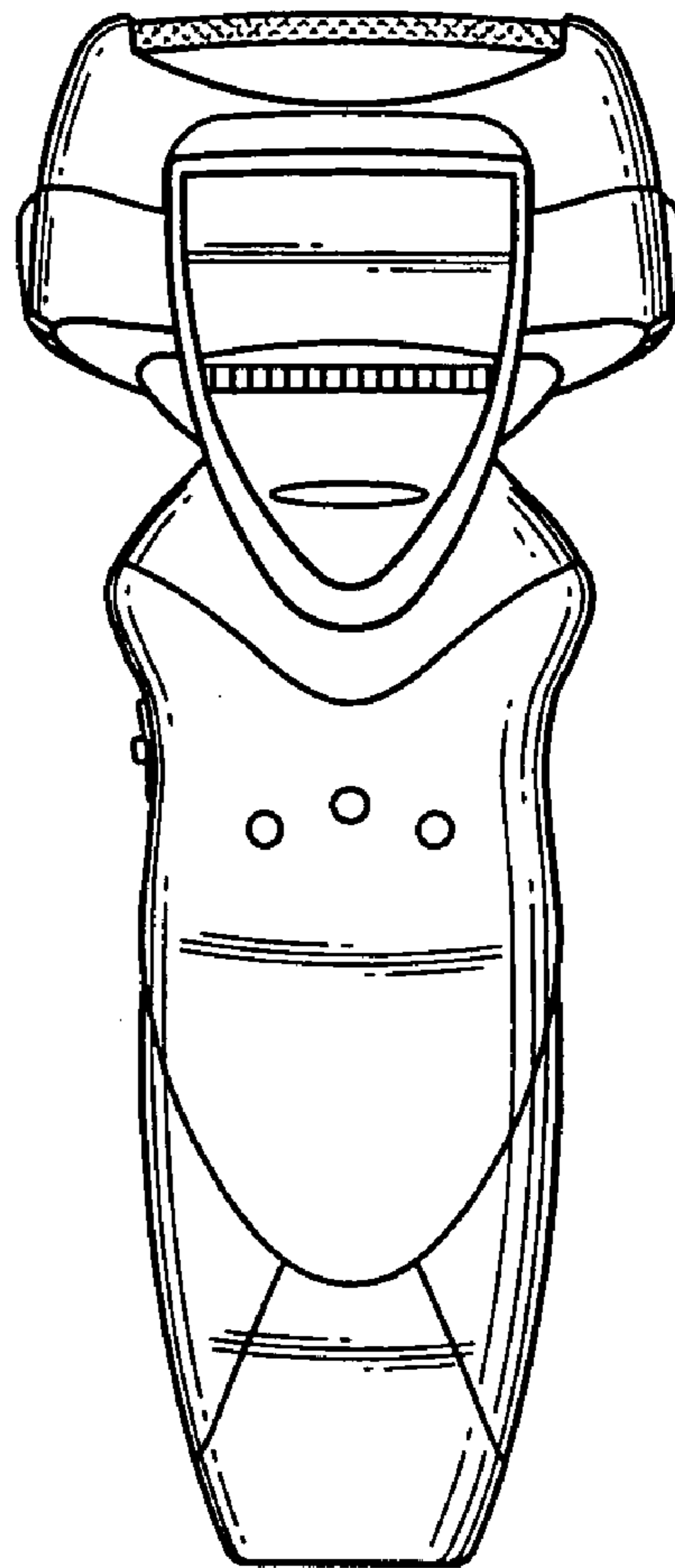




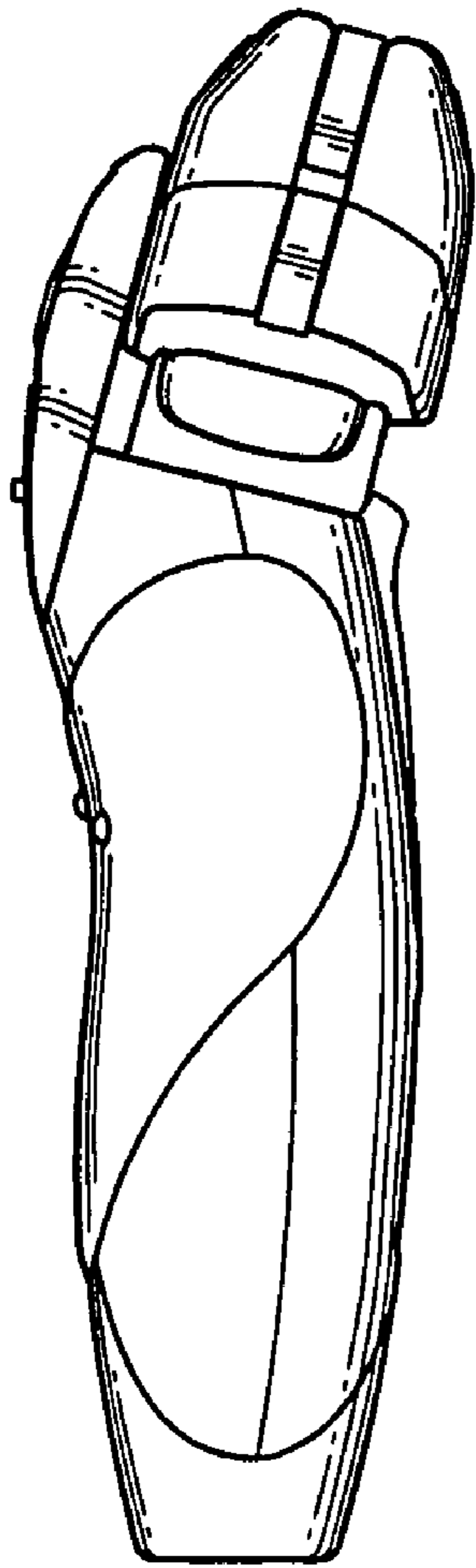

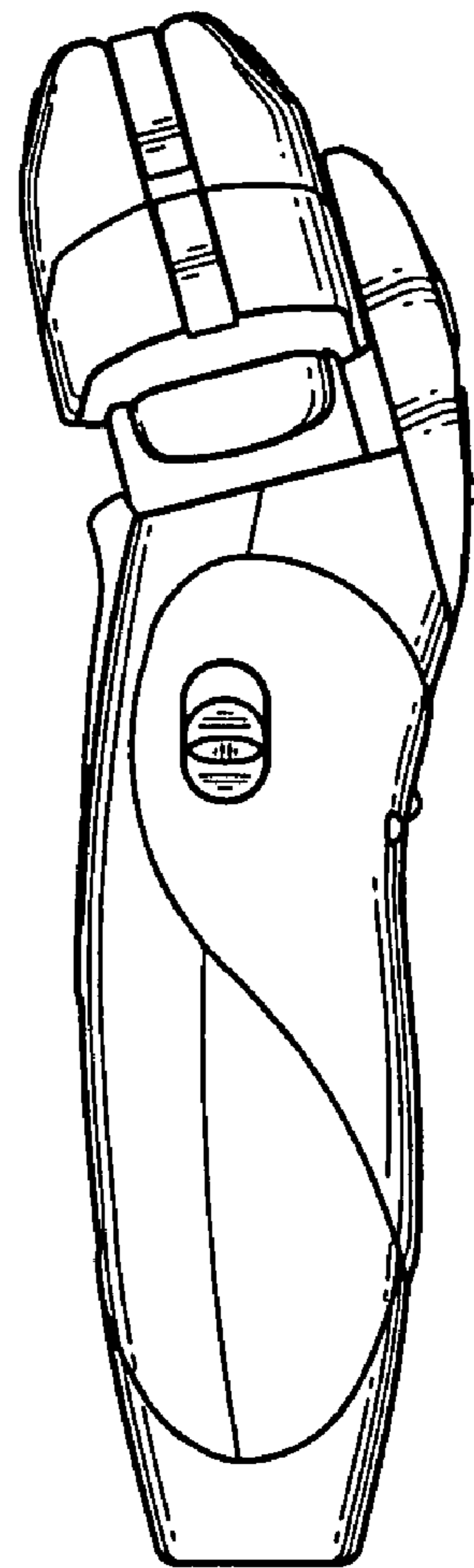

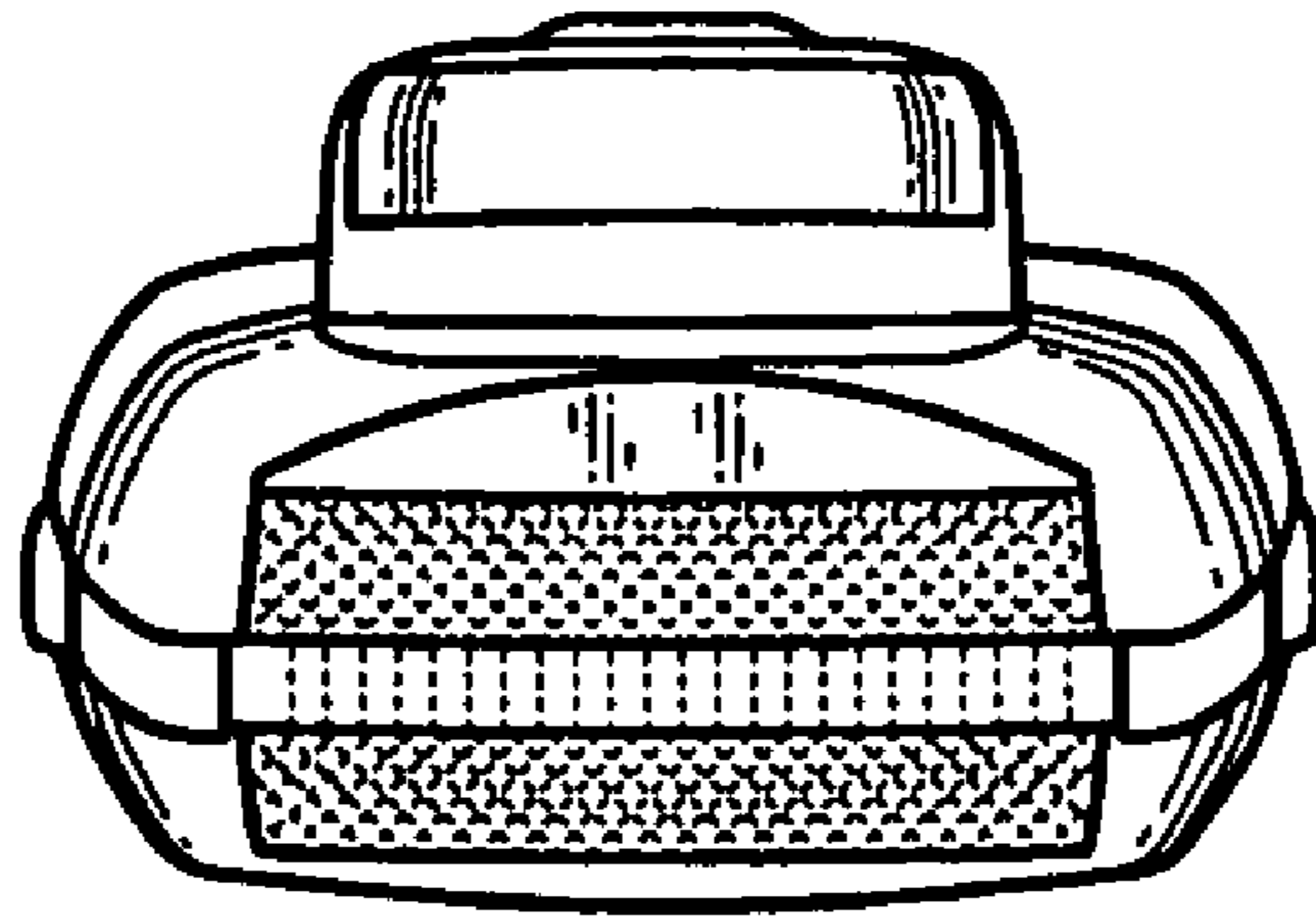

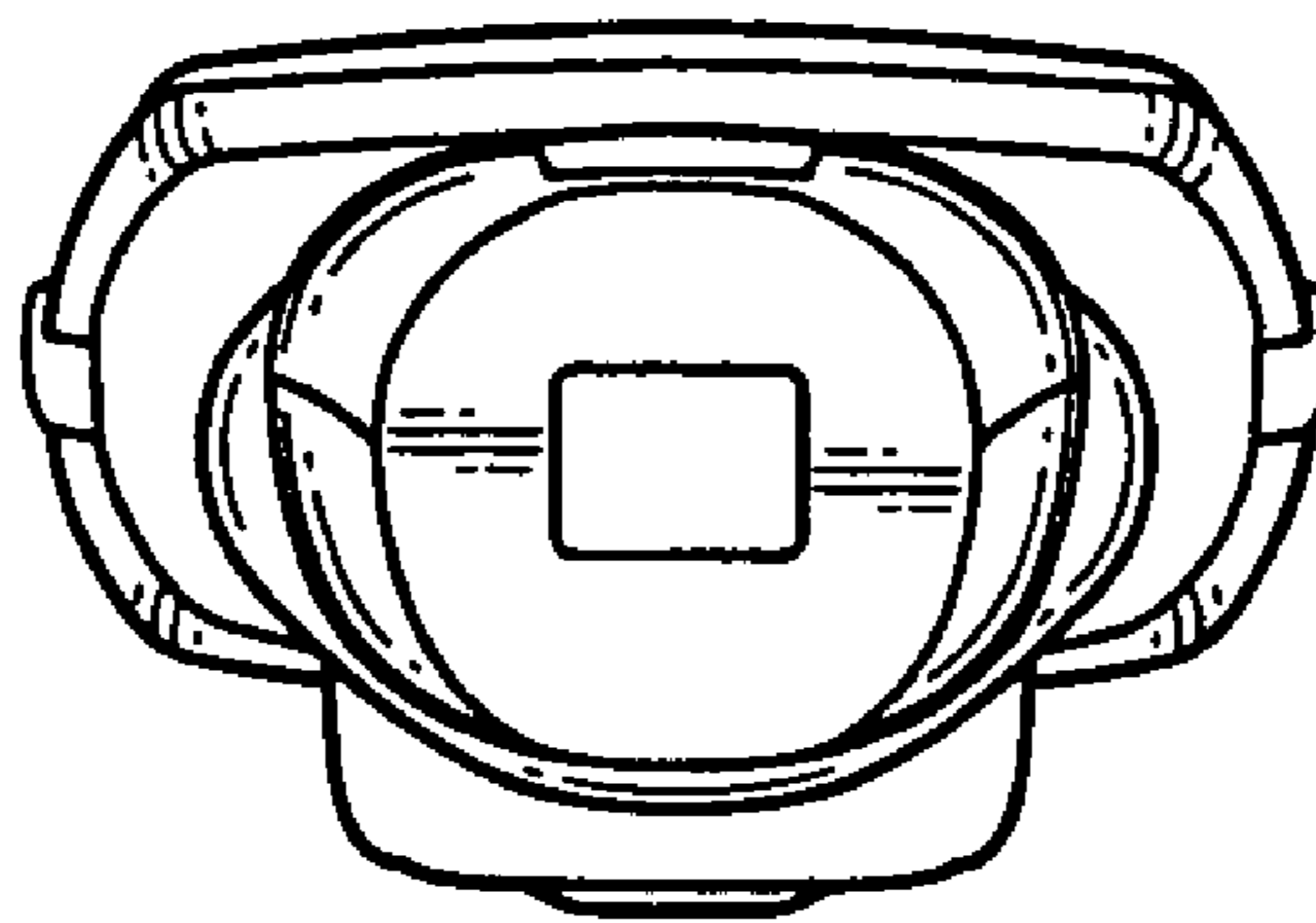
