FIG. 1 is a perspective view of an attachment assembly showing my new design shown on a dental floss holder.

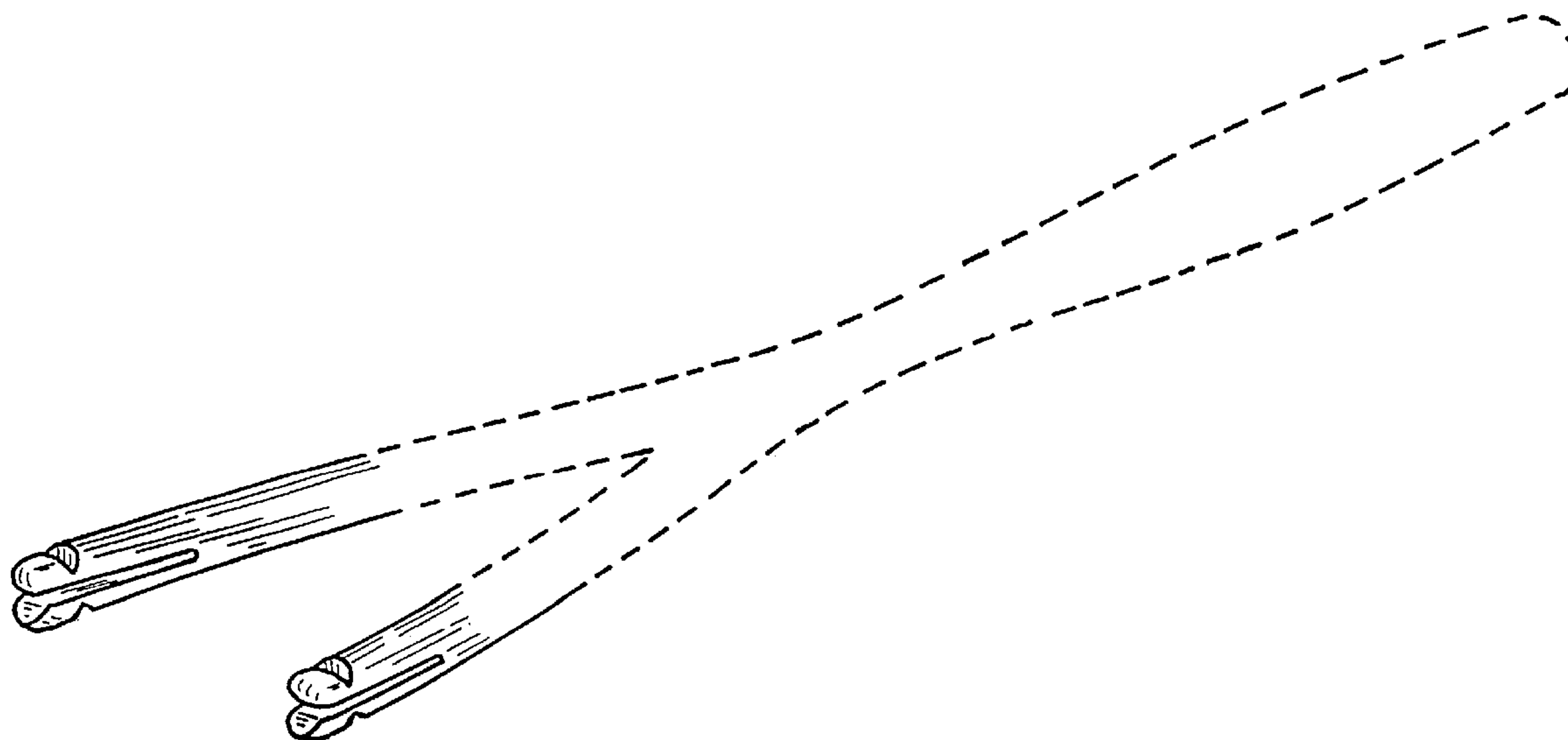
FIG. 2 is a top plan view of an attachment assembly showing my new design.

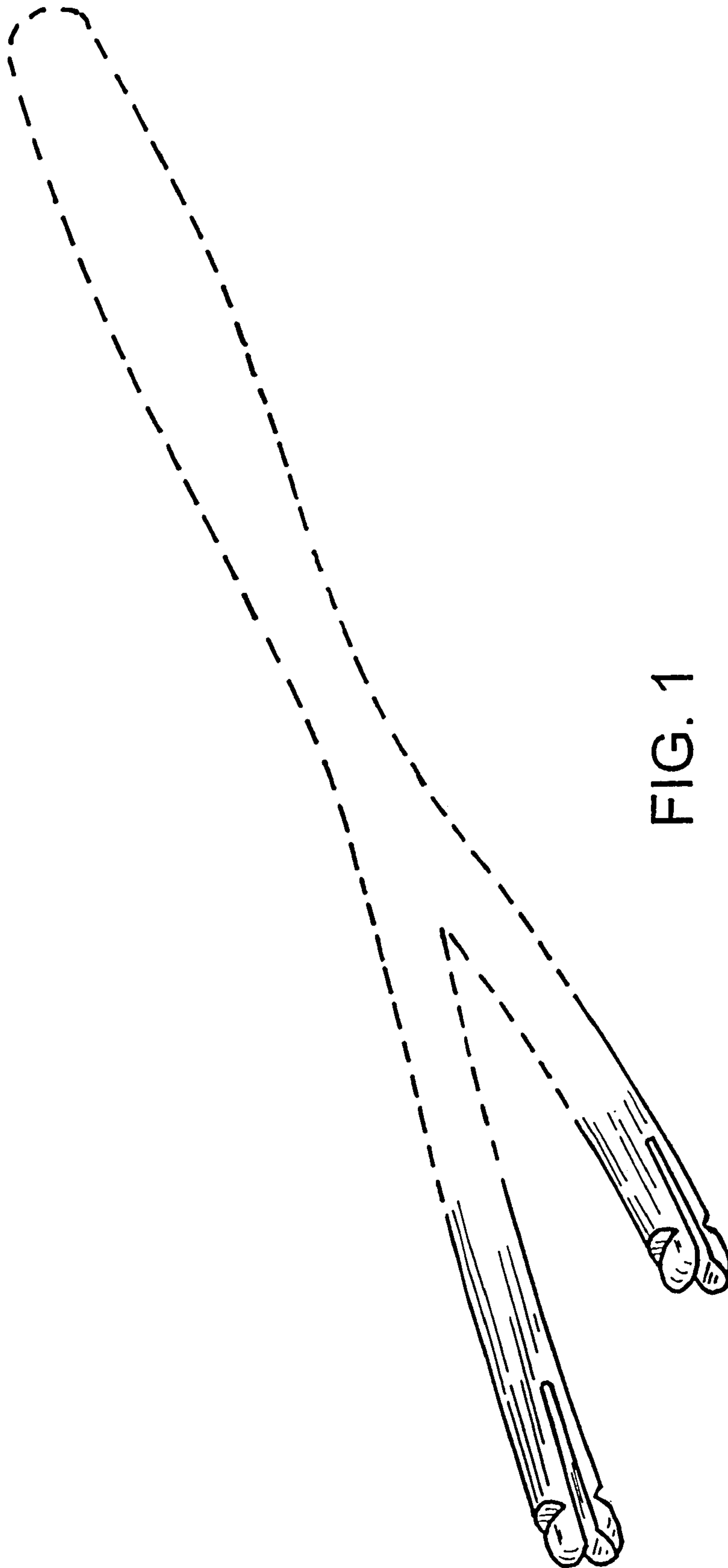
FIG. 3 is a front elevational view of an attachment assembly showing my new design; and,

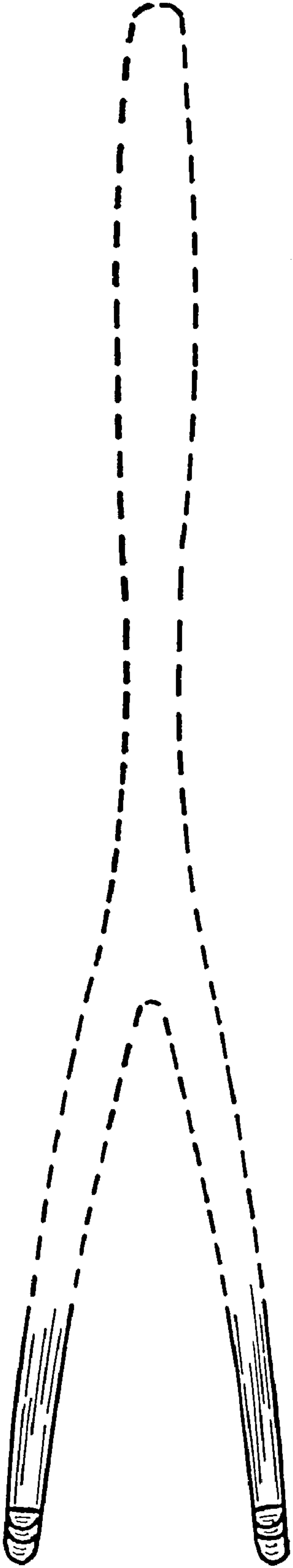

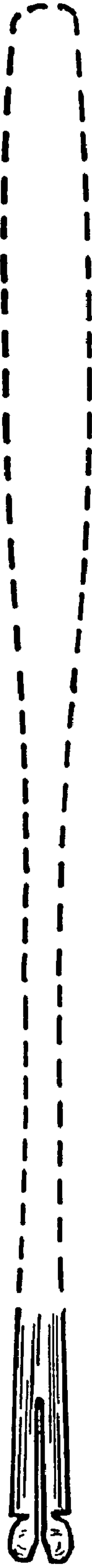
