(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a dorsal side plan view of a glove for a left hand showing my design;

FIG. 2 is a palmar side plan view of the glove thereof;

FIG. 3 is a left side view of the glove thereof;

FIG. 4 is a front perspective view of the glove thereof; and,

FIG. 5 is a right side view of the glove thereof.

The broken lines showing of portions of a glove is for illustrative purposes only and forms no part of the claimed design. Although shown in the context of a left hand glove, an embodiment of the present invention also may be incorporated in a right hand glove.

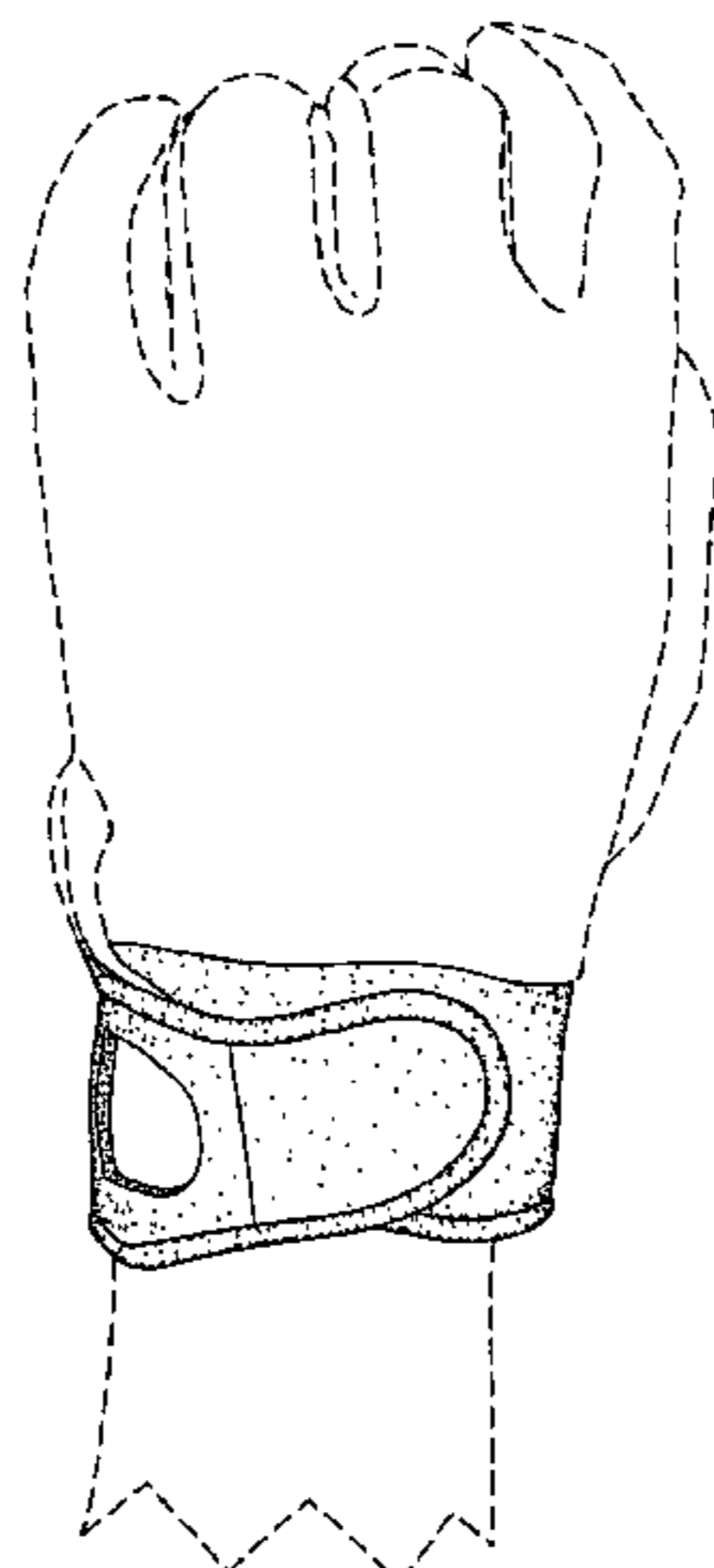

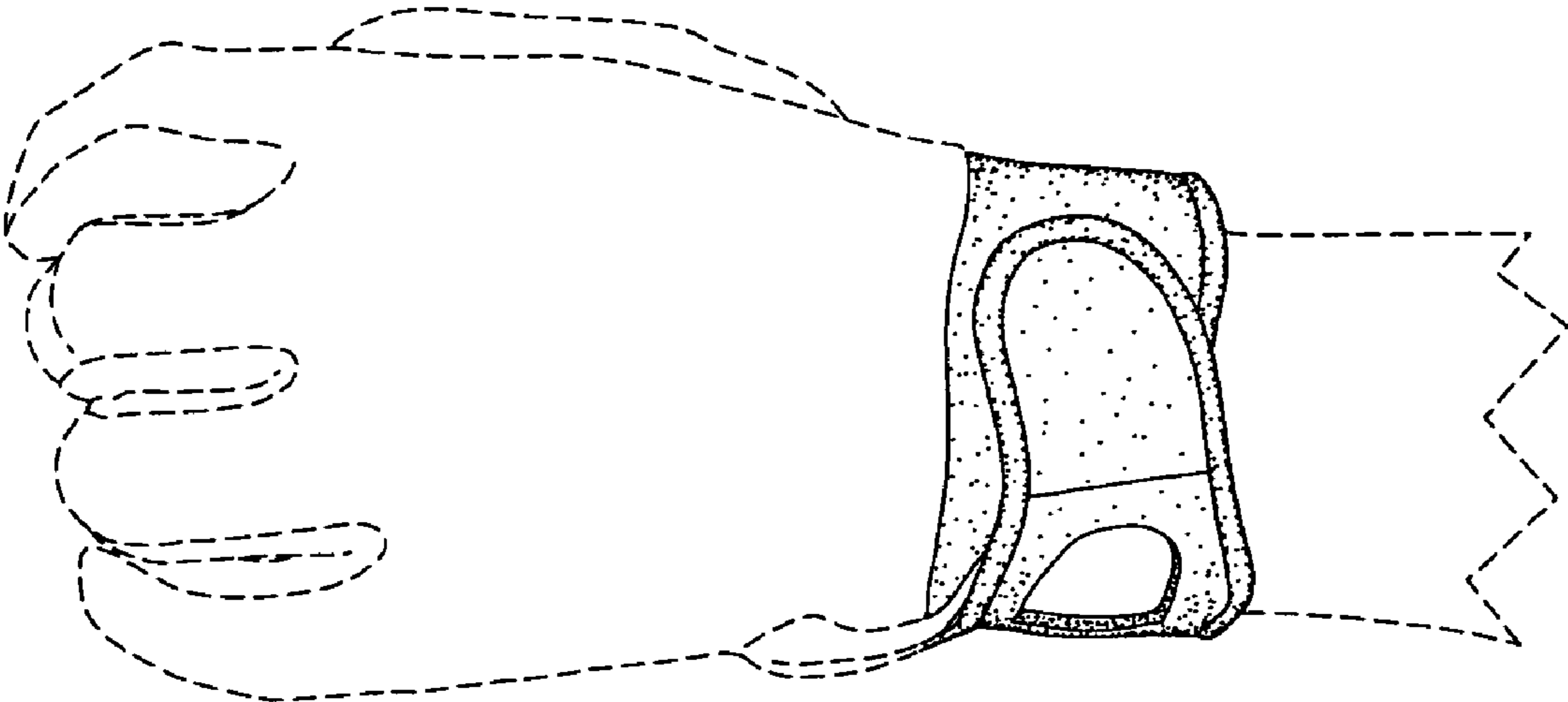

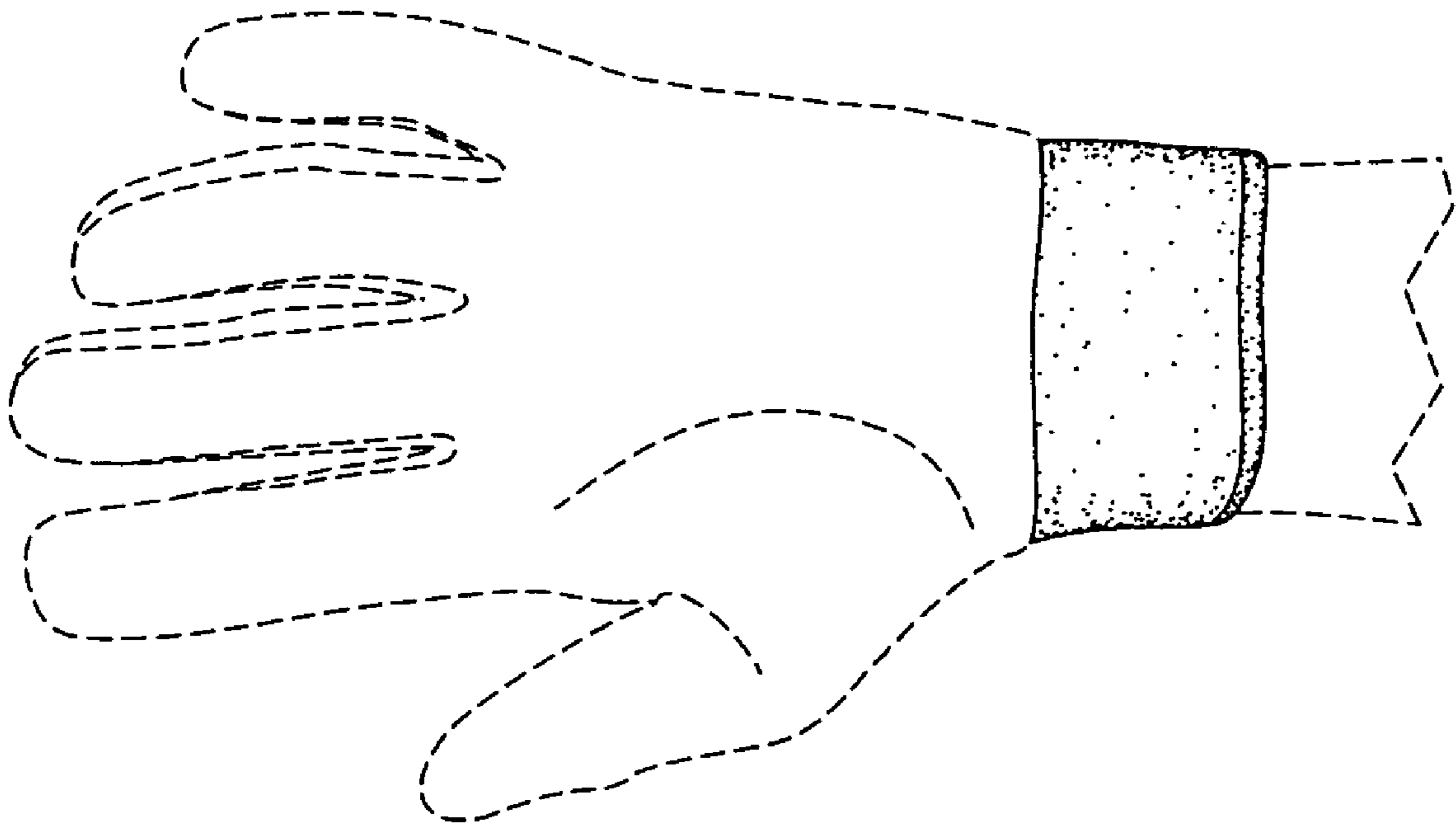
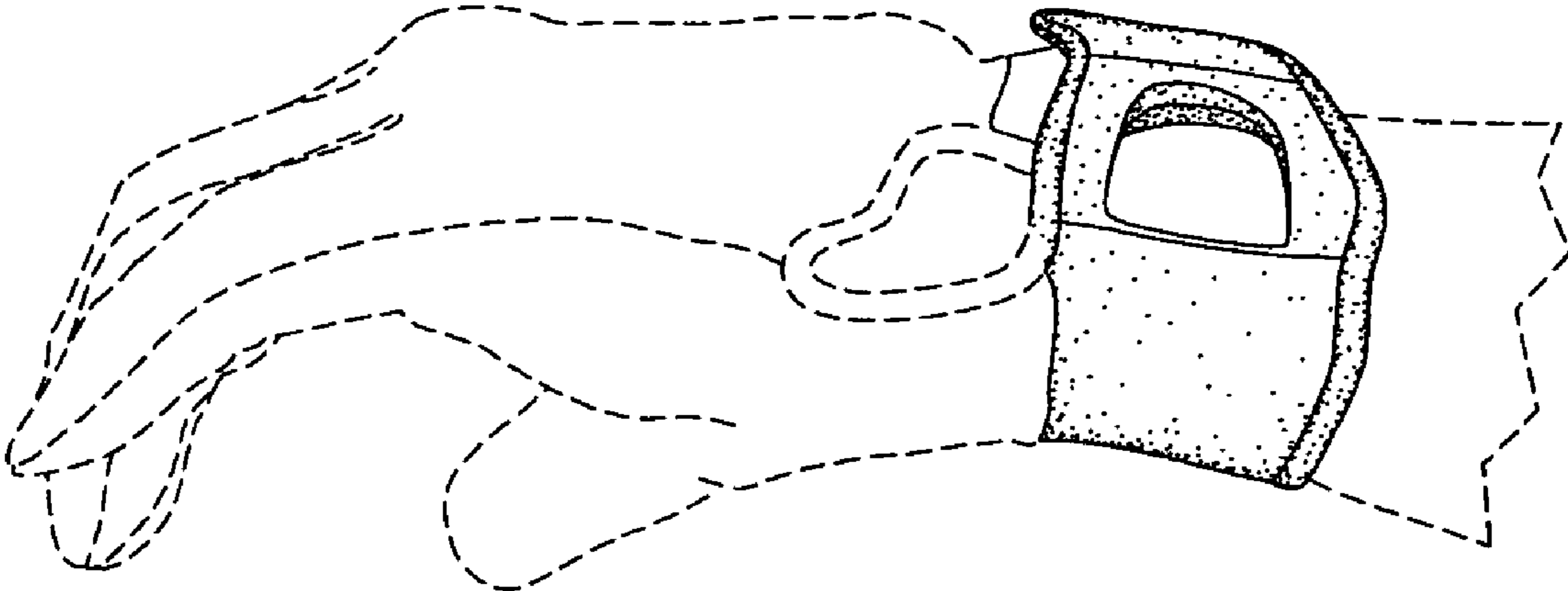

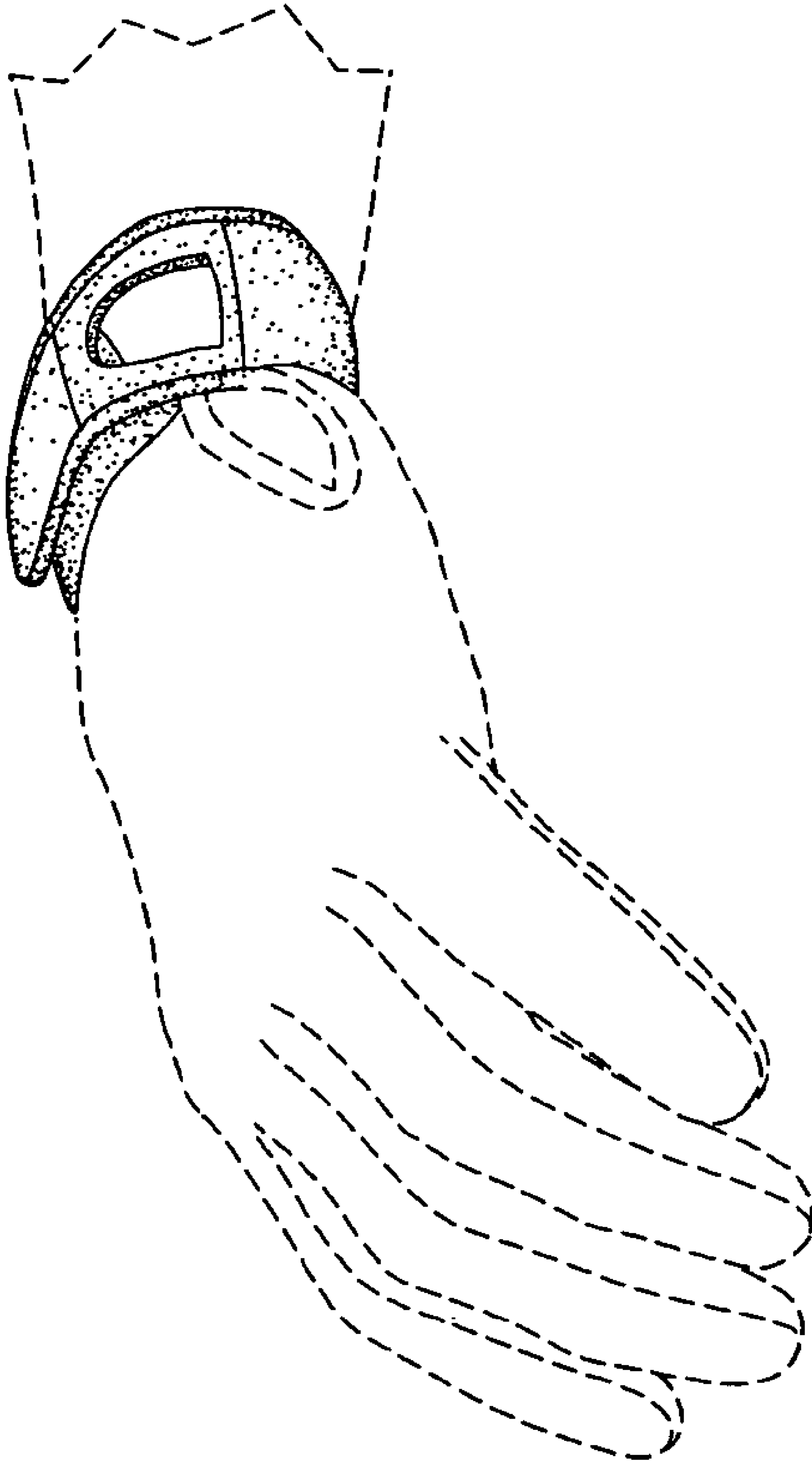

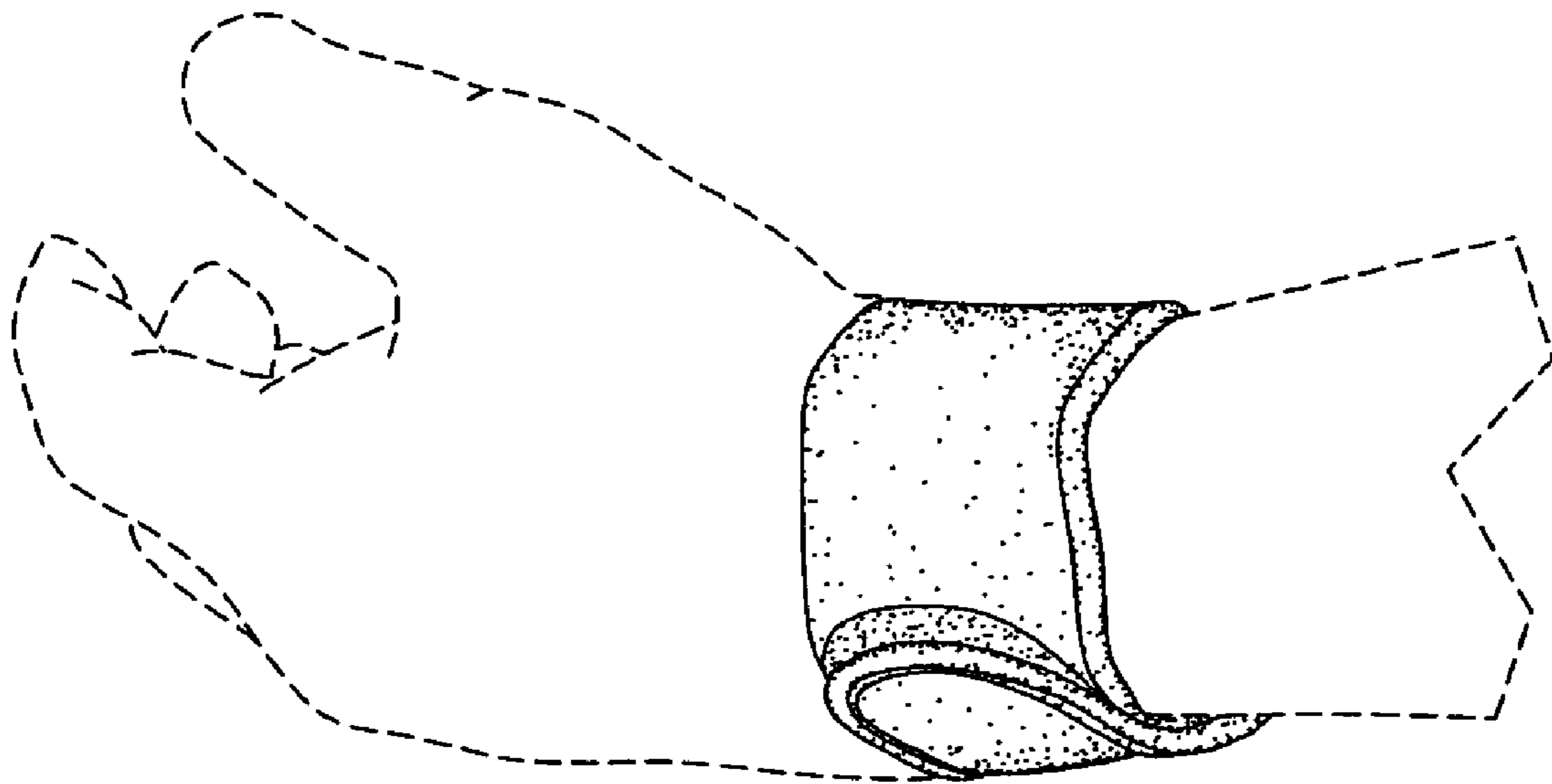
