The ornamental design for a percussion case, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a percussion case embodying my invention;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a top, front, left side perspective view thereof; and,

FIG. 8 is a top, rear, right side perspective view thereof, with multiple unclaimed percussion cases shown in the staked position.

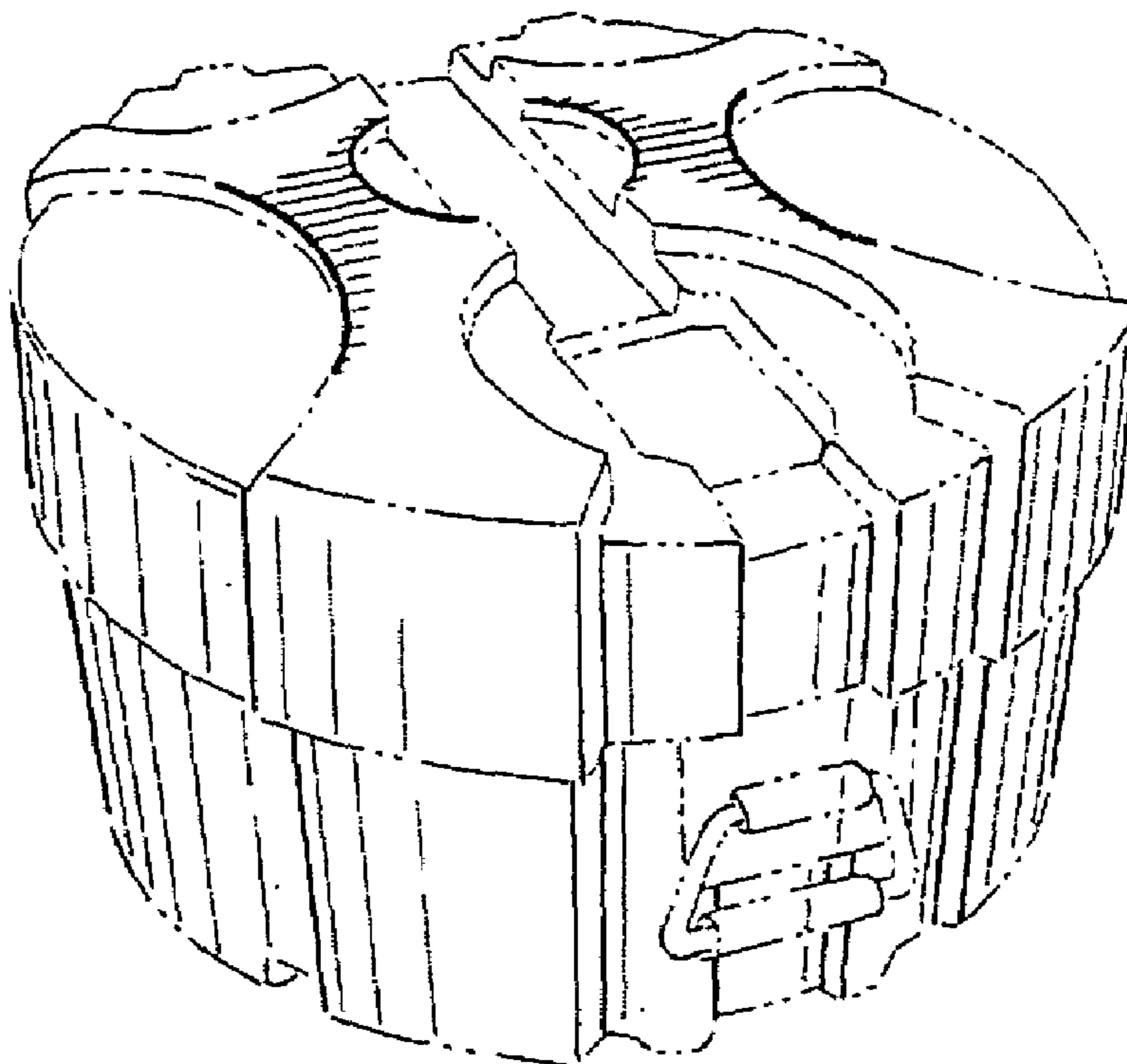

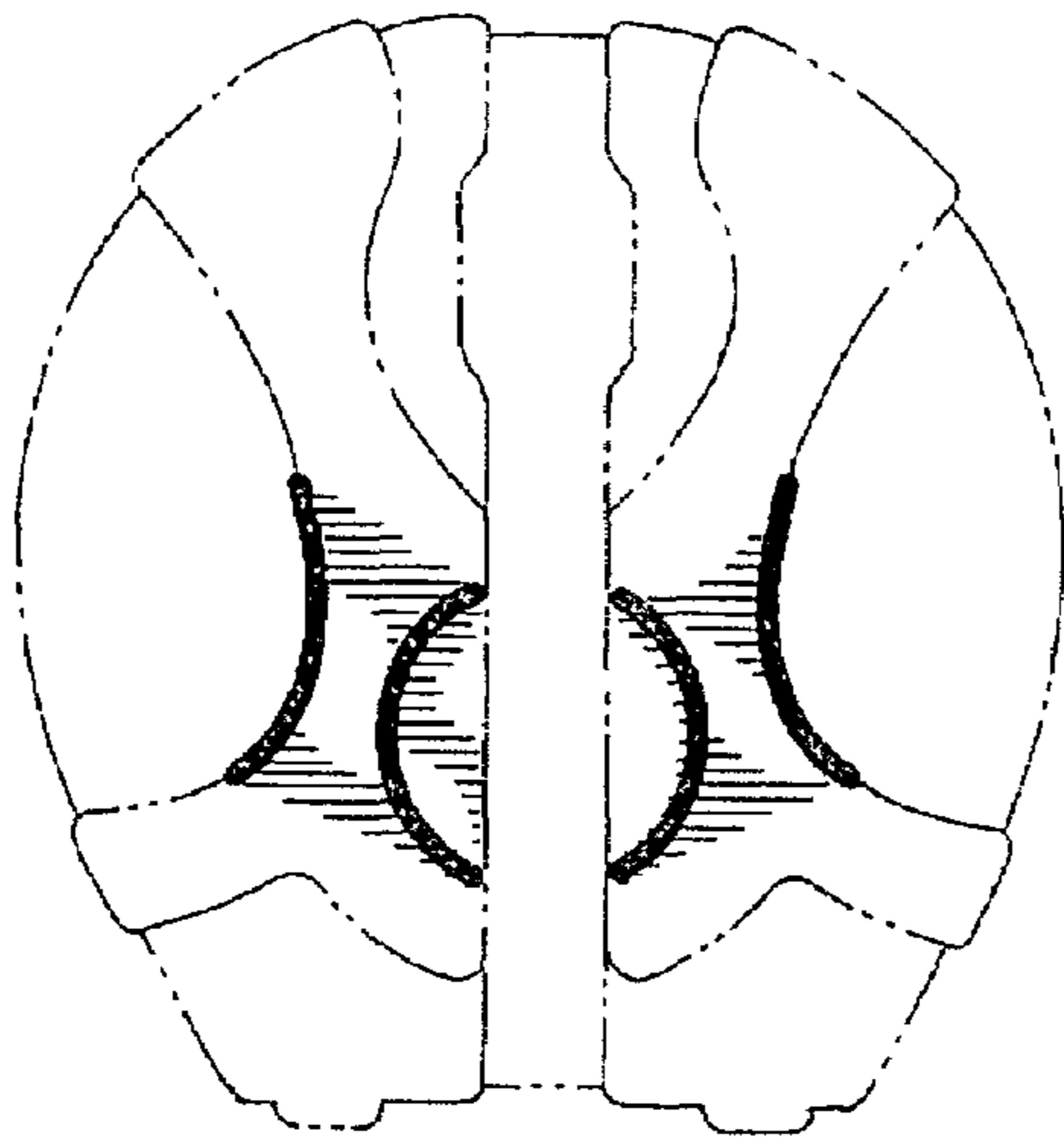

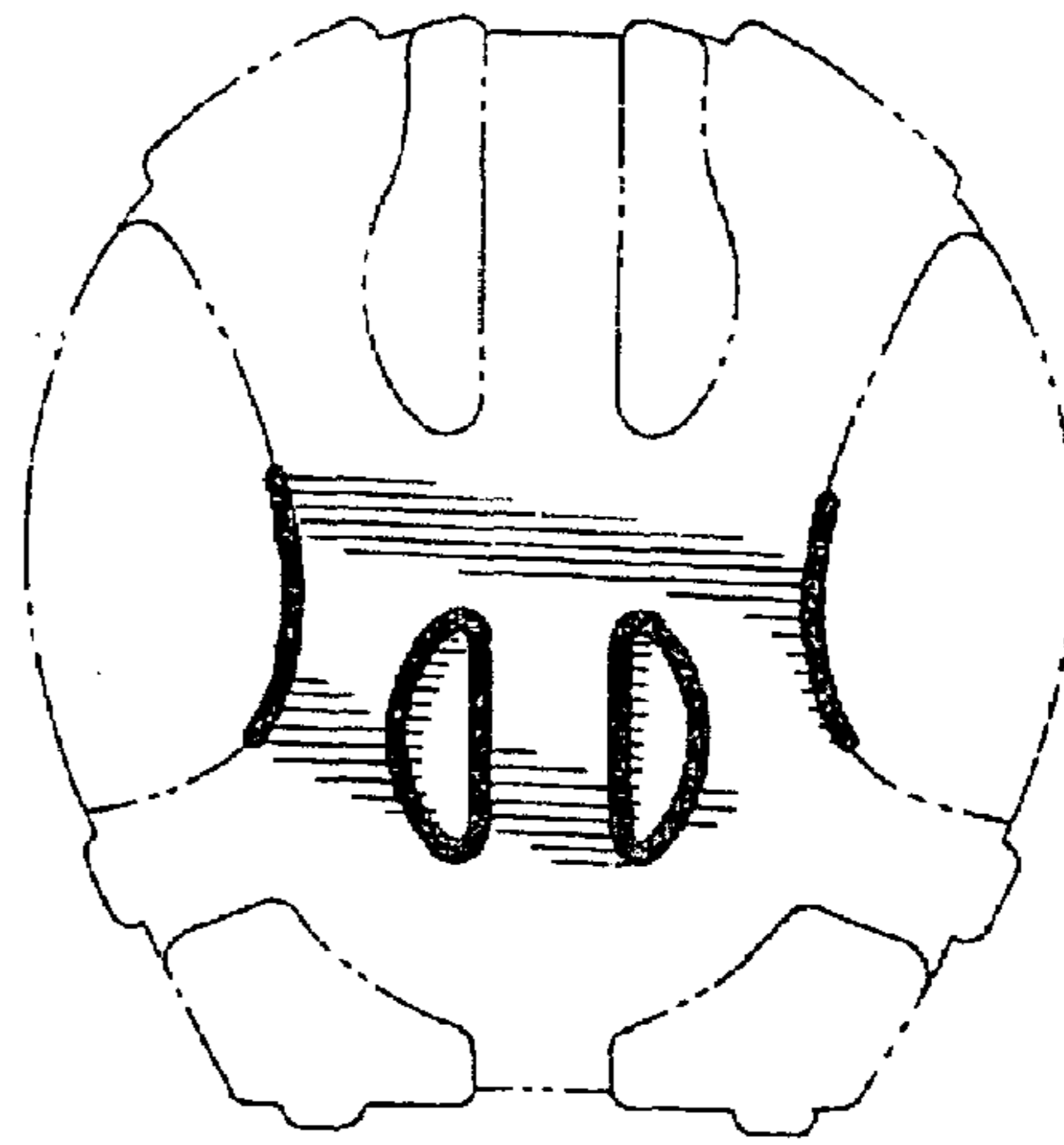

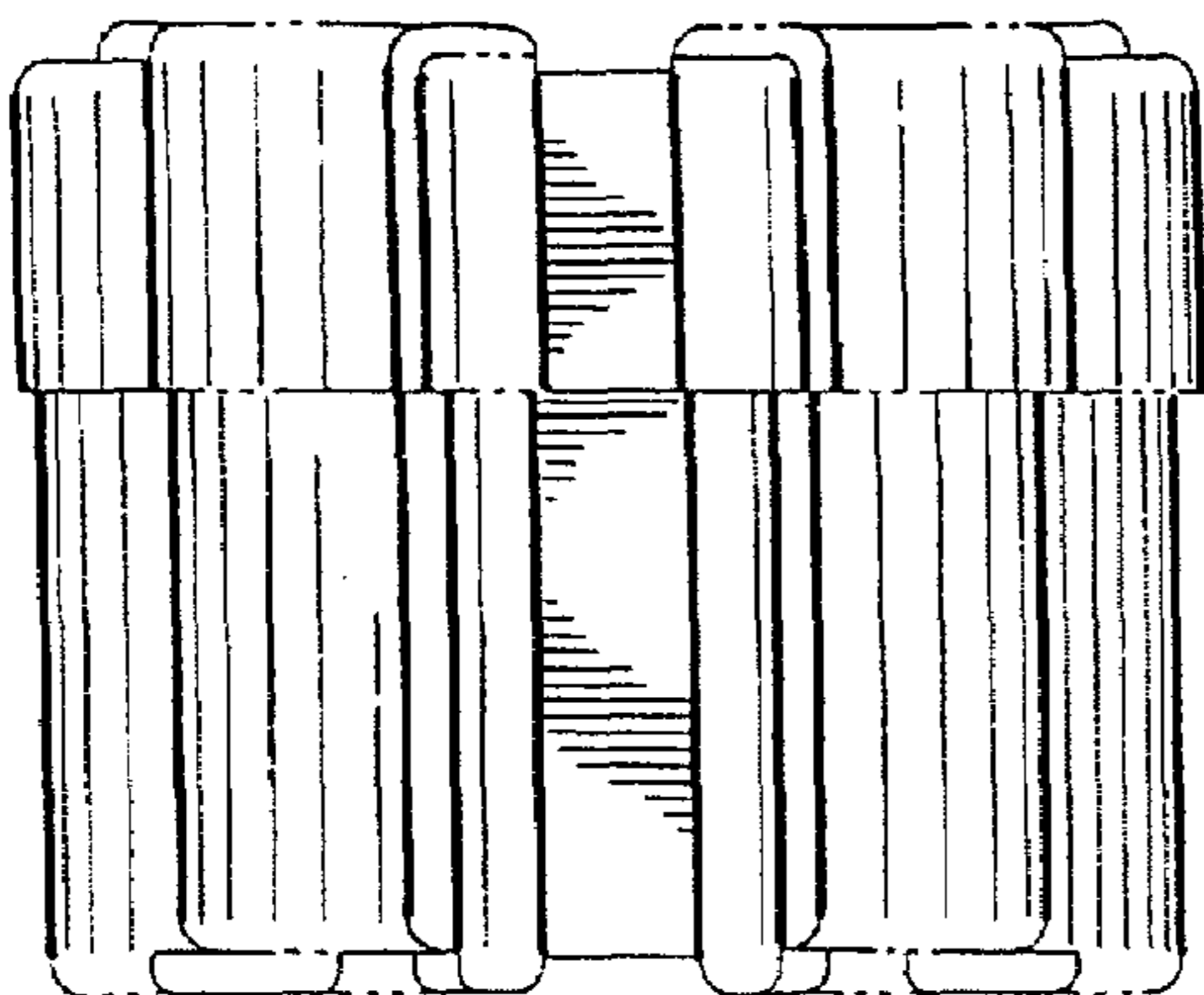

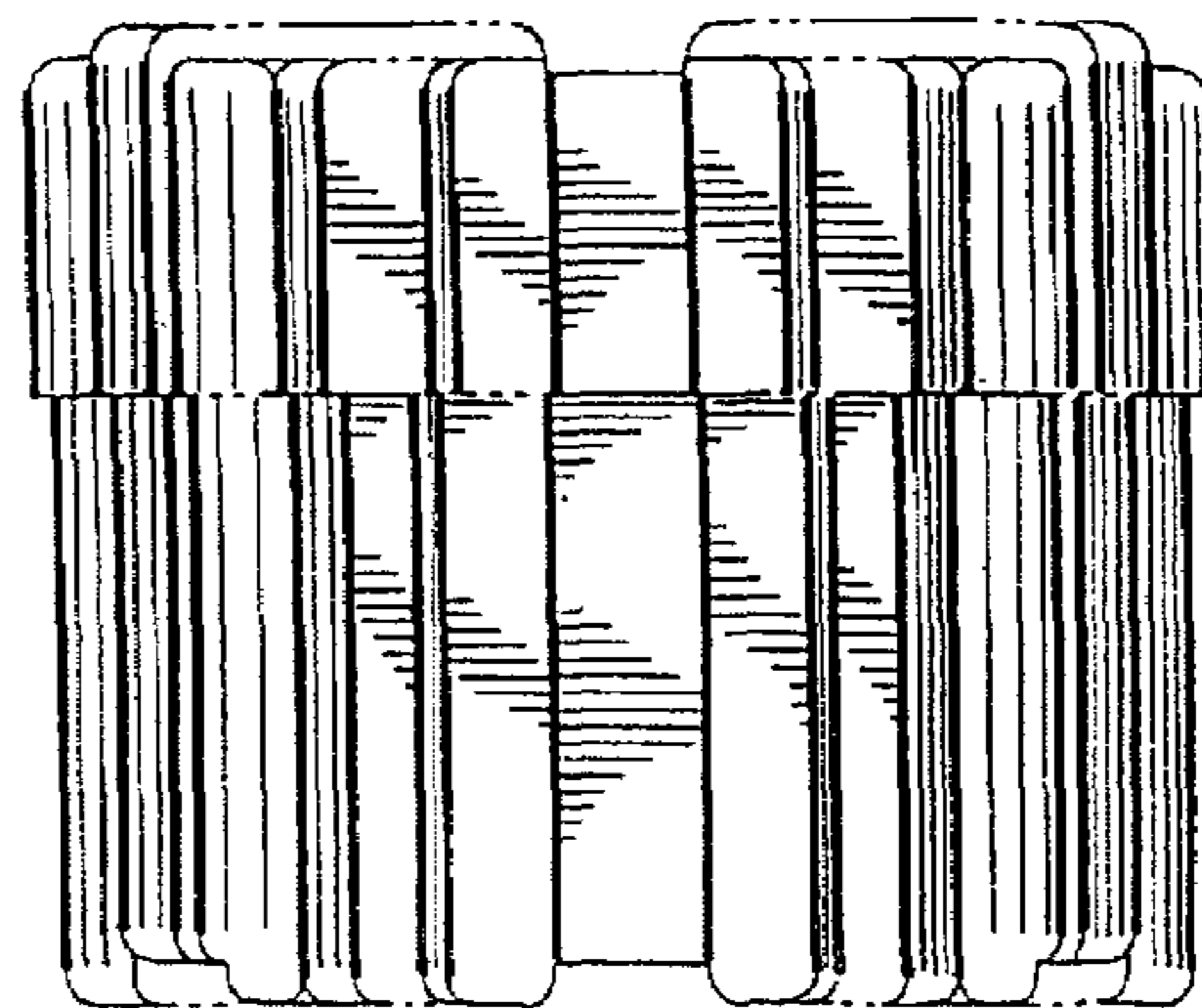

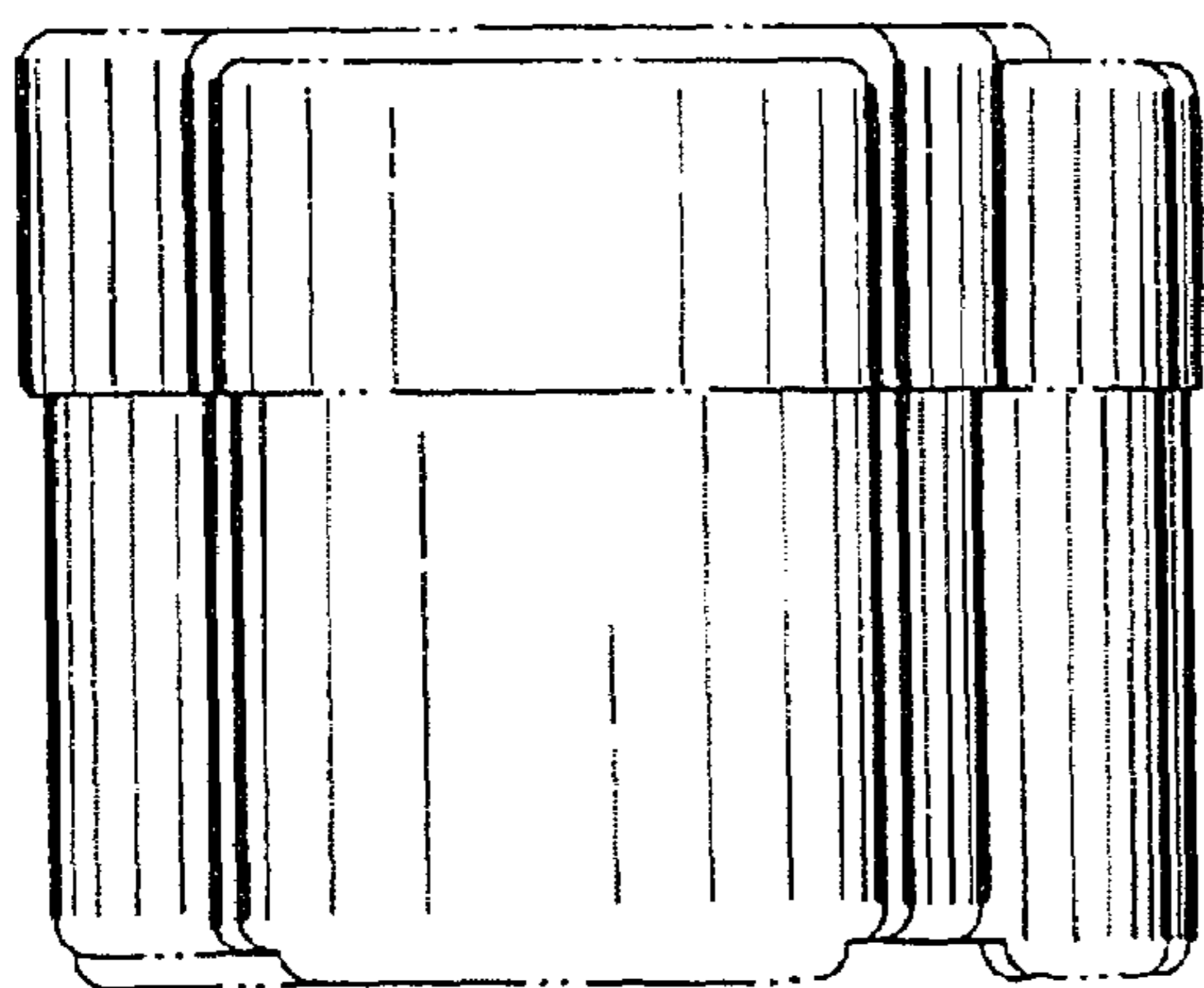

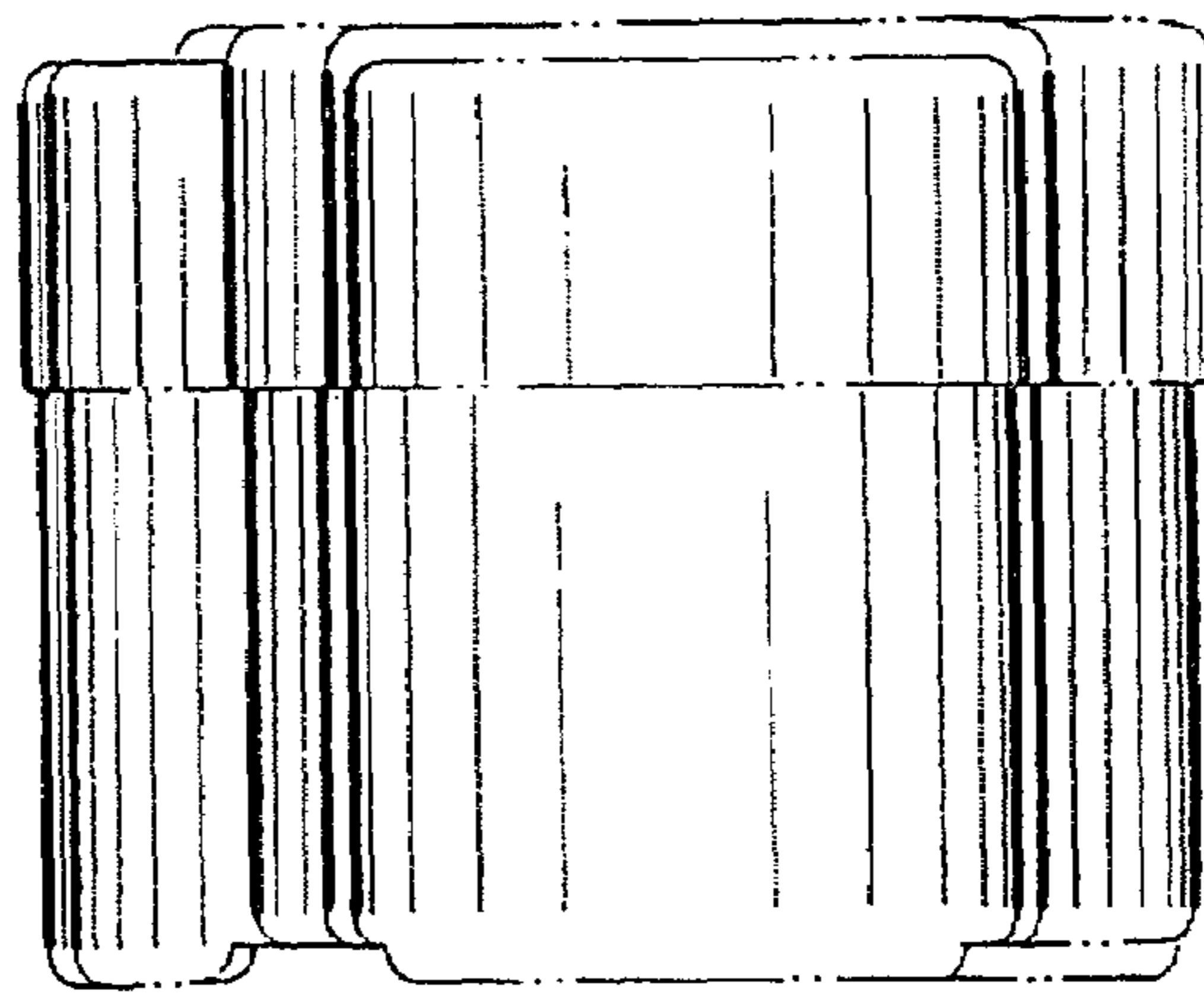

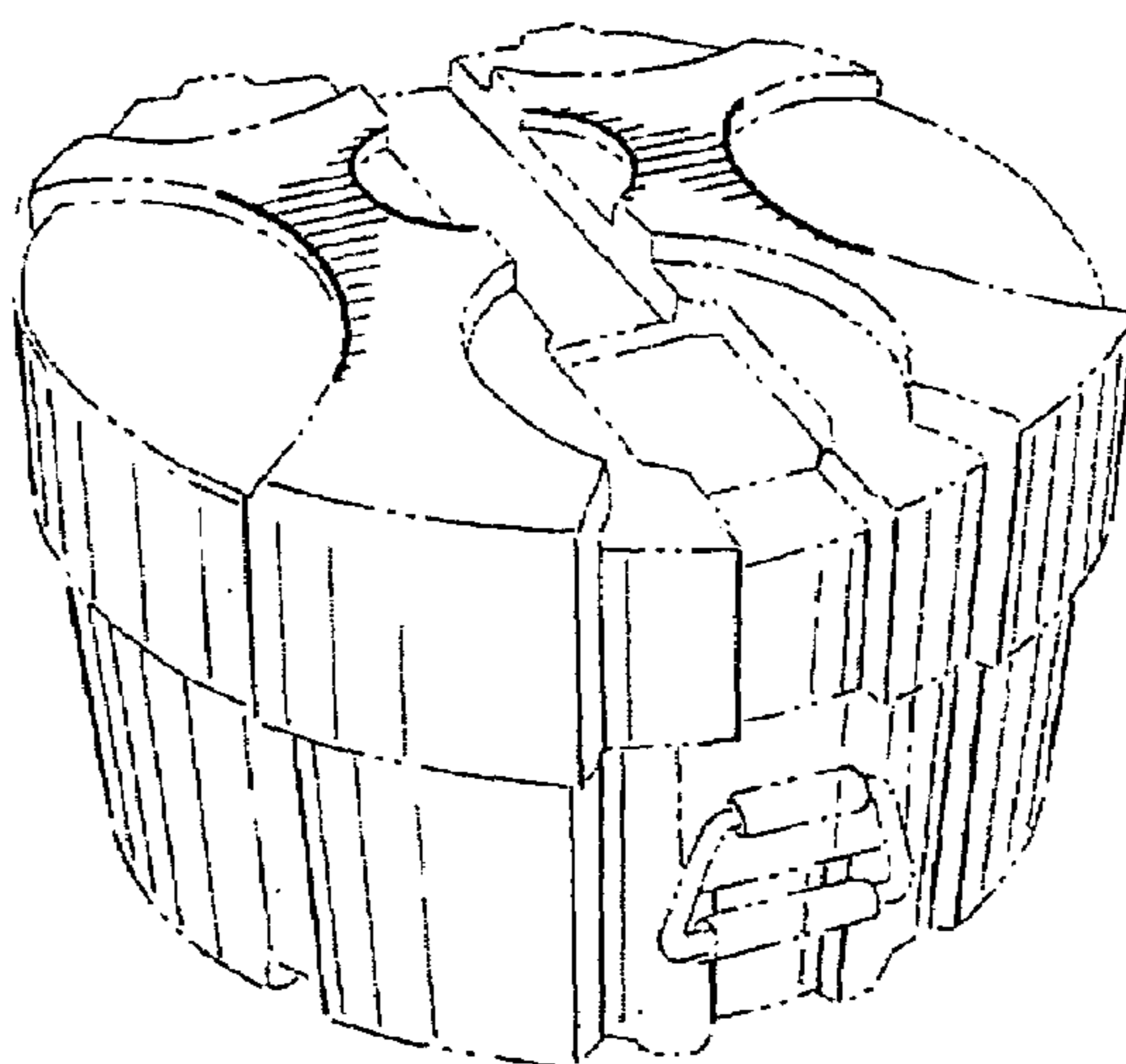
