FIG. 3 is a right side elevational view thereof, the left elevational view being a mirror image thereof; and,

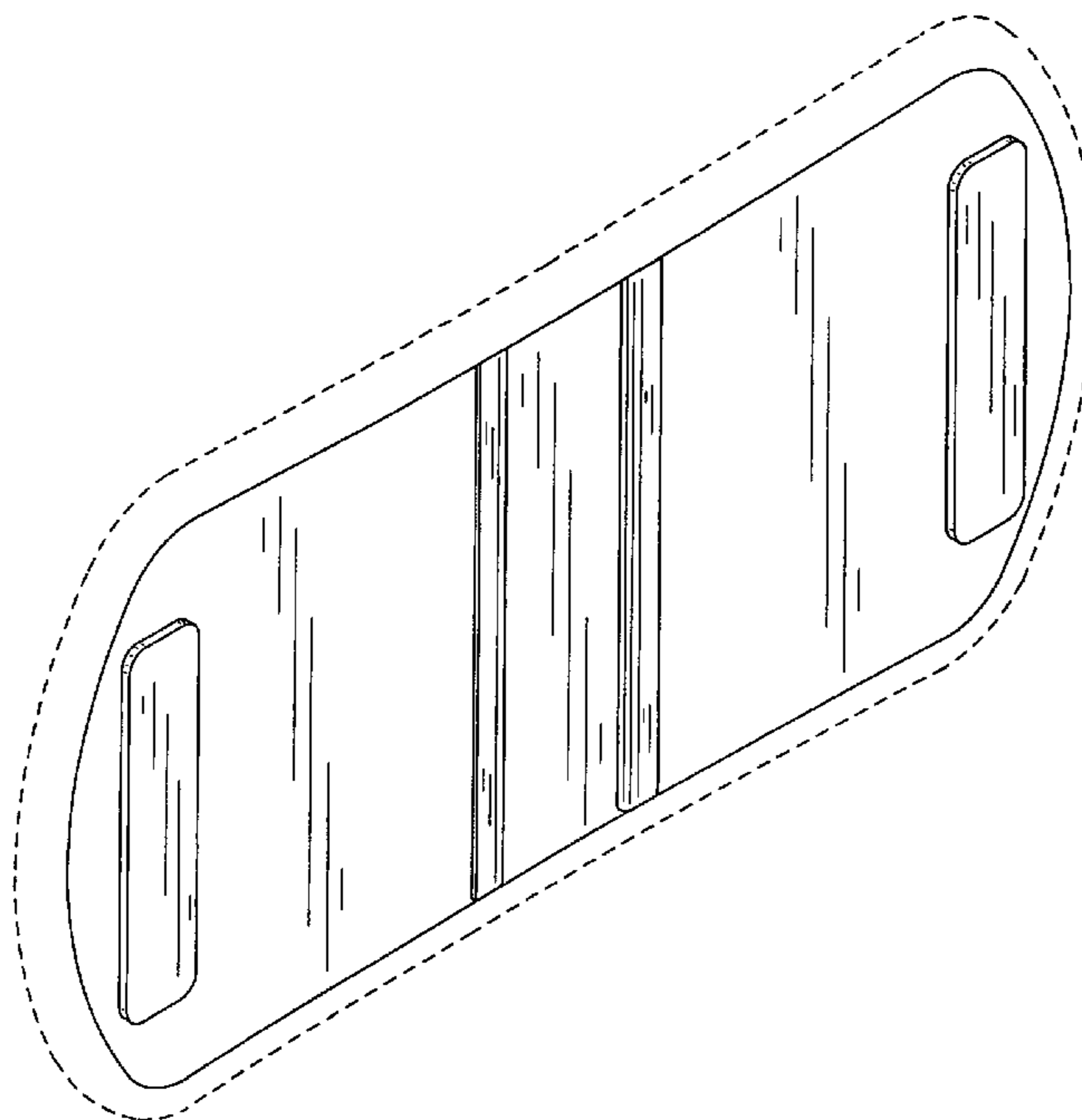
FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image thereof.

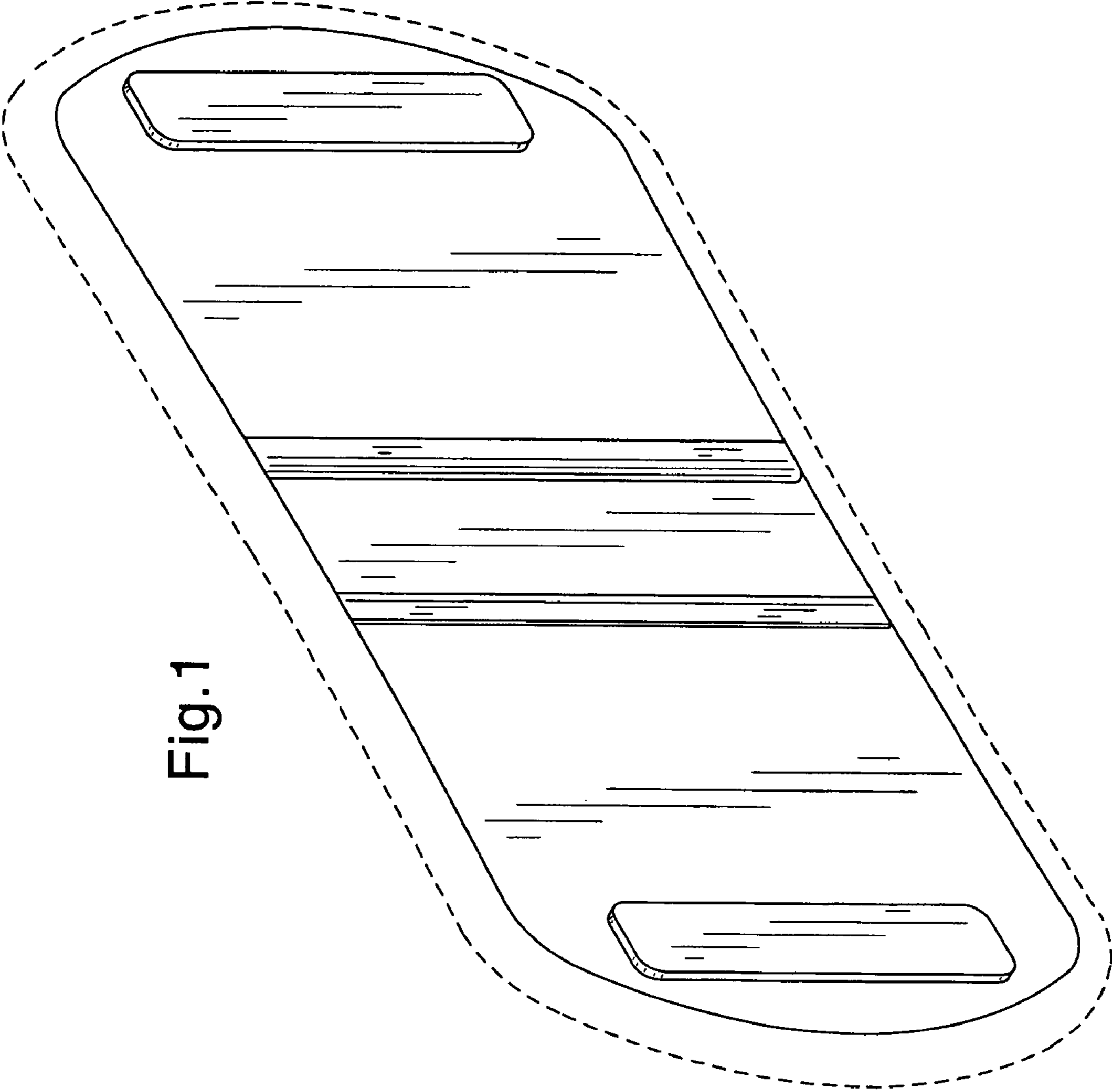
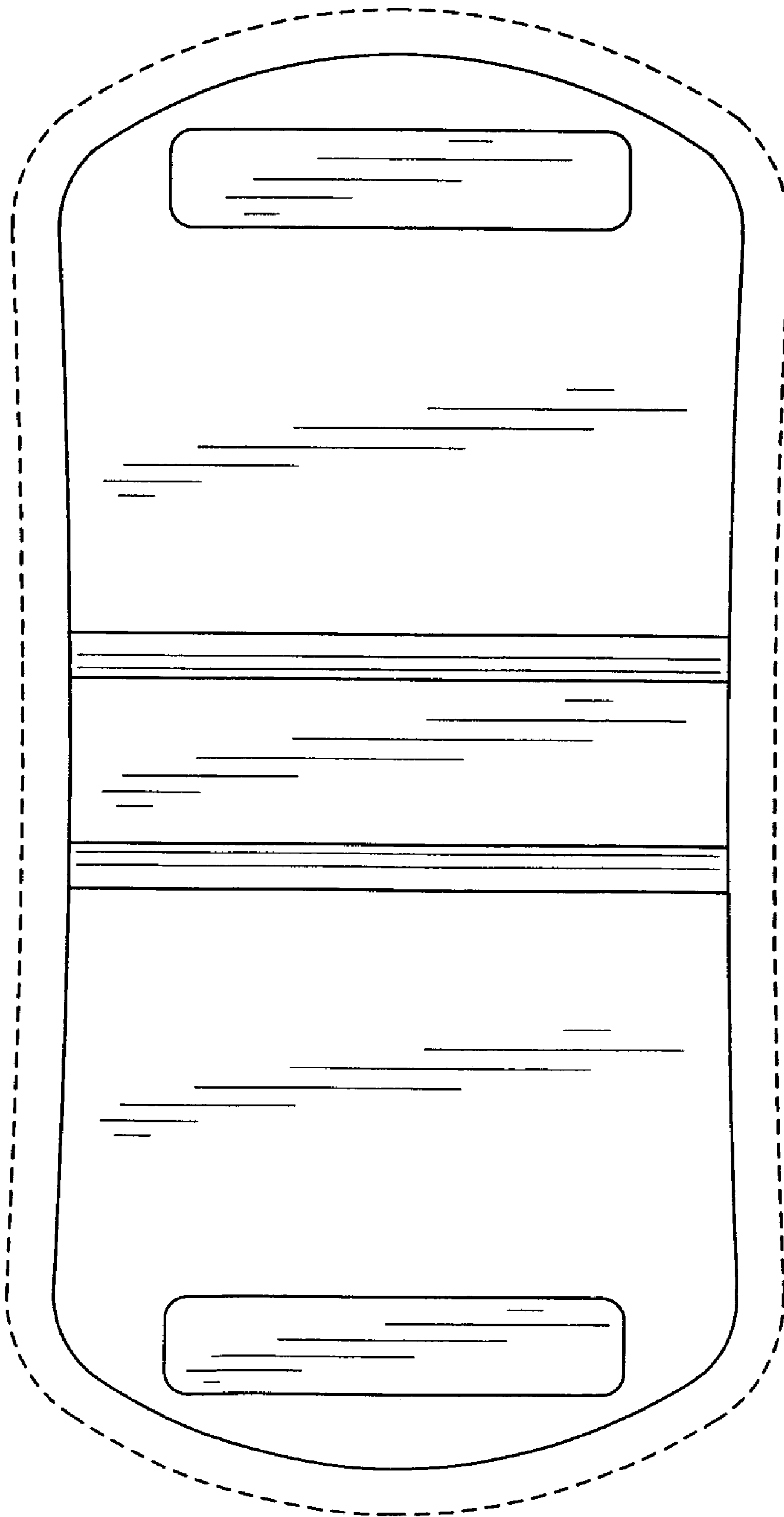

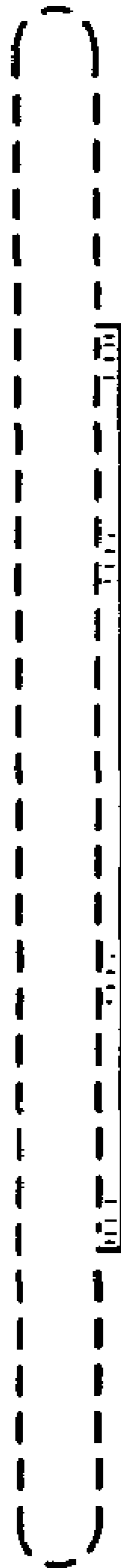
