DESCRIPTION

FIG. 1 is a top, side and front perspective view of a pitcher showing the new design;

FIG. 2 is a front elevation view thereof, the rear elevation being a mirror image thereof;

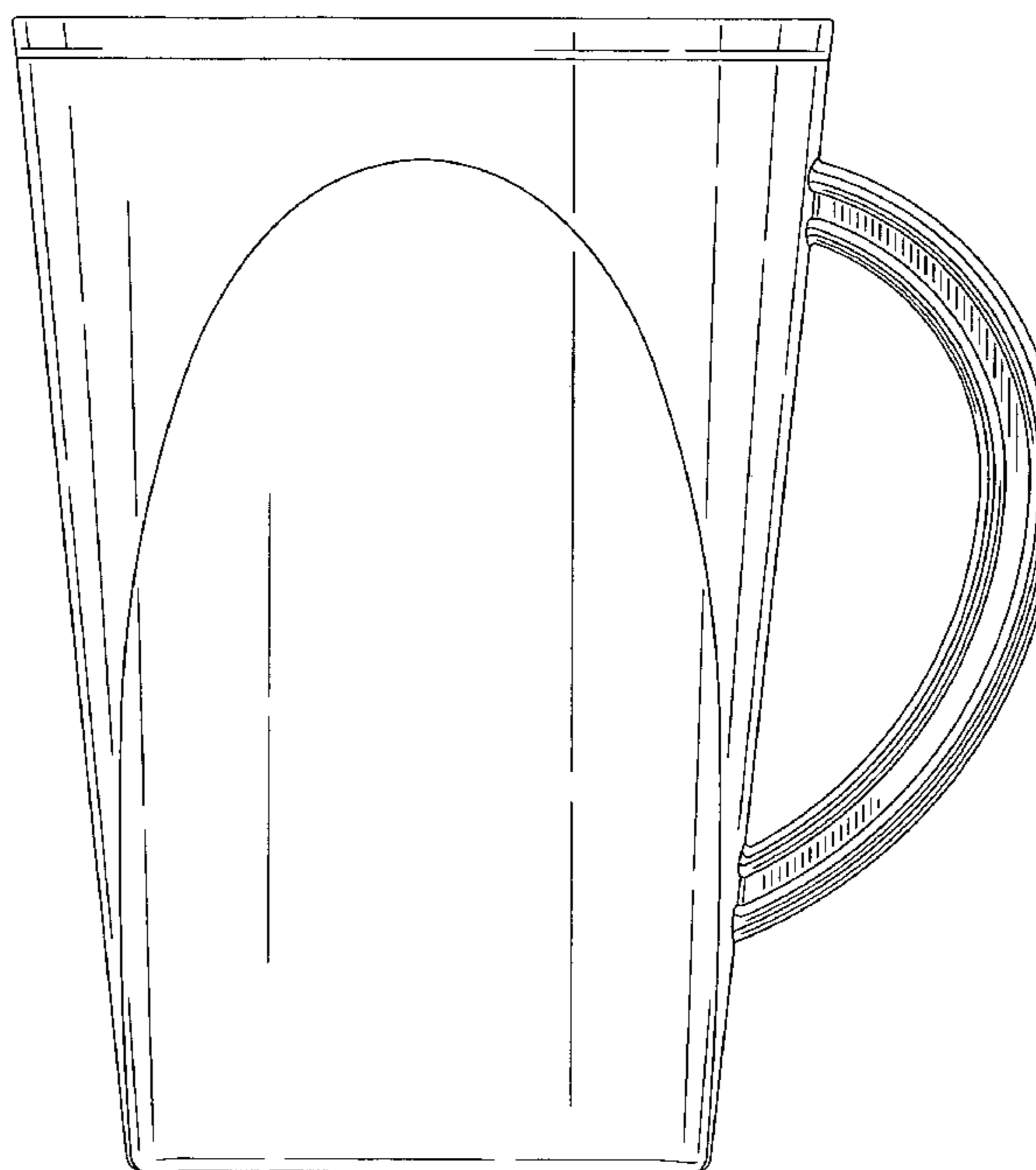
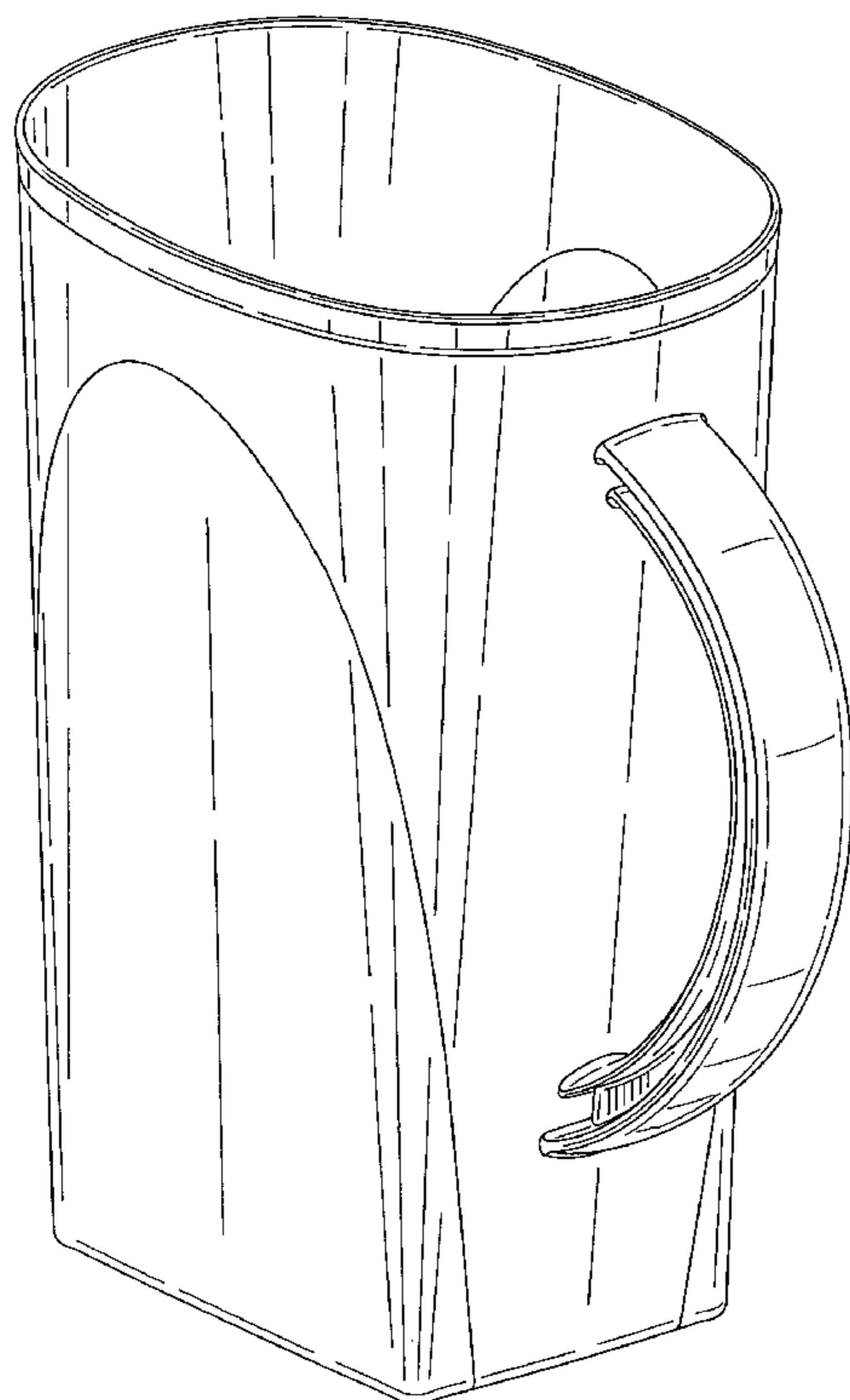
FIG. 3 is a right side elevation view thereof;

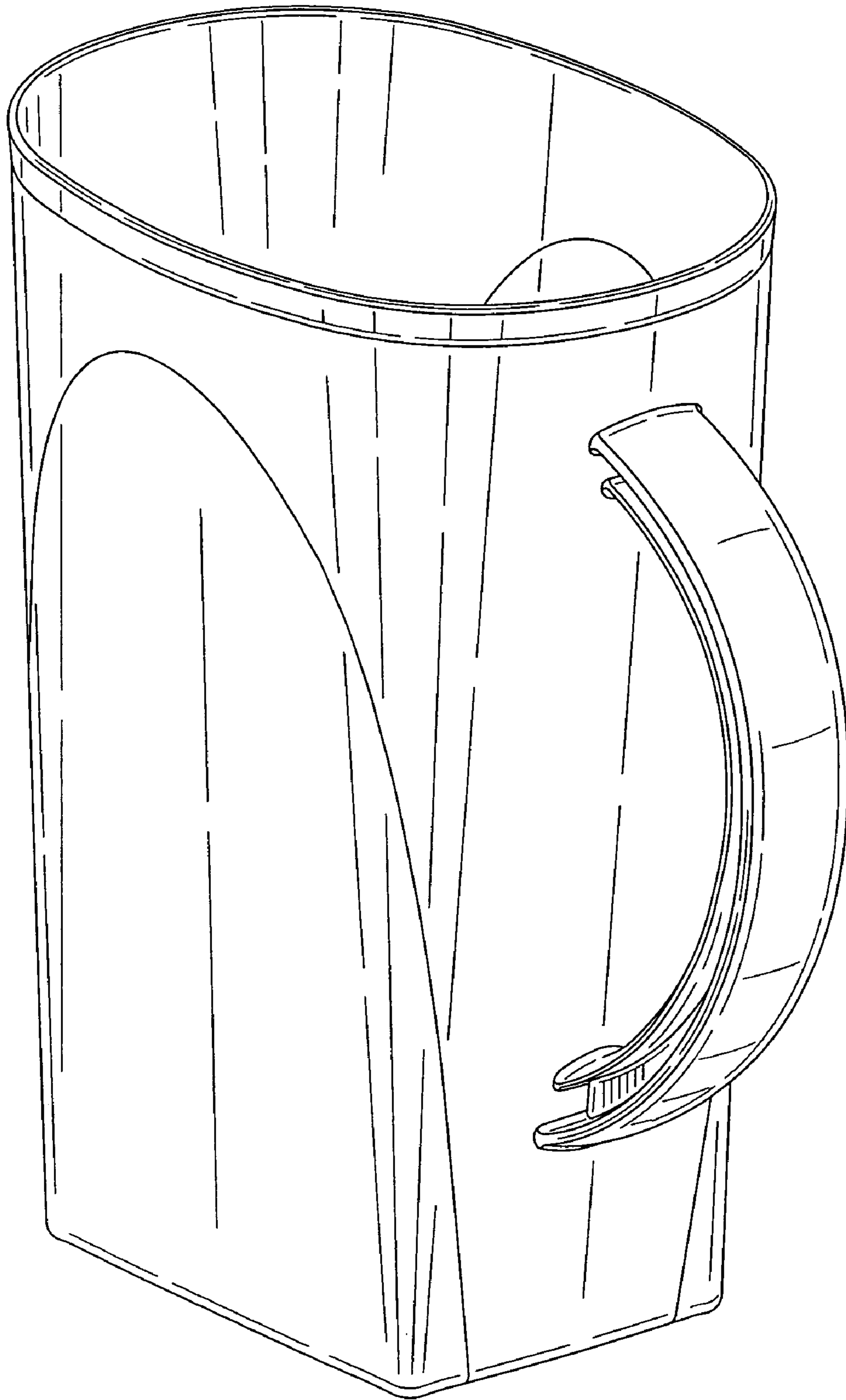

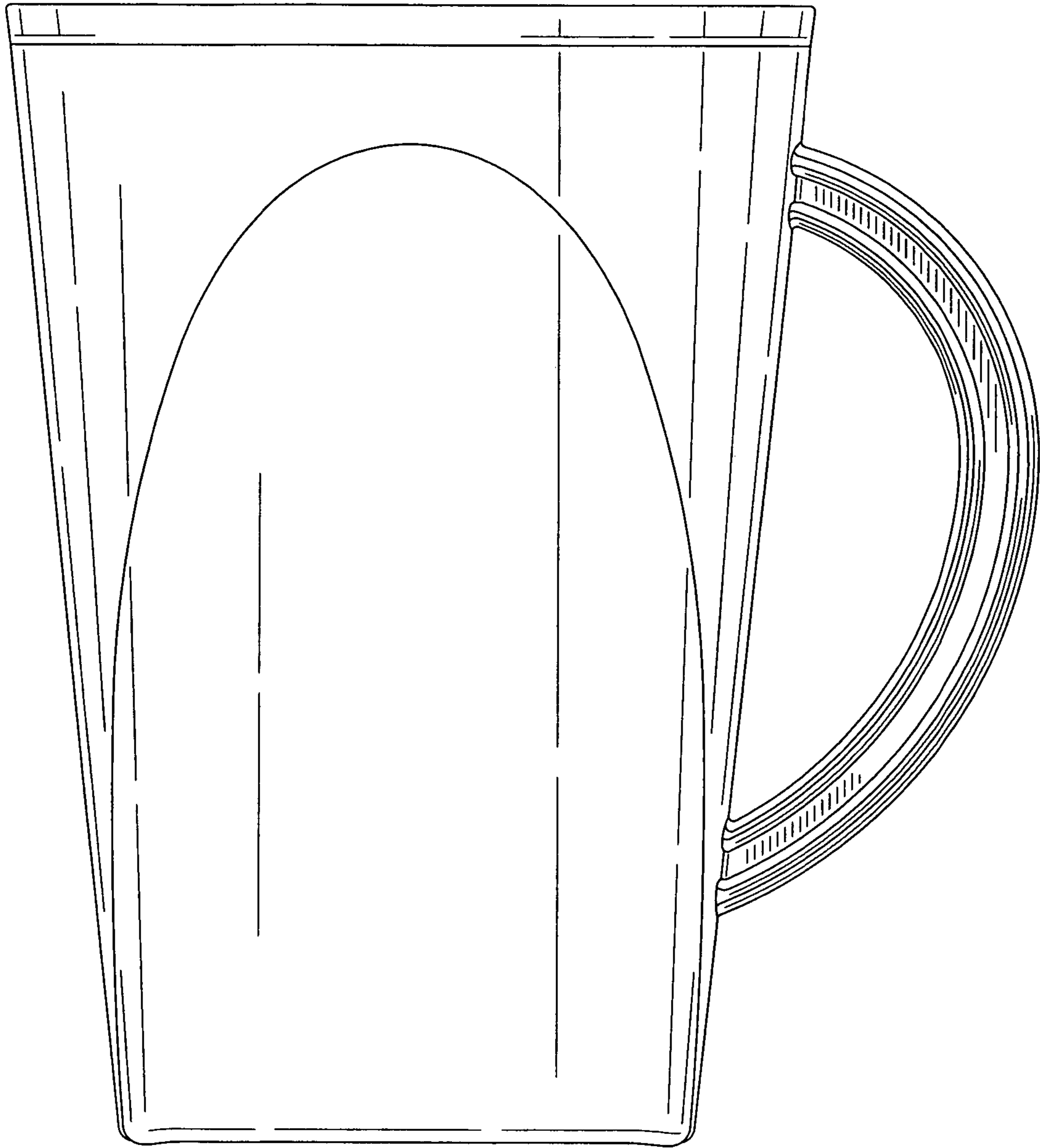

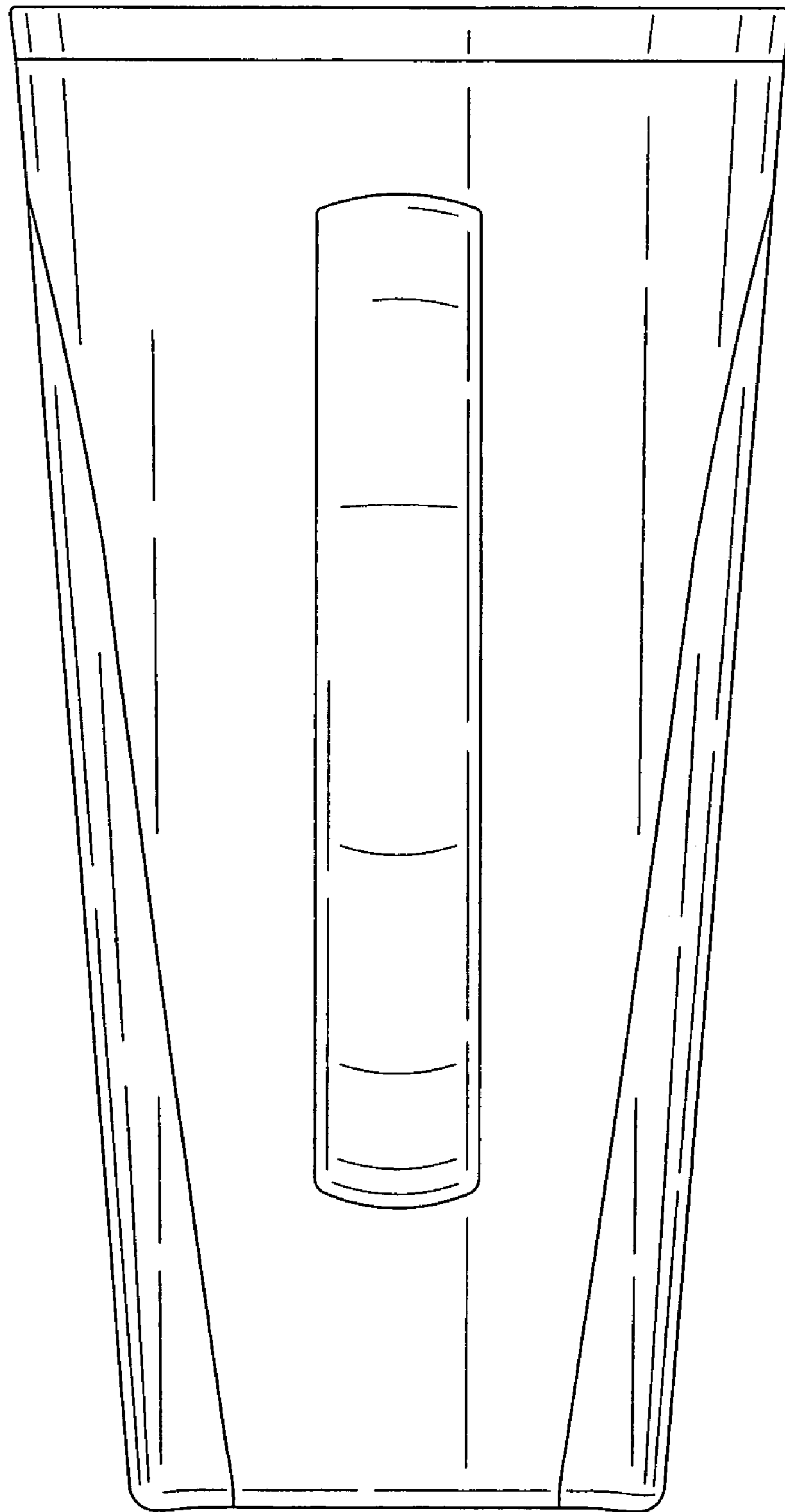

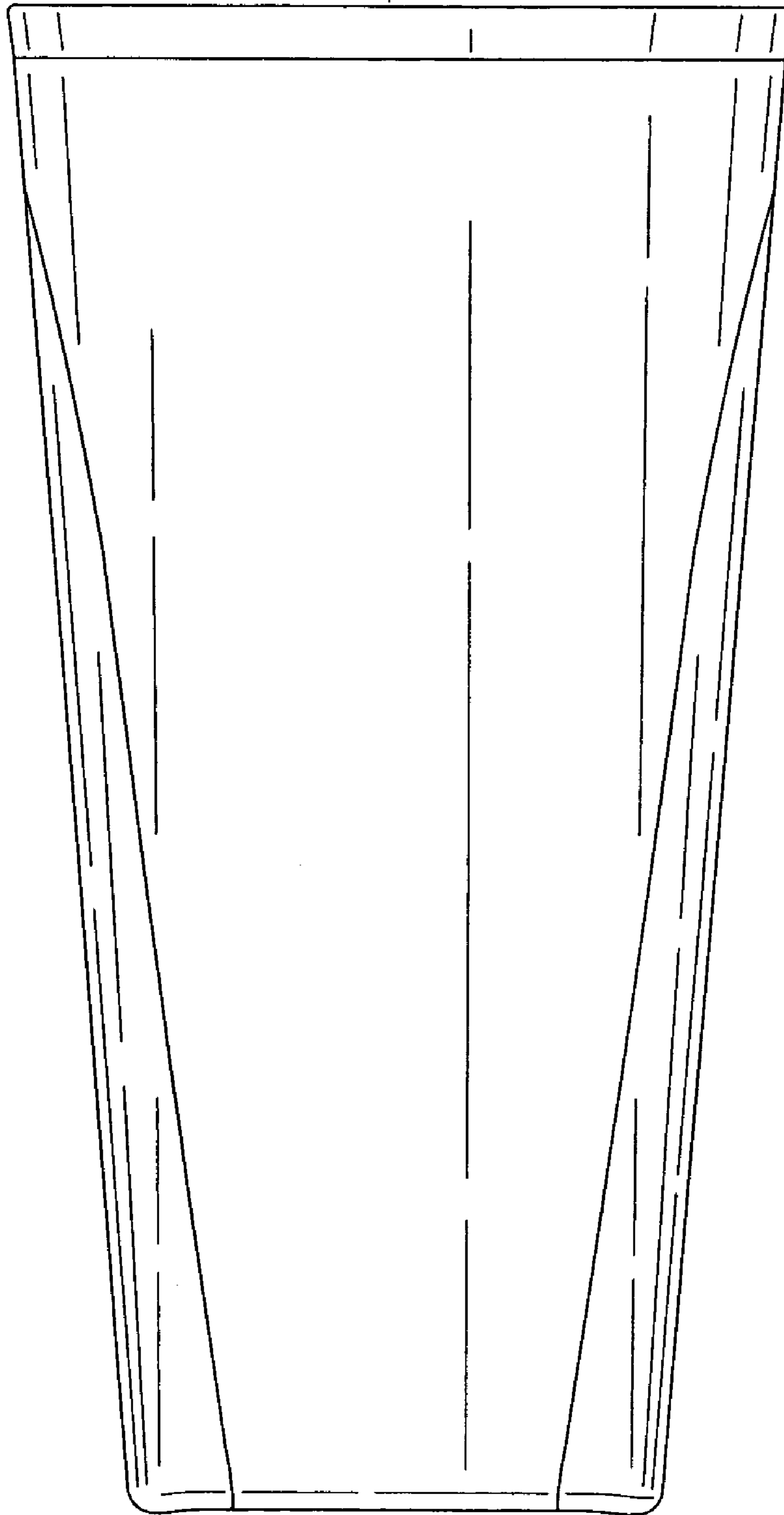

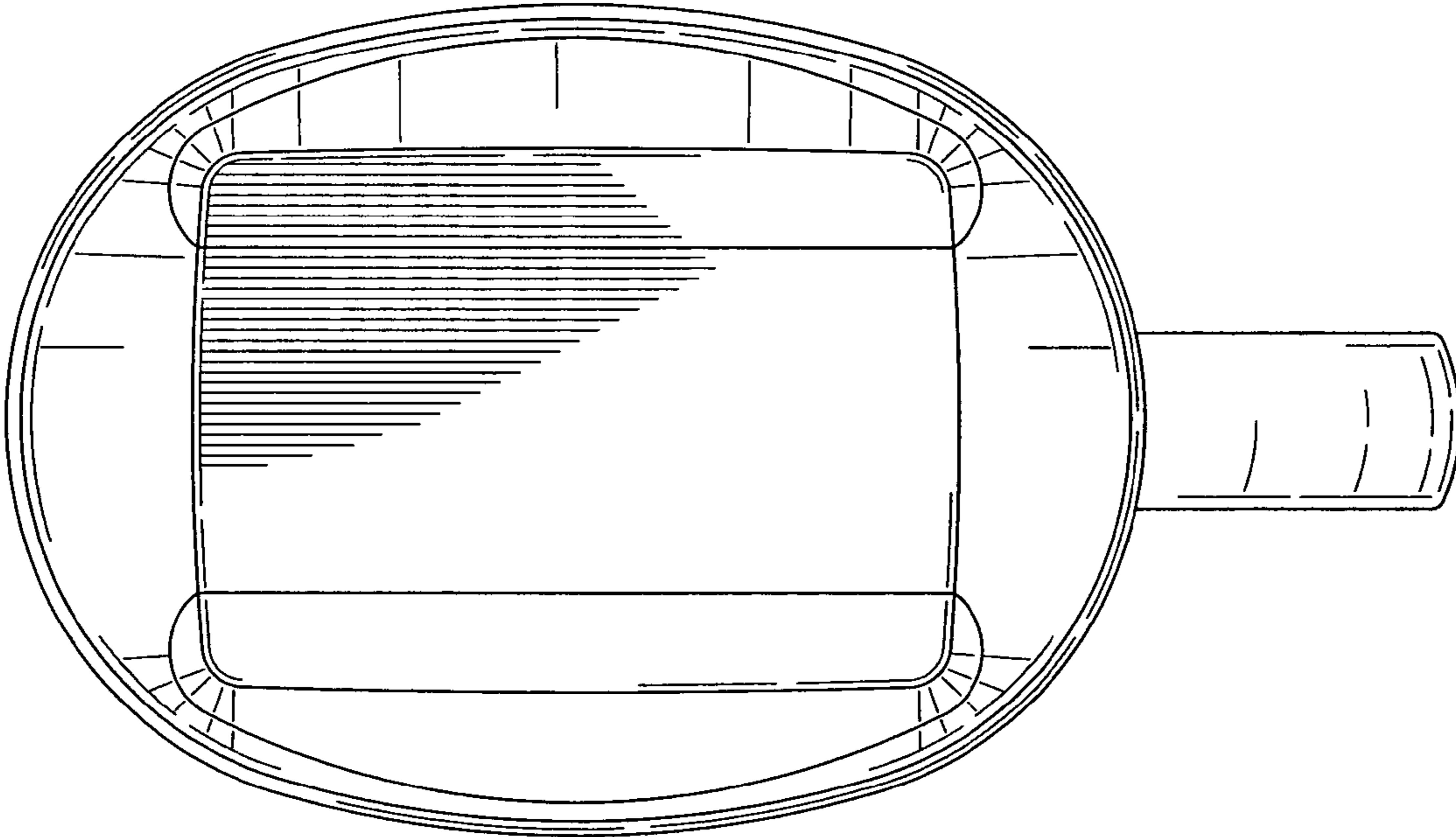

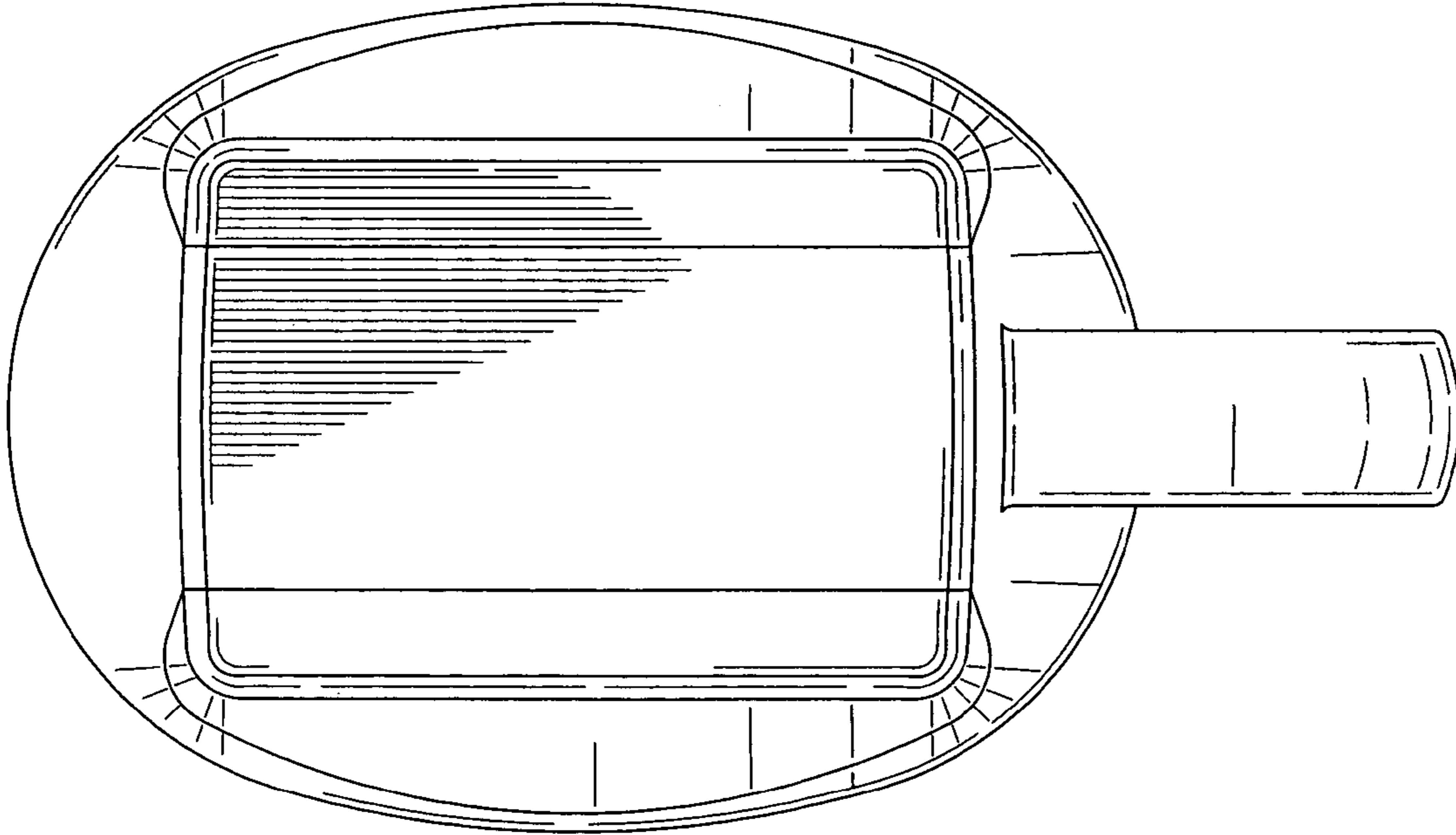
