DESCRIPTION

FIG. 12 is a left side elevation view thereof, the right side elevation view thereof being a mirror image;

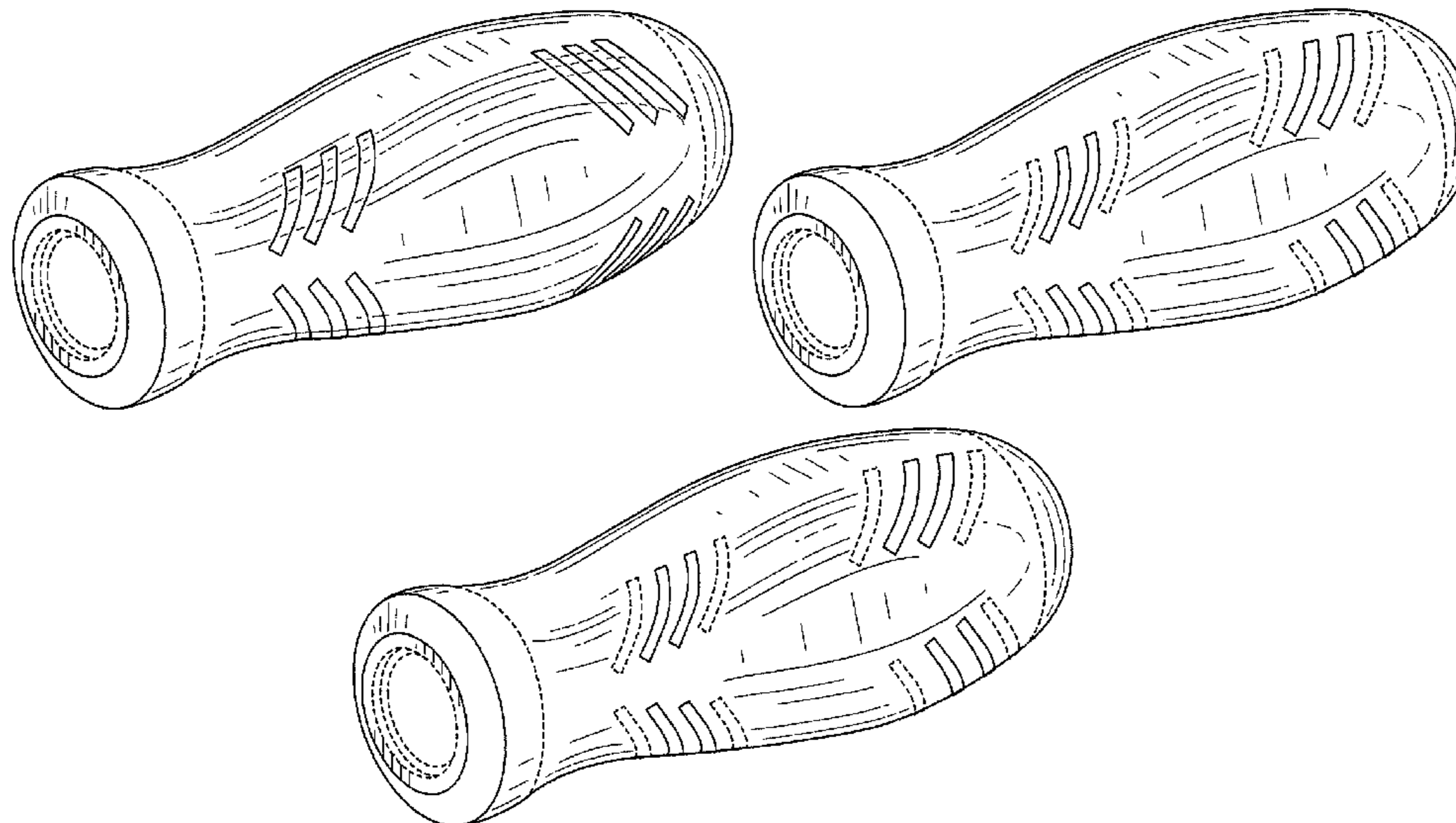
FIG. 13 is a top plan thereof, the bottom plan view thereof being a mirror image;

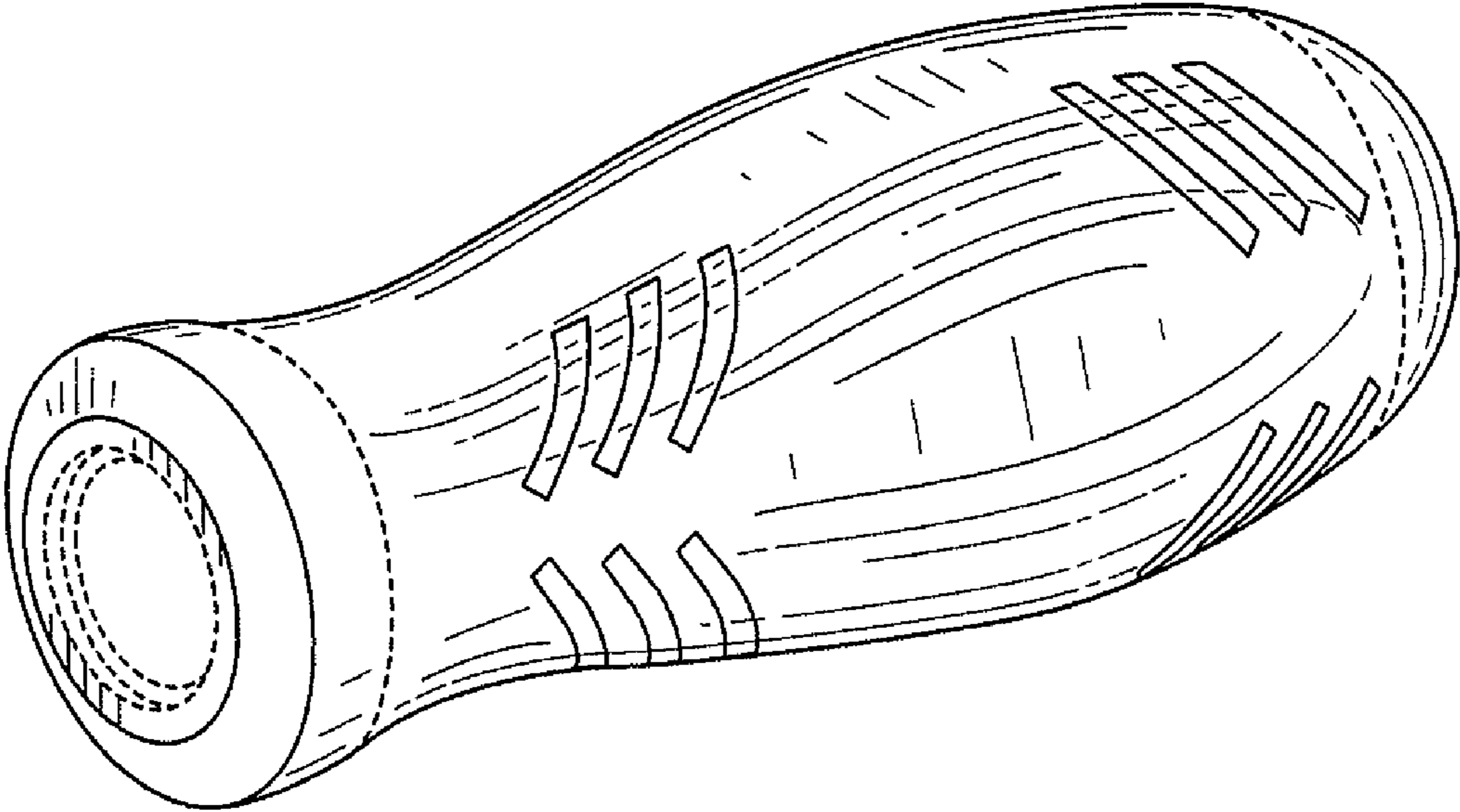

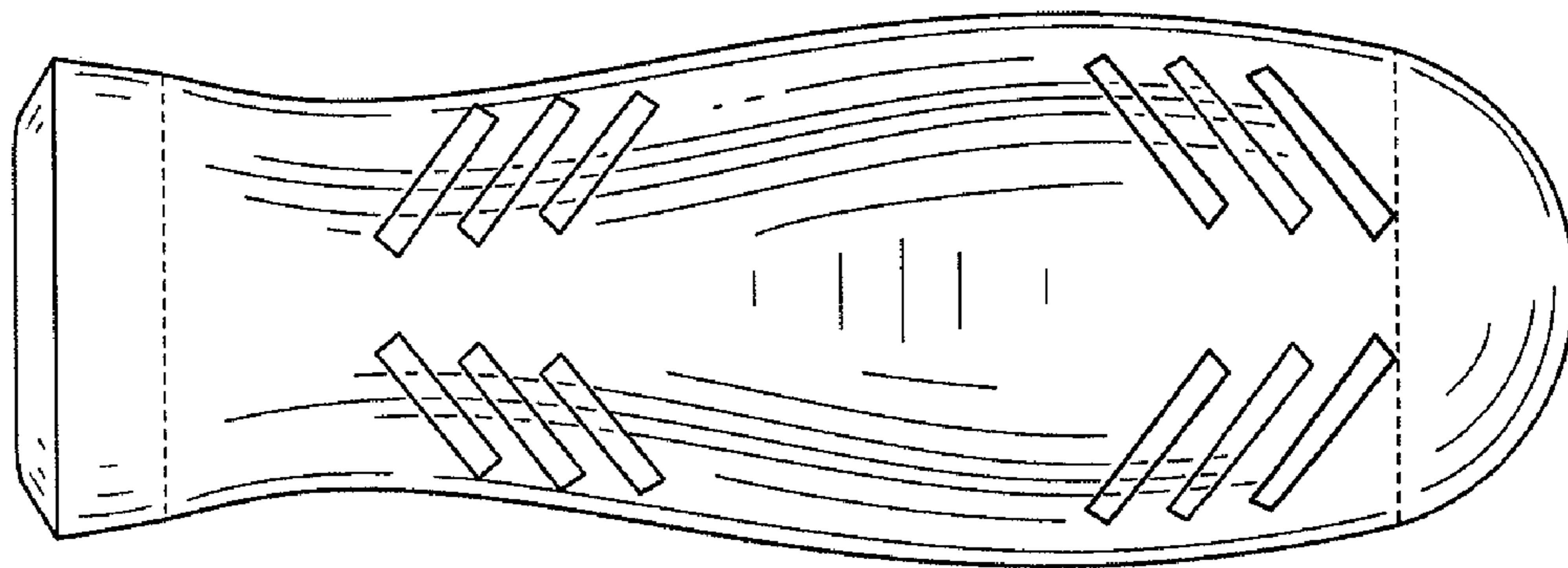

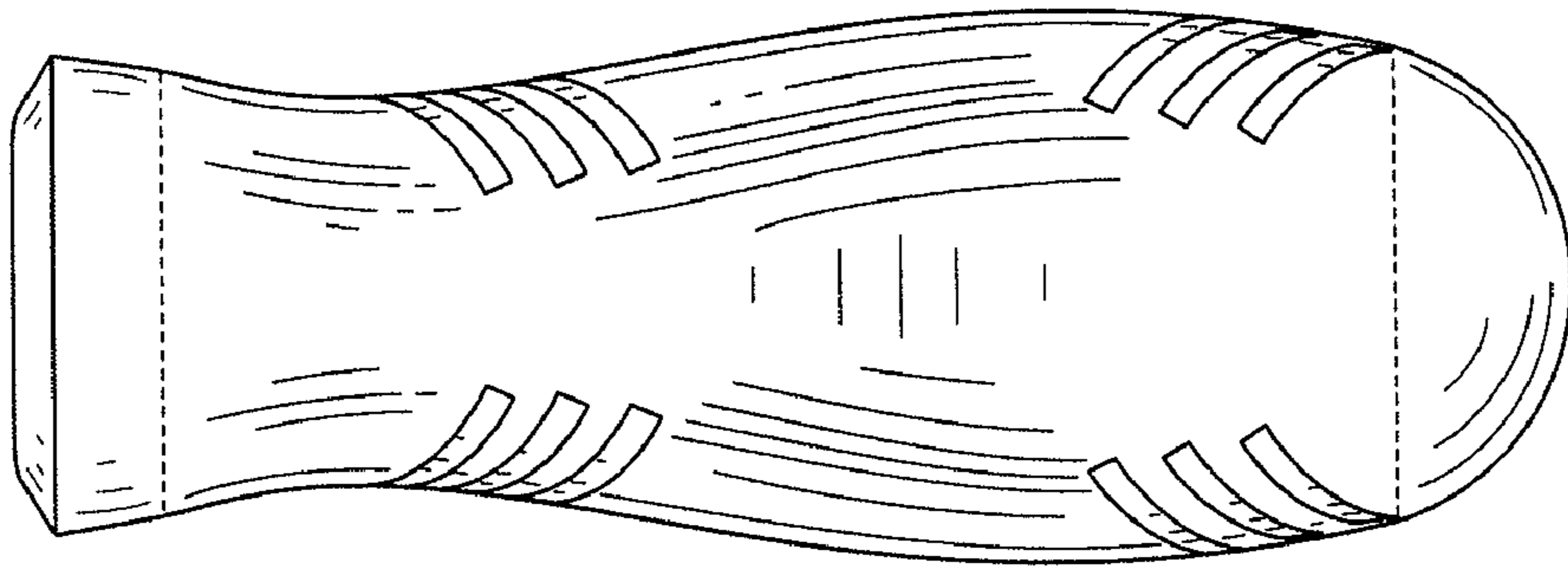

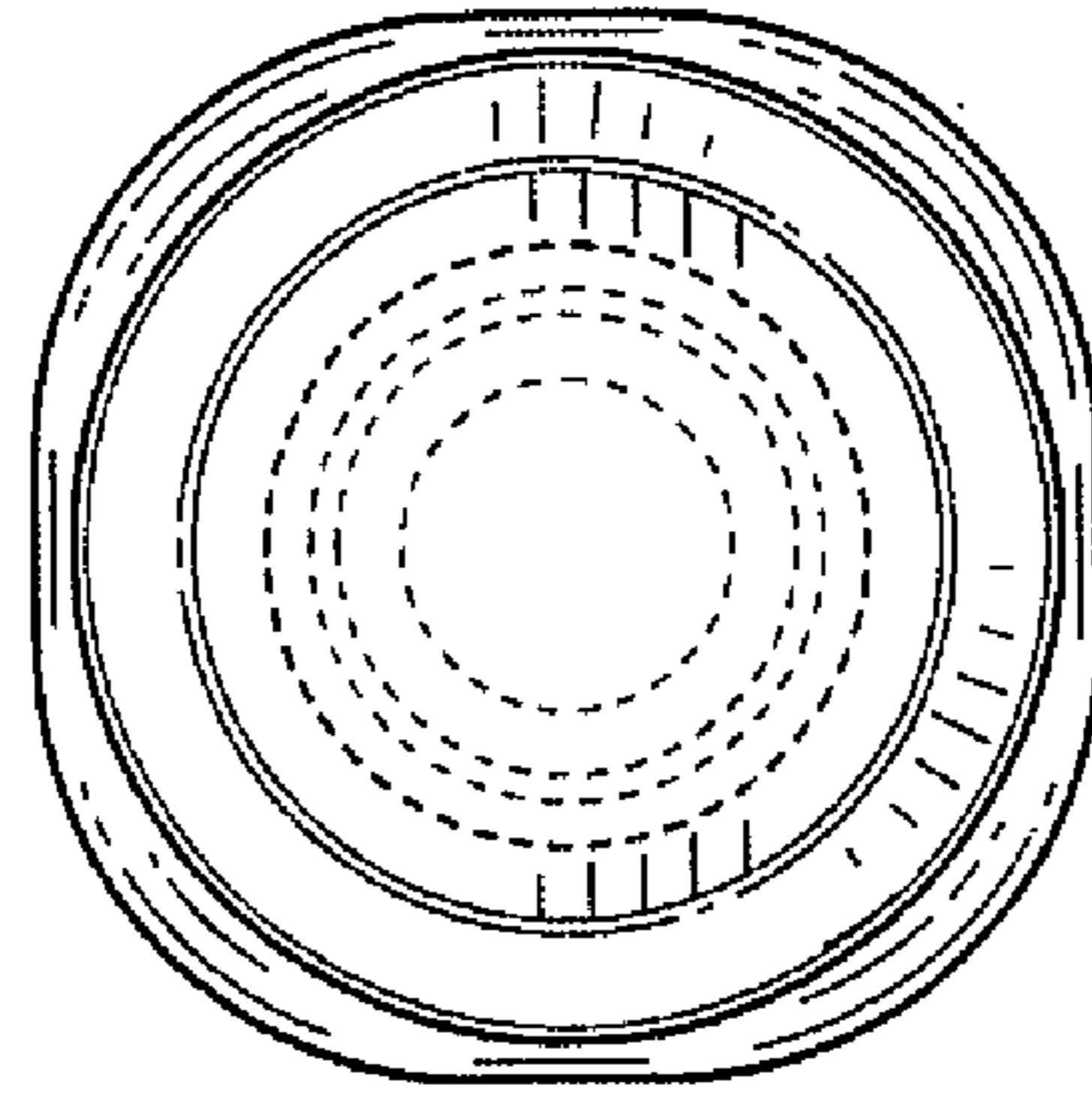

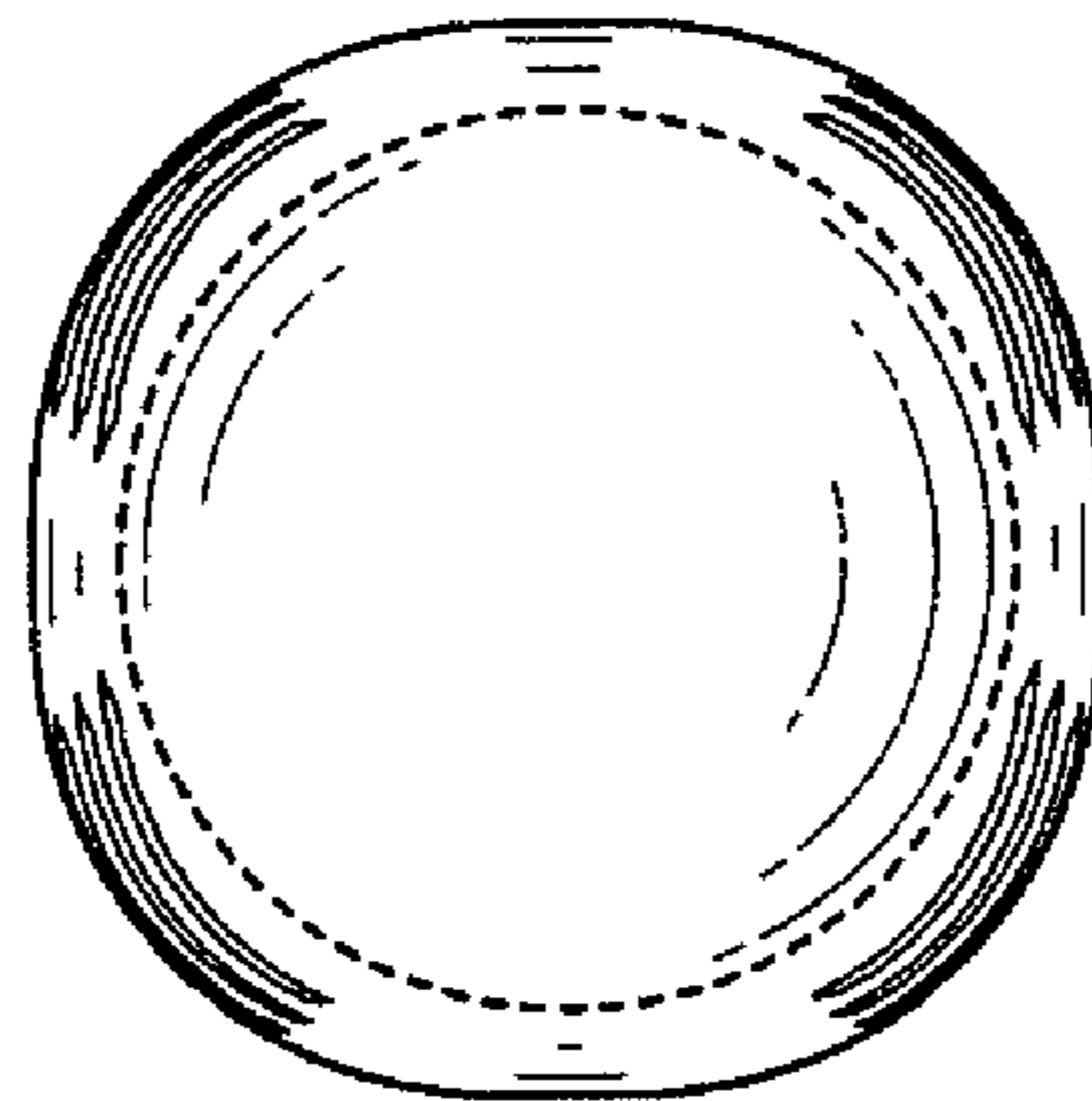

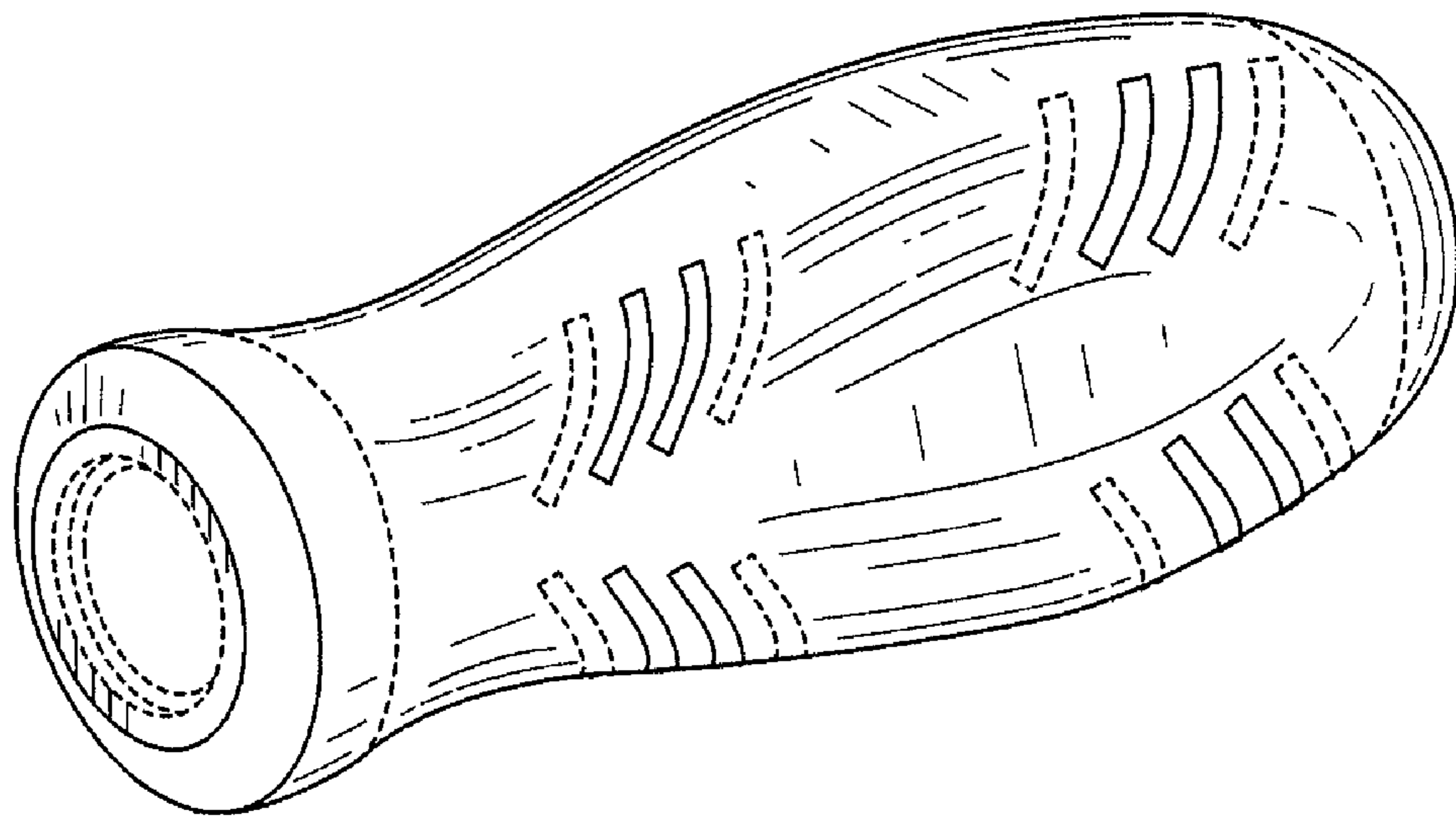

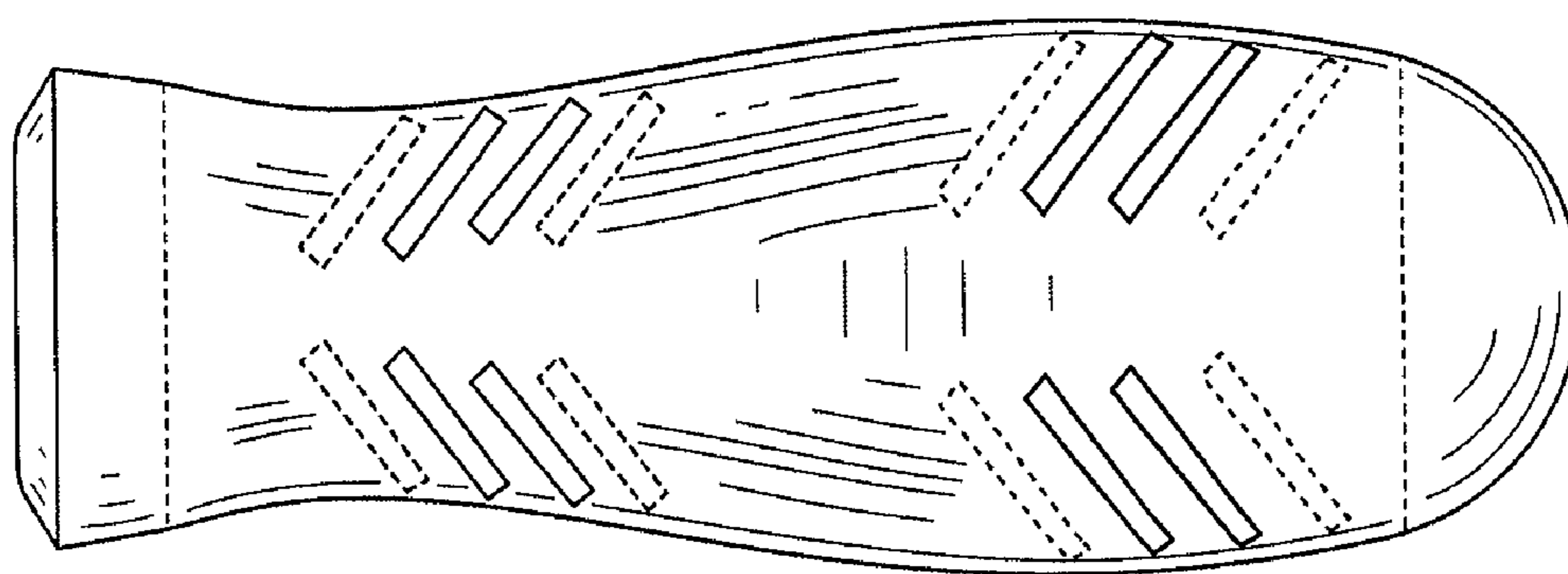

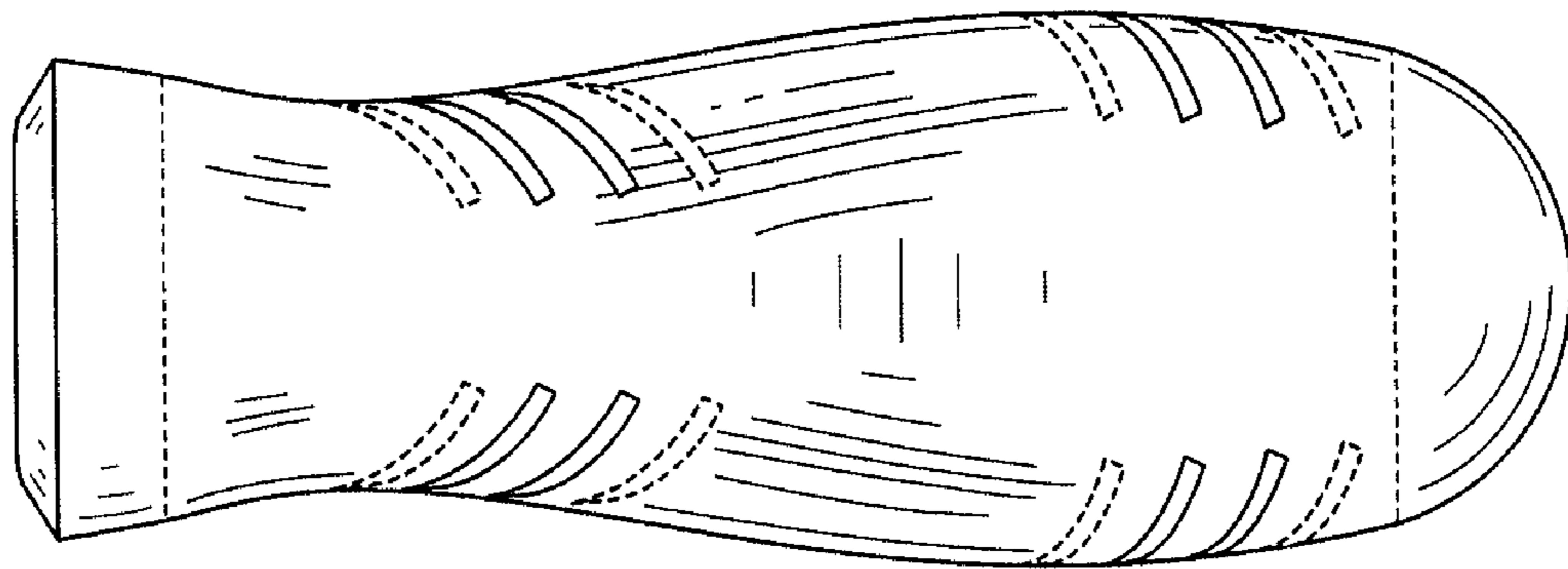

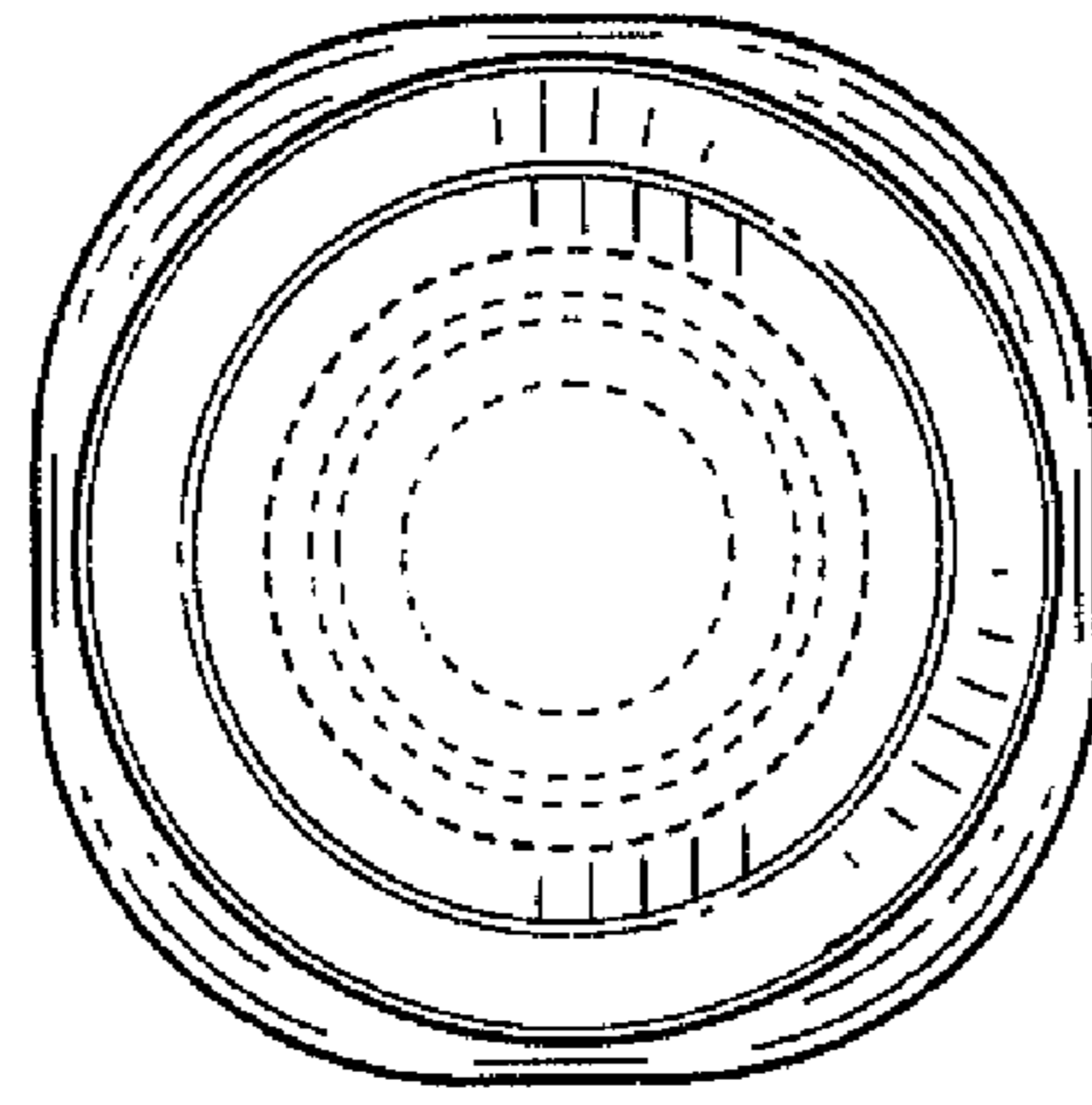

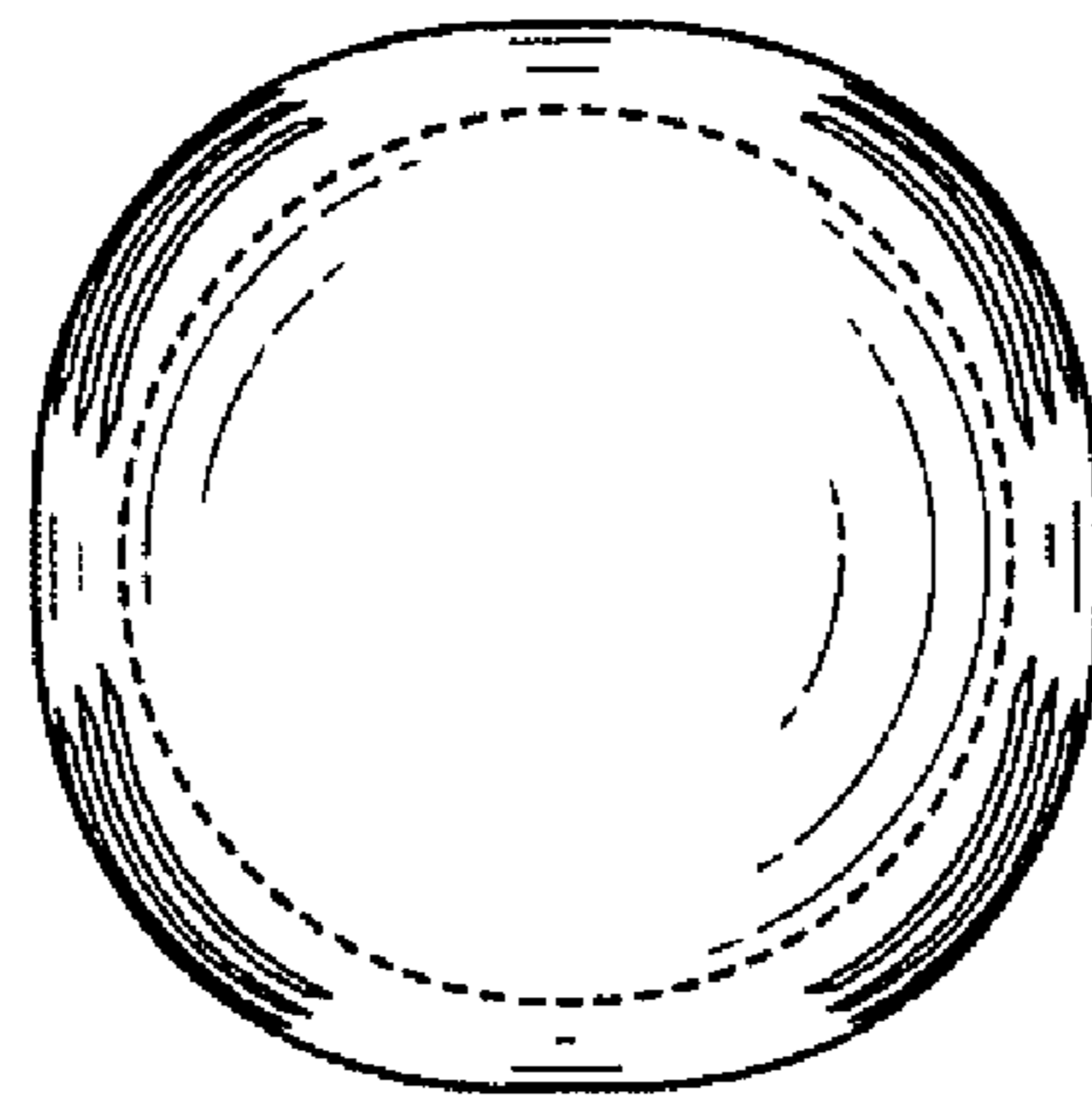

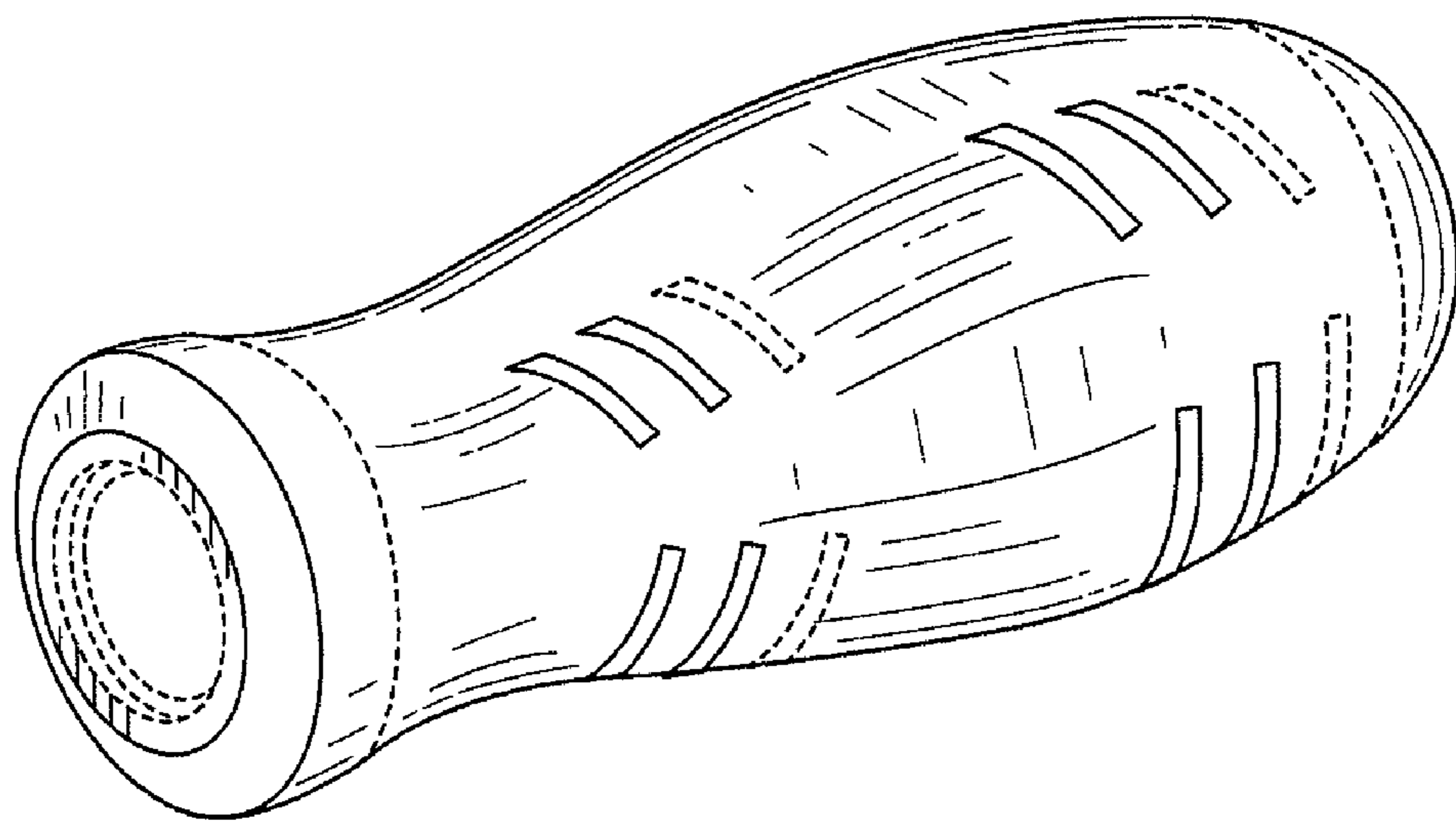

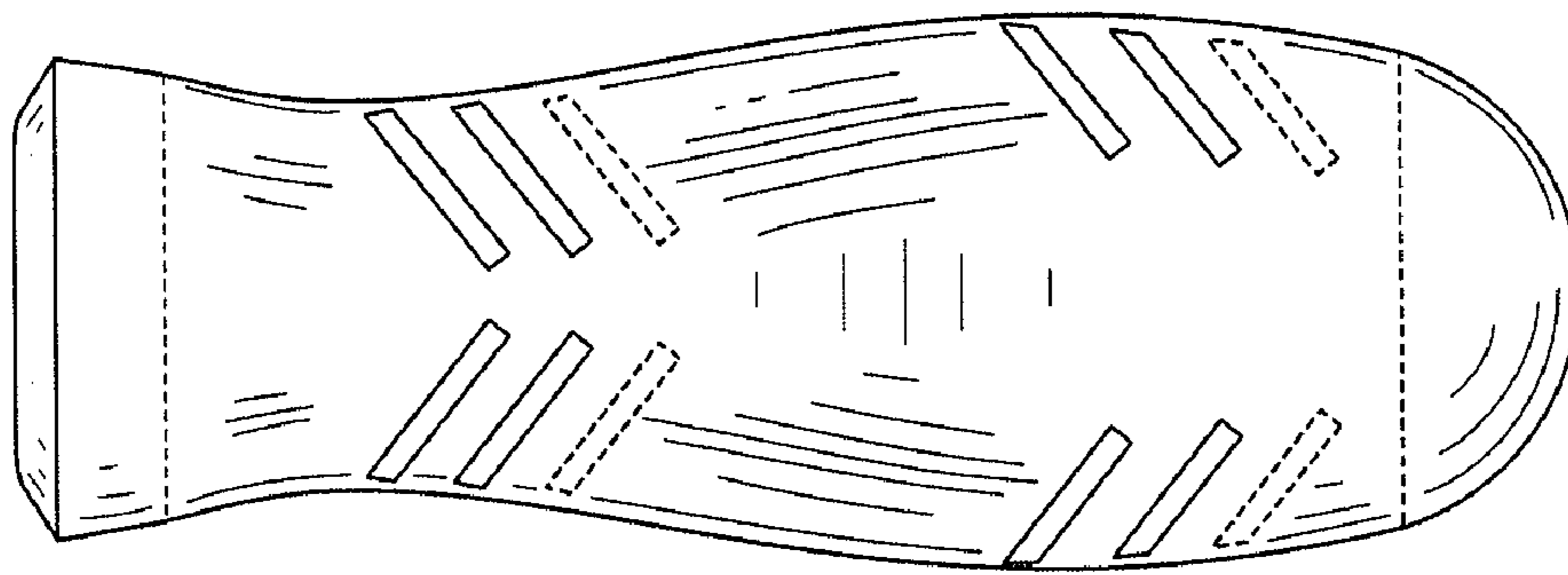

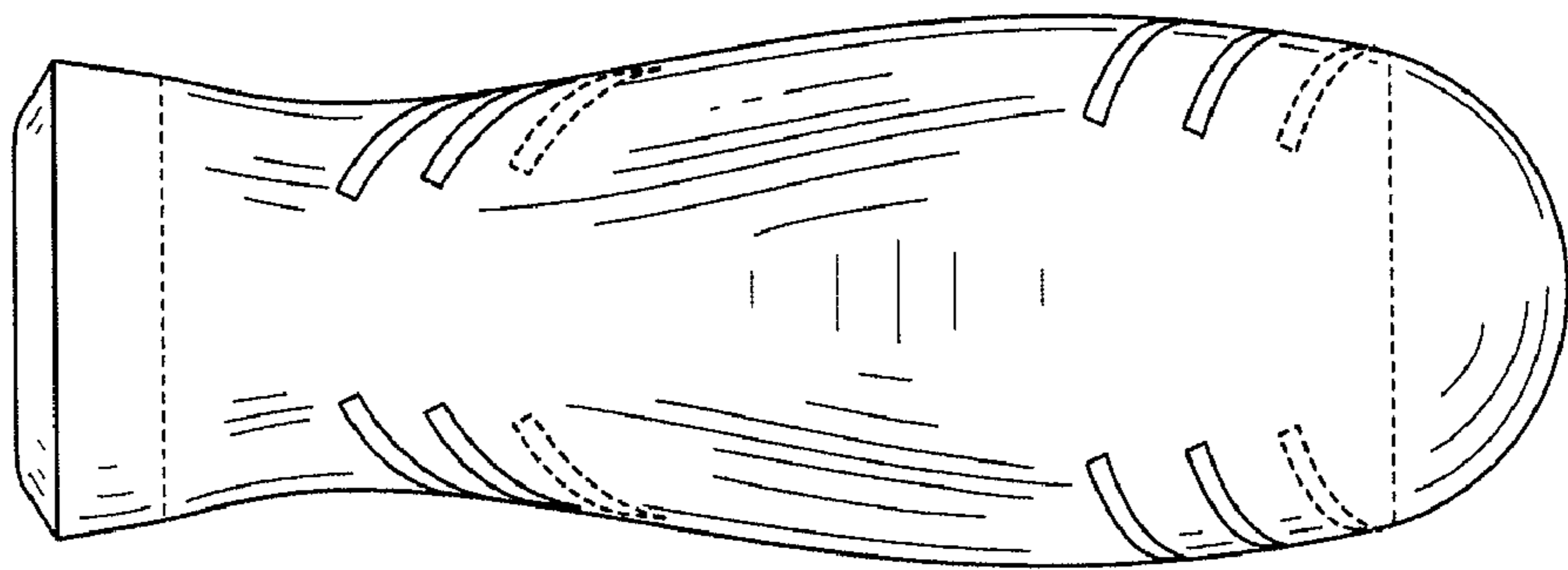

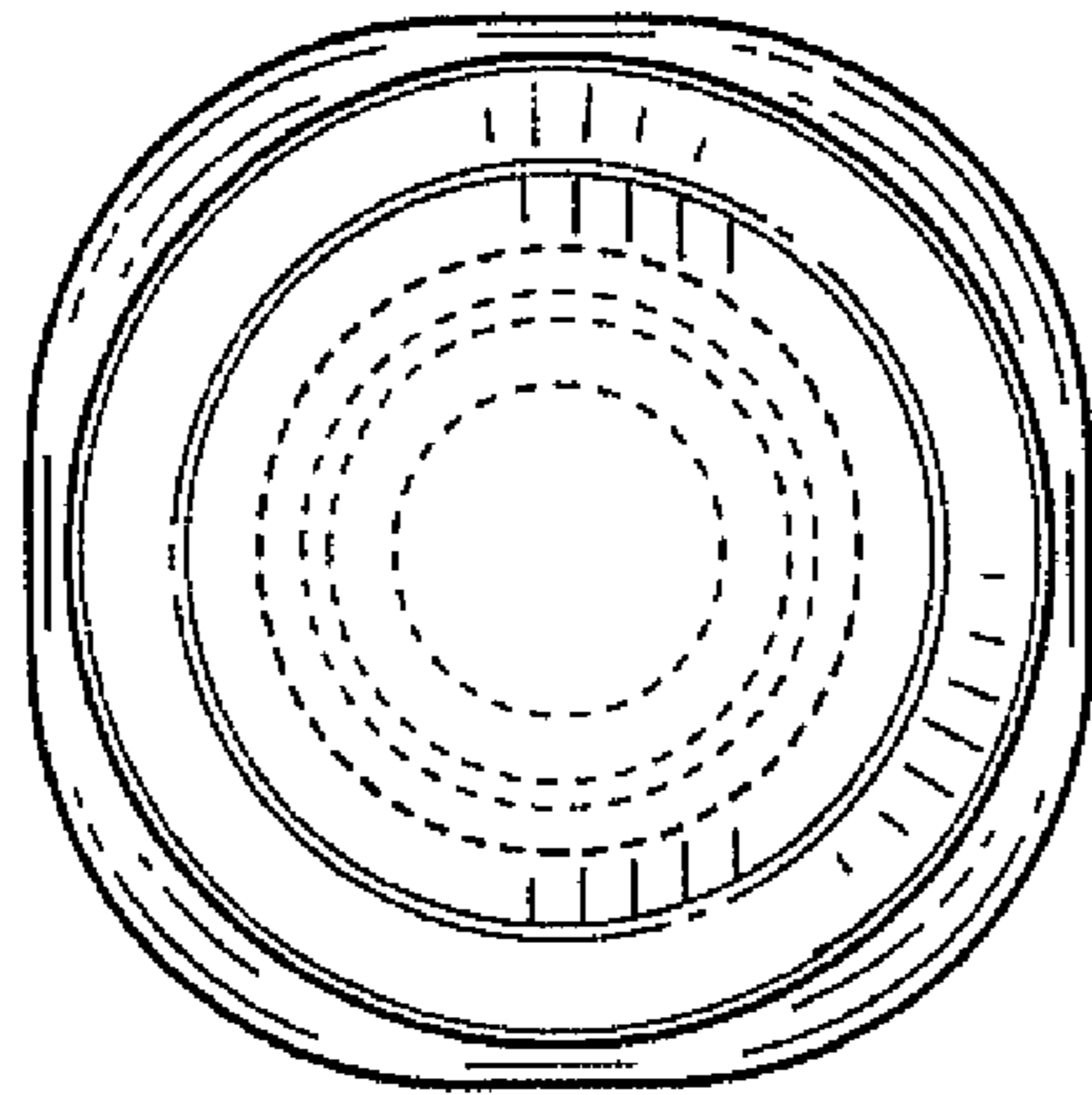

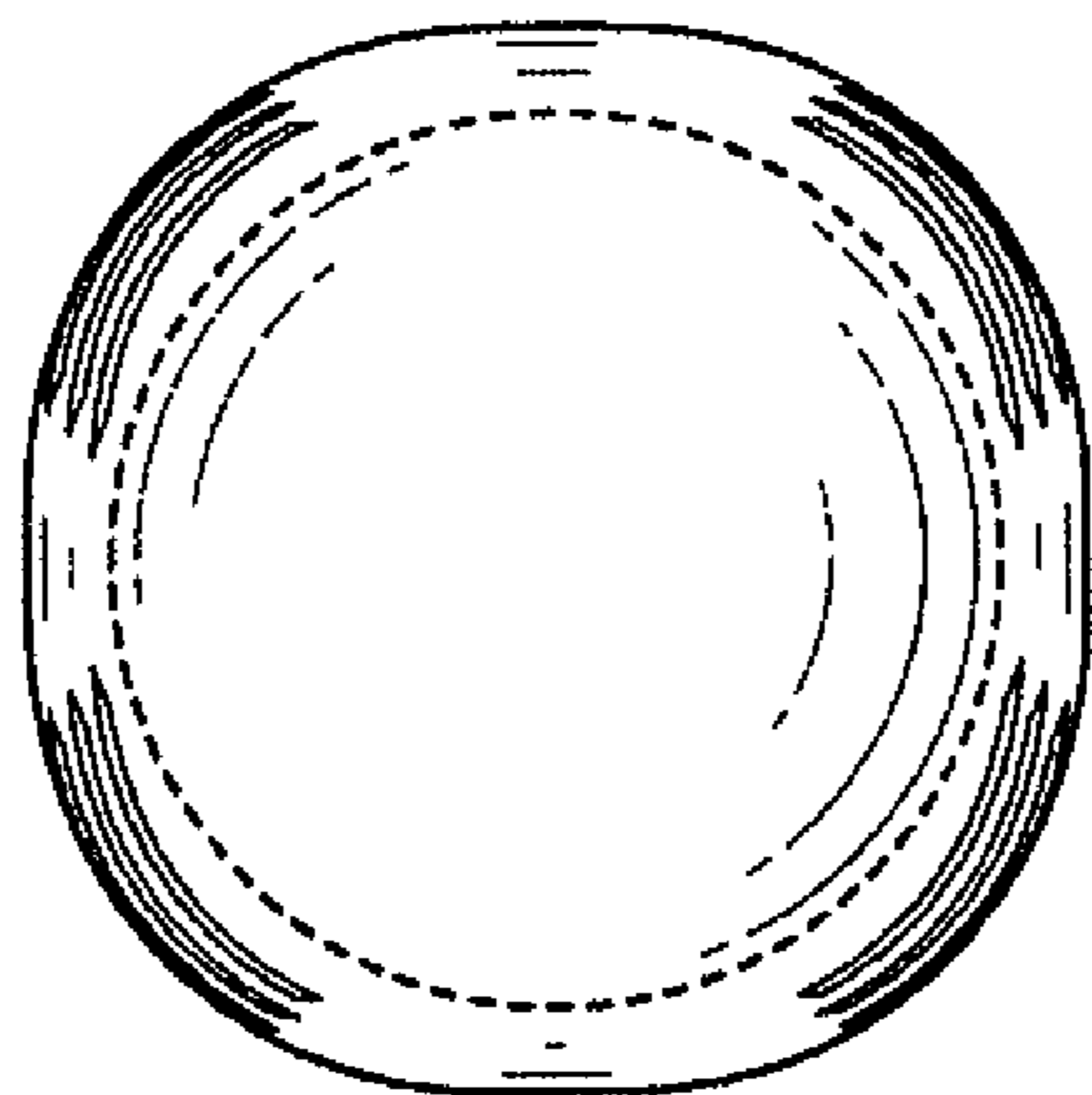
