FIG. 4 is the opposite side view of FIG. 2 thereof;

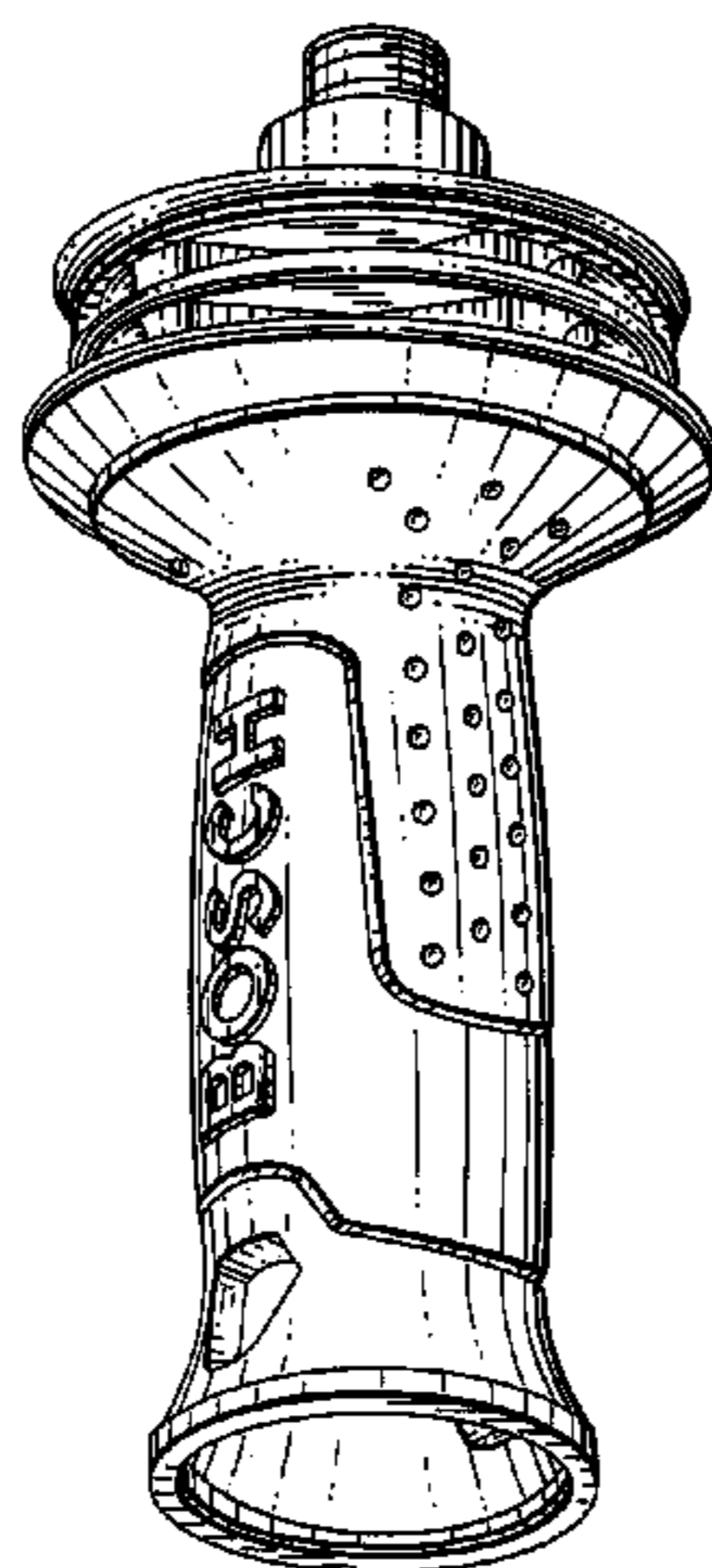
FIG. 5 is a rear view thereof;

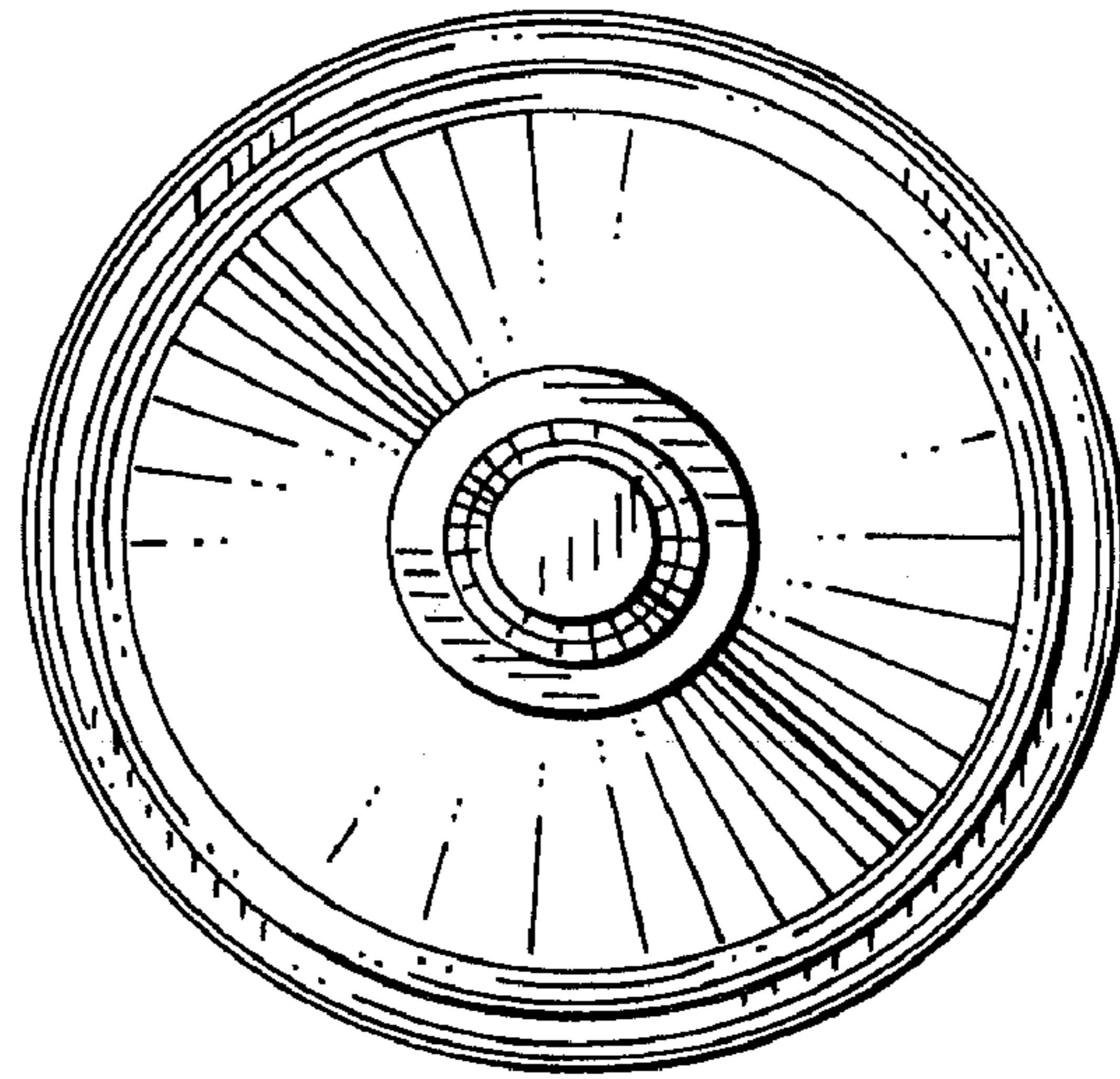
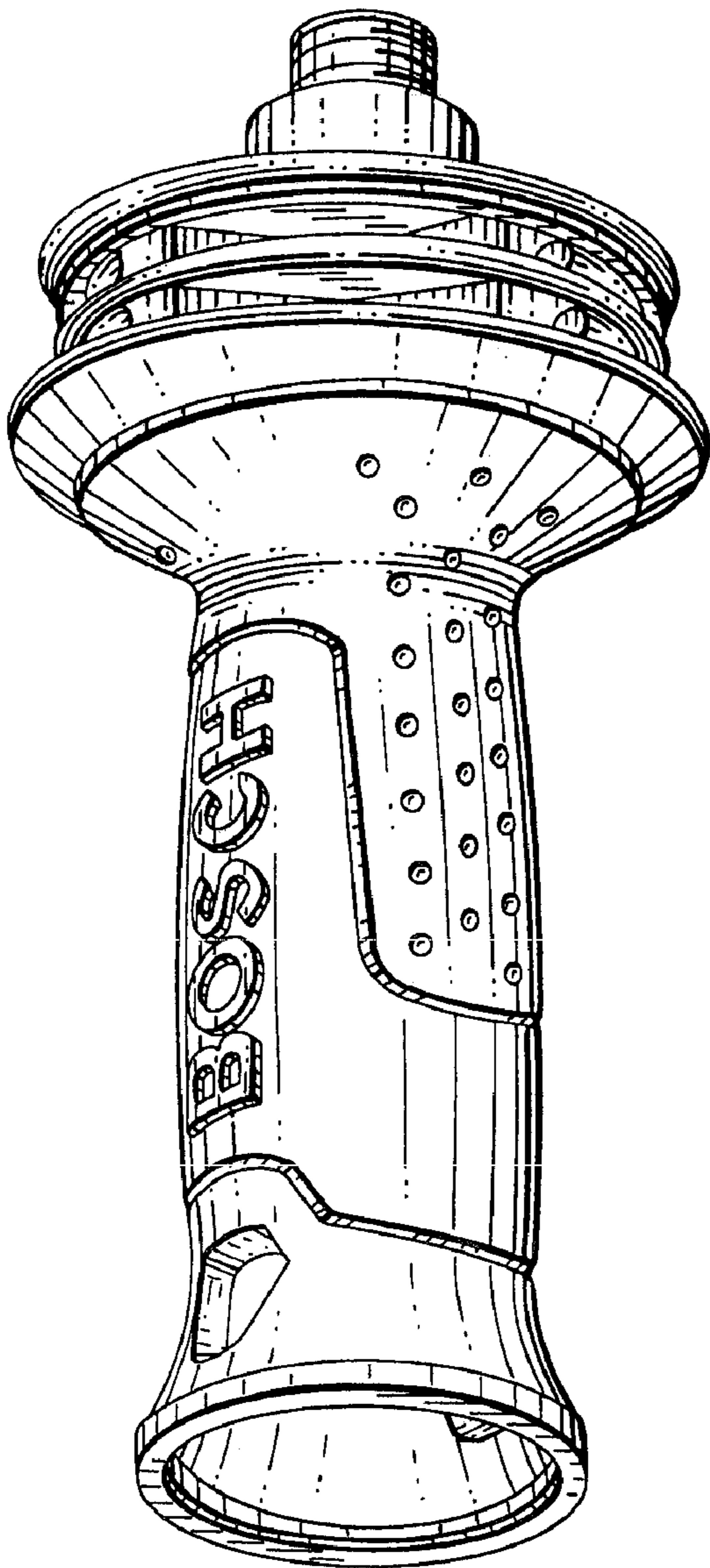

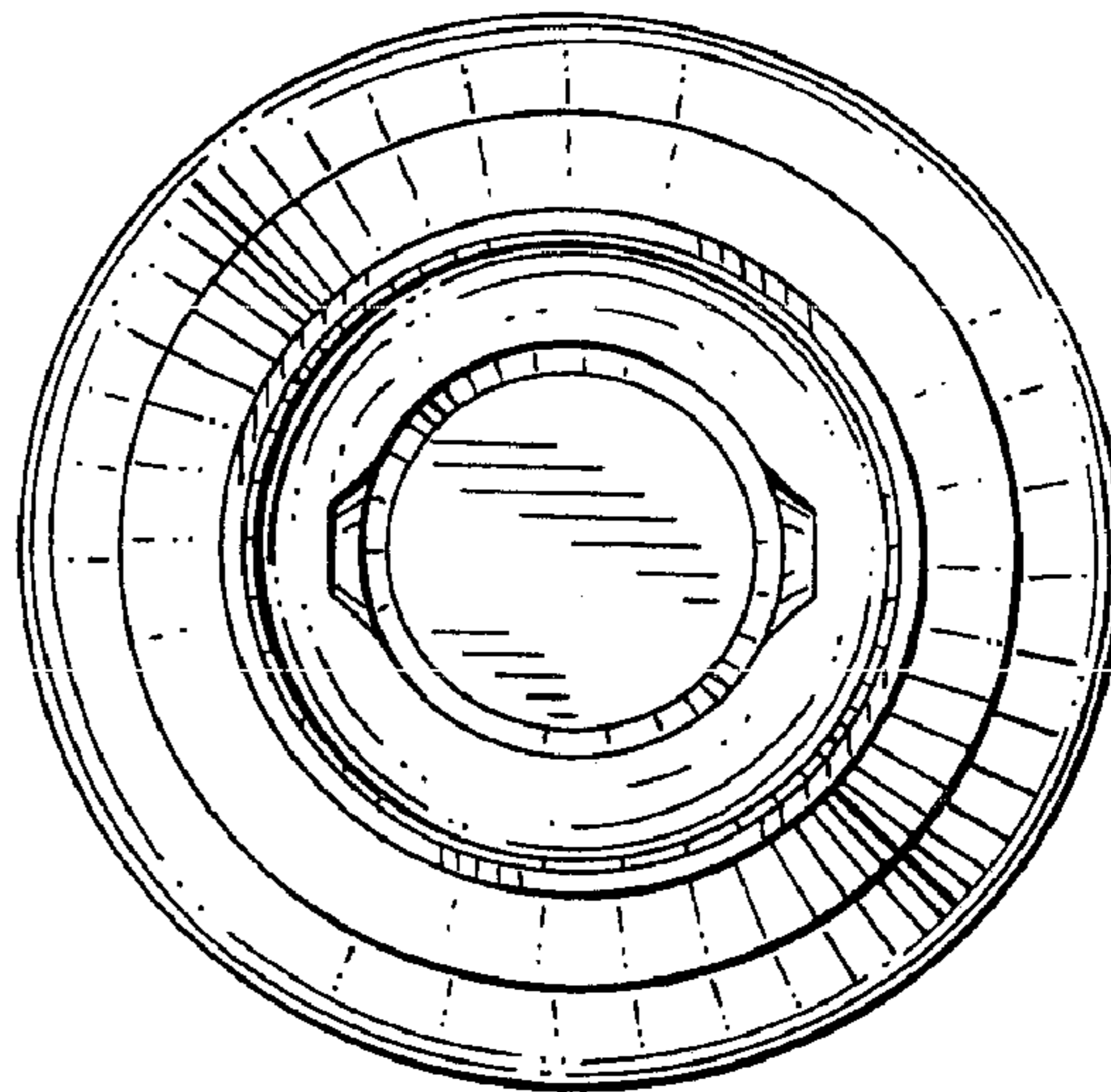

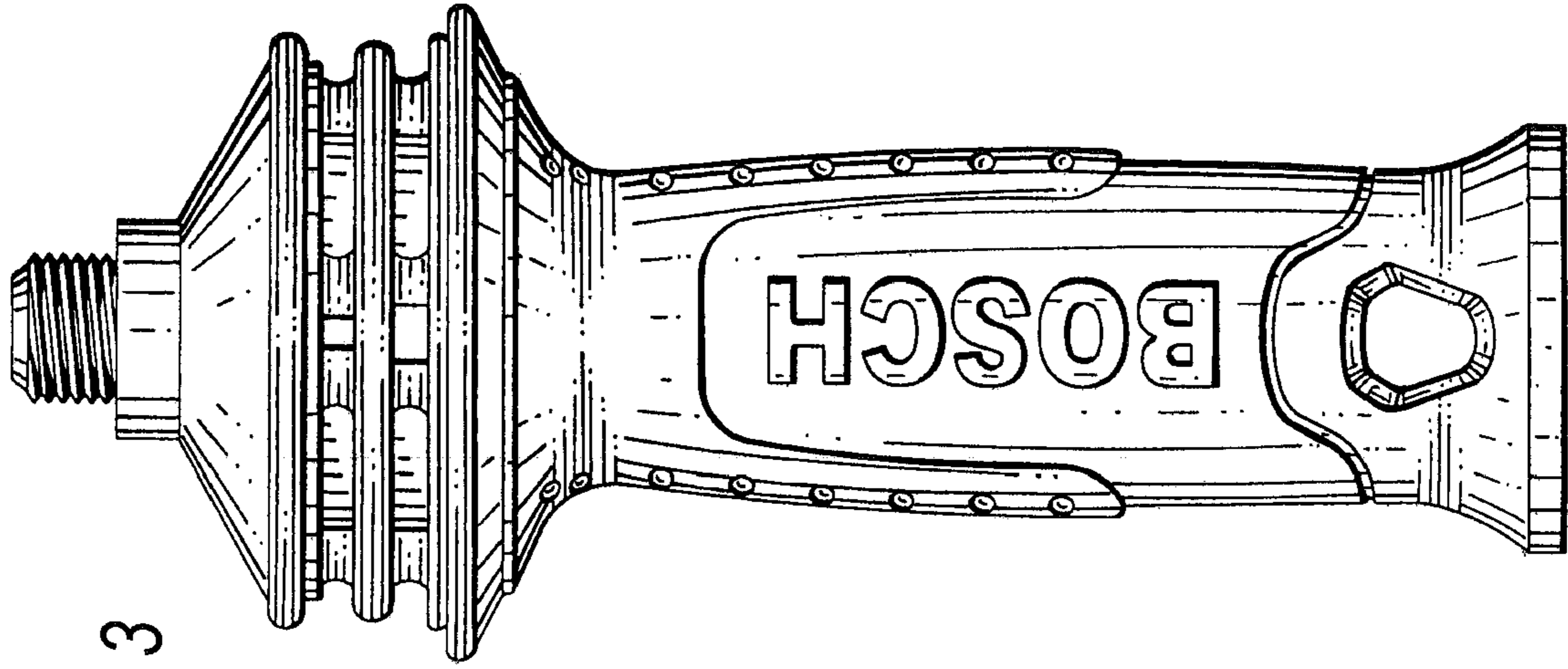

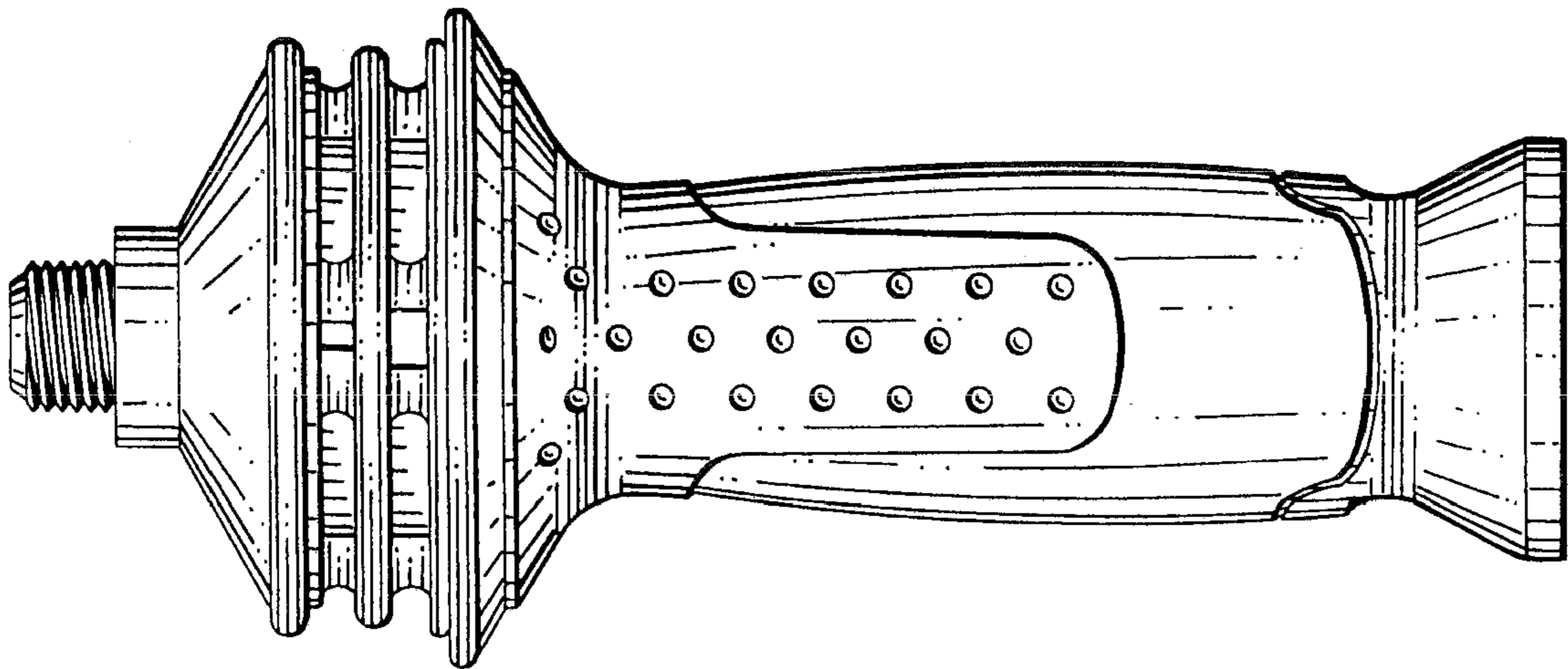

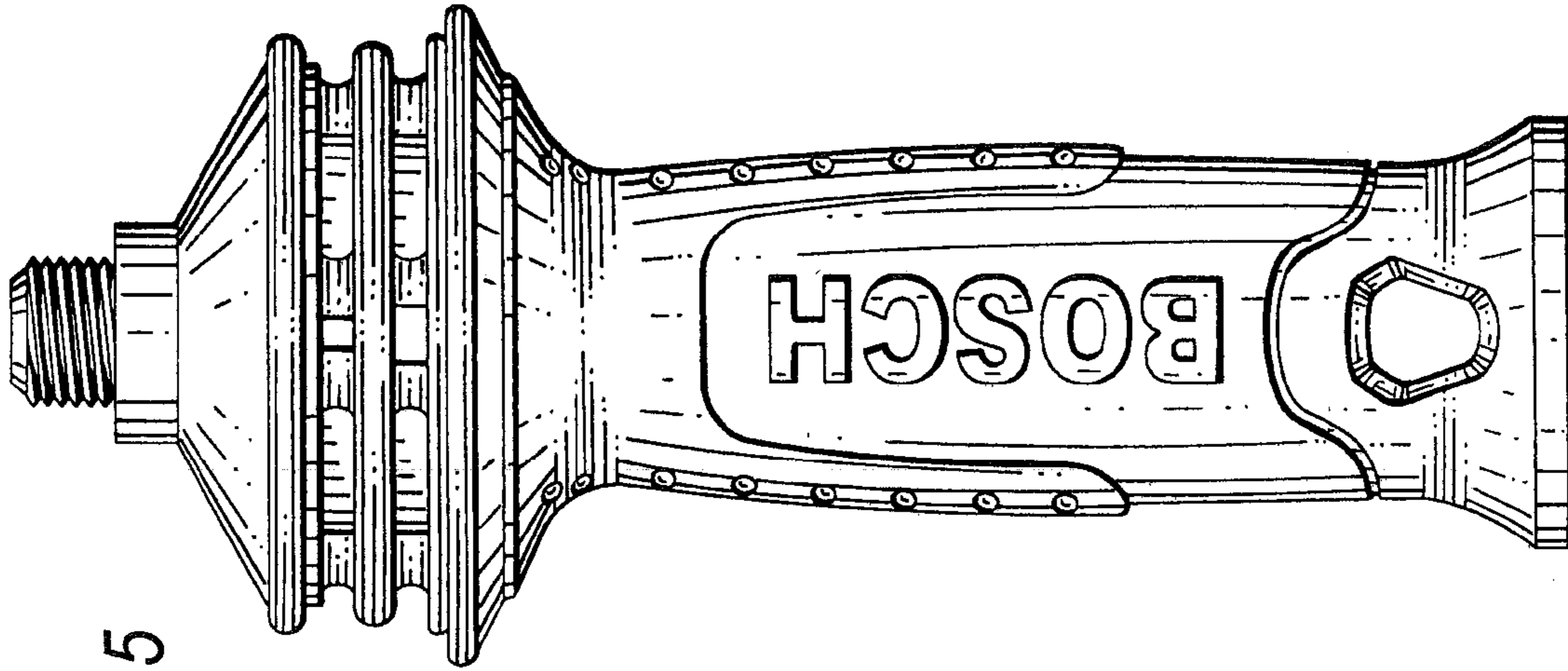

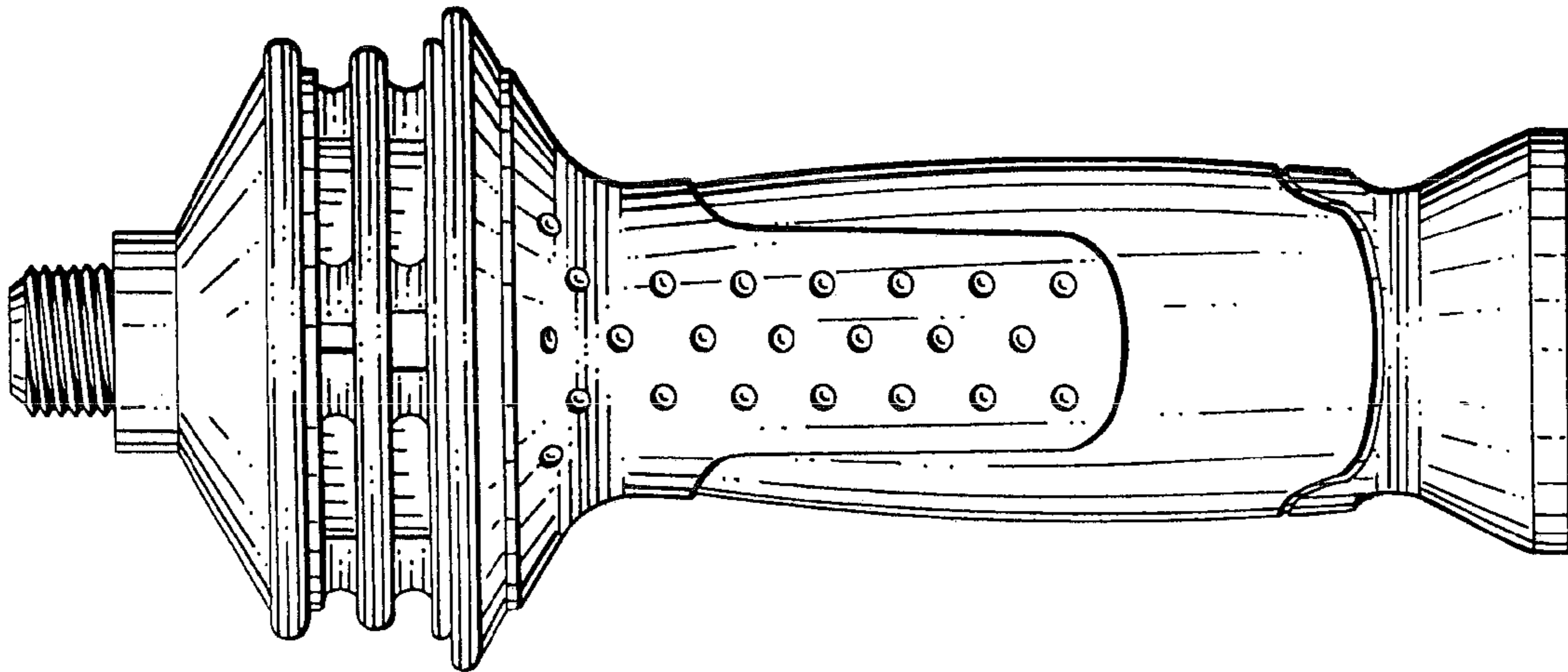
