The ornamental design for a container with corner handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with corner handle embodying our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

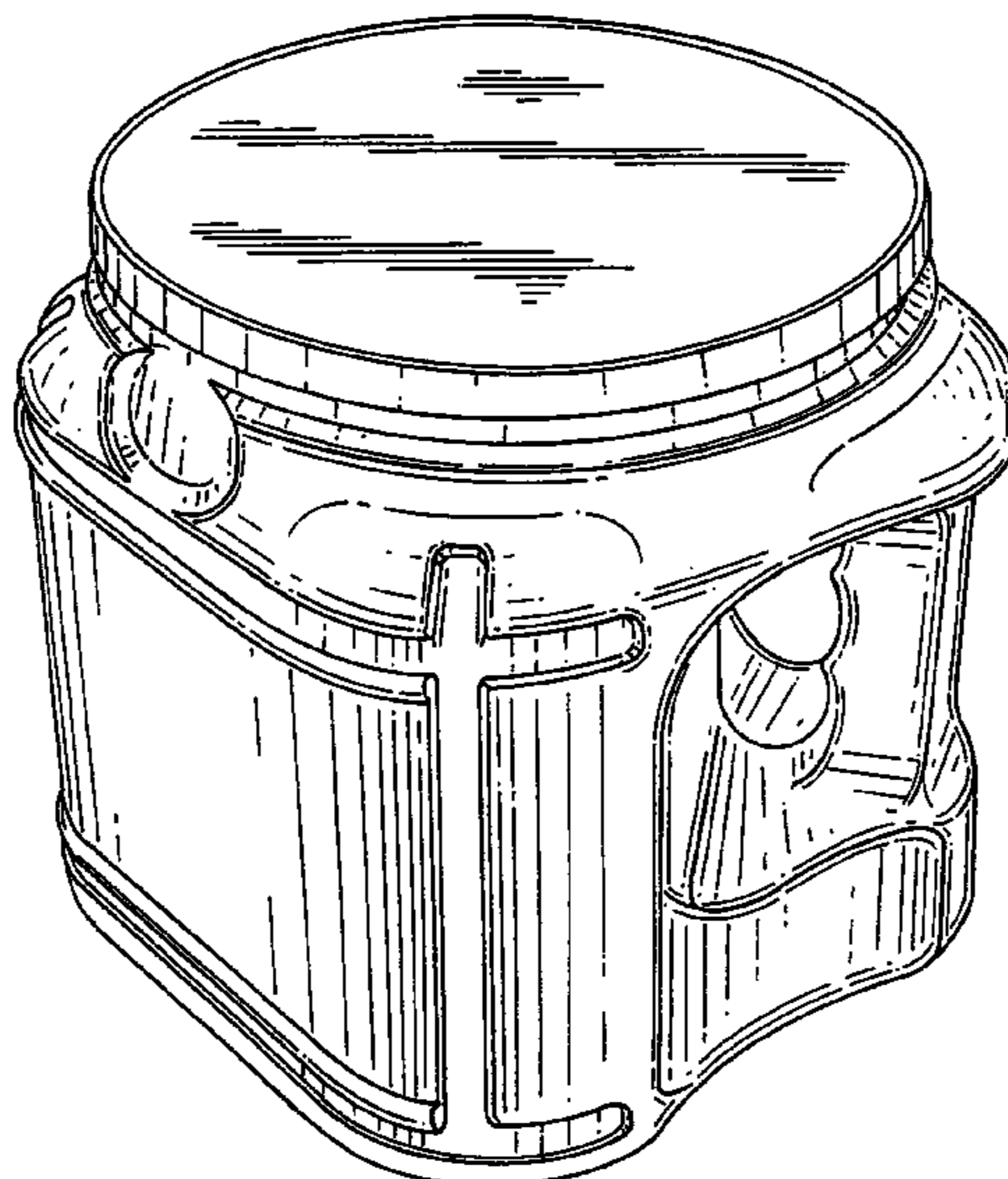
FIG. 3 is a bottom plan view thereof;

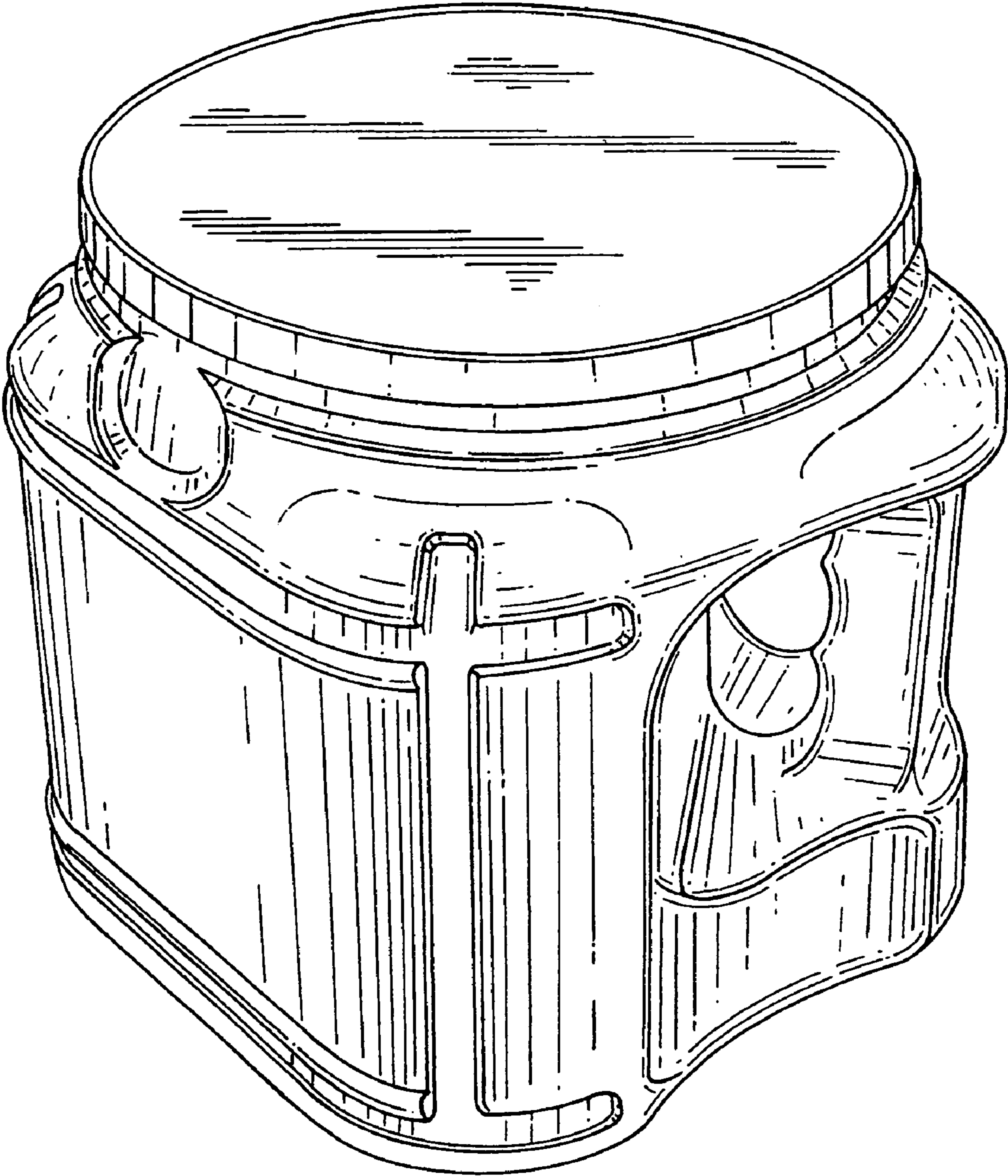

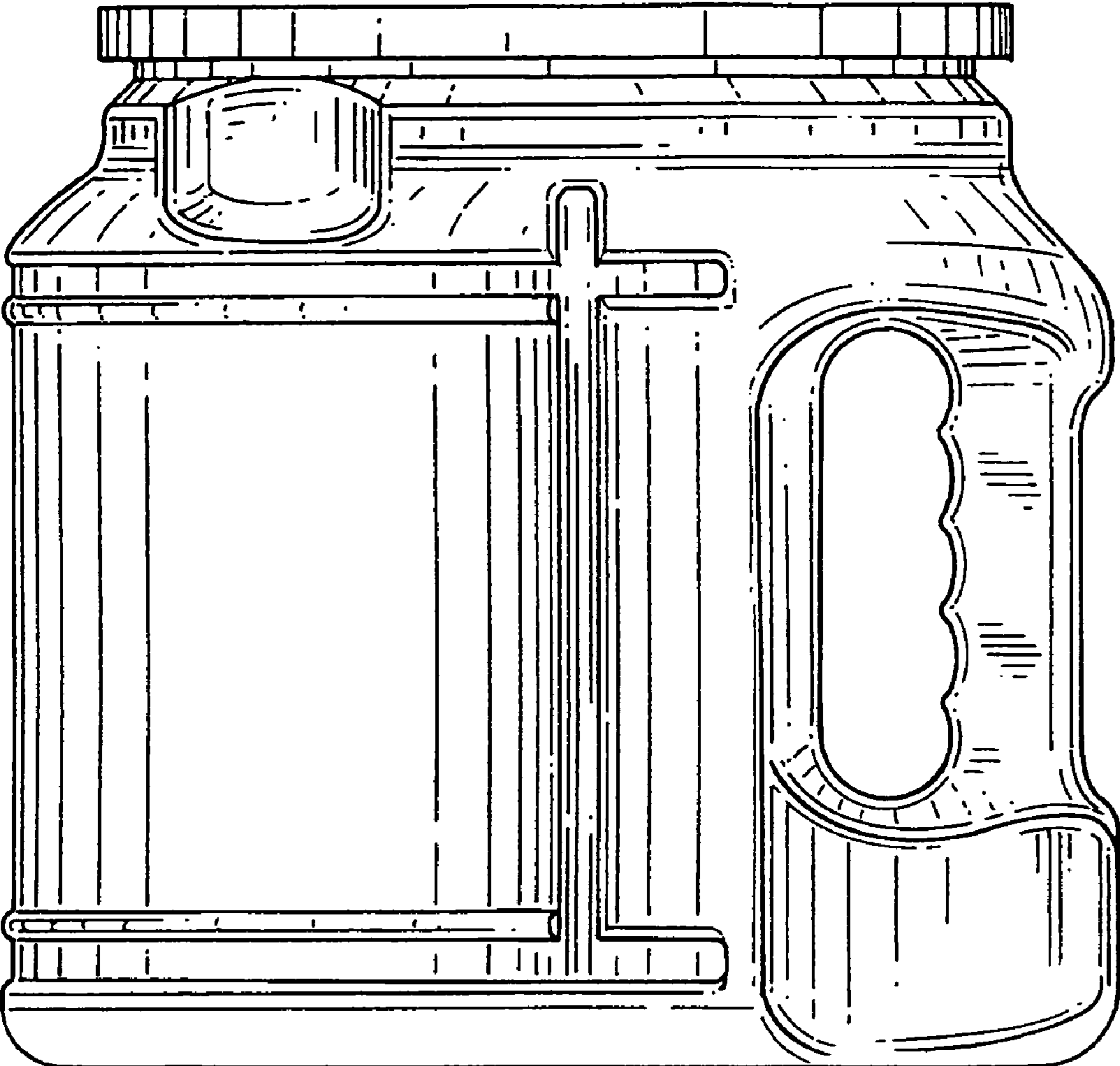

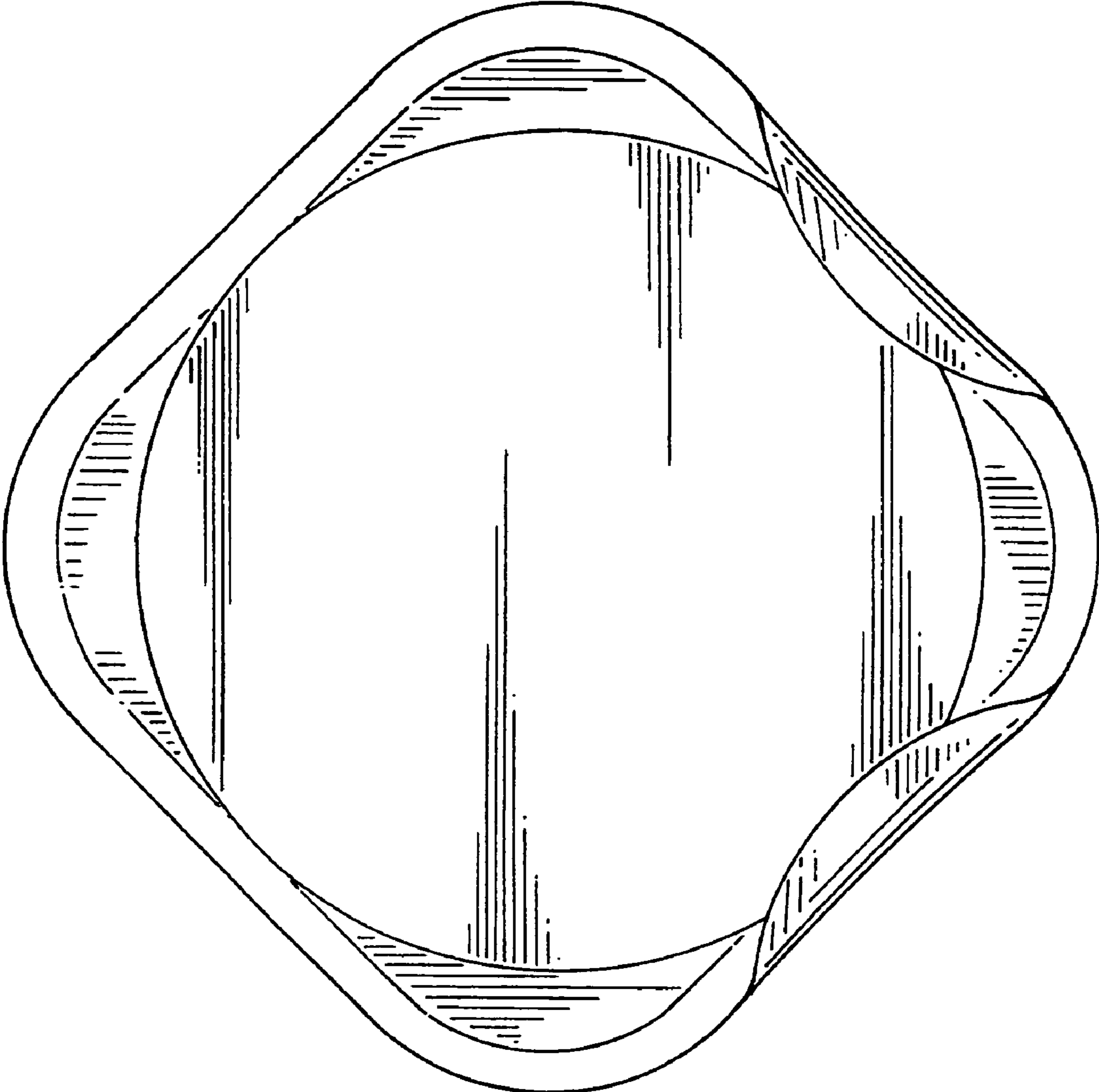

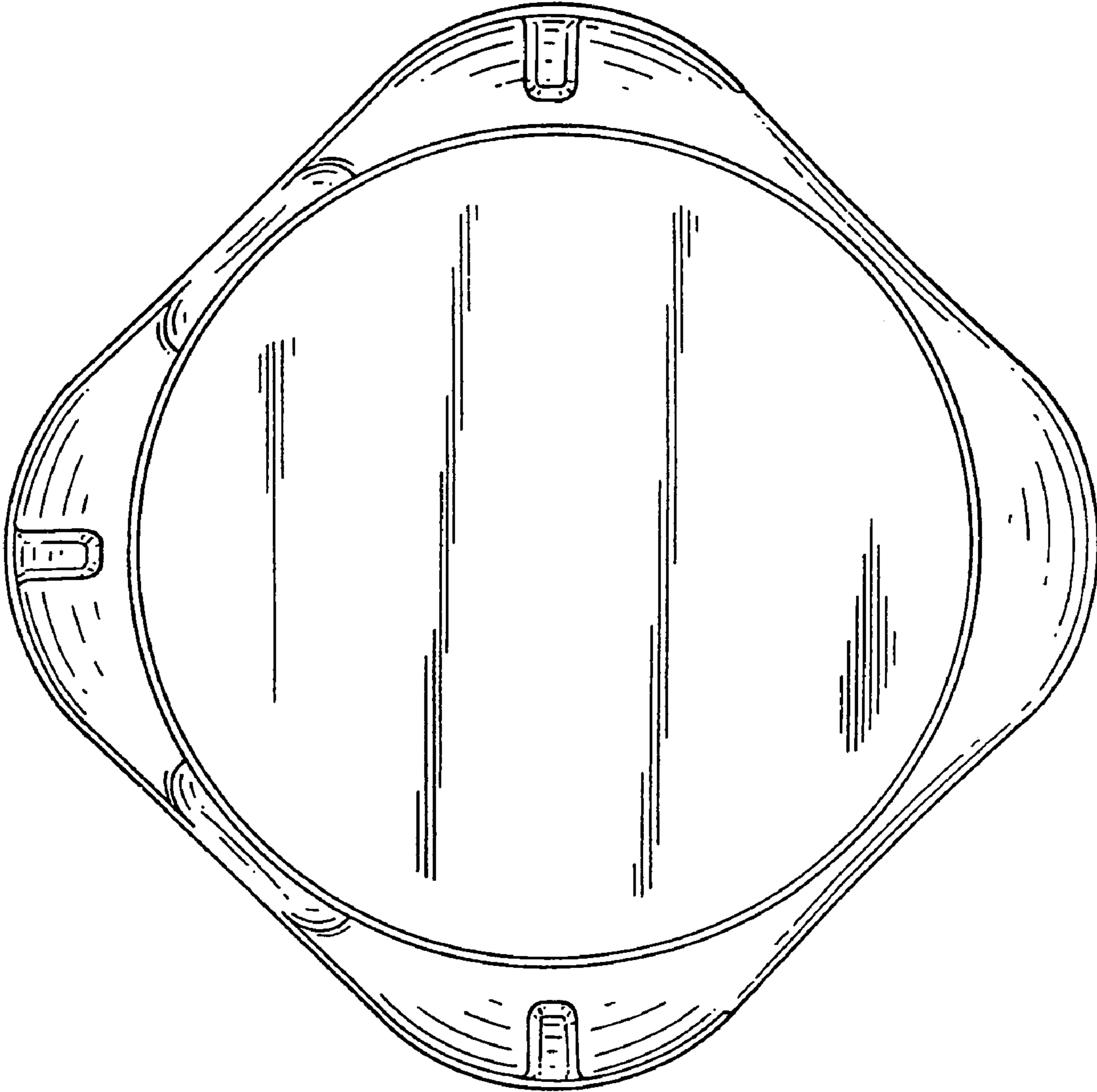

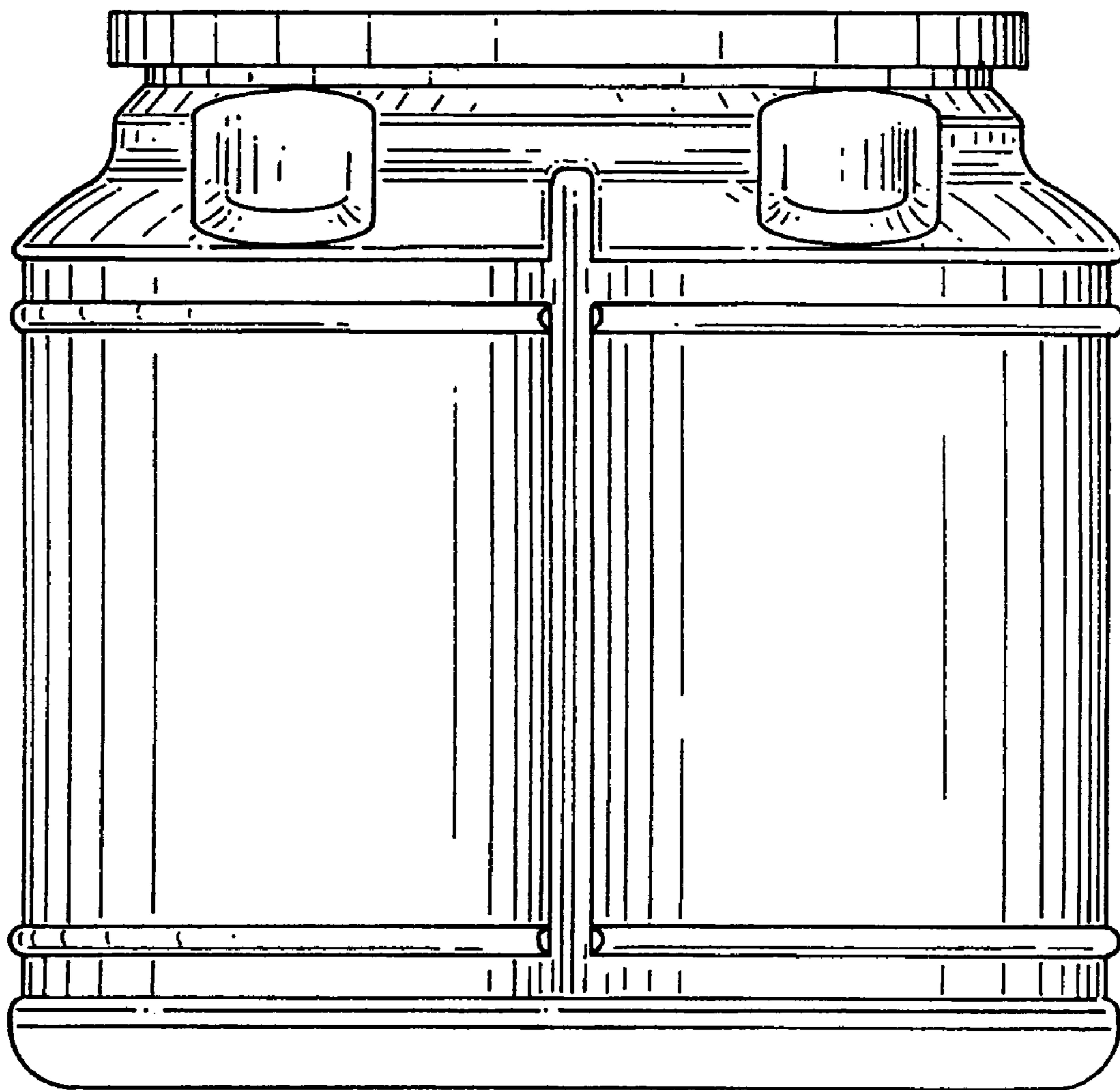

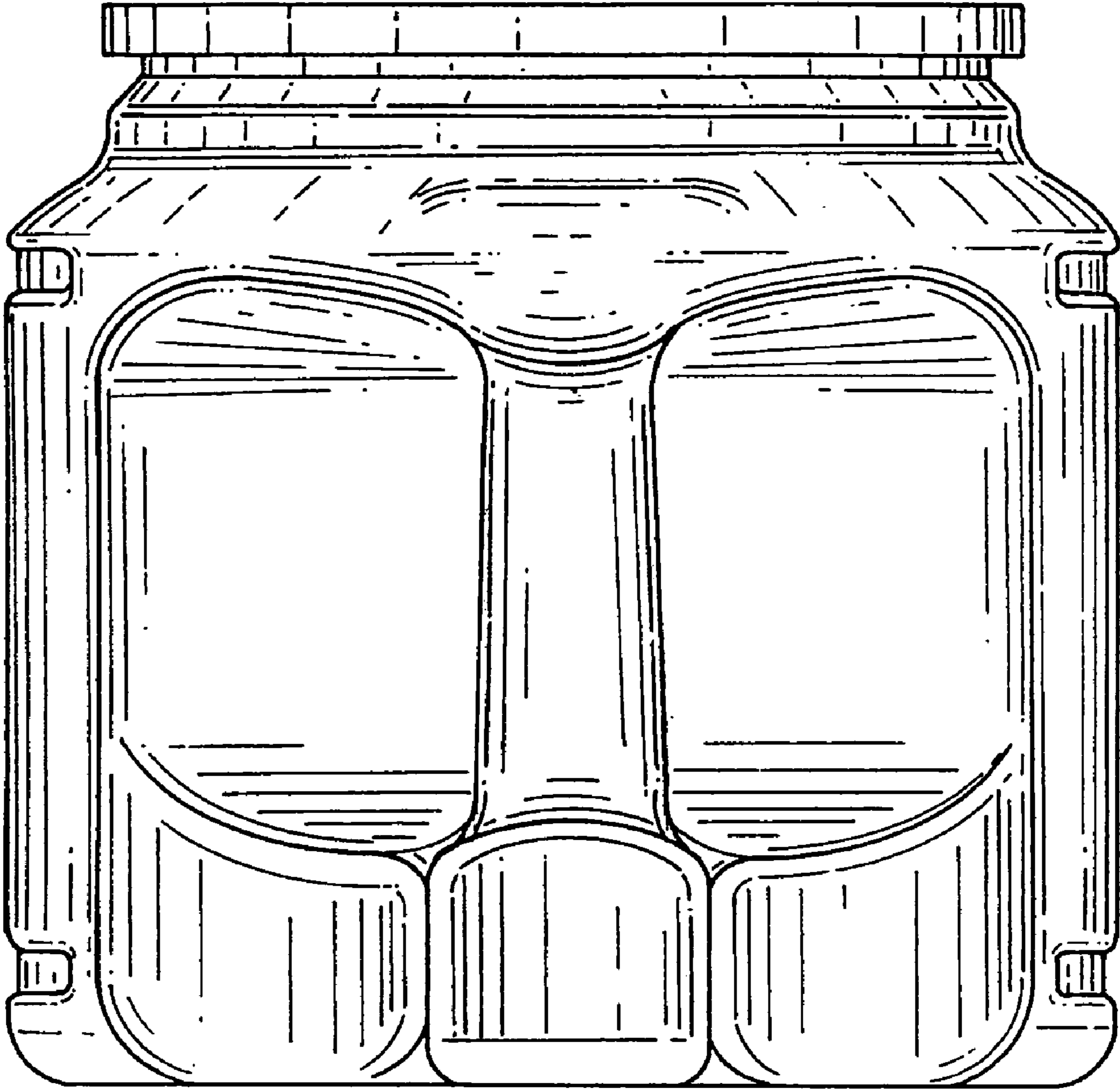
