FIG. 1 is a top, front perspective view of a the bottle of my present invention;

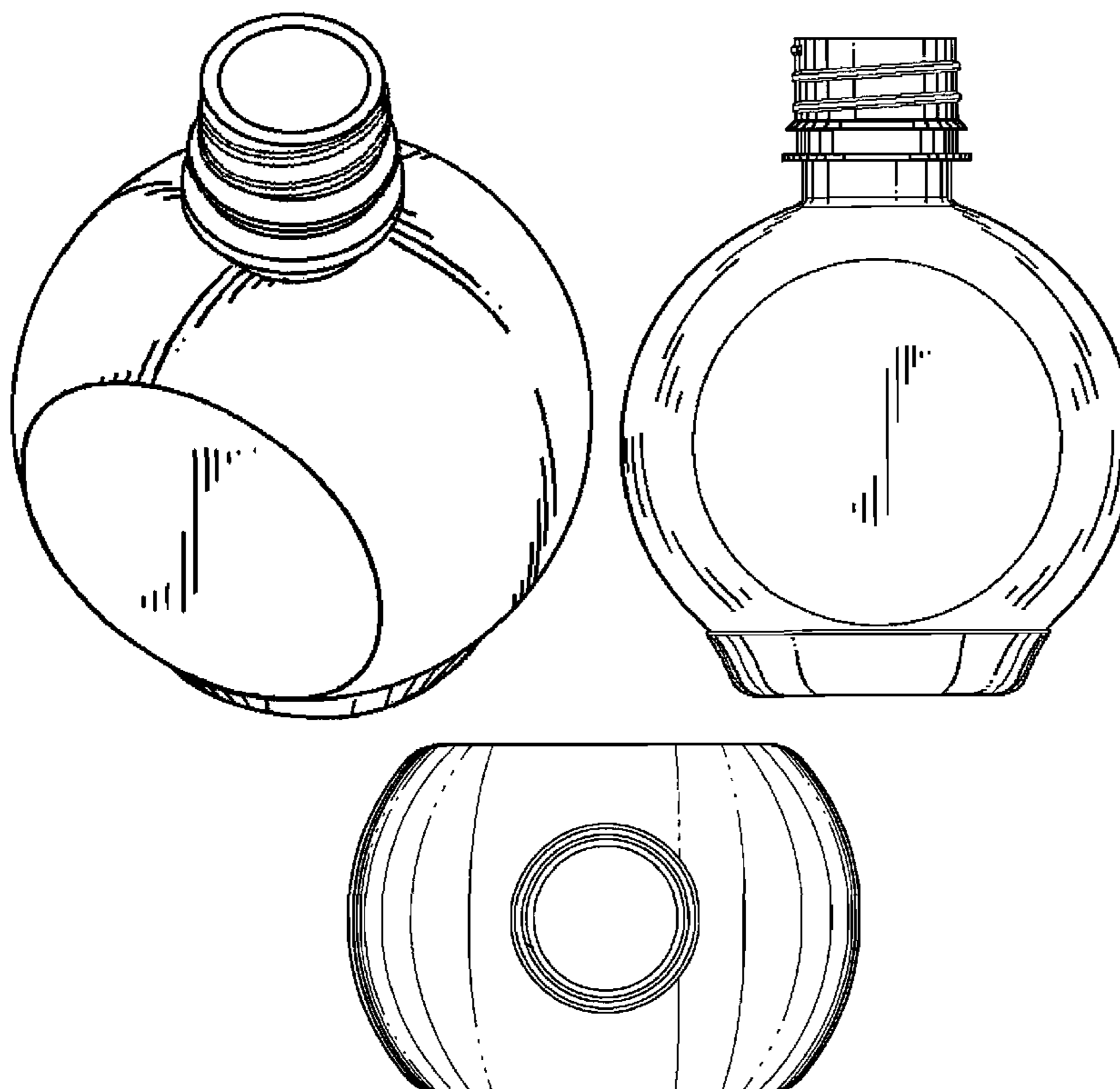
FIG. 2 is a front elevational view thereof;

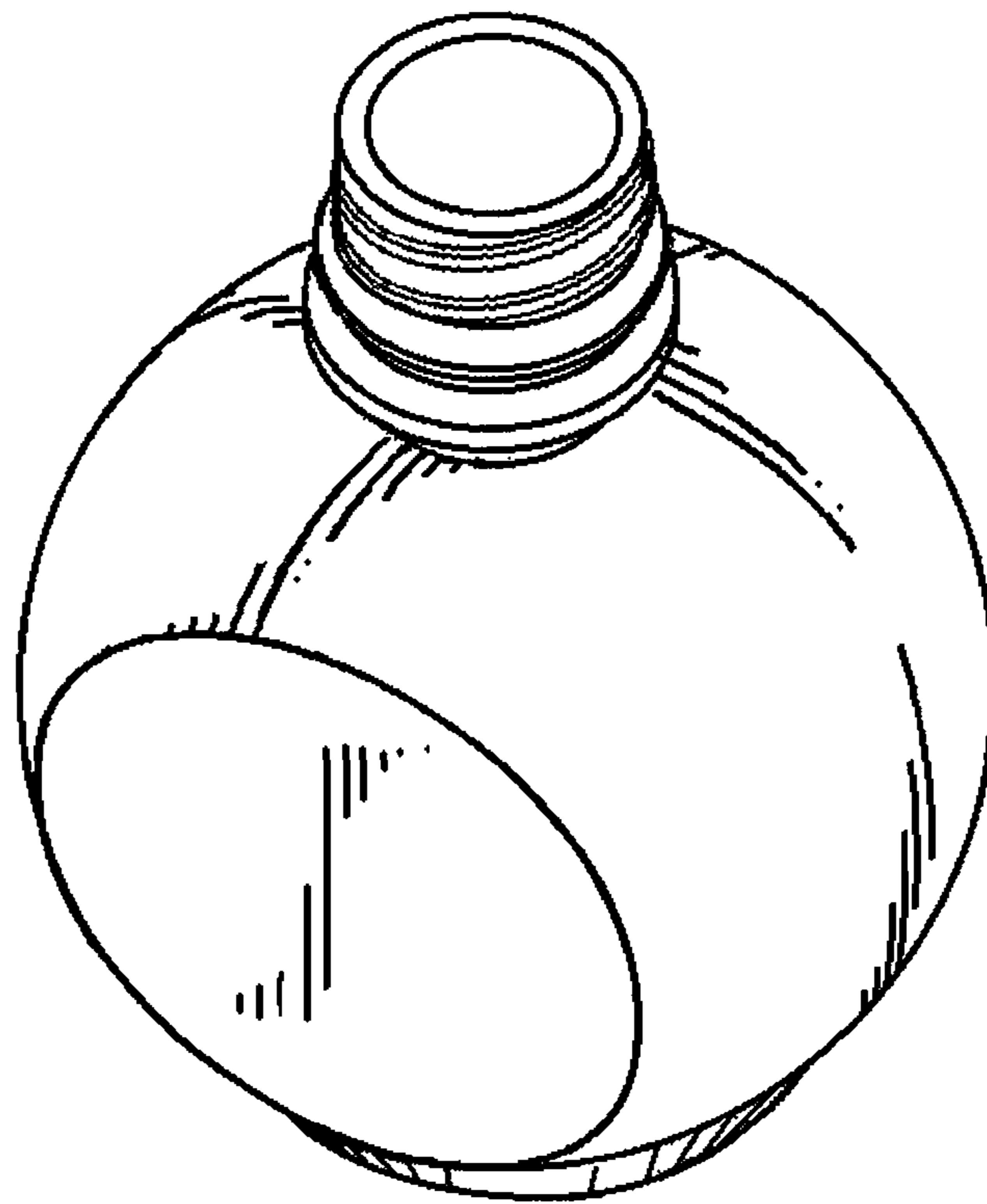

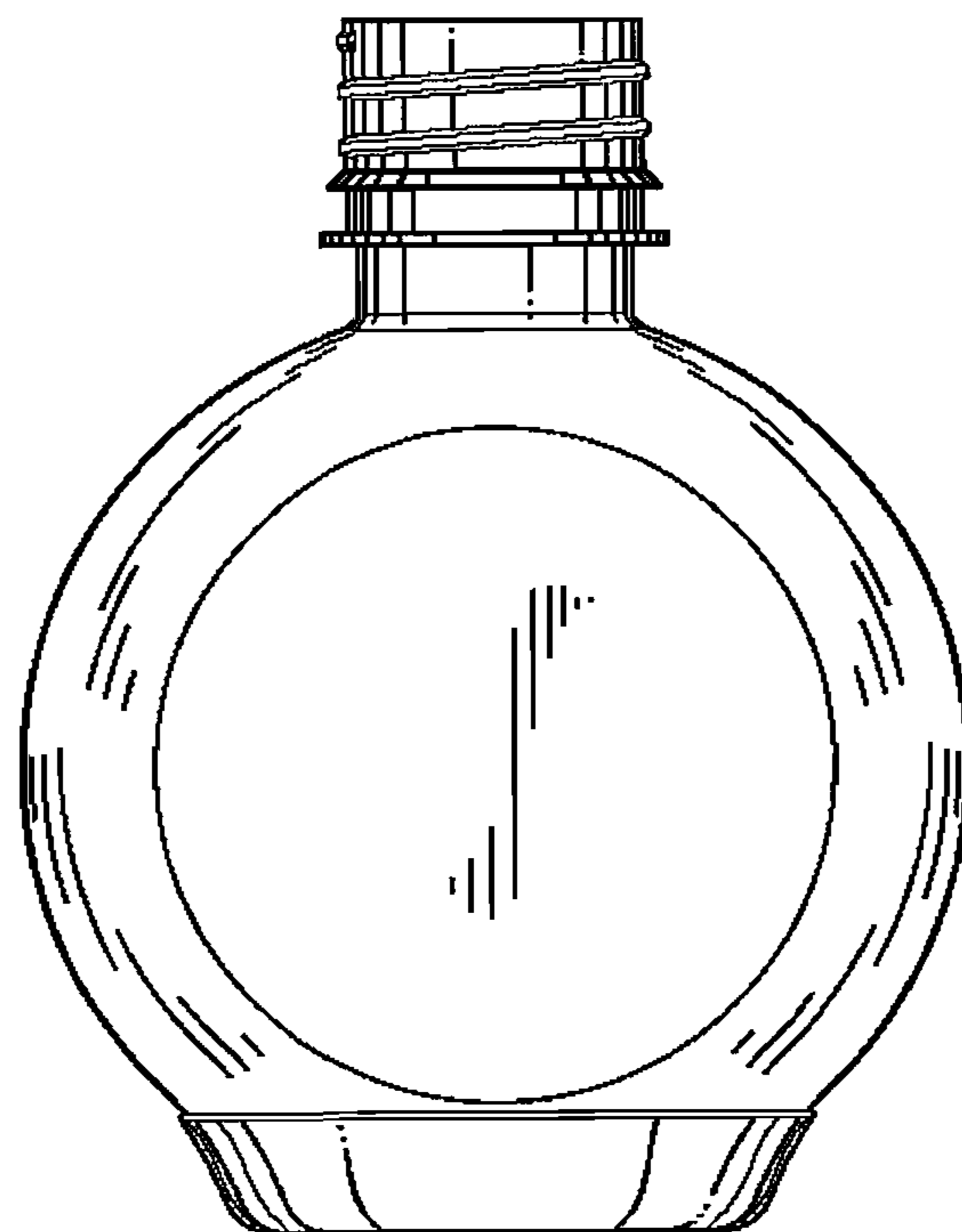

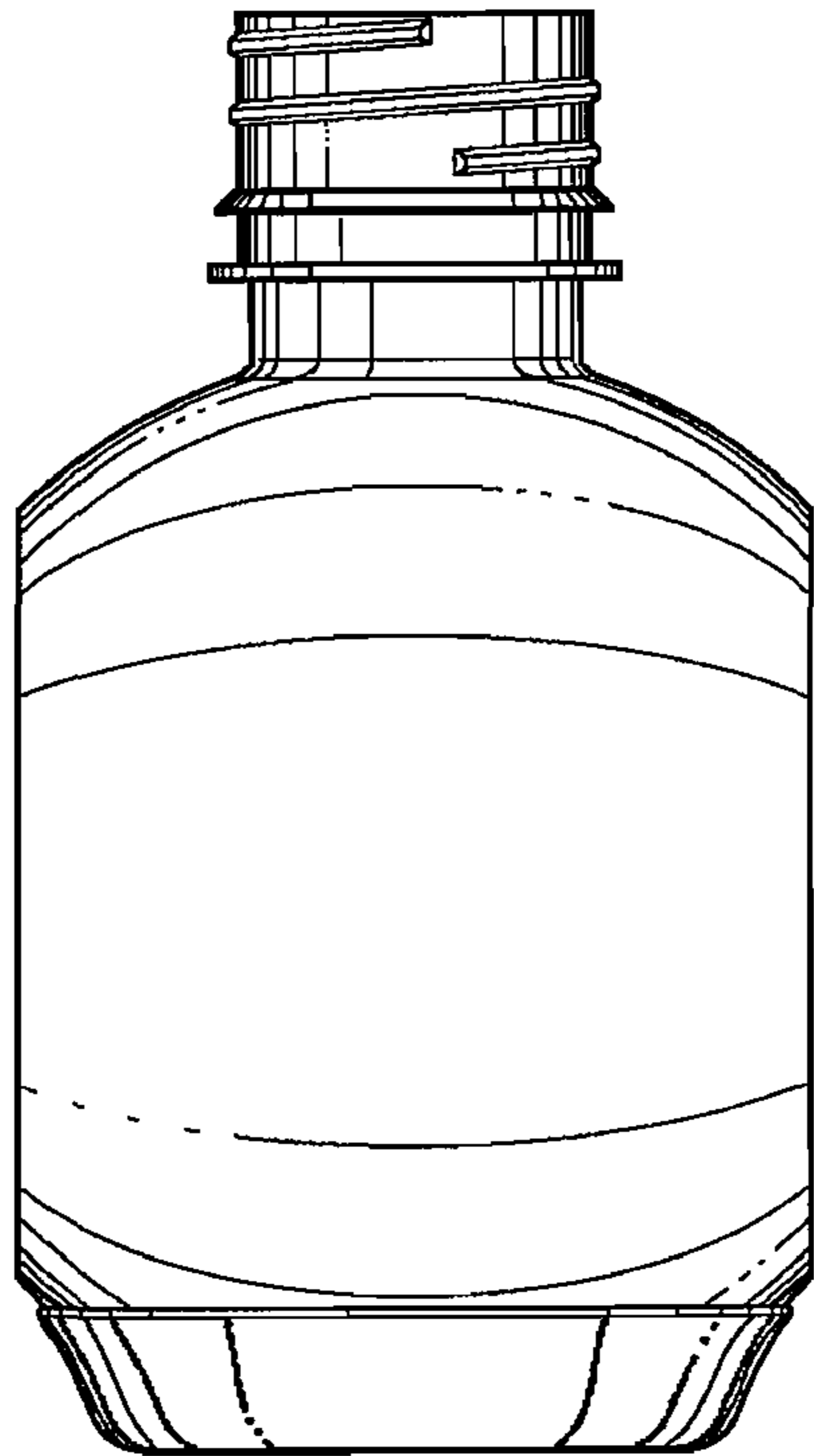

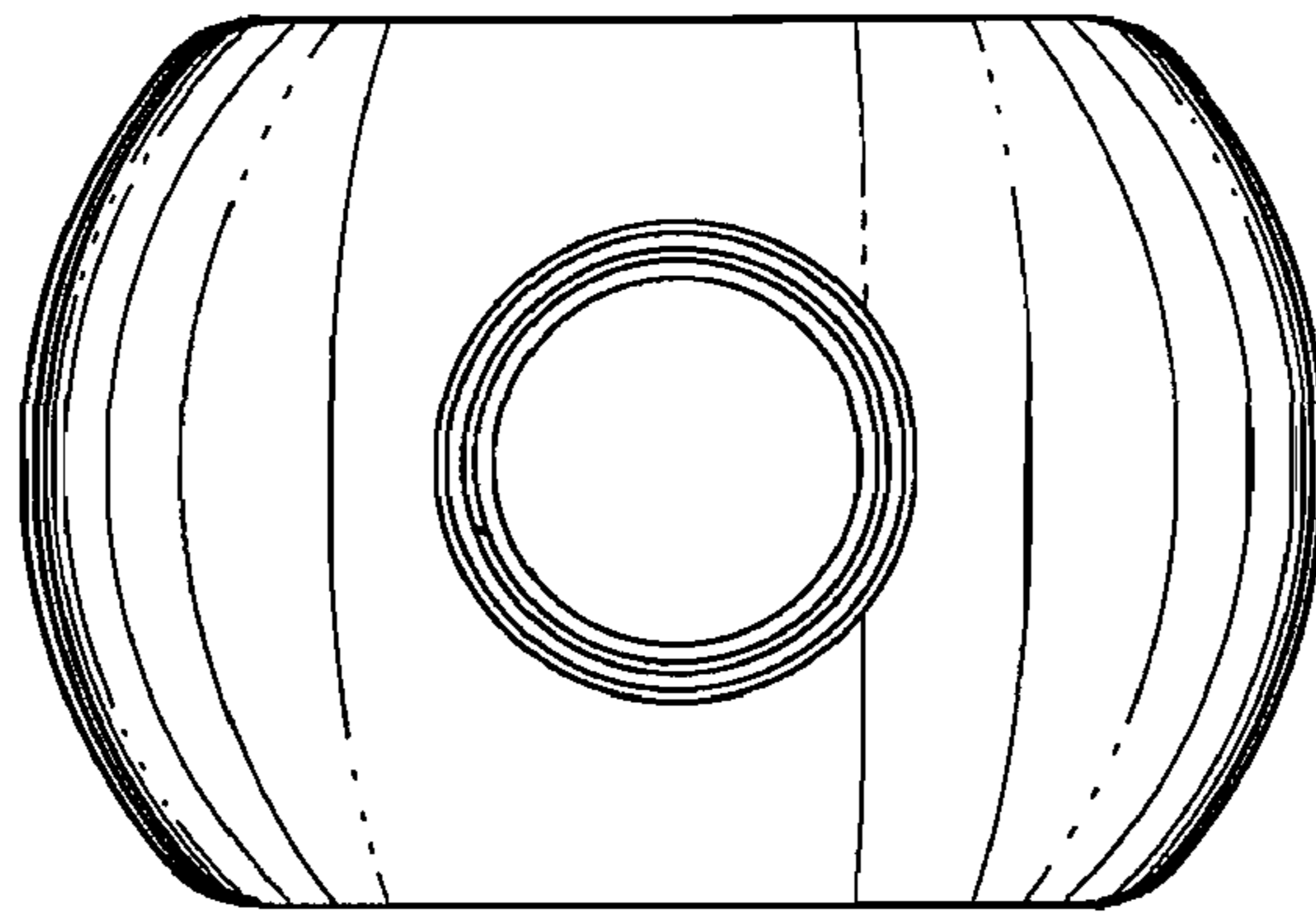

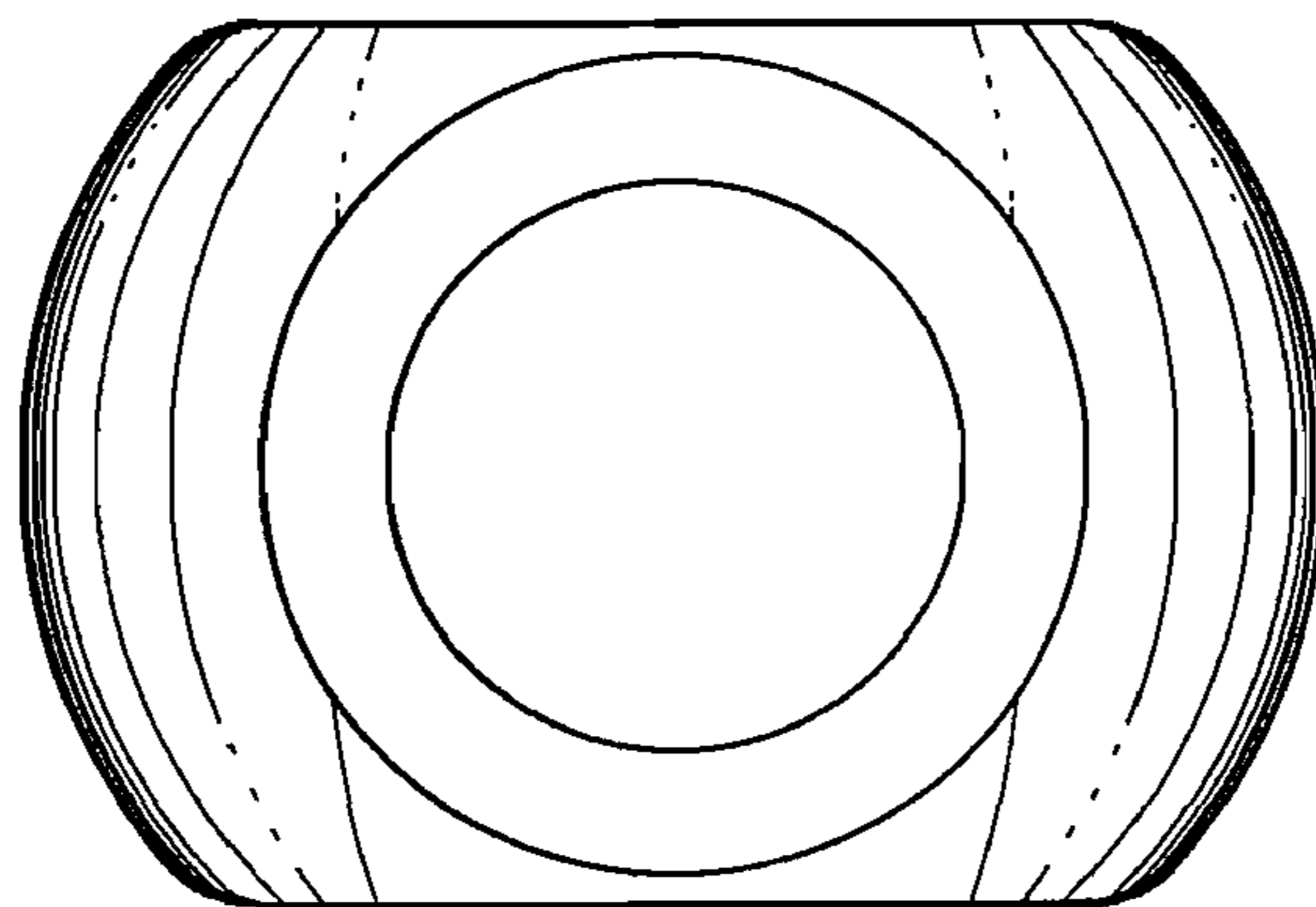
