FIG. 1 is a perspective view of the antenna housing showing the design;

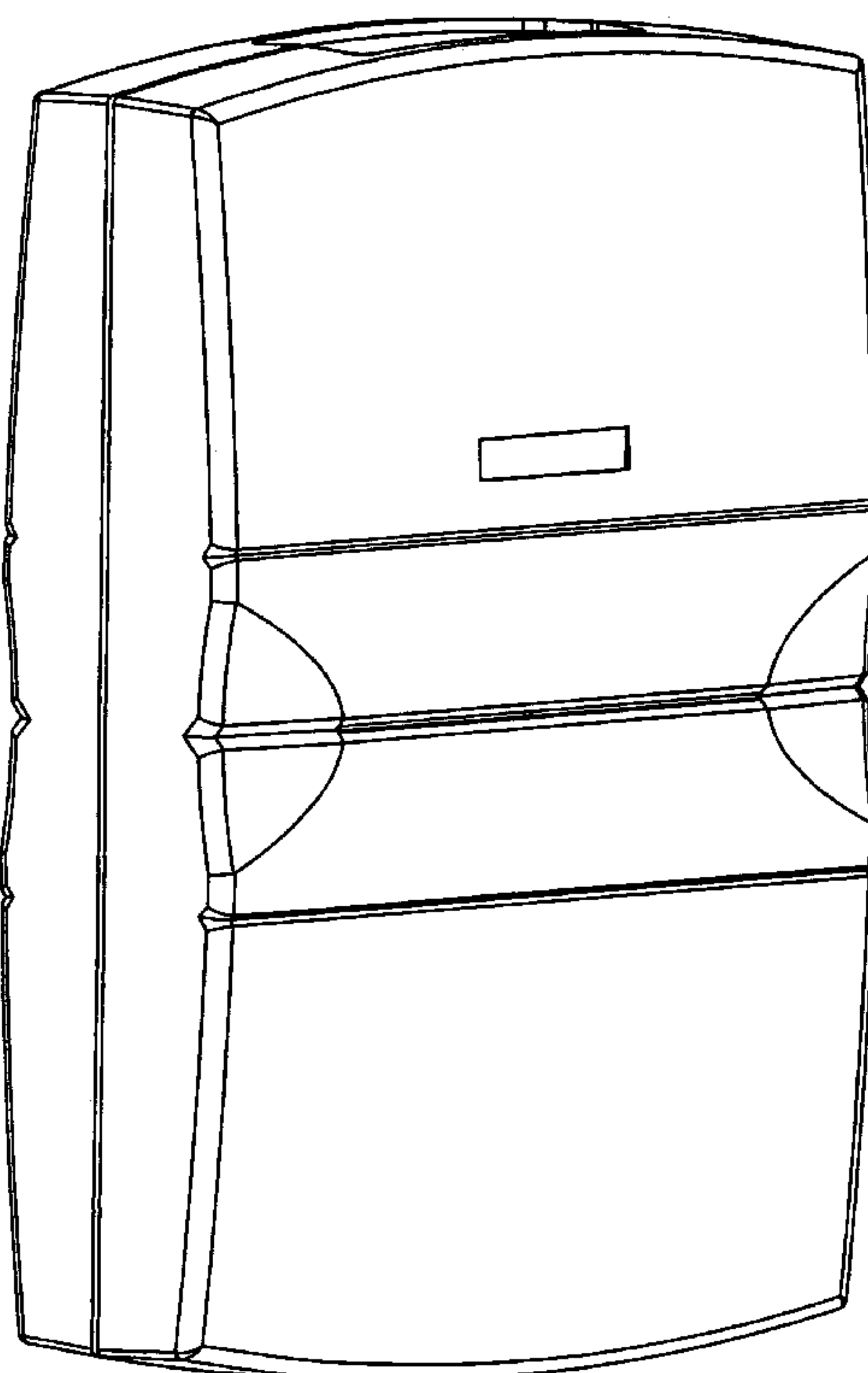
FIG. 2 is a side view thereof;

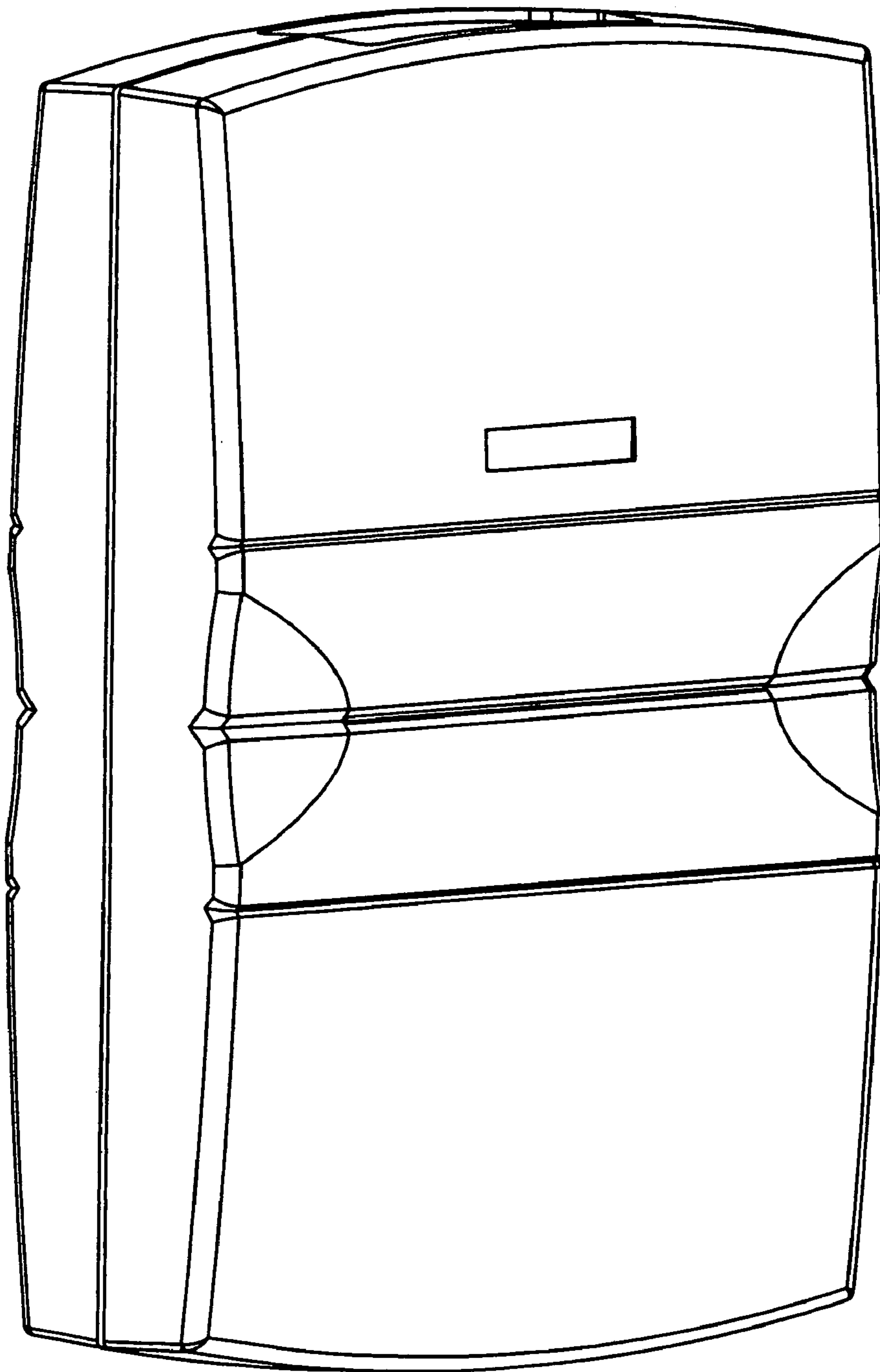

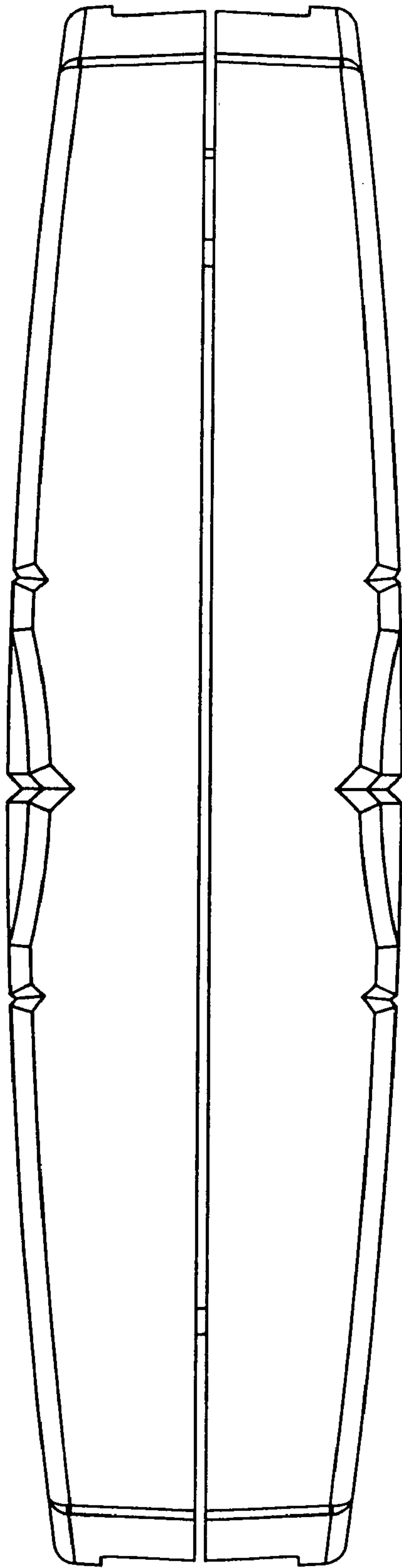

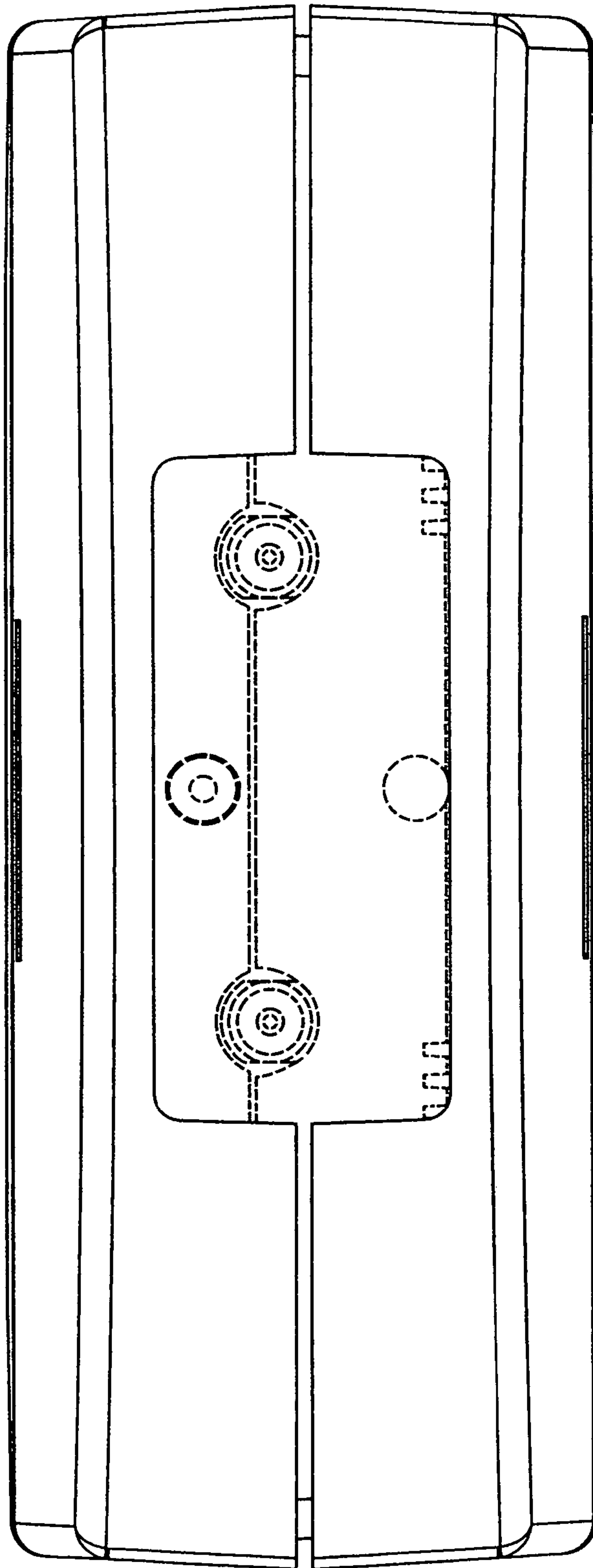

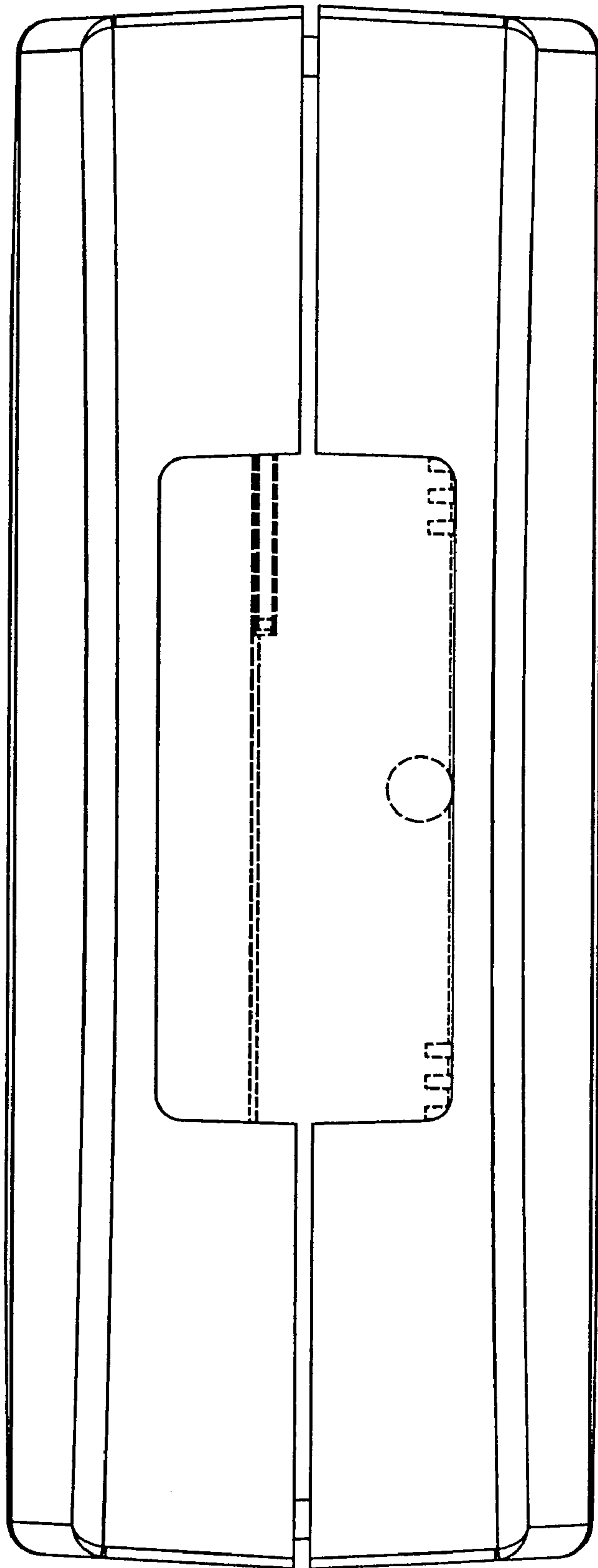
