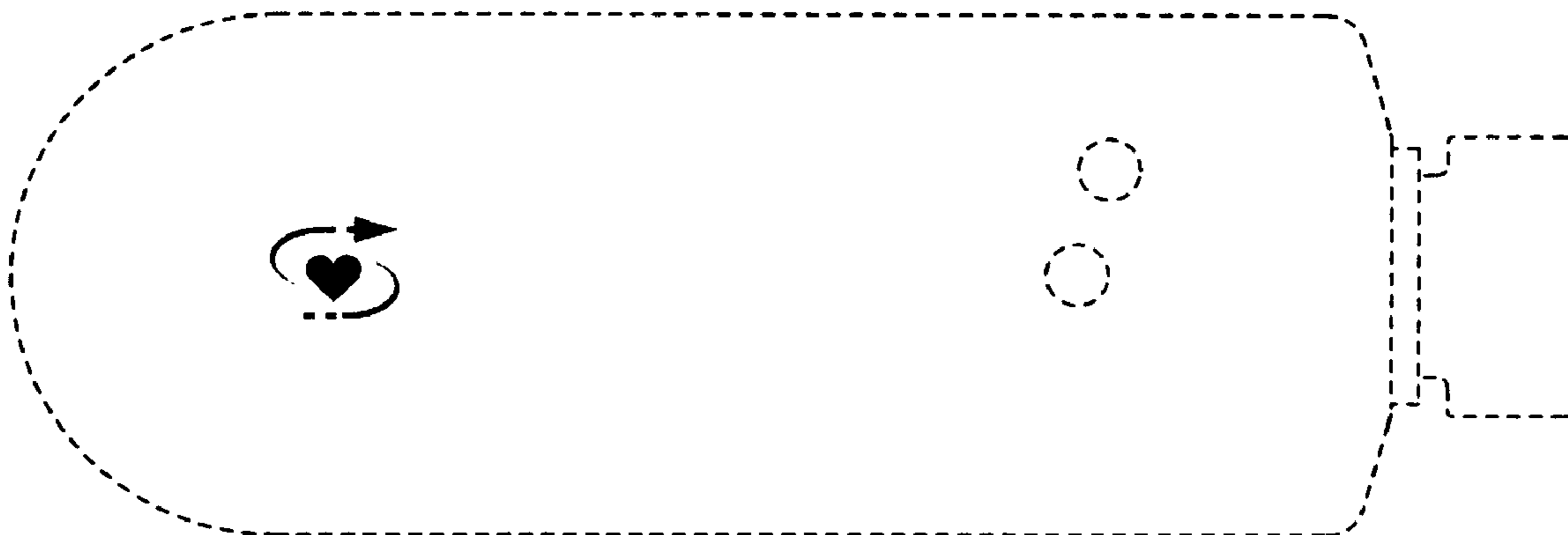

**DESCRIPTION**

FIG. 1 is a front elevational view of a computer generated image for a display panel or screen showing my new design; FIG. 2 is a front elevational view of a second image thereof; FIG. 3 is a front elevational view of a third image thereof; and, FIG. 4 is a front elevational view of a fourth image thereof. The broken line showing of a portion of a display panel or screen is for illustrating environmental structure and forms no part of the claimed design.

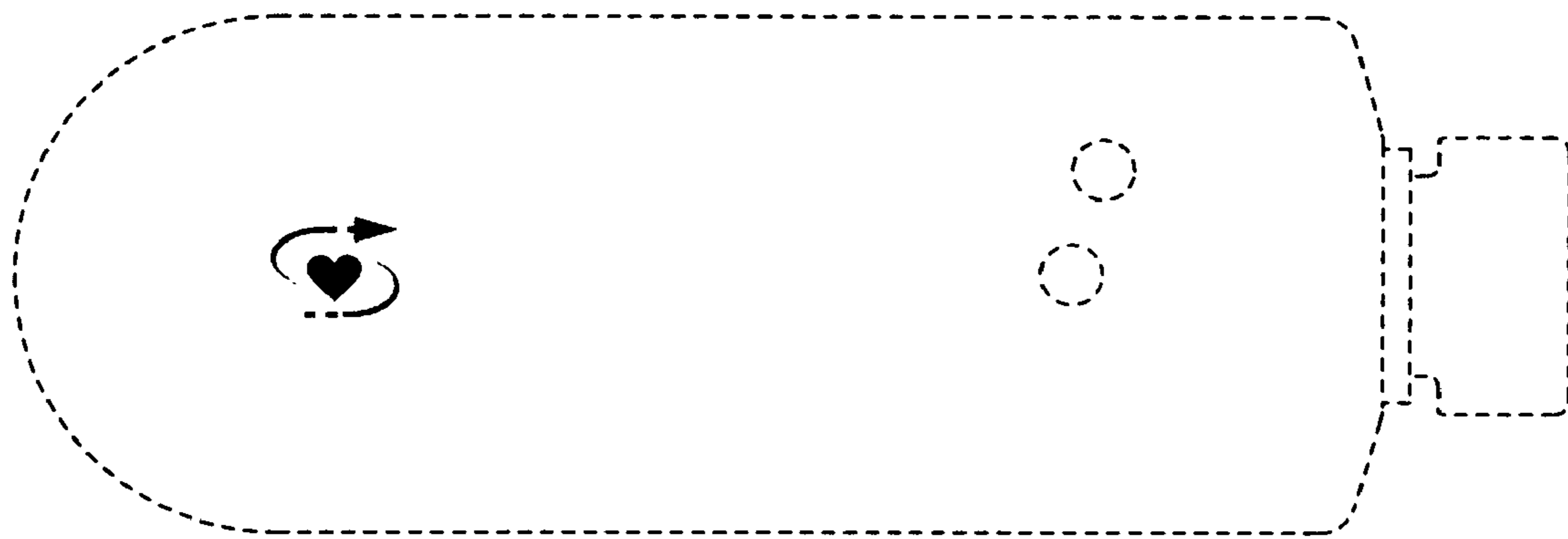

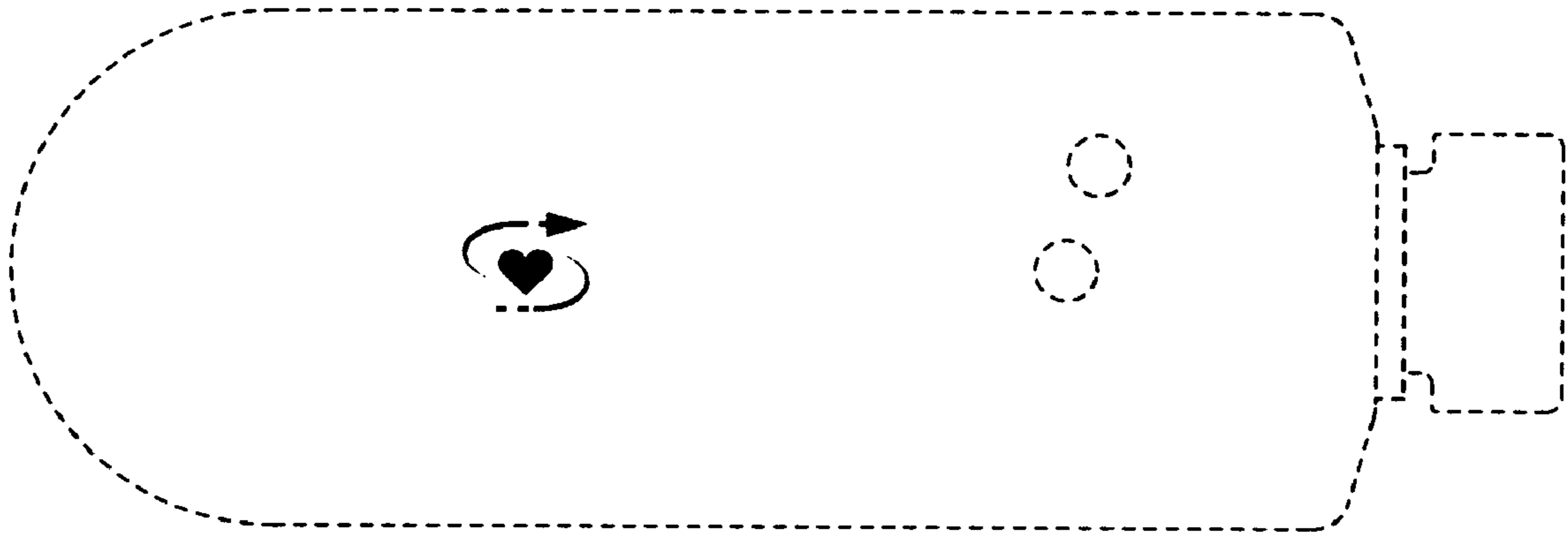

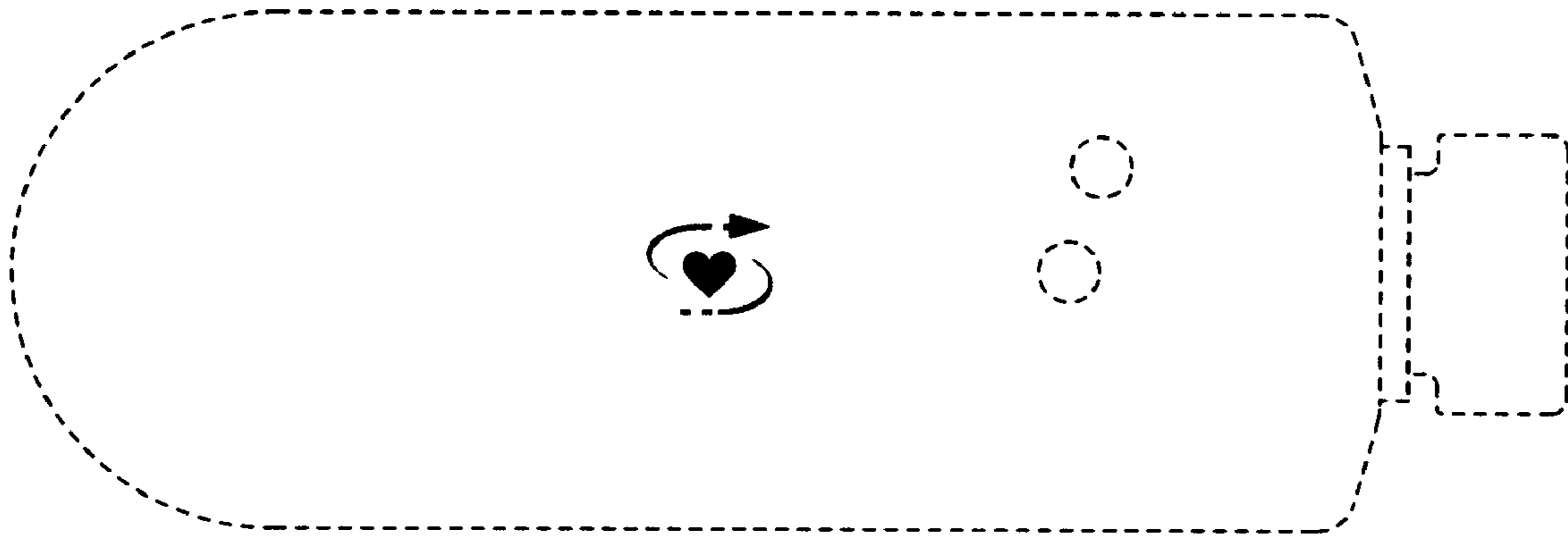

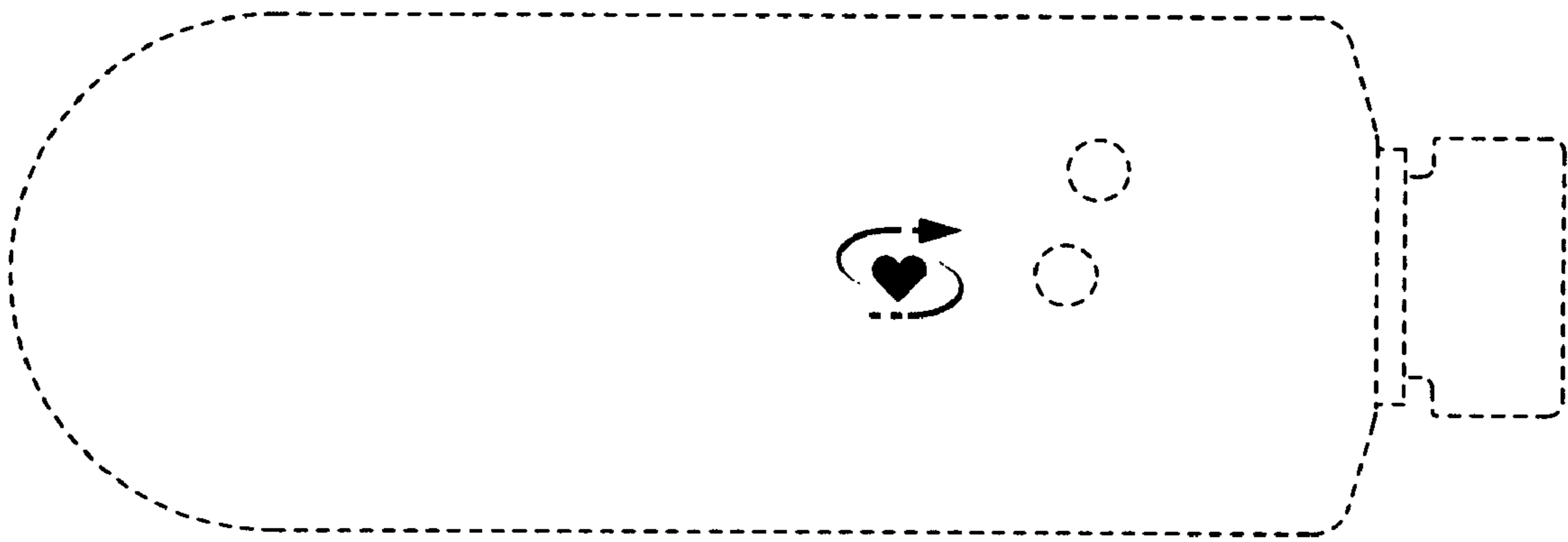
