FIG. 9 is a top view of my new and novel design with the handle folded

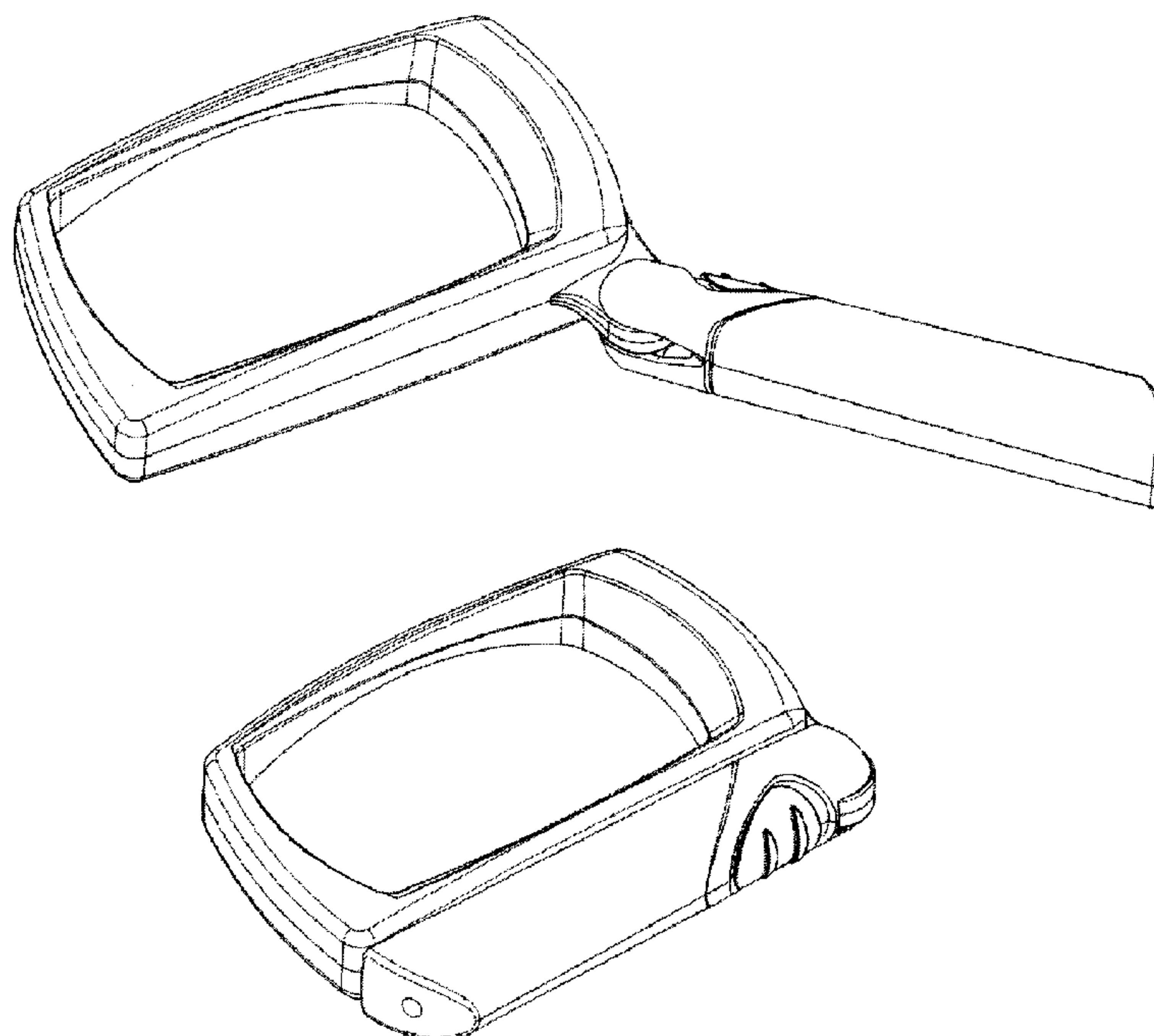
FIG. 10 is a Bottom view of my new and novel design with the handle folded

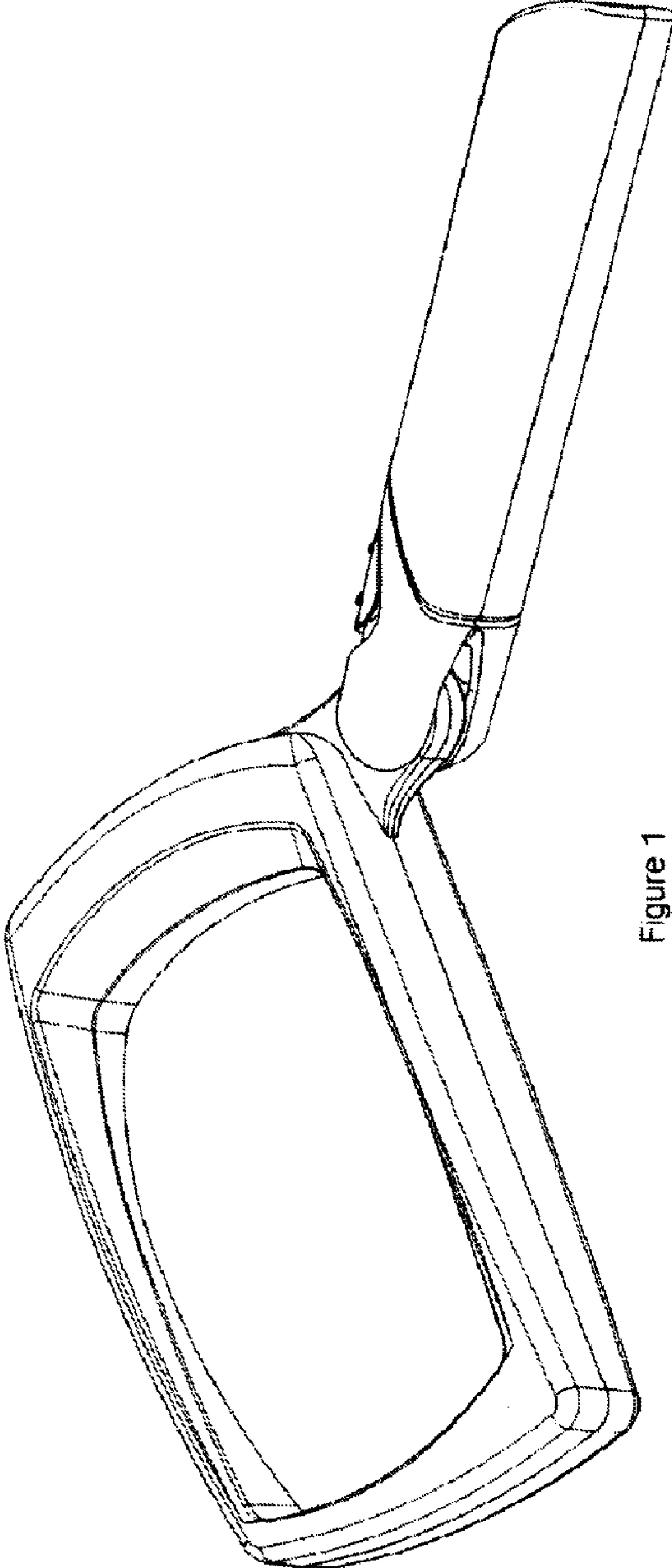

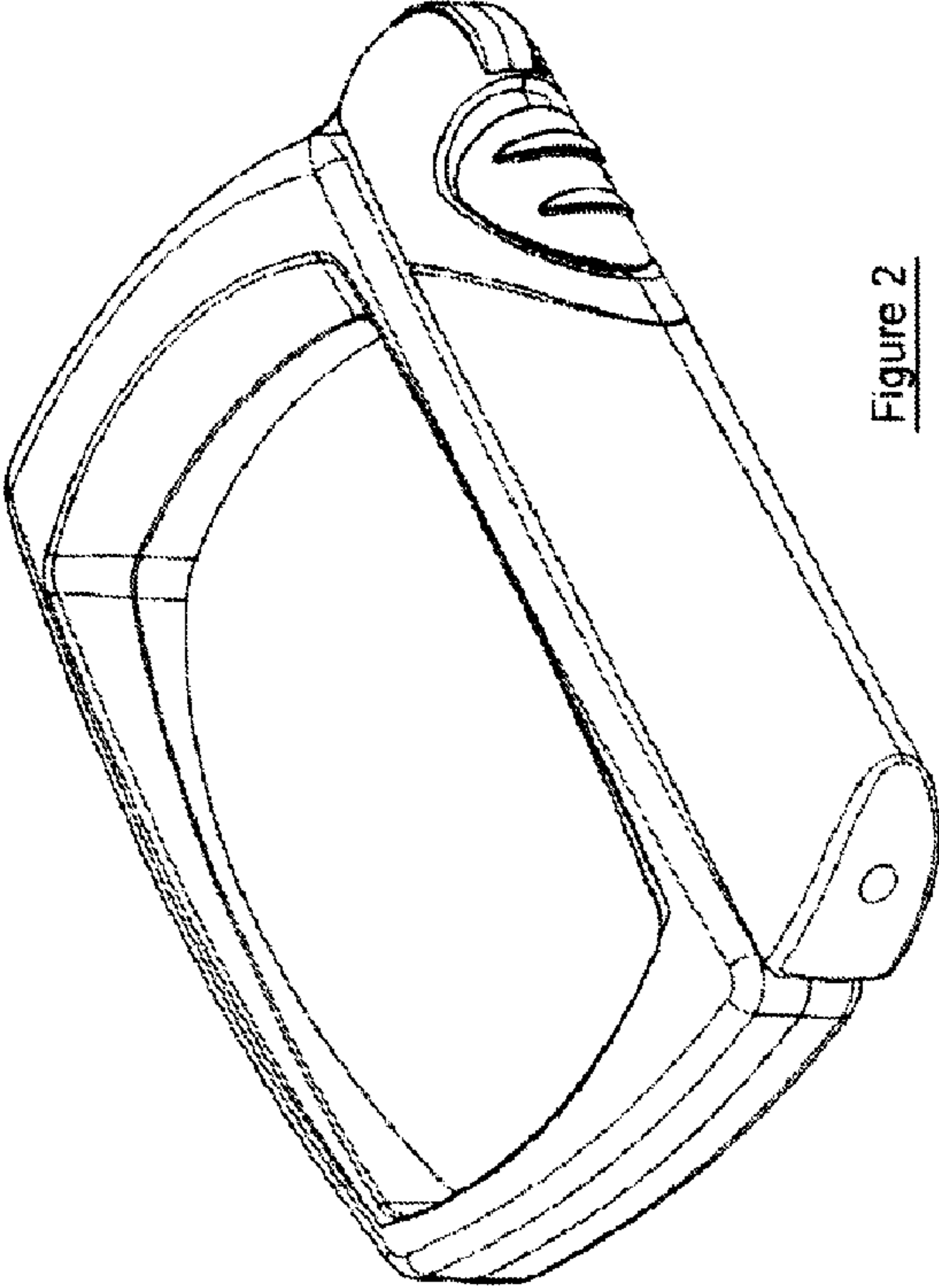

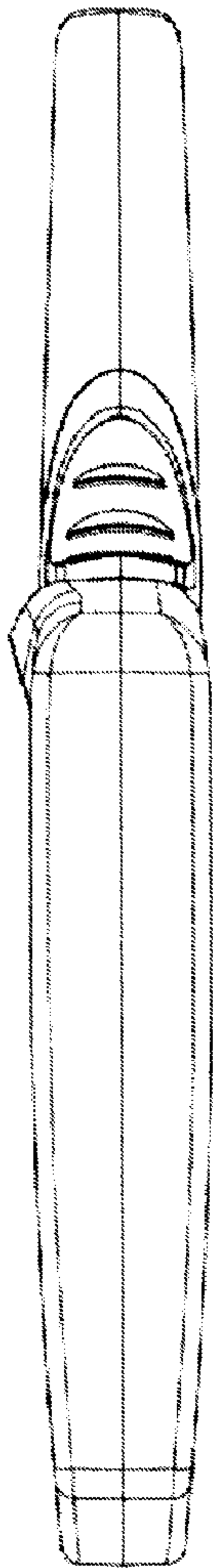

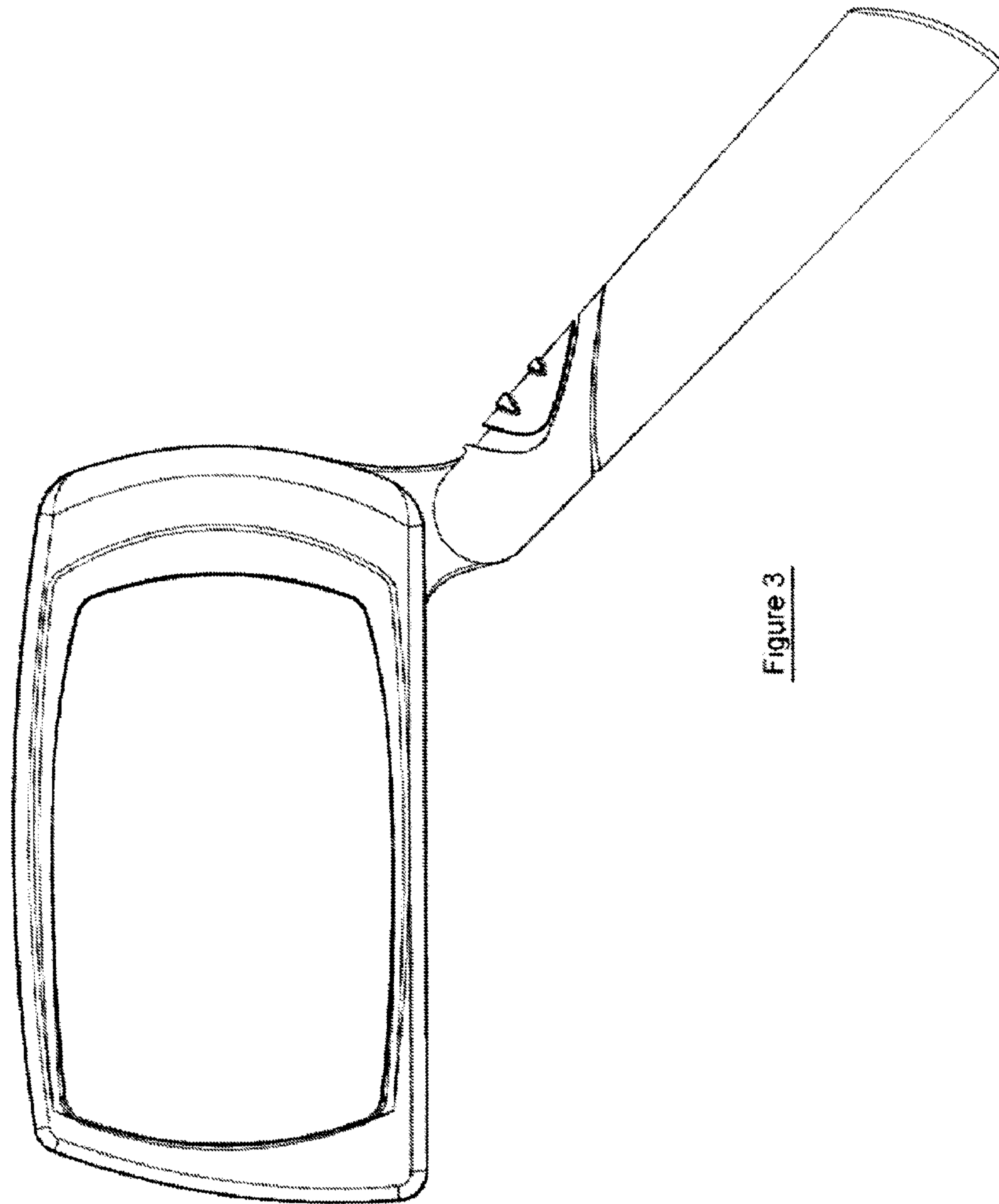

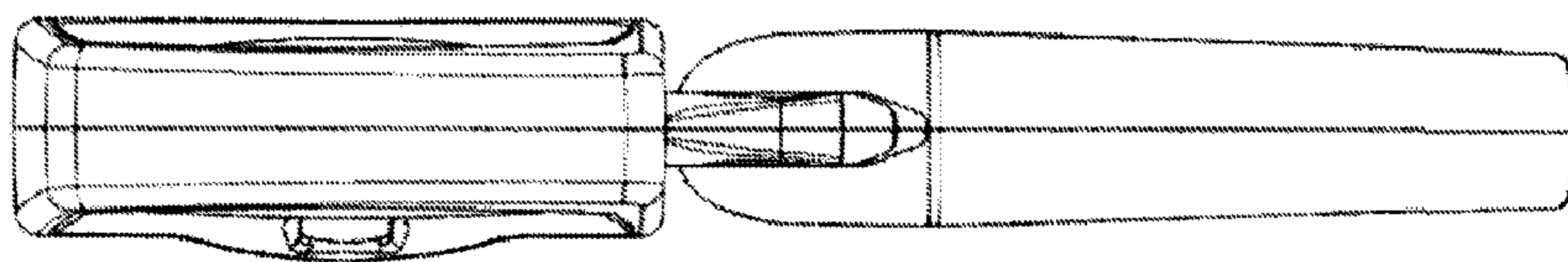

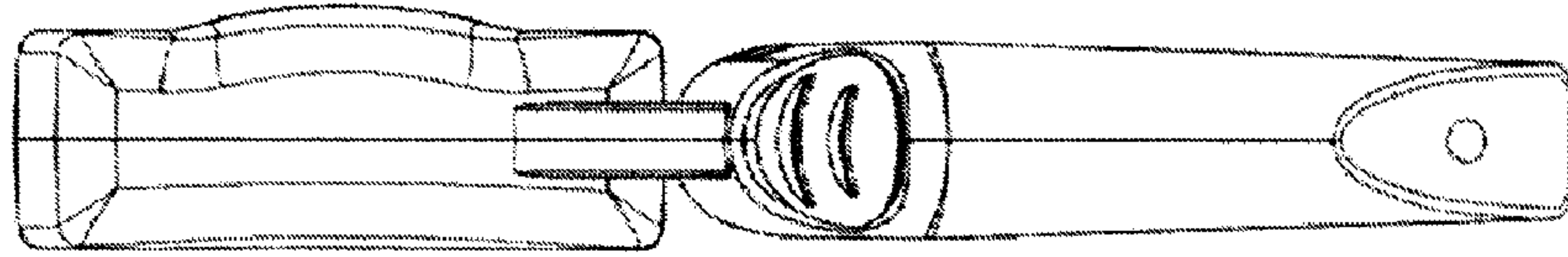

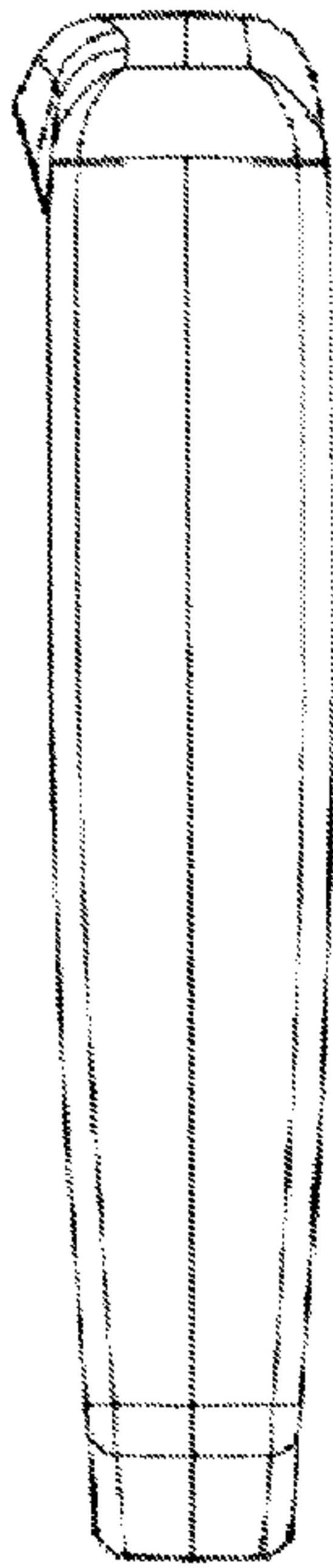

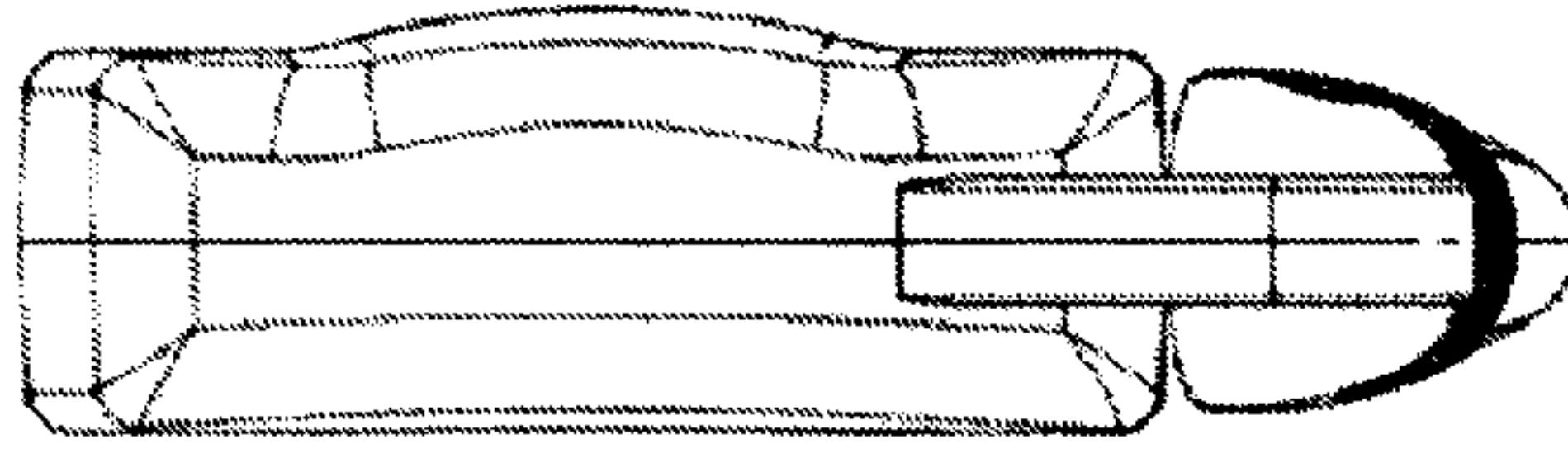

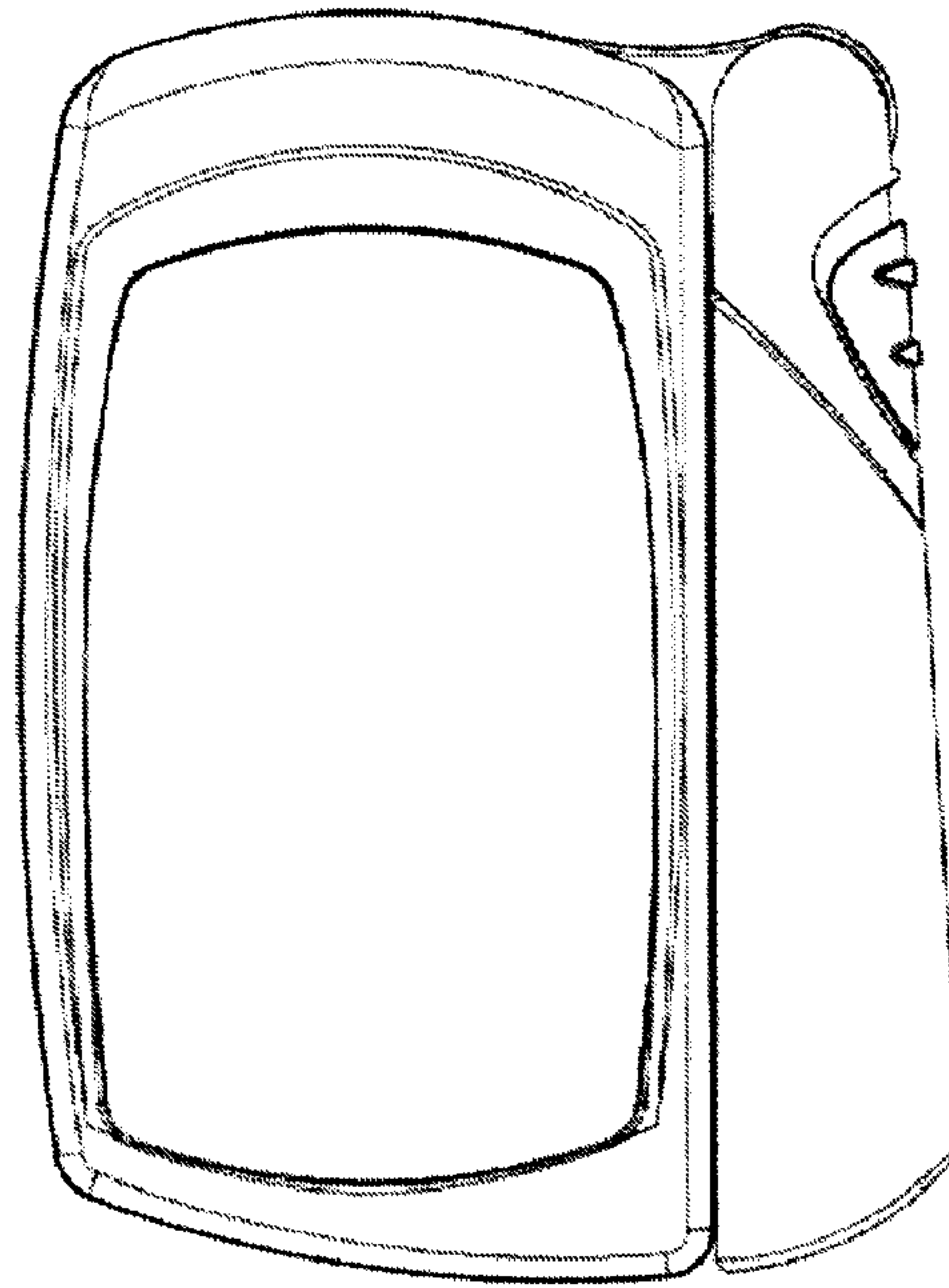

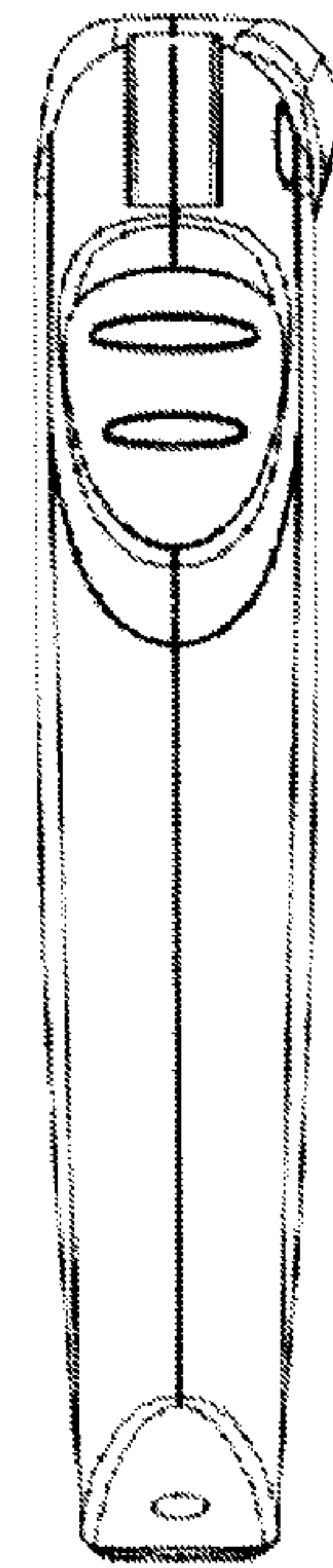

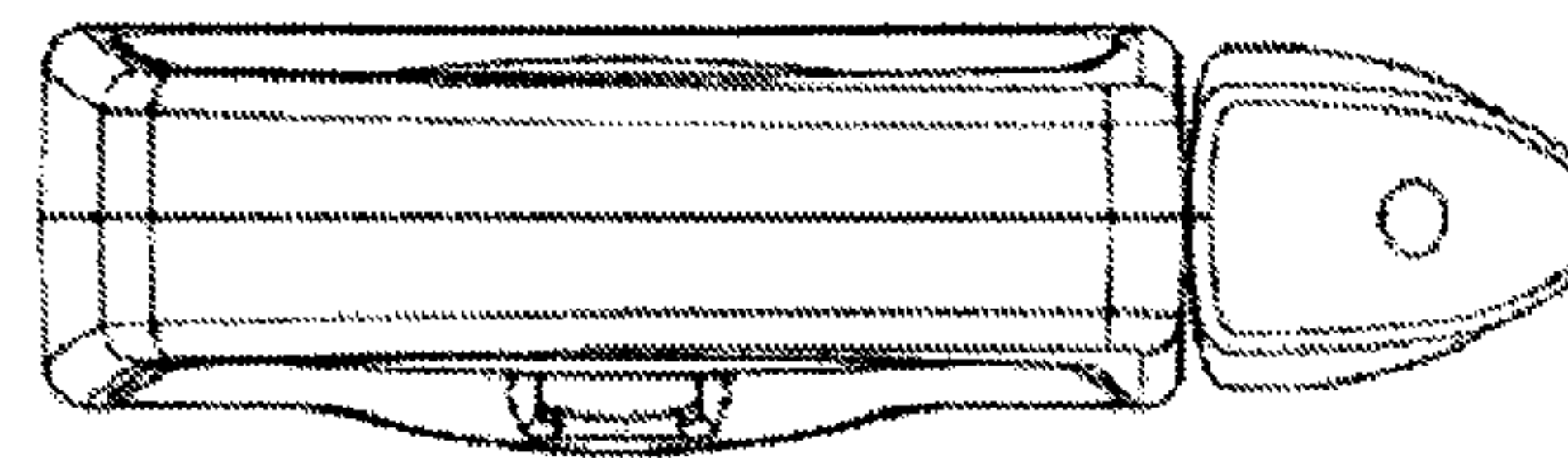

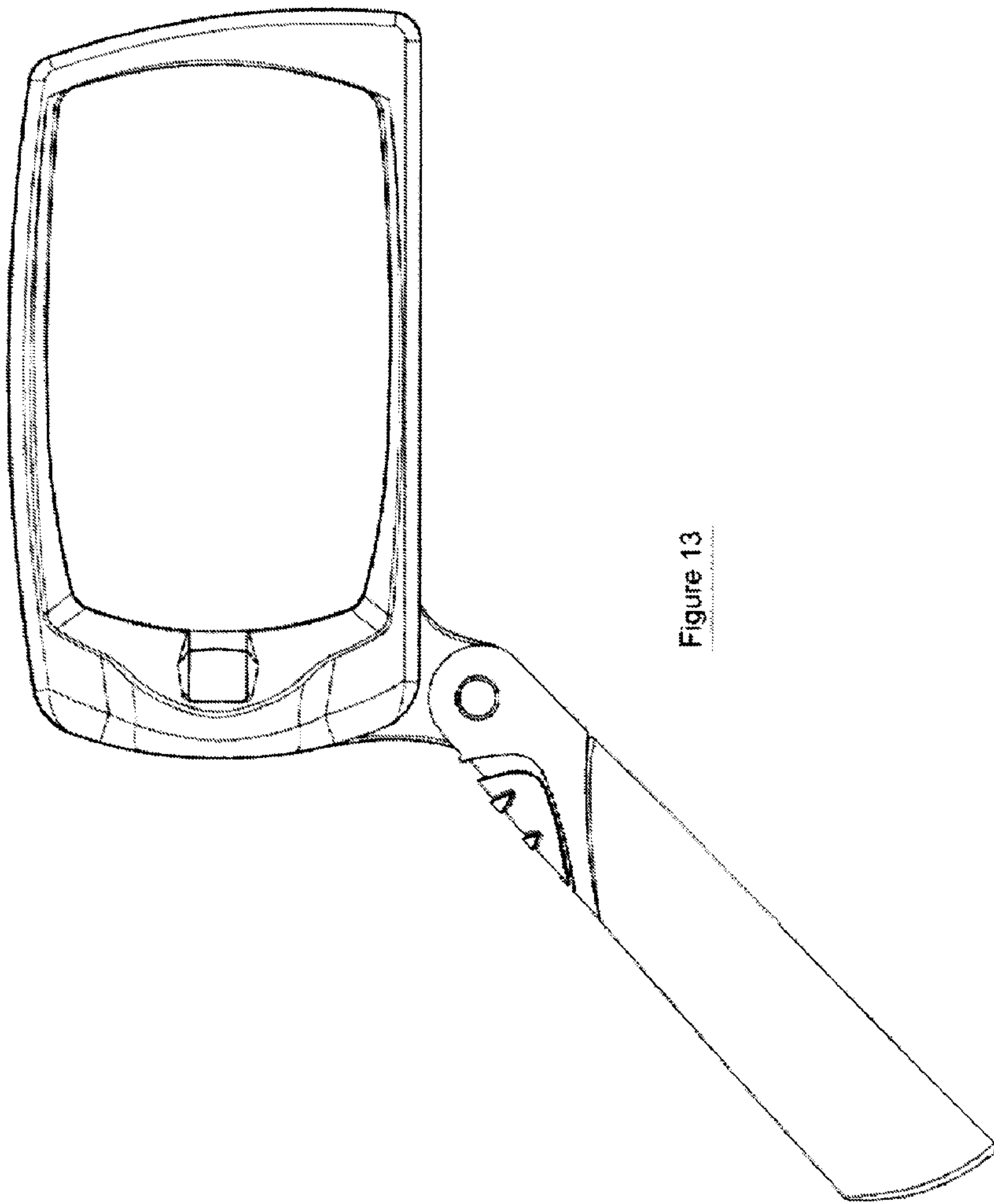

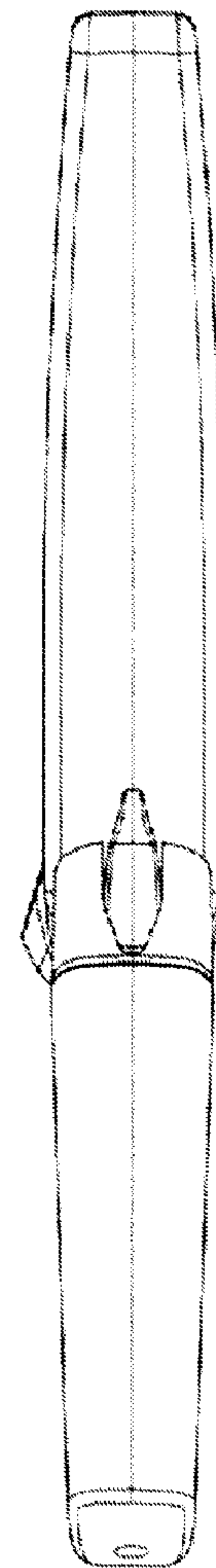
