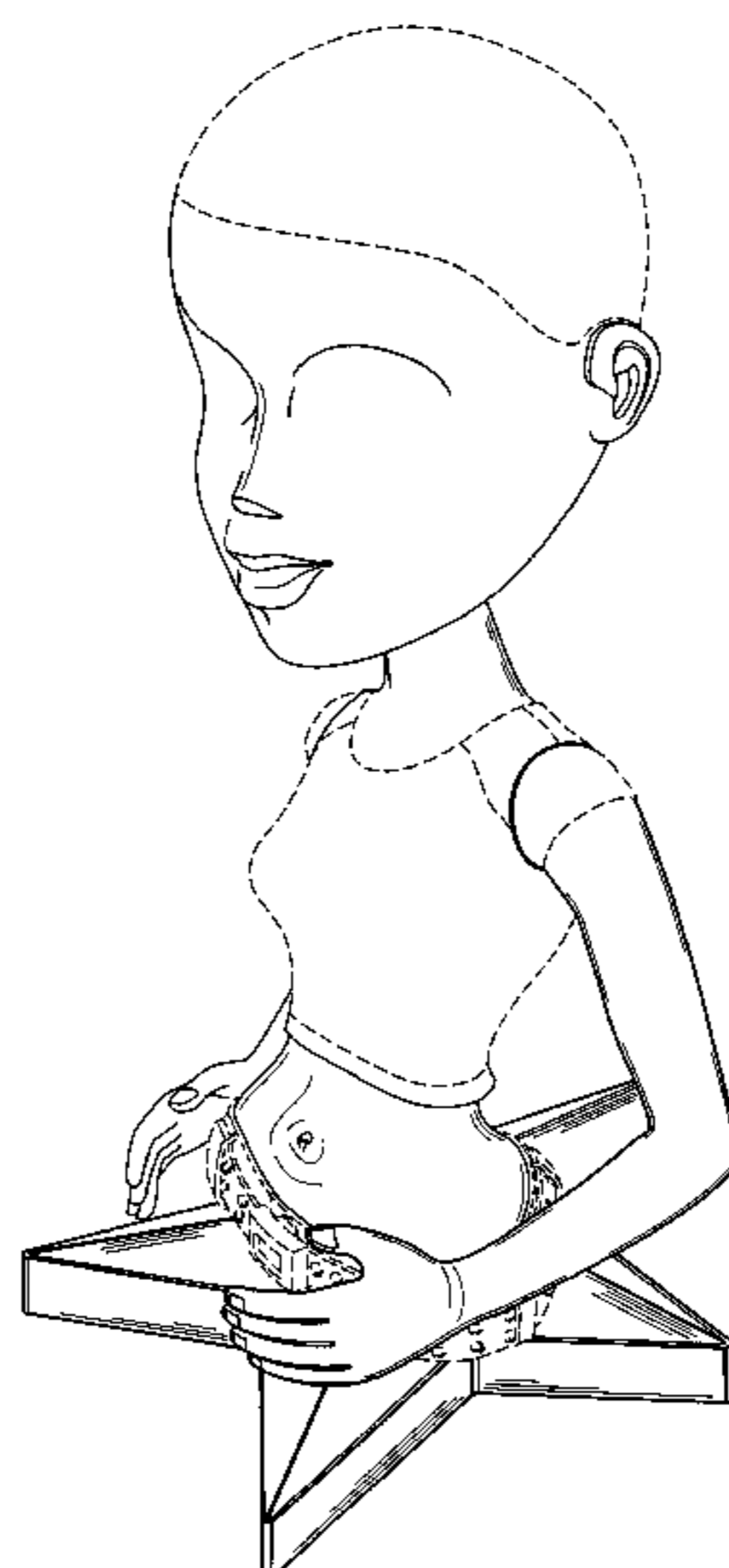
(57) **CLAIM**

We claim the ornamental design for a mannequin head and torso, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mannequin head and torso showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
In the drawings, the broken lines adjacent to portions of the figure shown in solid lines depict the boundaries of the claimed design and form no part of the claim; all other broken lines represent unclaimed environmental structure.

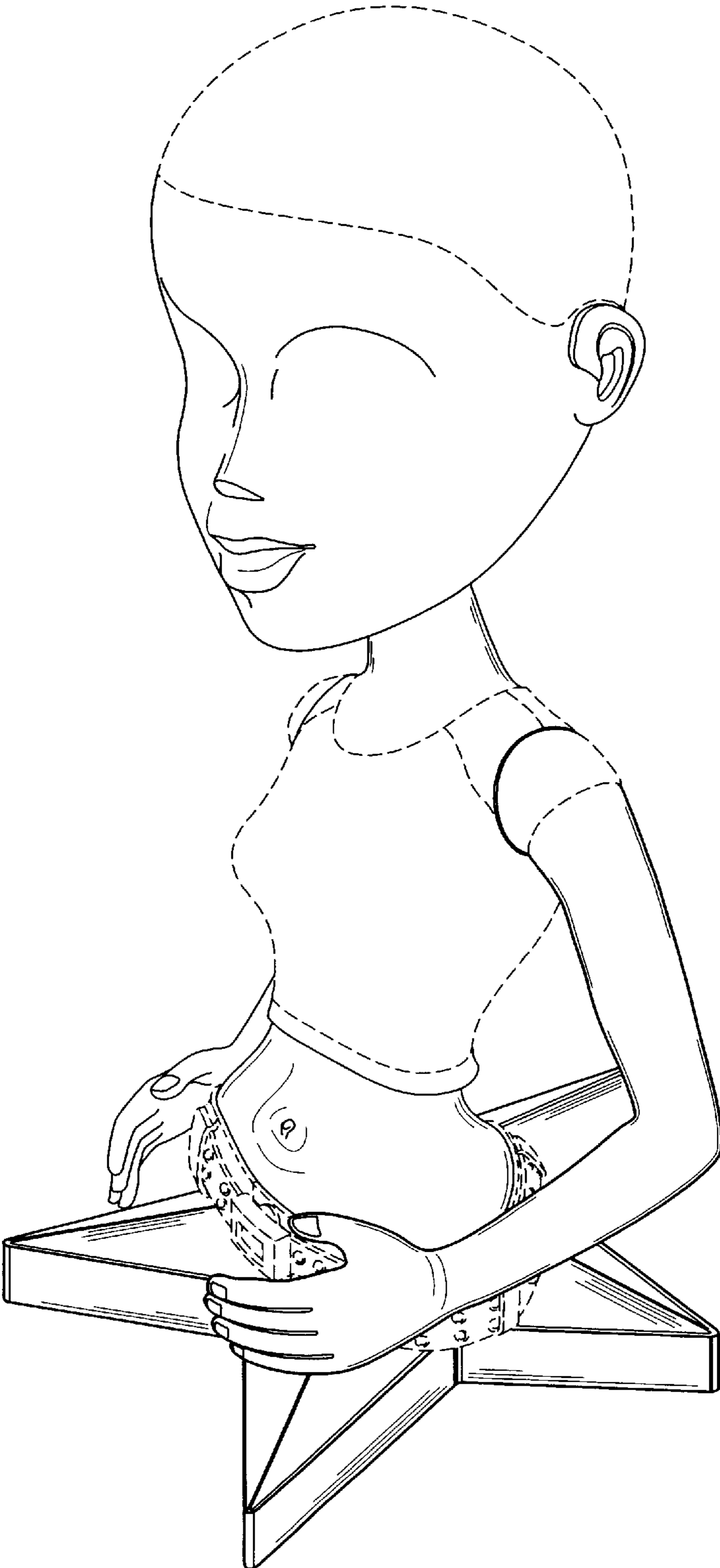

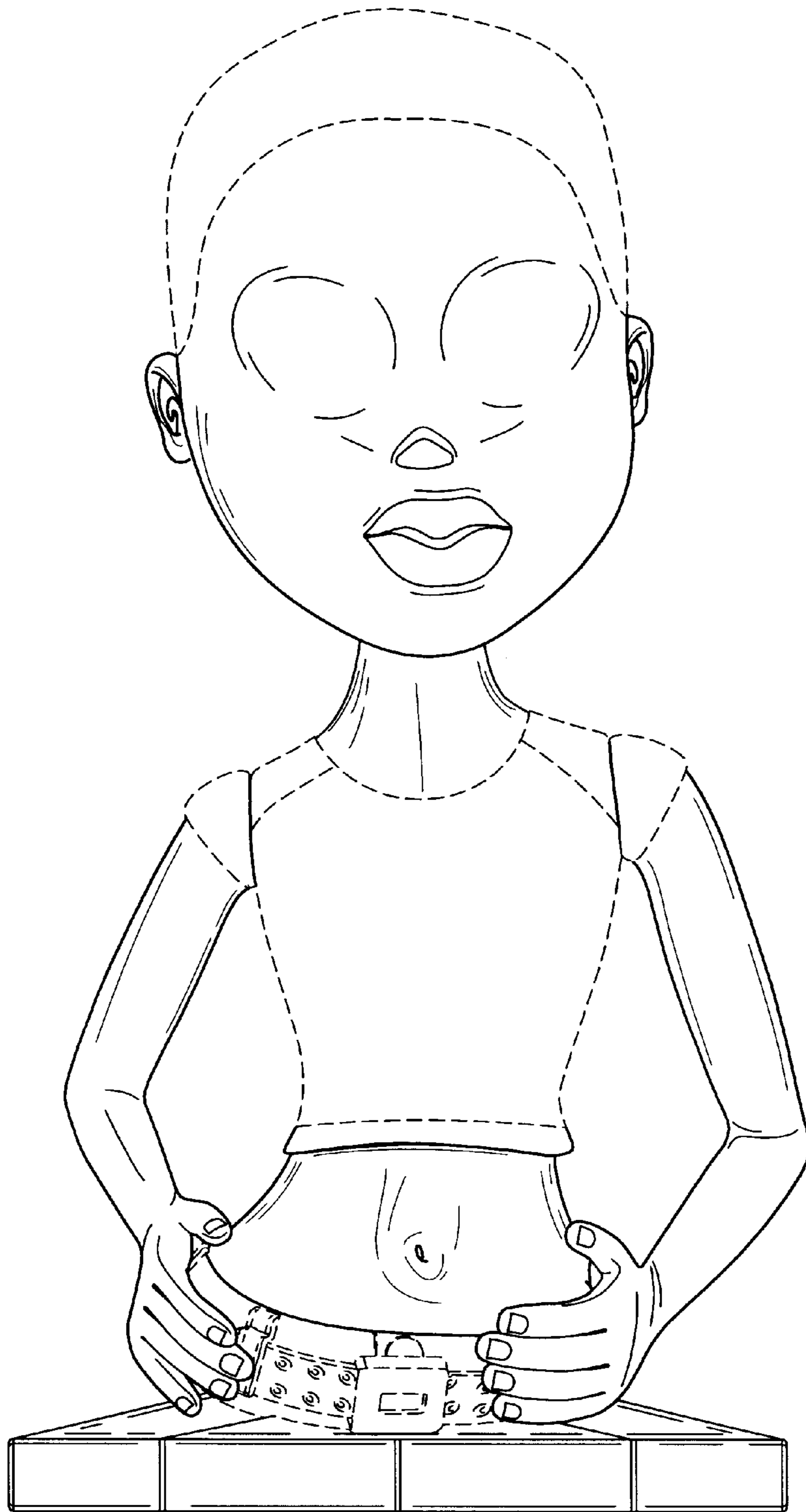

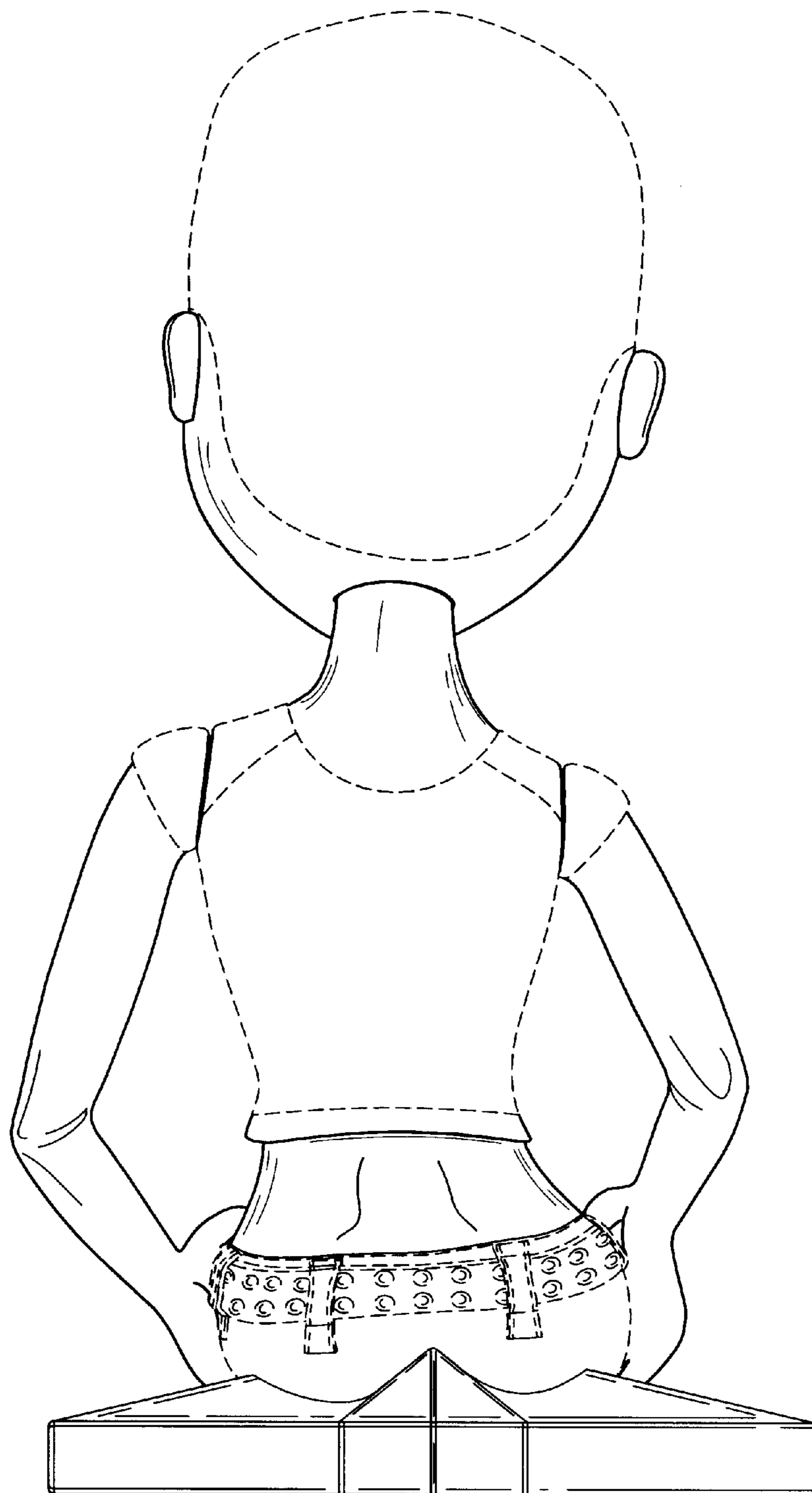

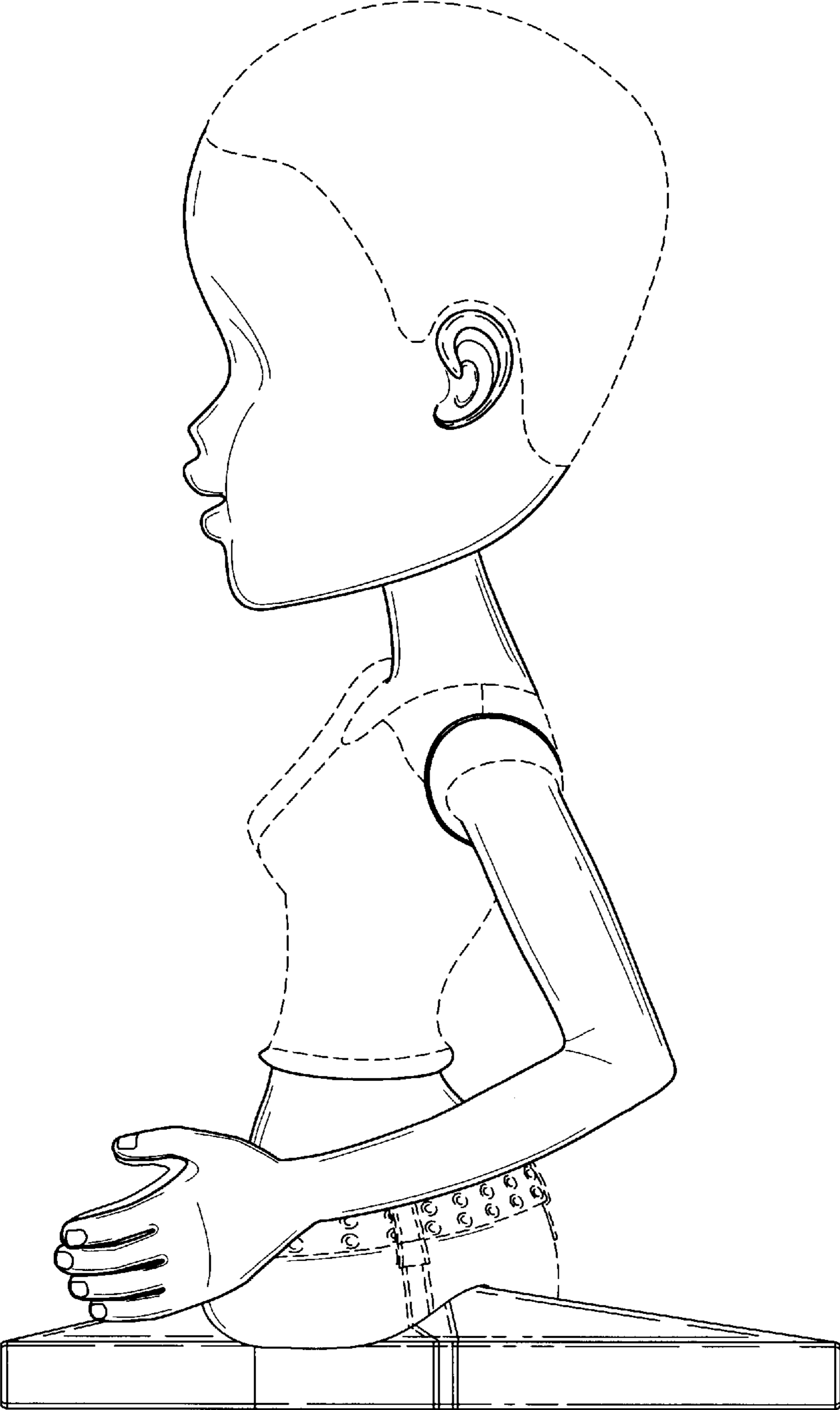

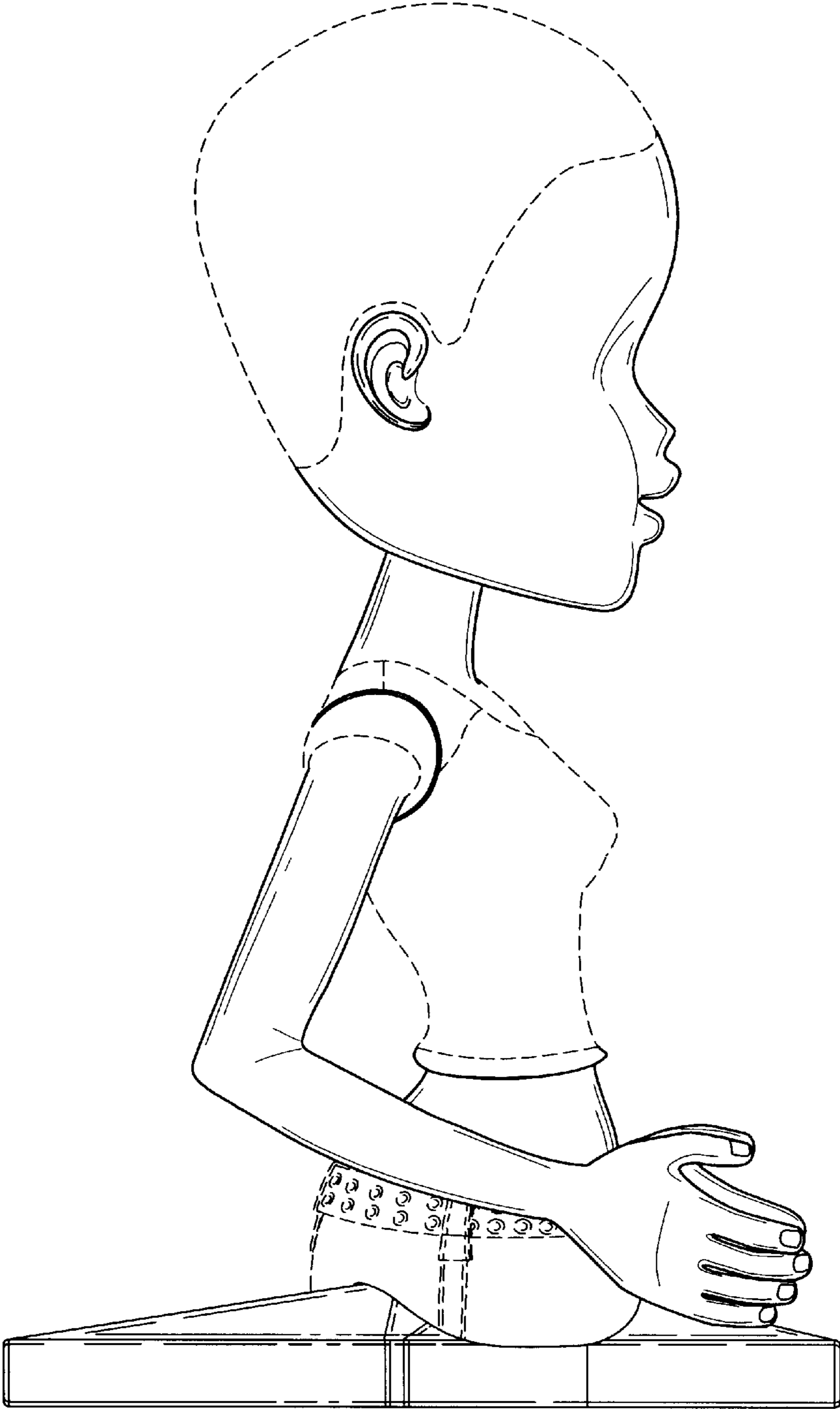

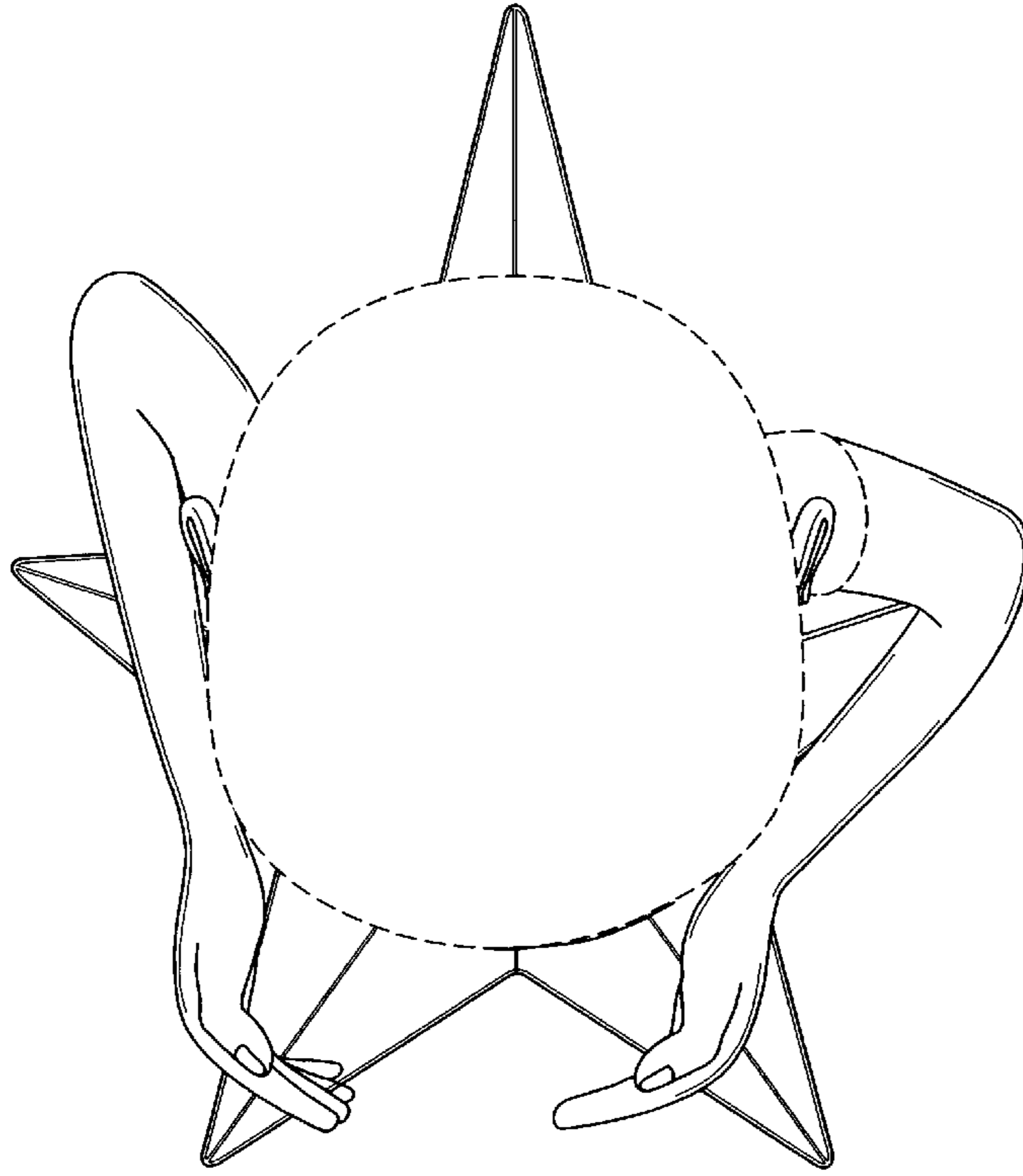

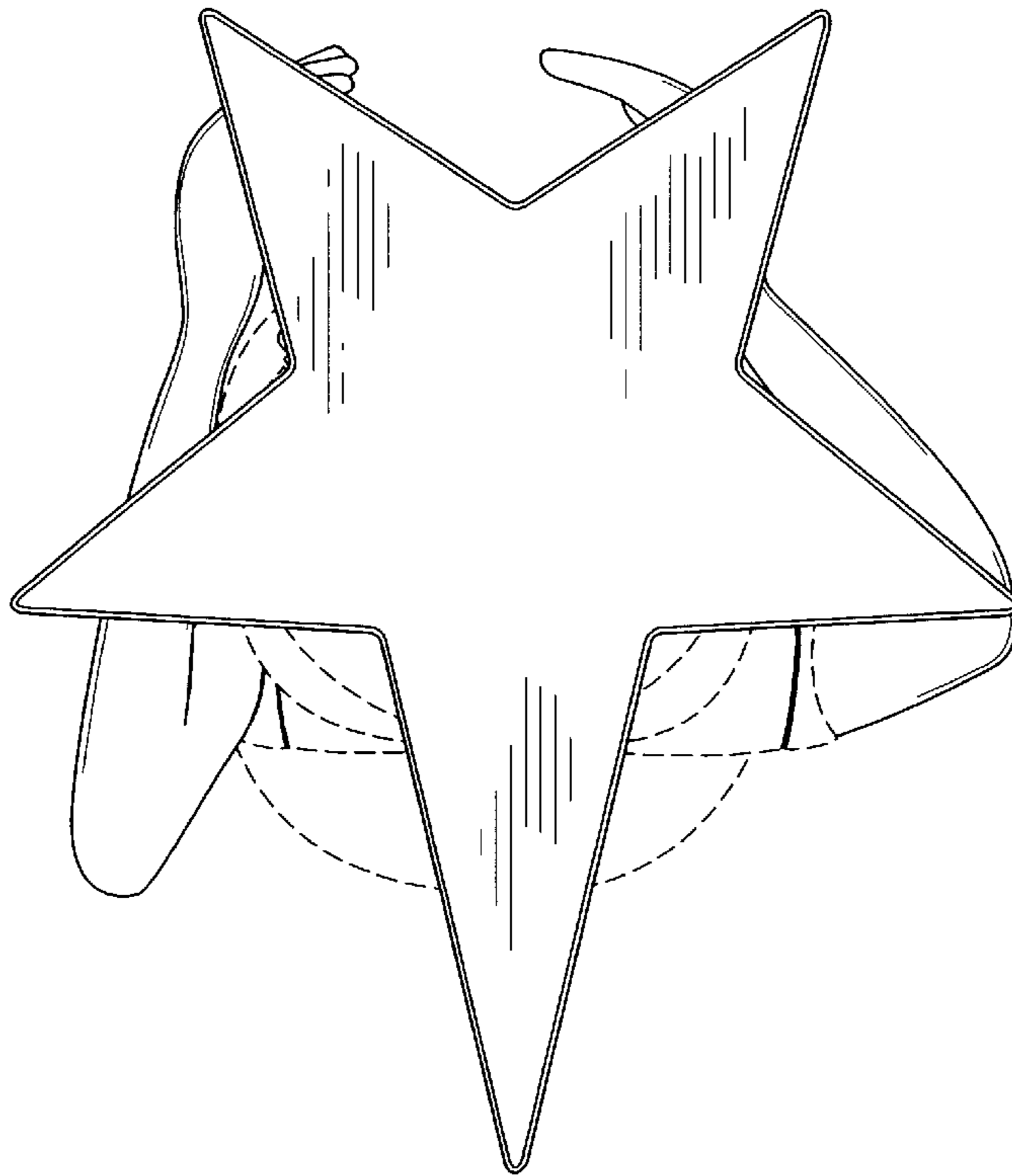
