The ornamental design for a weighted neck wrap, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a weighted neck wrap showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left elevational view thereof;

FIG. 6 is a right elevational view thereof;

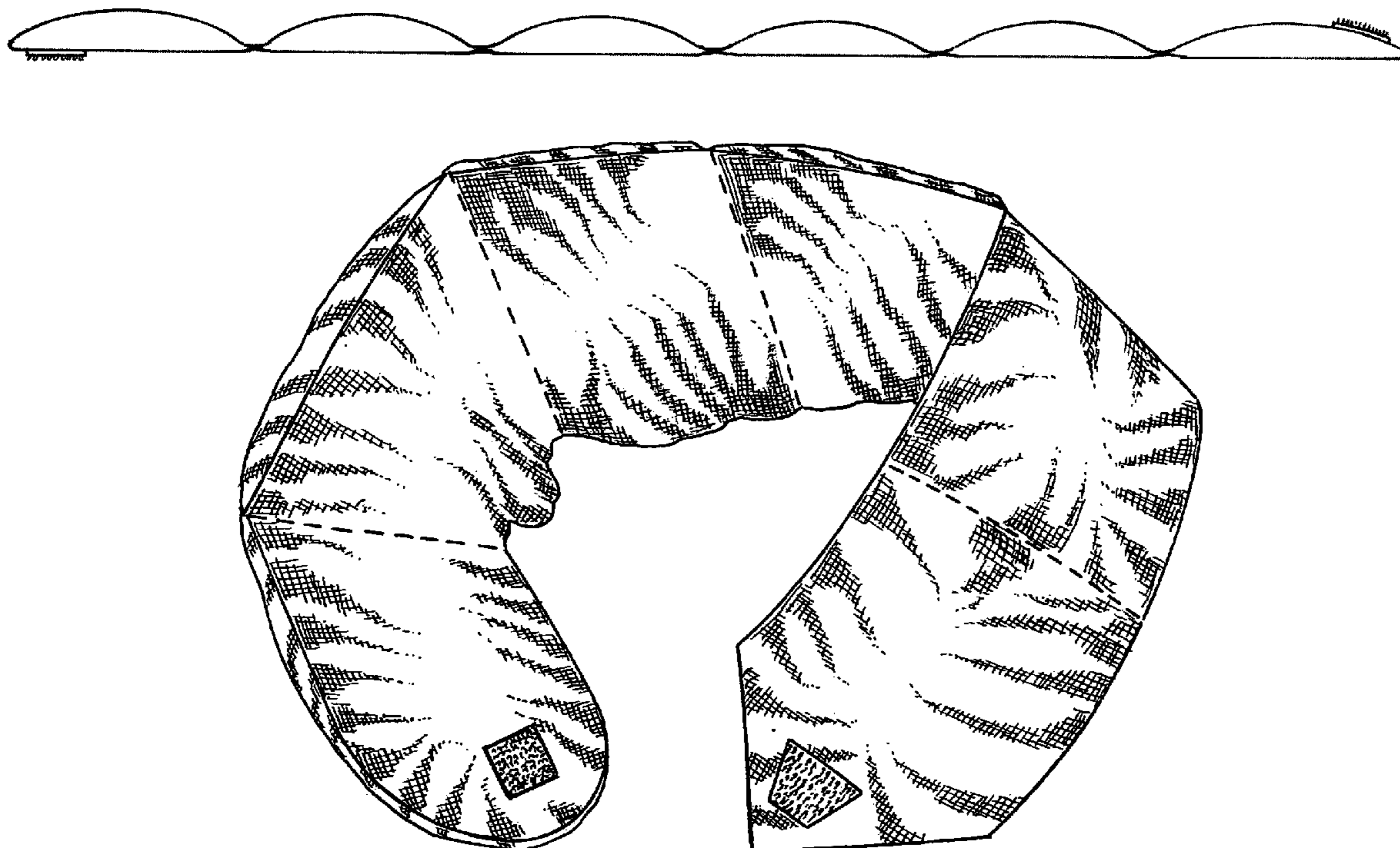
FIG. 7 is a perspective view thereof, with ends curved; and,

FIG. 8 is a perspective view thereof, with ends joined.

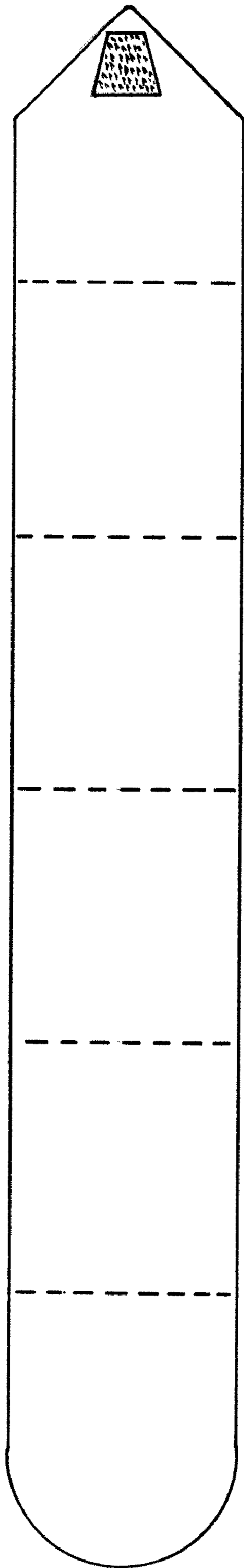

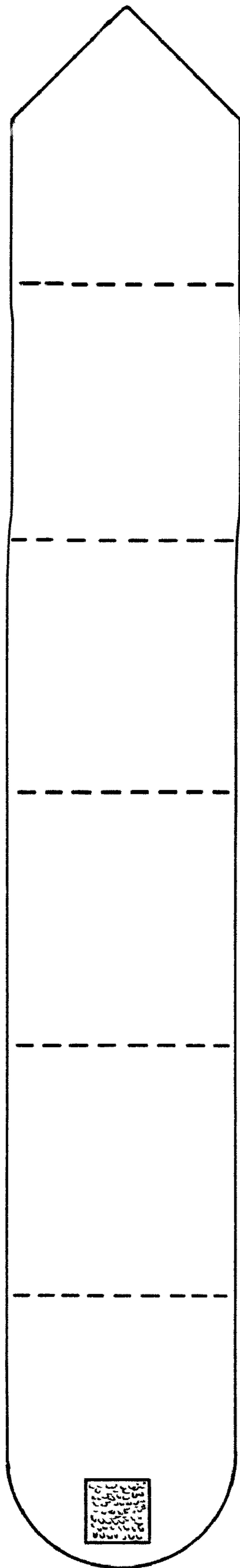

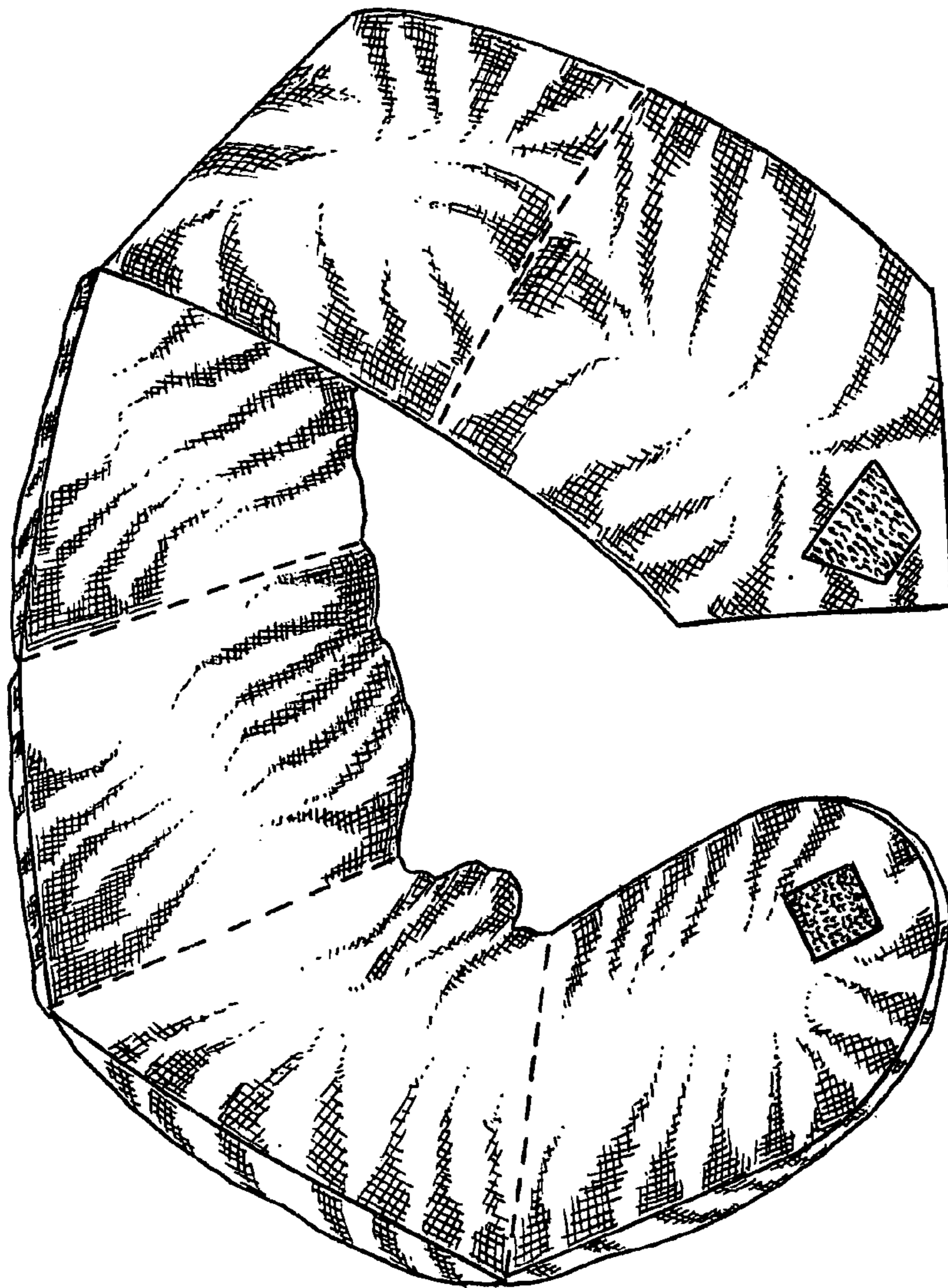

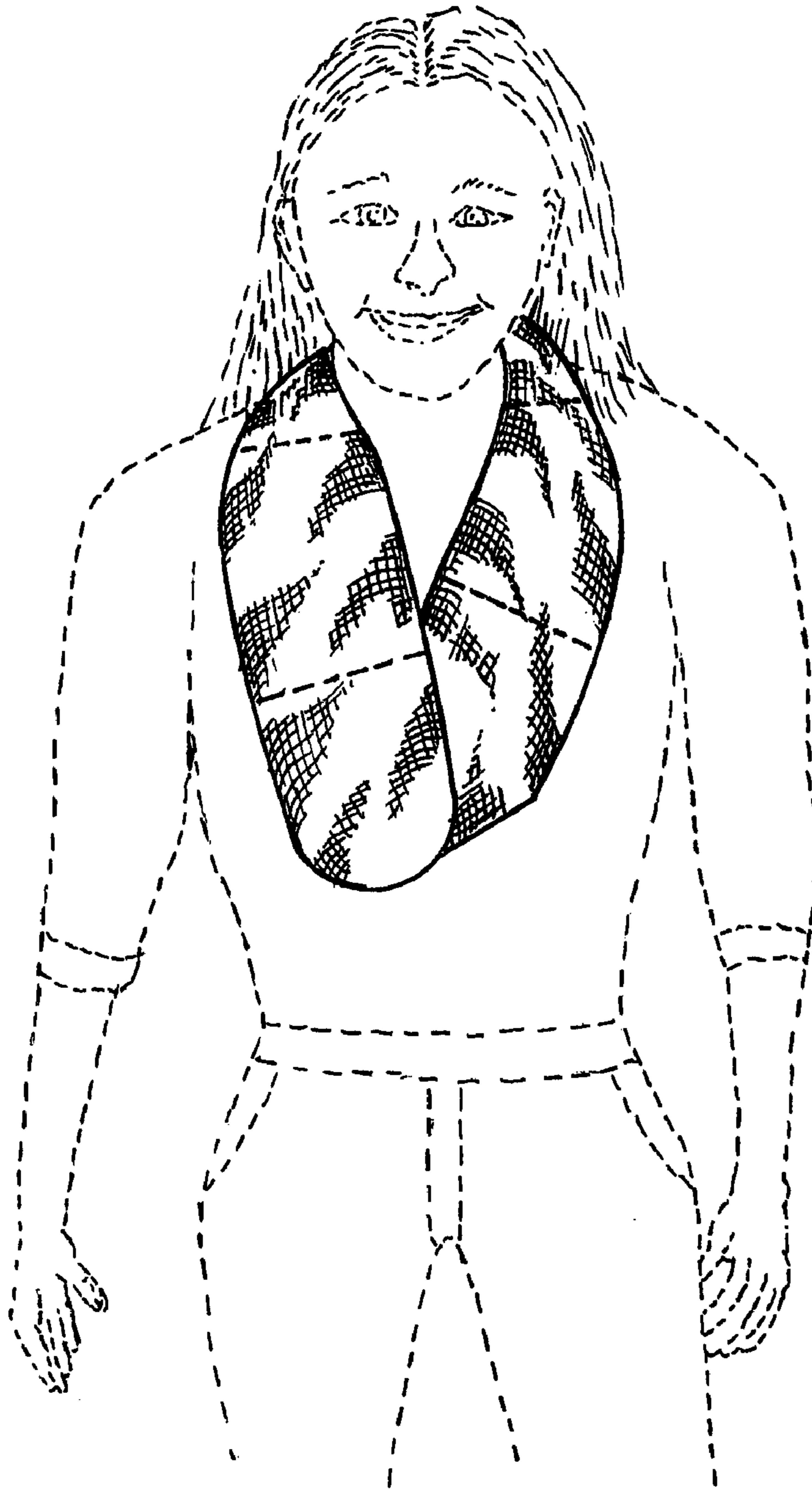
