The ornamental design for a vacuum cleaner unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vacuum cleaner unit showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

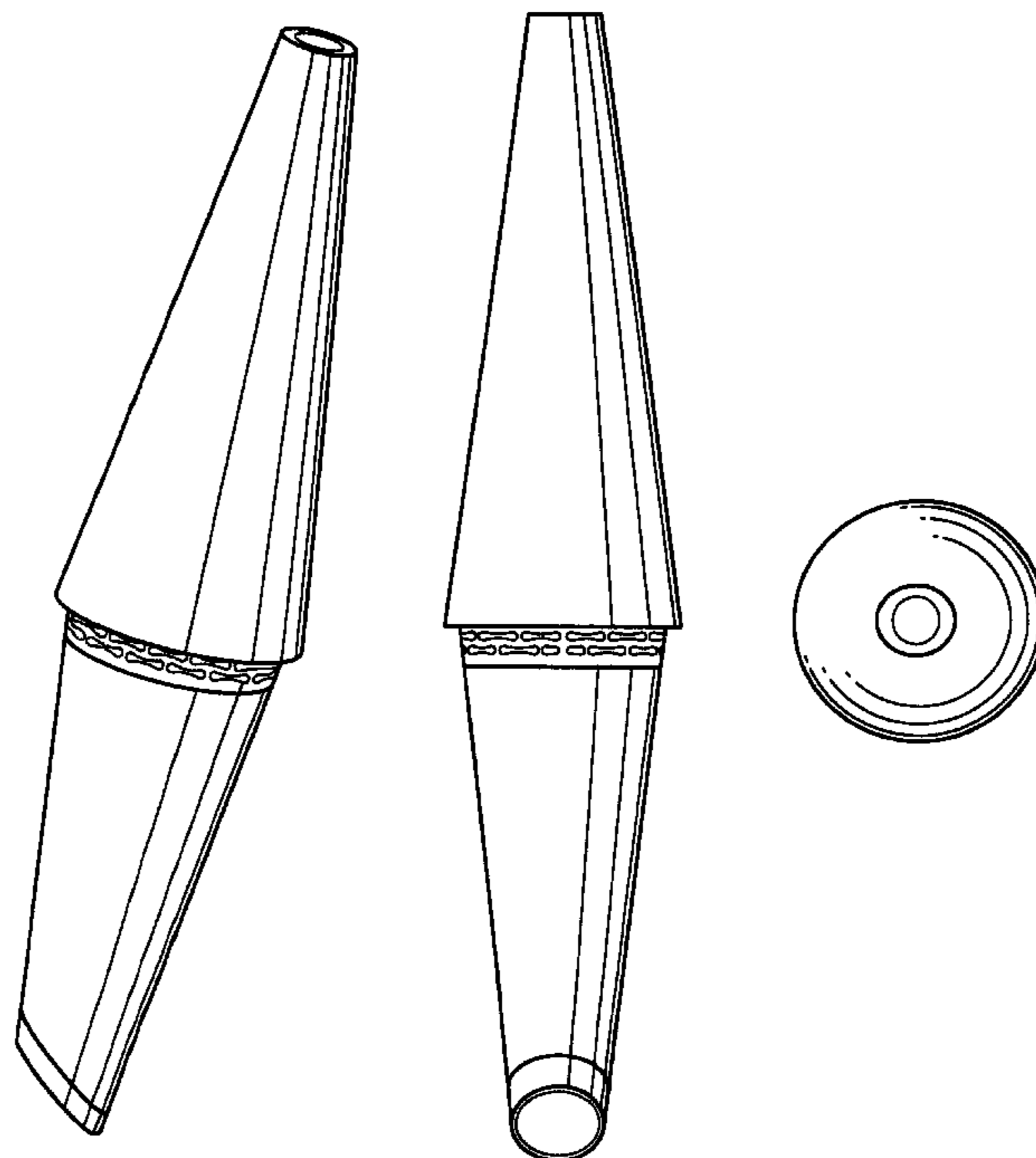
FIG. 4 is a right side elevational view thereof, with a left side elevational view being a mirror image thereof;

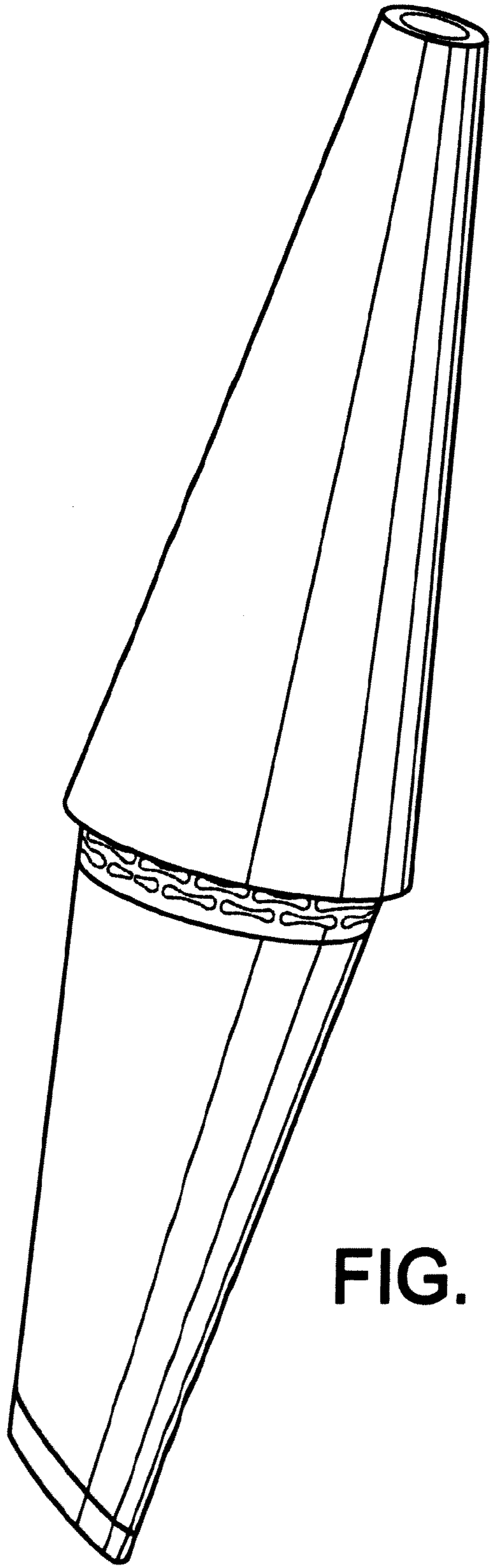

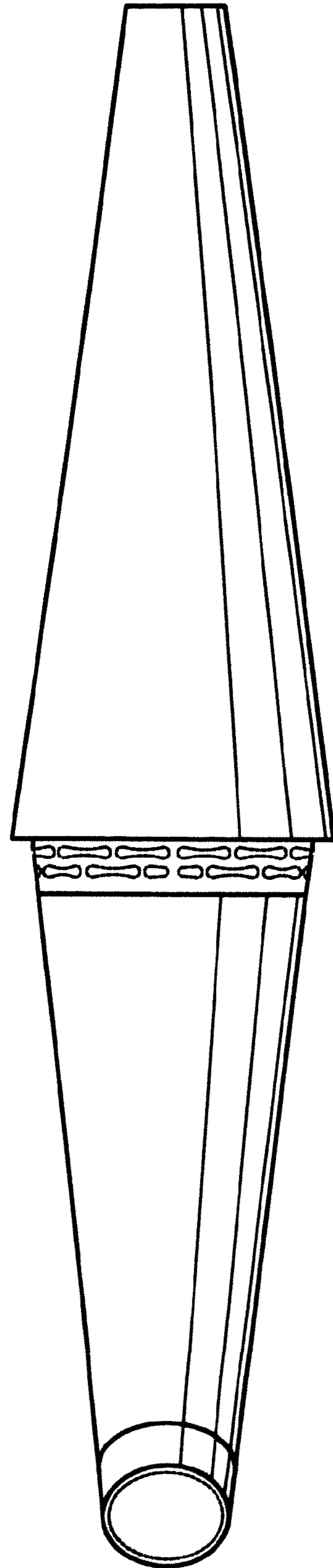

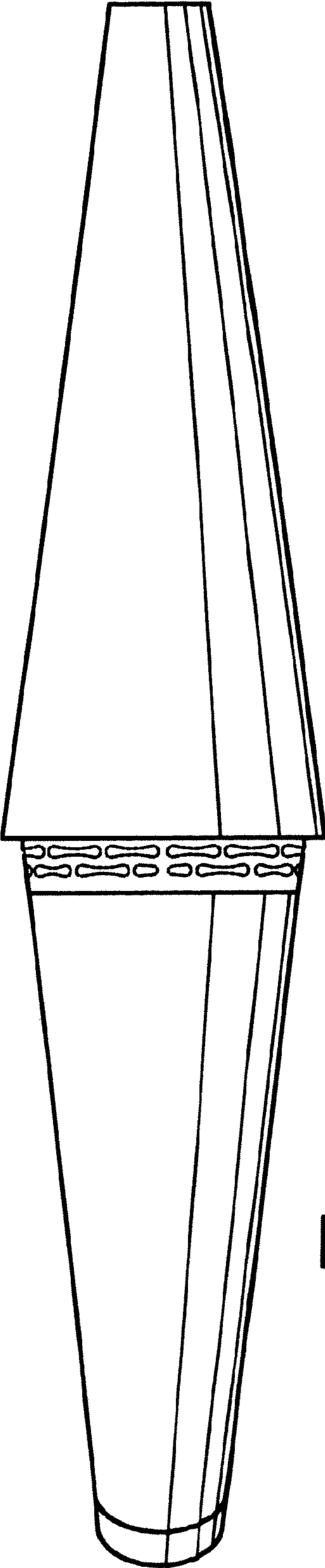

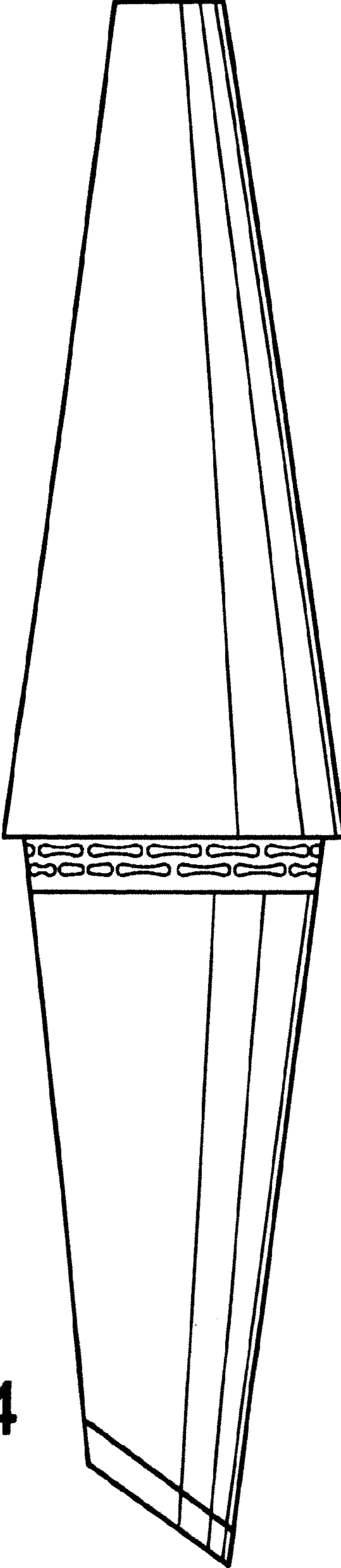

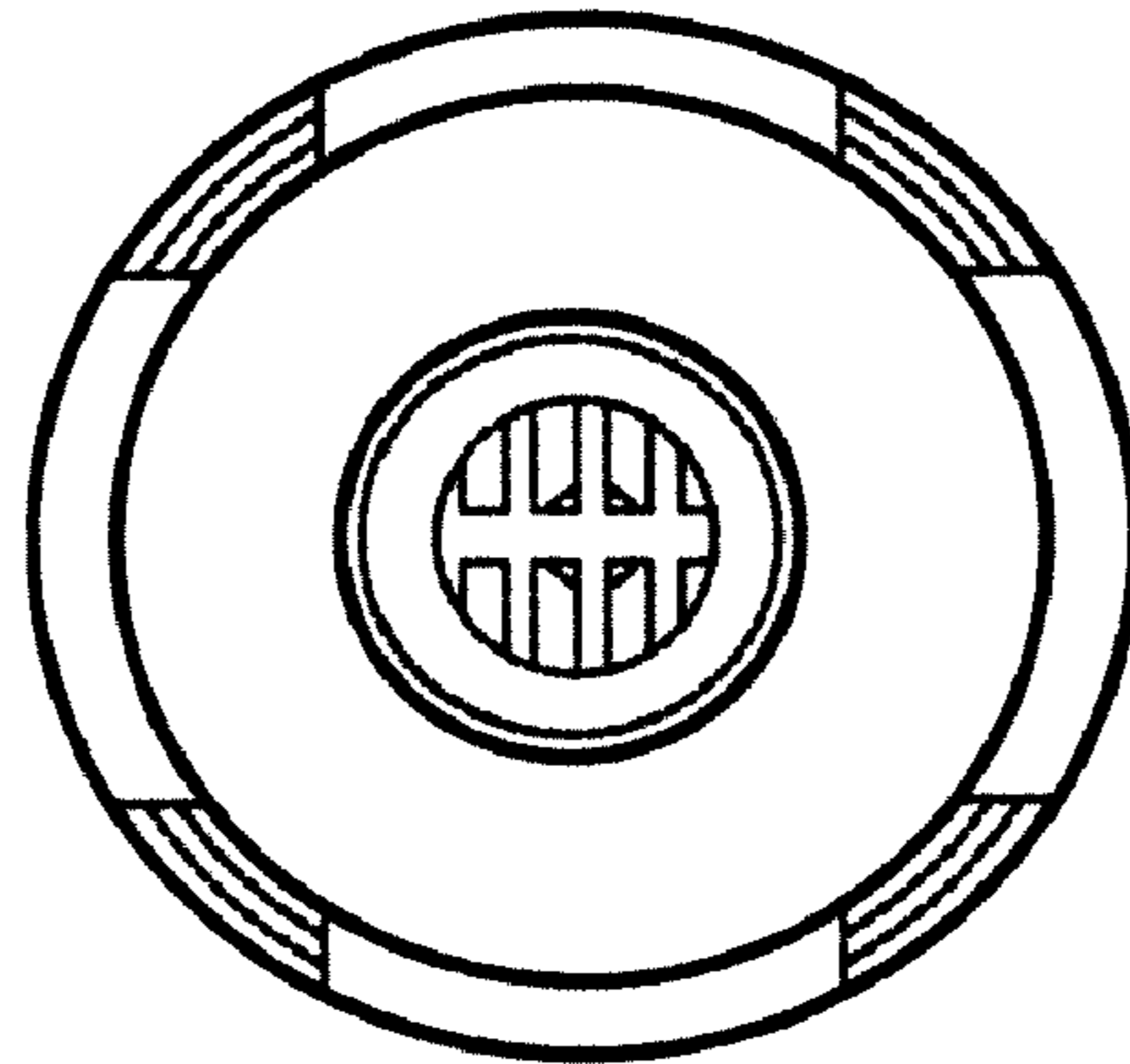

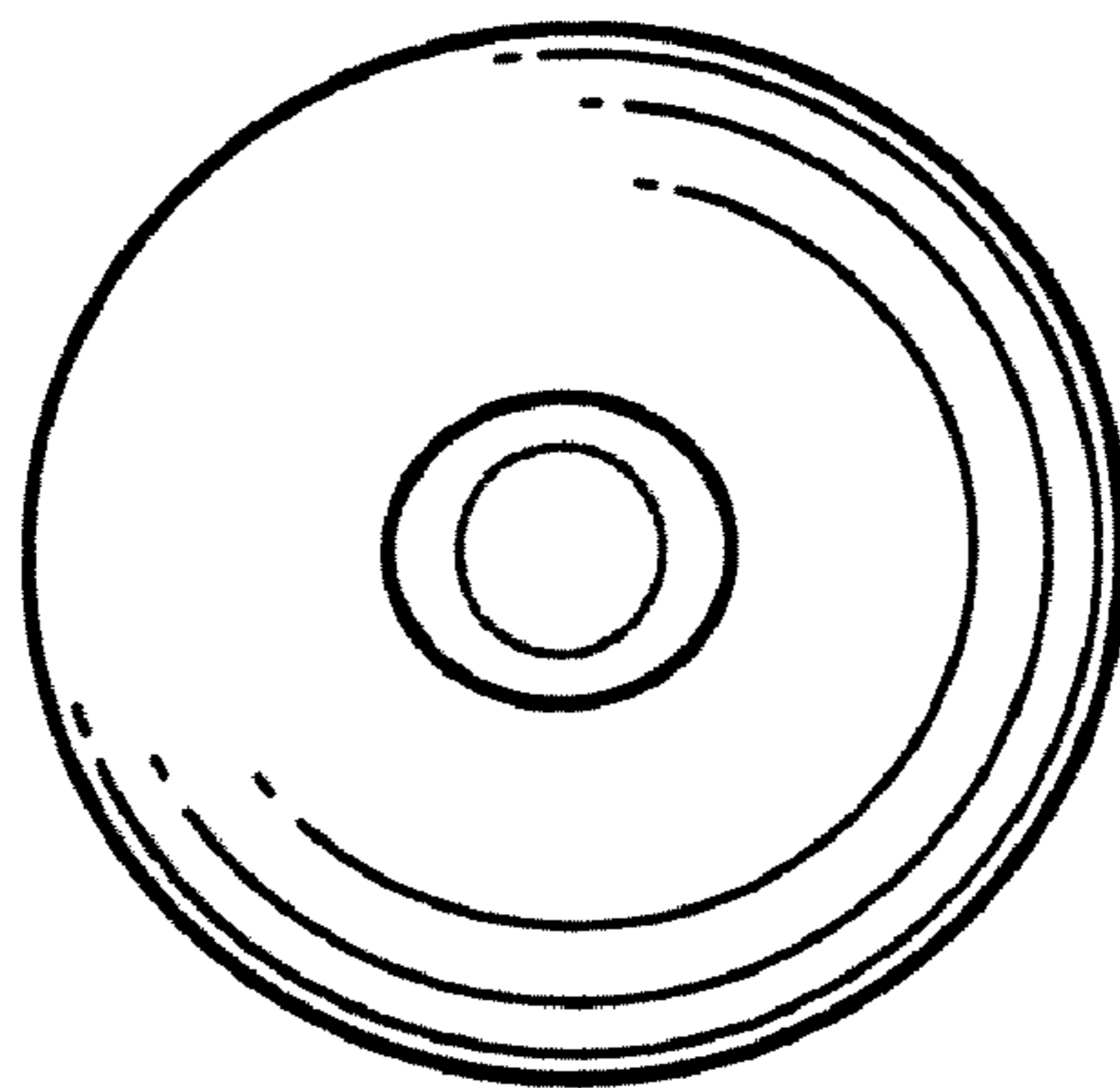
