DESCRIPTION

FIG. 1 is a front perspective view of the sport purse.

FIG. 2 is a front elevation view of the purse.

FIG. 3 is a rear elevation view of the purse opened.

FIG. 4 is a left side view of the purse.

FIG. 5 is a right side view of the purse.

FIG. 6 is a top view of the purse; and,

FIG. 7 is a bottom view of the purse.

The dotted lines represent conventional stitching.

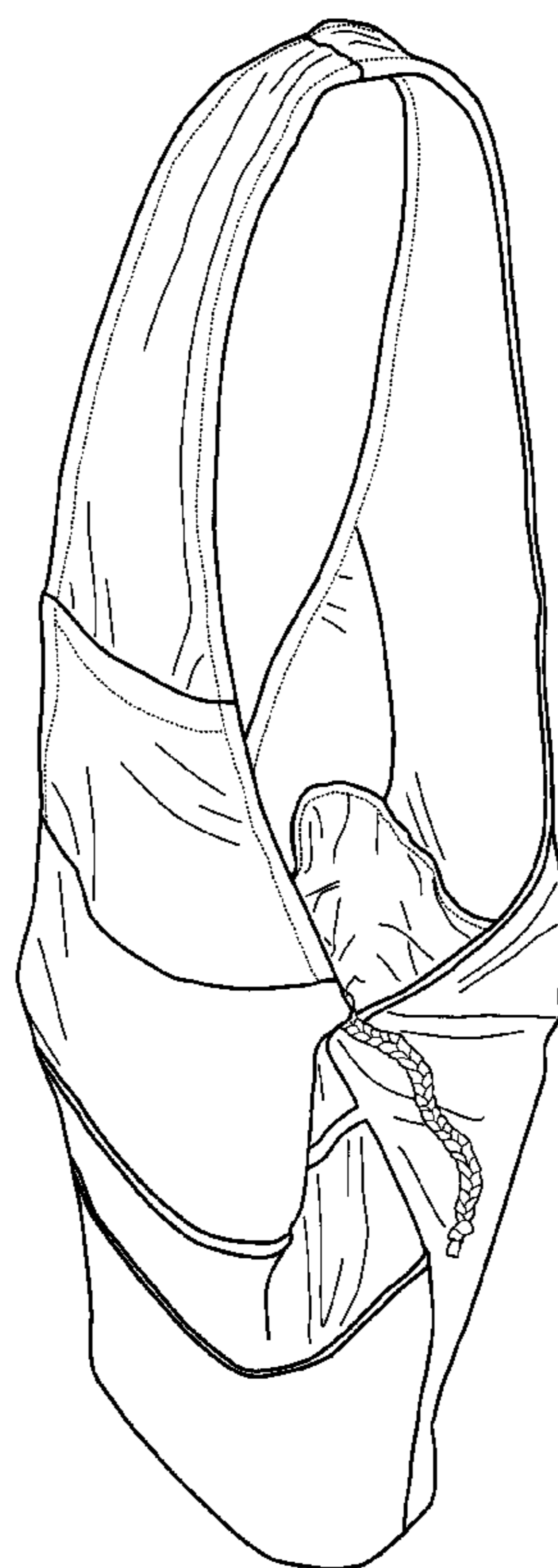

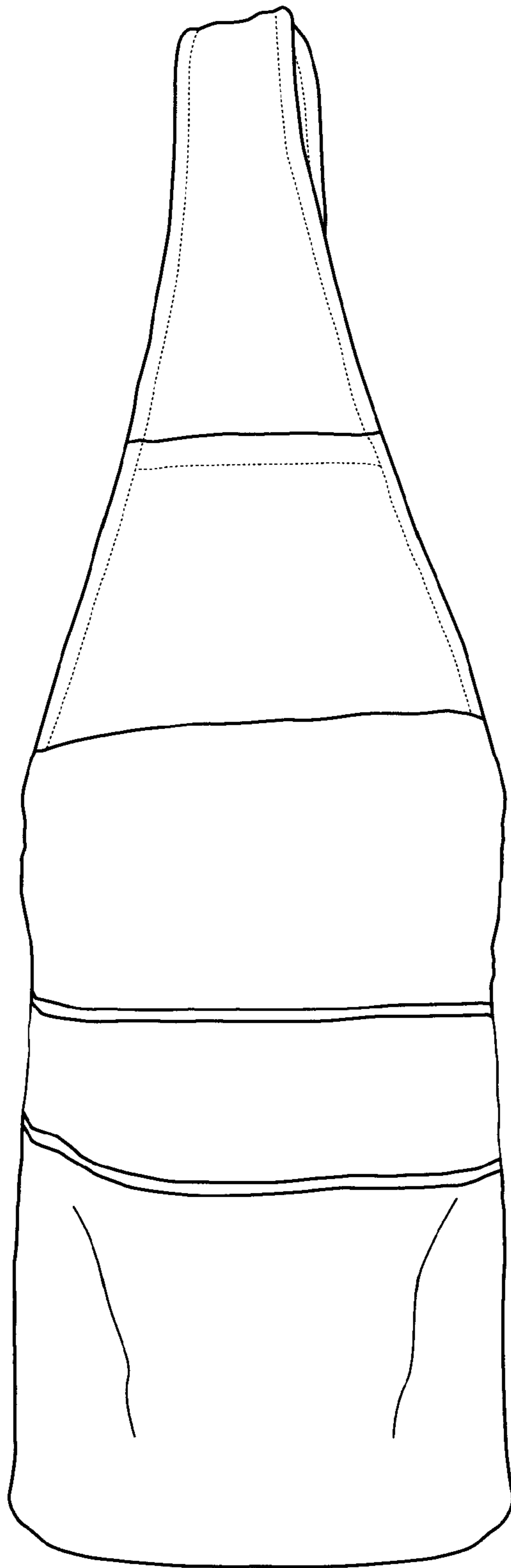

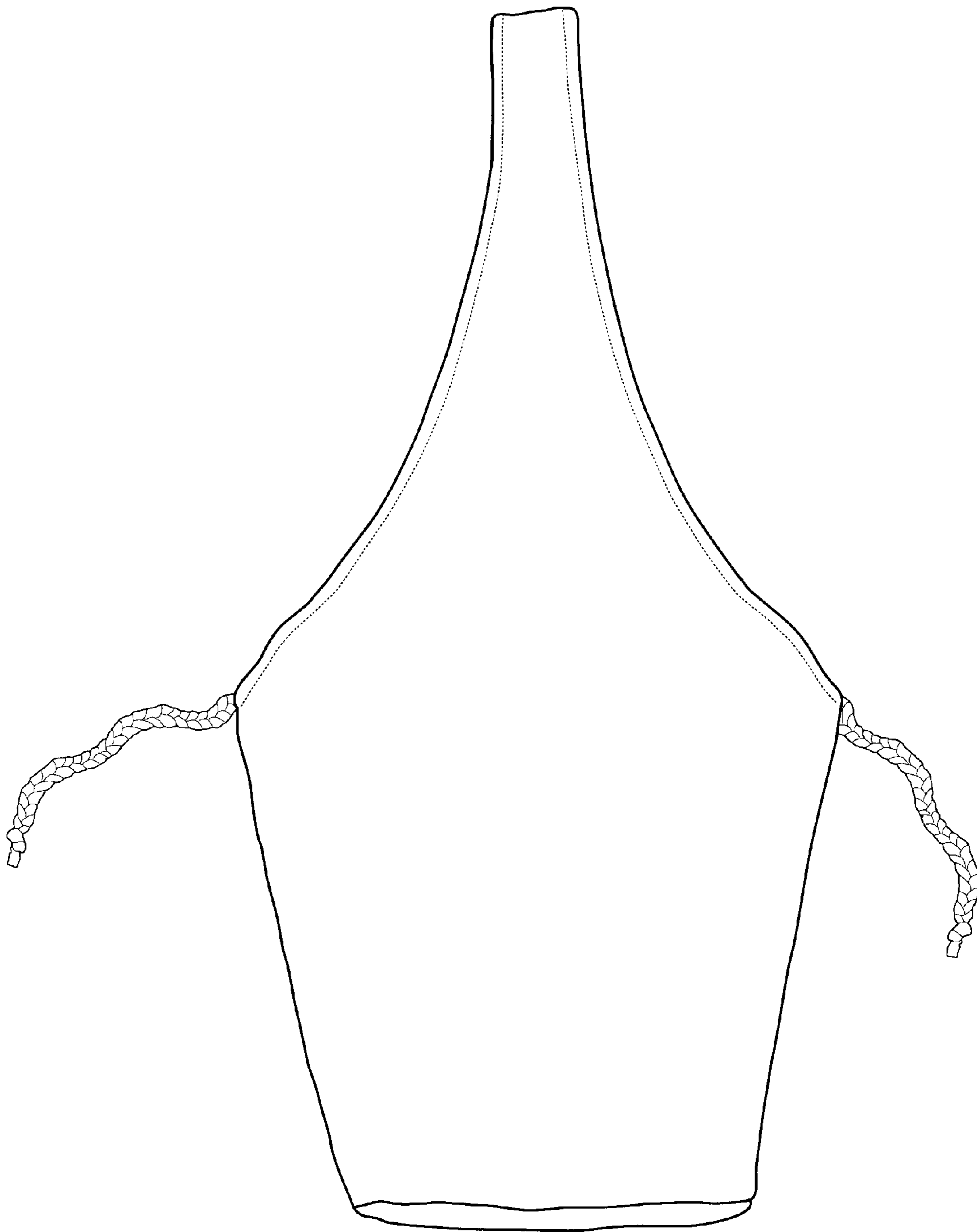

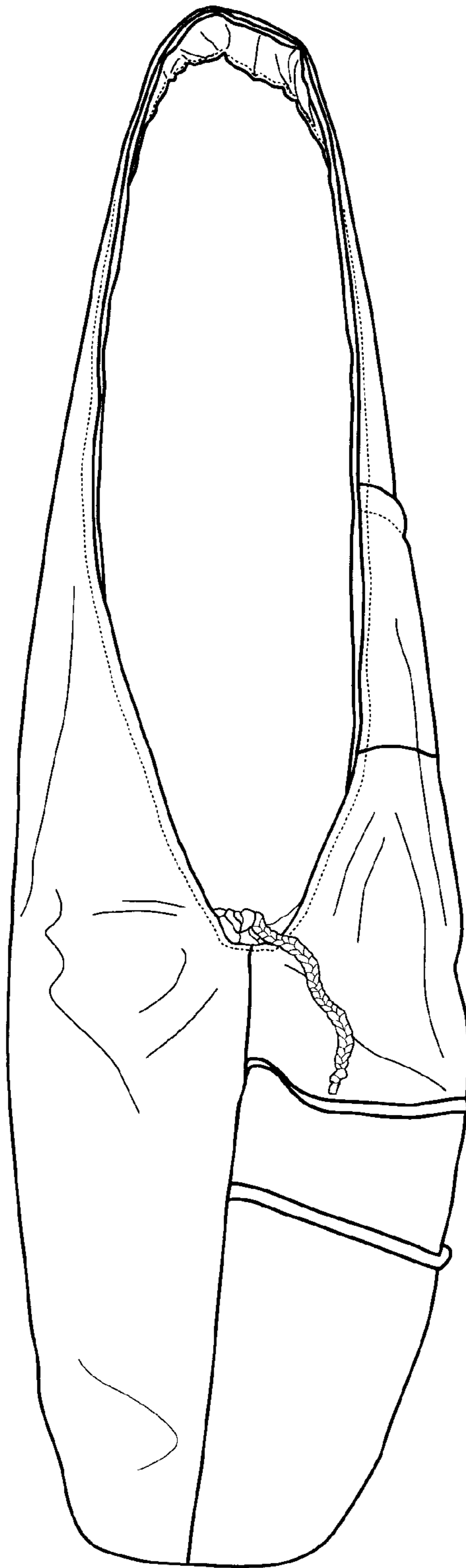

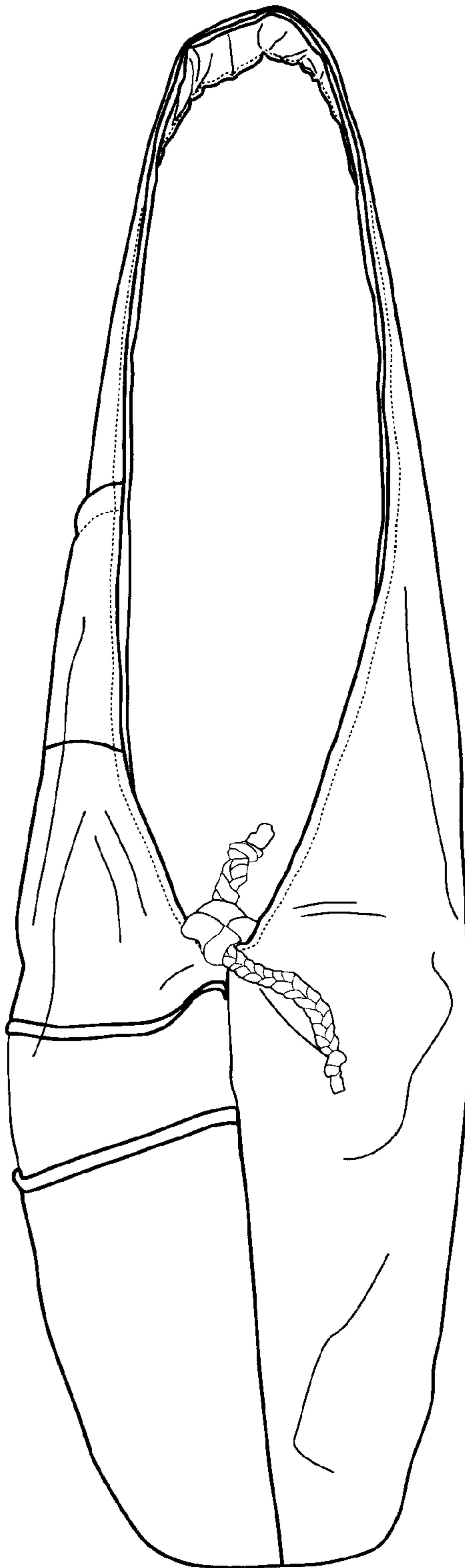

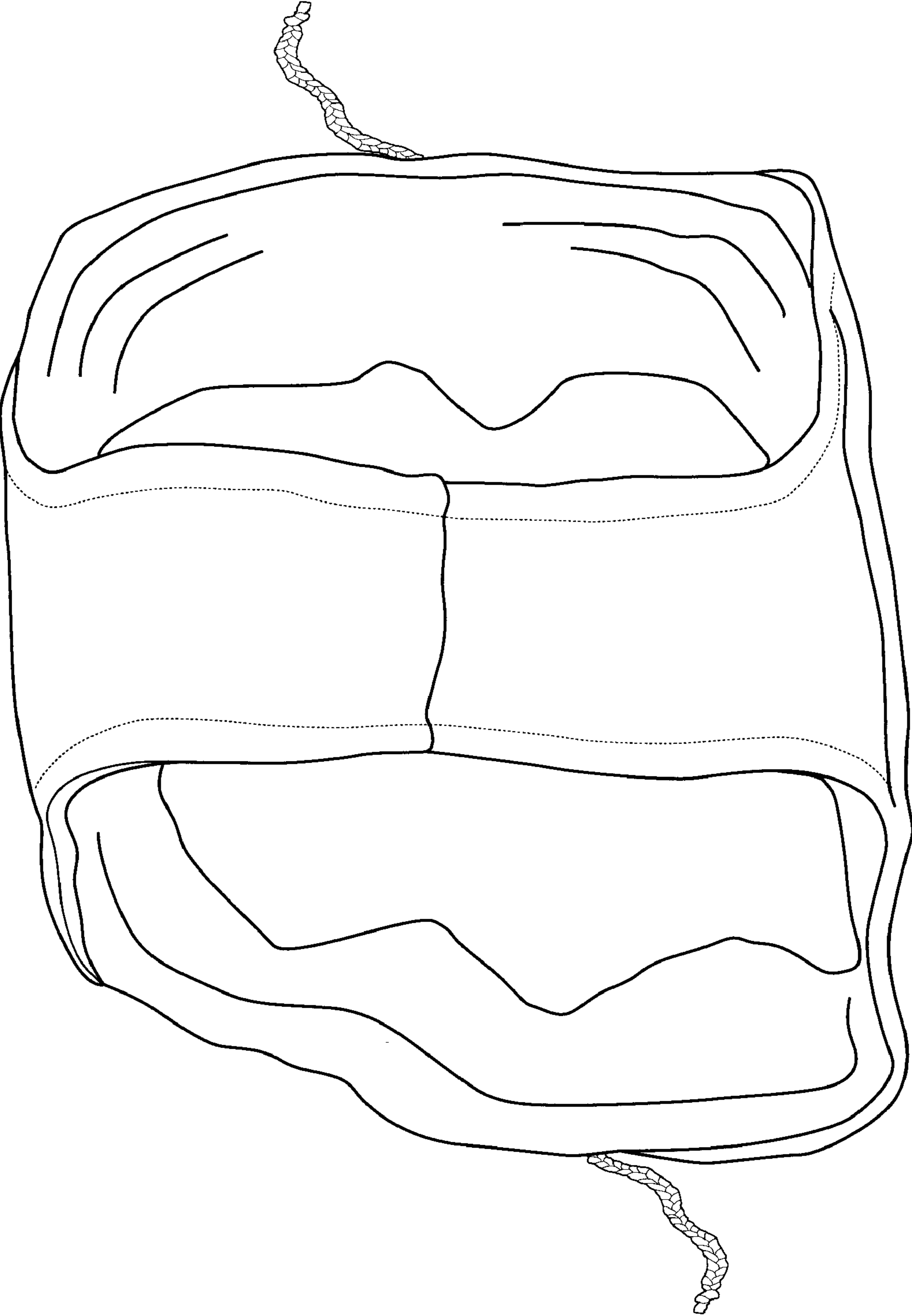

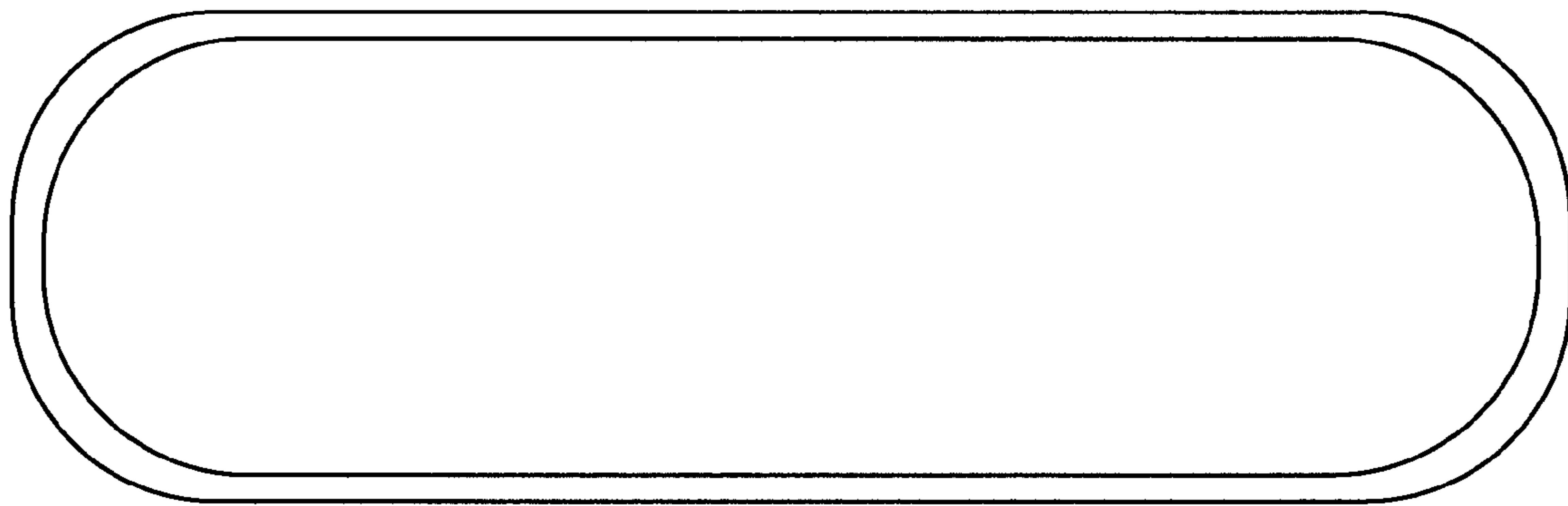
