(57) **CLAIM**

The ornamental design for a golf organizer, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the golf organizer in a folded position. The text “Optional Logo” and circle shown in broken lines are not part of the claimed design and are shown for illustrative purposes only.

FIG. 2 is a back plan view of the golf organizer in a folded position.

FIG. 3 is an elevation view of the top edges of the golf organizer in a folded position.

FIG. 4 is an elevation view of the bottom edges of the golf organizer in a folded position.

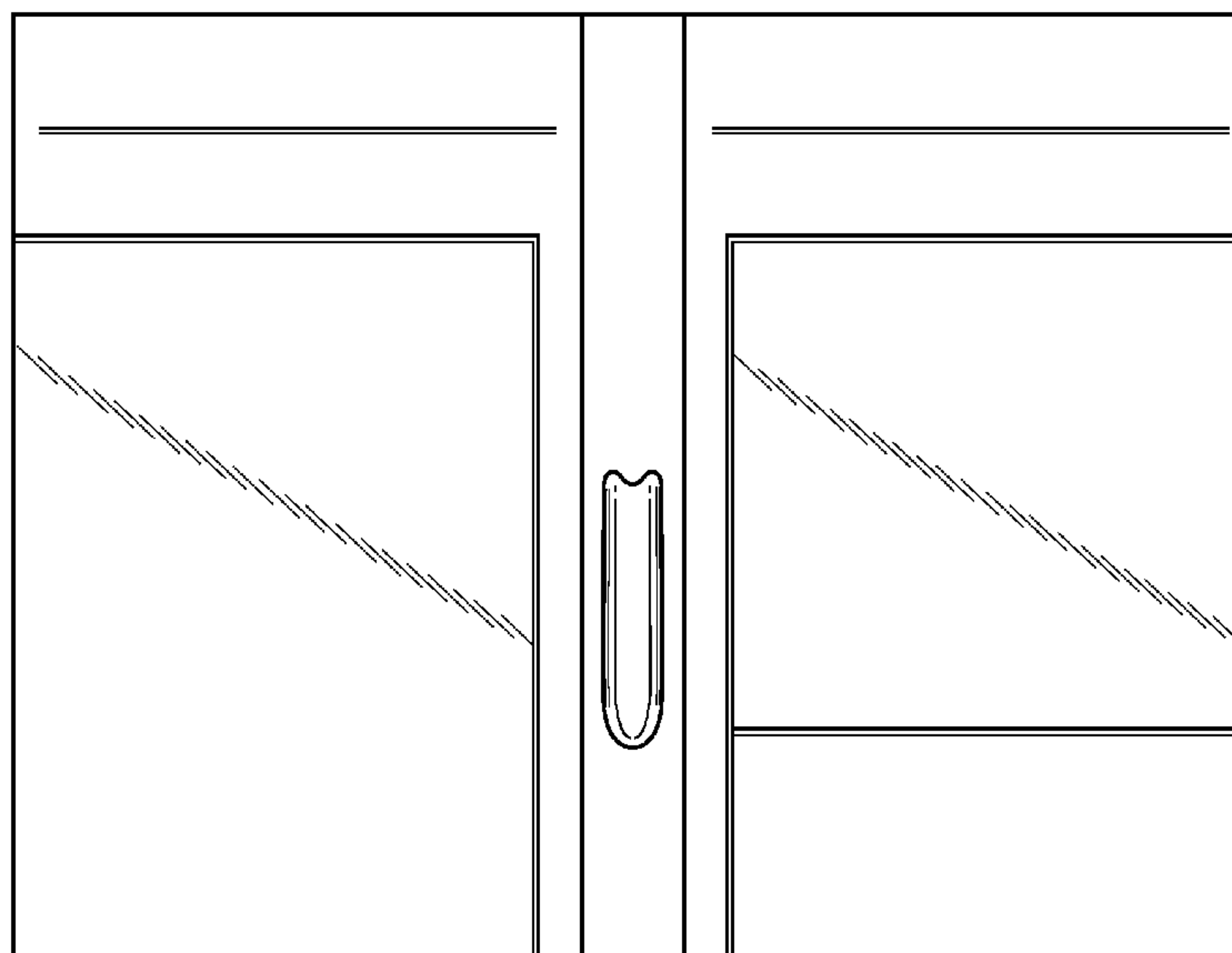
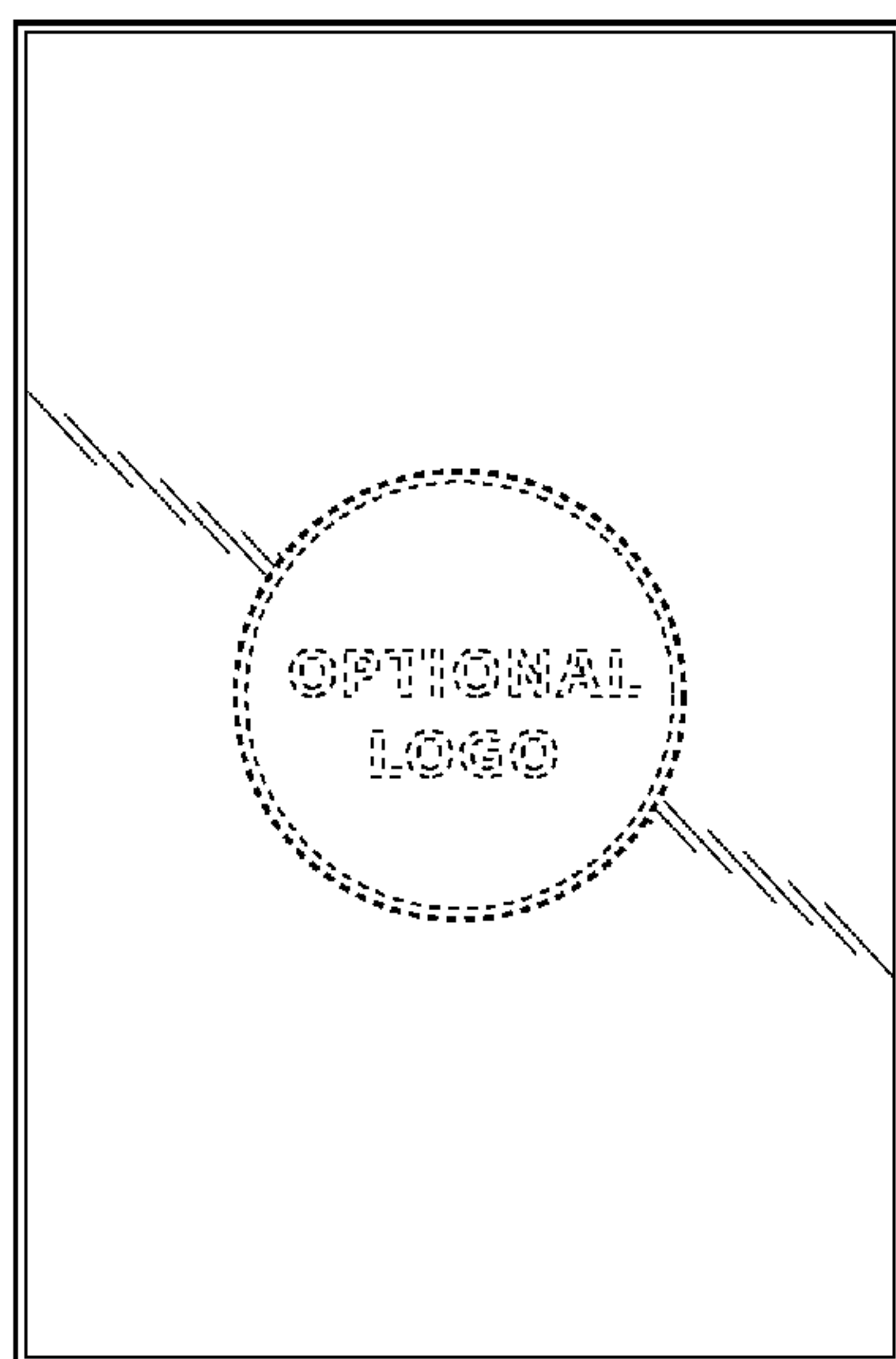
FIG. 5 is an elevation view of the two opening or side edges of the golf organizer in a folded position.

FIG. 6 is an elevation view of the back spine or living hinge section of the golf organizer in a folded position.

FIG. 7 is plan view of the inside portions of the golf organizer in an unfolded position; and,

FIG. 8 is a perspective view of the inside portions of the golf organizer in a partially folded position. The scorecard and yardage book shown in broken lines are not part of the claimed design.

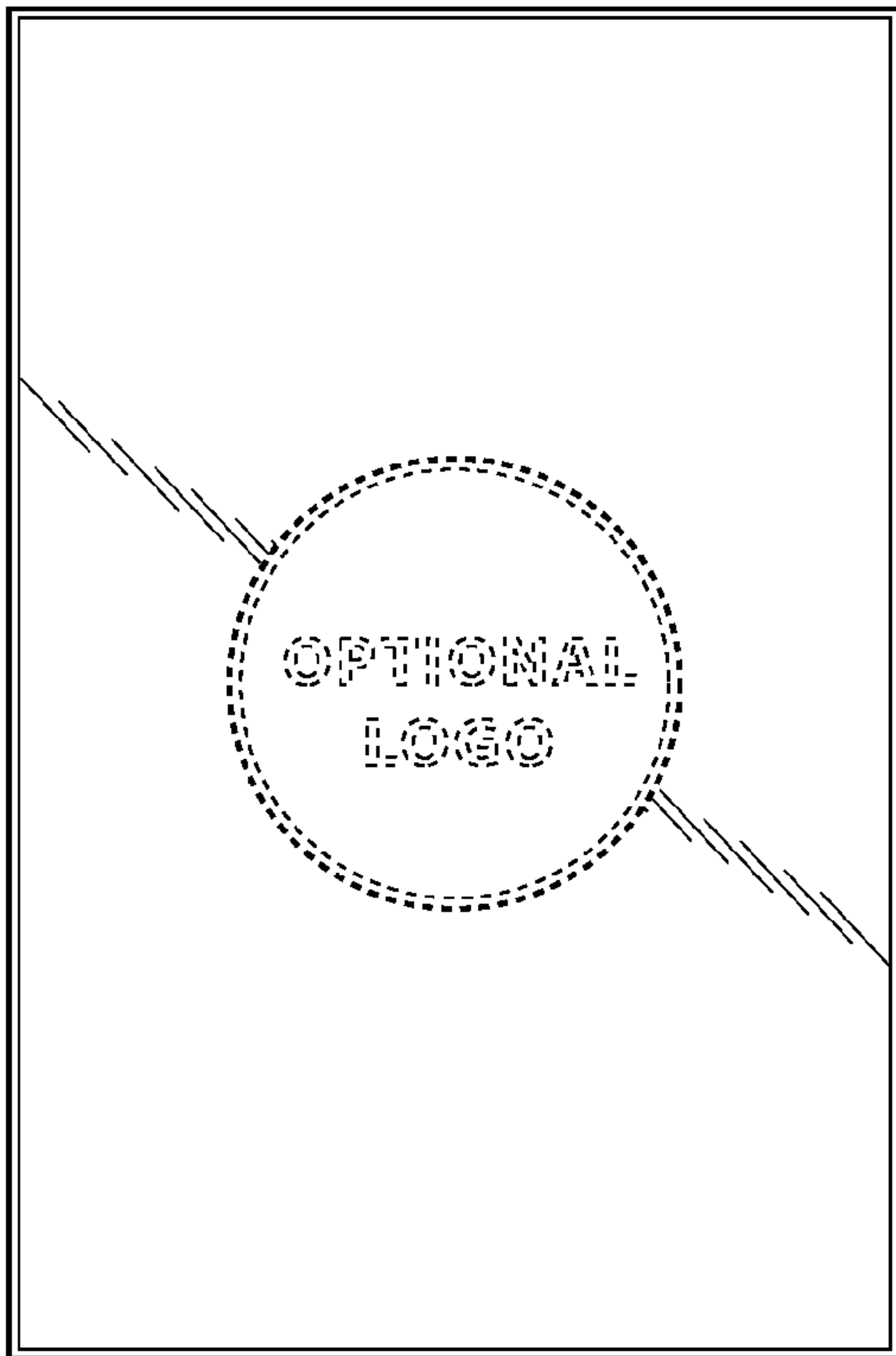

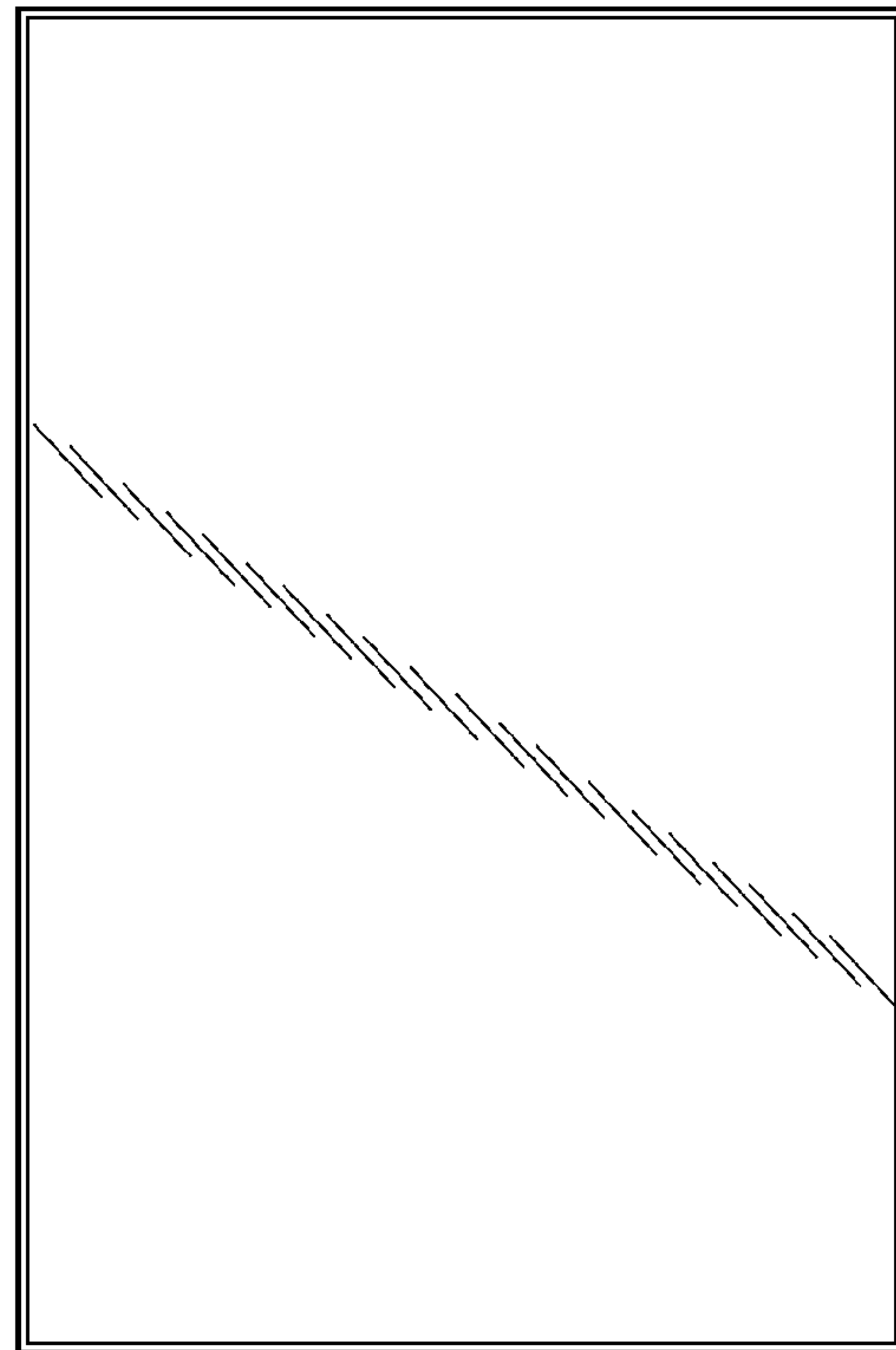

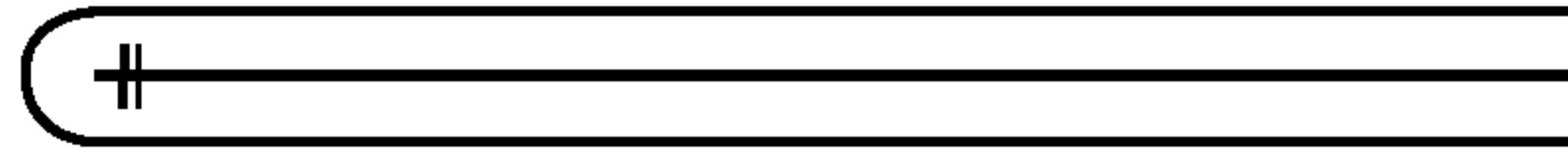

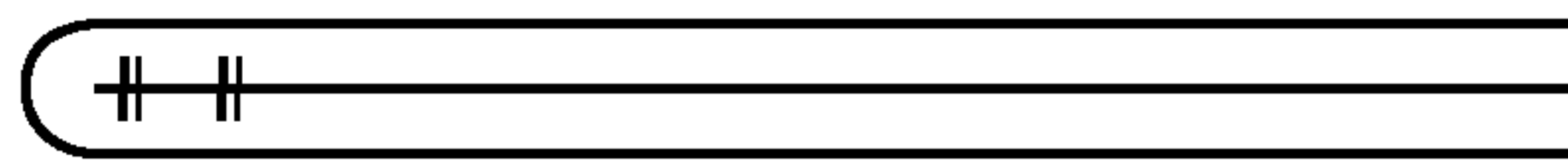

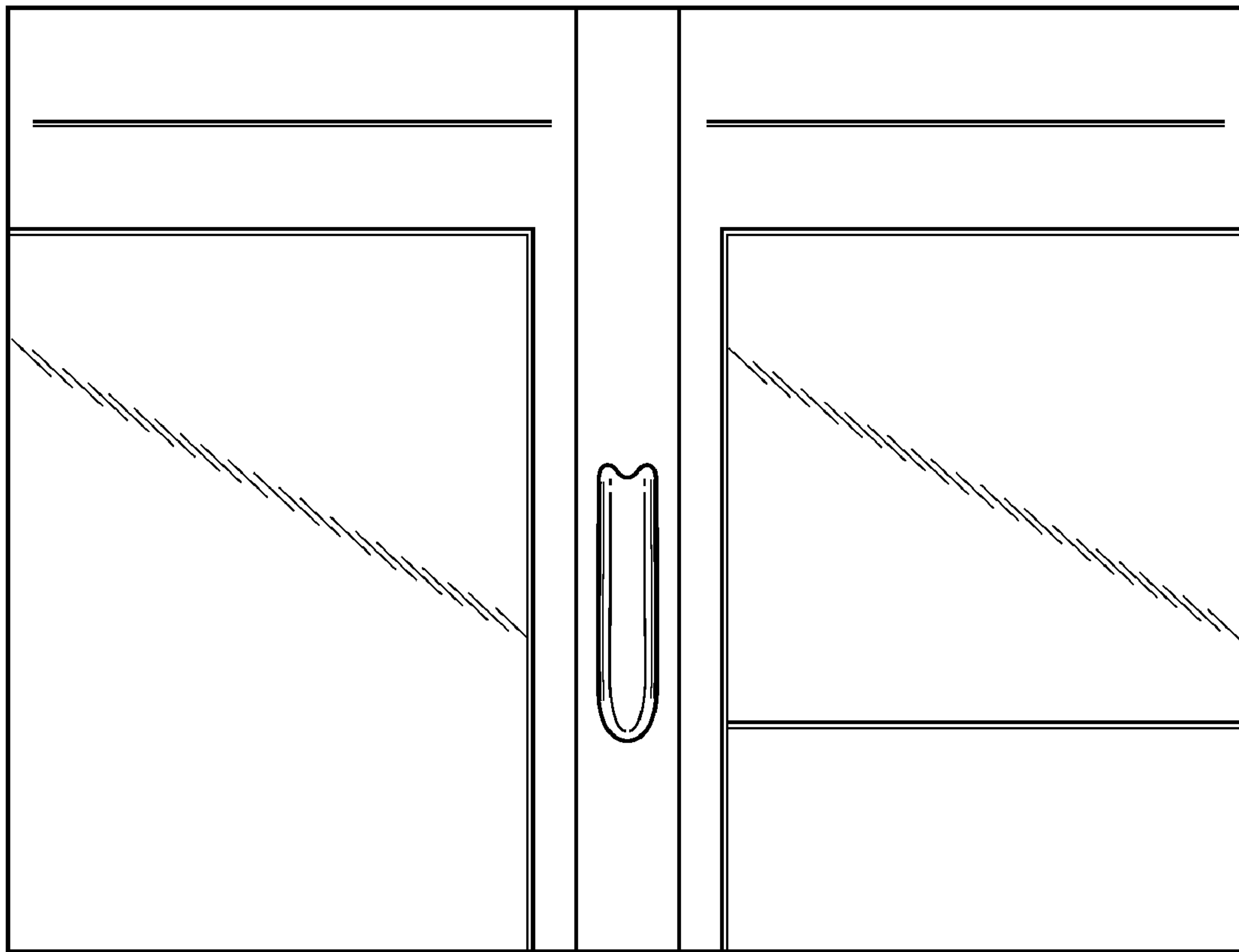

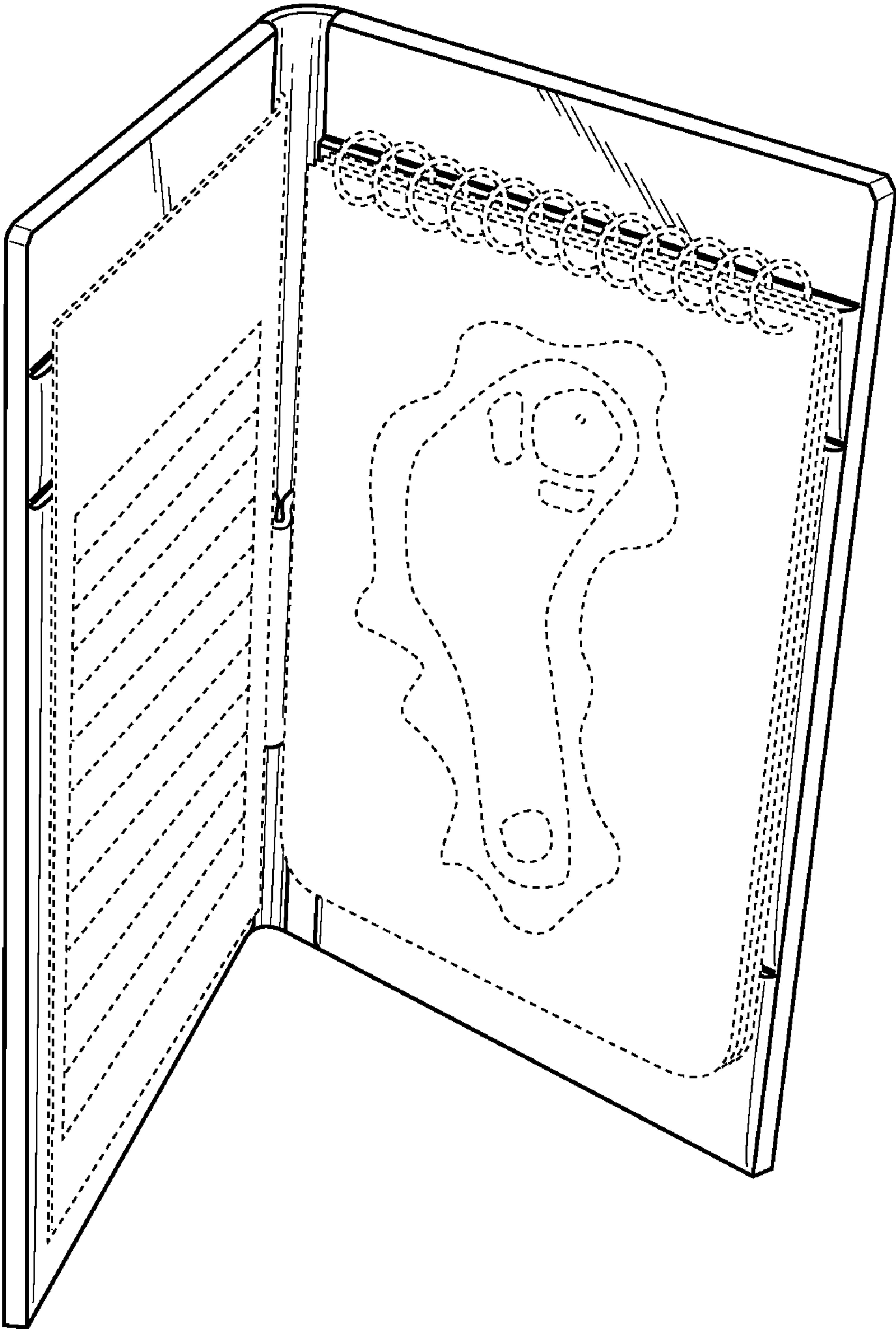
