FIG. 4 is a front elevation view of the golf club holder.

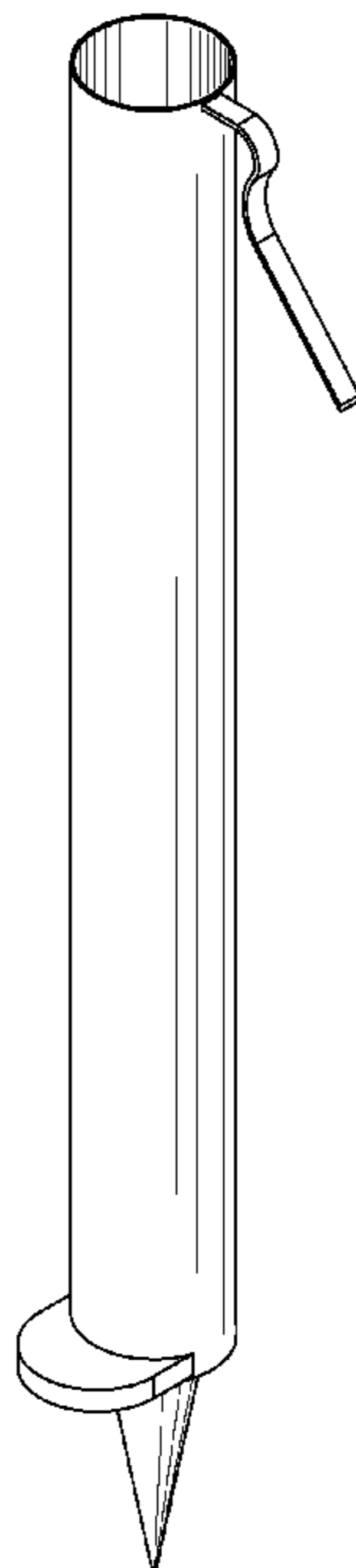
FIG. 5 is a right elevation view of the golf club holder.

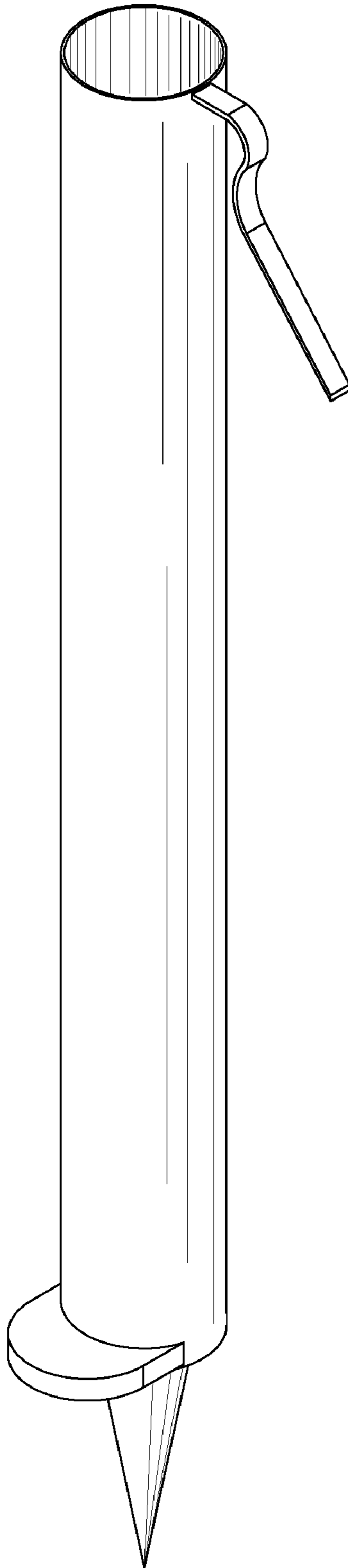

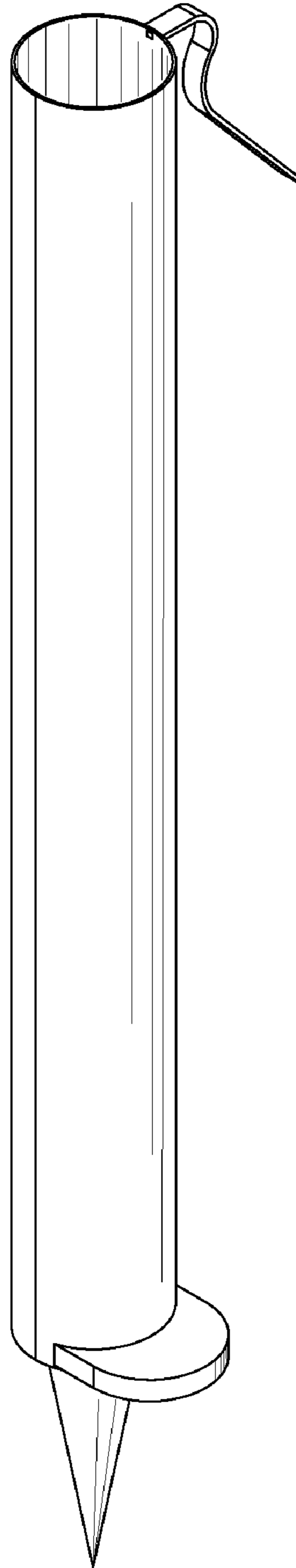

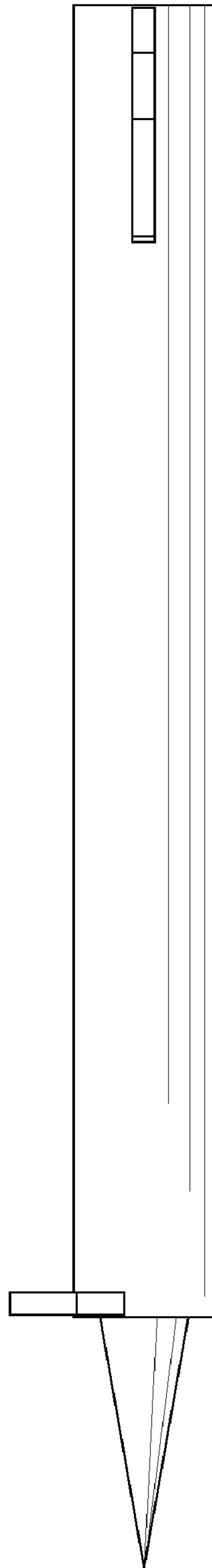

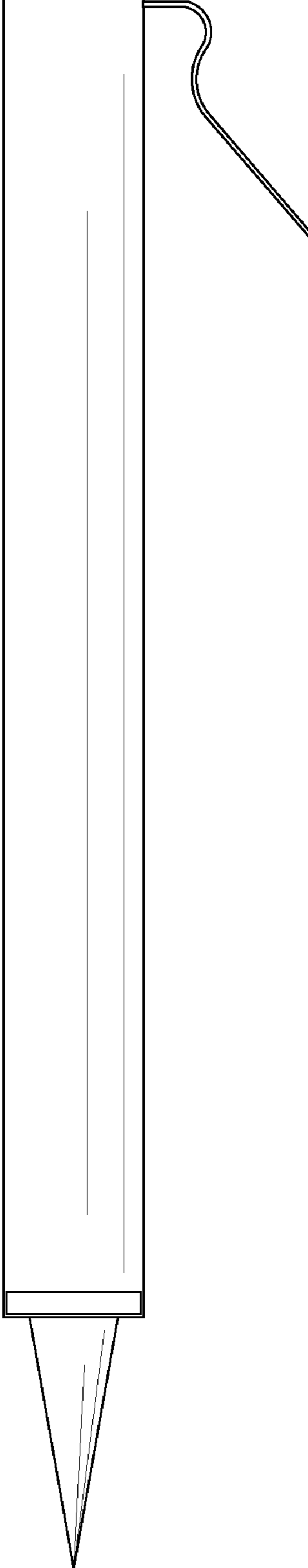

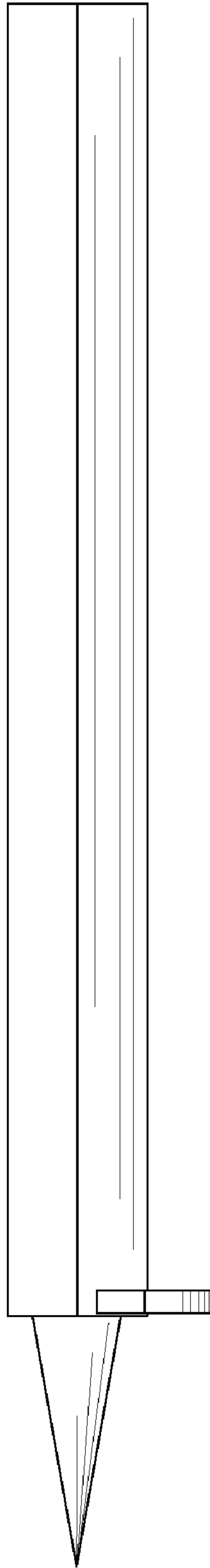

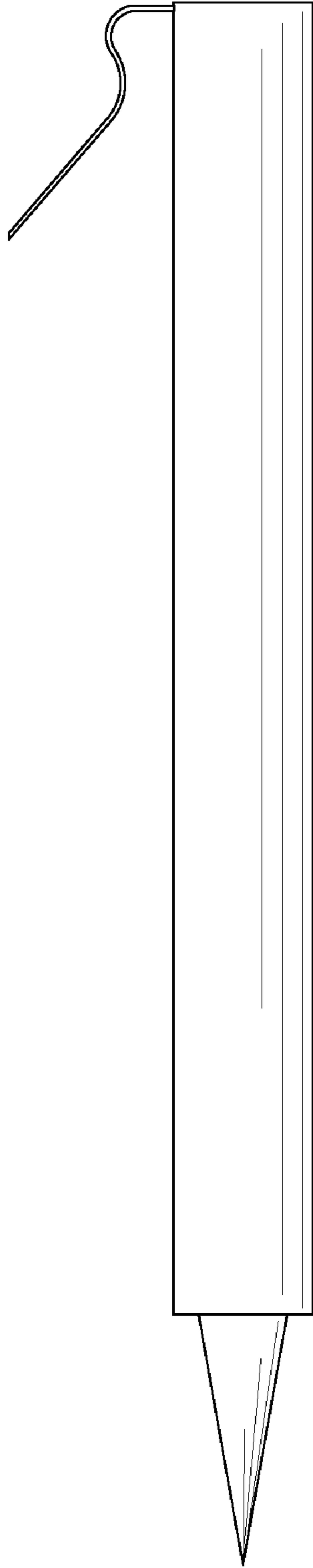

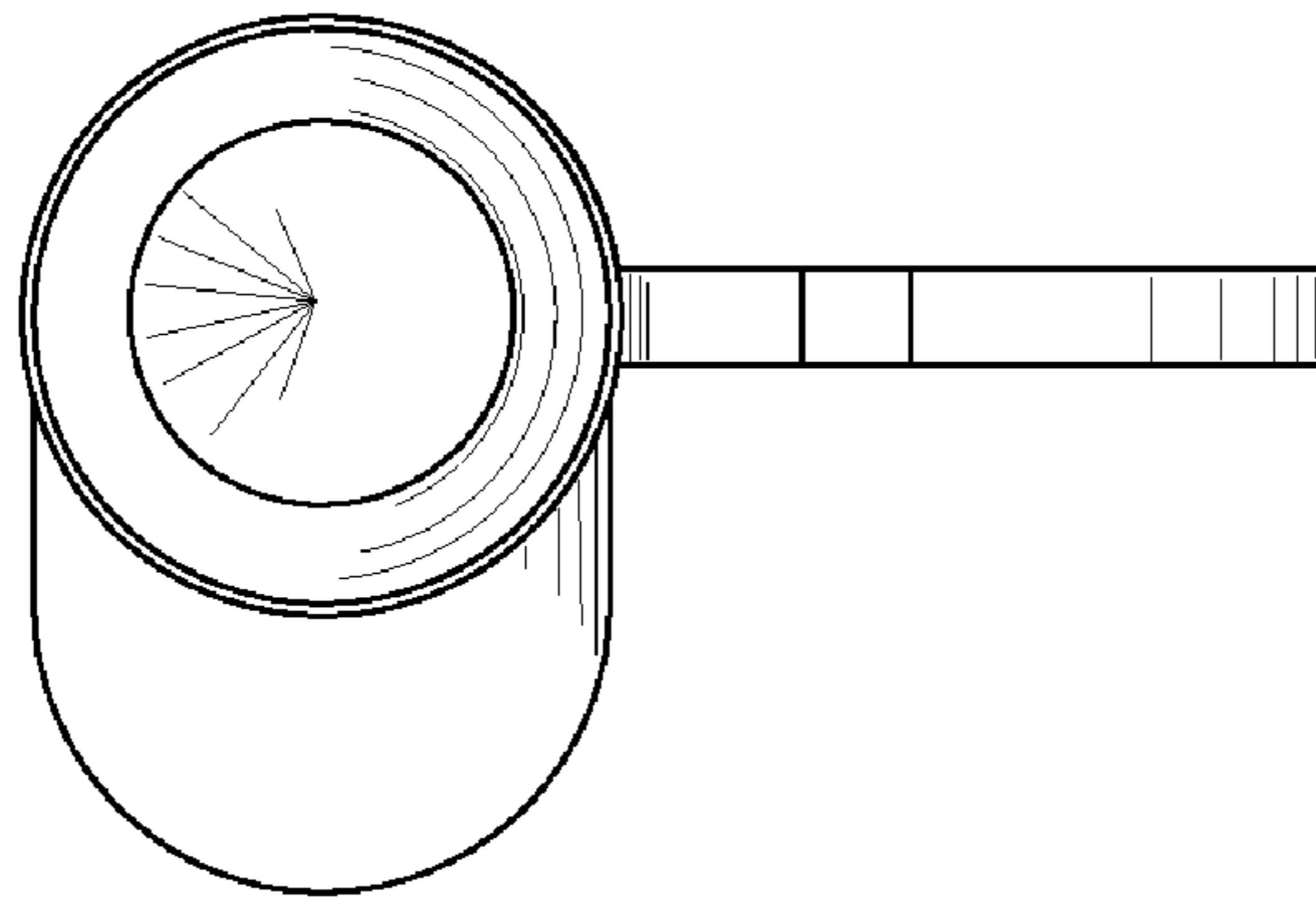

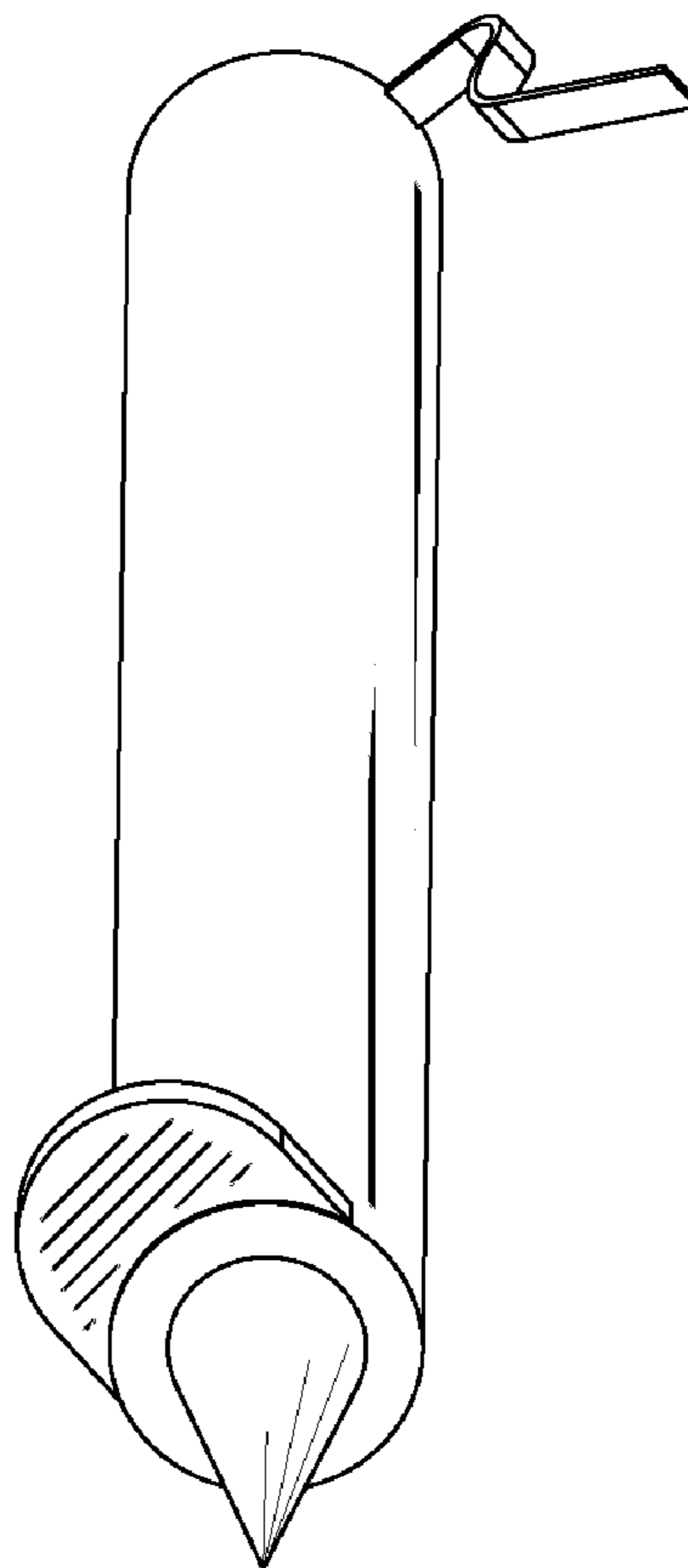
