(57) **CLAIM**

I claim, the ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a seat showing my new design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is top view thereof;
 FIG. 4 is a side view thereof taken from the right of FIG. 1,
 the opposite side being a mirror image thereof;
 FIG. 5 is a front perspective view thereof; and,
 FIG. 6 is a rear perspective view thereof.

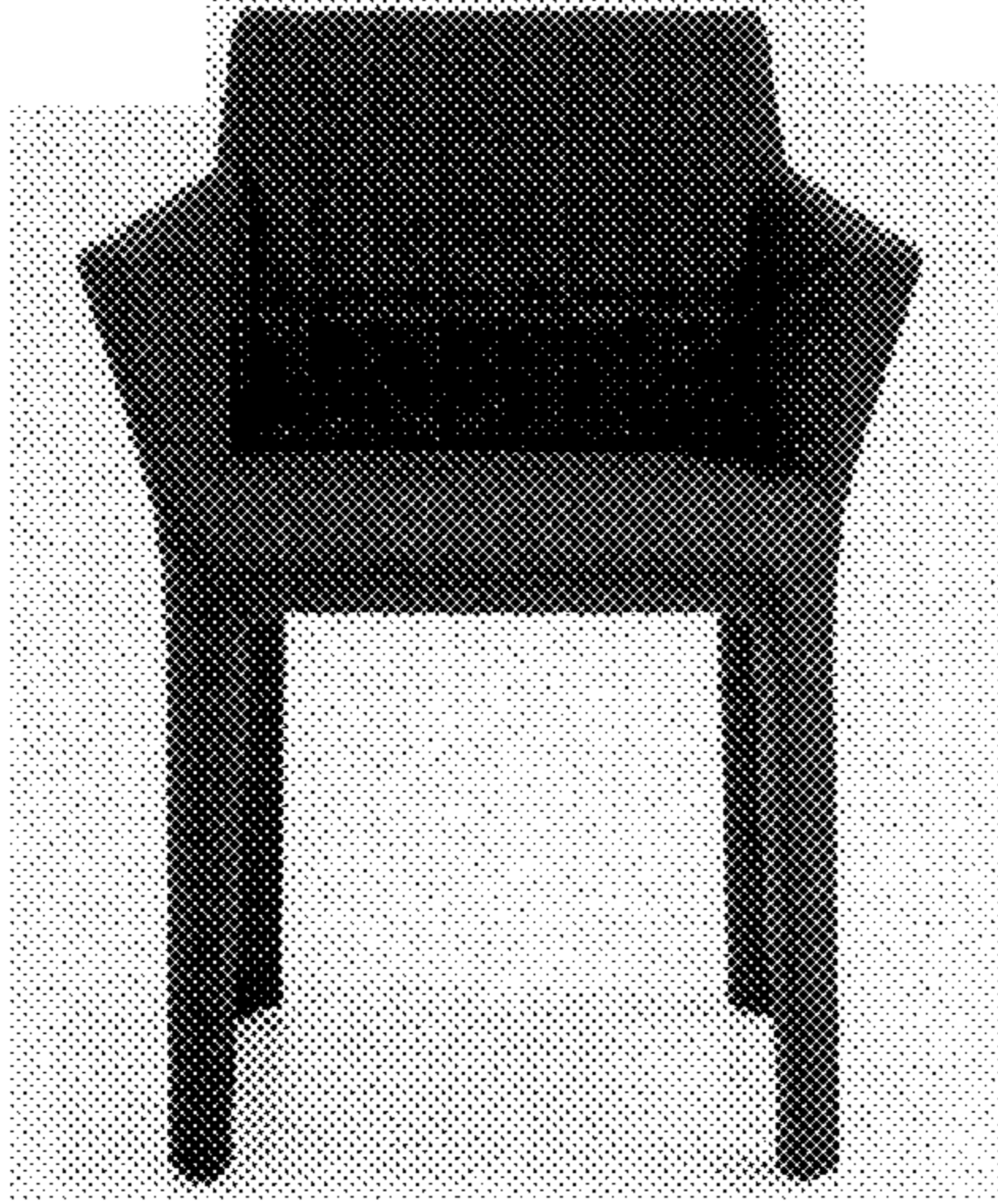

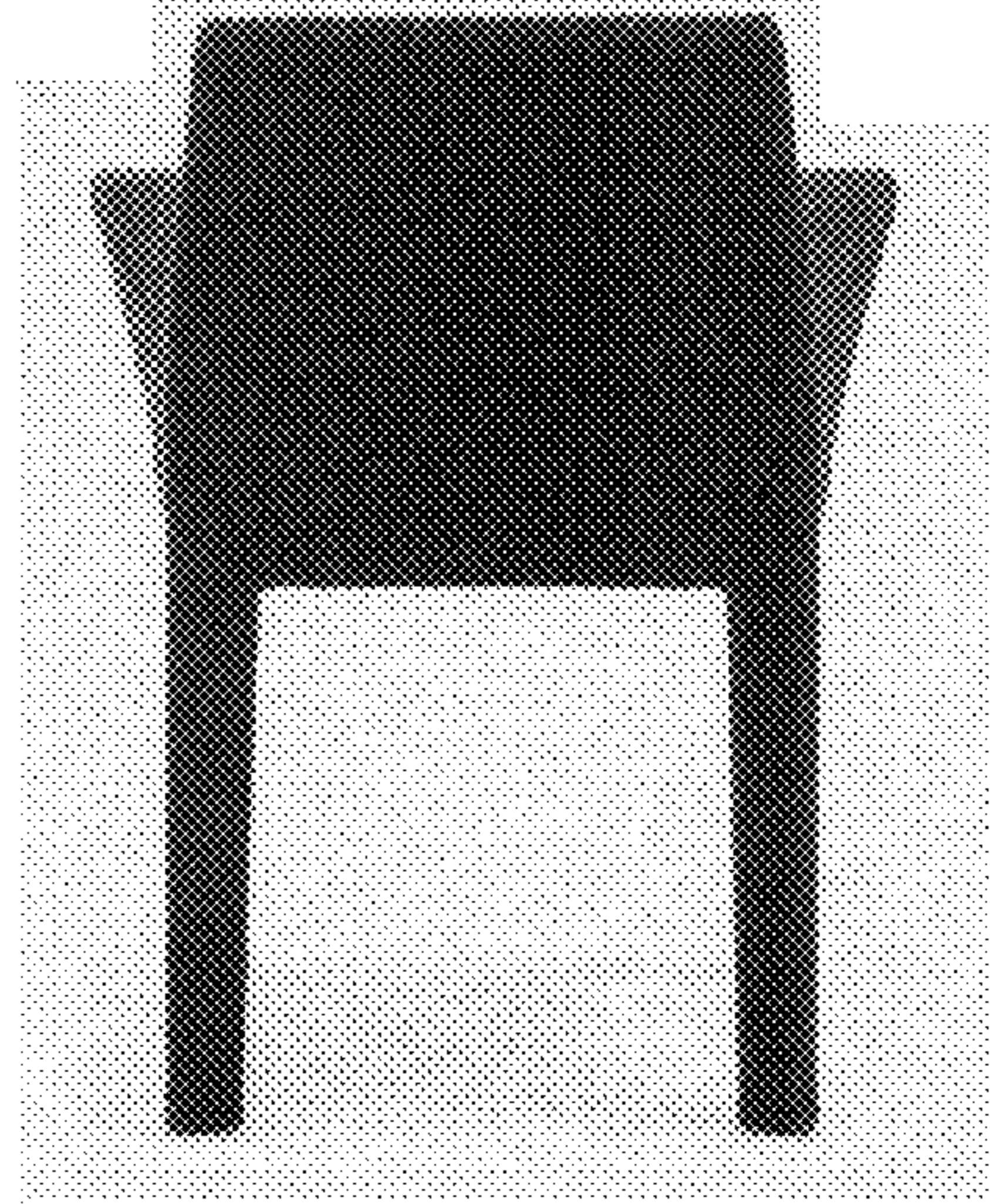

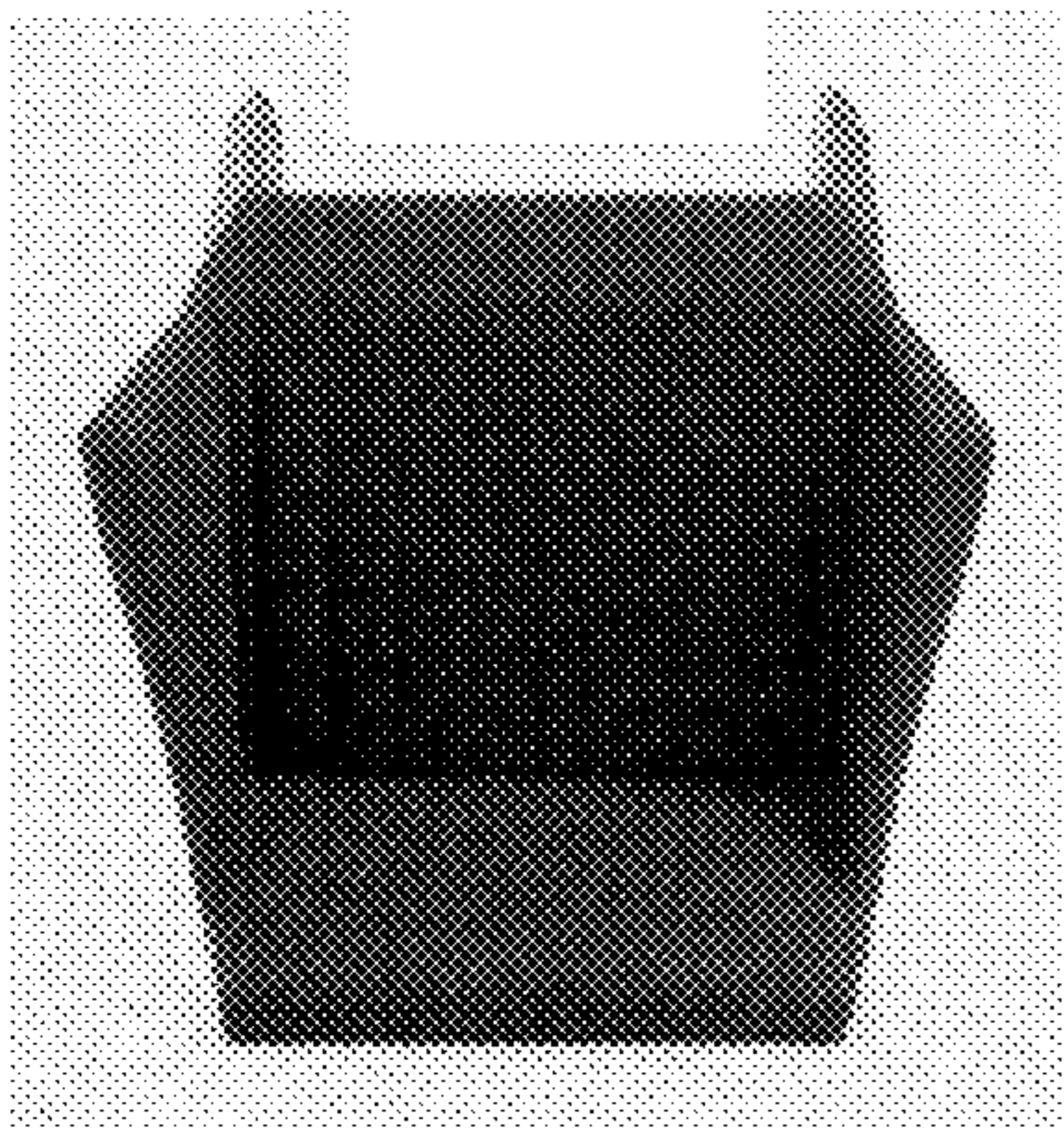

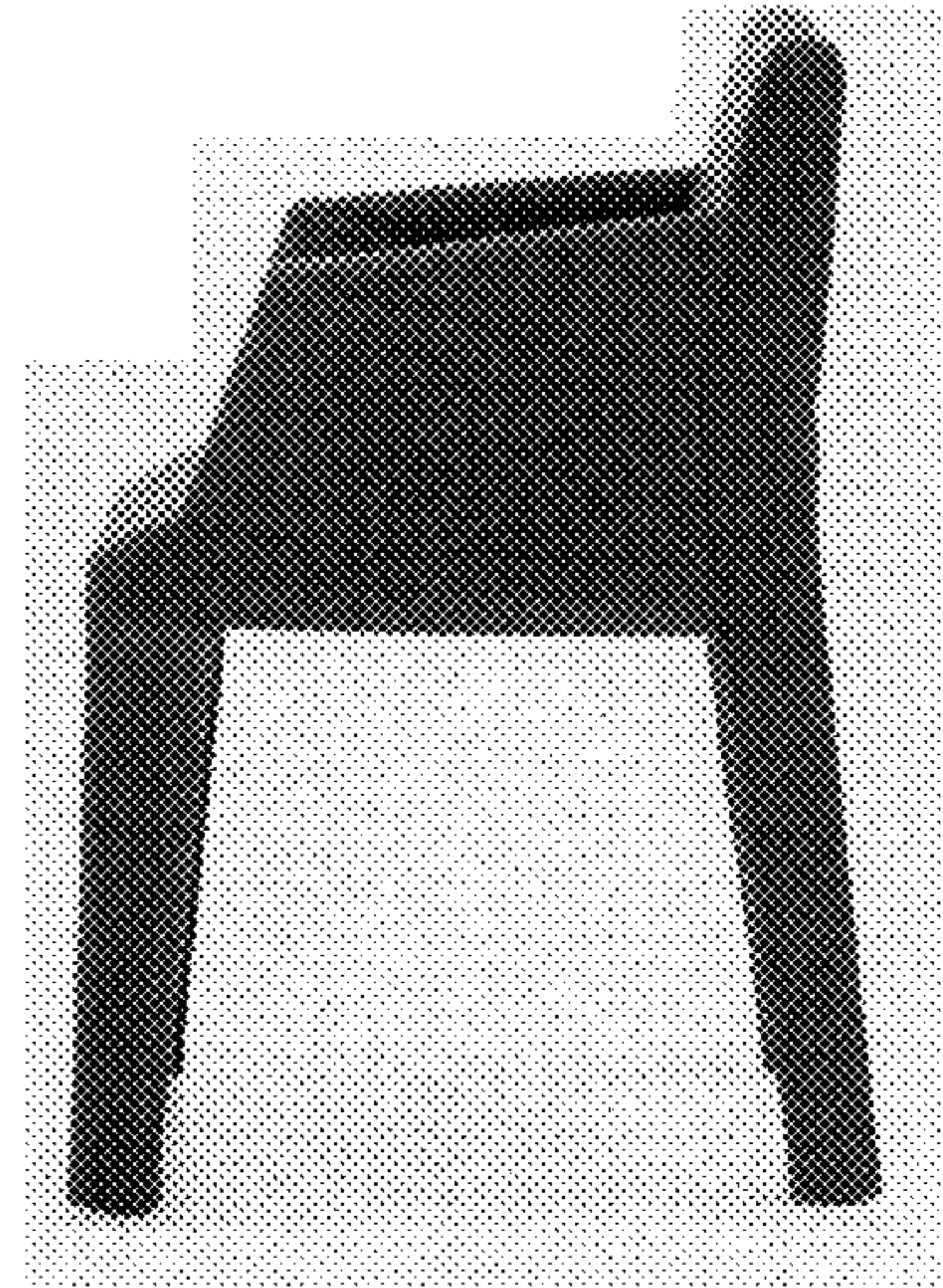
