DESCRIPTION

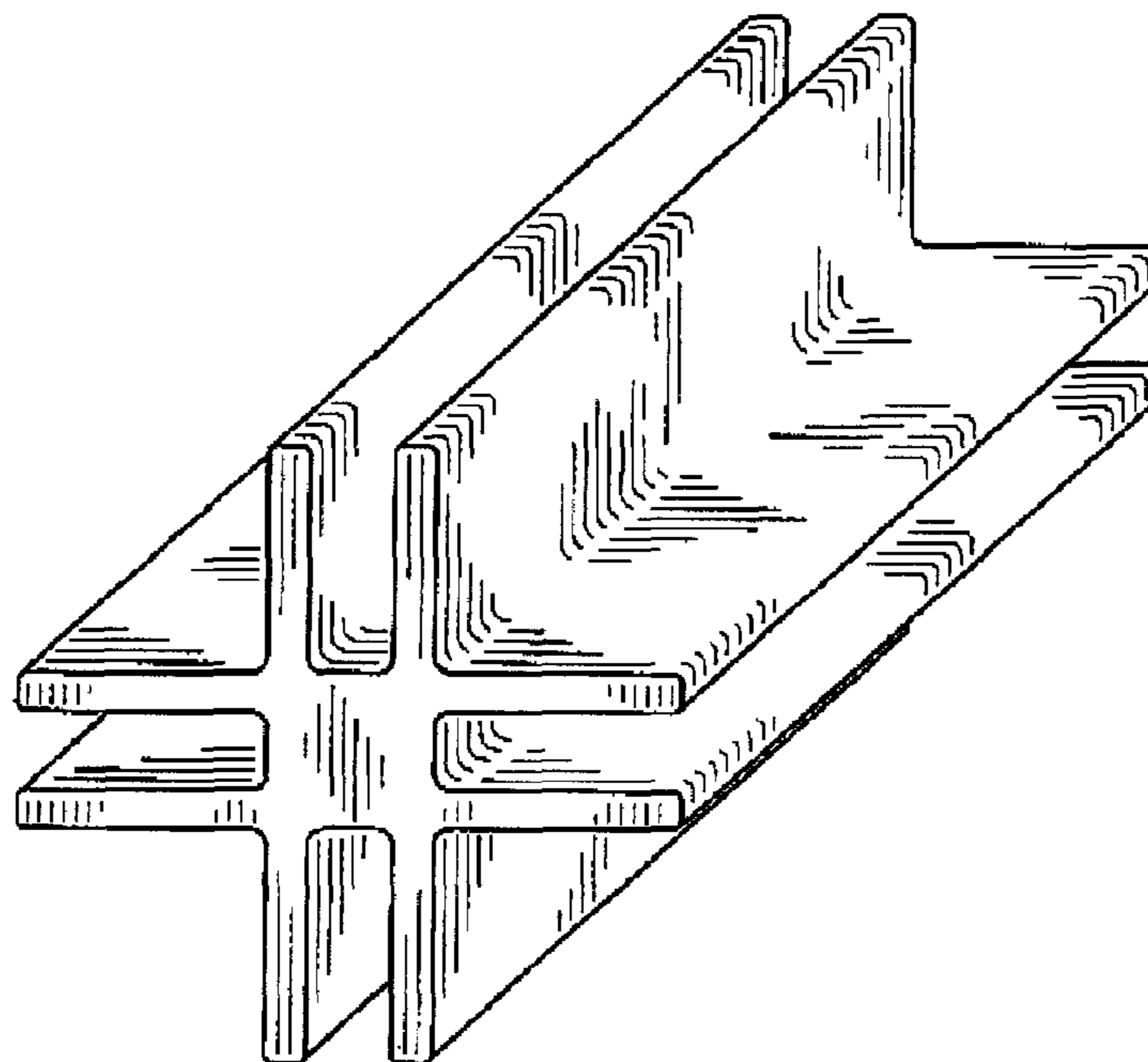
FIG. 1 is a front view of the section, the rear view being identical;

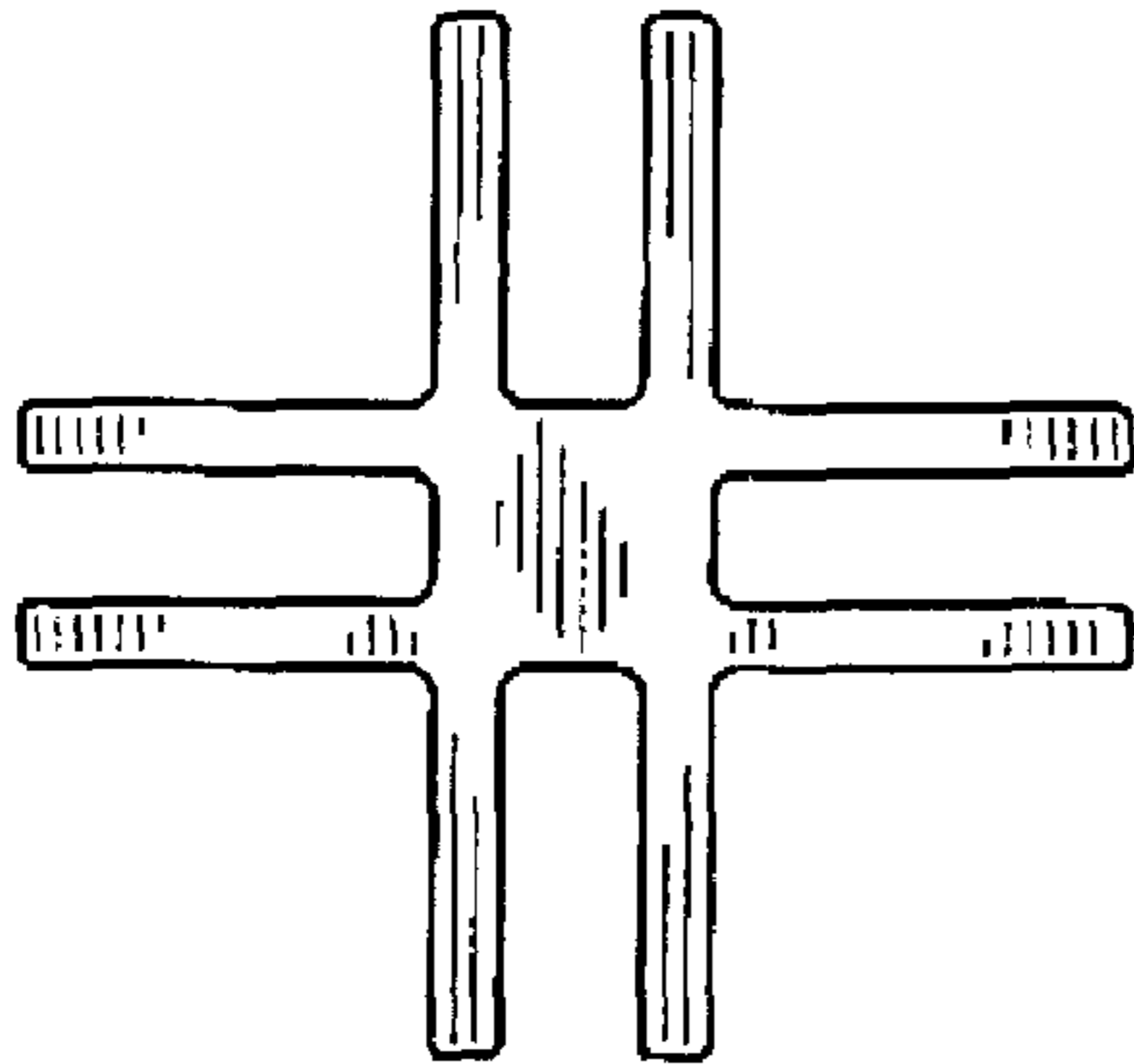

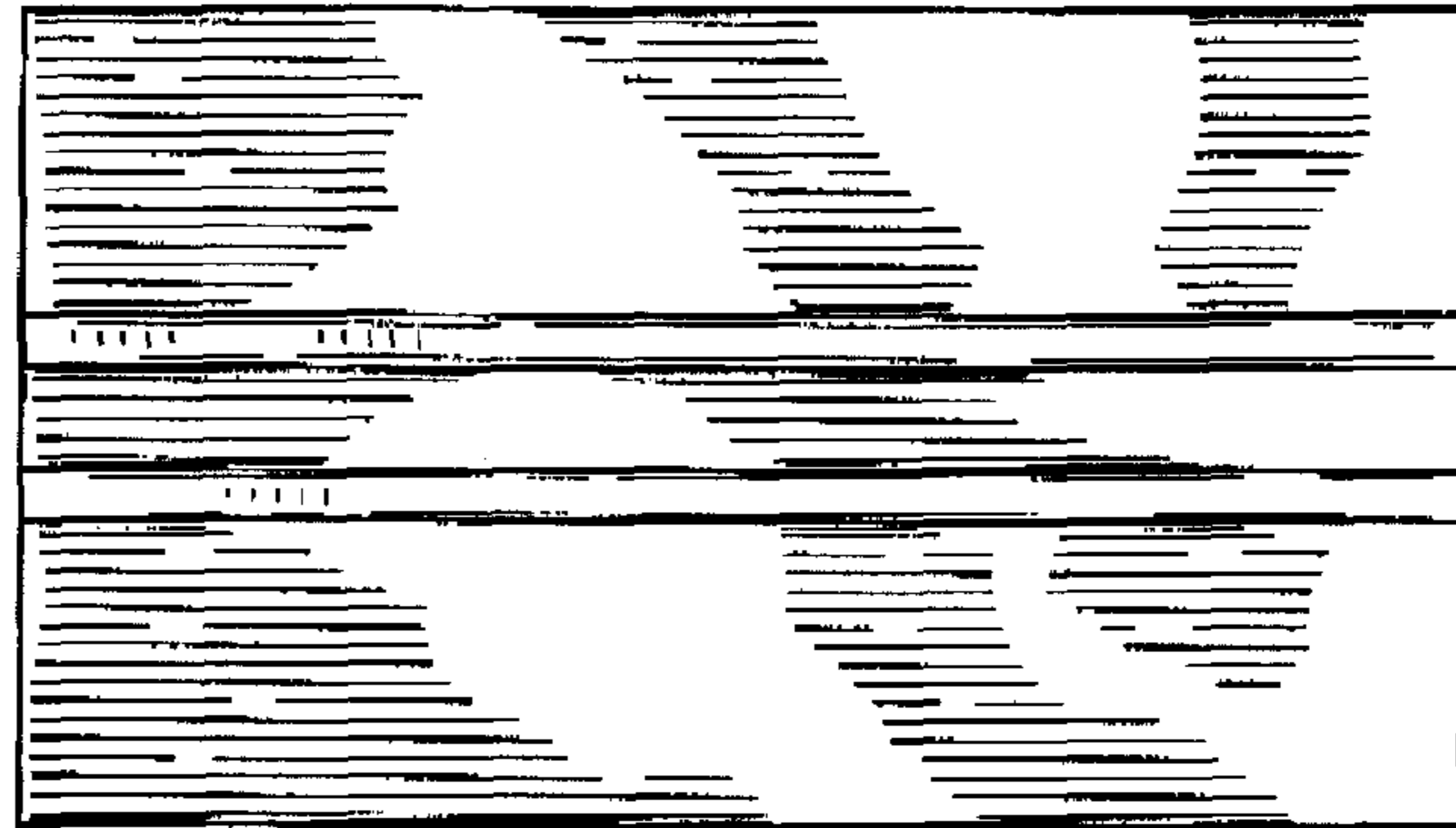

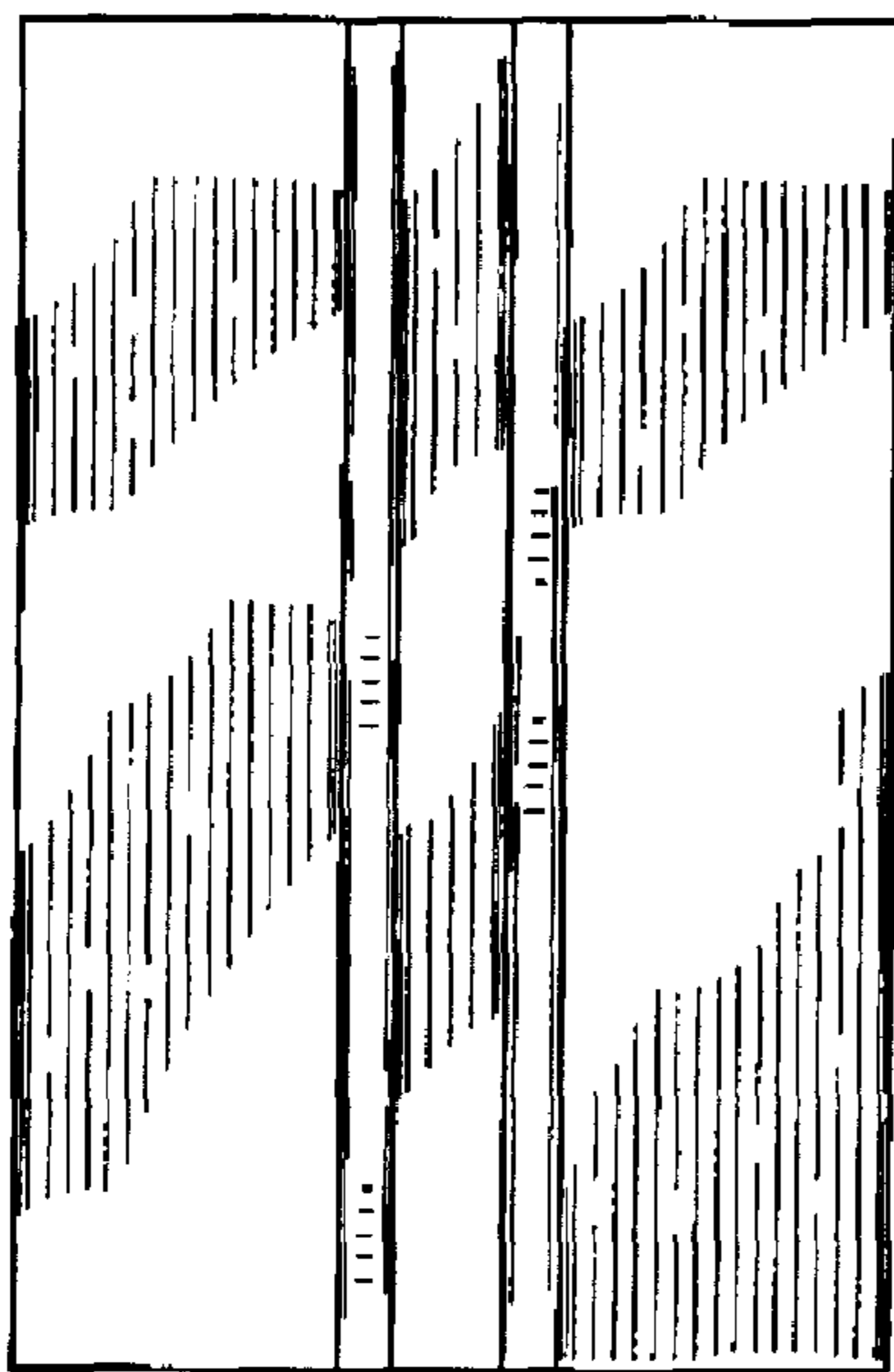

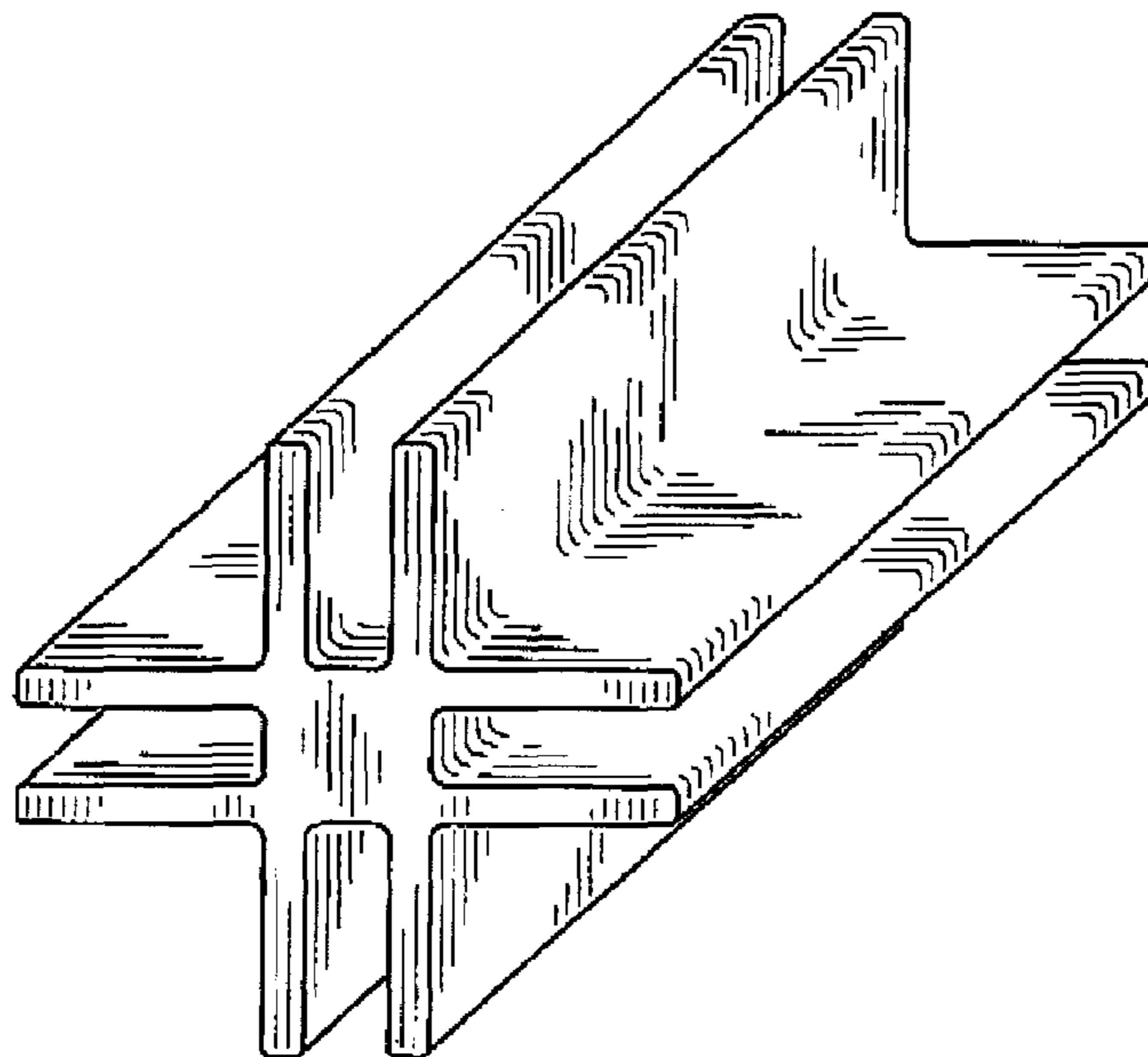
