(57) **CLAIM**

The ornamental design for a base unit, as shown and described.

**DESCRIPTION**

In a preferred embodiment the nature of this product is as a base unit that facilitates heating a portion of a container of shaving cream, lotion or other personal care liquid.

FIG. 1 is a right, top, frontal perspective view of a base unit embodying our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a view similar to FIG. 1, but of a second embodiment;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

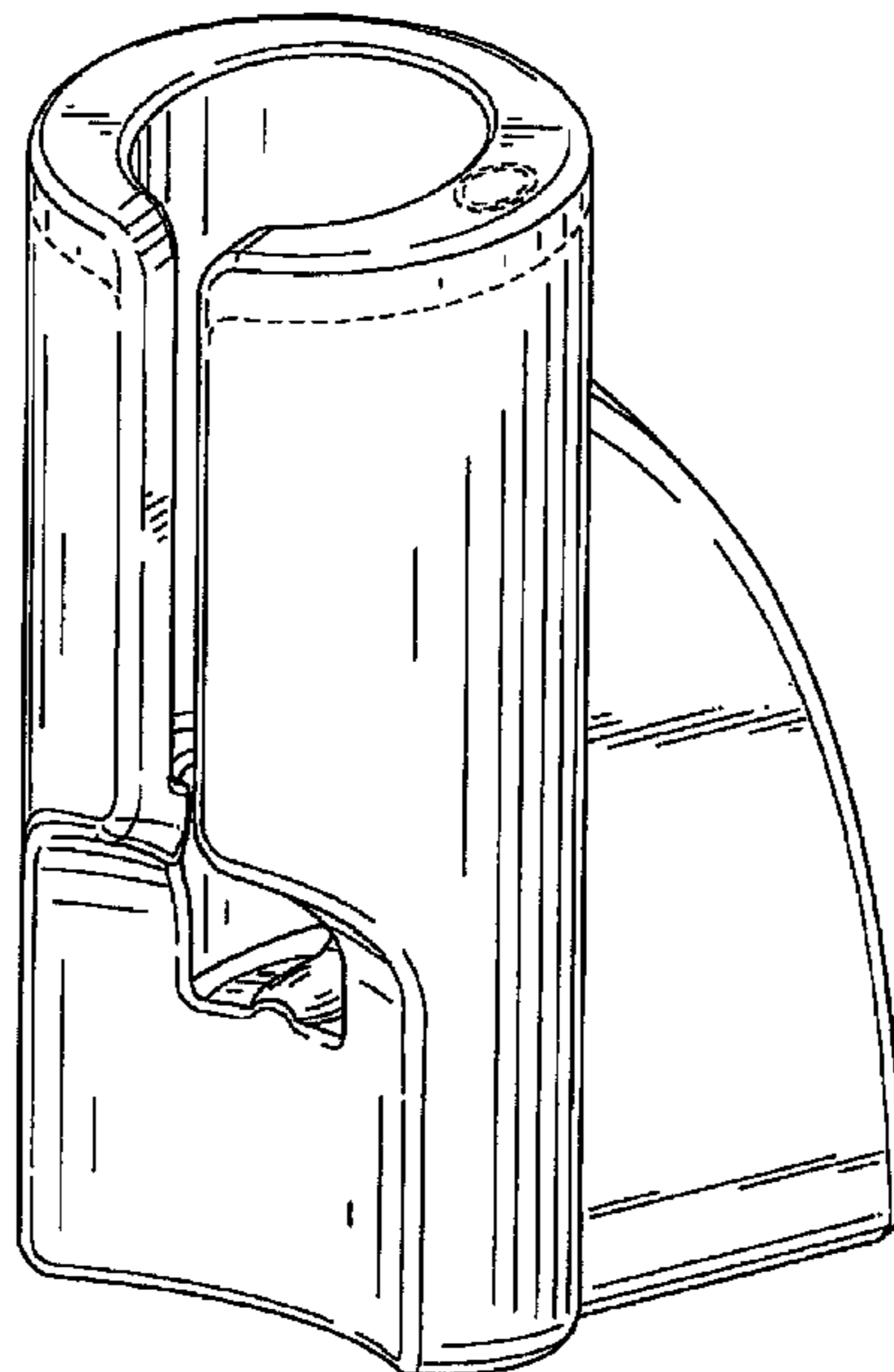
FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof; and,

FIG. 12 is a rear elevational view thereof.

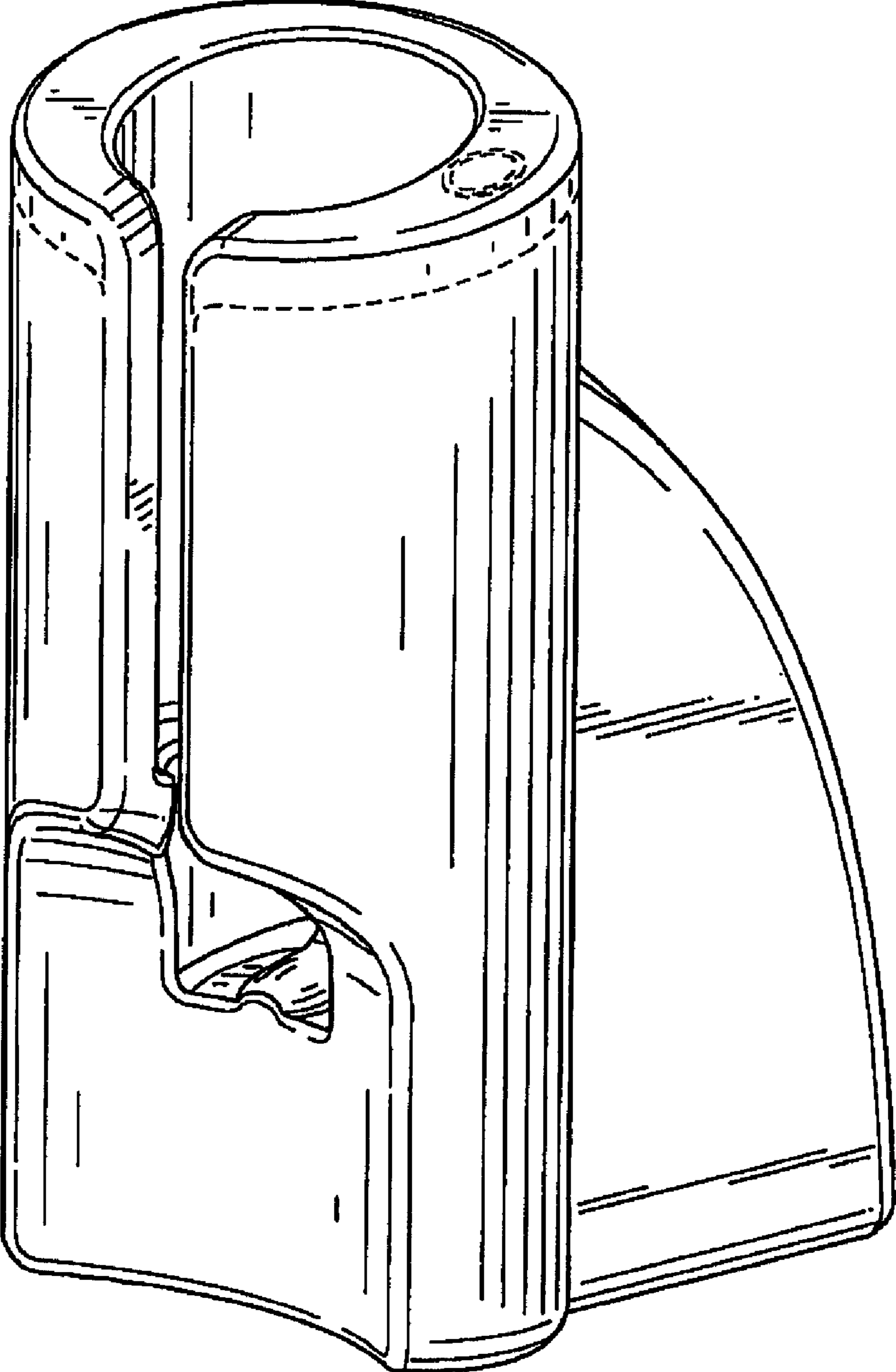

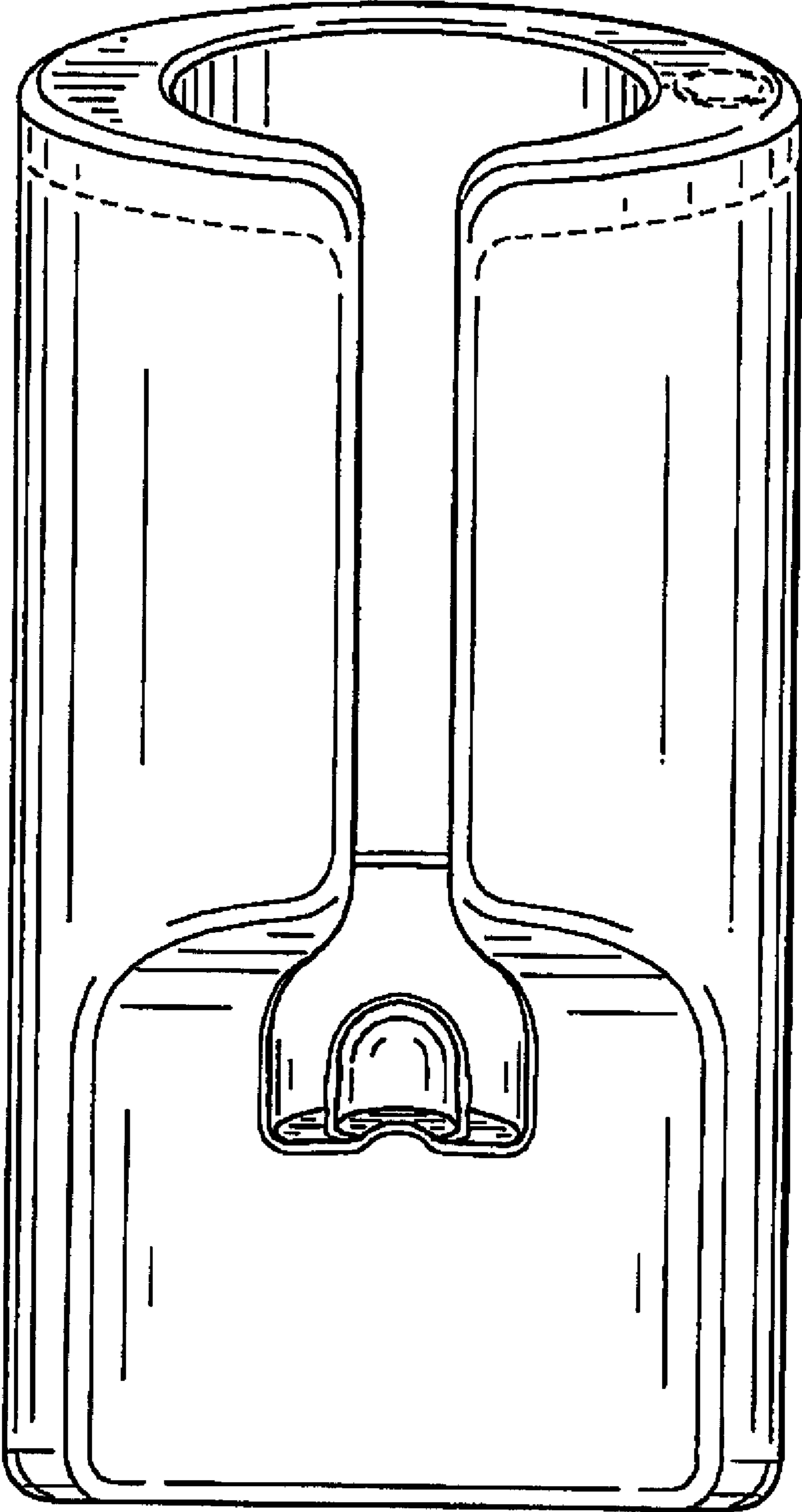

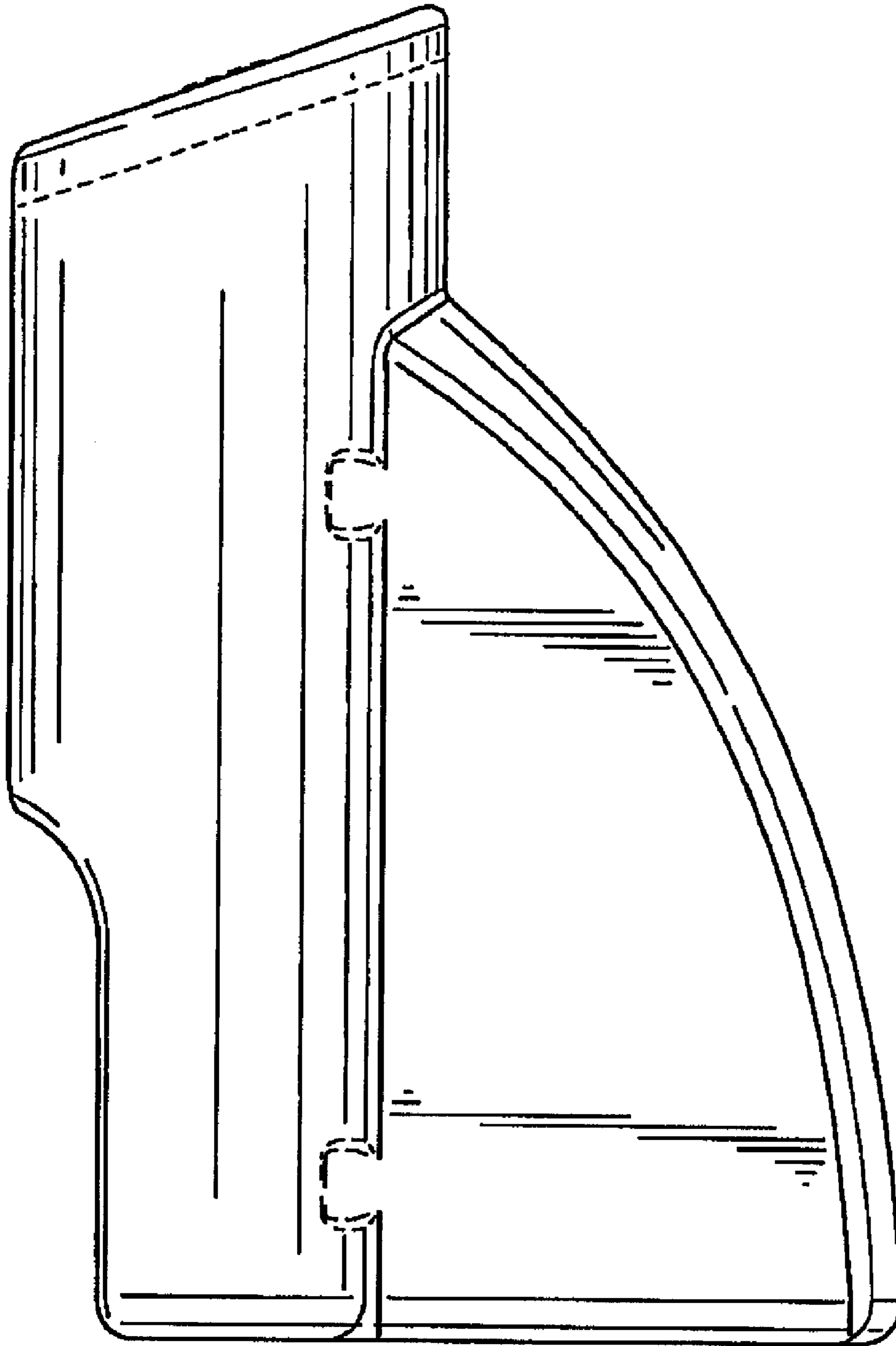

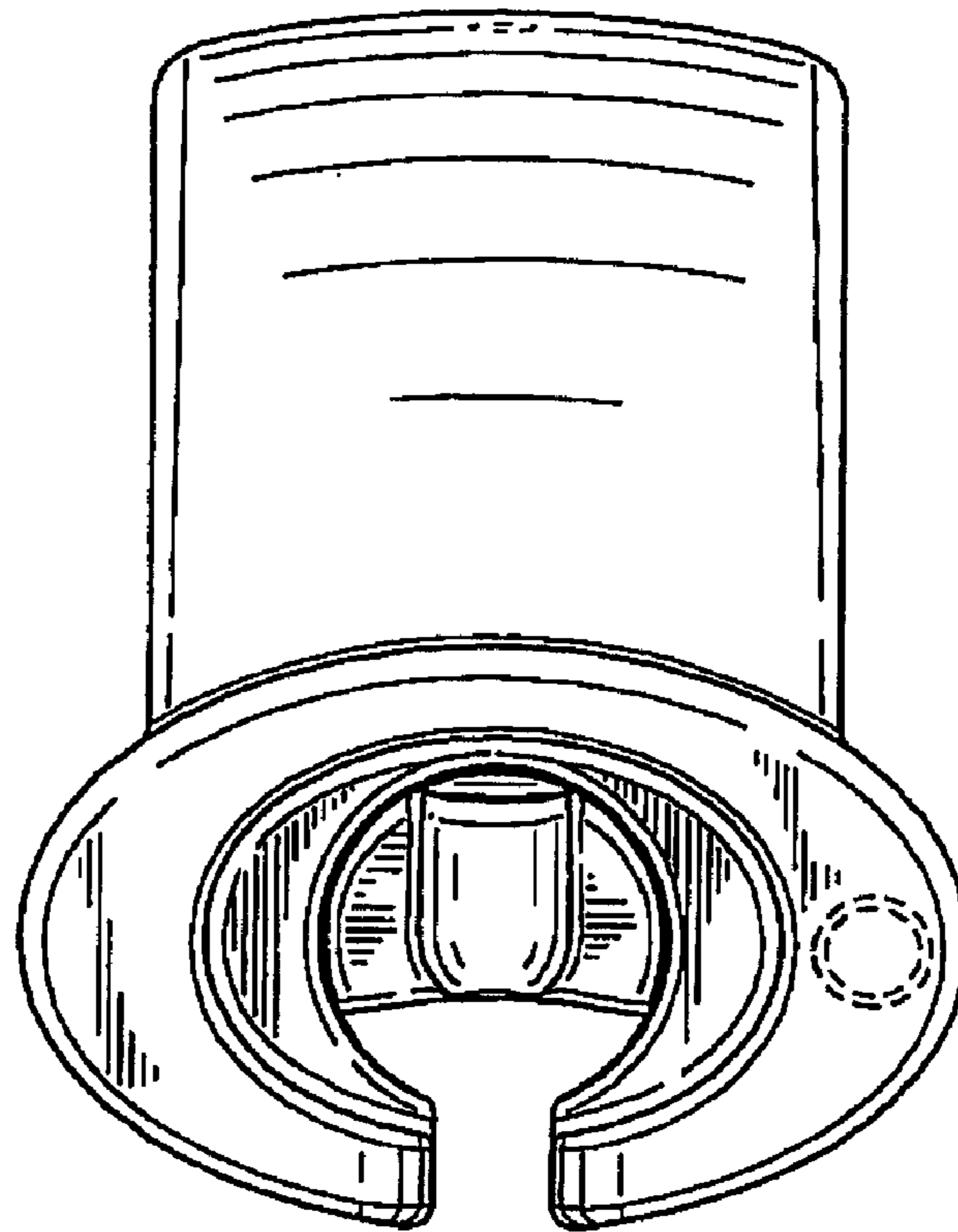
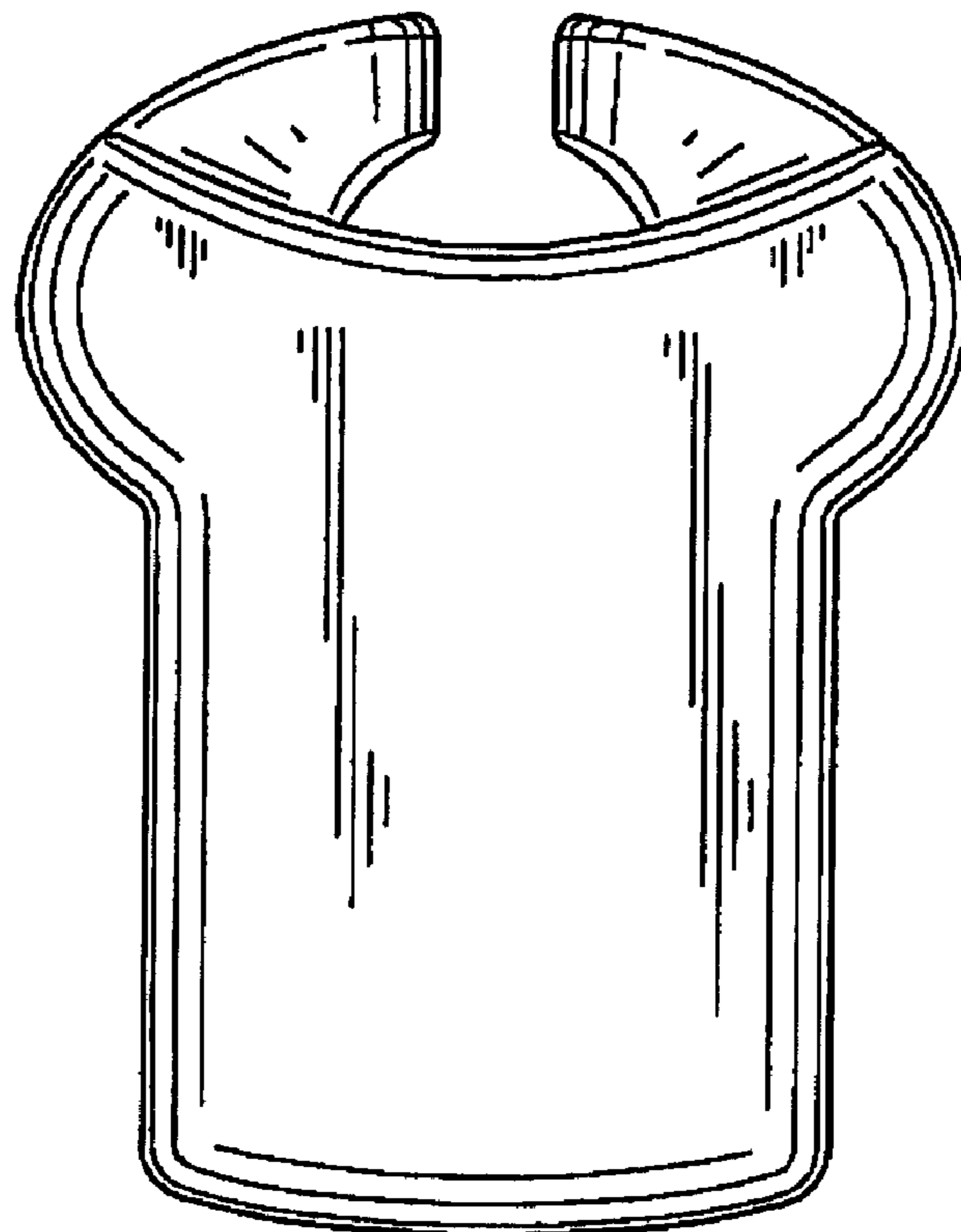

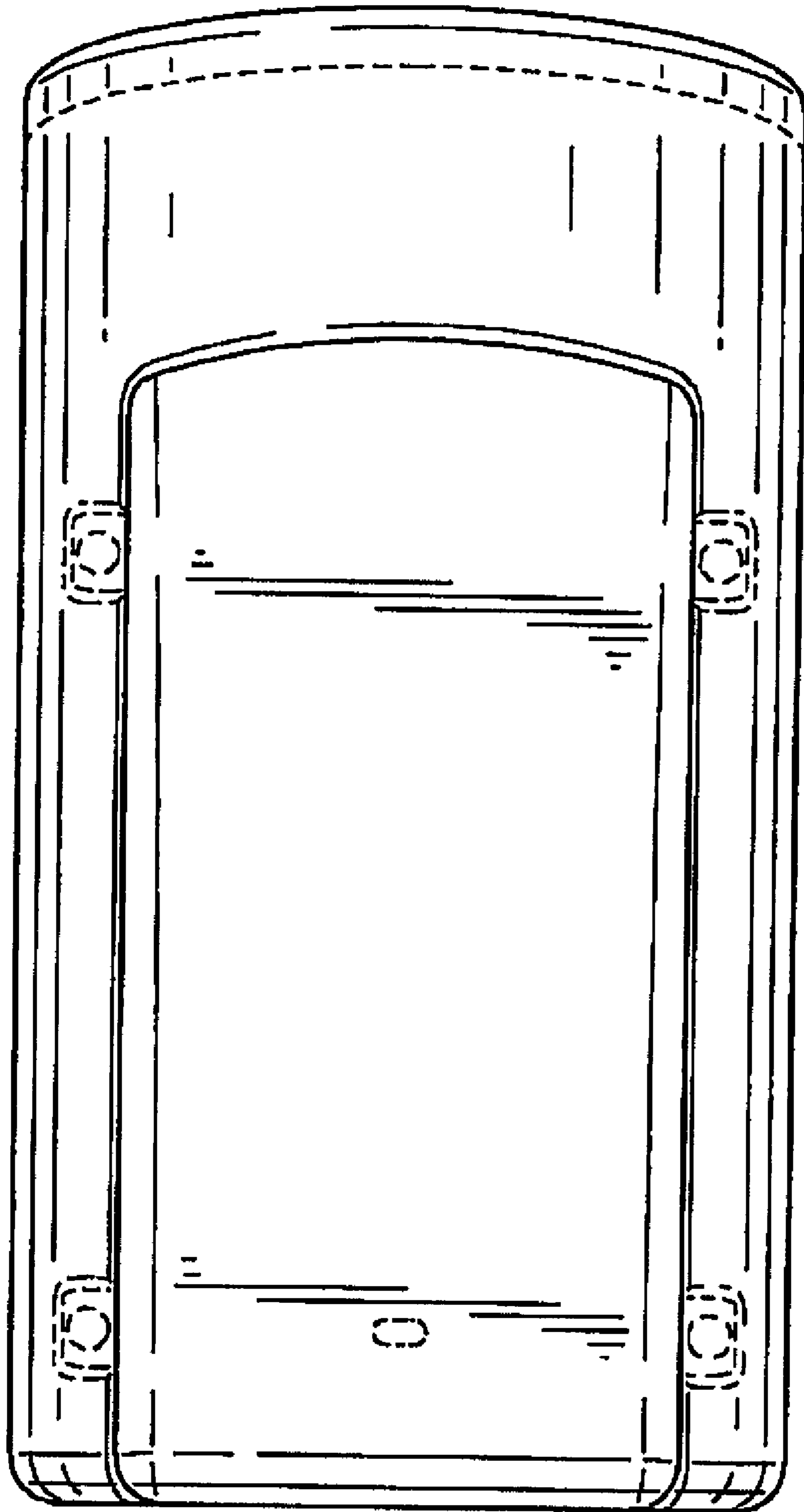

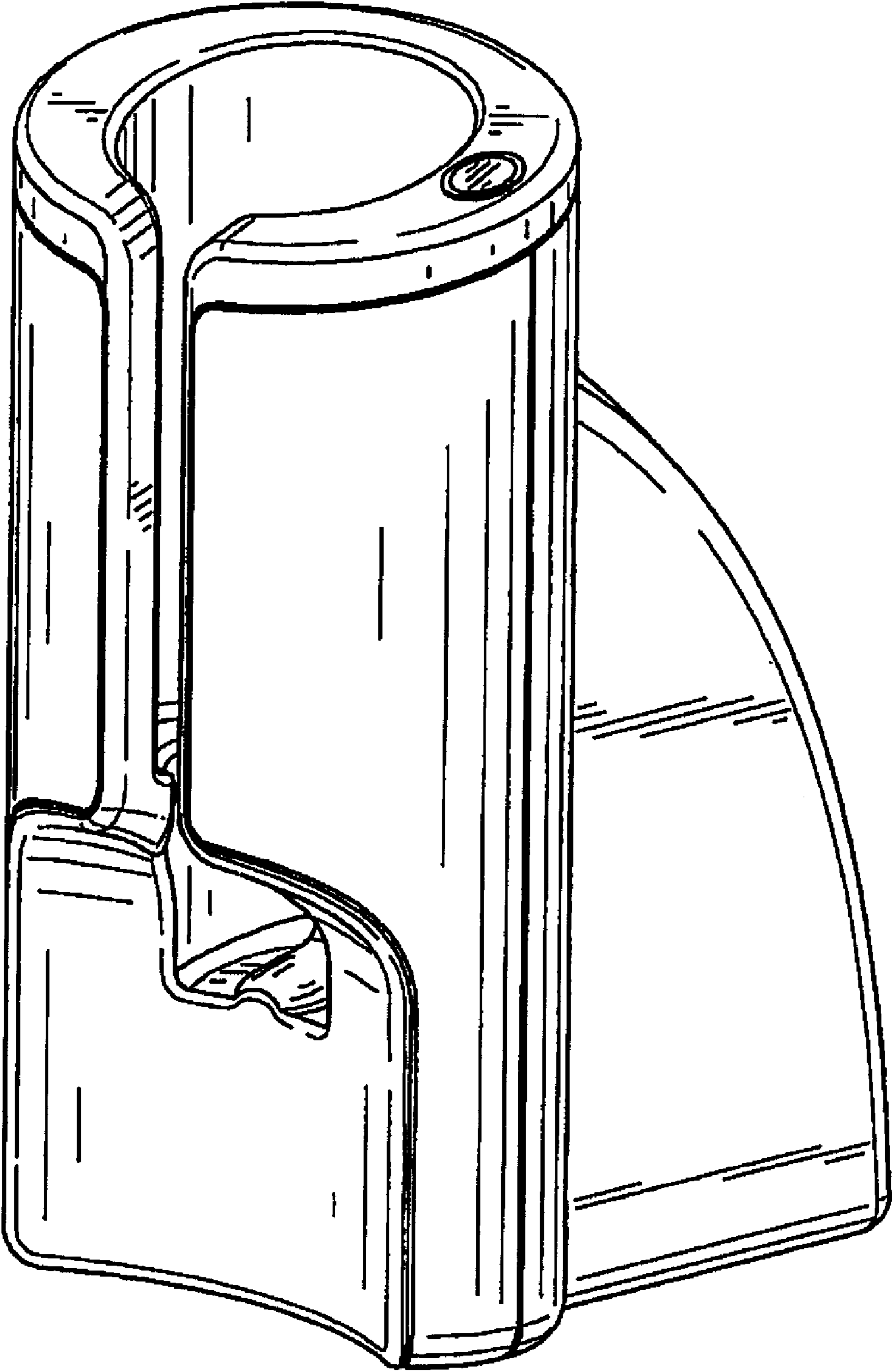

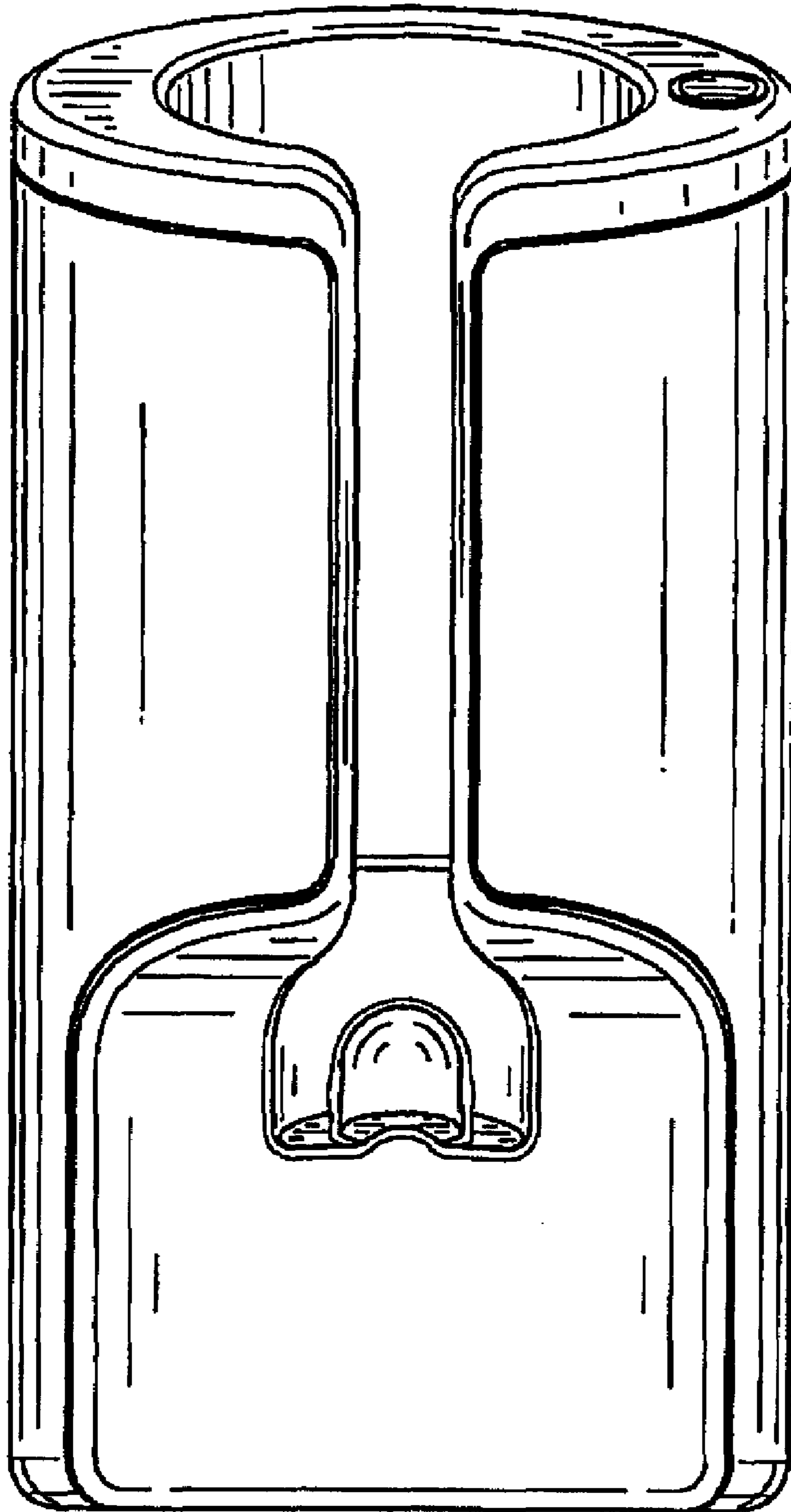

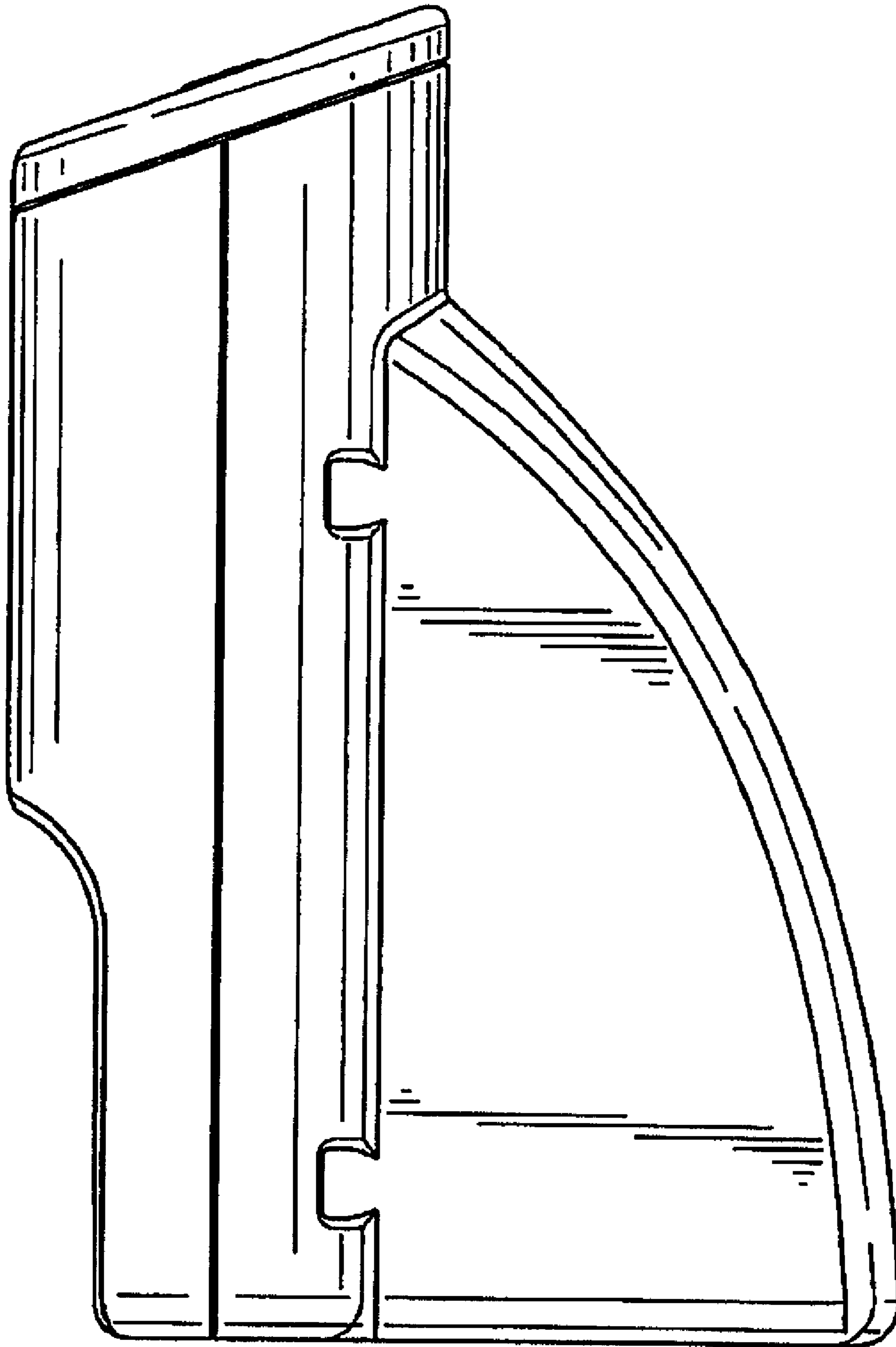

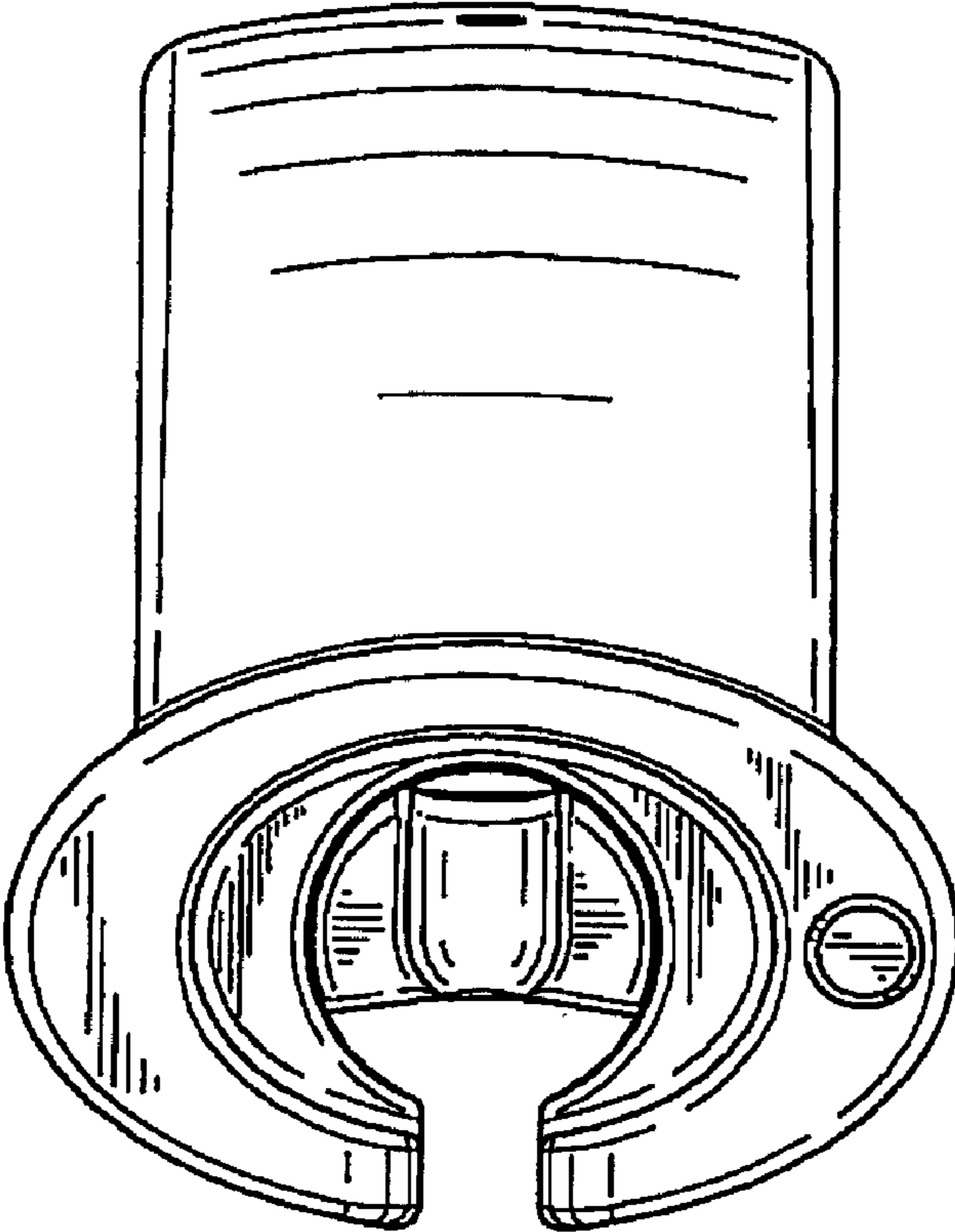
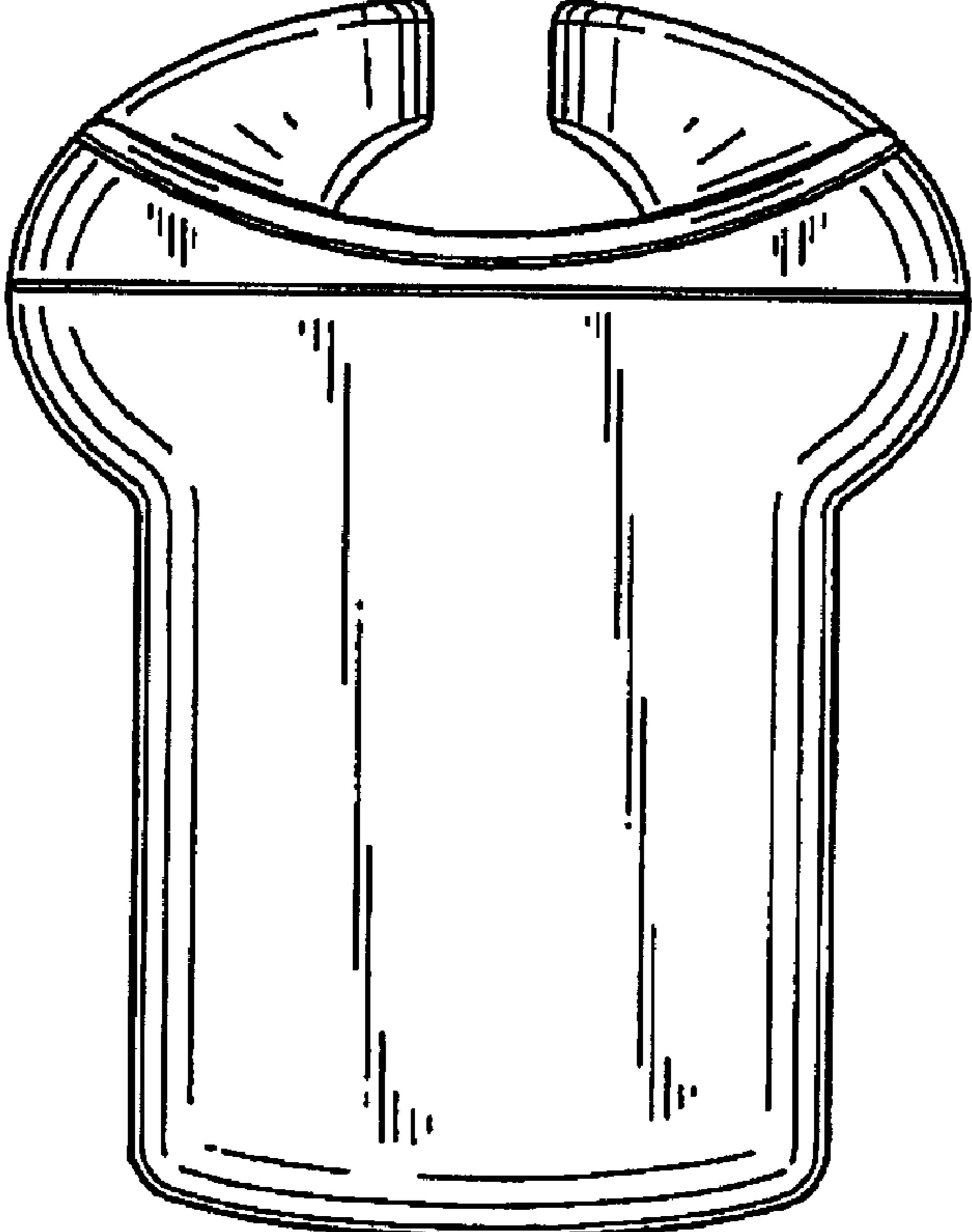

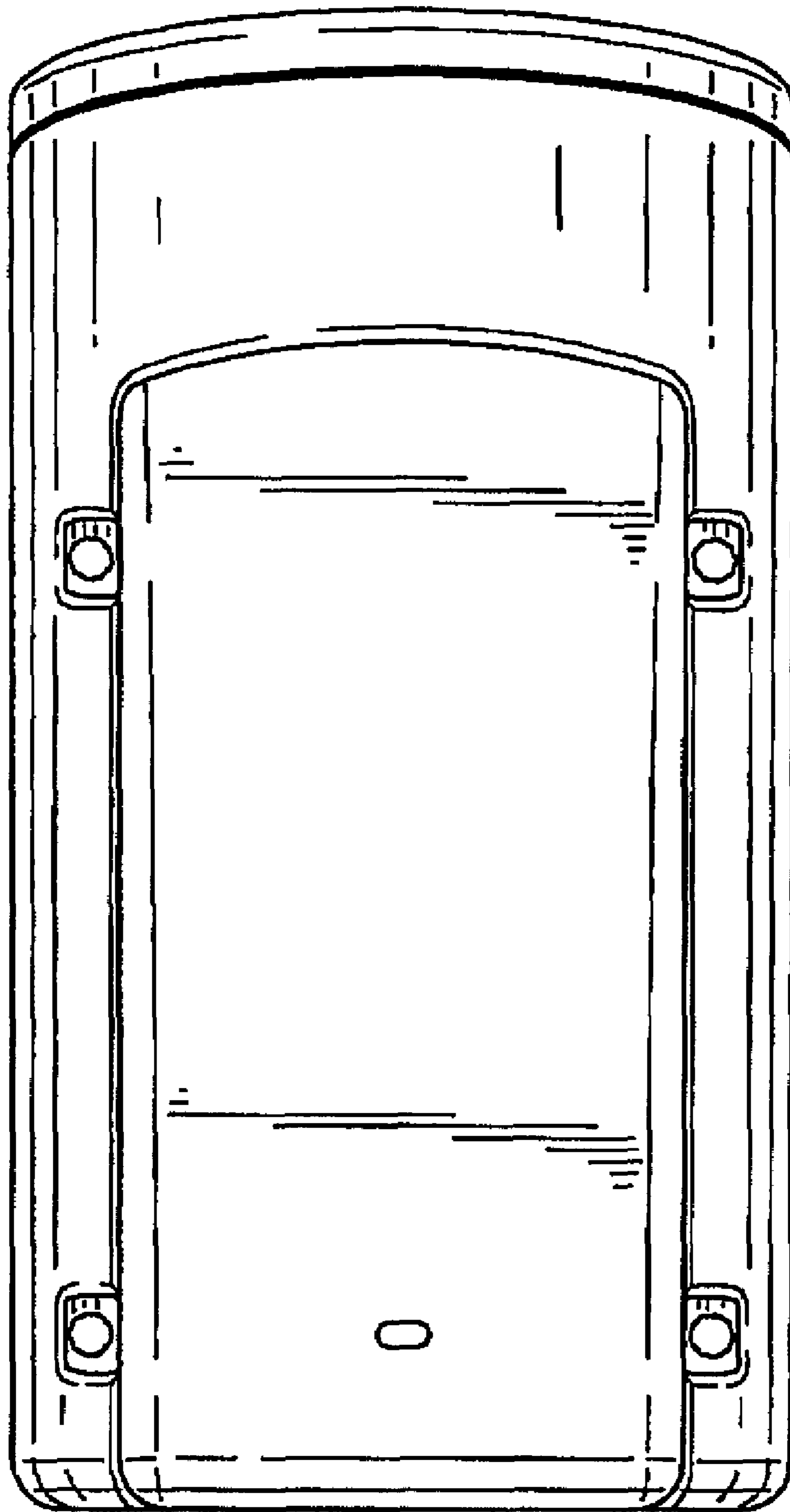
