FIG. 5 is a right side elevational view showing my ornamental design for a plant marker, the left elevational view being a mirror image of the right side;

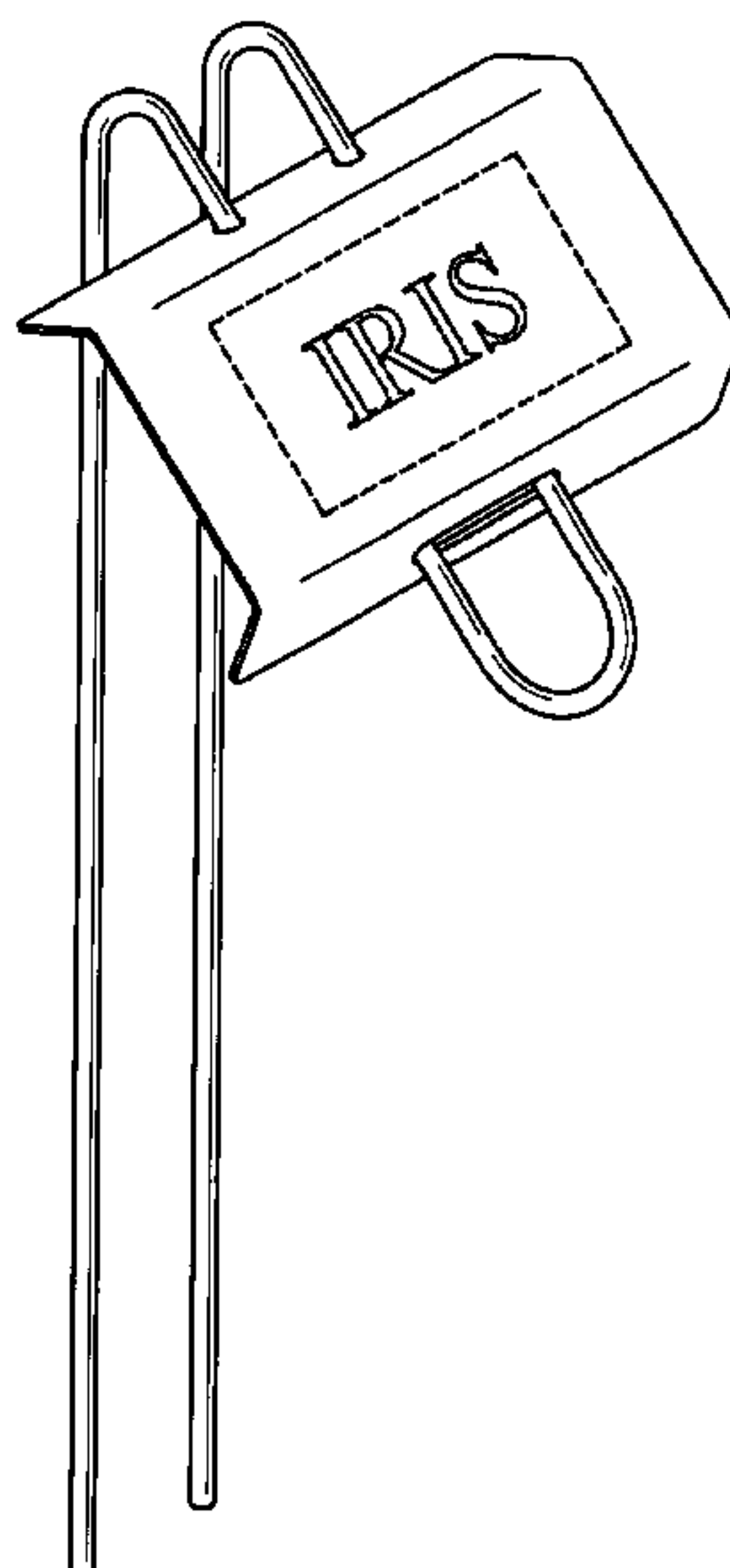
FIG. 6 is a top plan view showing my ornamental design for a plant marker; and,

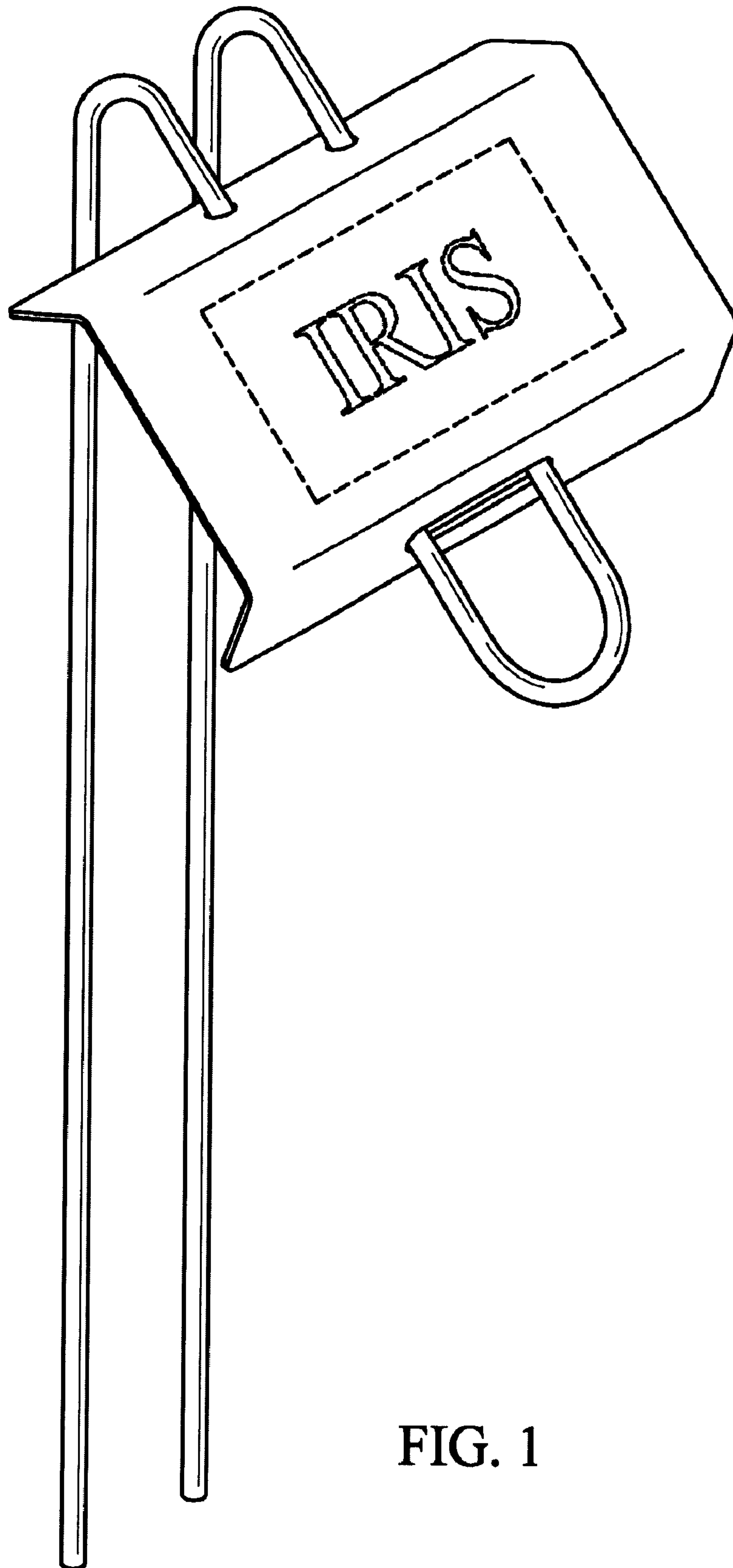

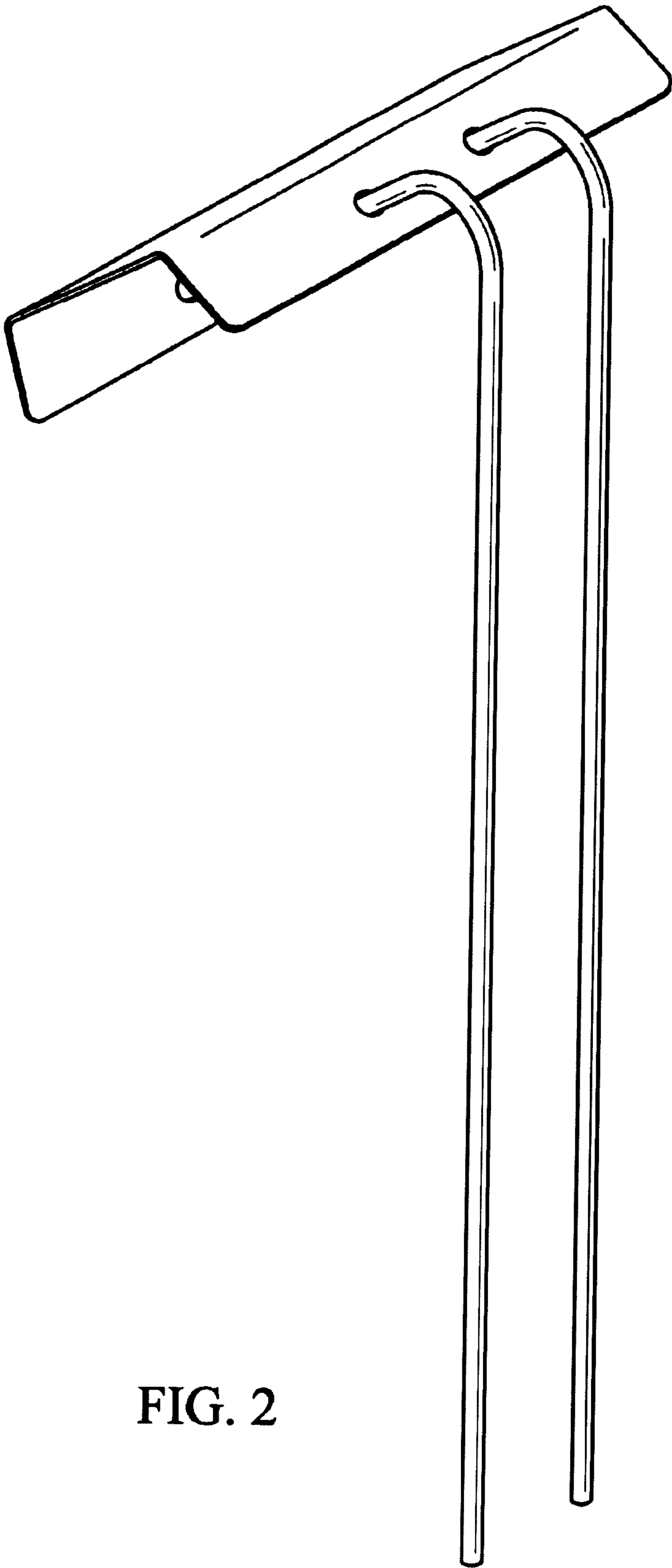

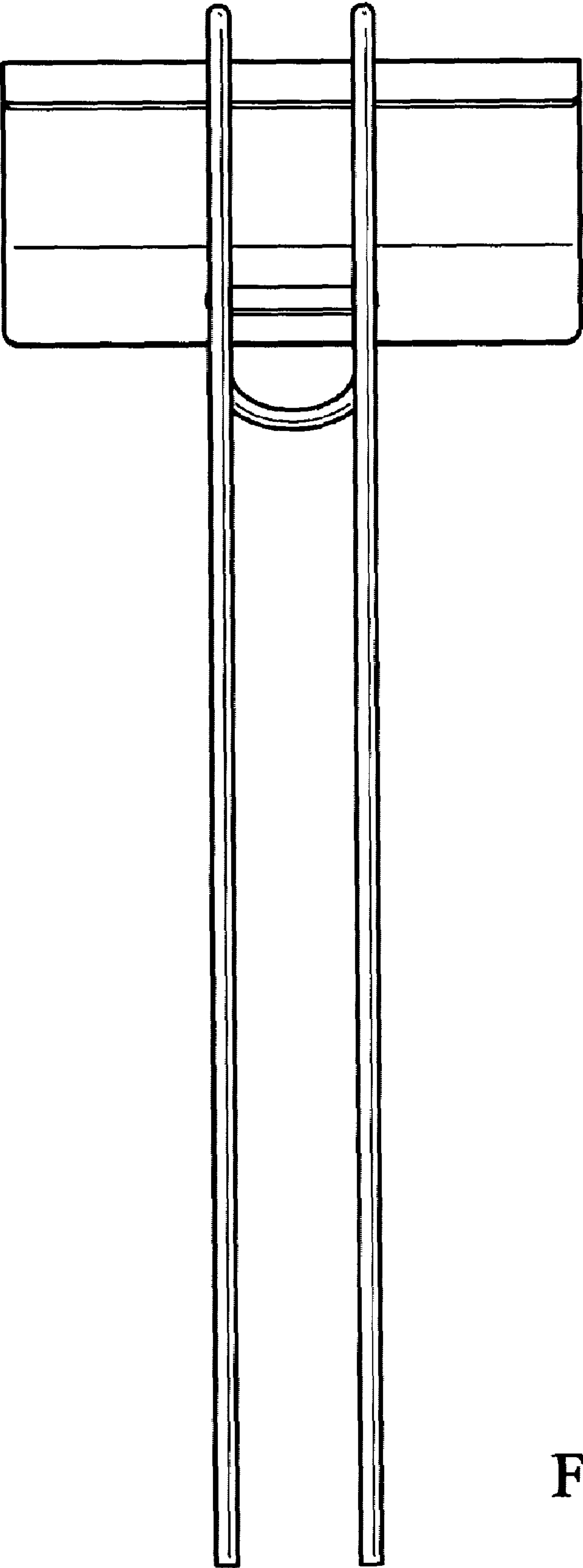

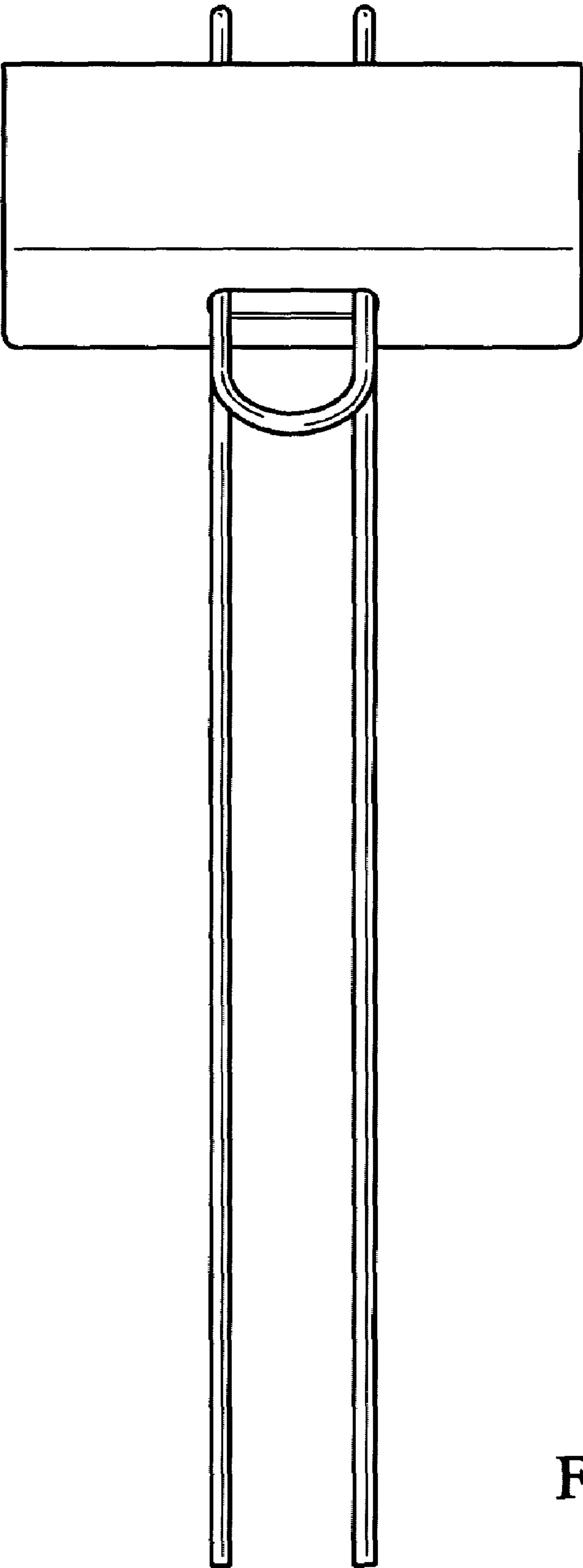

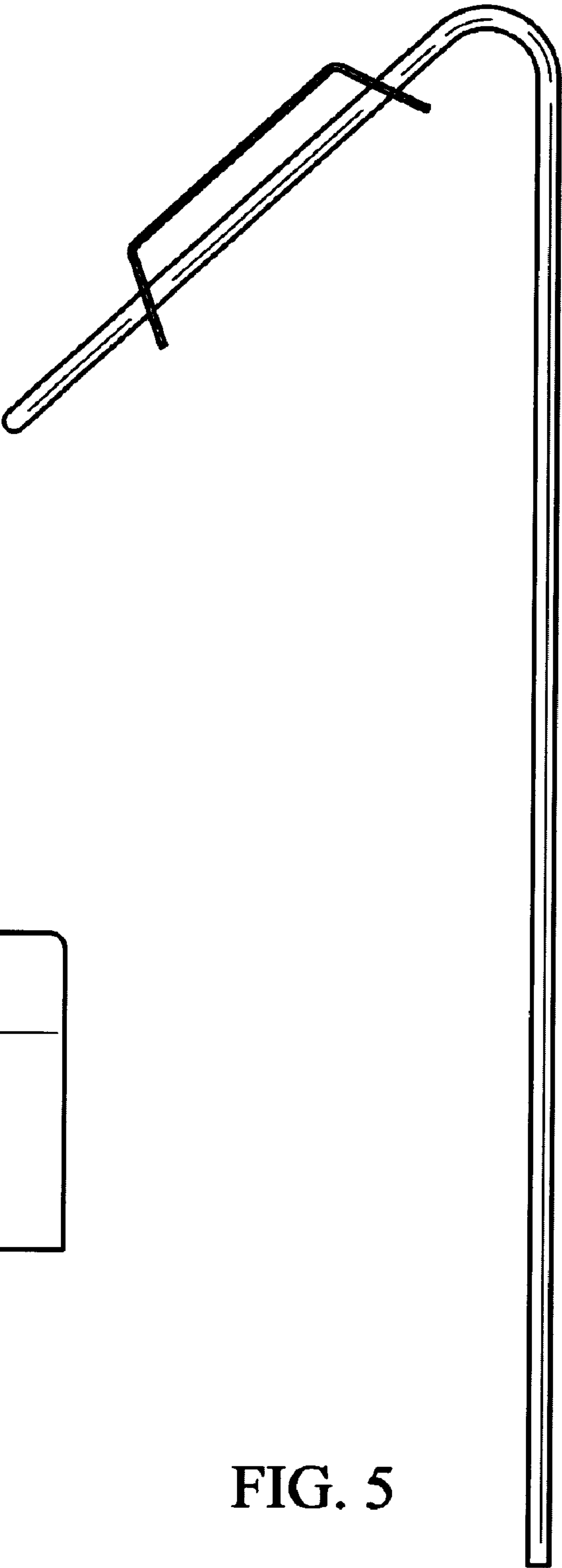

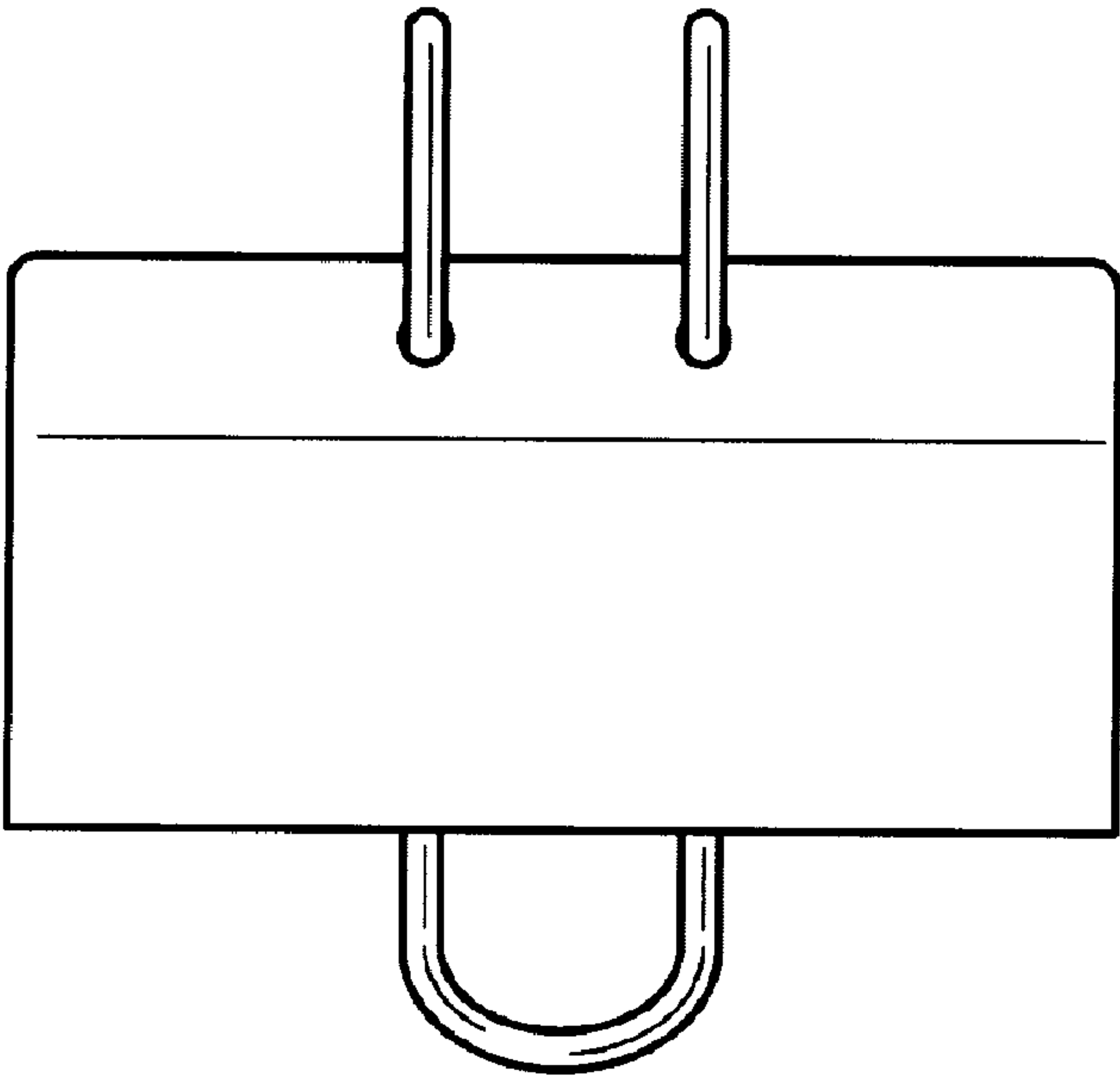

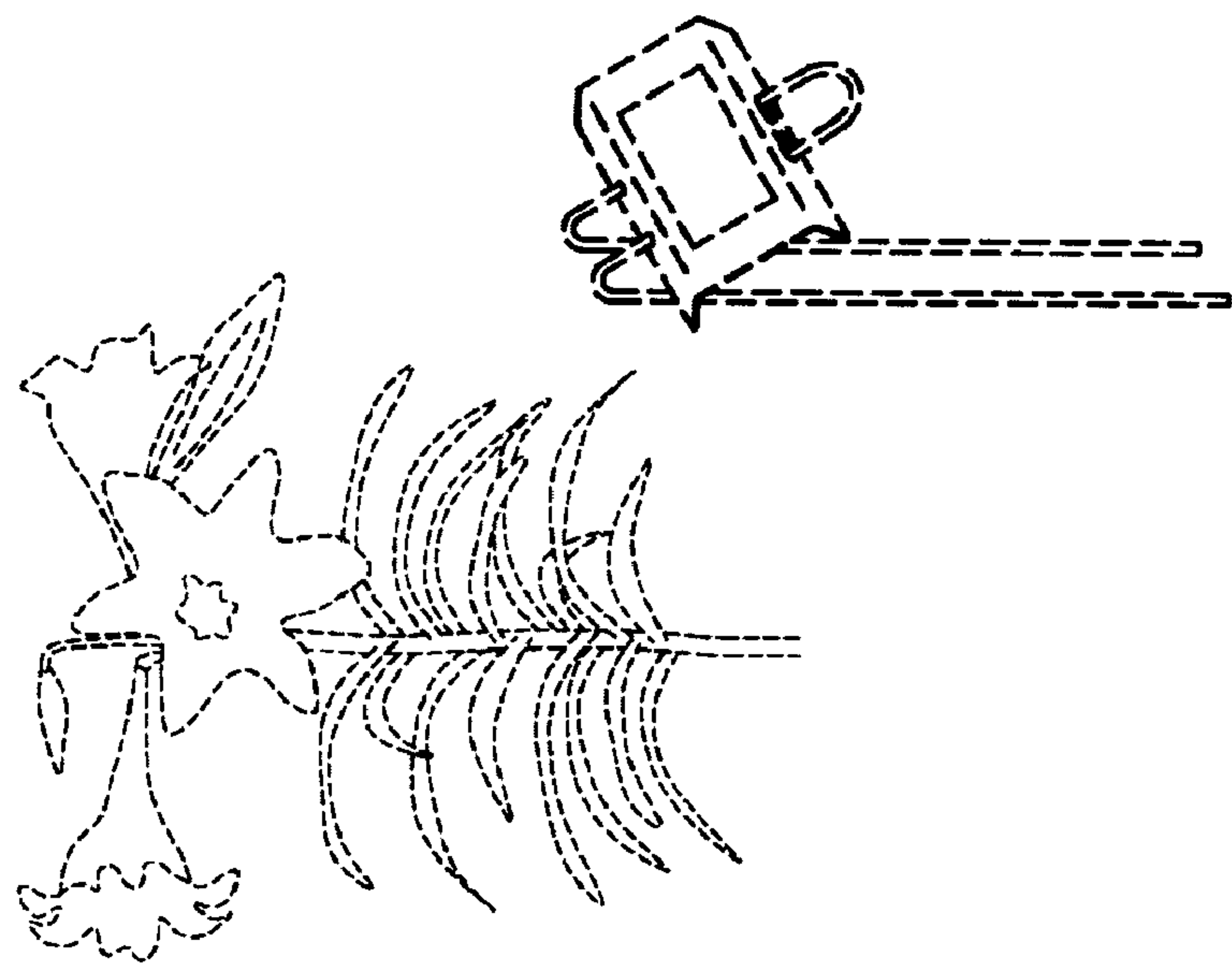
