The ornamental design for a graphic user interface for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a graphic user interface for a cellular phone according to our new design;

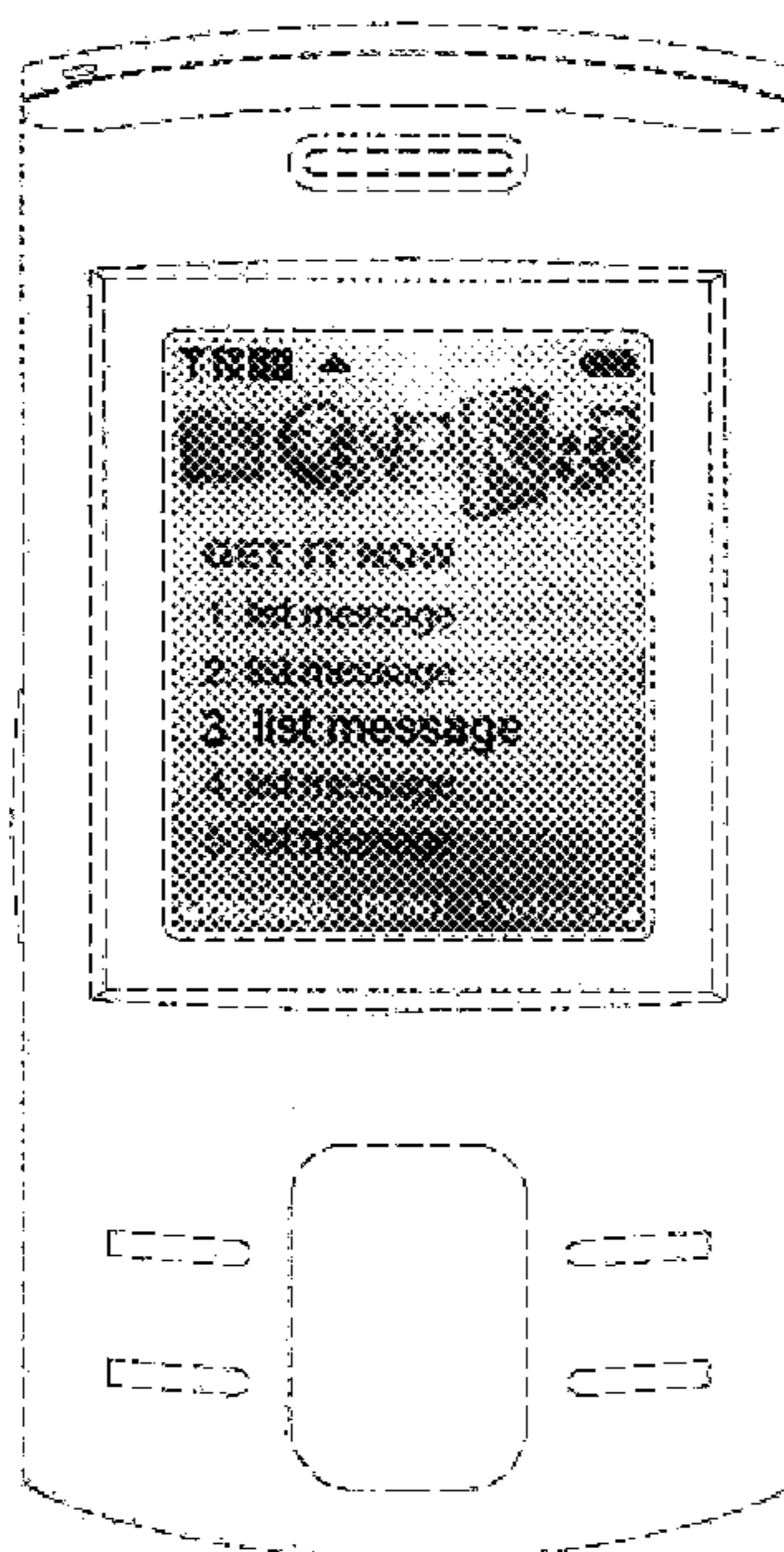

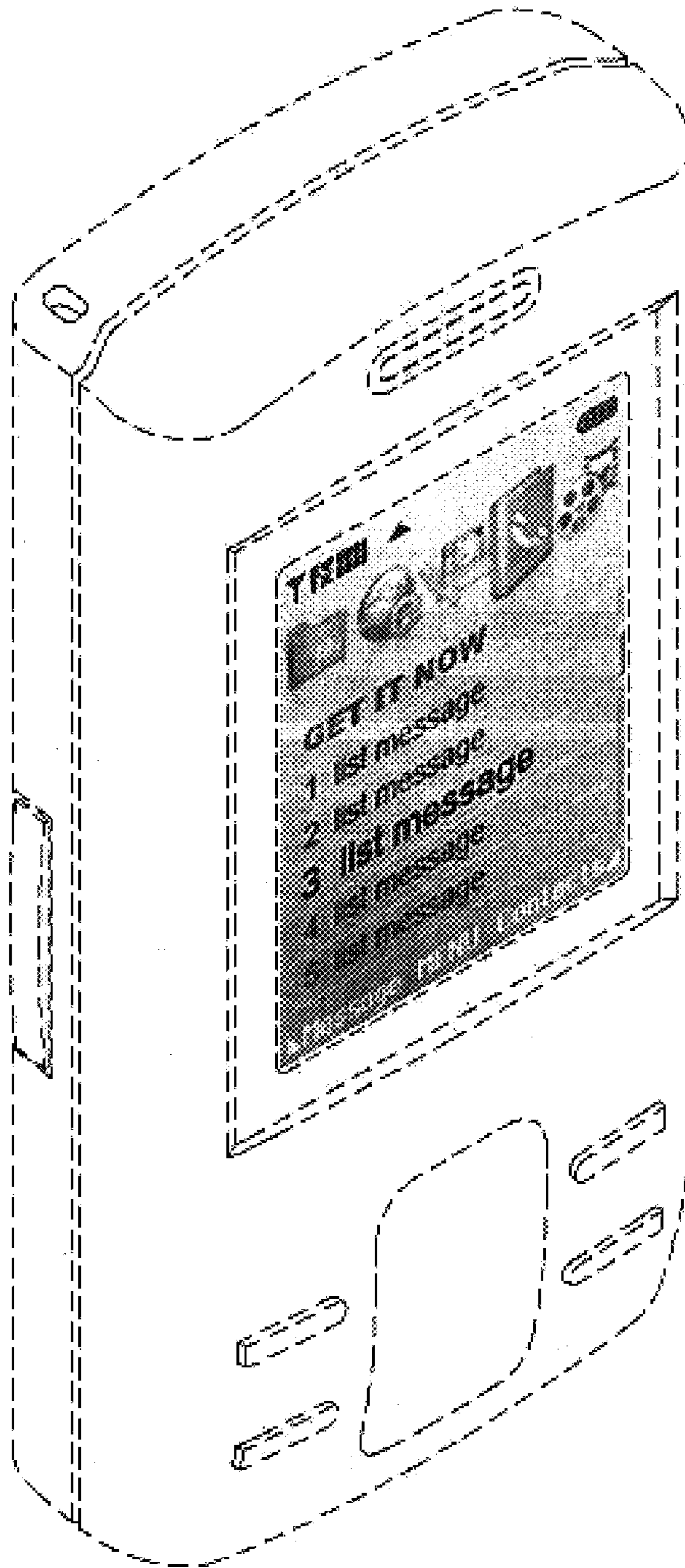

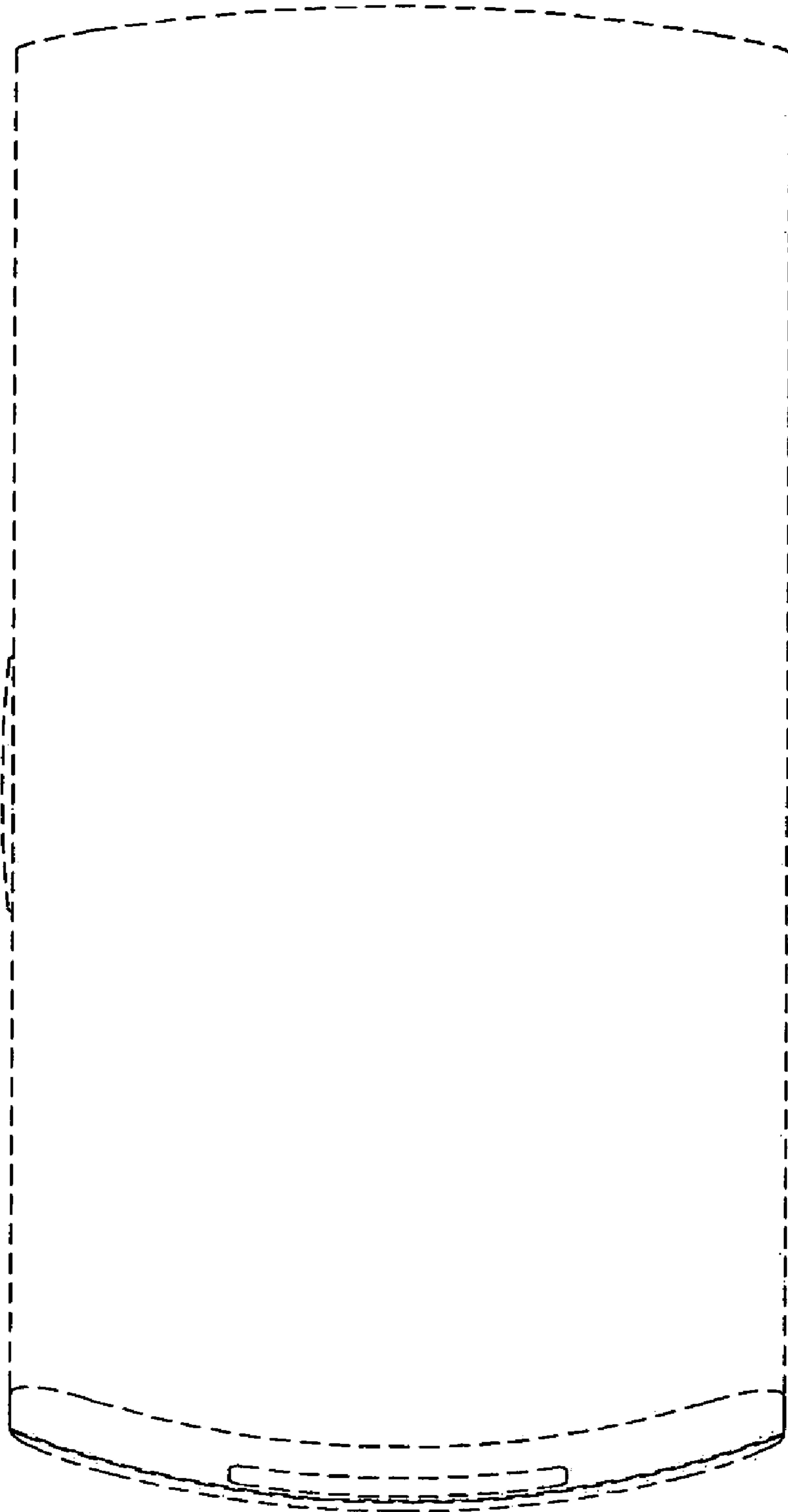

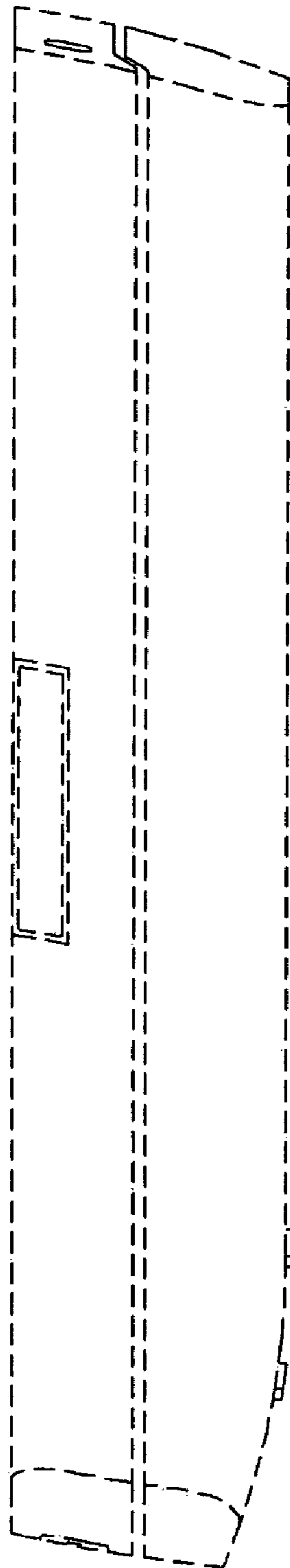

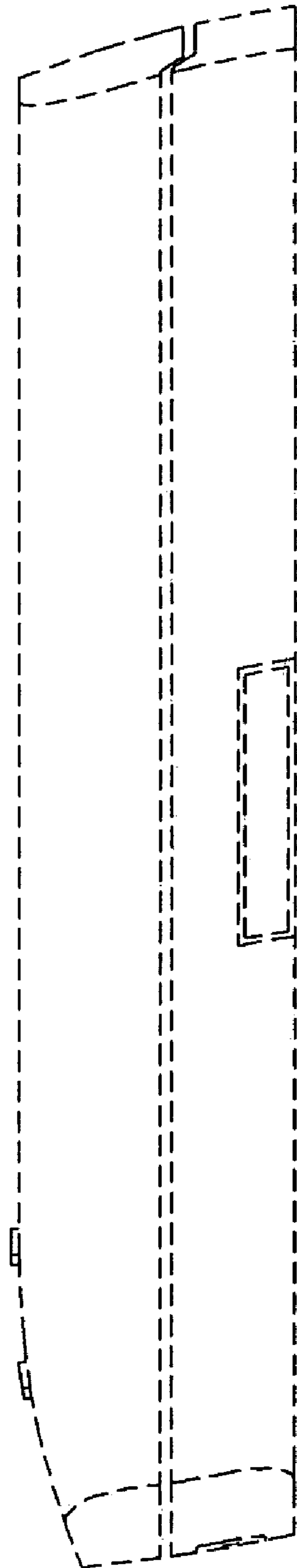

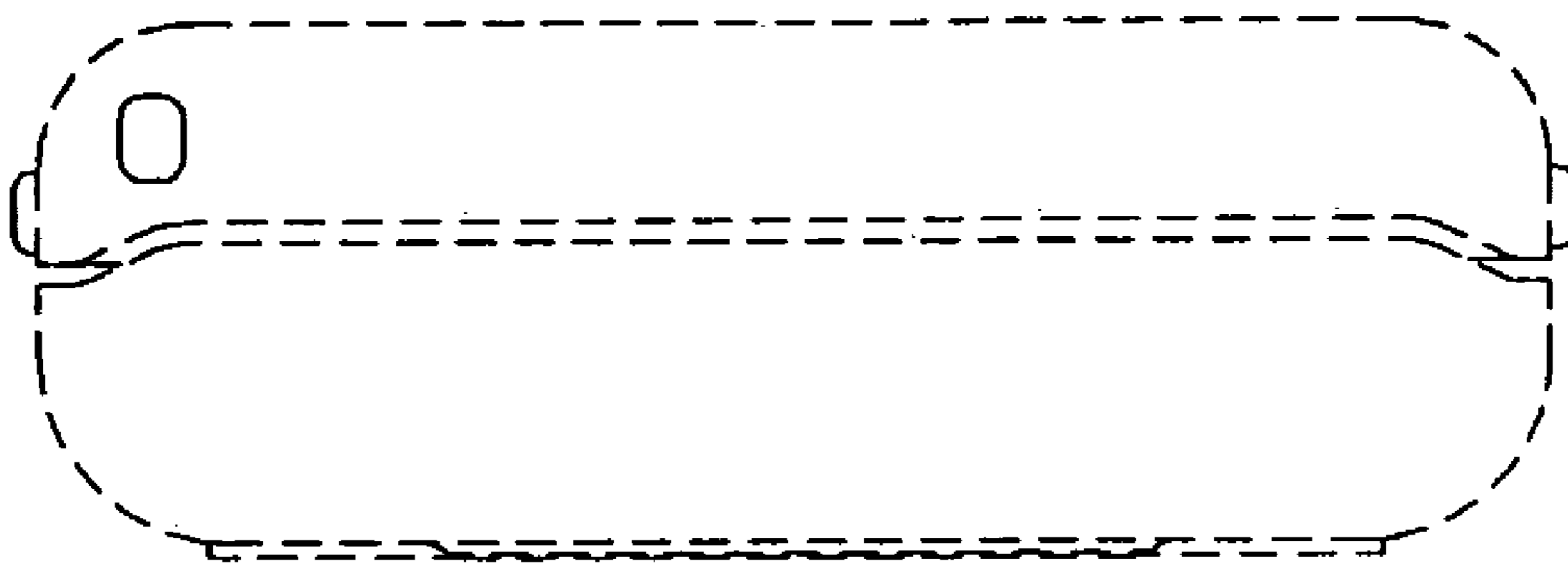

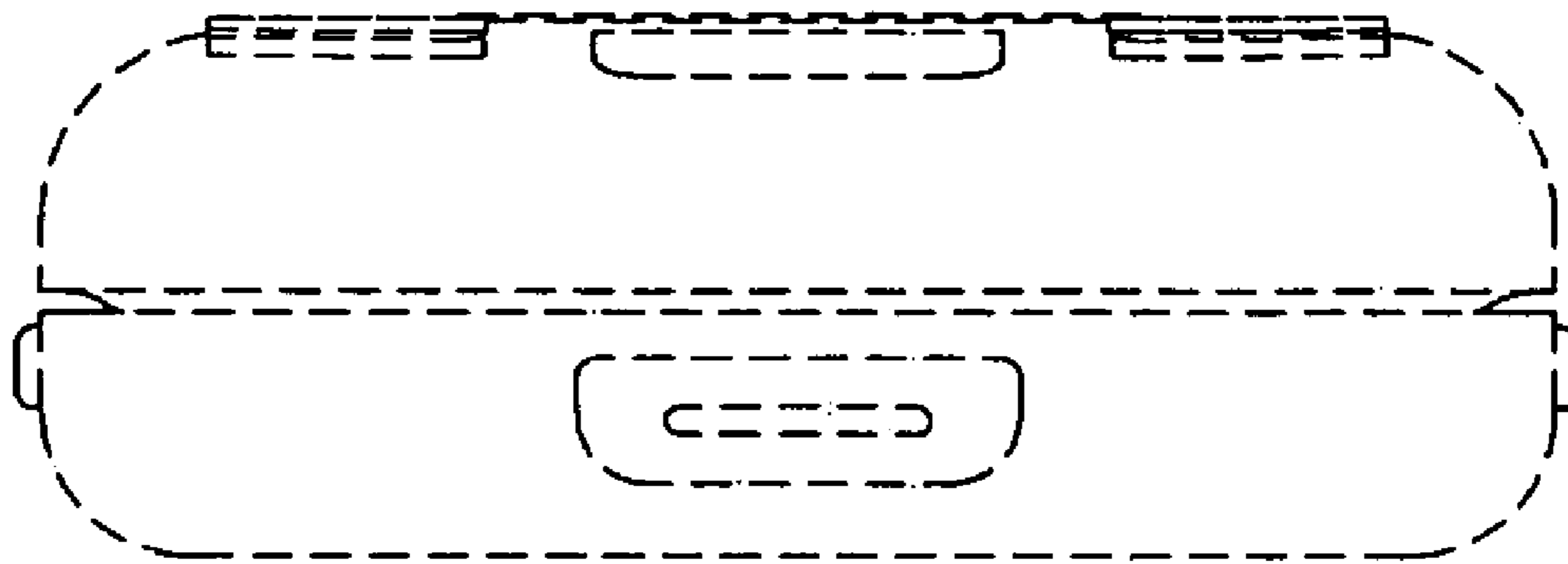
