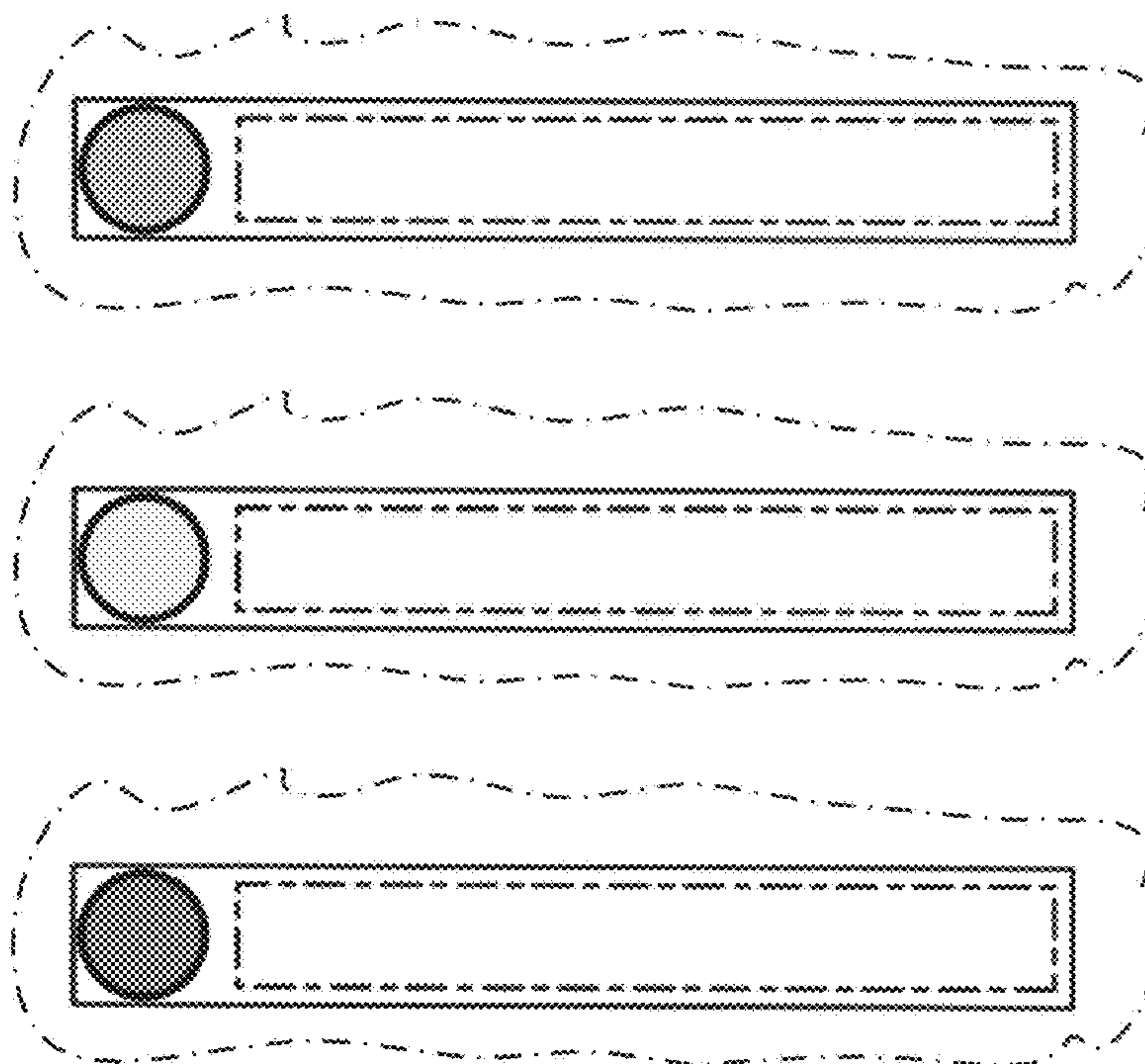
FIG. 1 is a front view of the first image of a set of images for portions of a display screen showing our new design;

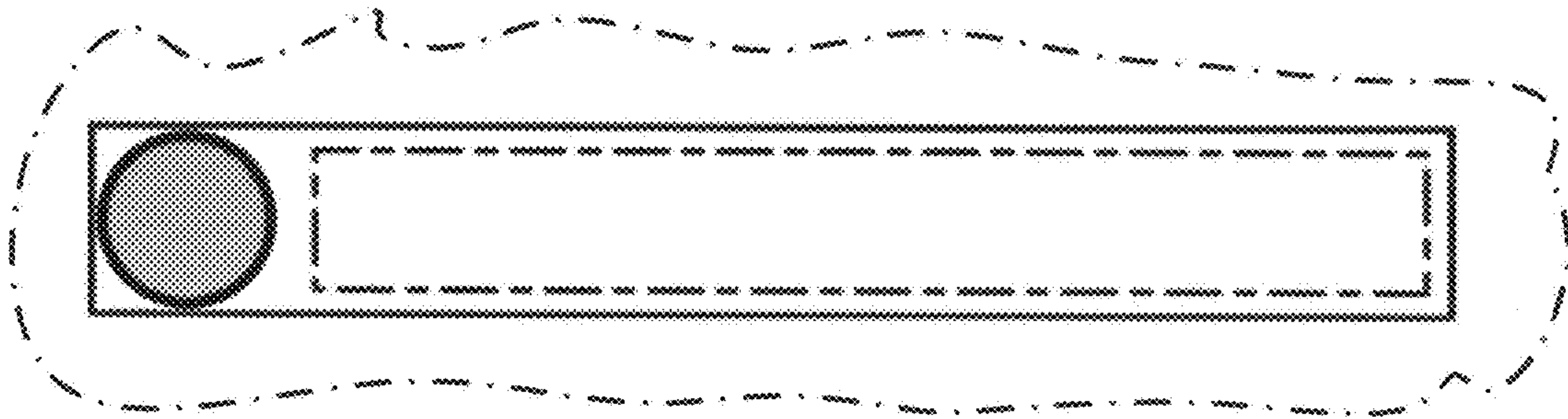

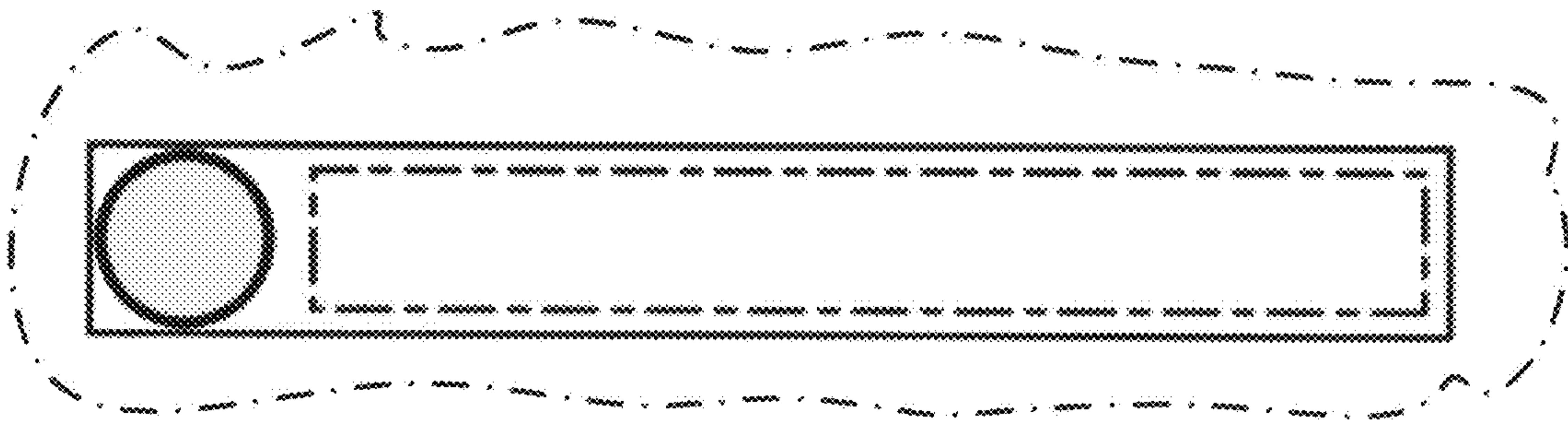

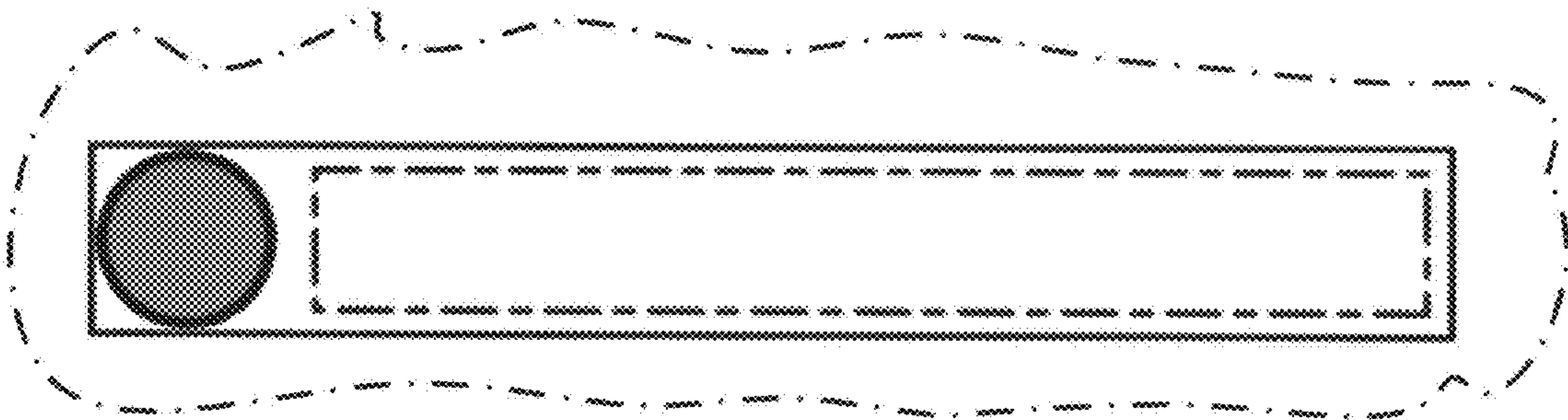
