DESCRIPTION

FIG. 1 is a front, top and right side perspective view of an atomizer for inhaler showing our new design;

FIG. 2 is a rear, bottom and left side perspective view thereof;

FIG. 3 is a front elevational view thereof;

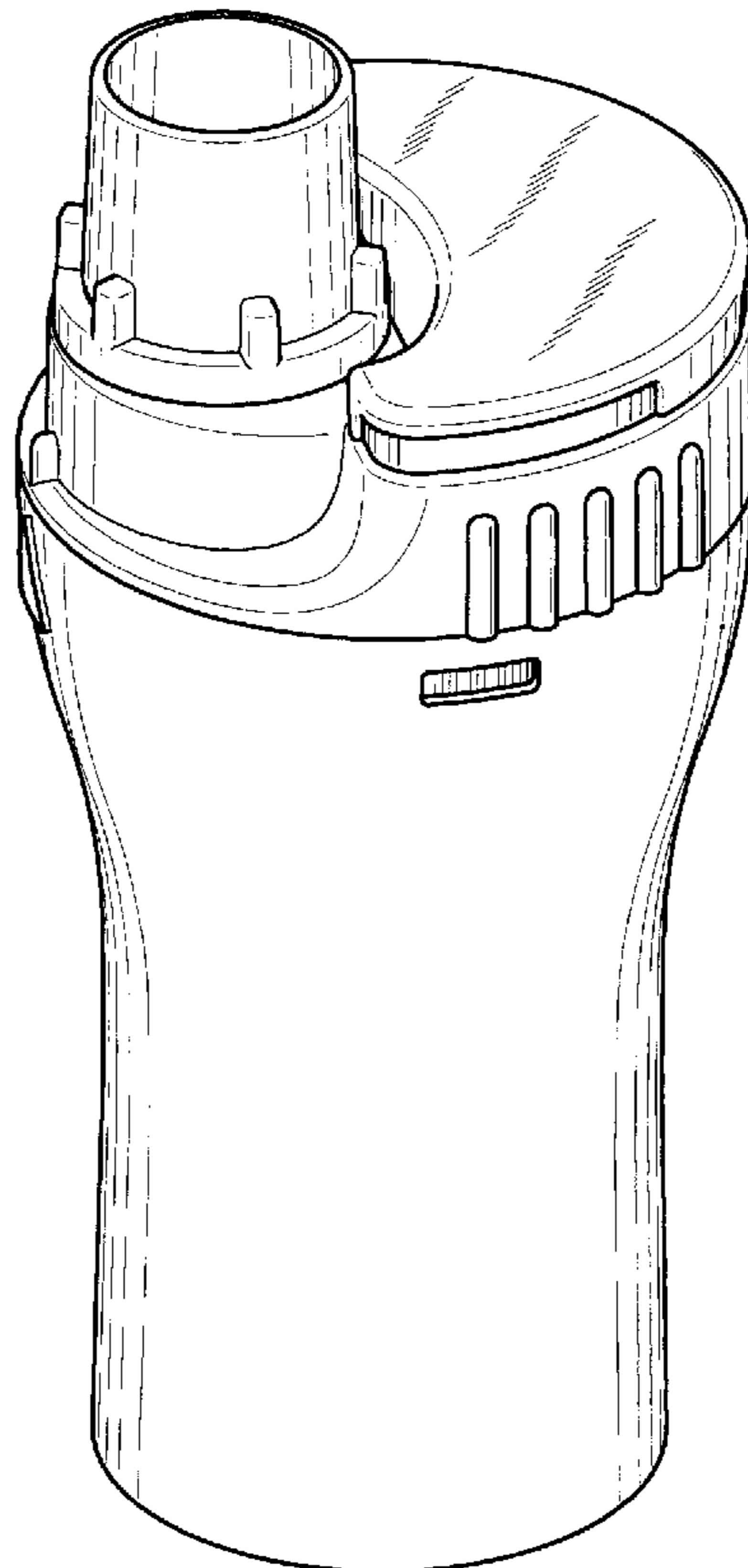

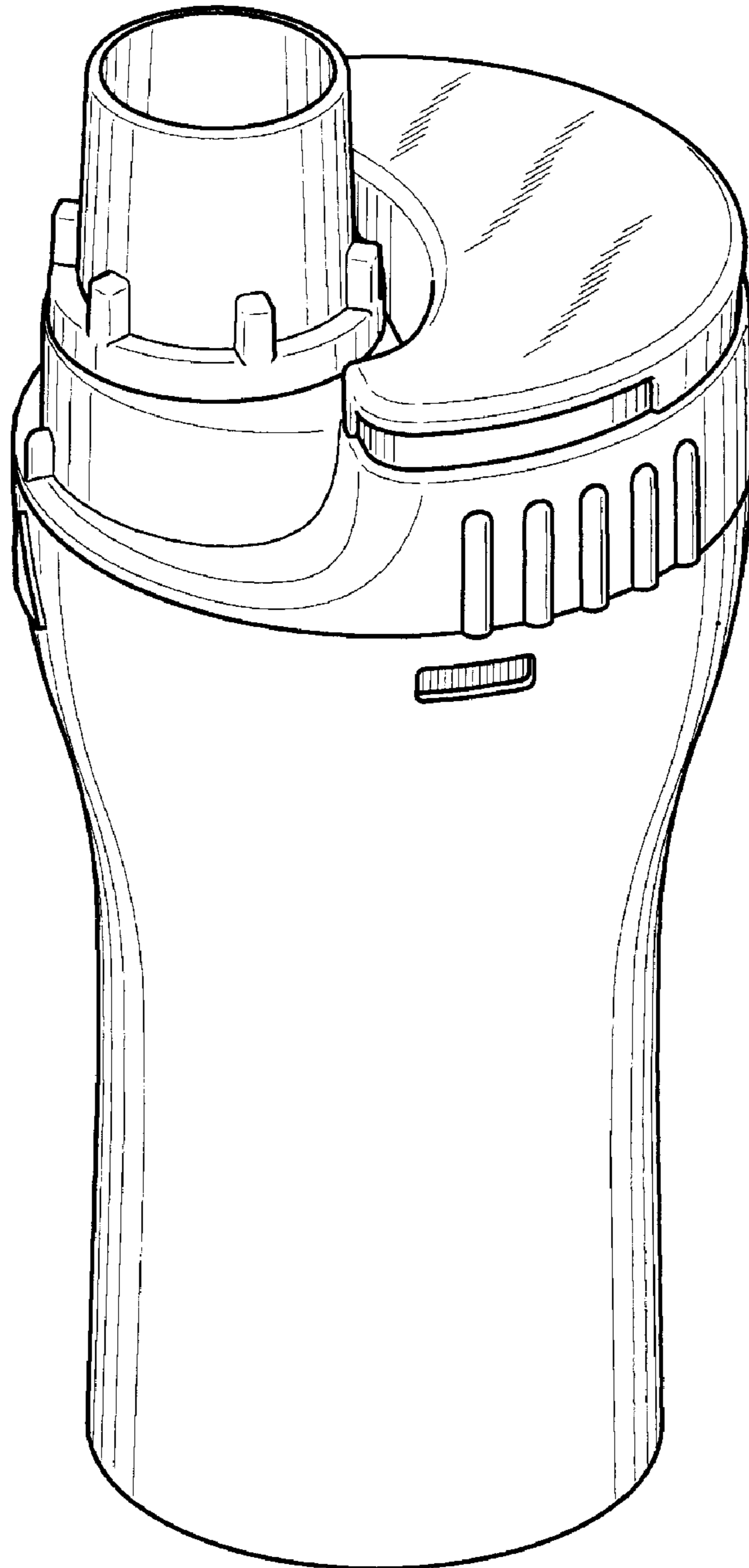

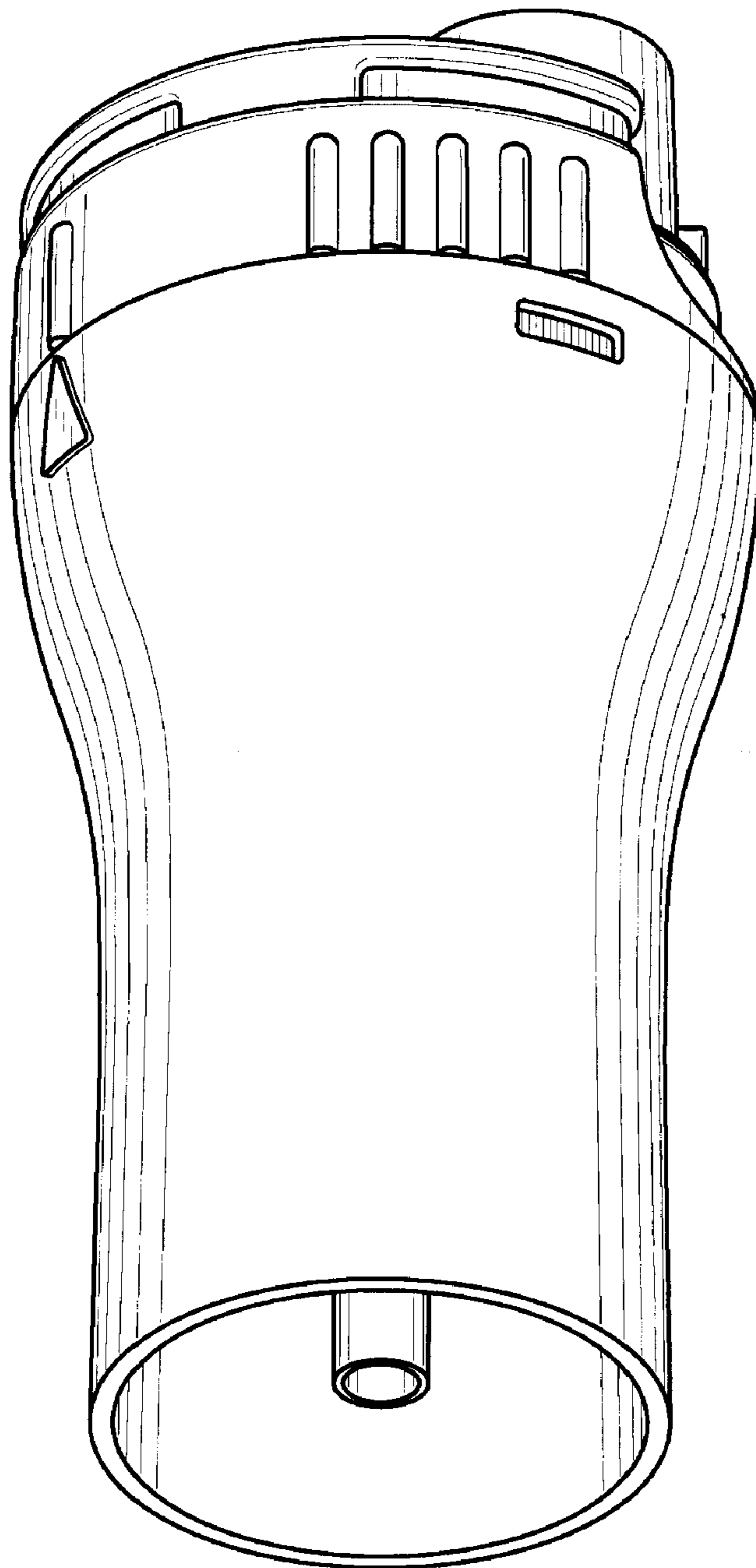

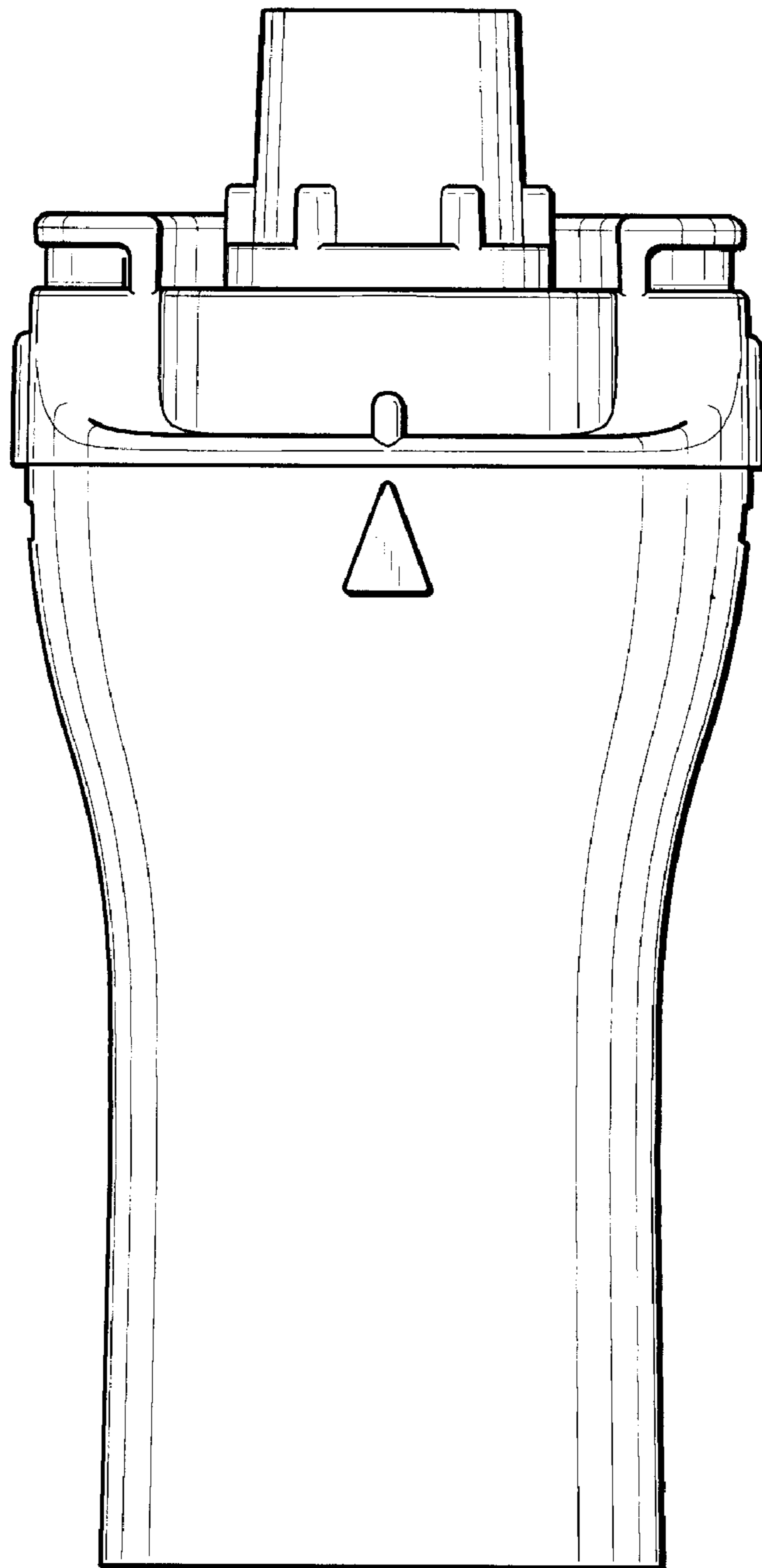

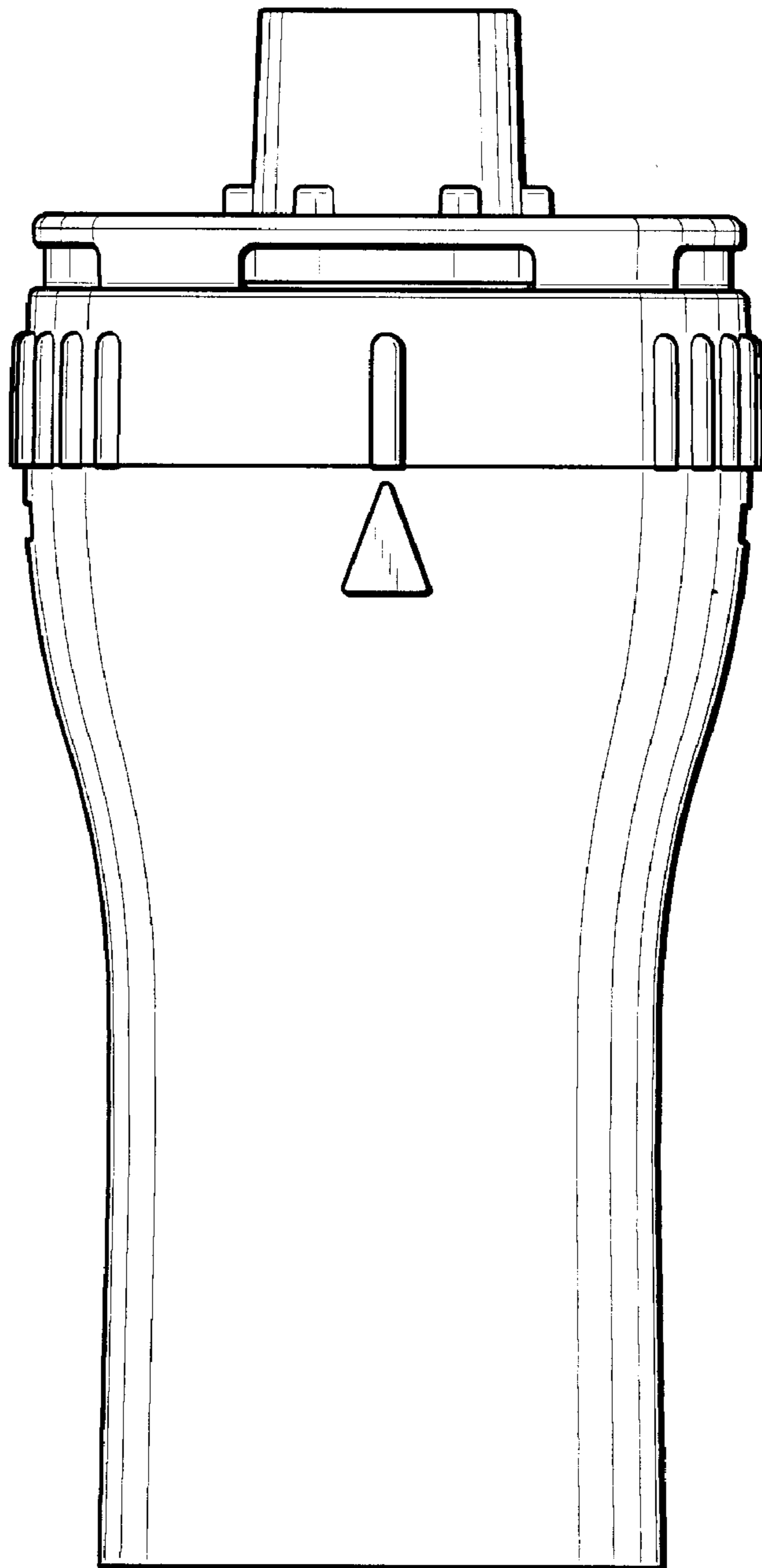

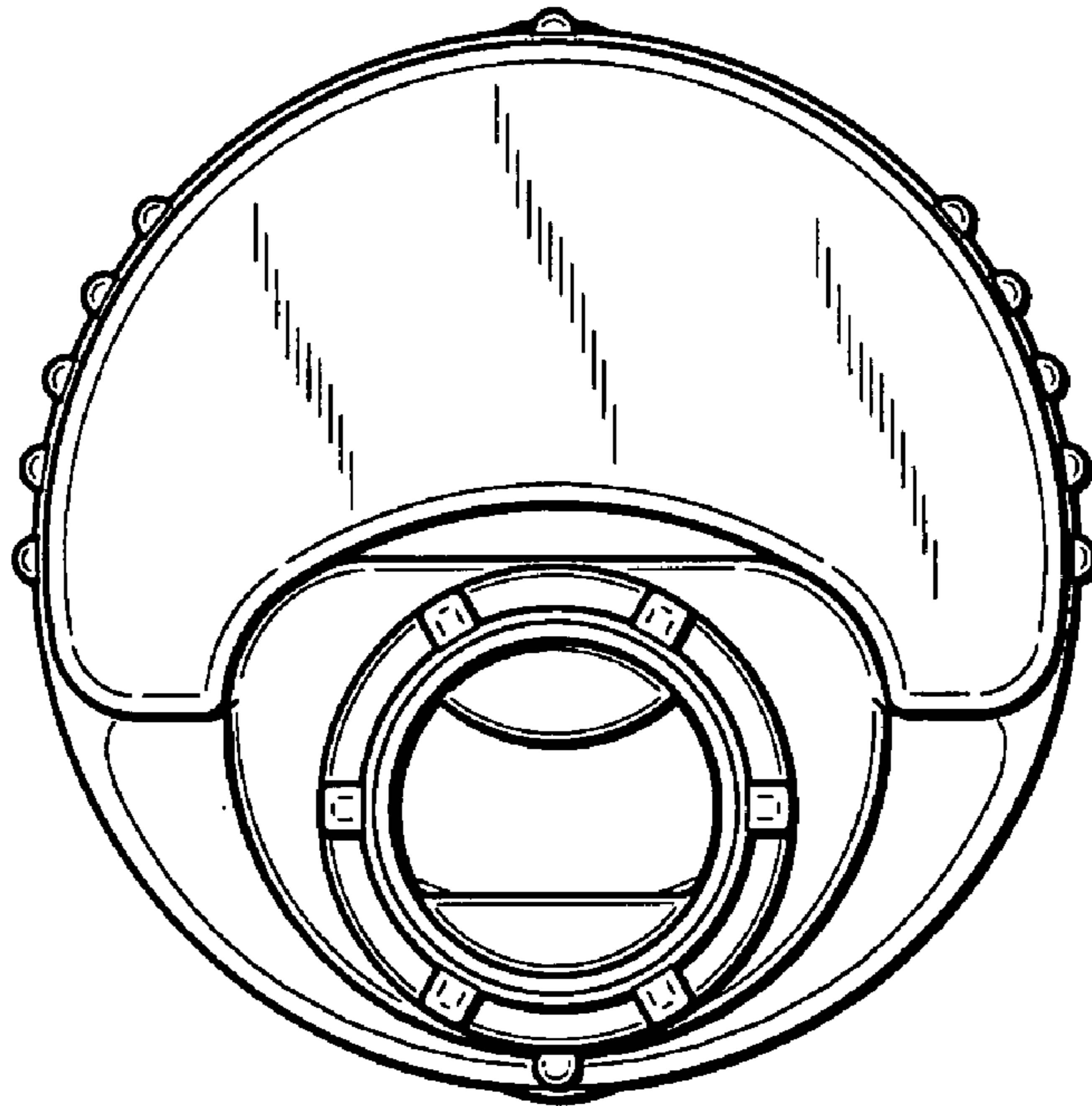

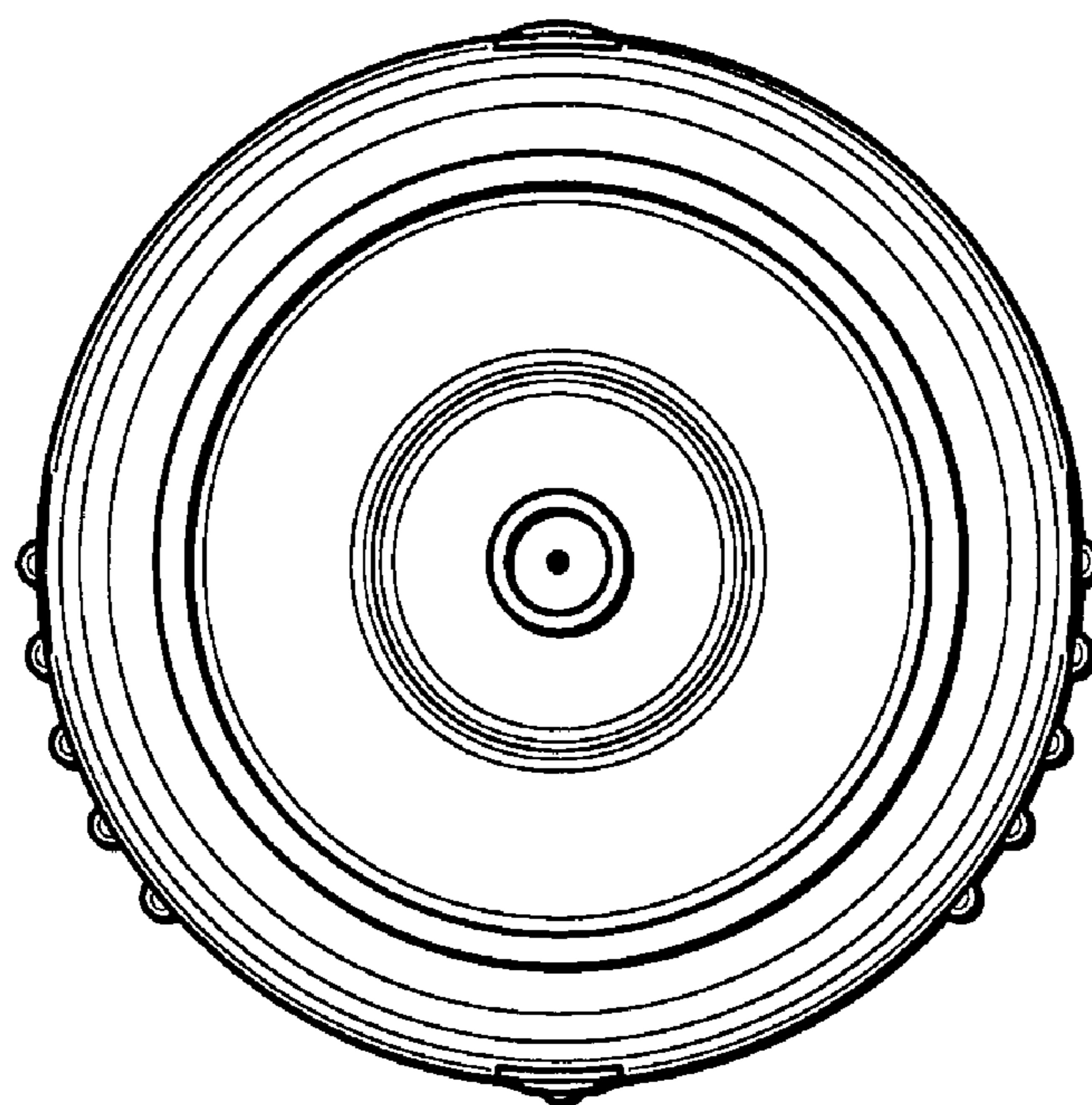

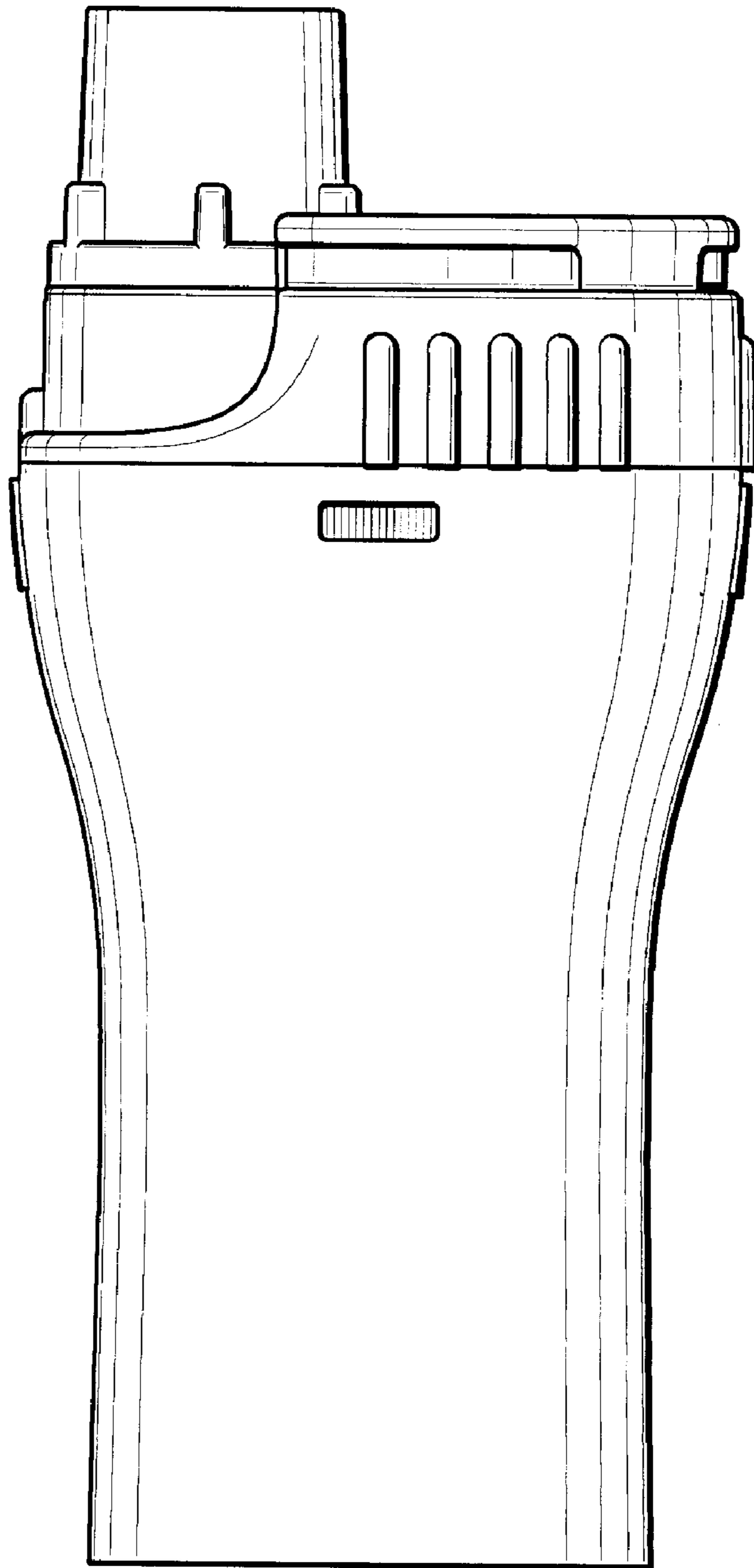
