(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a rear perspective view thereof; and

FIG. 3 is a bottom view thereof;

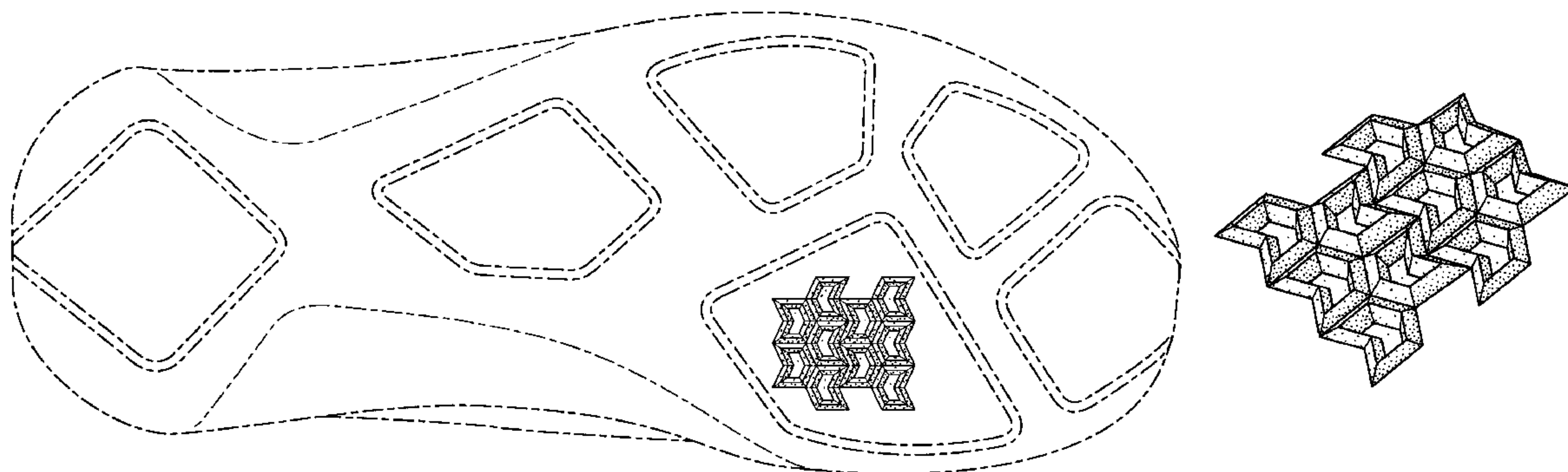
FIG. 4 is an enlarged view of the claimed region as viewed in FIG. 1, shown in isolation;

FIG. 5 is an enlarged view of the claimed region as viewed in FIG. 2, shown in isolation; and,

FIG. 6 is an enlarged view of the claimed region as viewed in FIG. 3, shown in isolation.

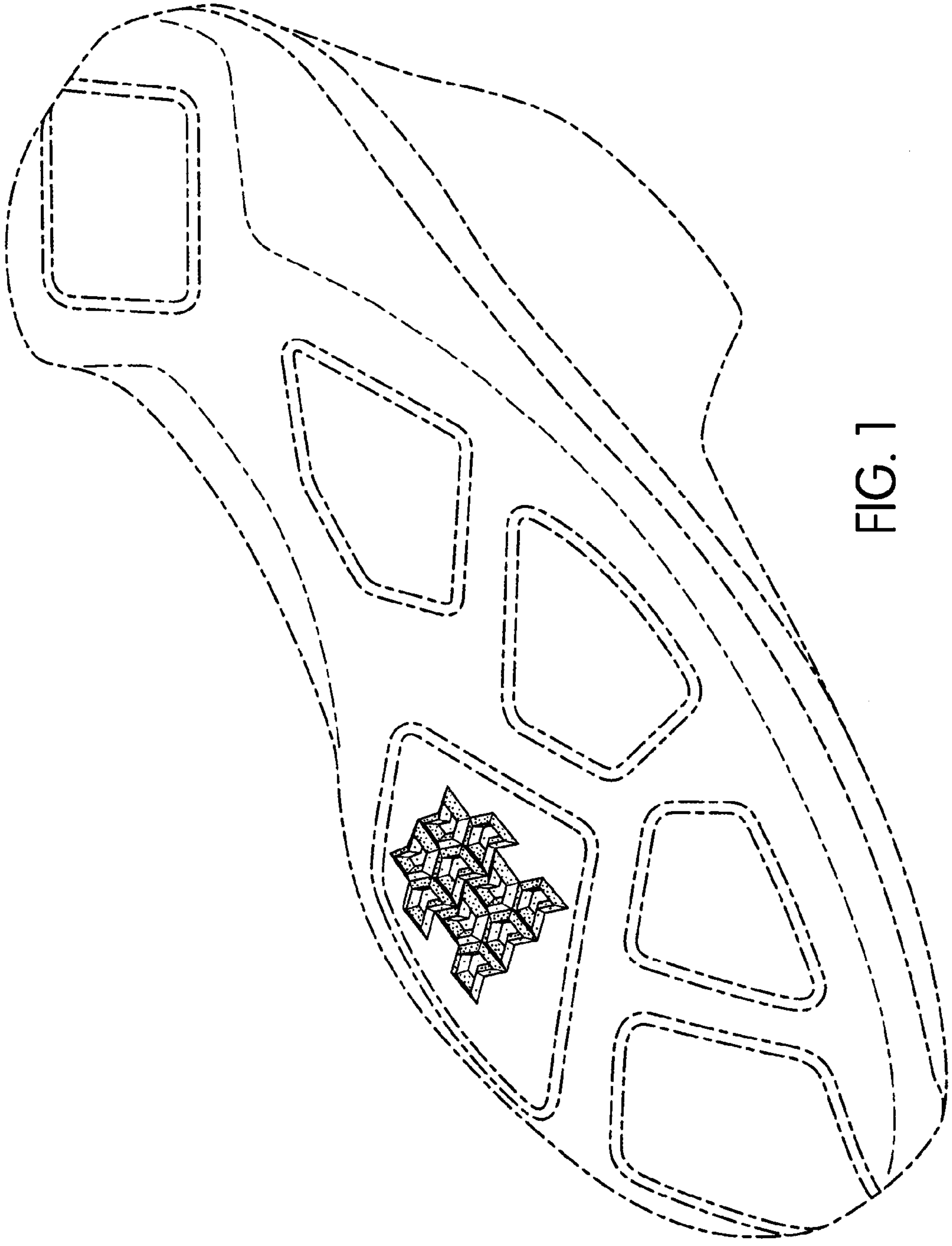

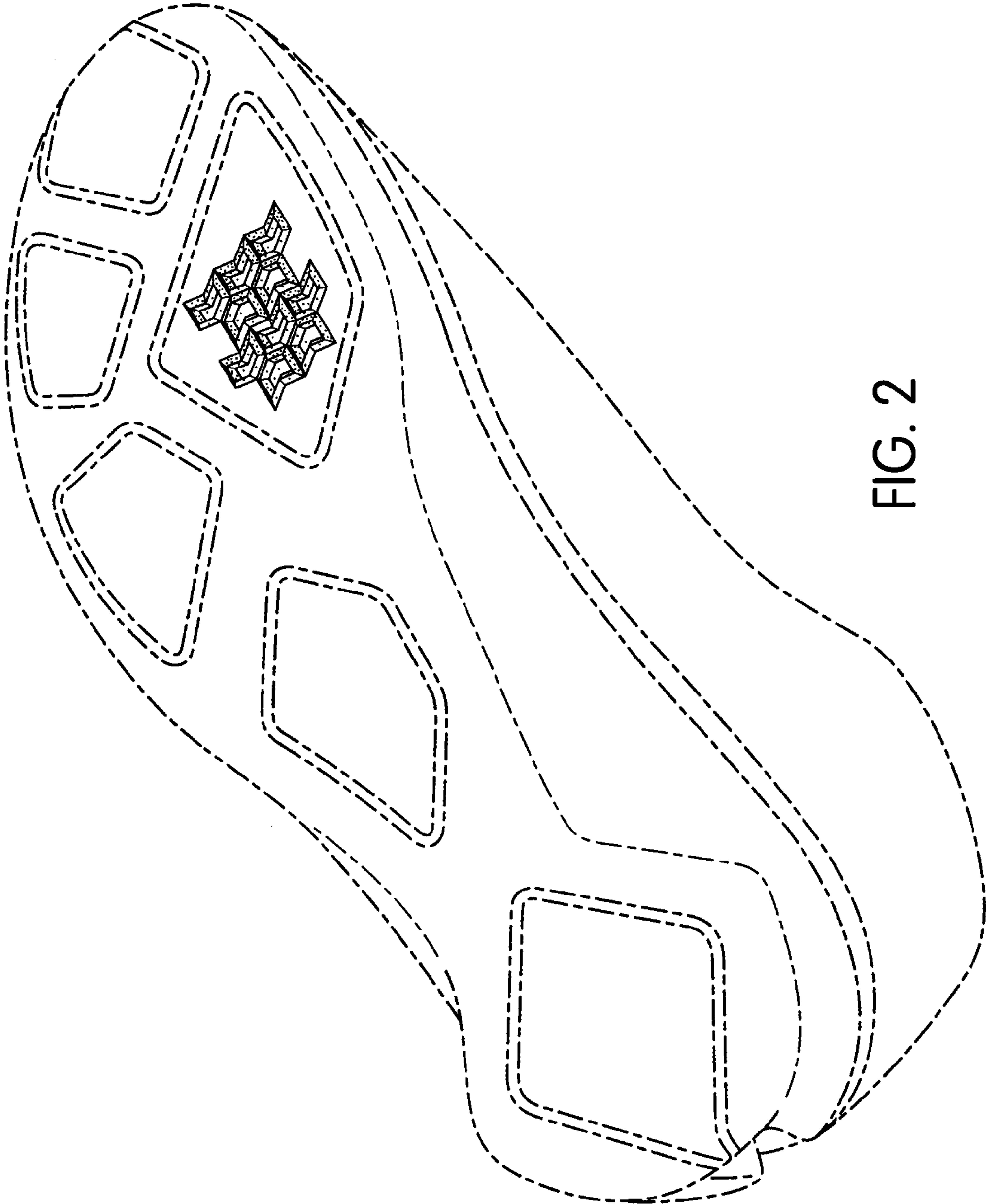

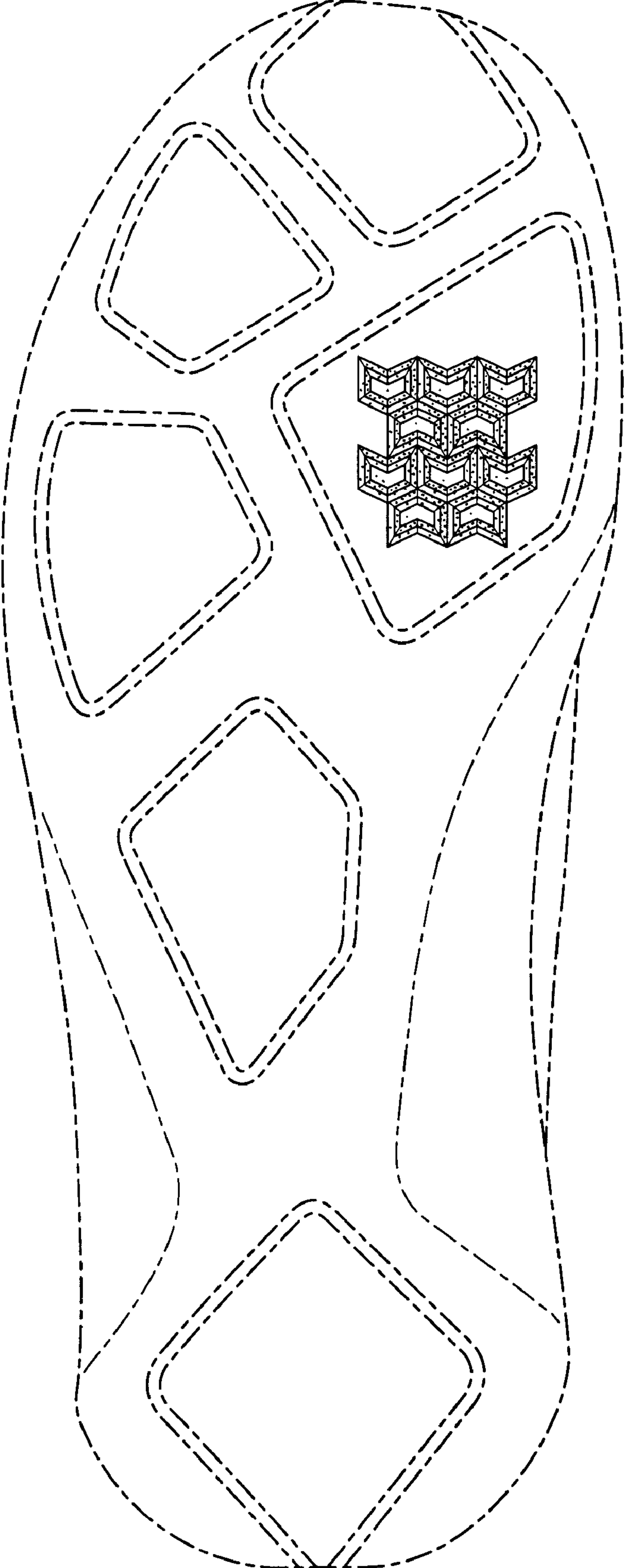

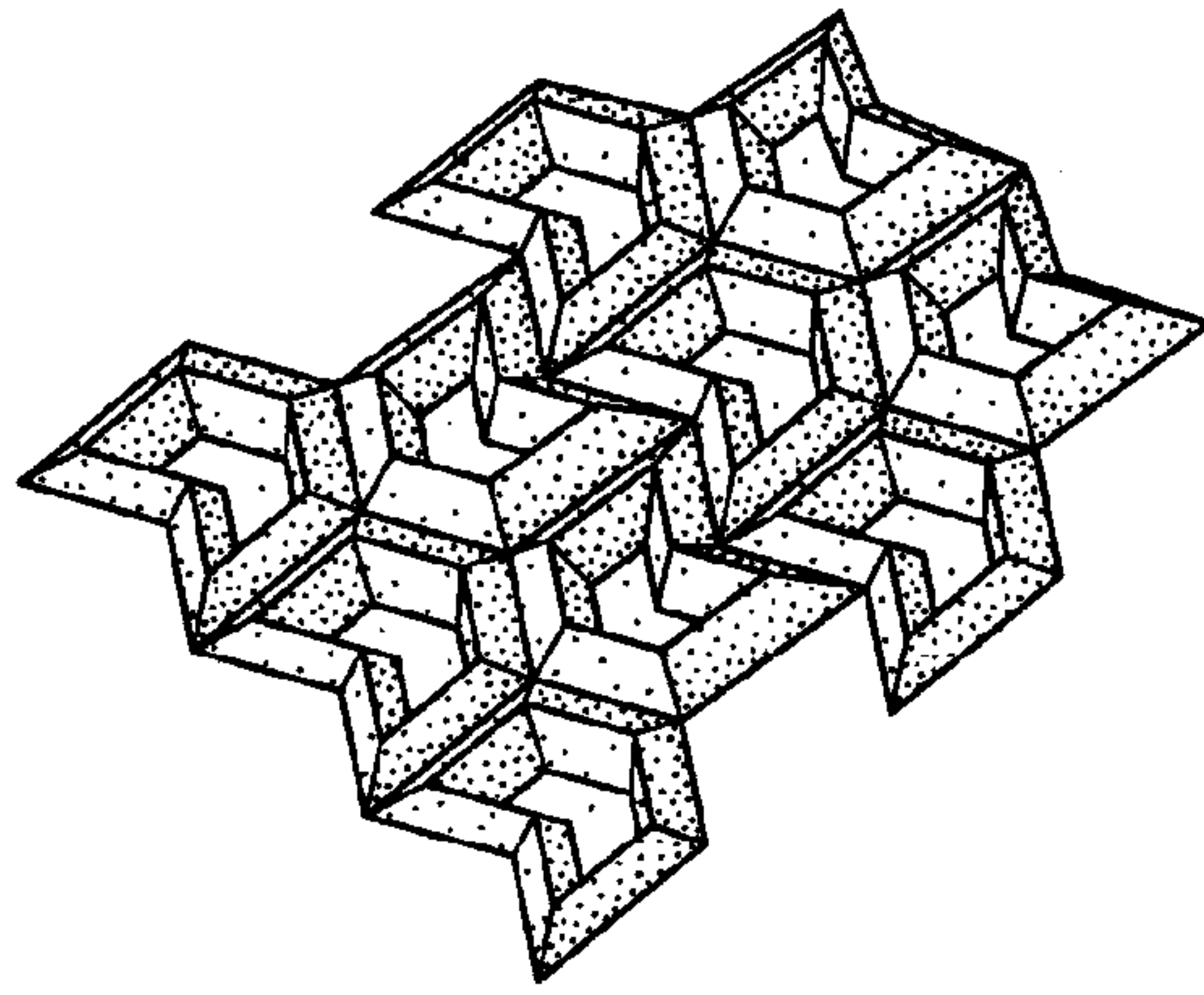

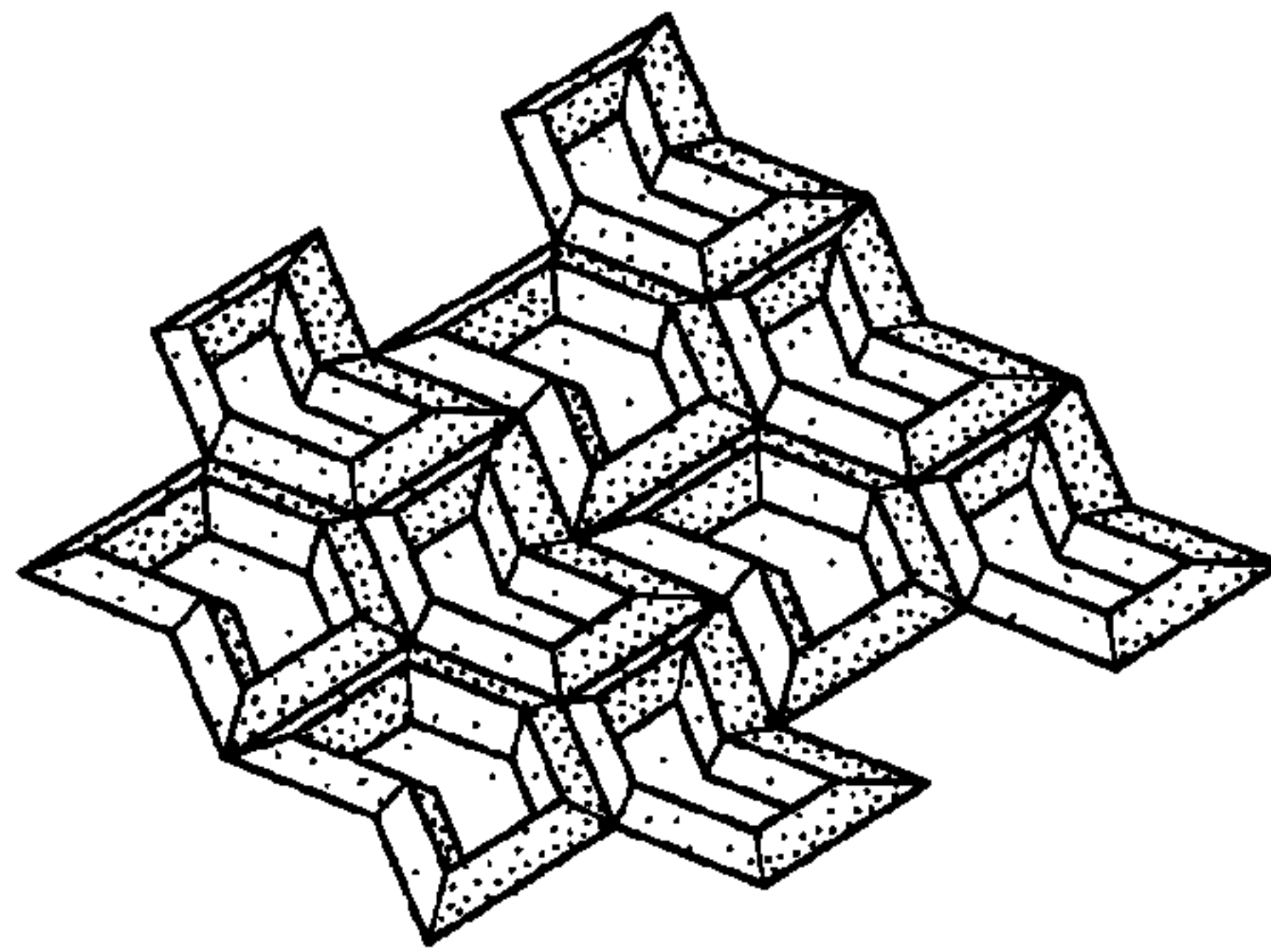

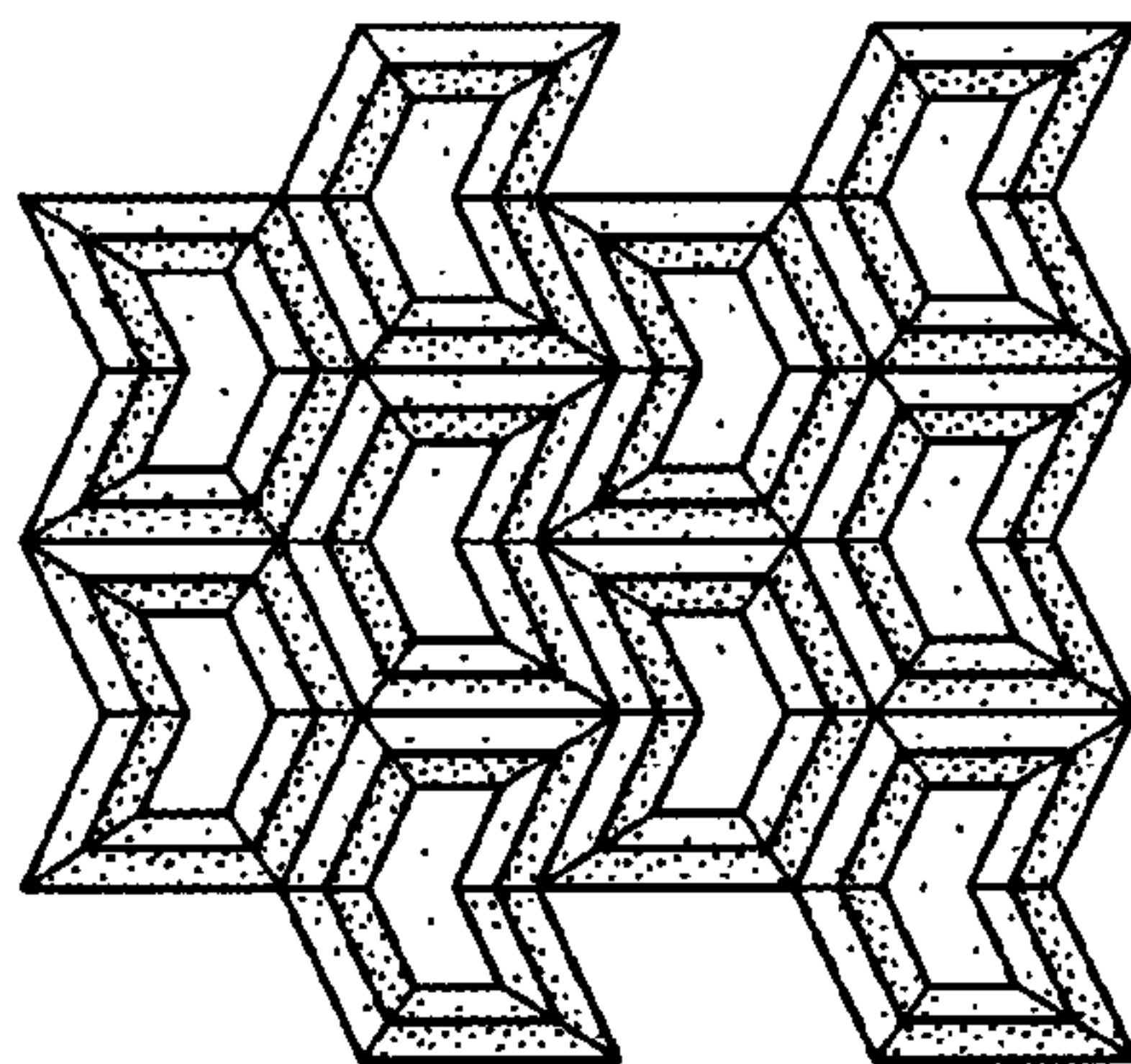
