(57) **CLAIM**

The ornamental design for a wall mountable support, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is a support bar, or portion thereof, for supporting items such as towels or for grasping when entering shower enclosure.

FIG. 1 is a right, top, front perspective view embodying my new design;

FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image of the top view shown;

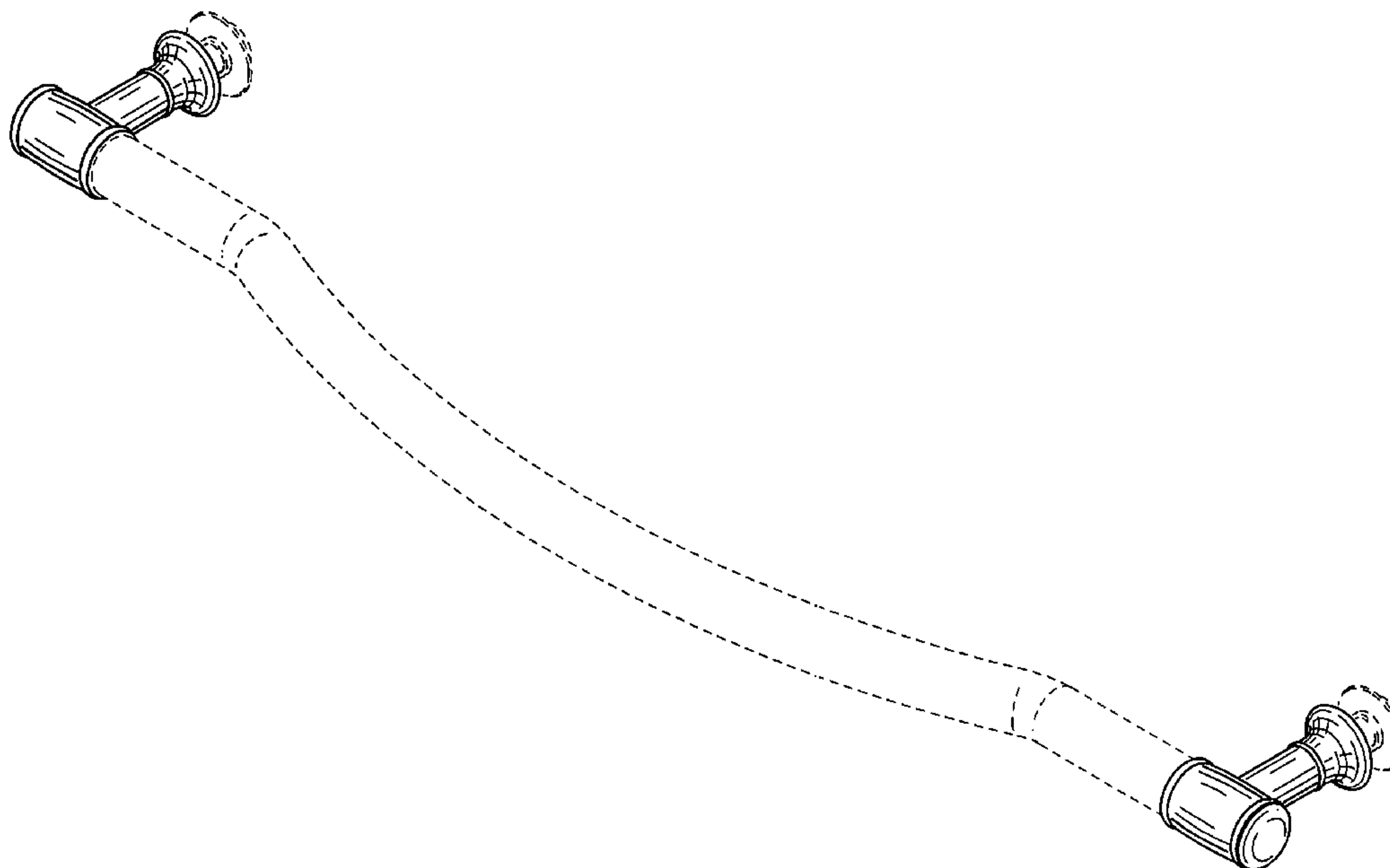
FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown; and,

FIG. 5 is a rear elevational view thereof.

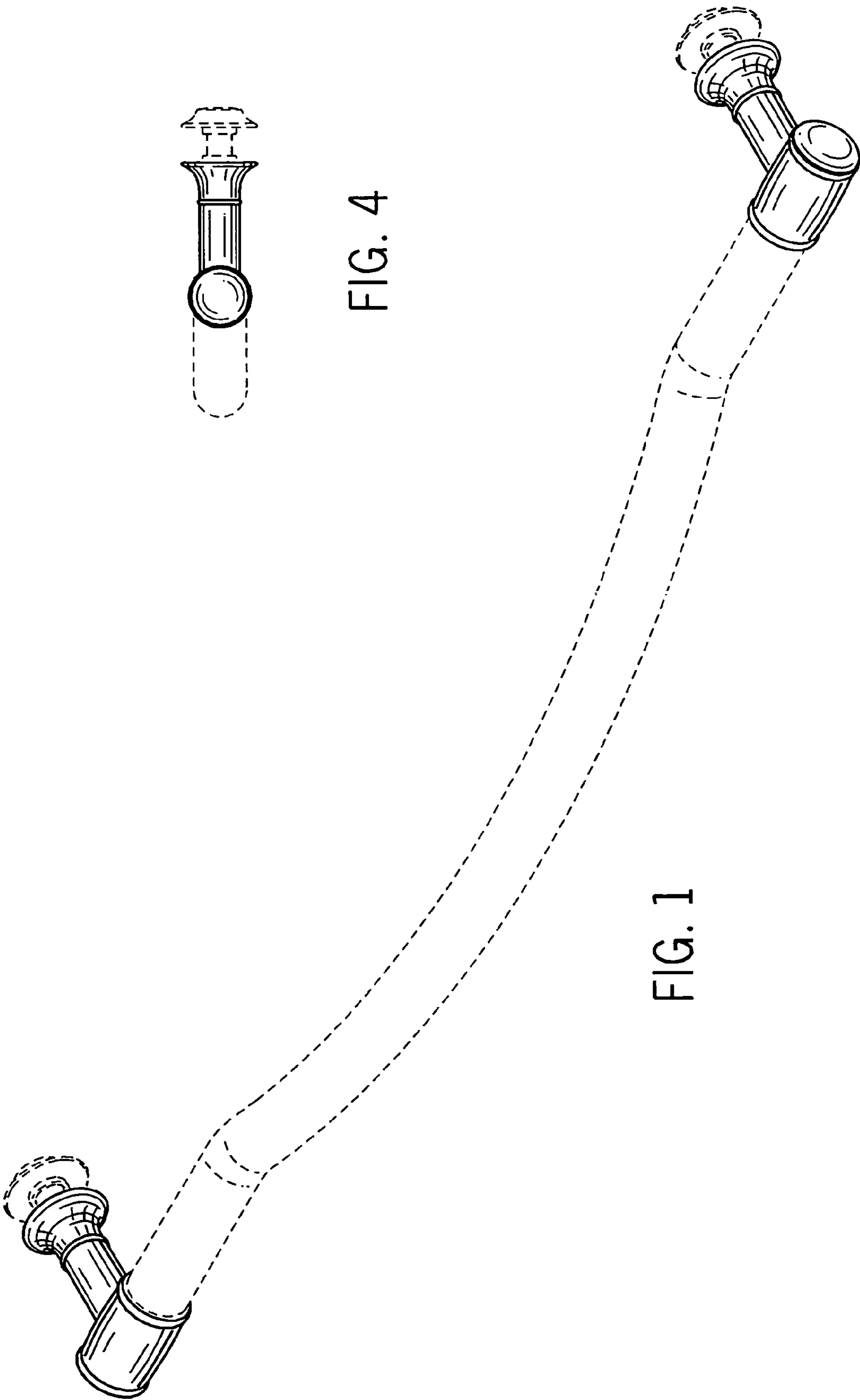

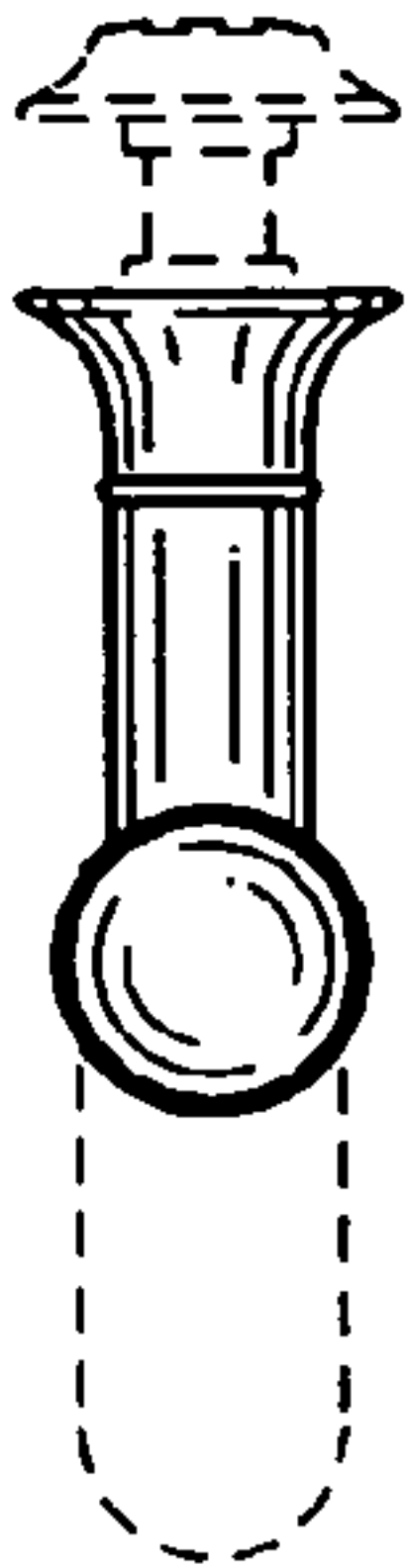

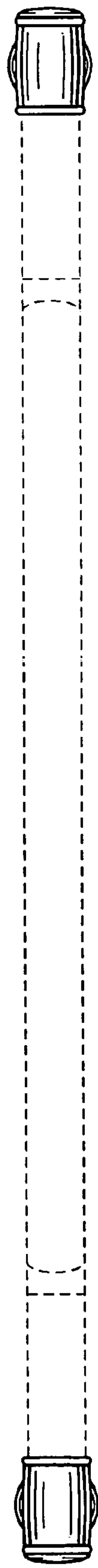

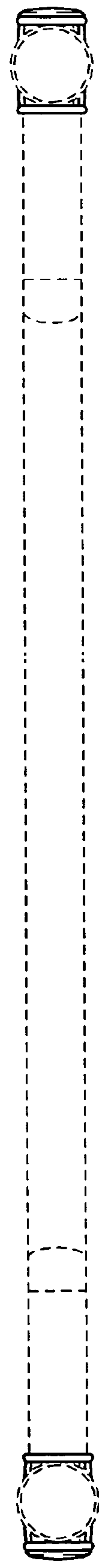
