DESCRIPTION

FIG. 1 is a perspective view of a double-sided shower ring showing my new design;

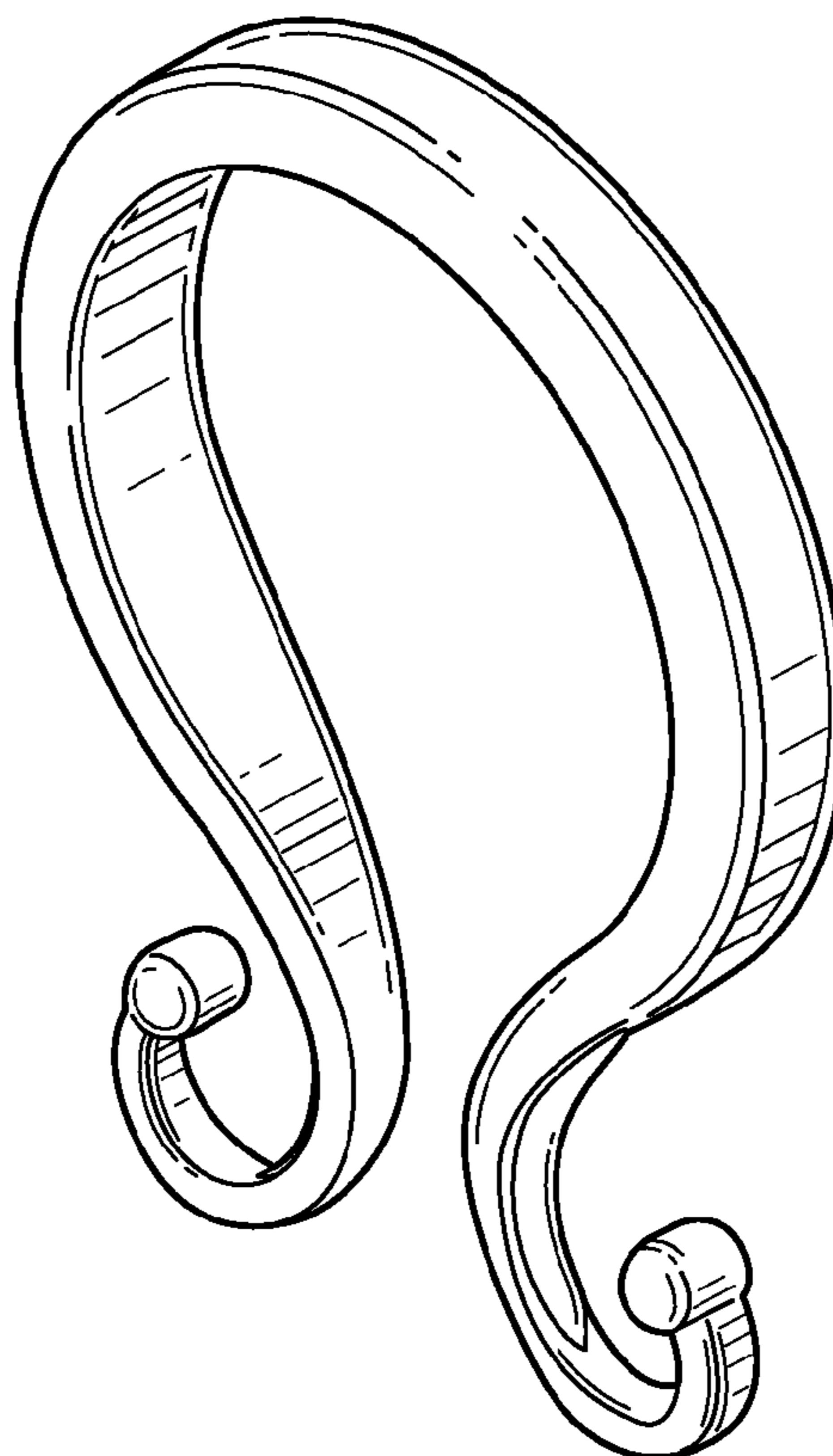
FIG. 2 is a front elevation view thereof, it being understood that the rear elevation view is a mirror image thereof;

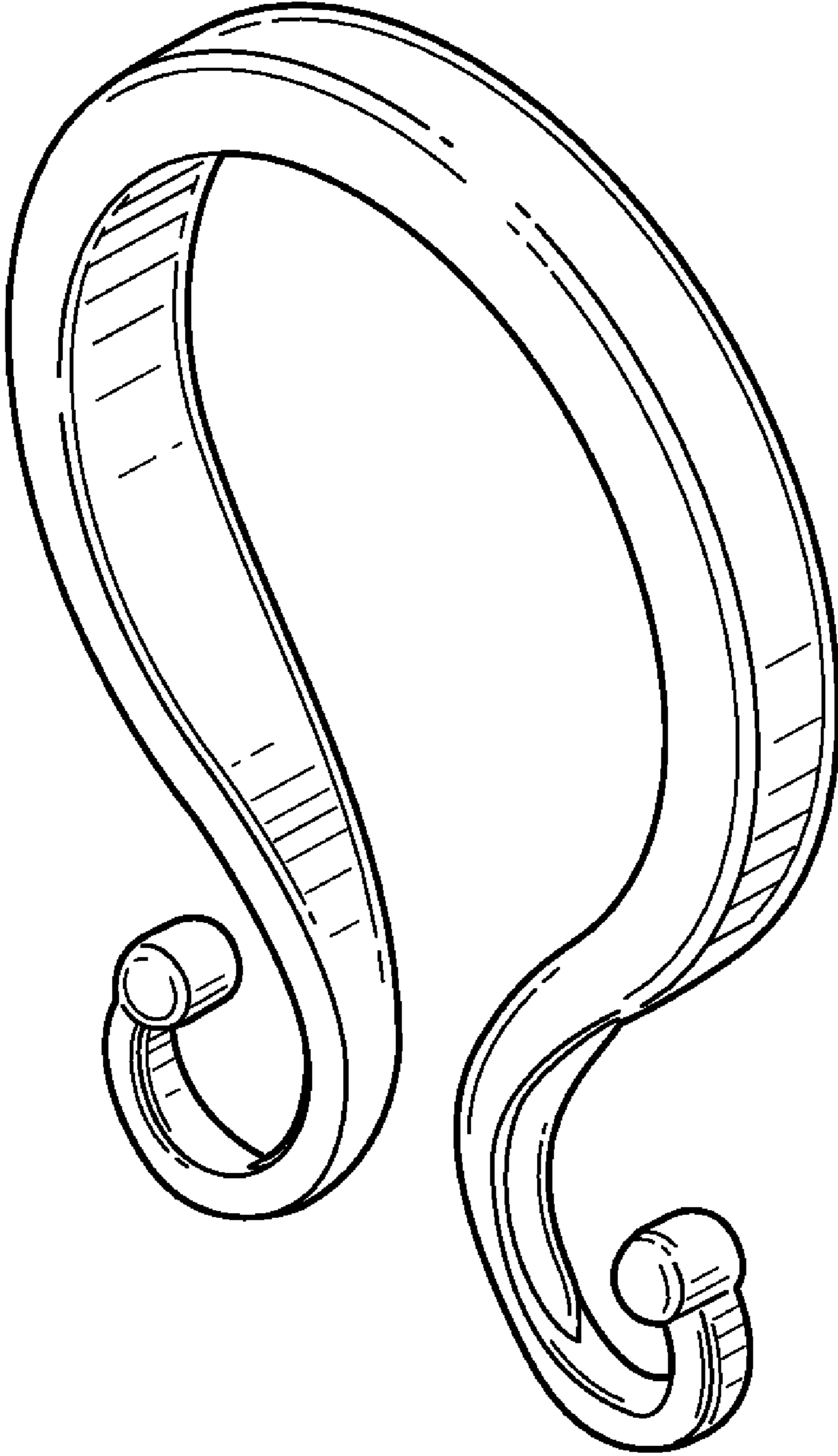

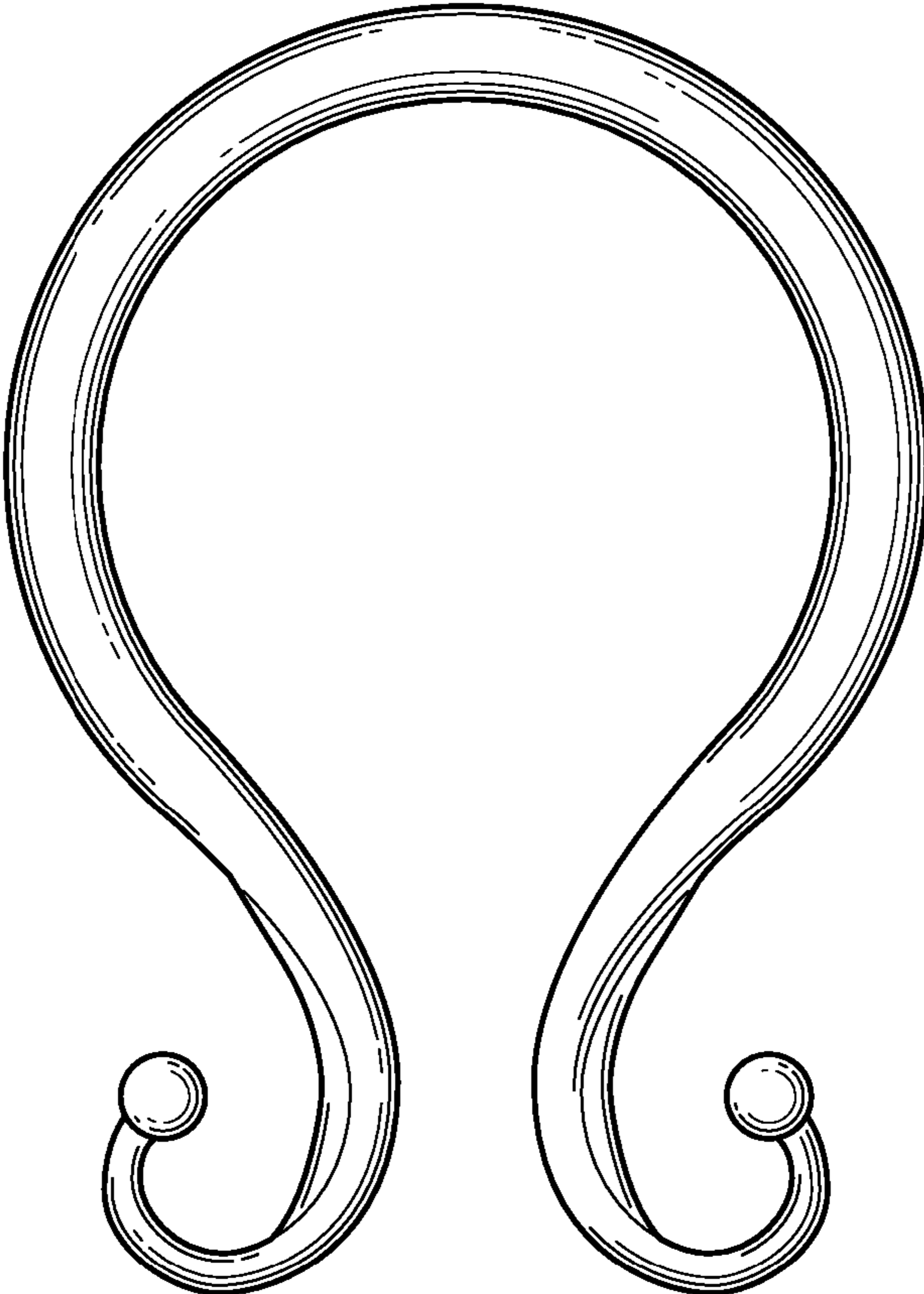

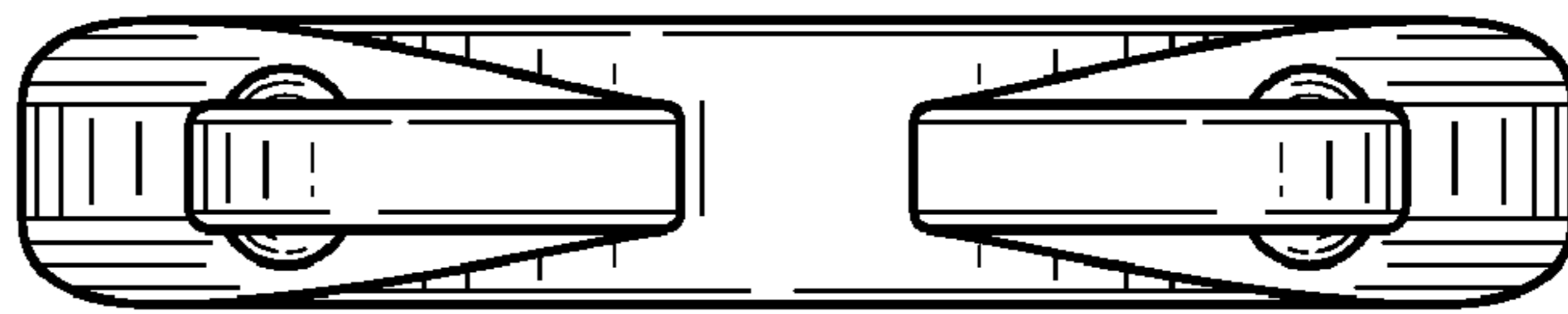
