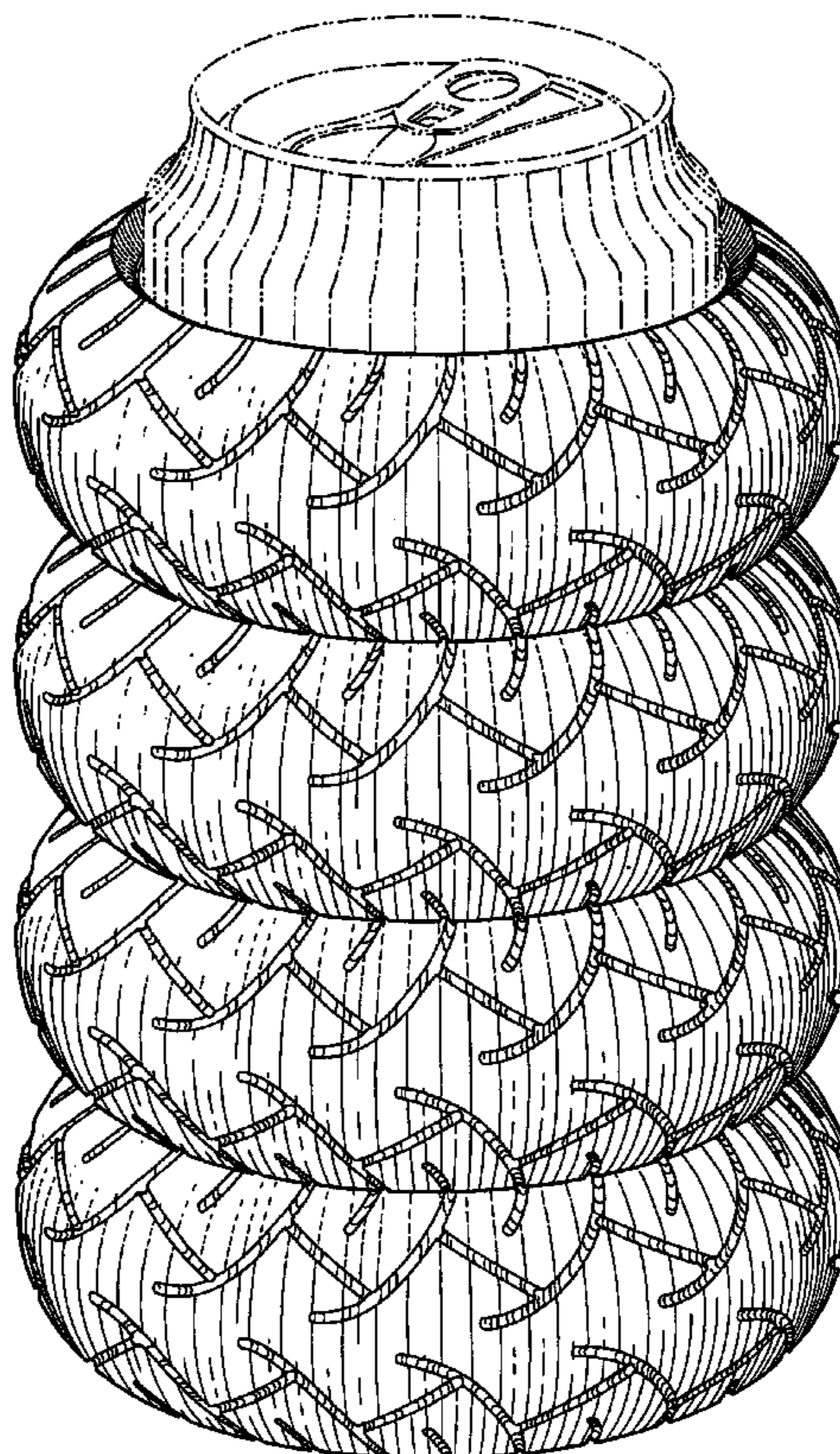
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage can cooler  
showing my new design, the beverage can being shown in  
broken lines for illustrative purposes only;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof; and,  
FIG. 4 is a side view thereof, all other sides being substan-  
tially identical.

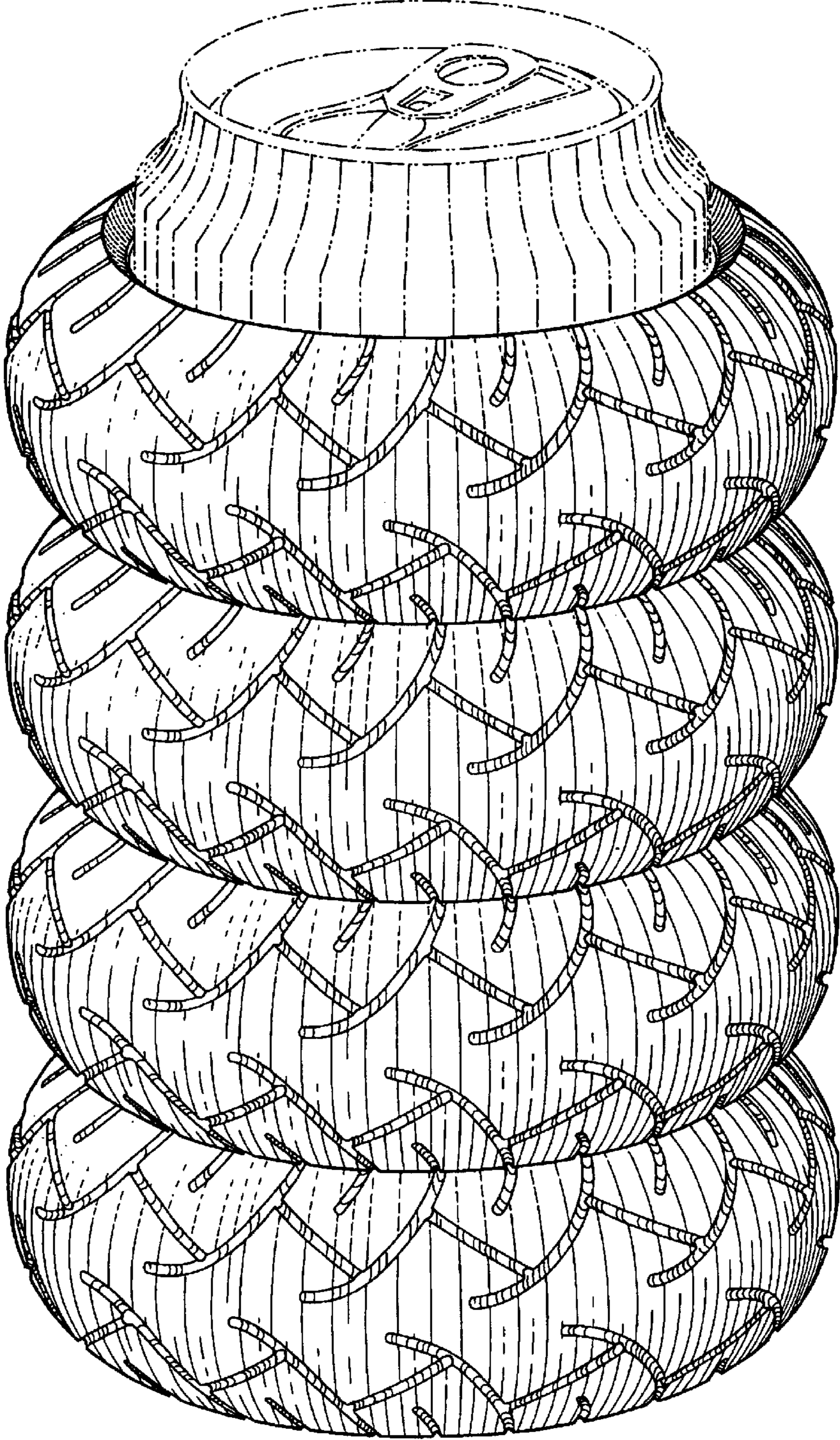

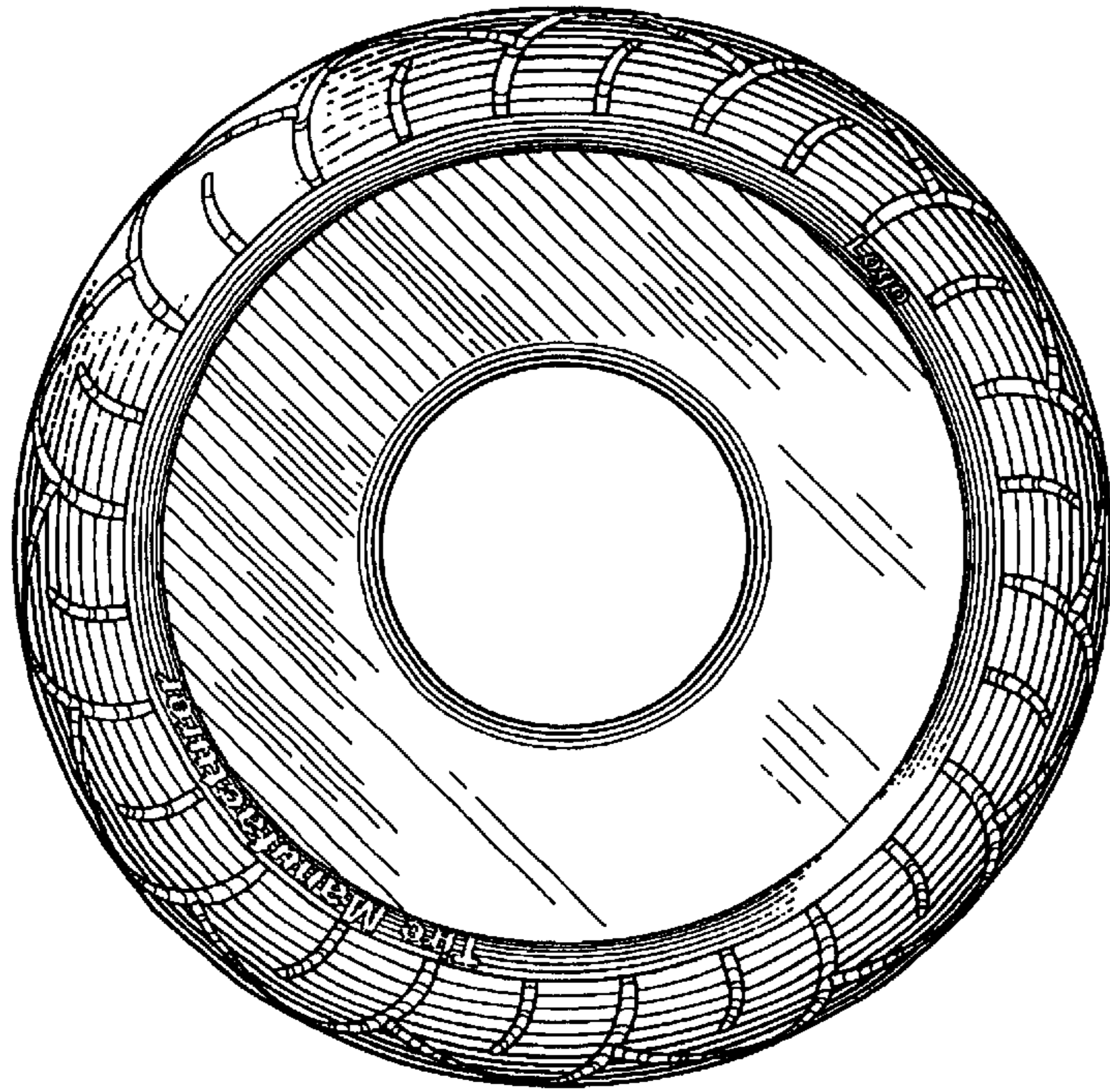

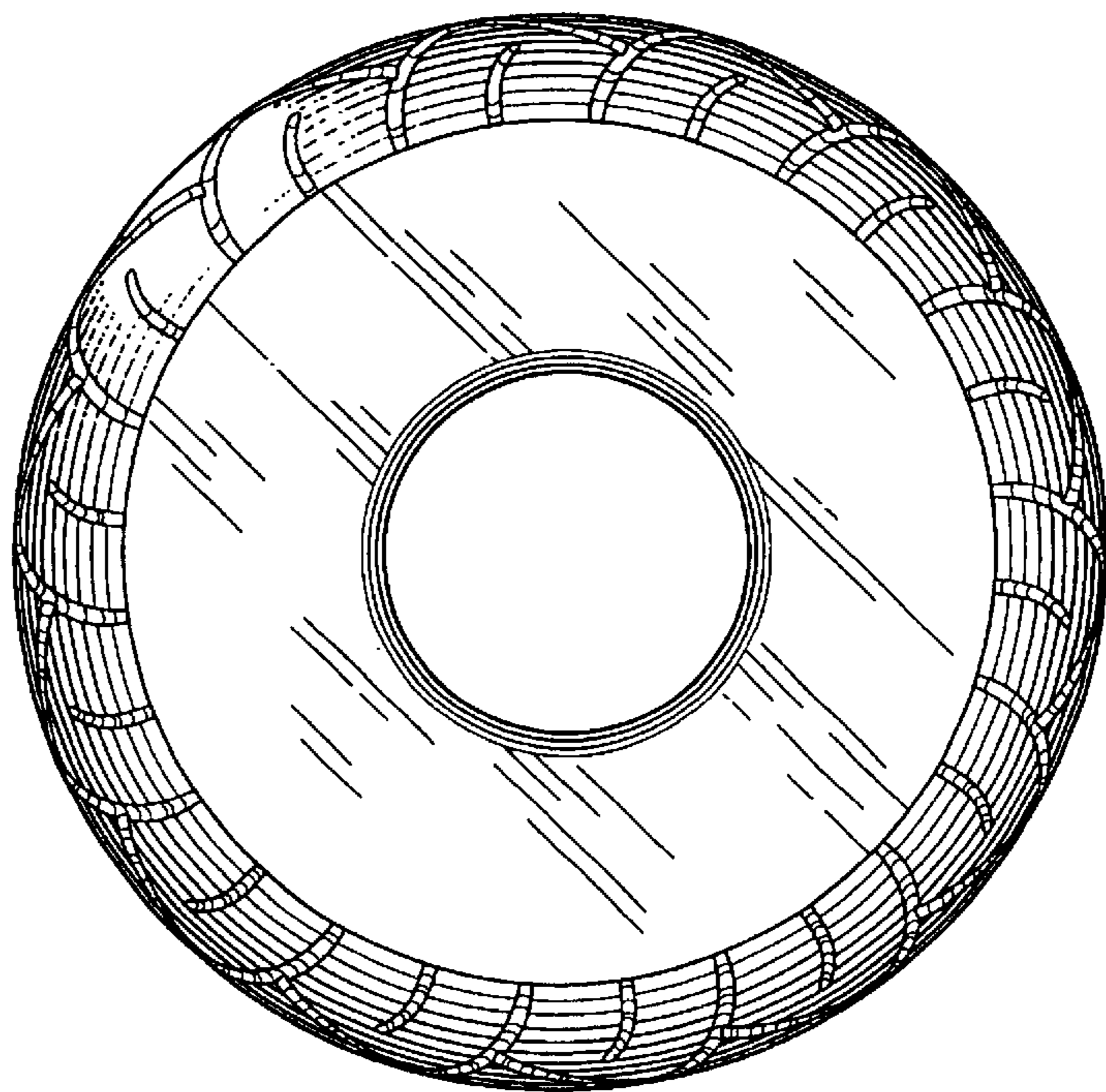

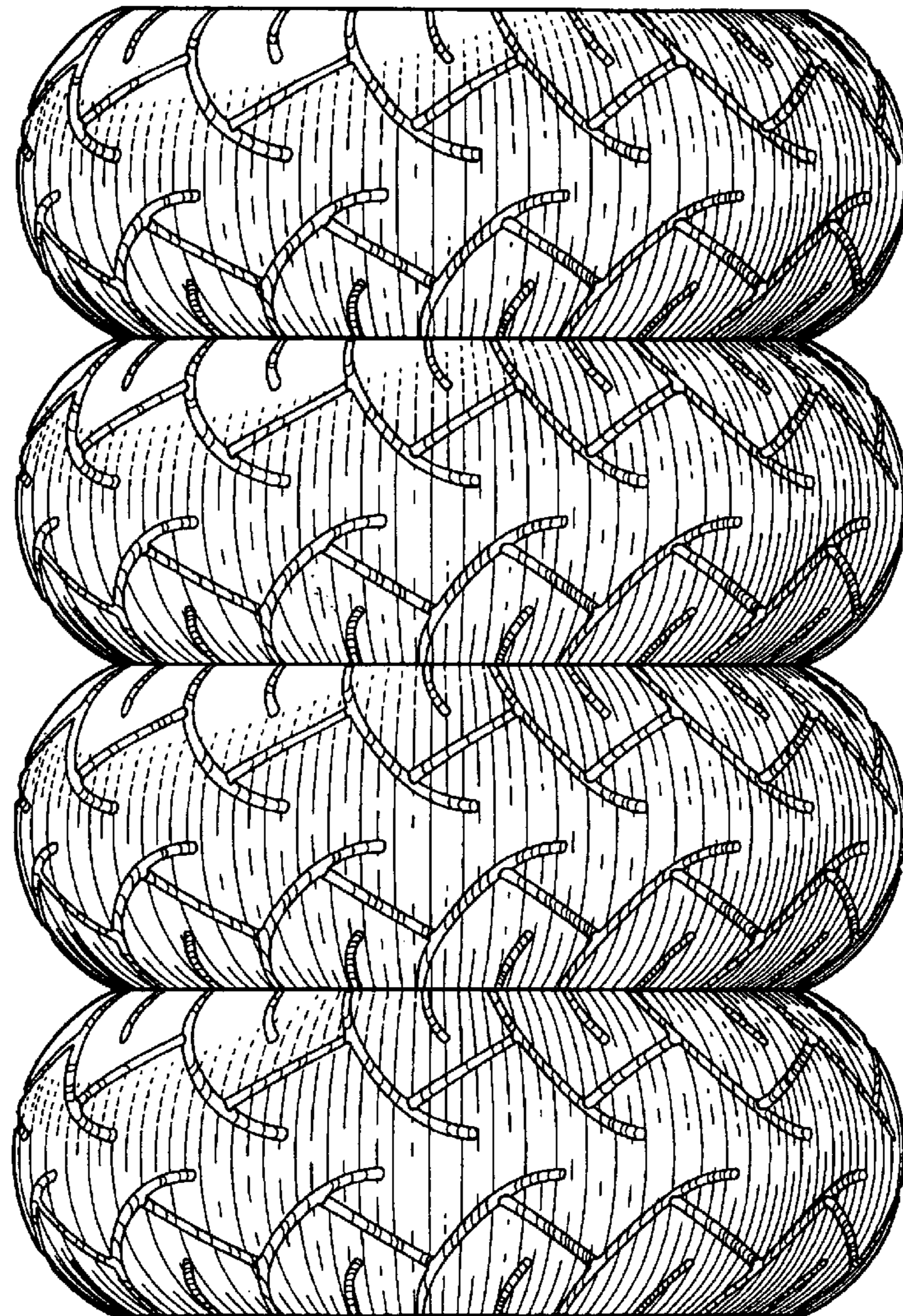
