DESCRIPTION

FIG. 1 is a perspective view of the dog head chopstick of this invention looking at the right hand and rear side of the chopstick.

FIG. 2 is an enlarged top plan view of the dog head chopstick of this invention;

FIG. 3 is an enlarged bottom plan view of the dog head chopstick of this invention;

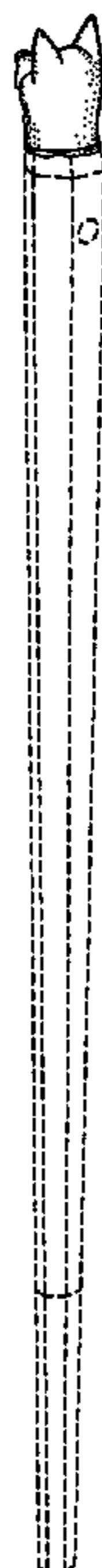
FIG. 4 is a rear view of the dog head chopstick of this invention.

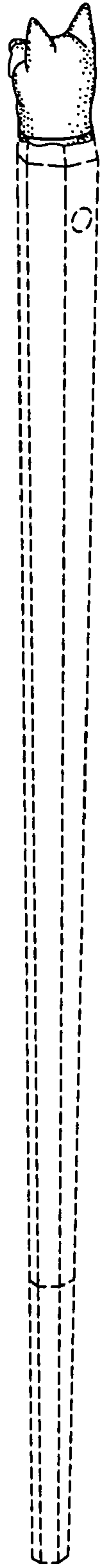

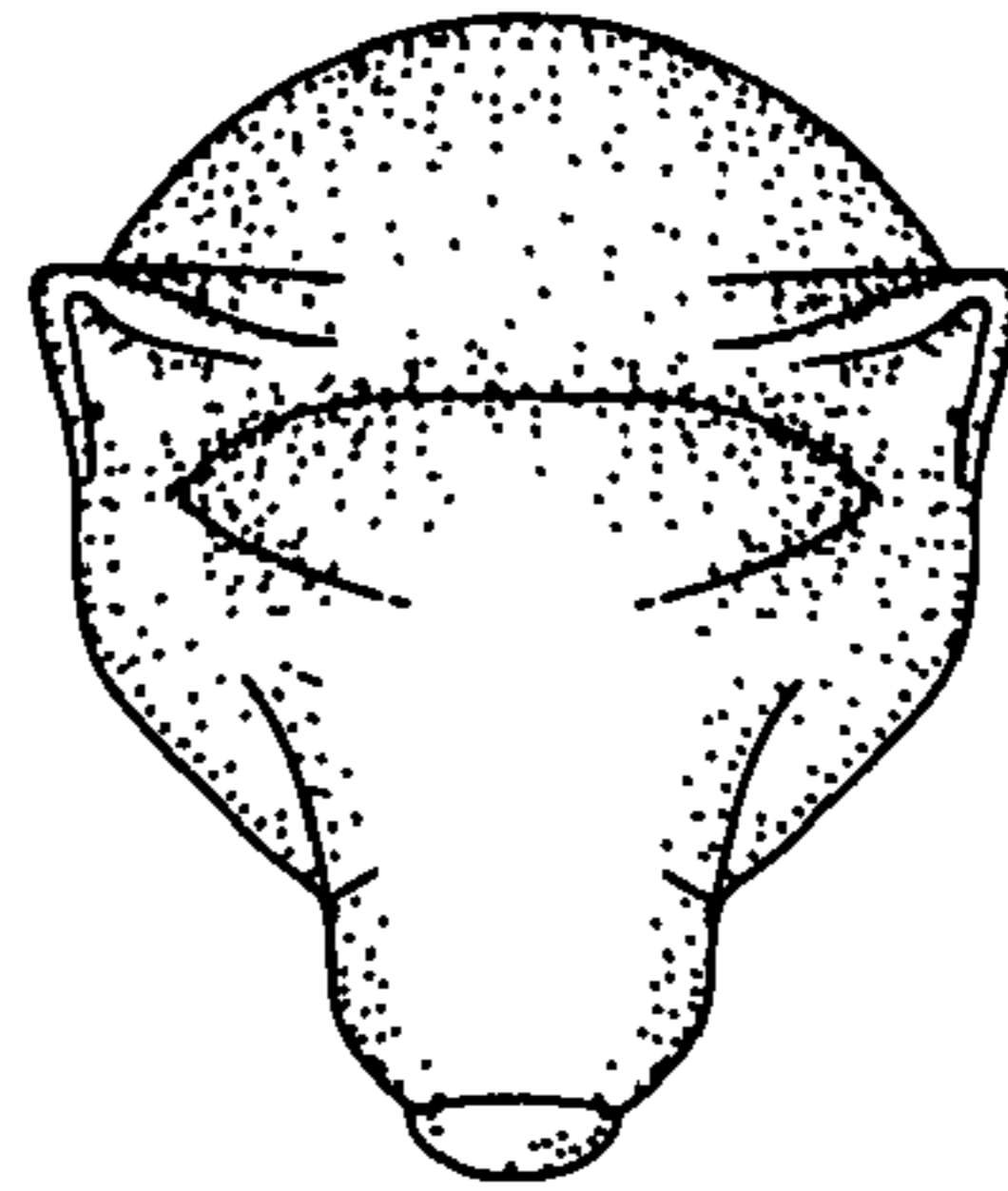

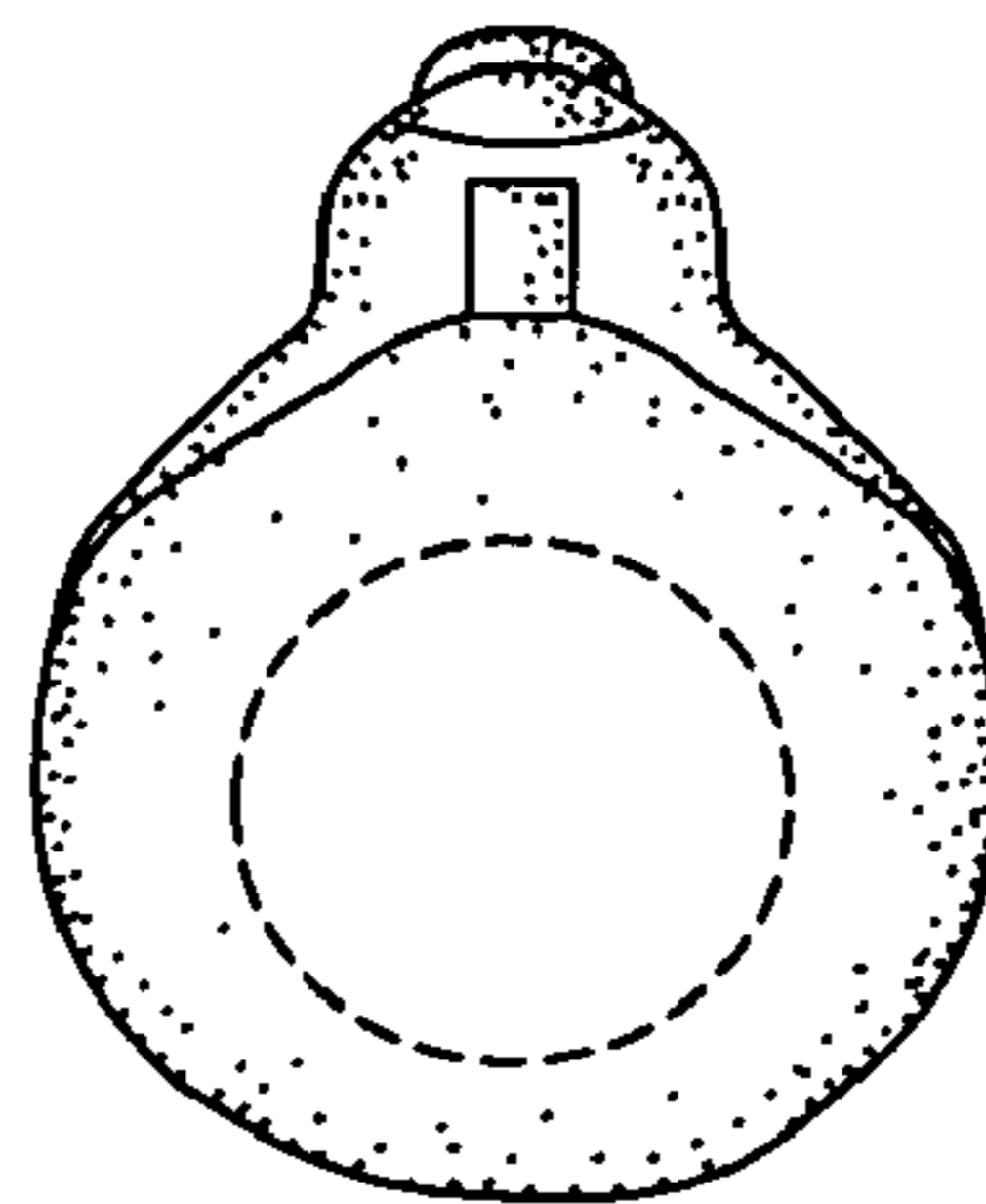

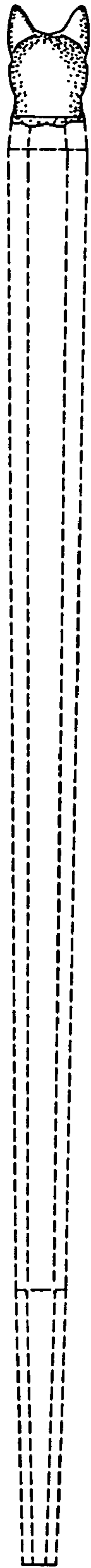

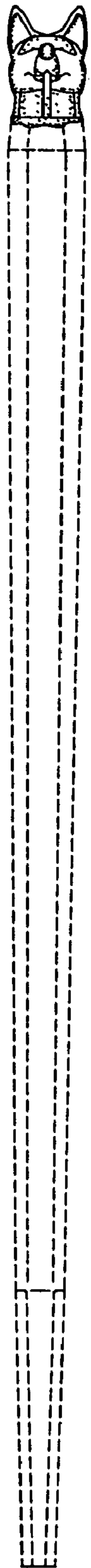

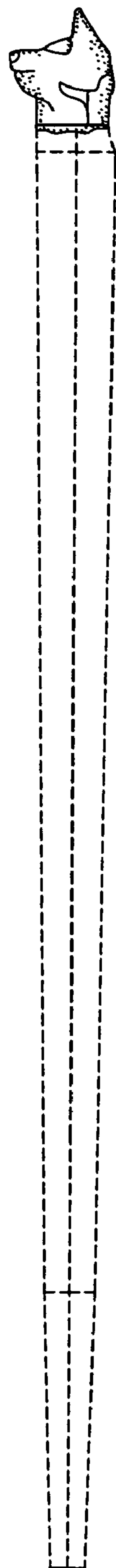
