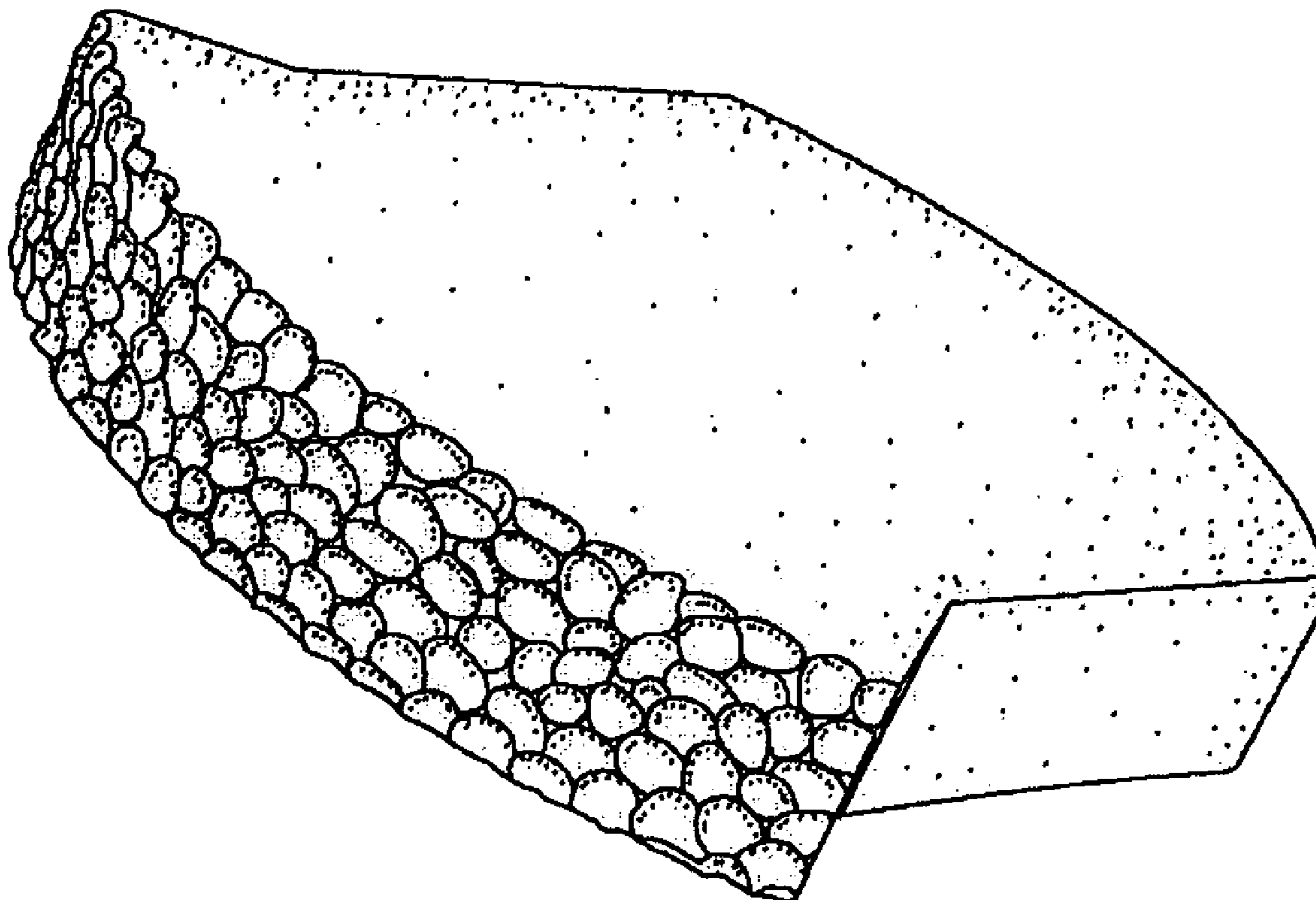
FIG. 1 is a perspective view of an impression tool showing my new design;

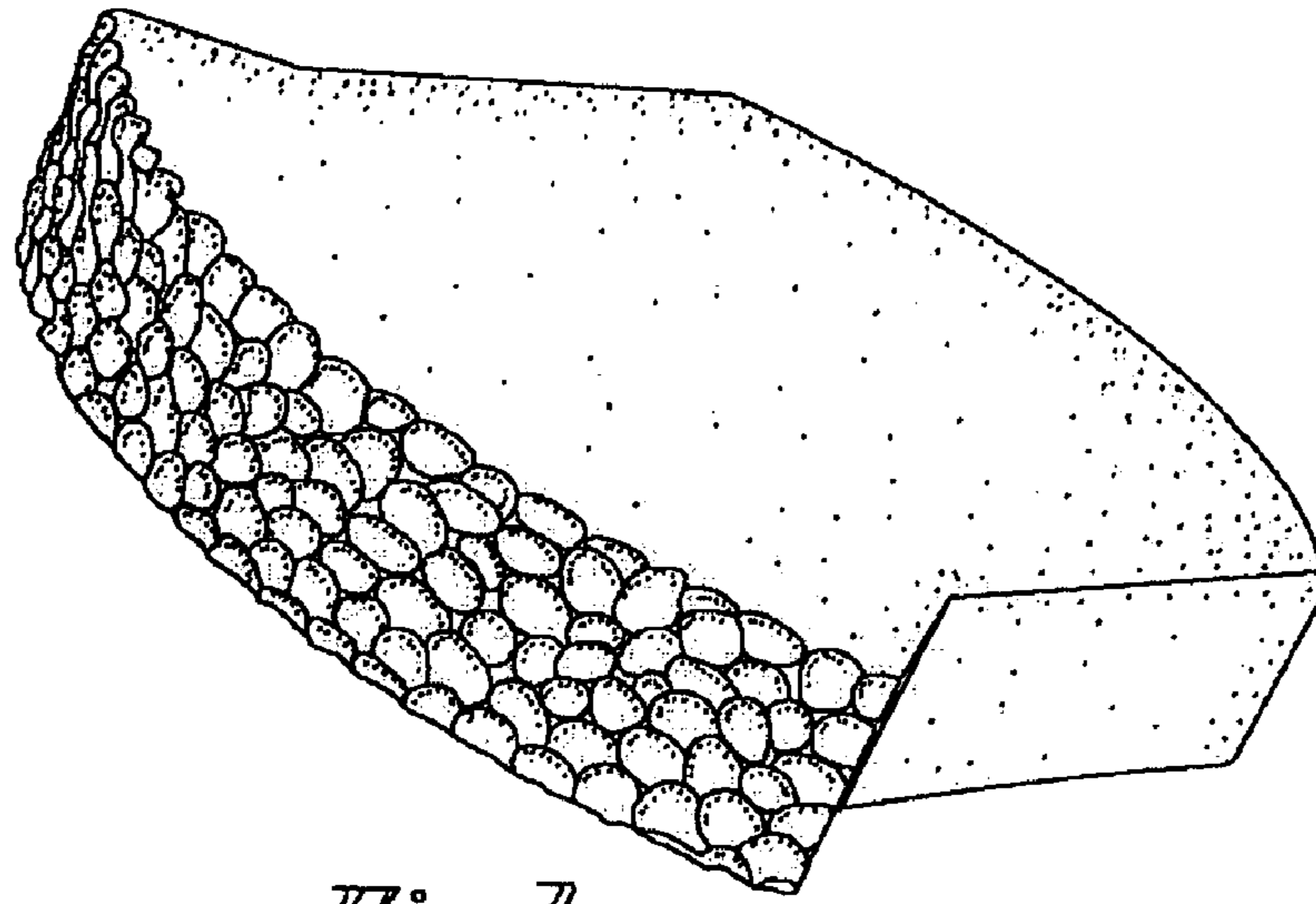
FIG. 2 is a left side elevational view thereof;

FIG. 3 is a front elevational view thereof; and,

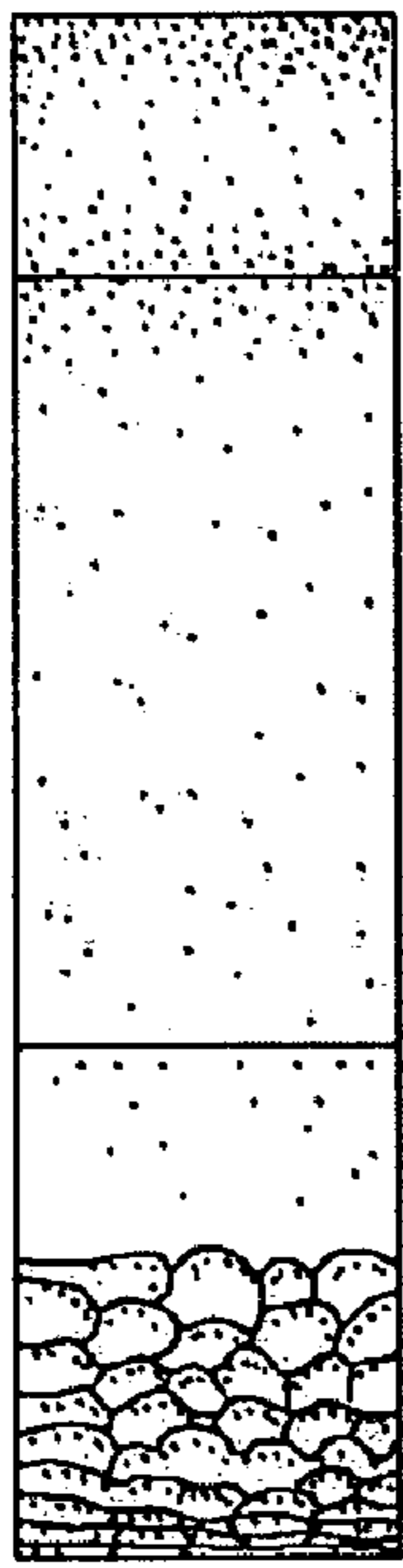
FIG. 4 is a bottom plan view thereof.

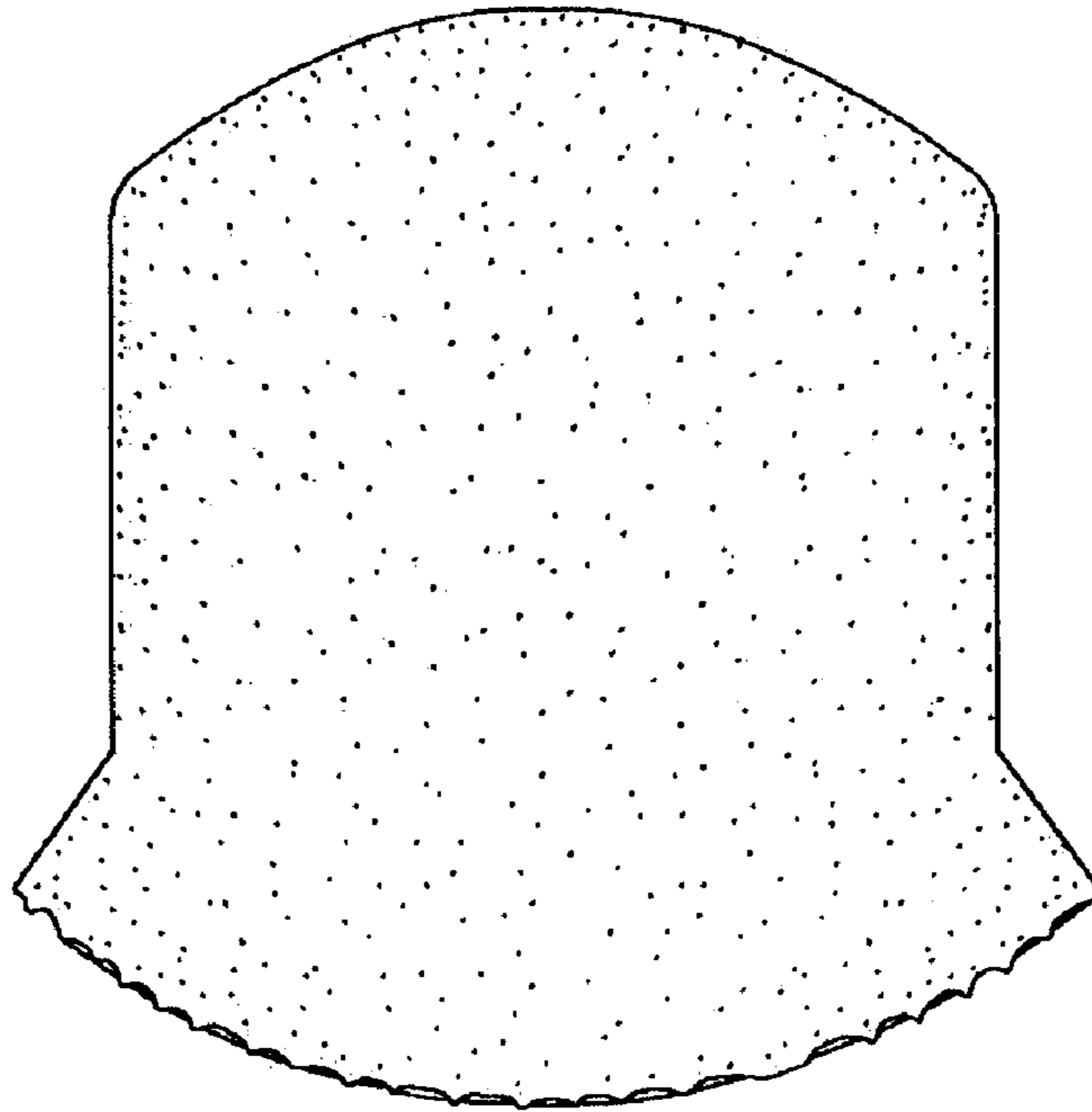




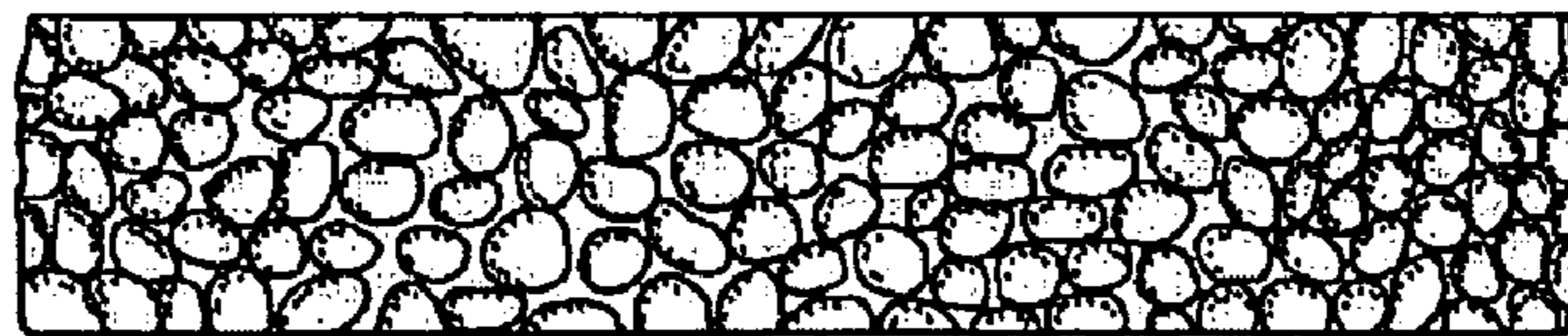
