**DESCRIPTION**

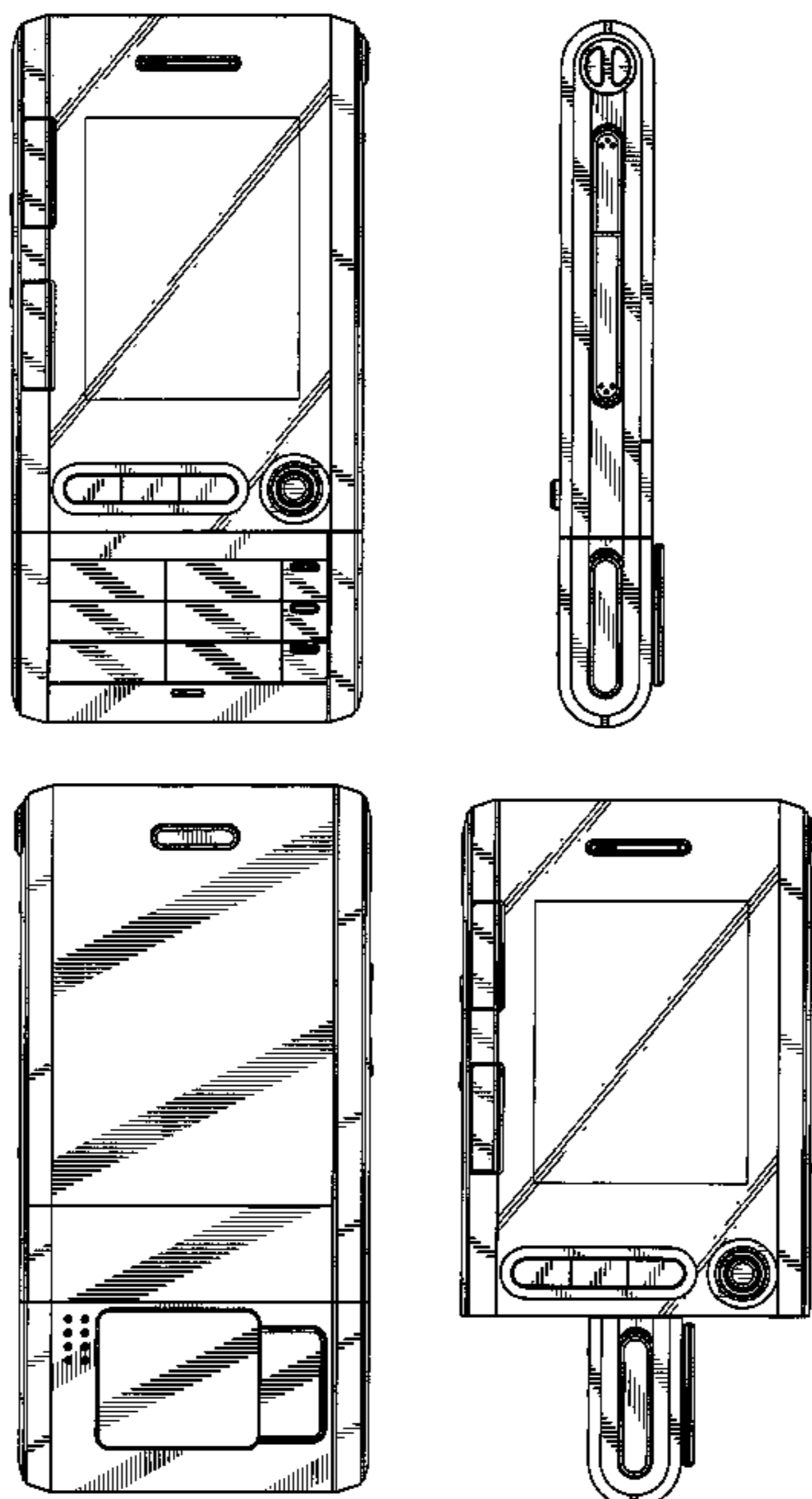

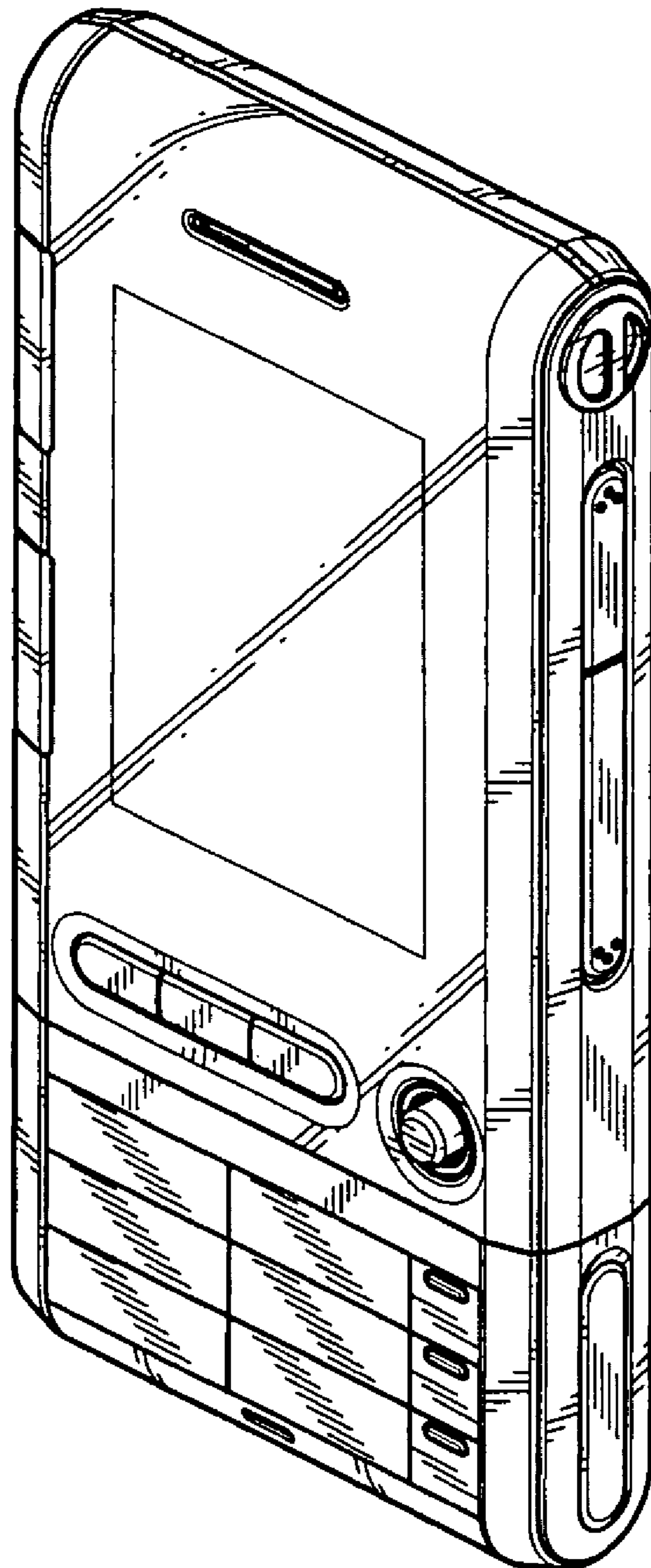

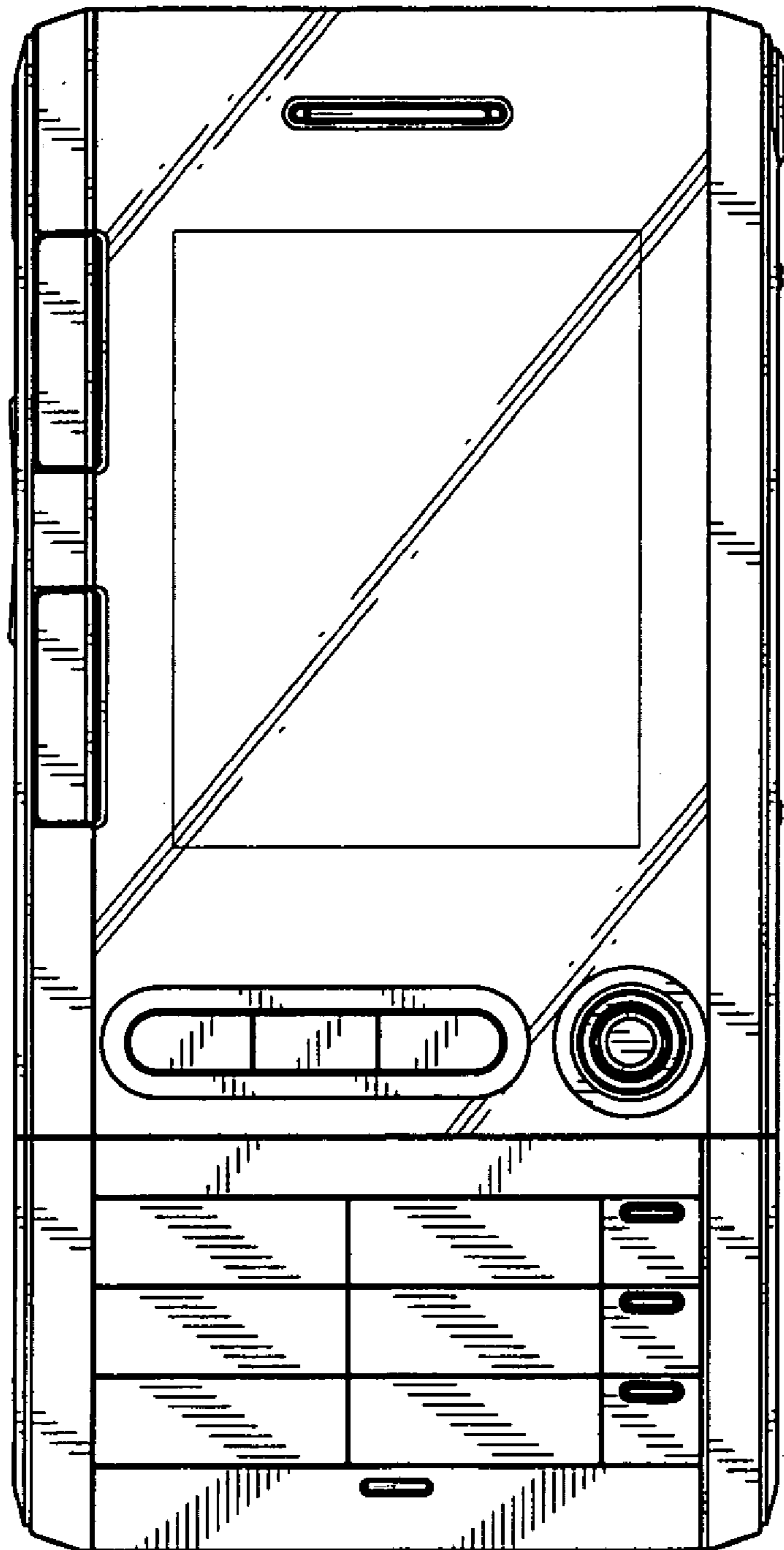

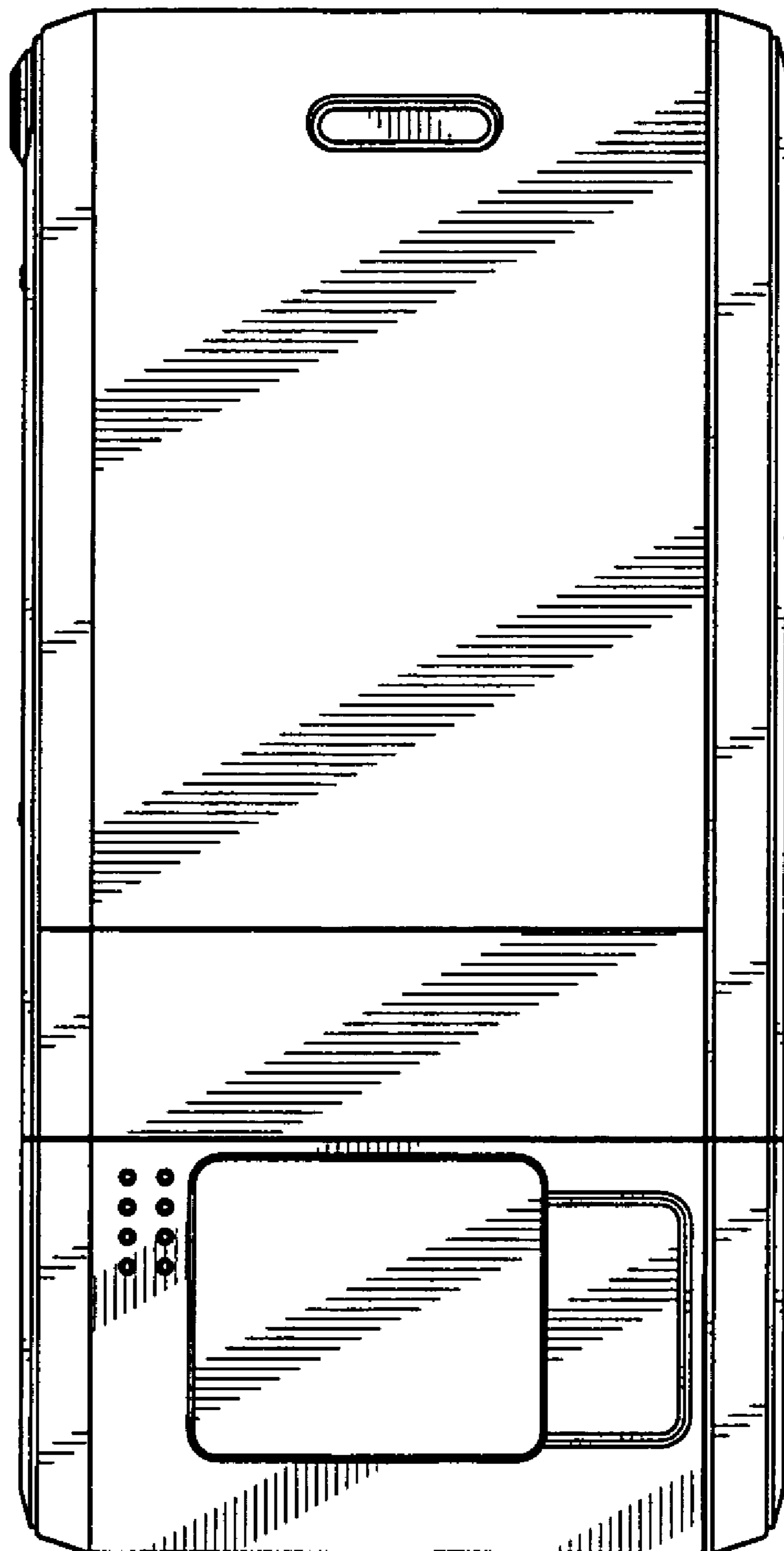

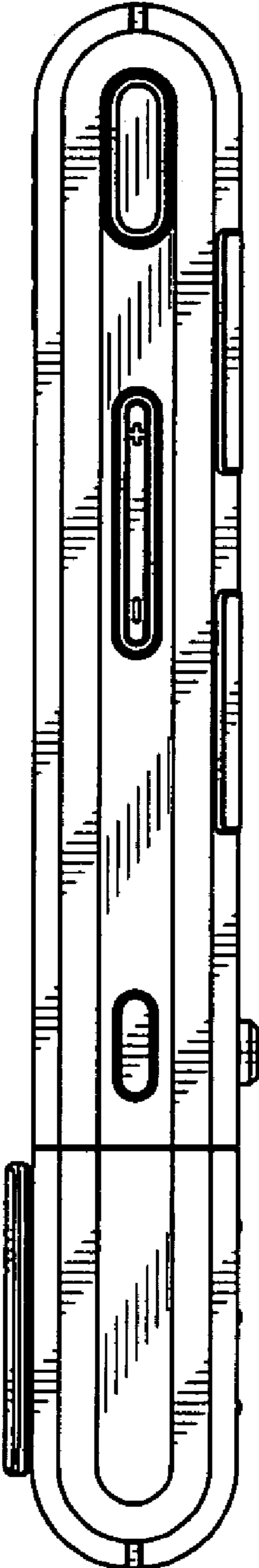
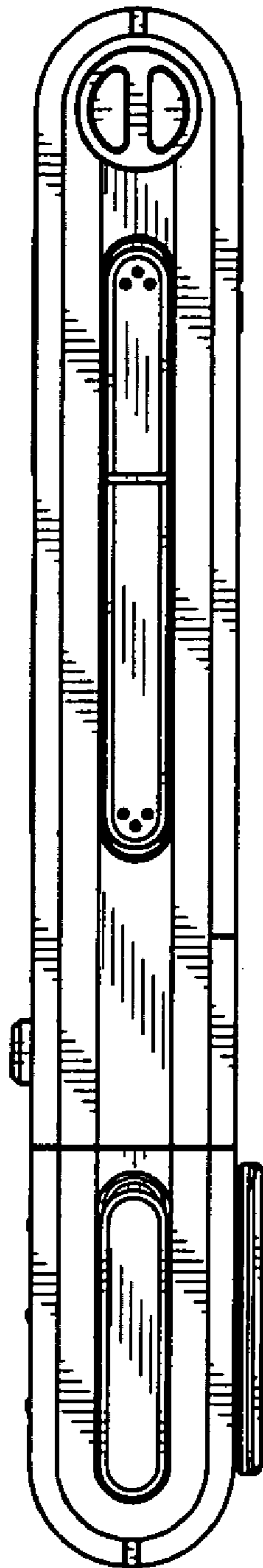
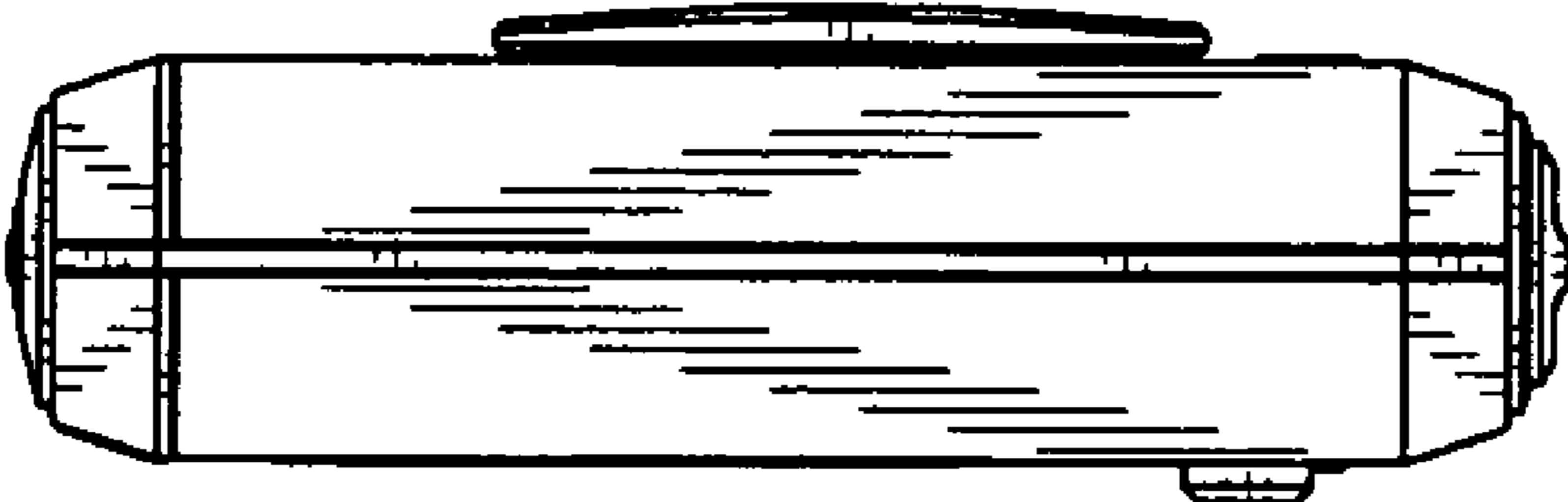

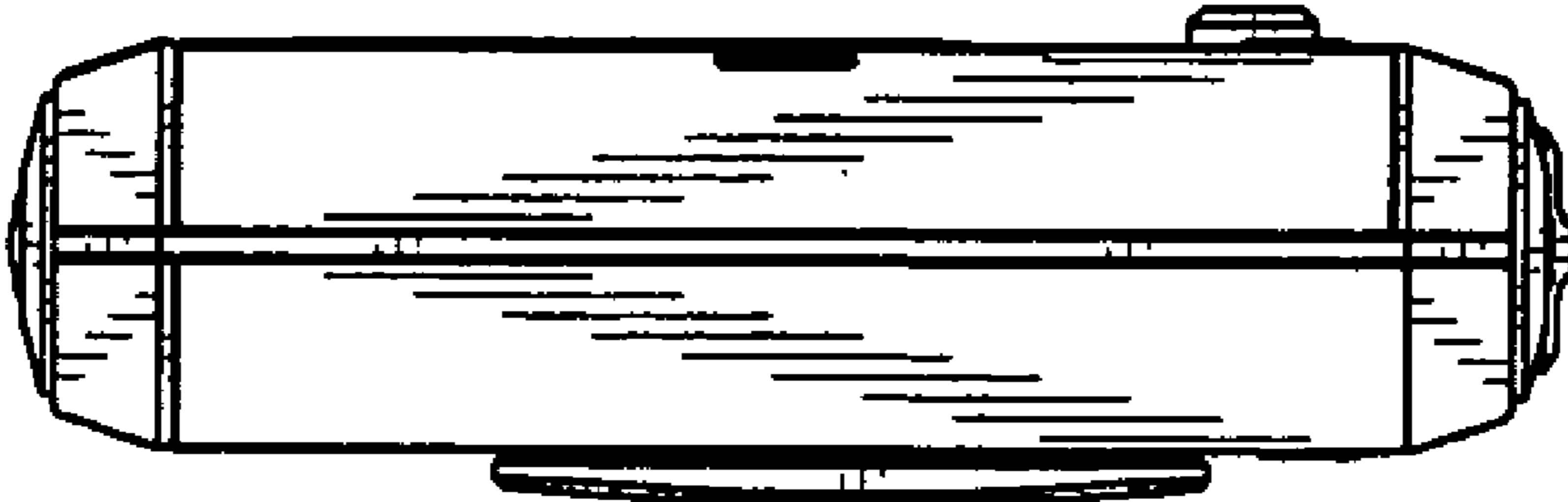
