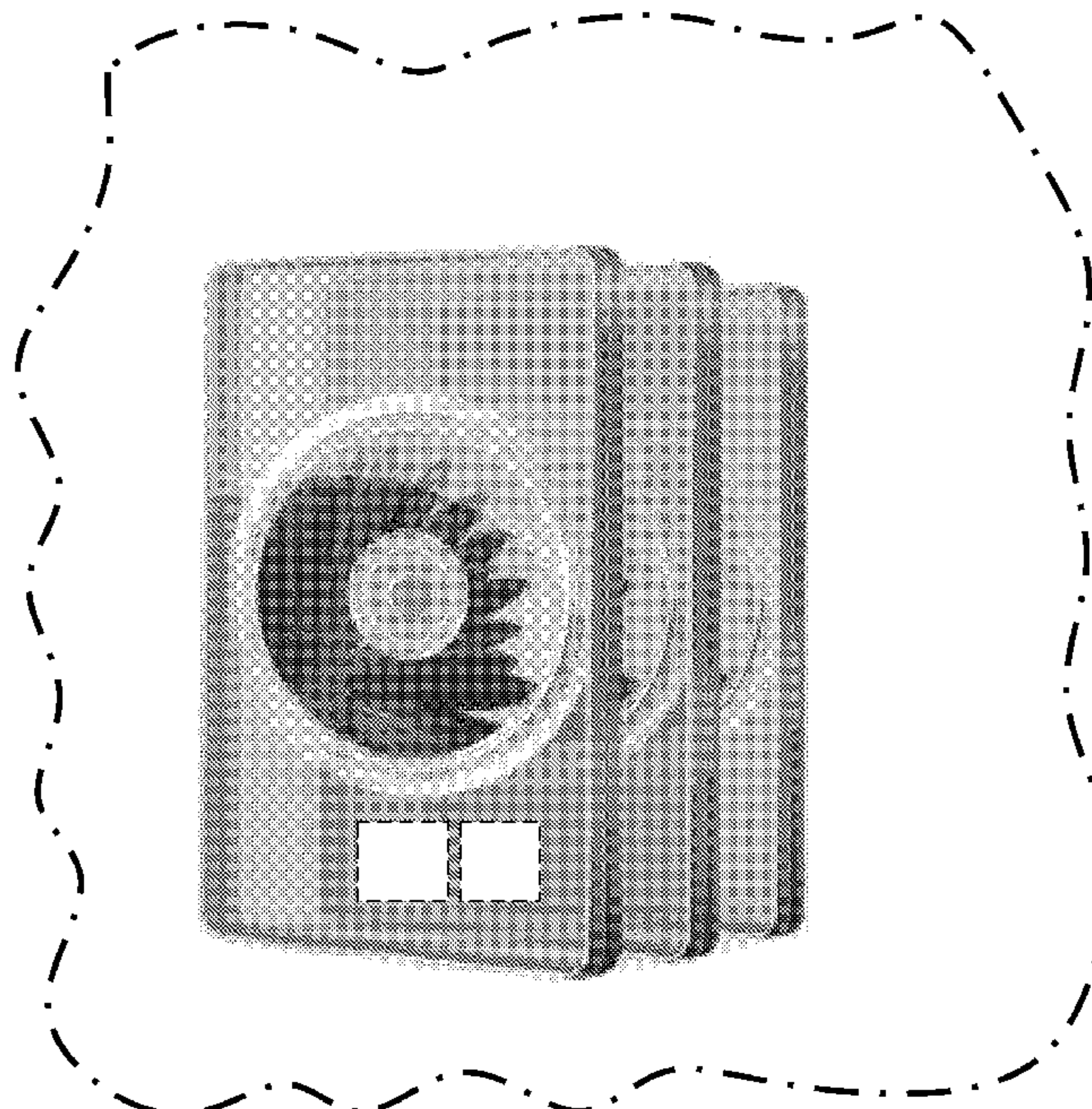
The ornamental design for an icon for a portion of a display screen, as shown and described.

**DESCRIPTION**

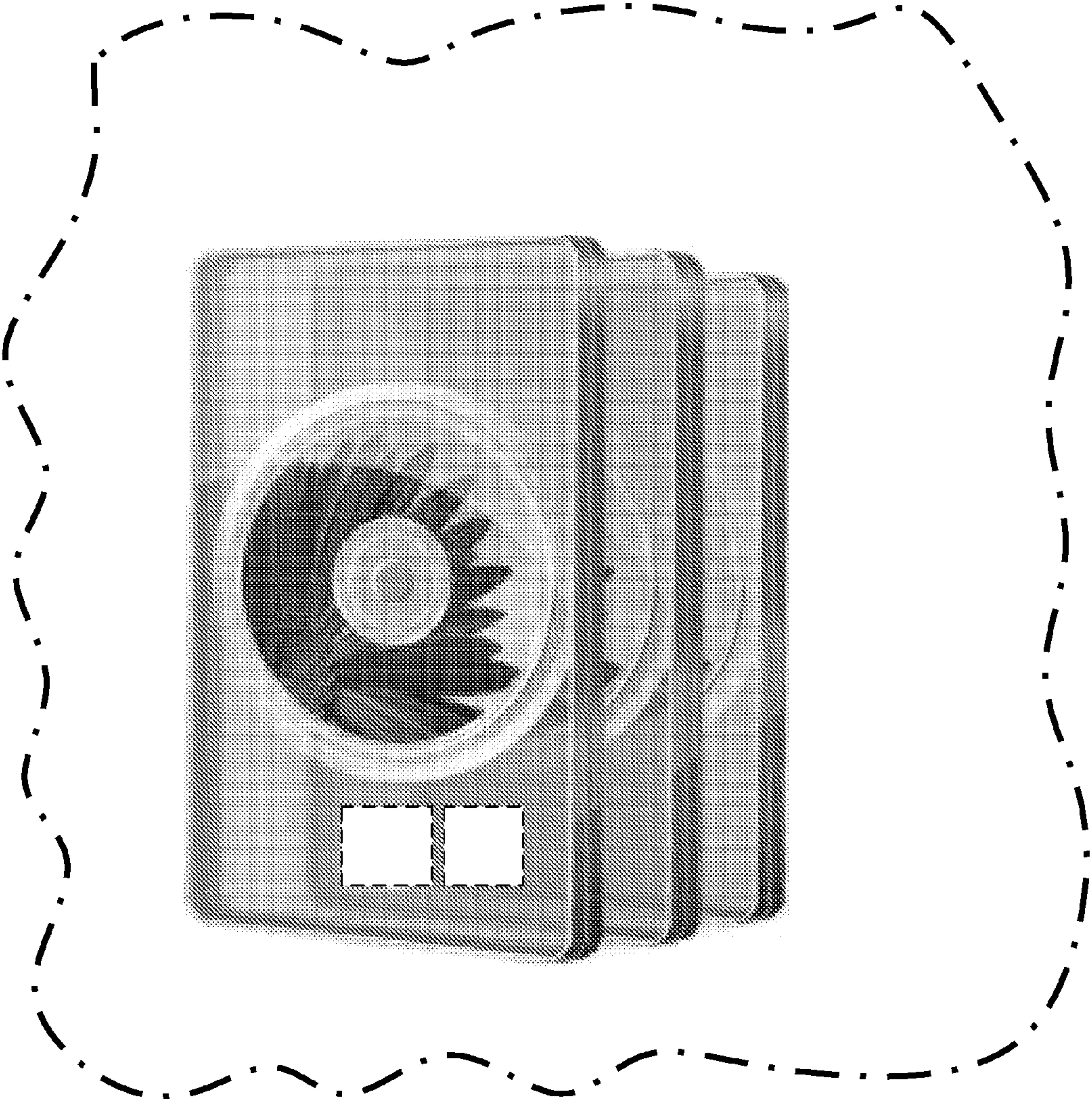
The FIGURE is a front view of an icon for a portion of a display screen showing our new design.
