DESCRIPTION

FIG. 1 is perspective view of a refrigerator showing my ornamental design;

FIG. 3 is a right side view of the refrigerator embodiment shown in FIG. 1;

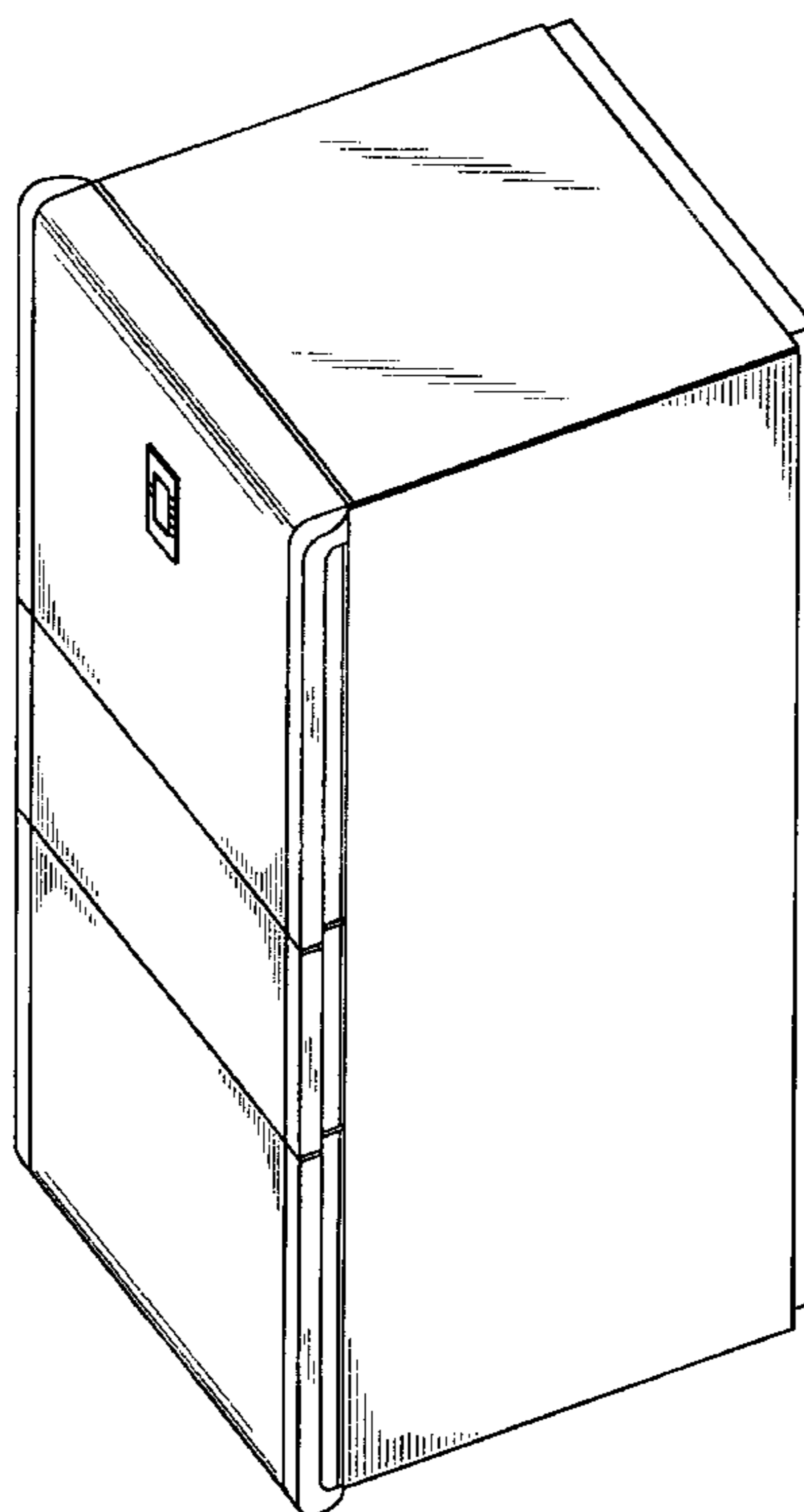
FIG. 4 is a left side view of the refrigerator embodiment shown in FIG. 1;

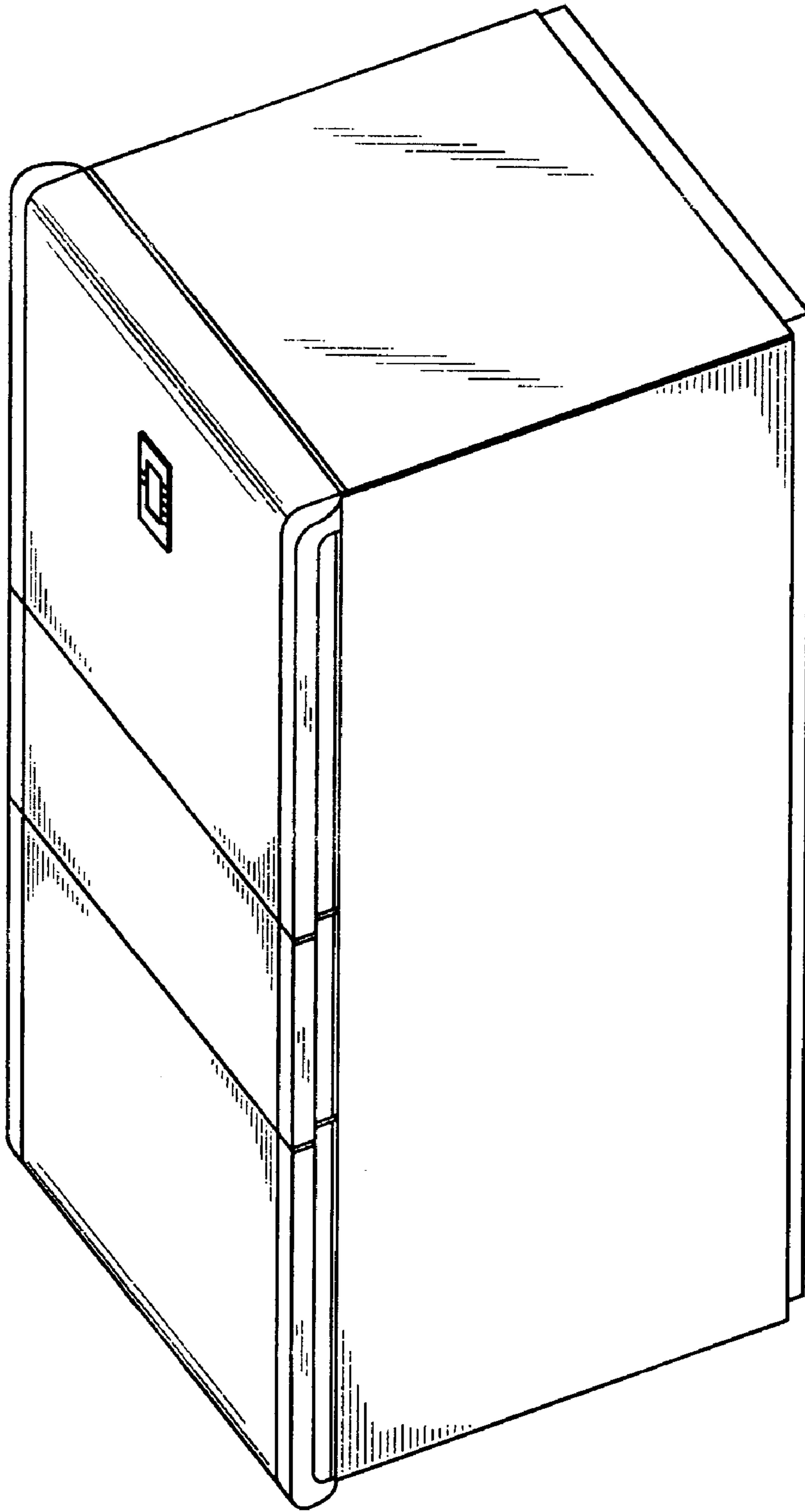

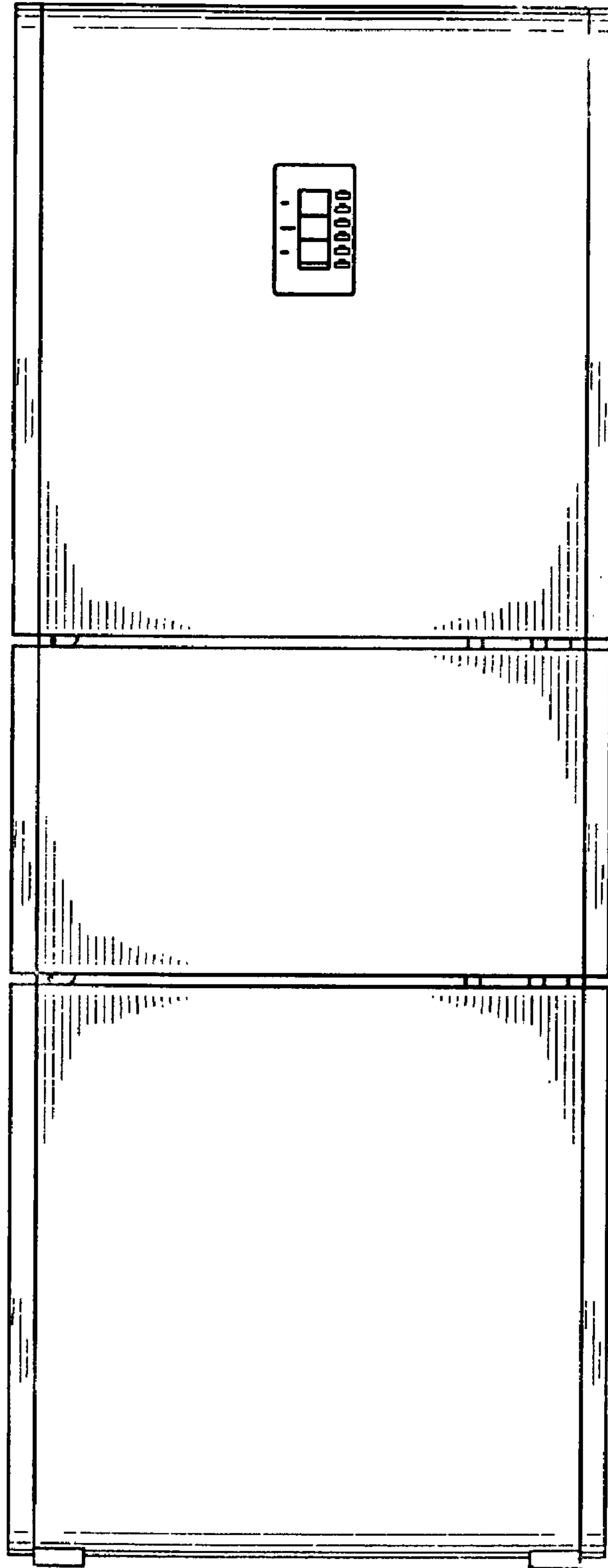

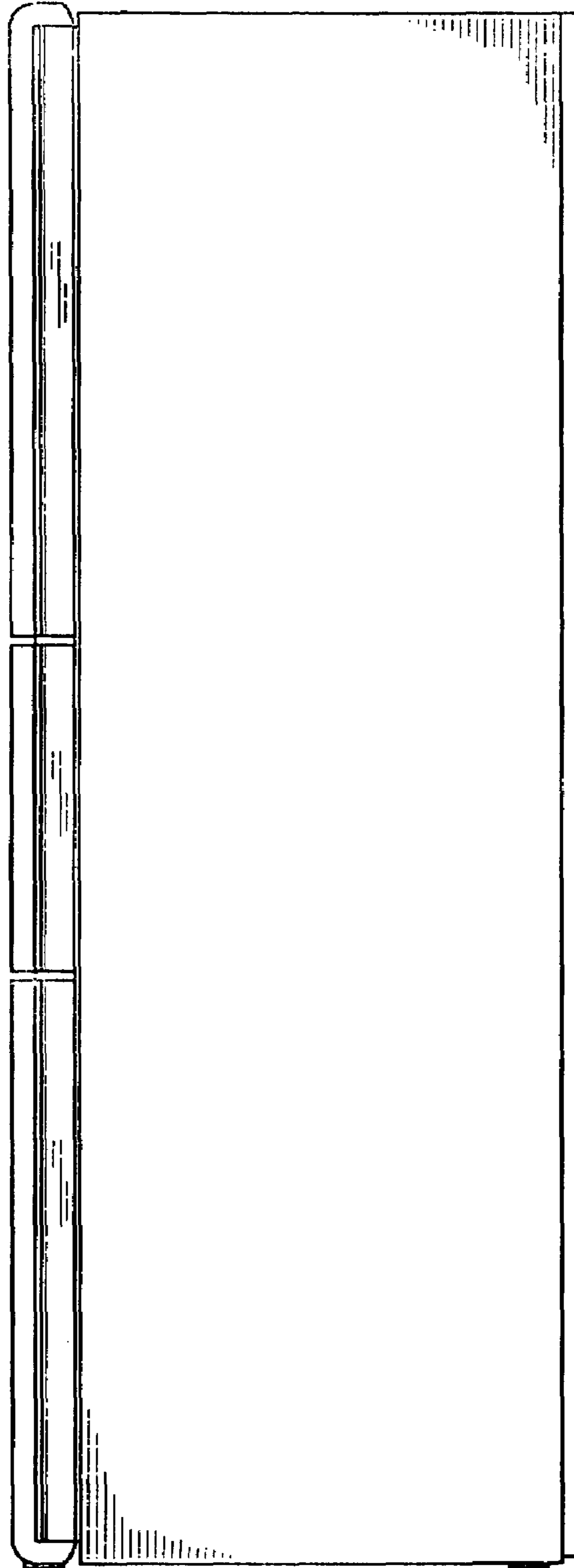

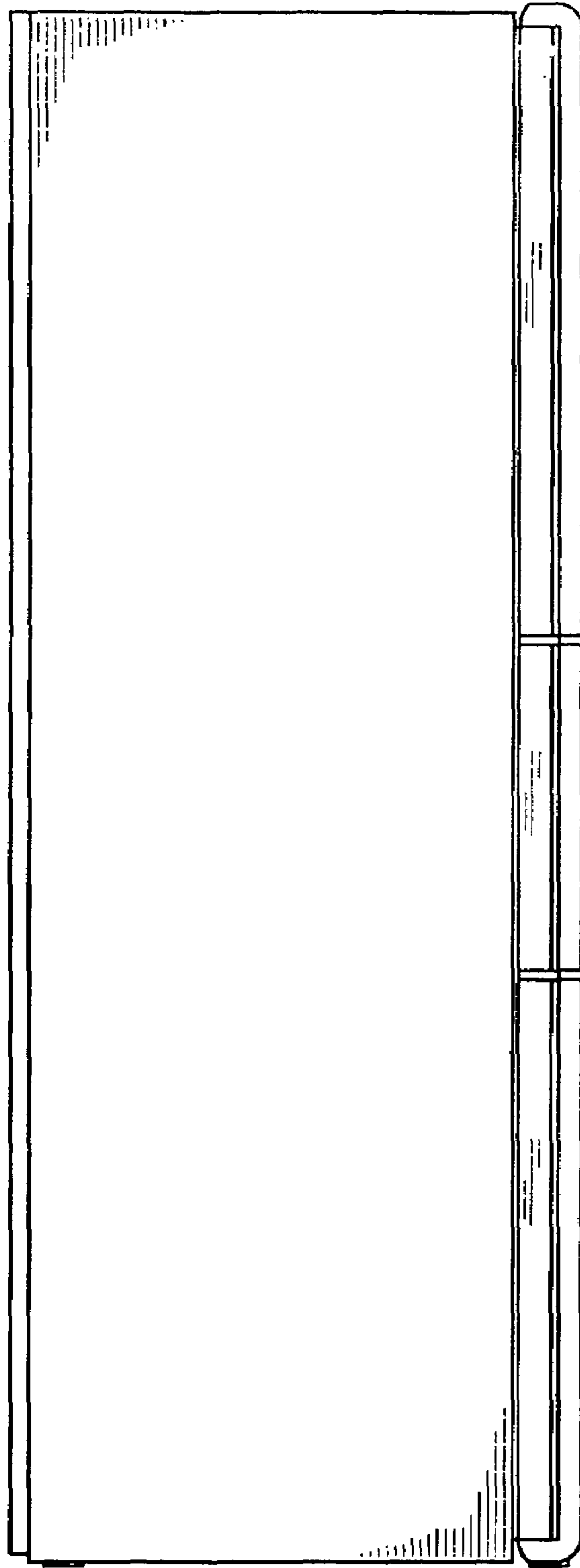

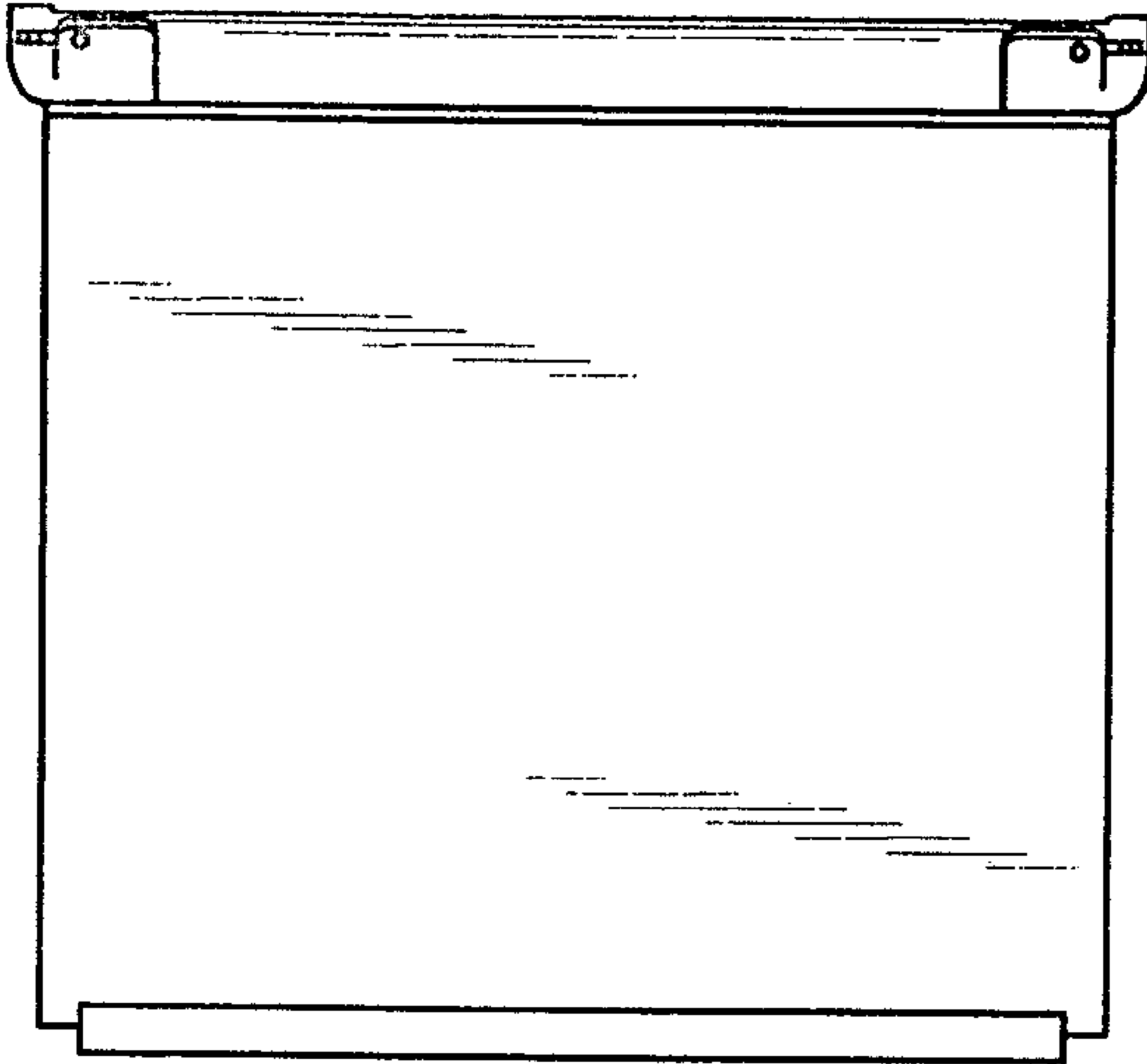

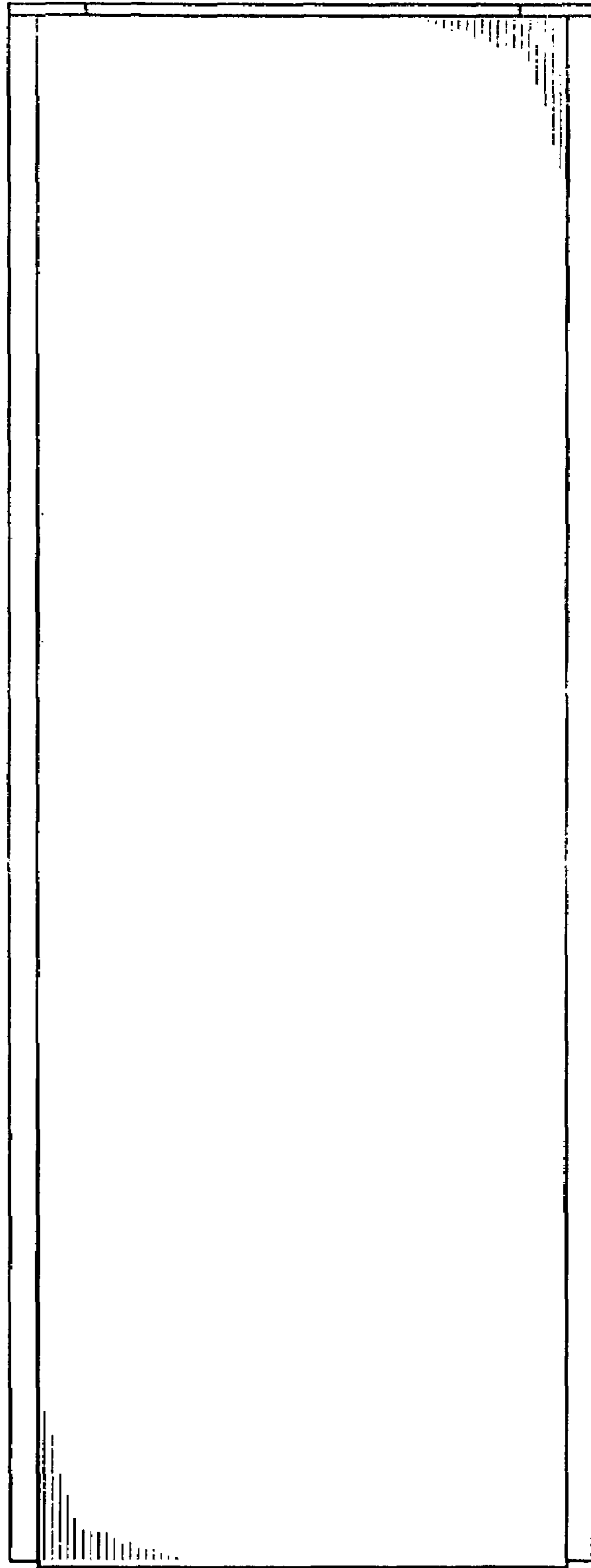

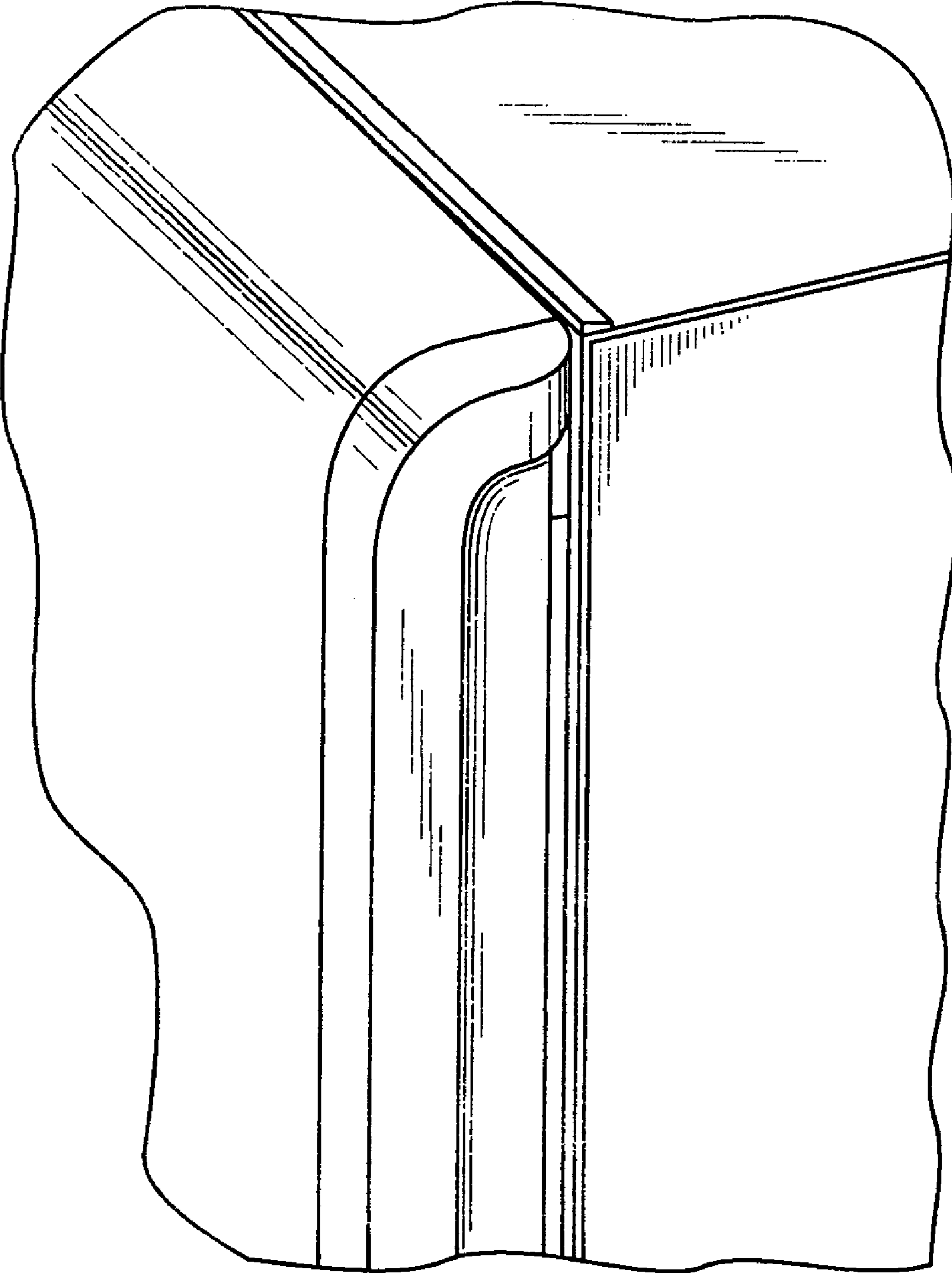
