The ornamental design for a citation pad holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front left of a citation pad holder according to the present invention in the closed position;

FIG. 2 is a front plan view thereof;

FIG. 3 is a rear plan view thereof;

FIG. 4 is a side elevational view thereof from the left;

FIG. 5 is a side elevational view thereof from the right;

FIG. 6 is an end elevational view thereof from the bottom;

FIG. 7 is an end elevational view thereof from the top;

FIG. 8 is a perspective view from the front left thereof in an opened position;

FIG. 9 is a front plan view thereof;

FIG. 10 is a rear plan view thereof;

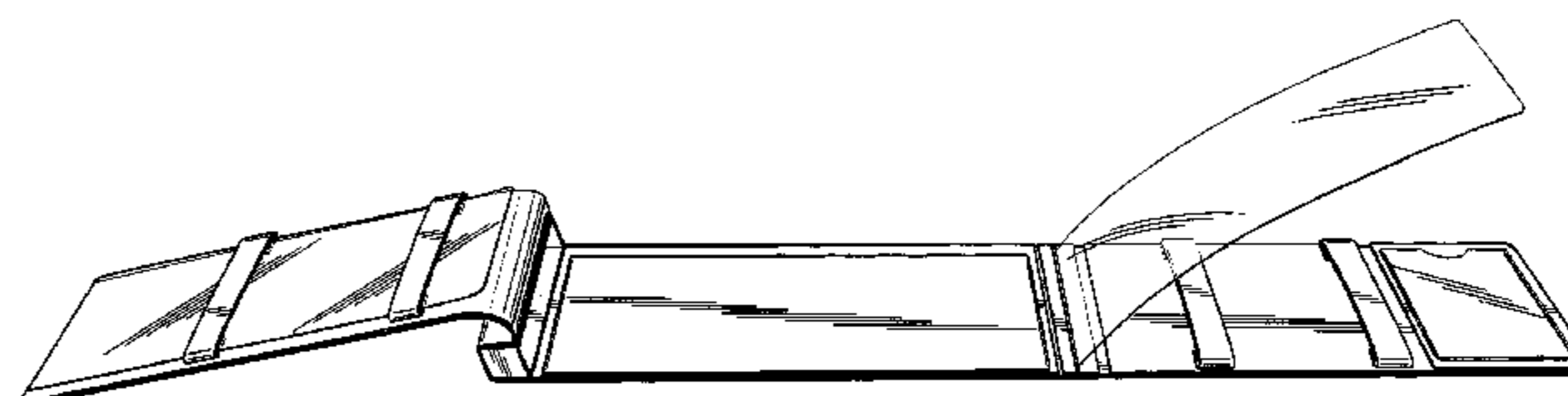
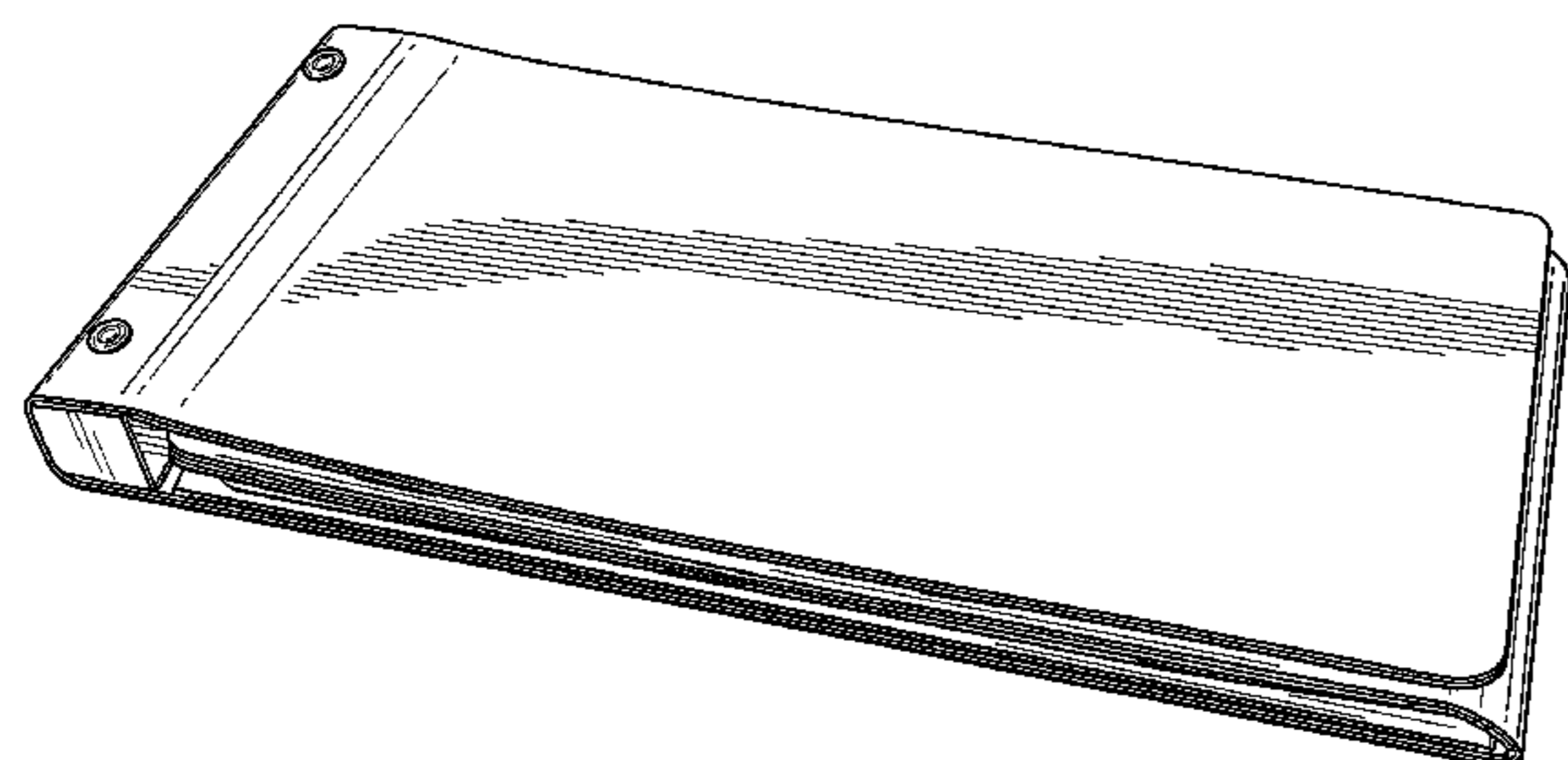
FIG. 11 is a side elevational view thereof from the left;

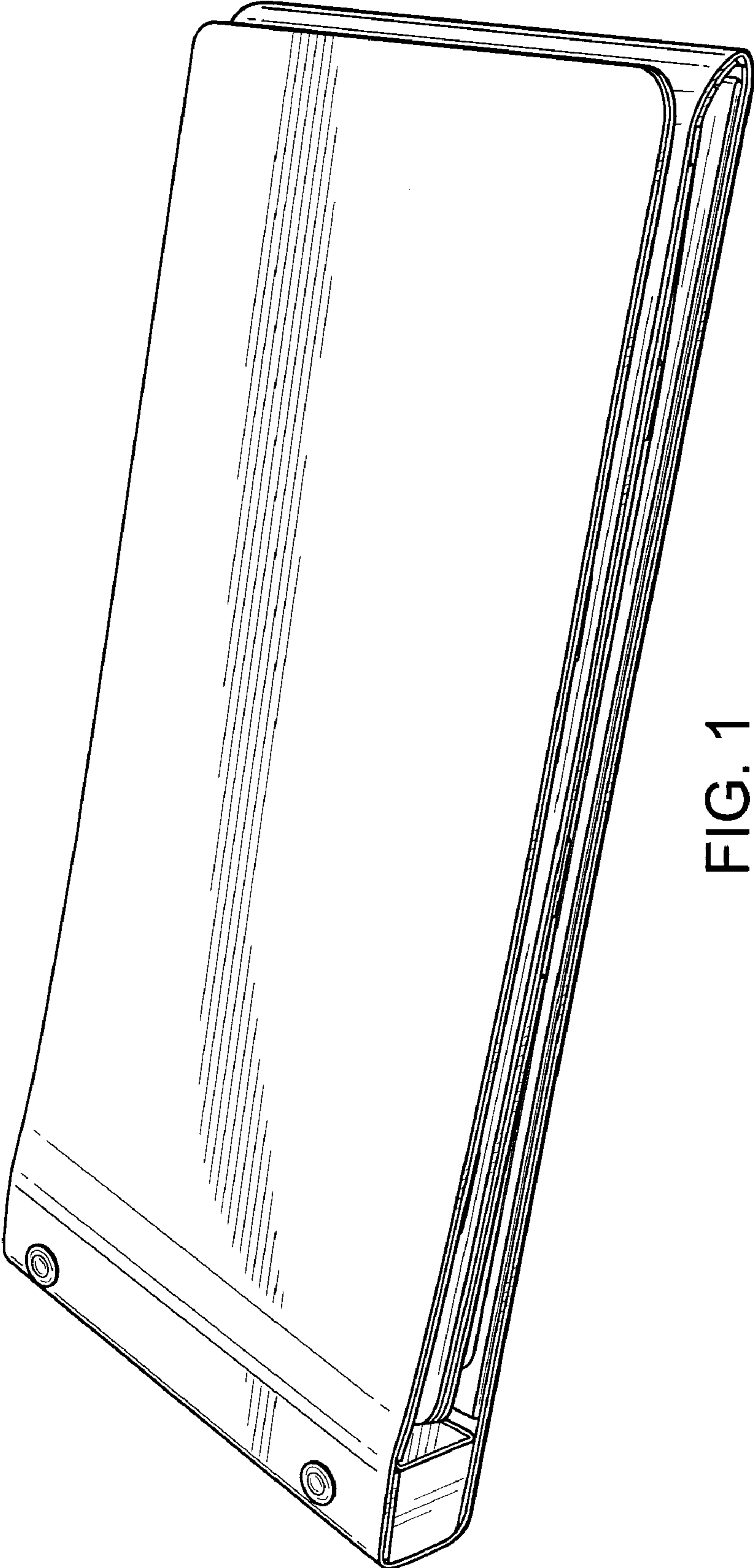

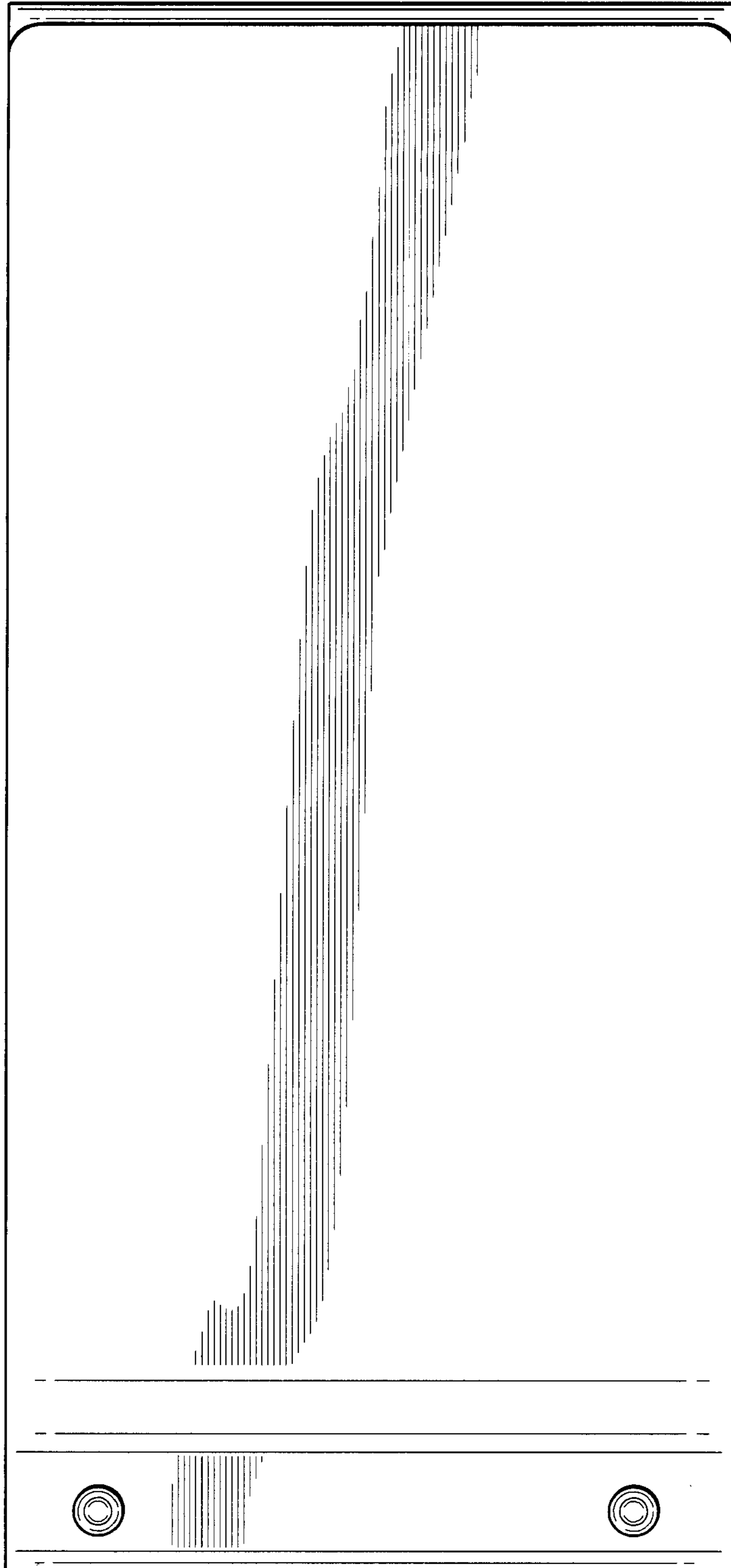

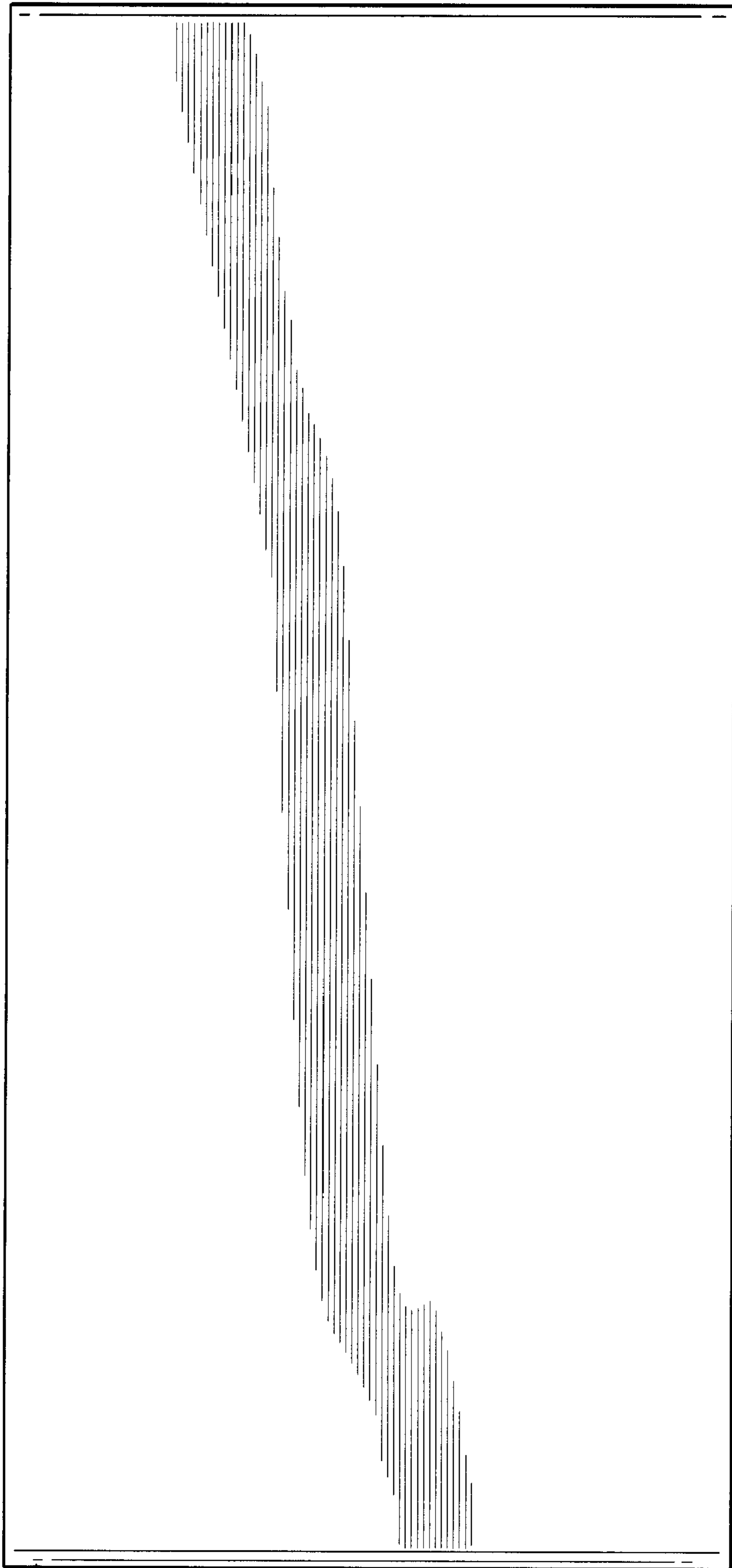

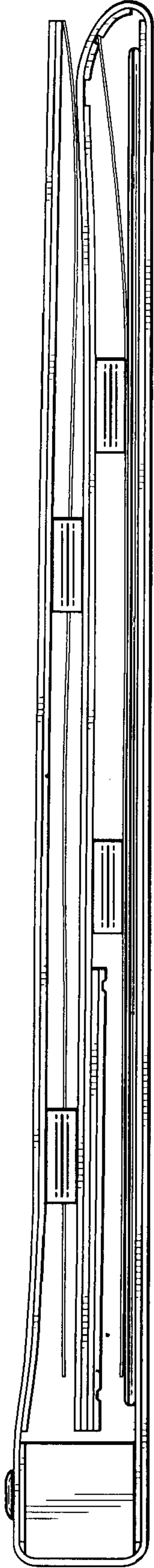

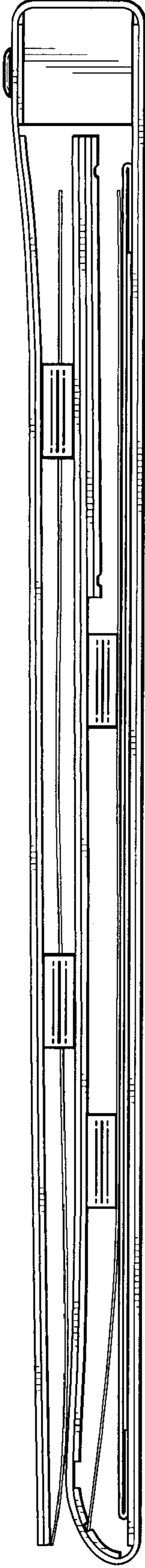

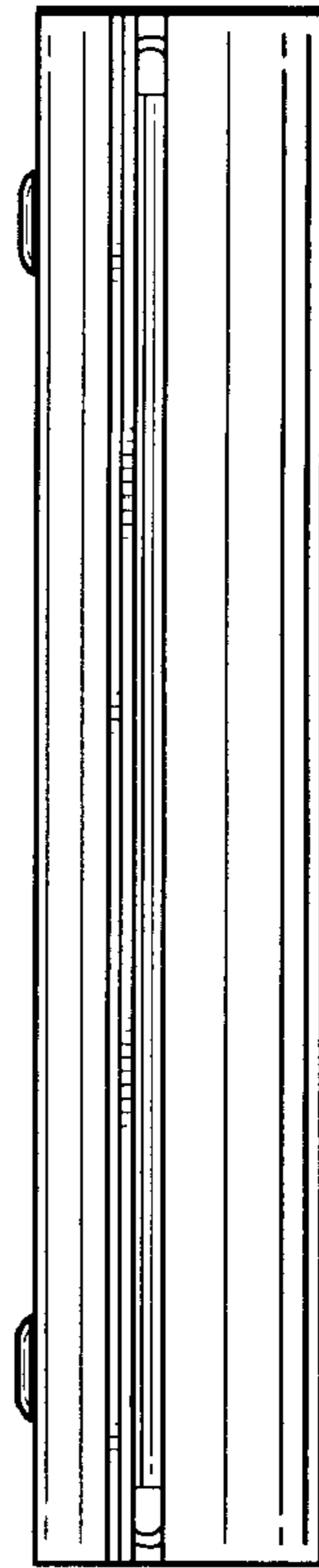

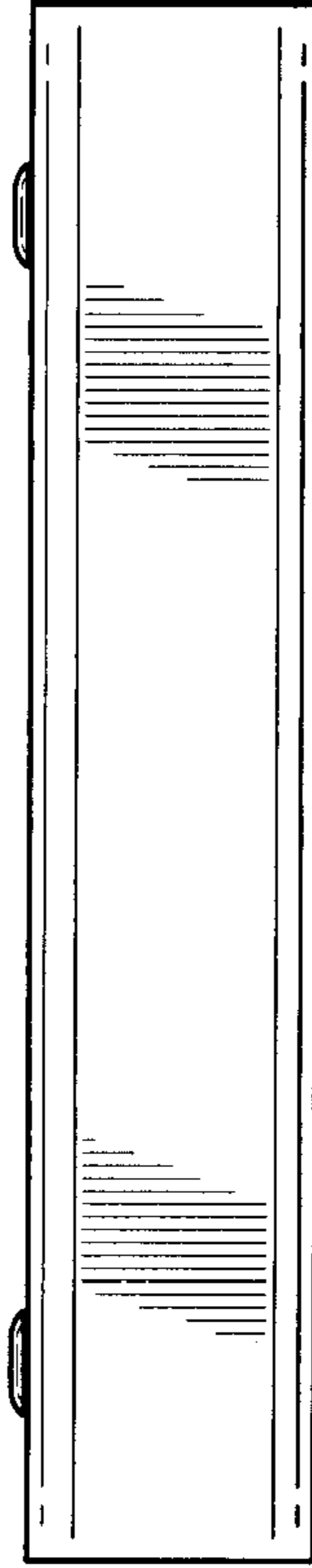

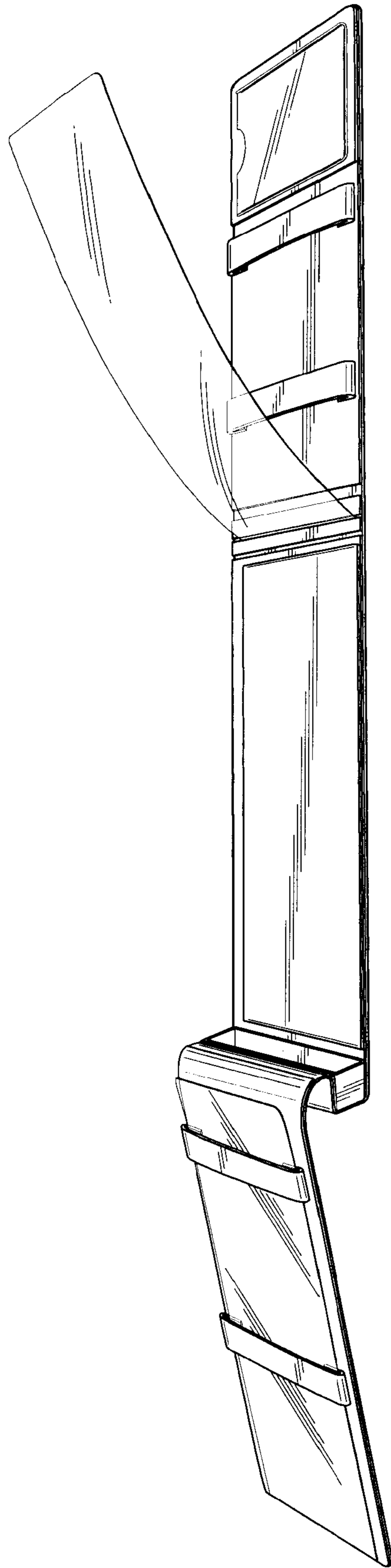

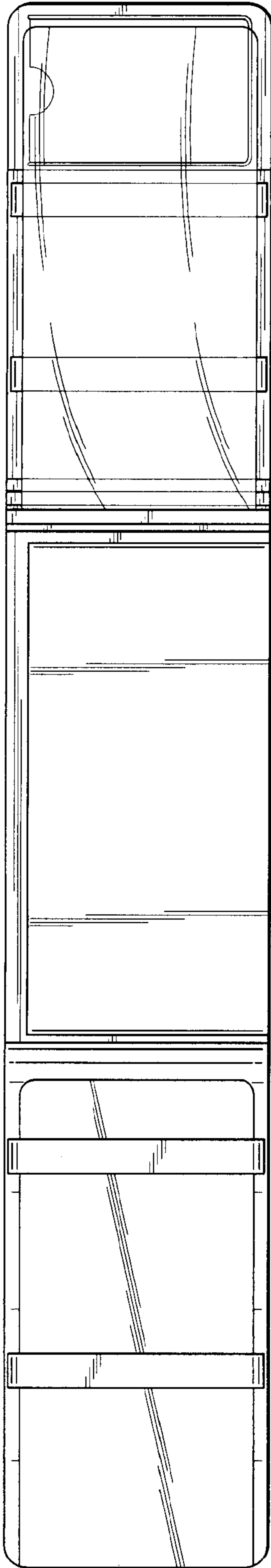

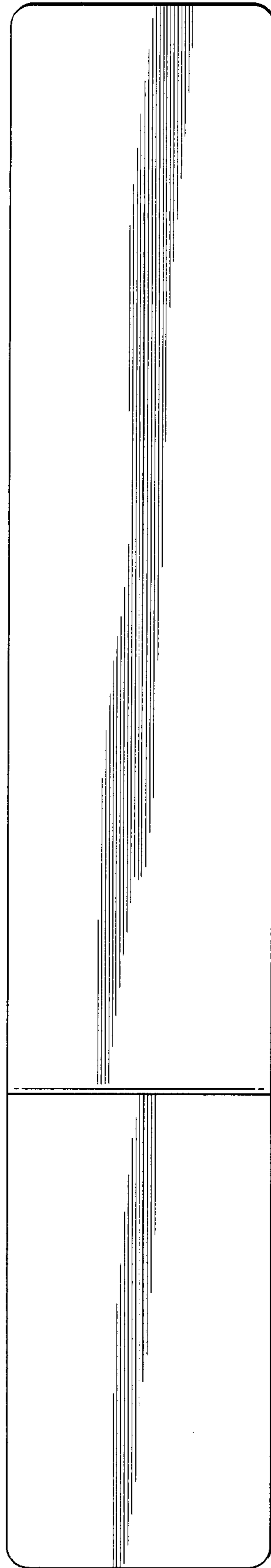

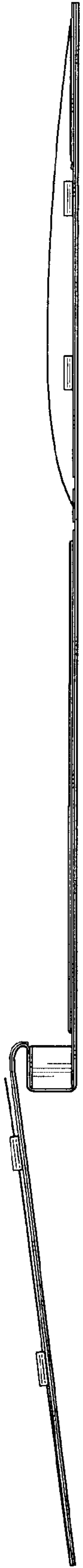

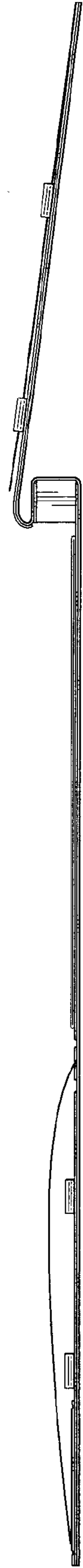

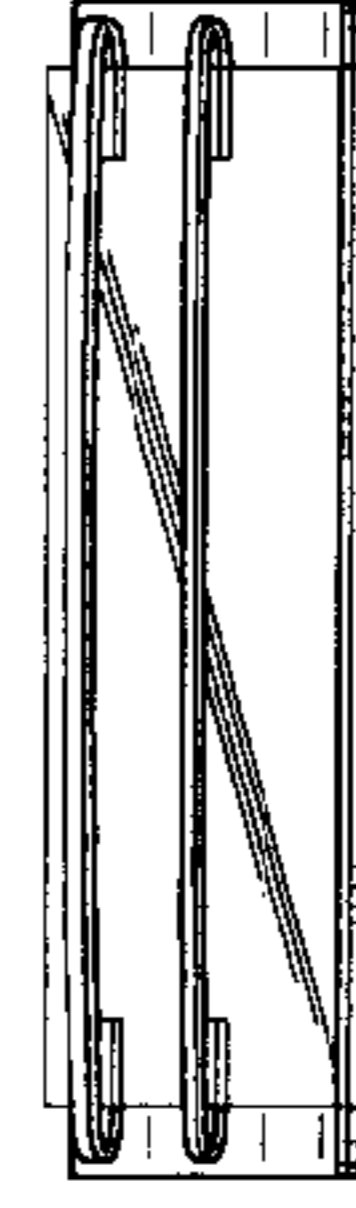
